as shown and described.

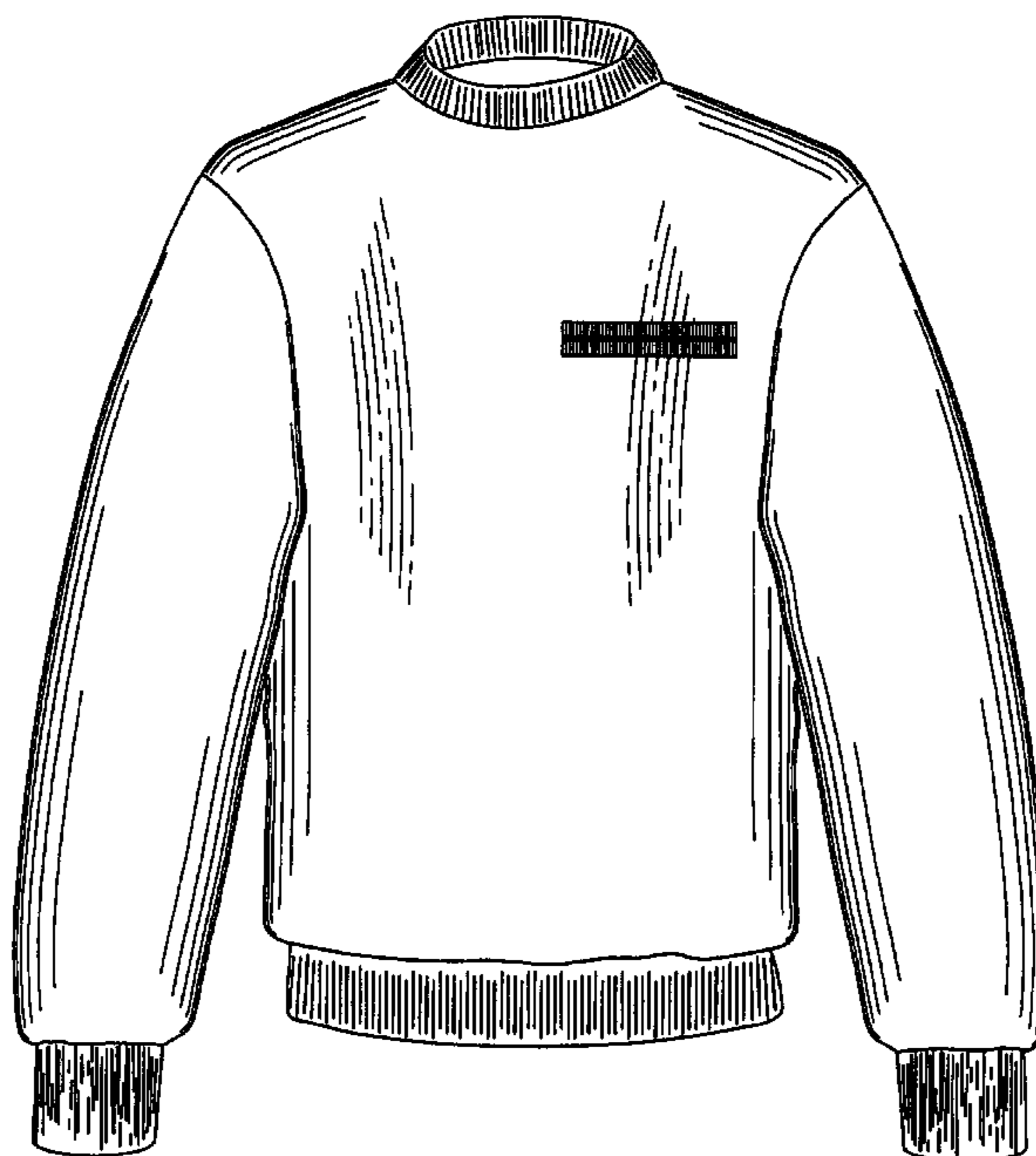
**DESCRIPTION**

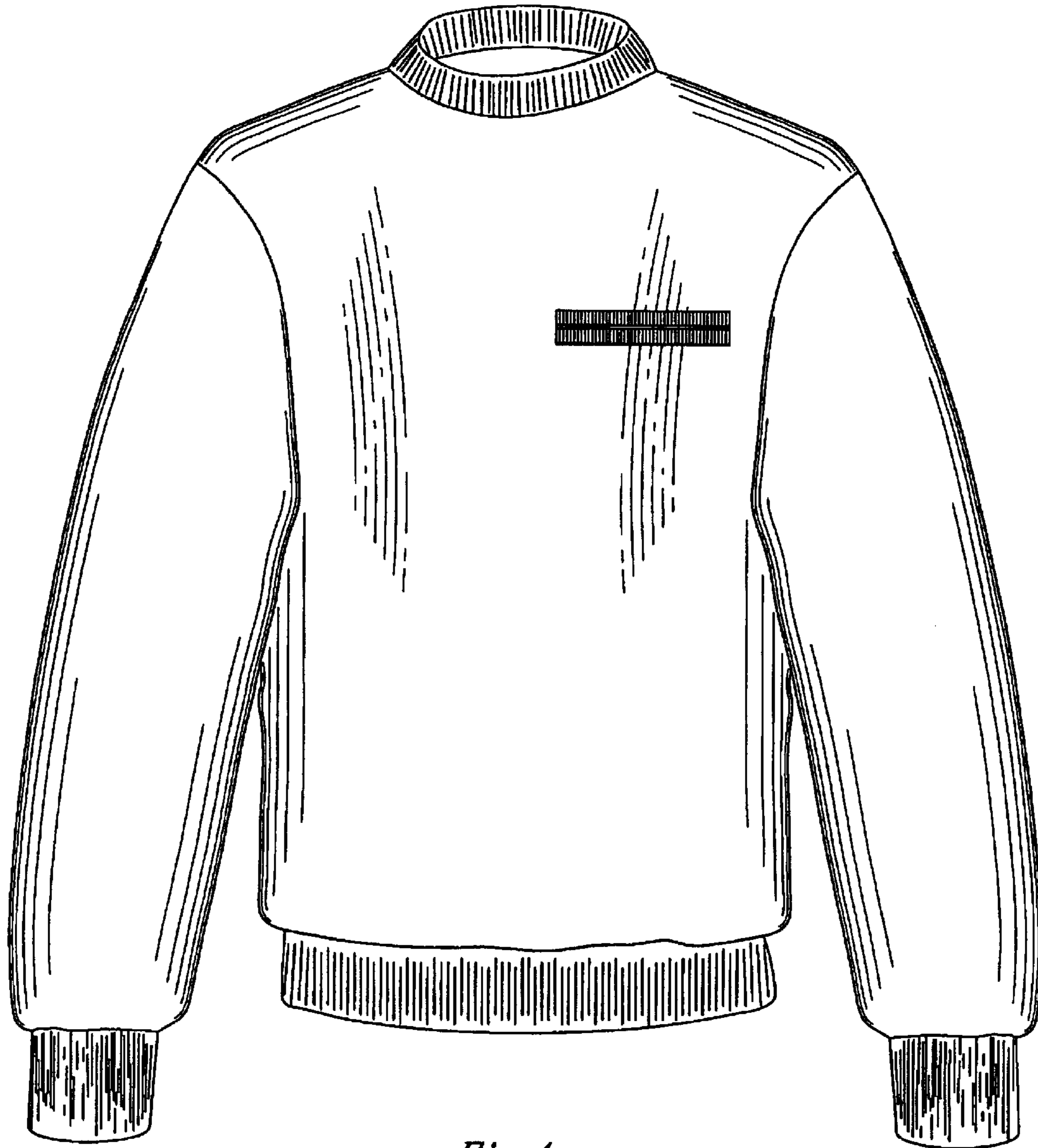
FIG. 1 is a front view of a pocketed sweatshirt showing our

FIG. 2 is a rear view thereof; and,

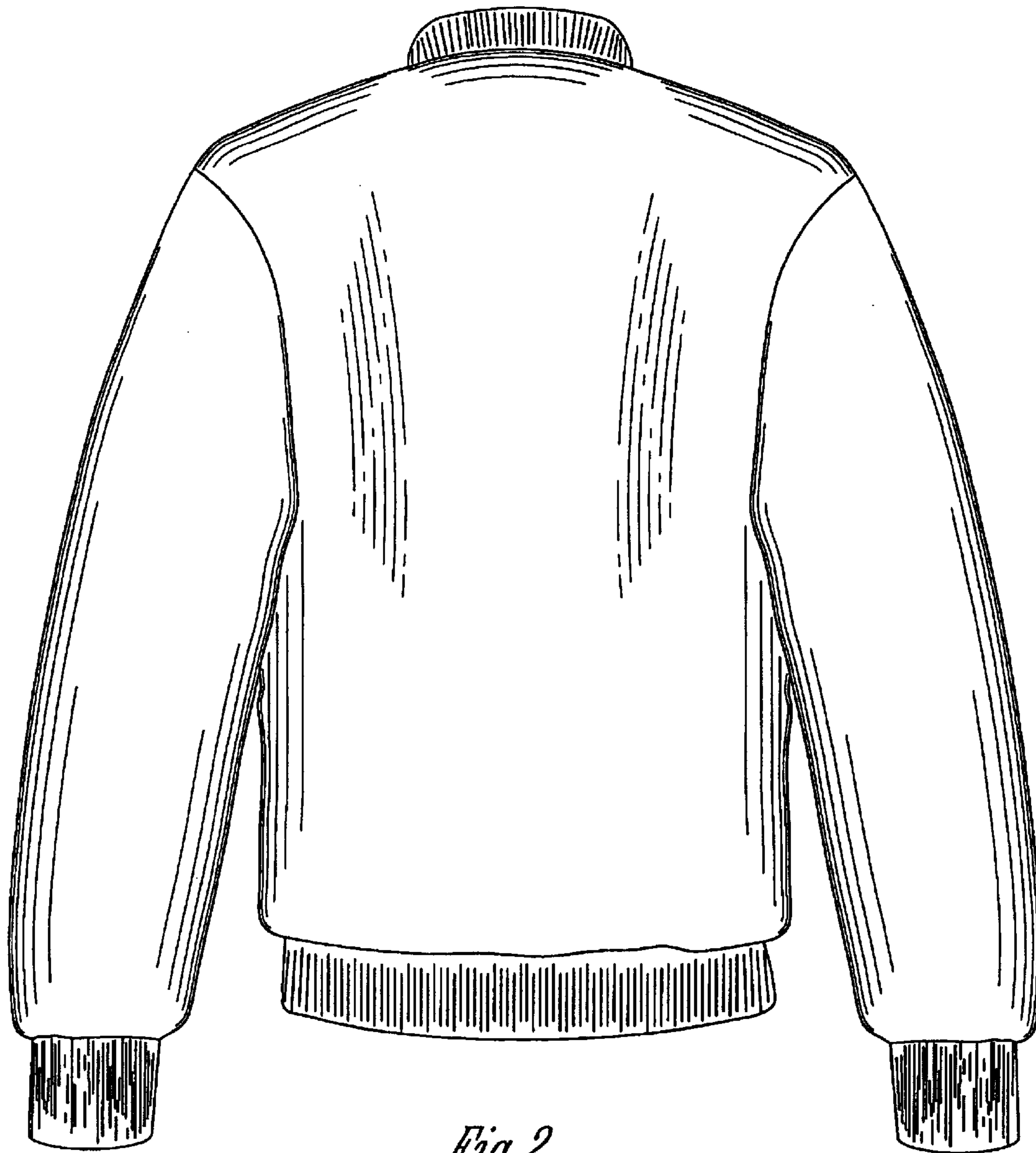
FIG. 3 is an enlarged fragmentary front view of the pocket

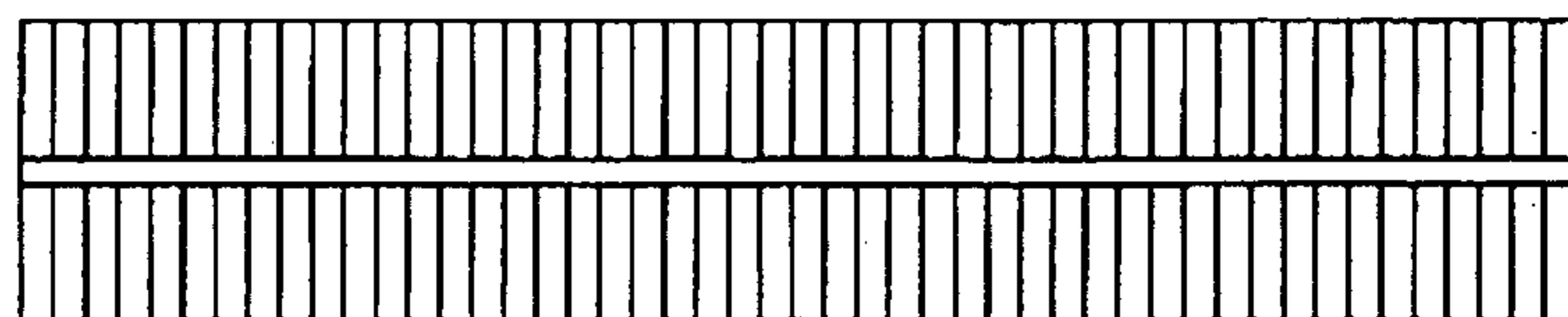
