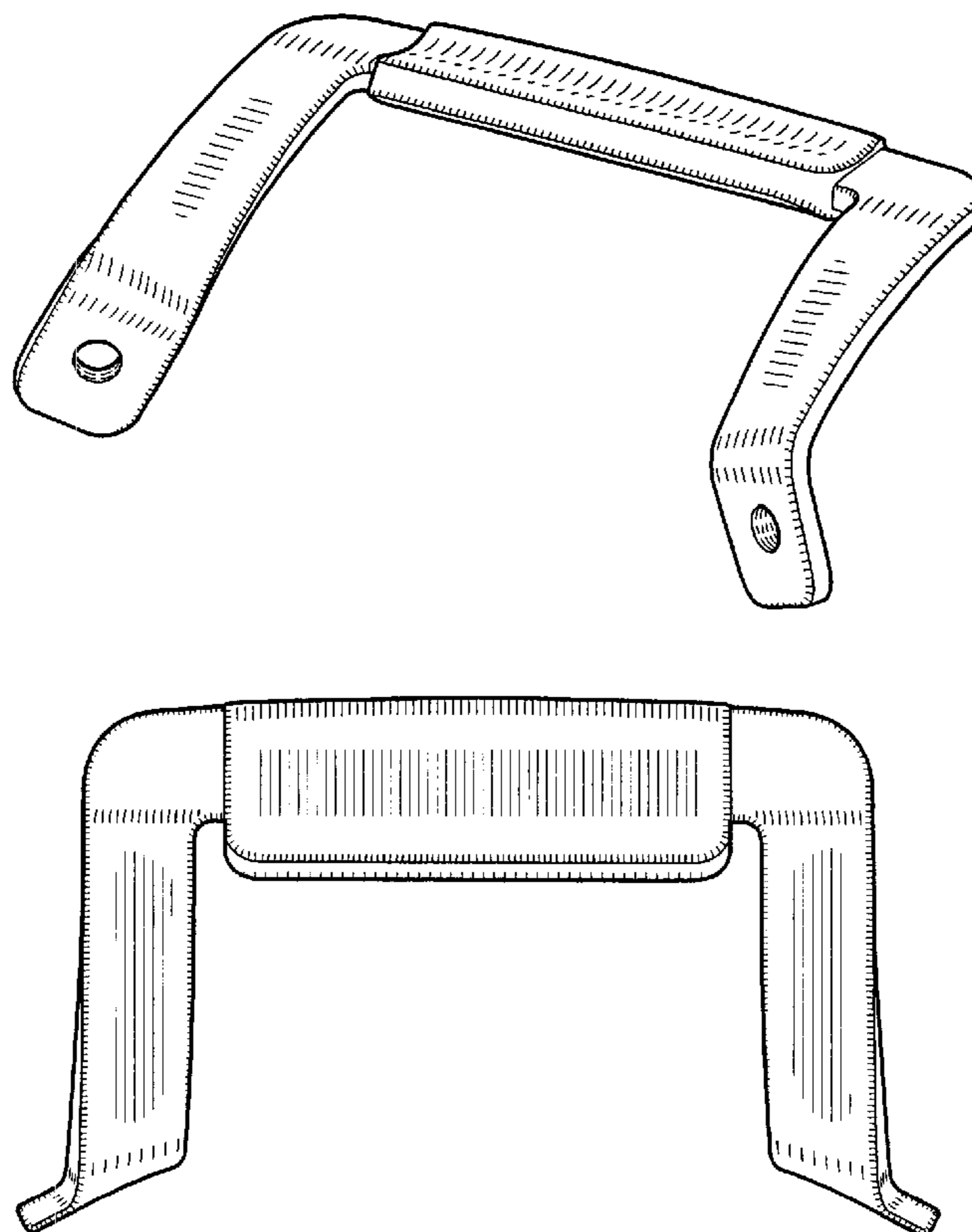
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a perspective view of a side handle showing my new design;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a side elevational view, the opposite side being a mirror image thereof;  
FIG. 5 is front elevational view thereof; and,

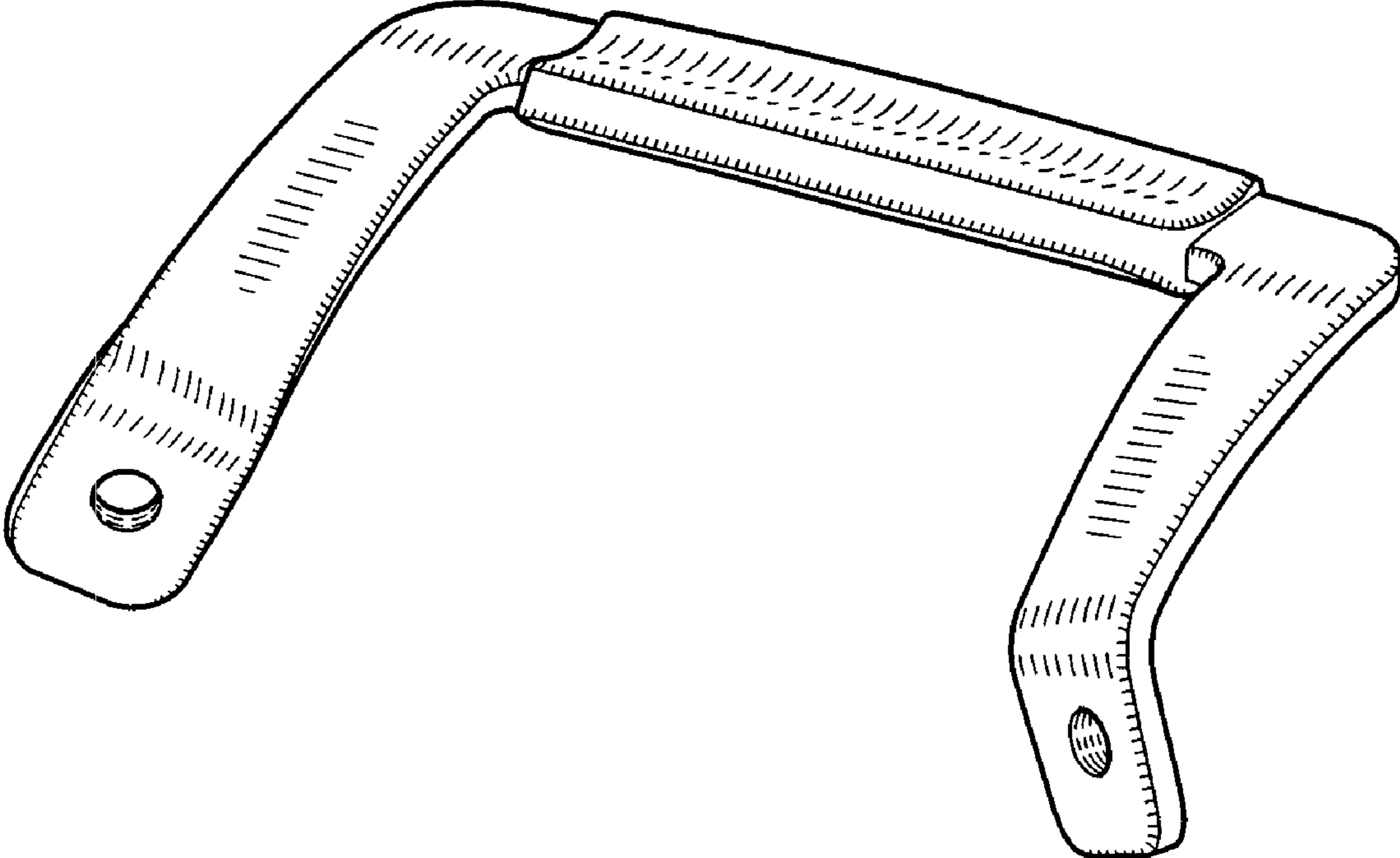

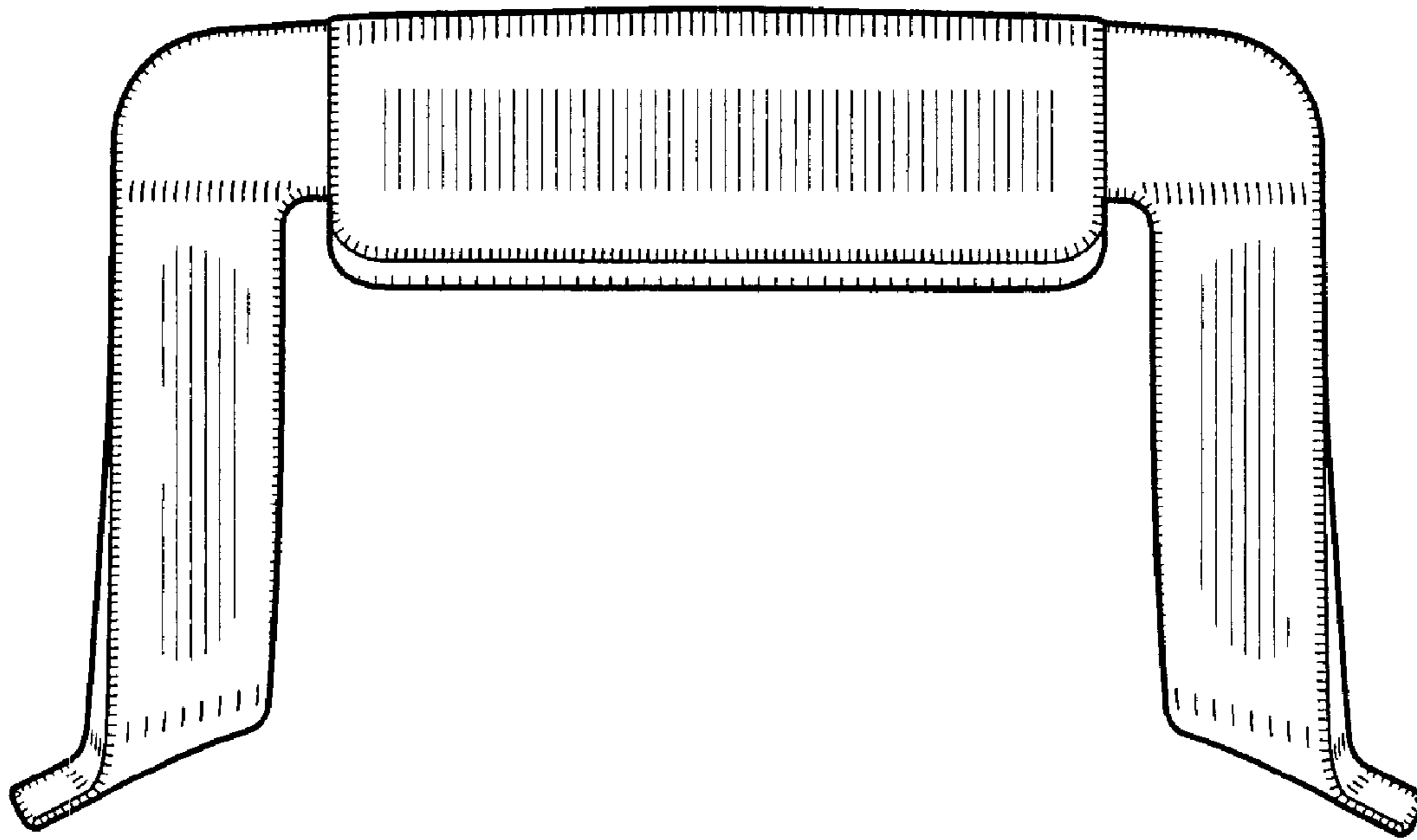

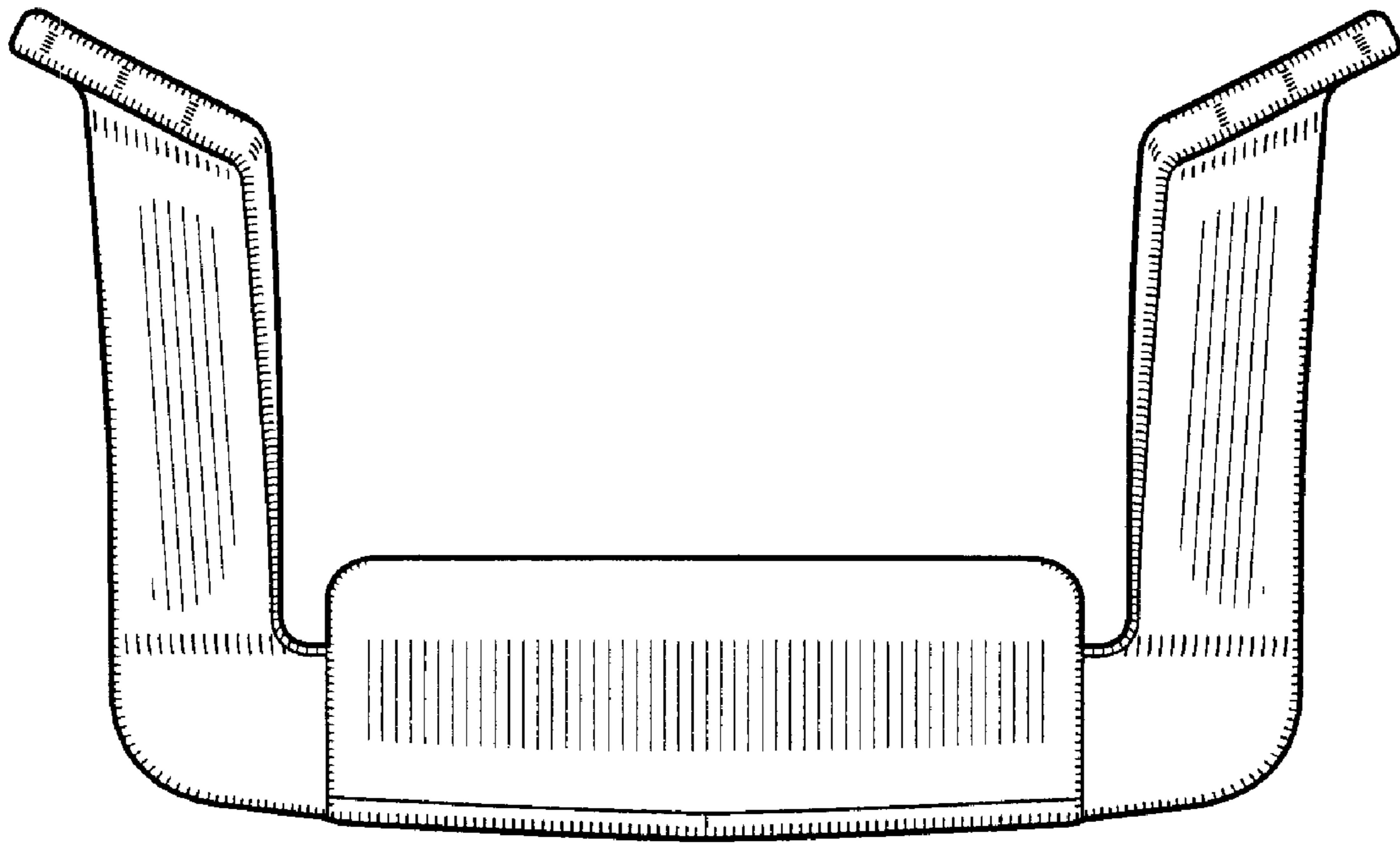
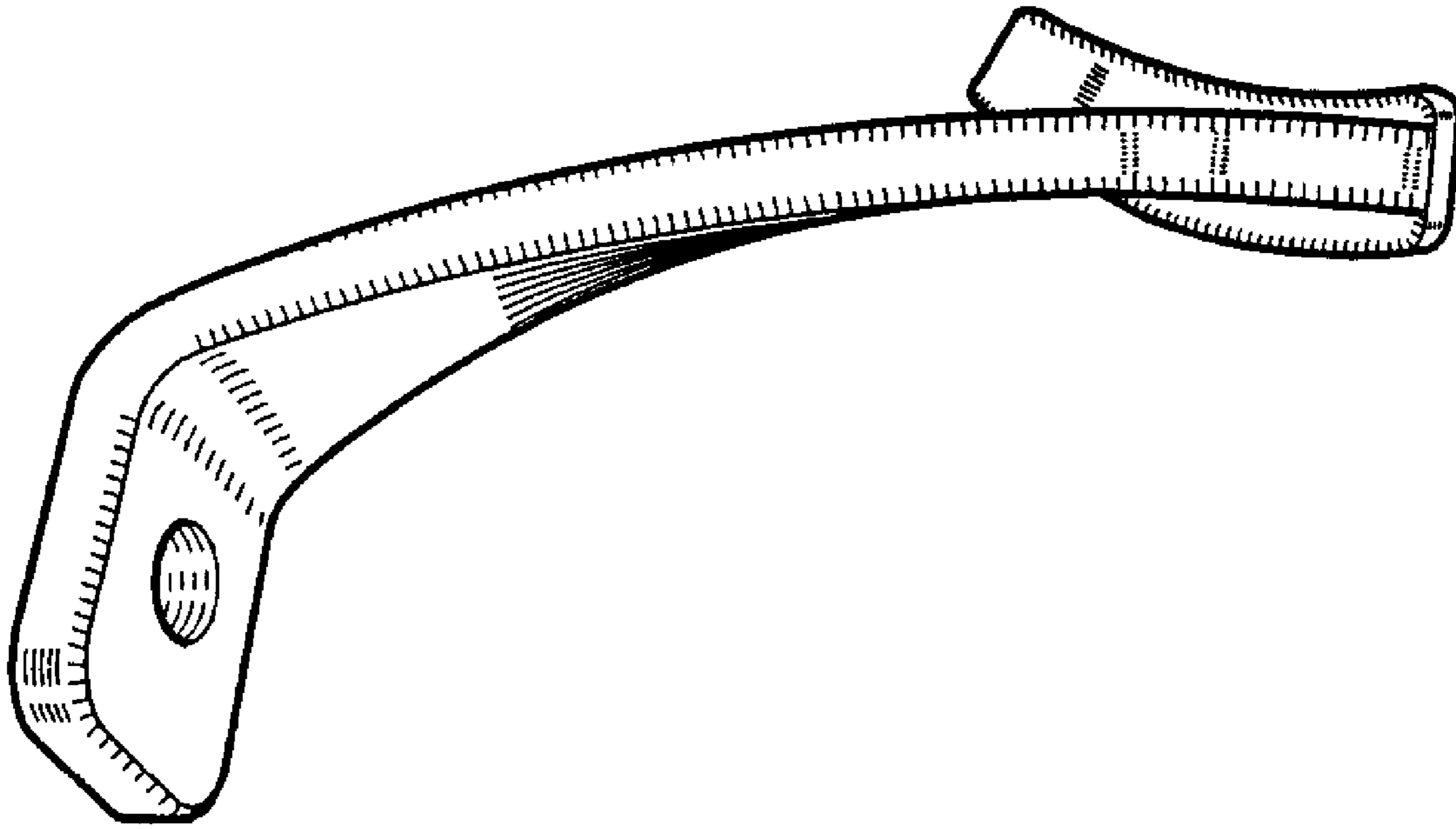
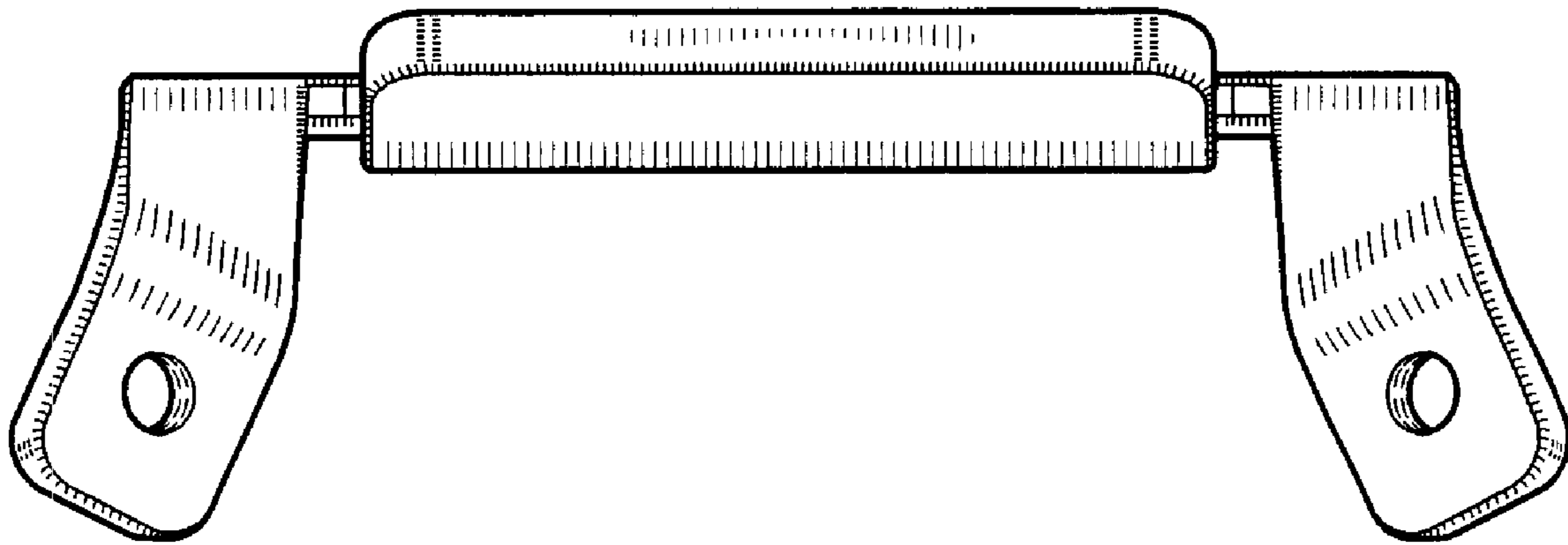

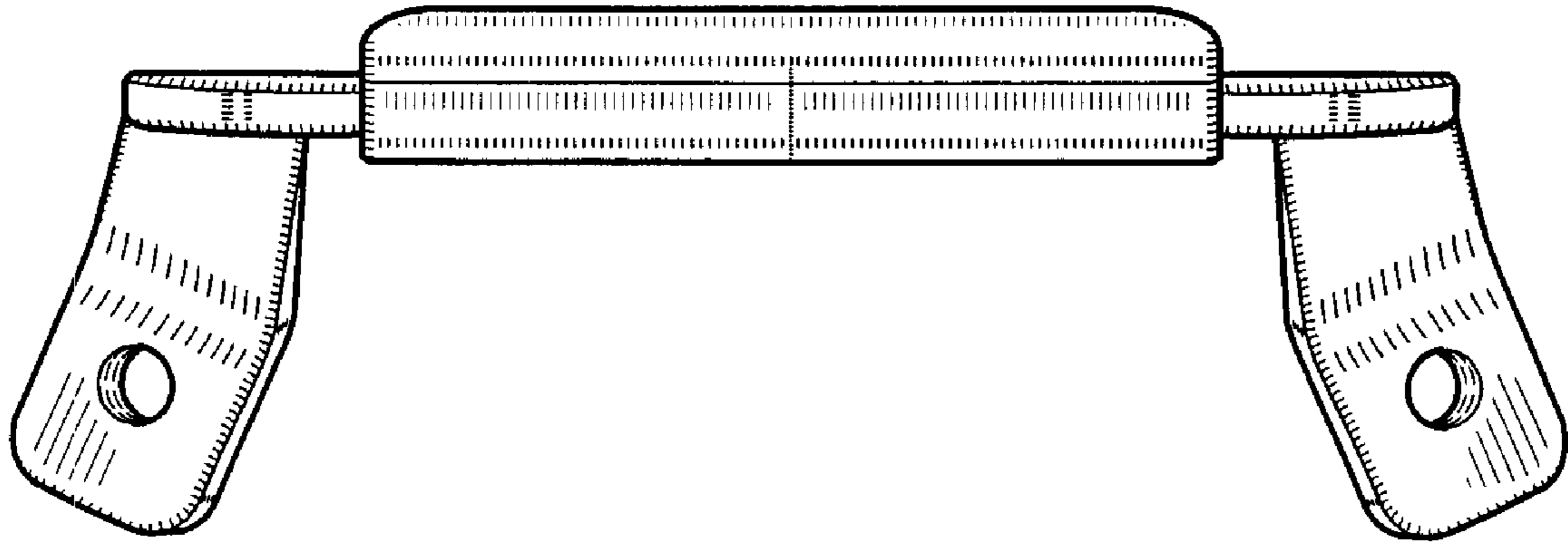
