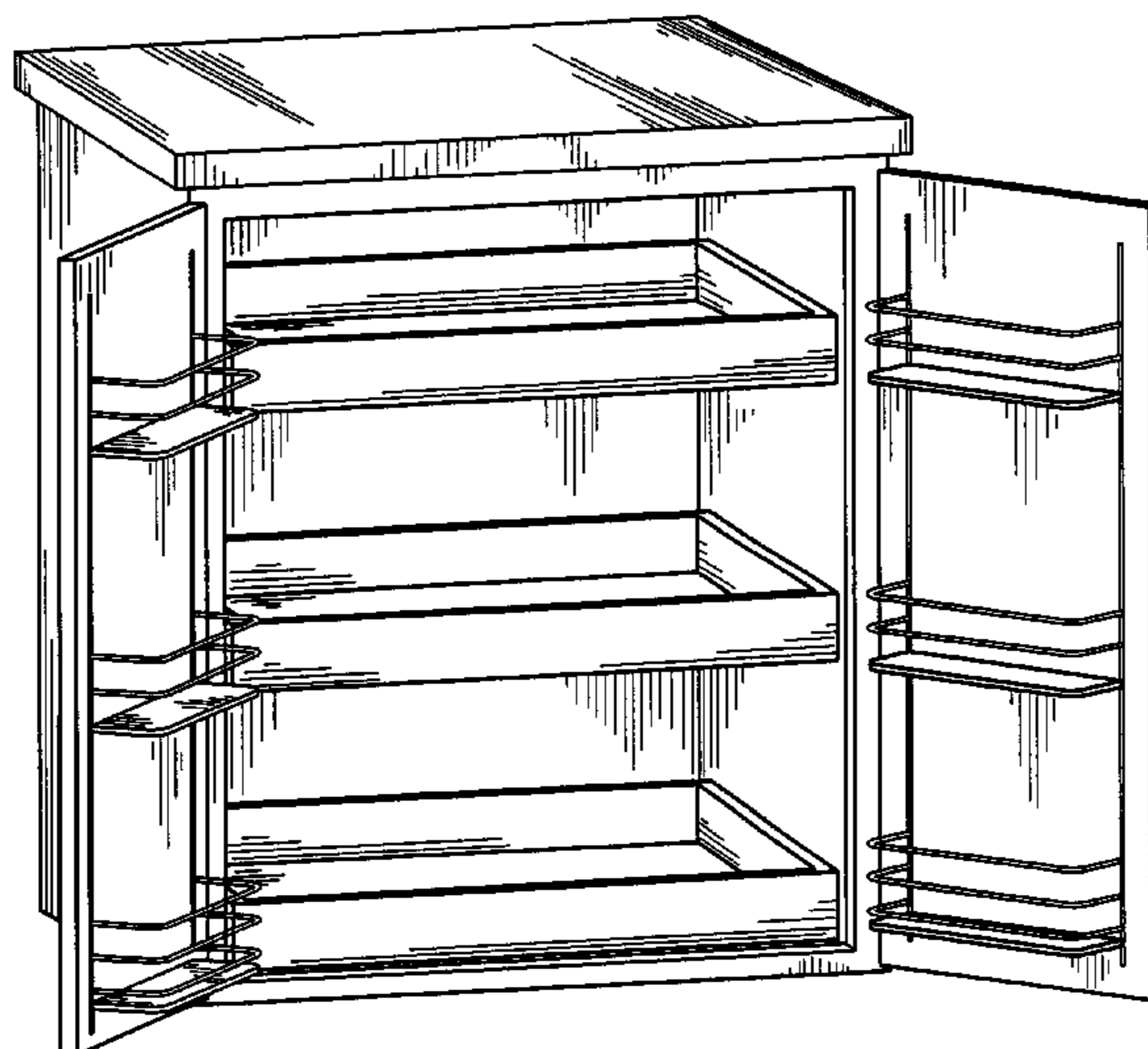
(57) **CLAIM**

We claim the ornamental design for a cabinet, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cabinet of the new design; FIG. 2 is a side view of the cabinet of FIG. 1, the other side view being a mirror image; FIG. 3 is a front view of the cabinet of FIG. 1; FIG. 4 is a back view of the cabinet of FIG. 1; FIG. 5 is a top view of the cabinet of FIG. 1; FIG. 6 is a bottom view of the cabinet of FIG. 1; and, FIG. 7 is a perspective view of the cabinet of FIG. 1, wherein the drawers are extended.

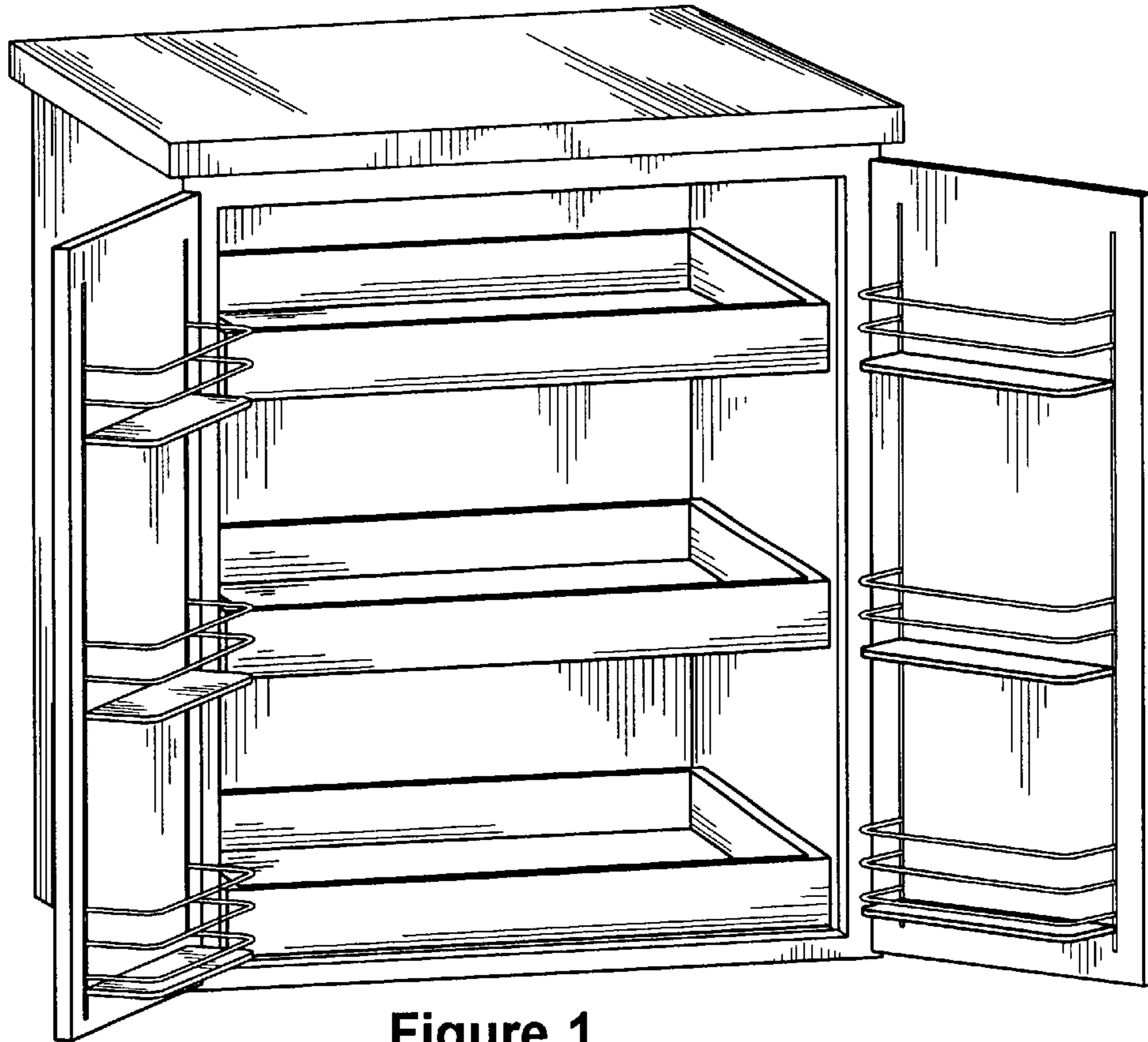

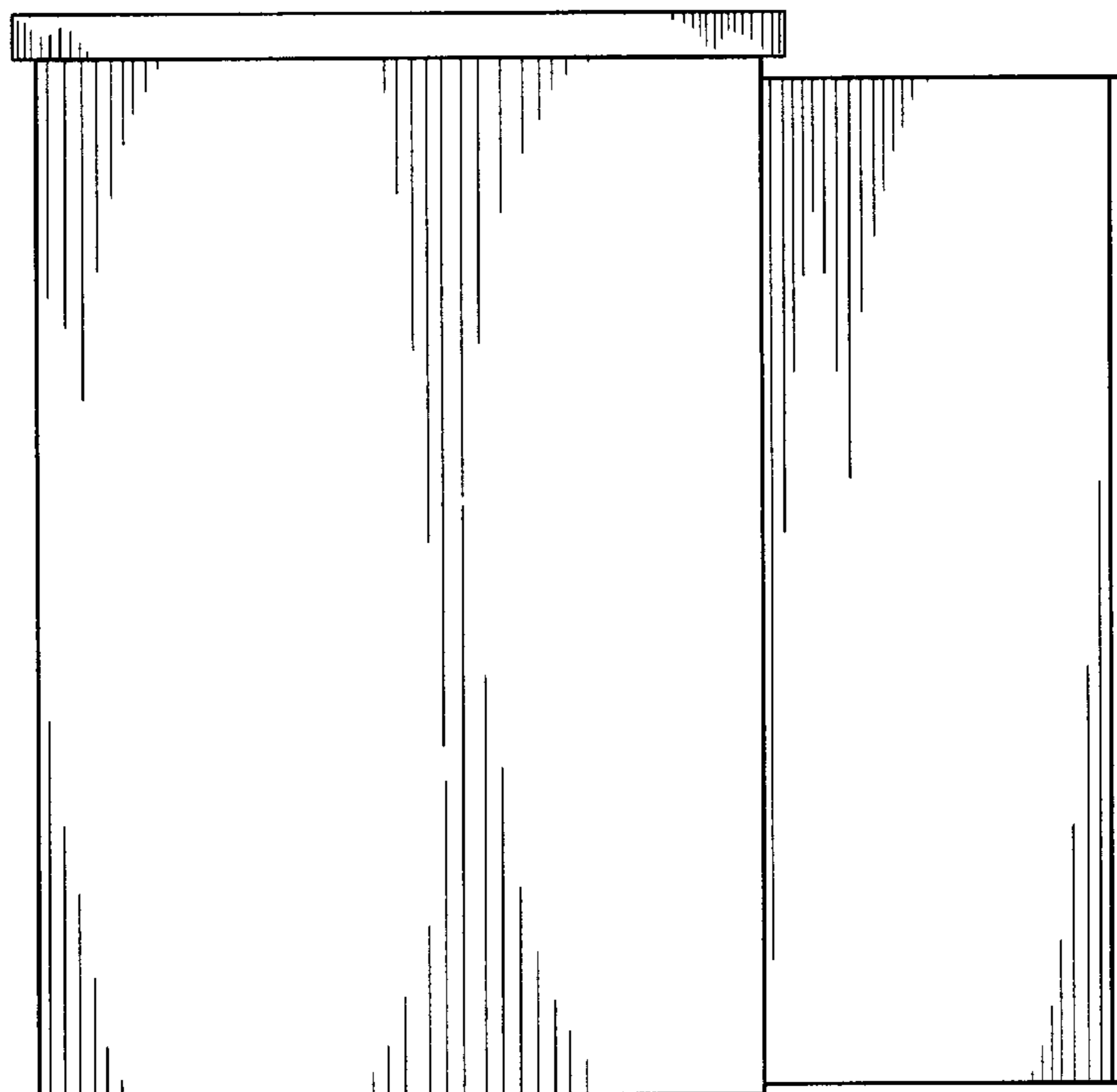

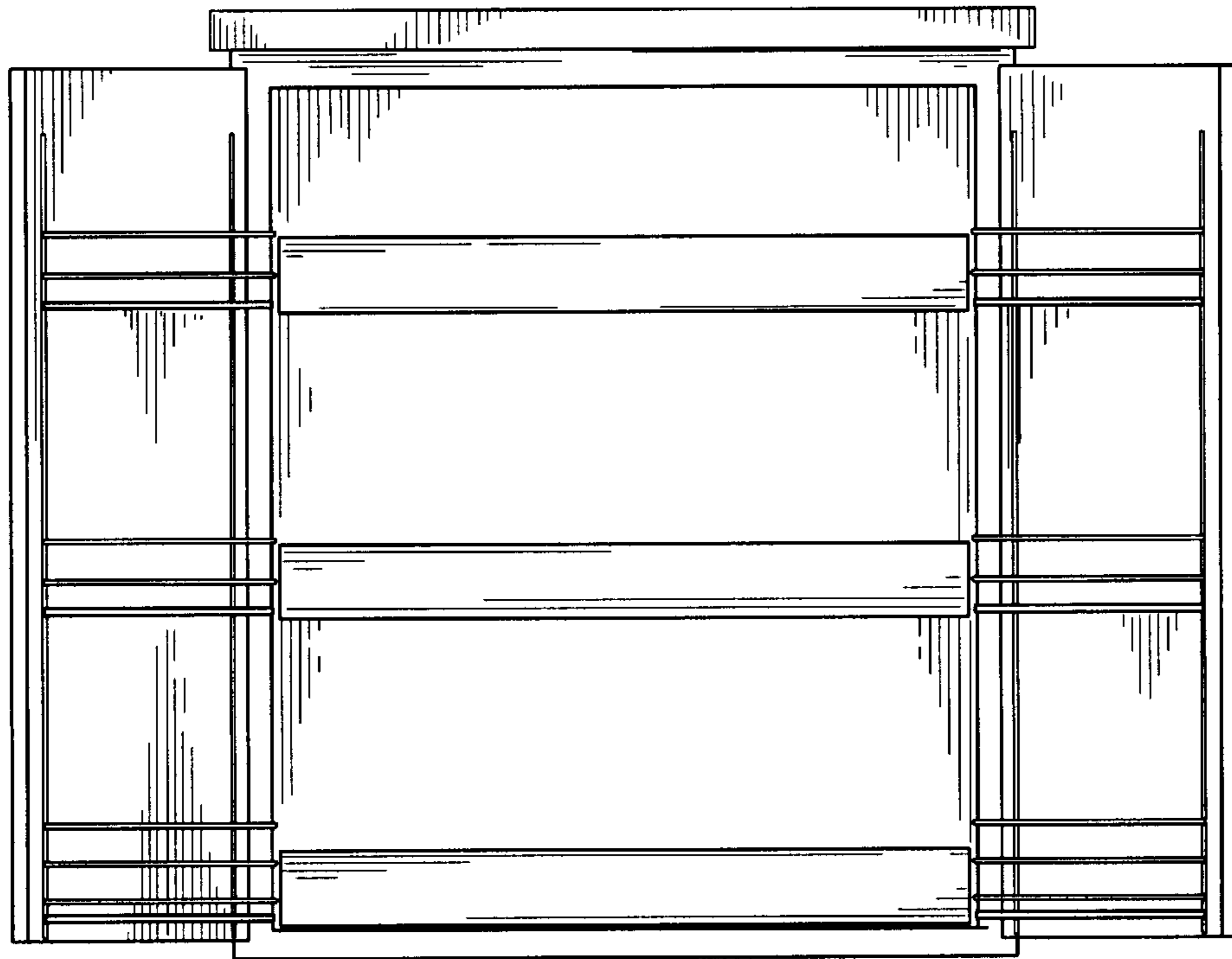

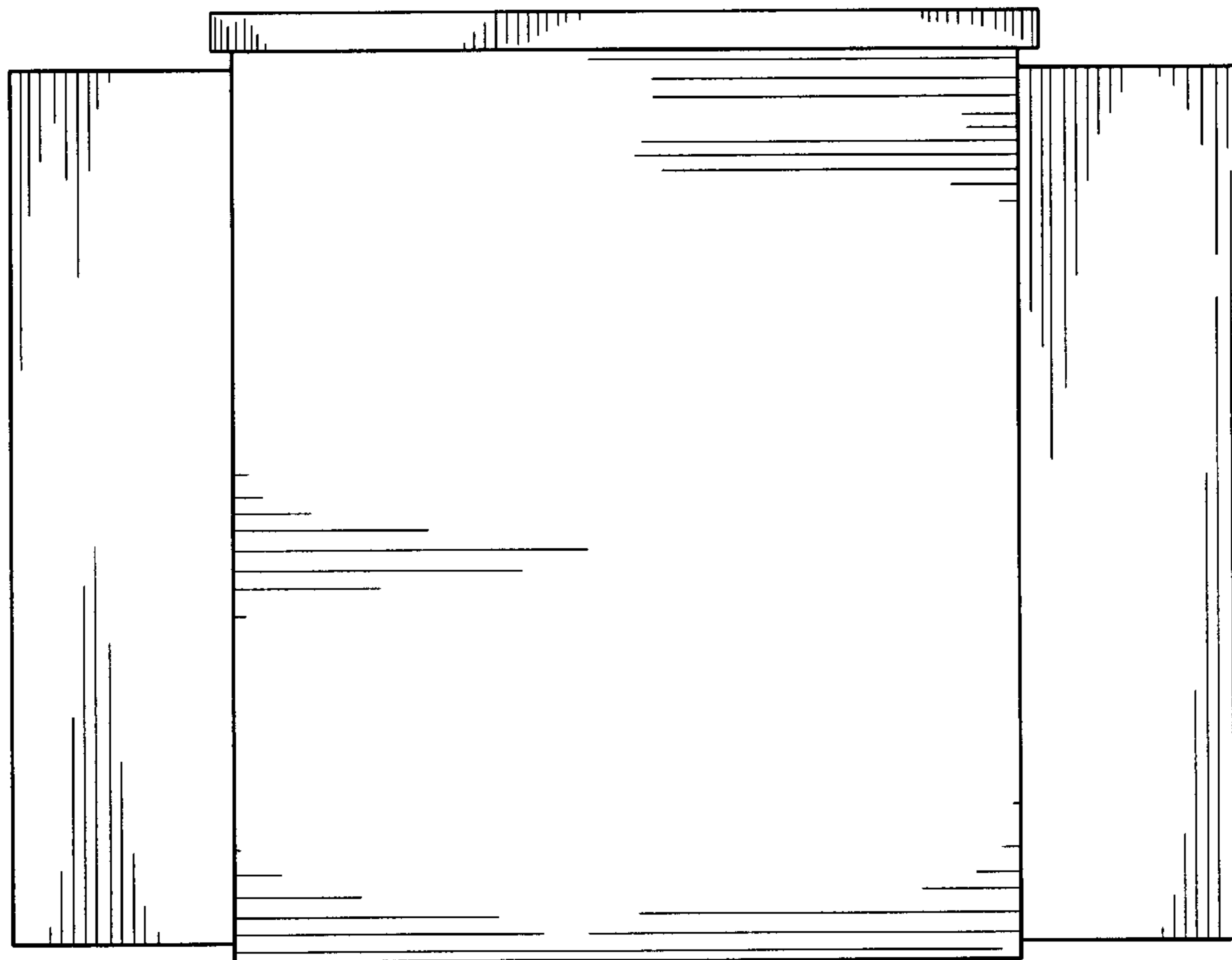

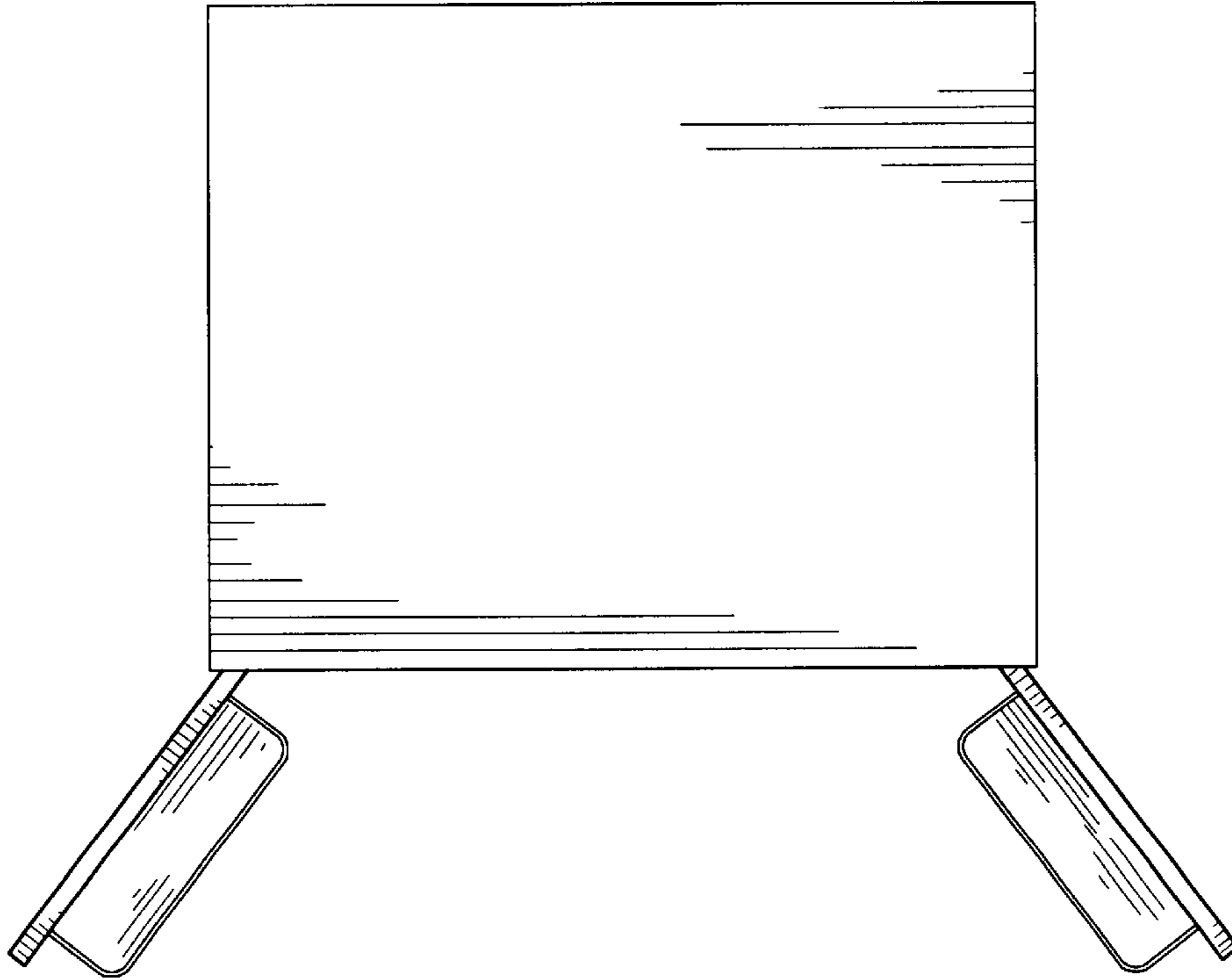

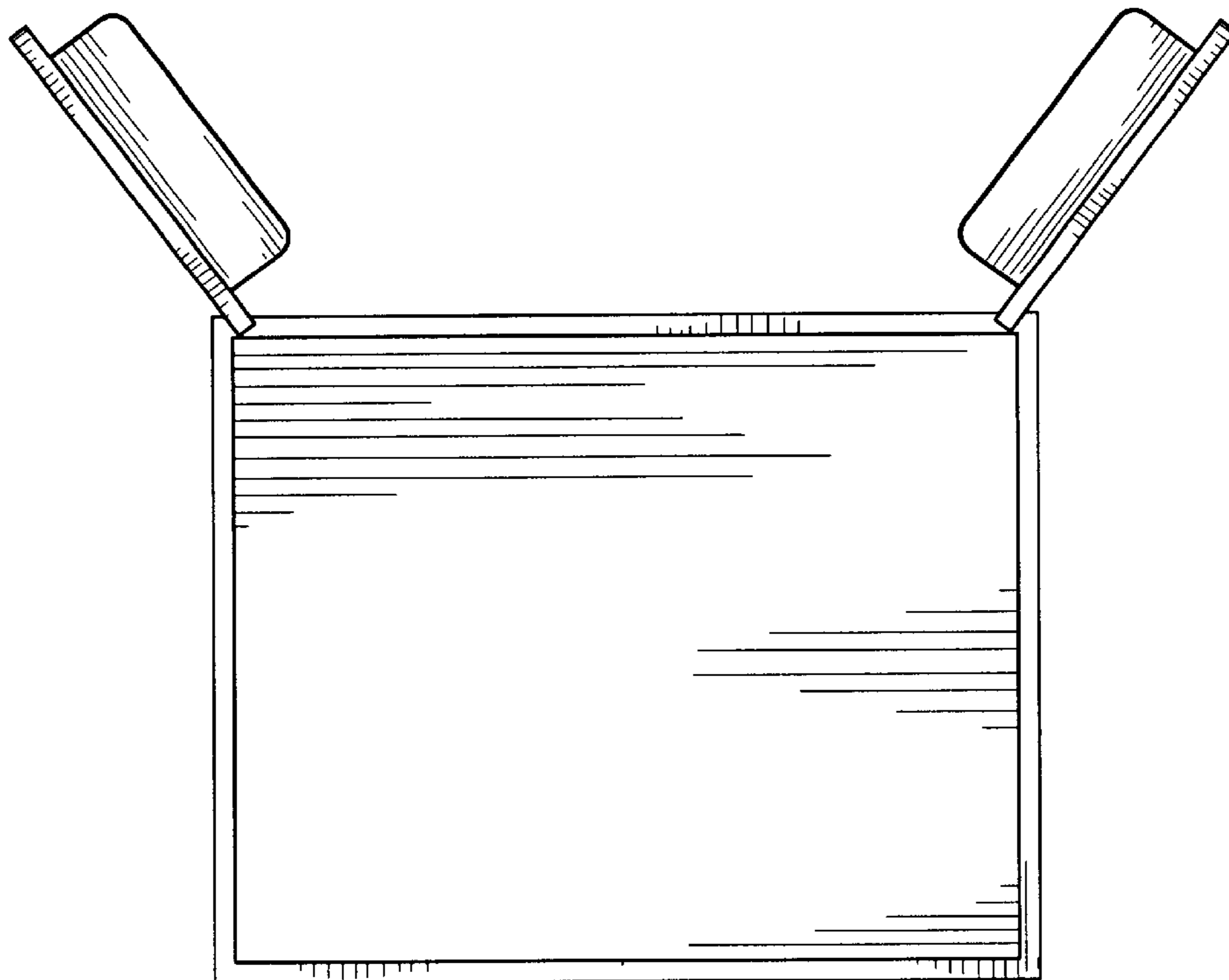

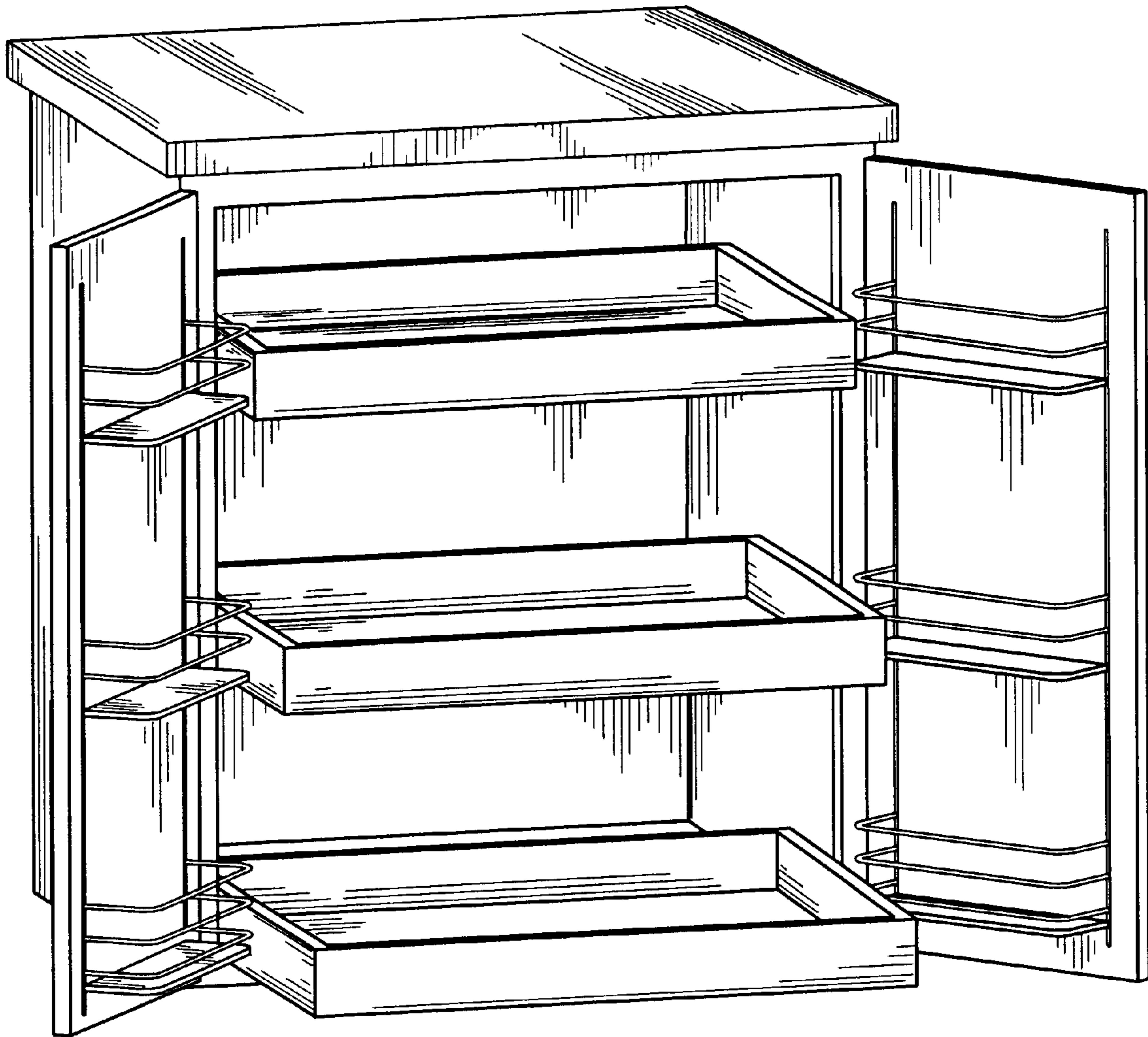
