FIG. 3 is a back elevation view thereof.

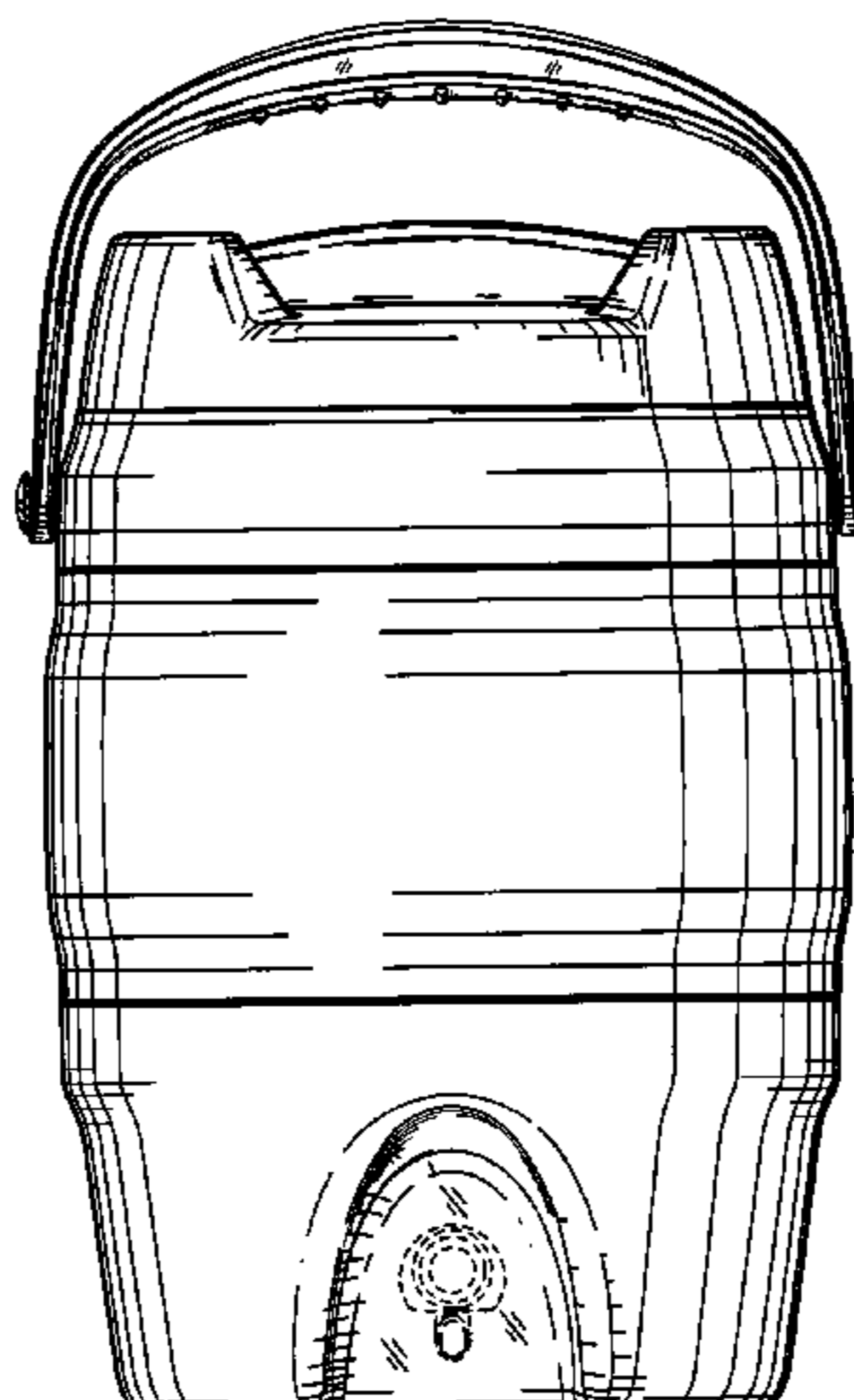
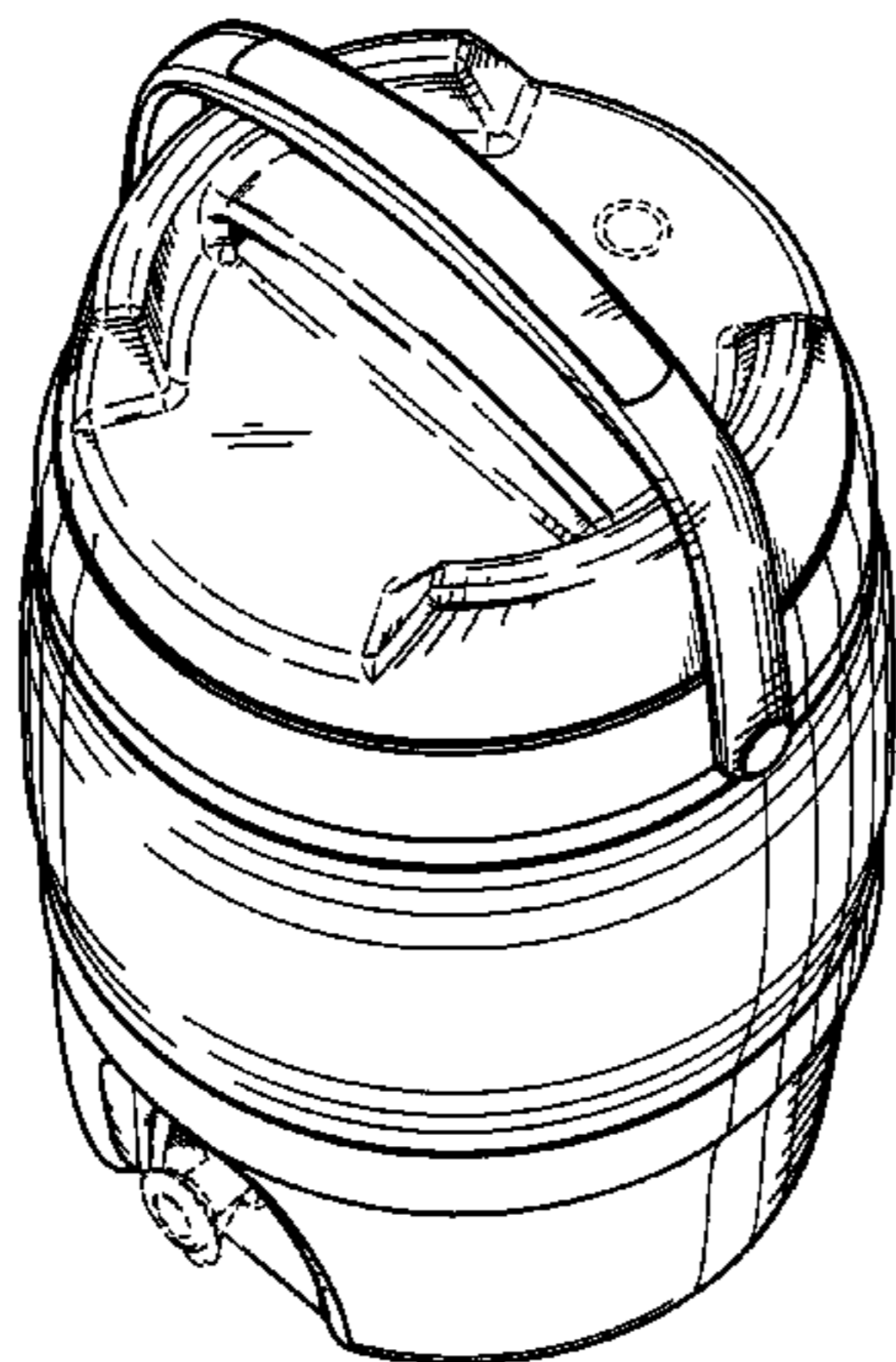
FIG. 4 is a right side elevation view thereof, the left side being a mirror image thereof.

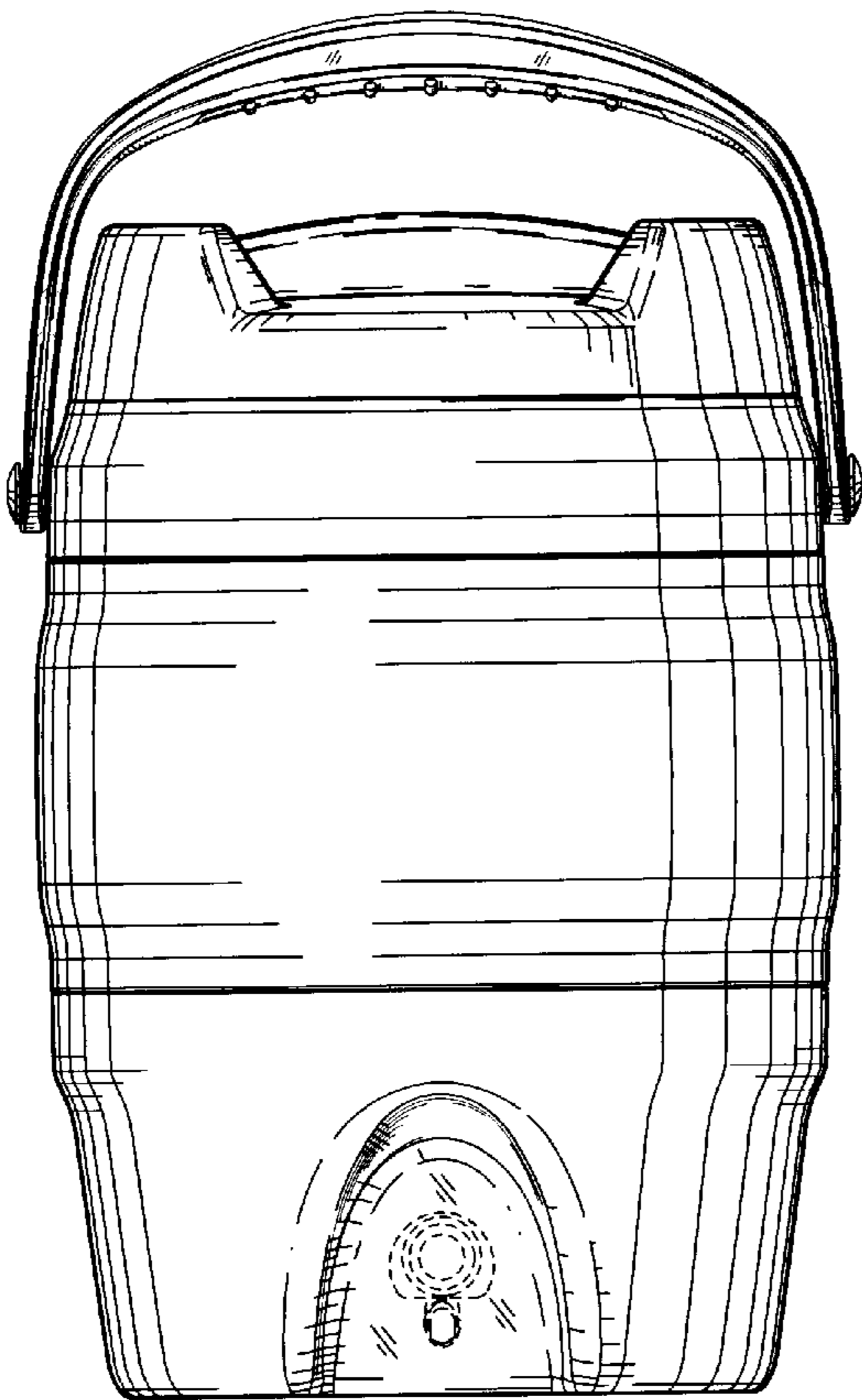
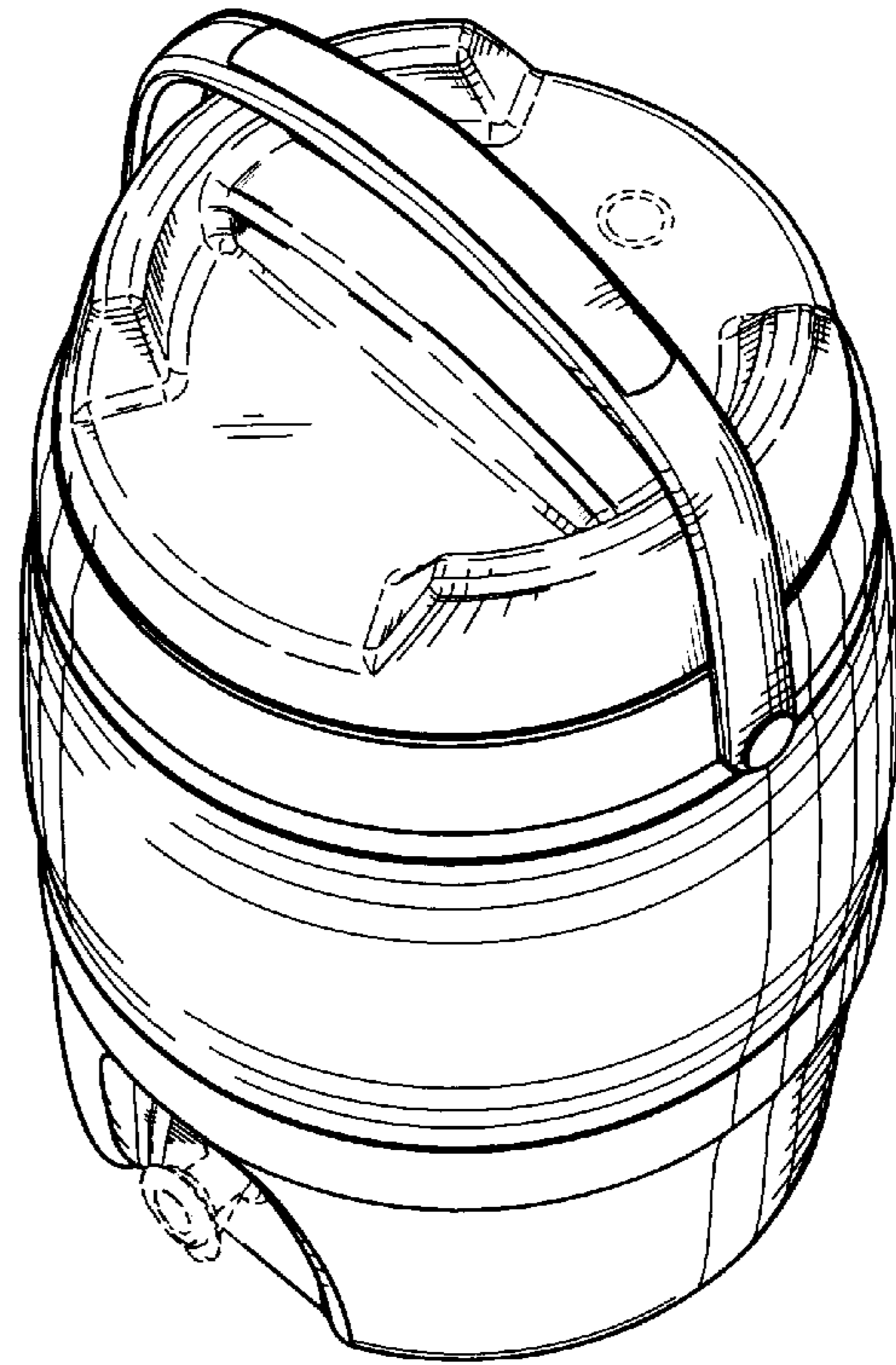

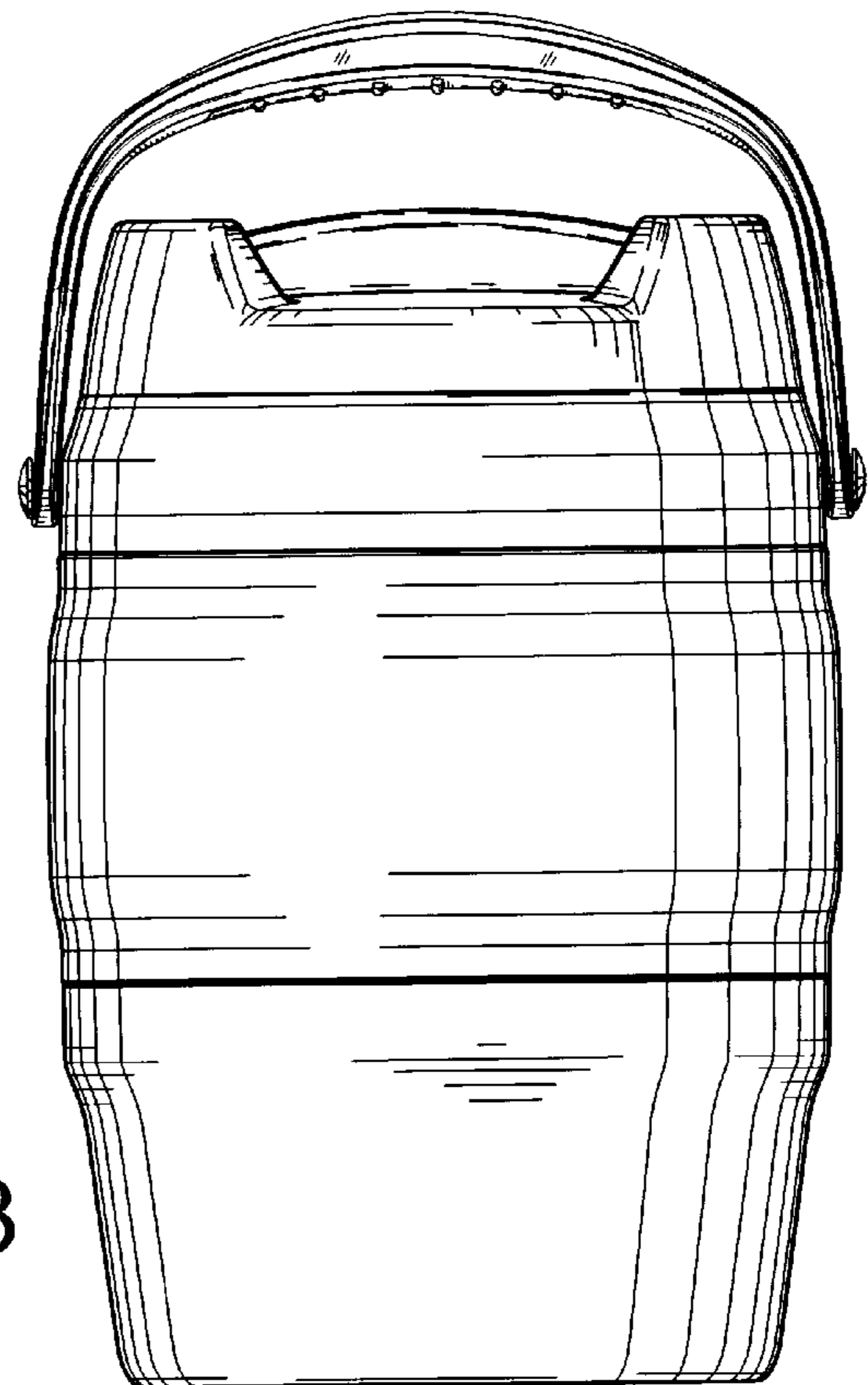

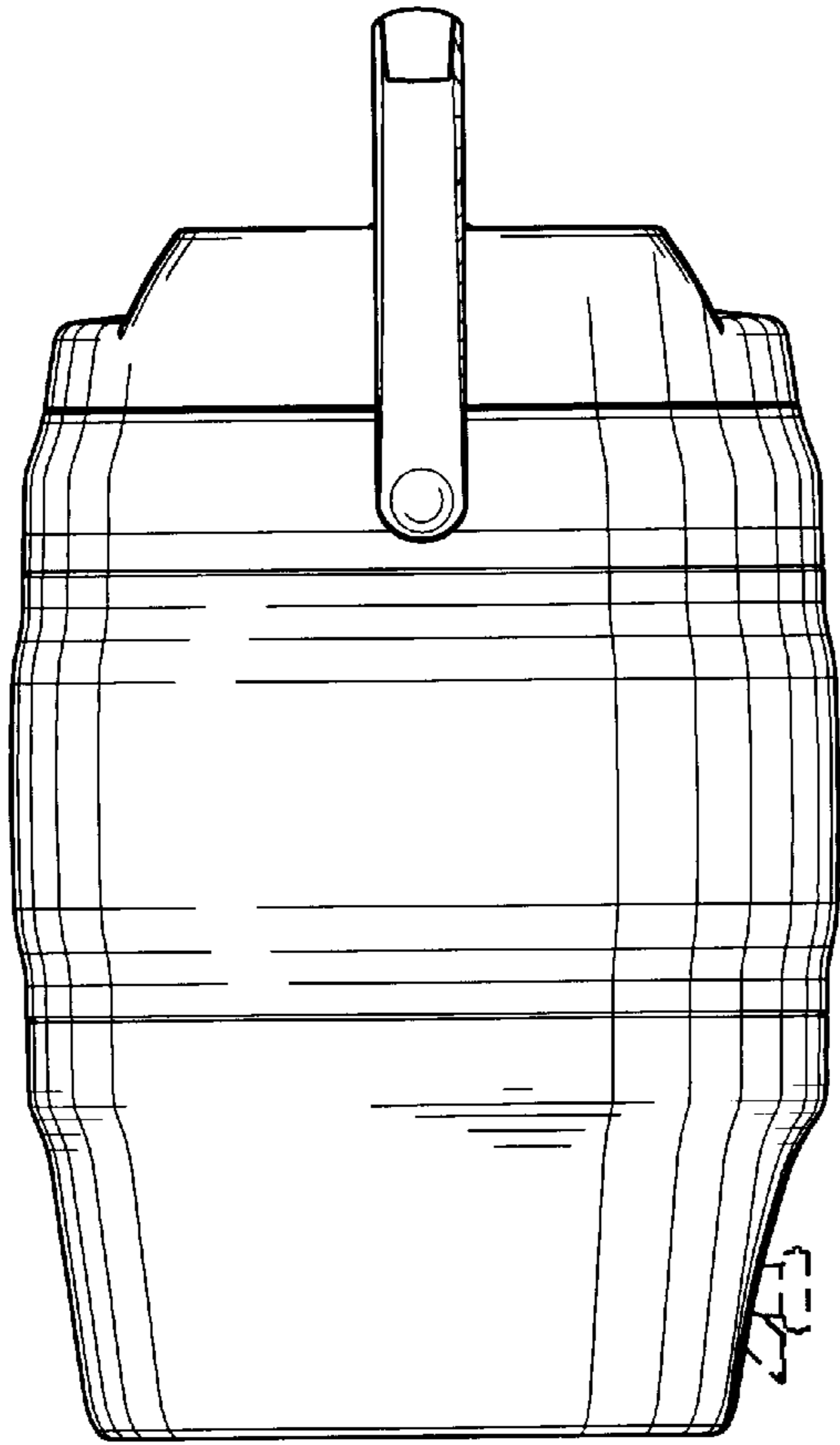

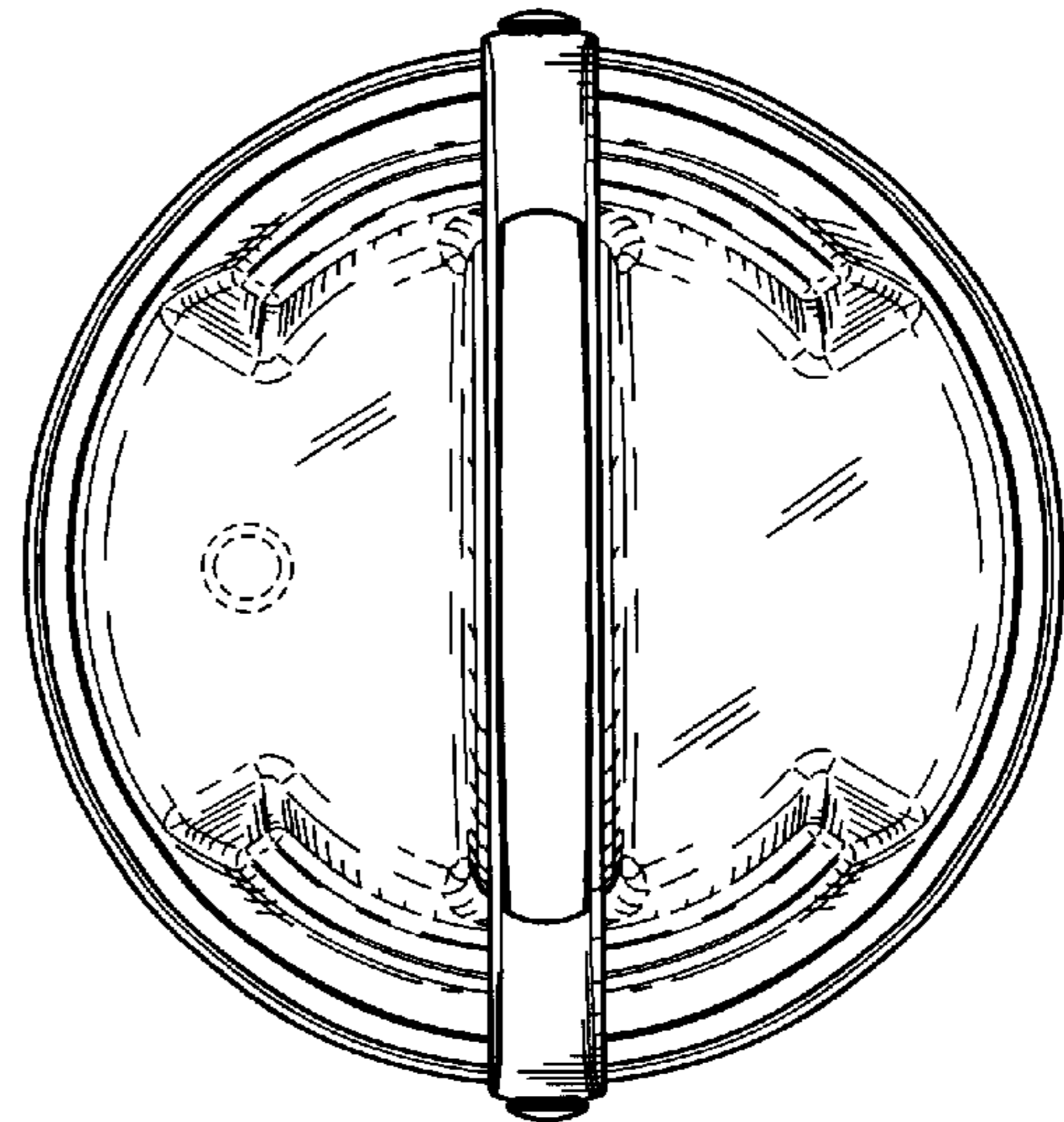

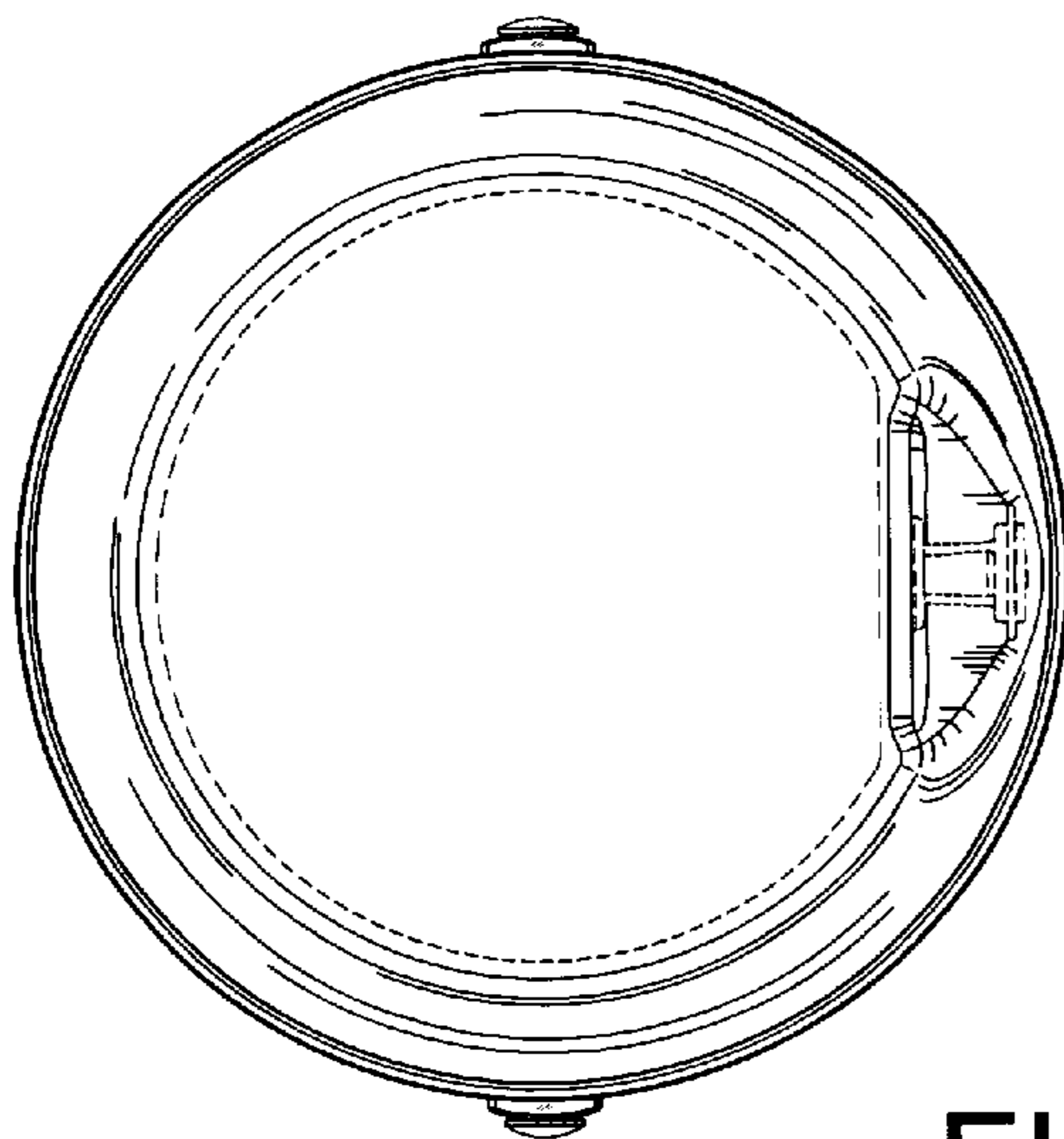
