**DESCRIPTION**

FIG. 1 is a top, front perspective view of a mug grip pattern  
made in accordance with my new design having all but the  
design shown in phantom lines;

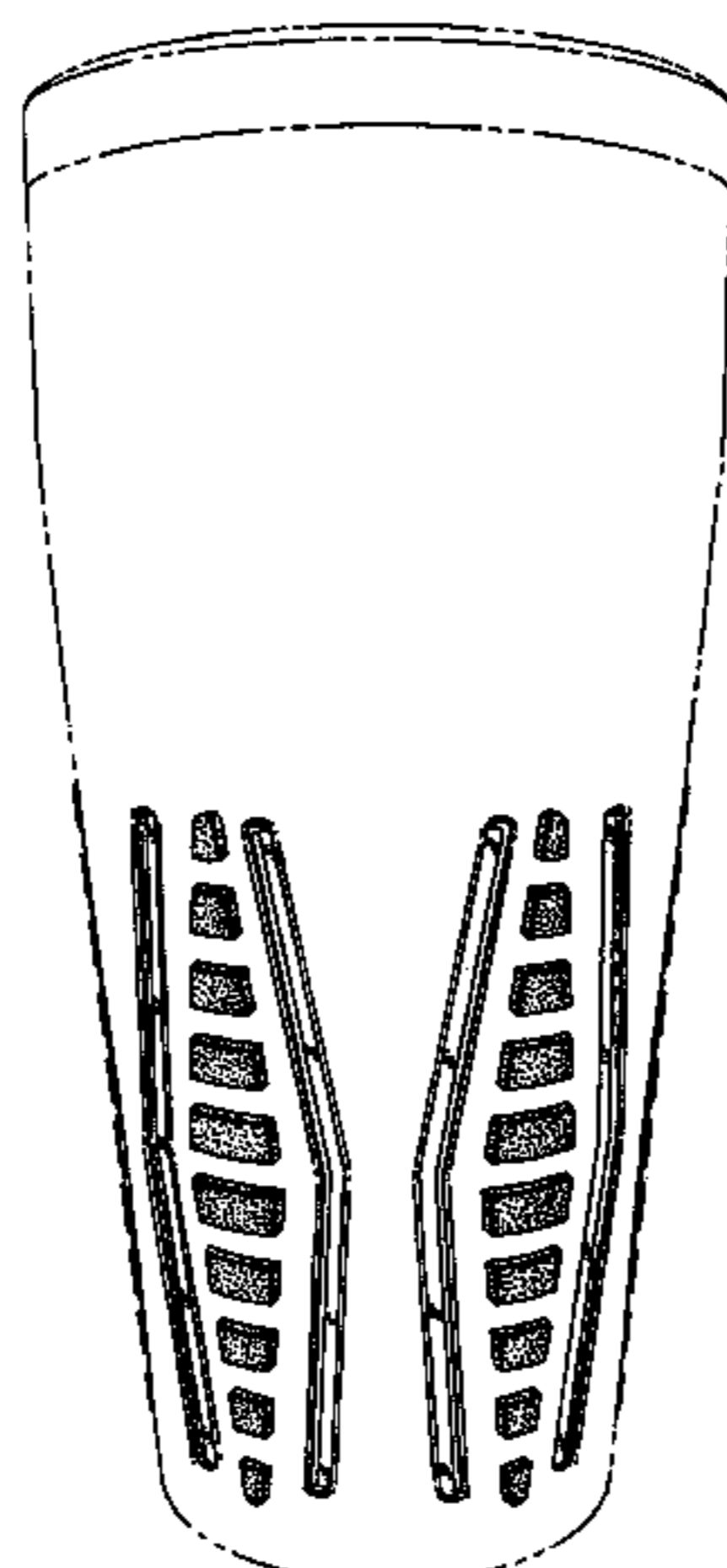
FIG. 2 is a front view of the embodiment of FIG. 1, with the  
back view being the mirror image of the front view having  
all but the design shown in phantom lines;

FIG. 3 is a left side view of the embodiment of FIG. 1, with

FIG. 4 is a bottom plan view thereof.

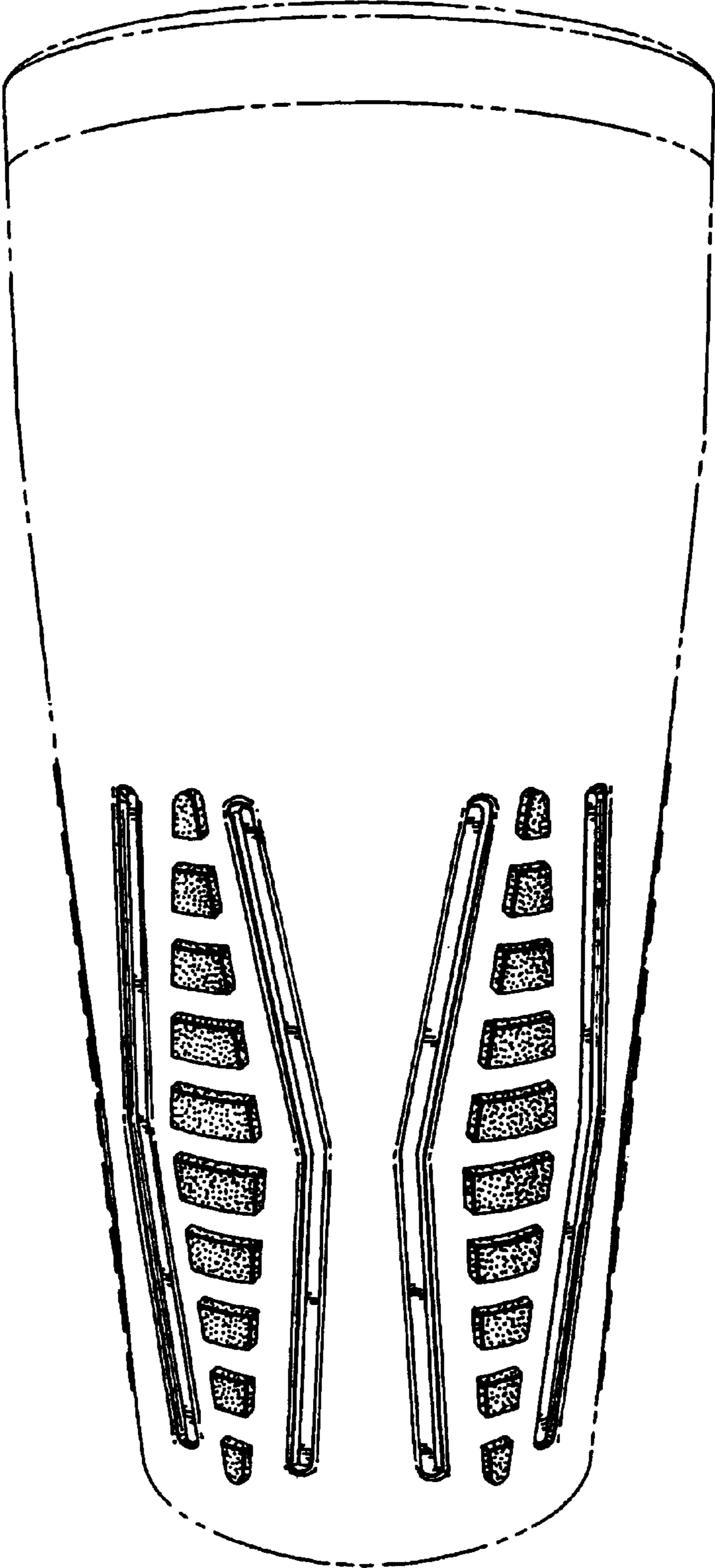

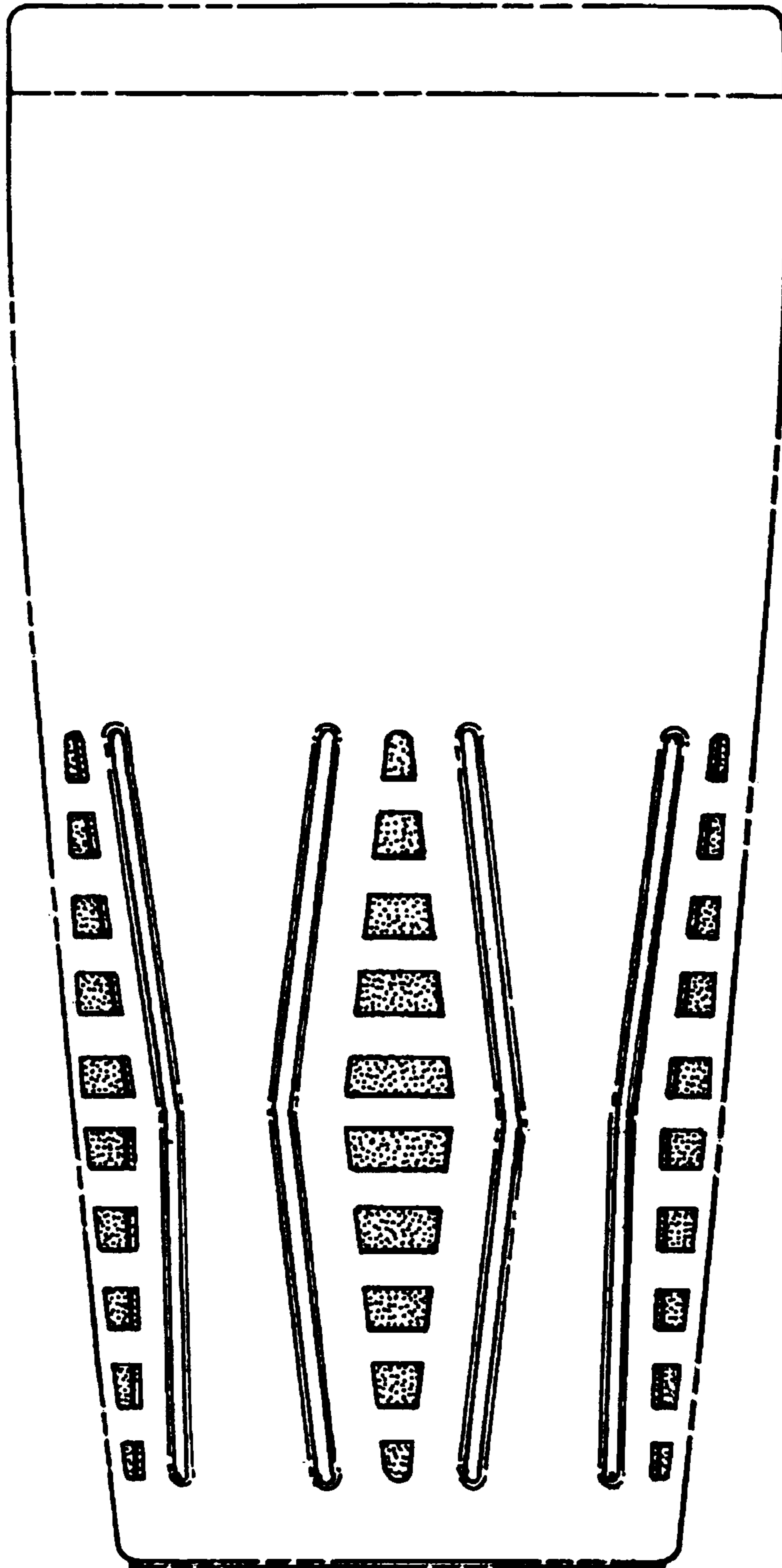

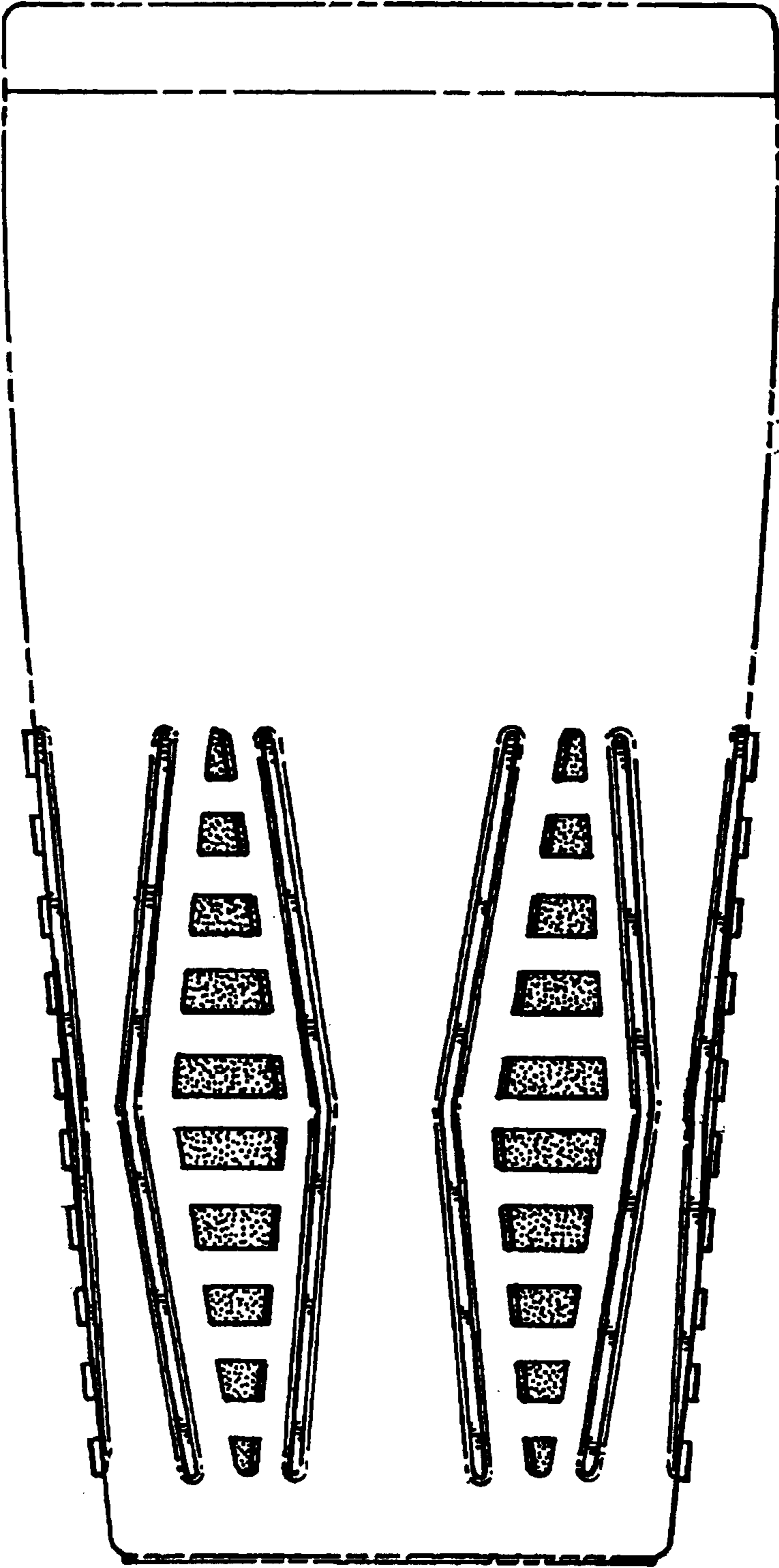
