FIG. 10 is a right side elevational view thereof.

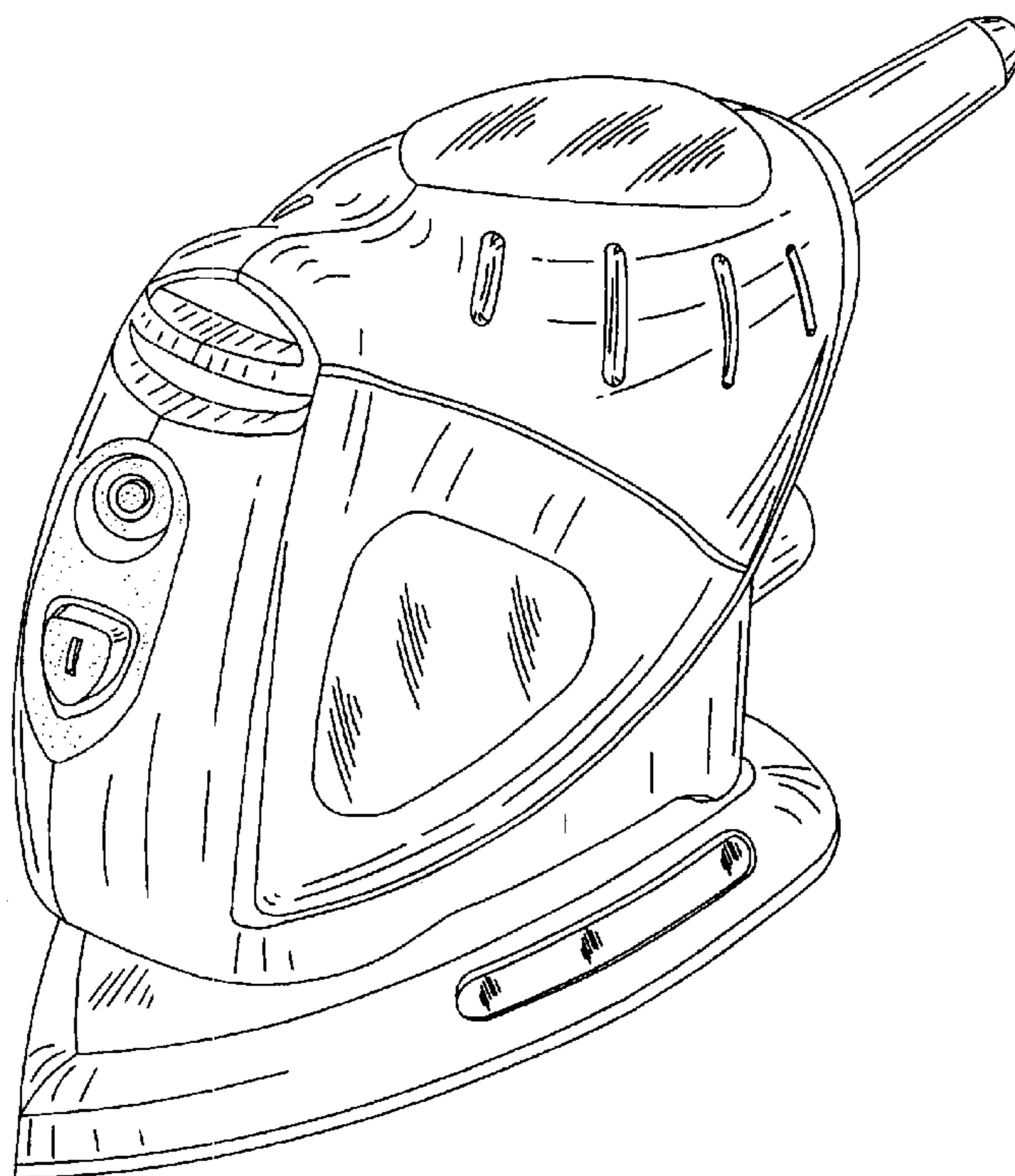
FIG. 11 is a front view thereof.

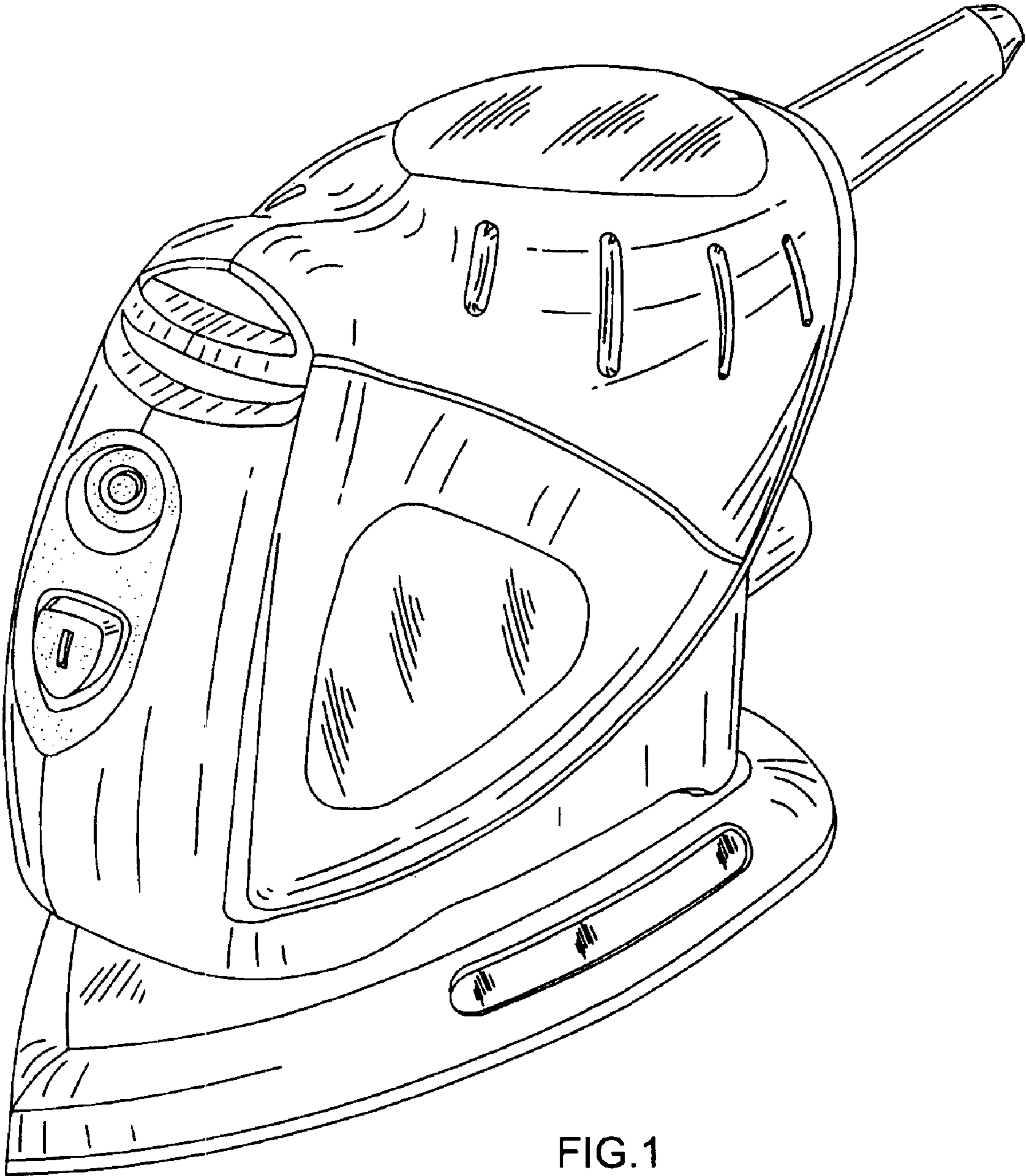
FIG. 12 is a rear view thereof.

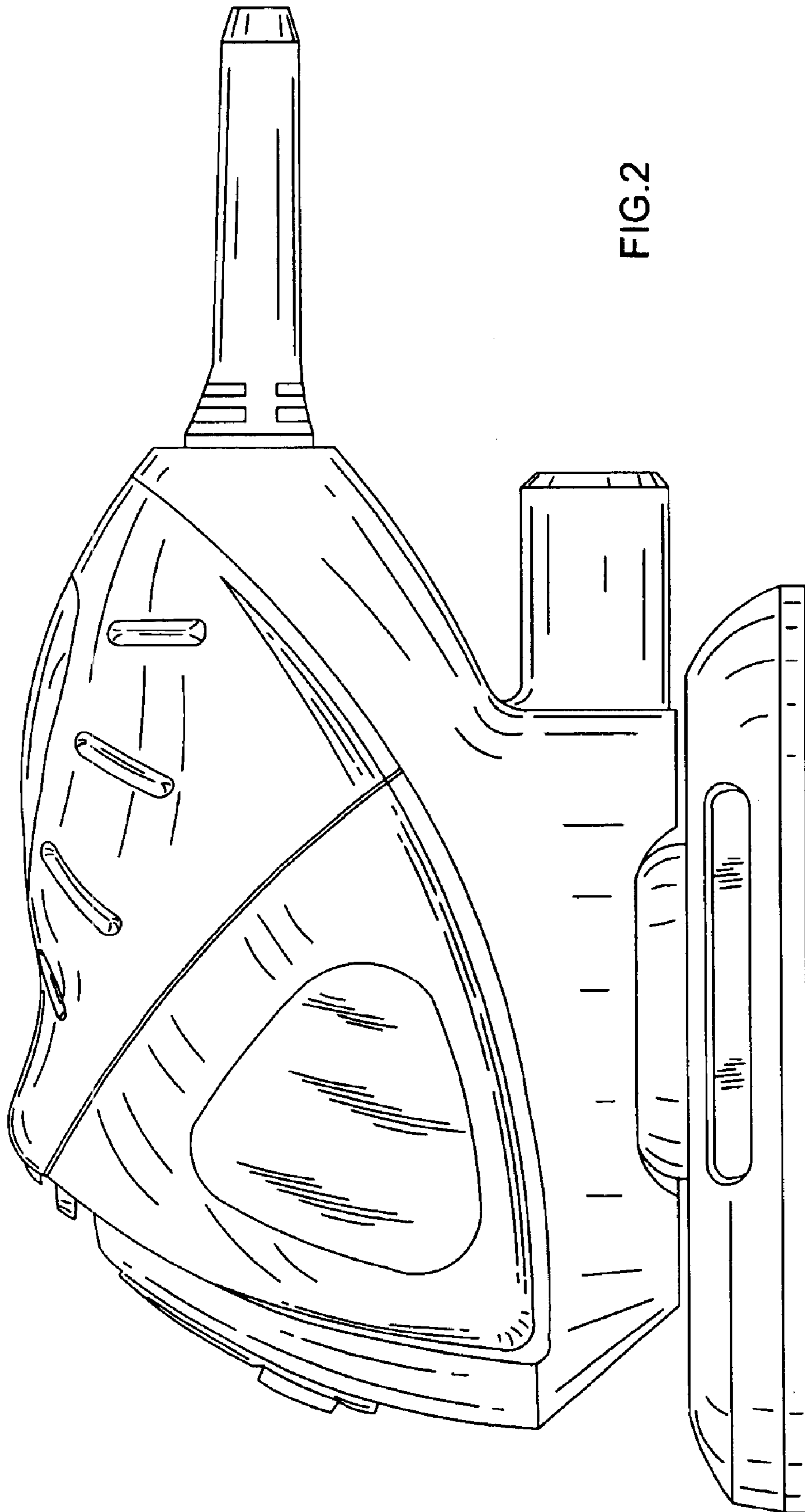

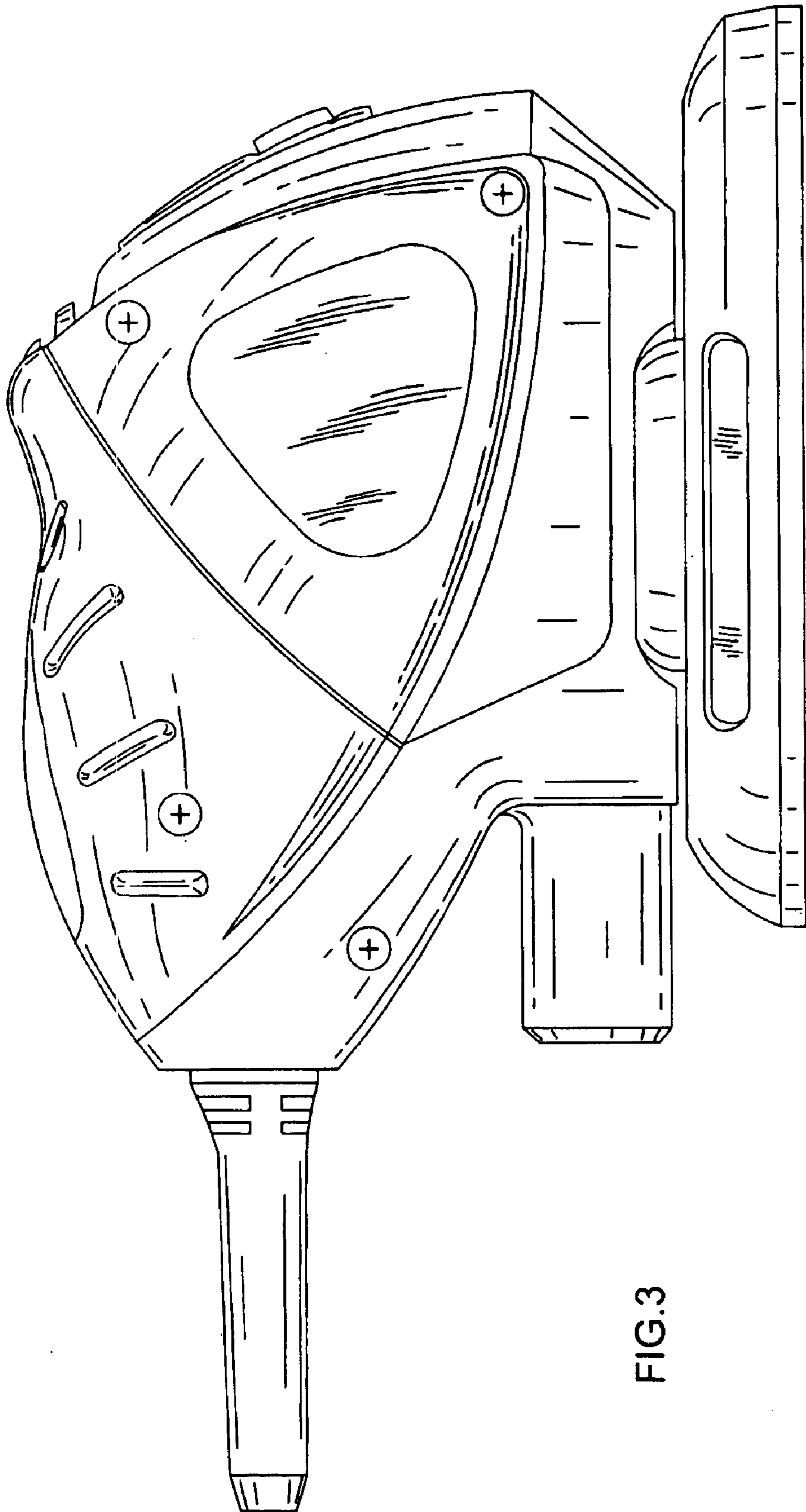

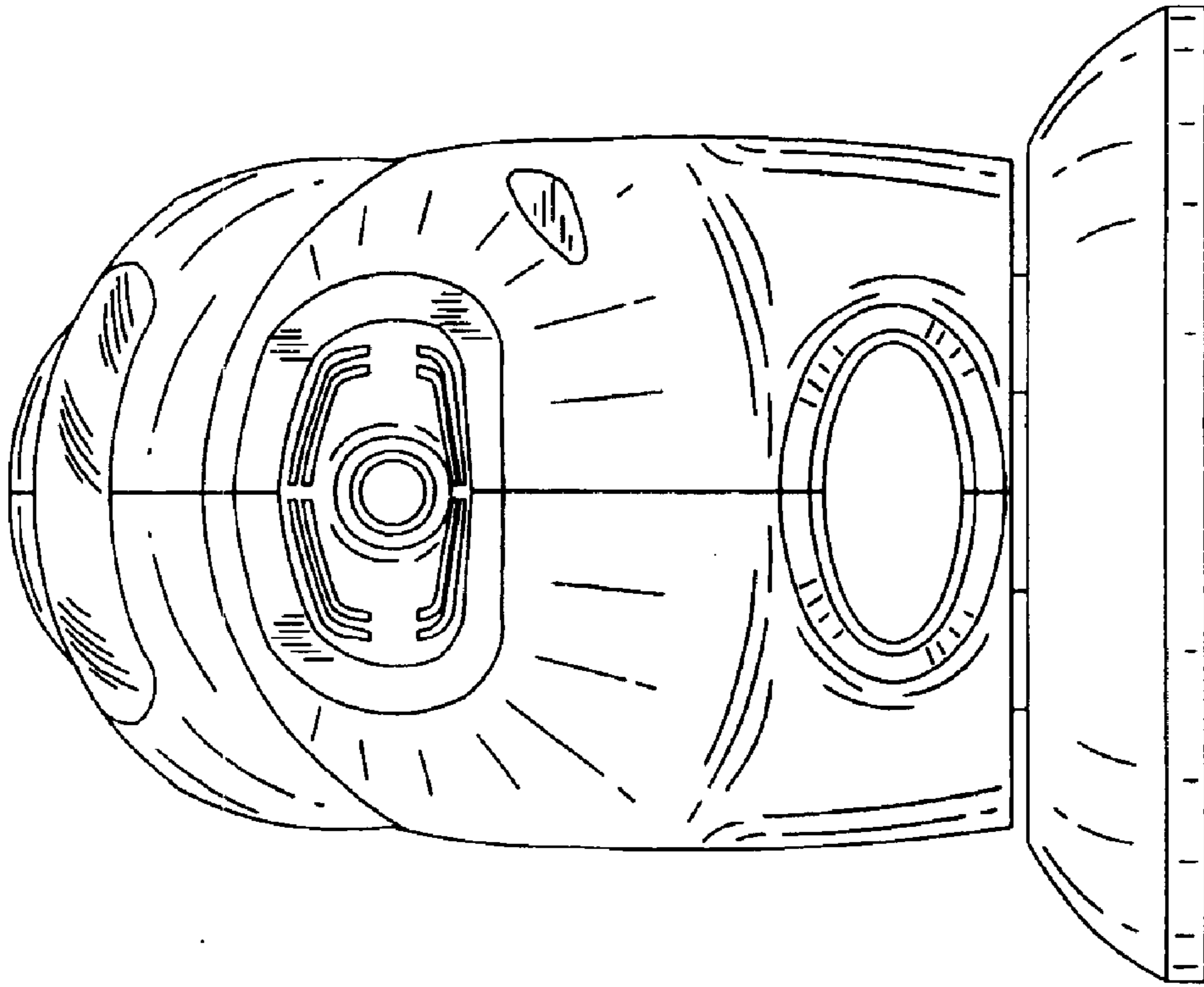

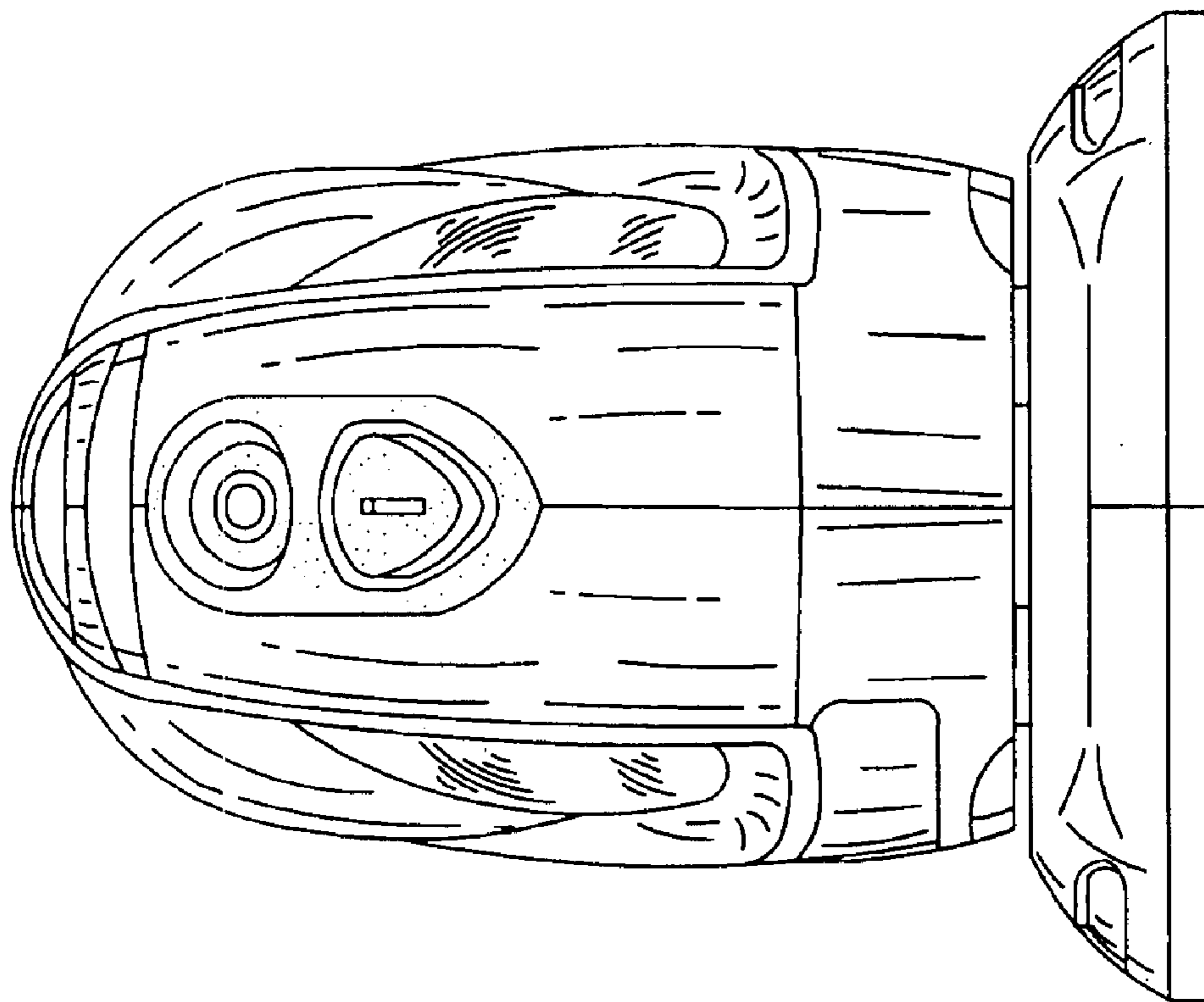

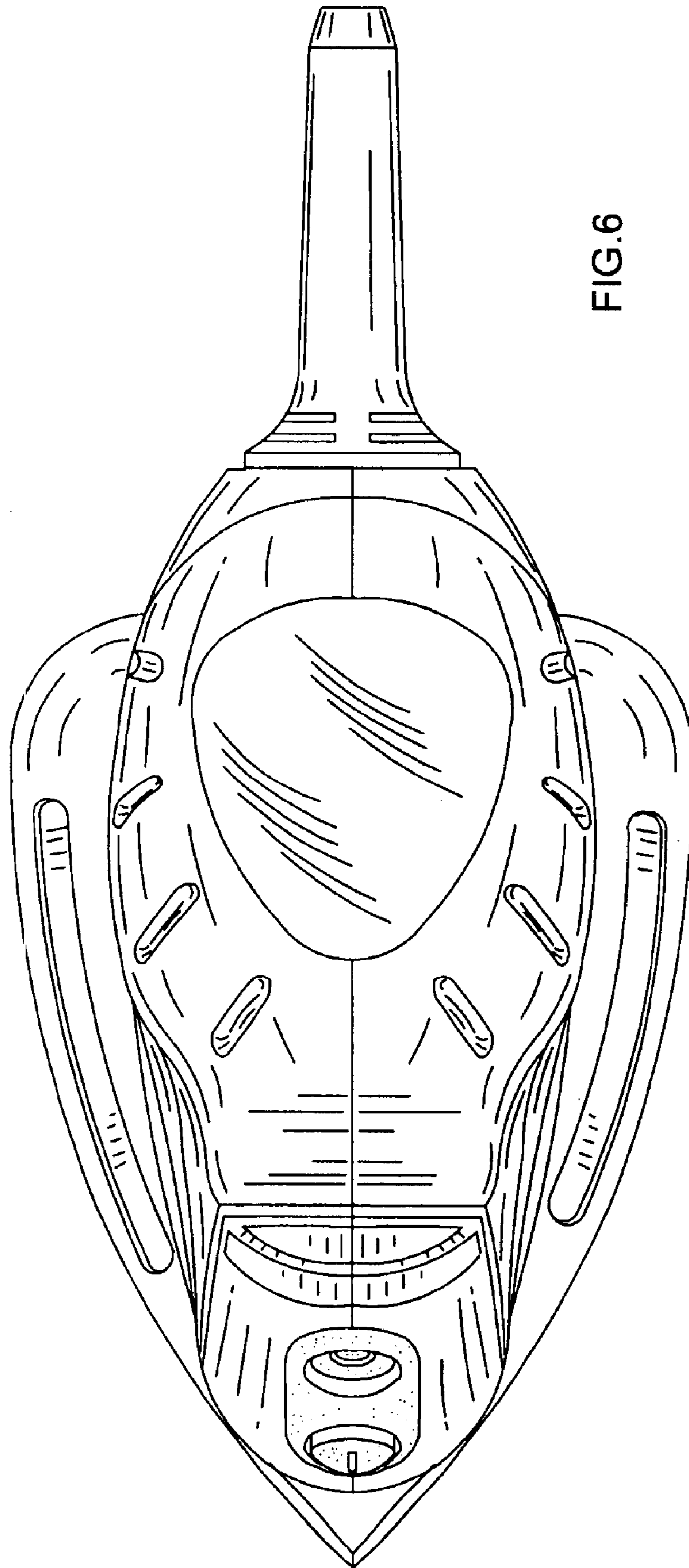

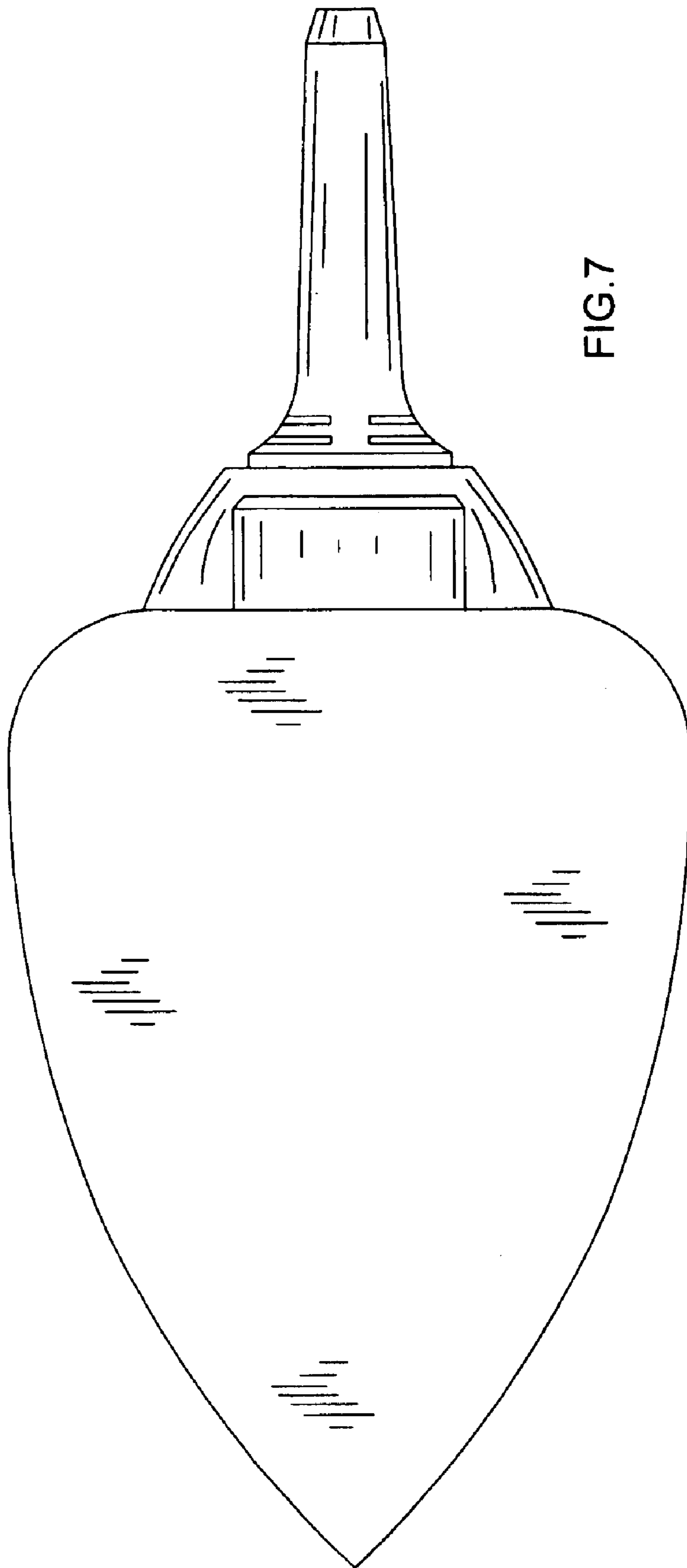

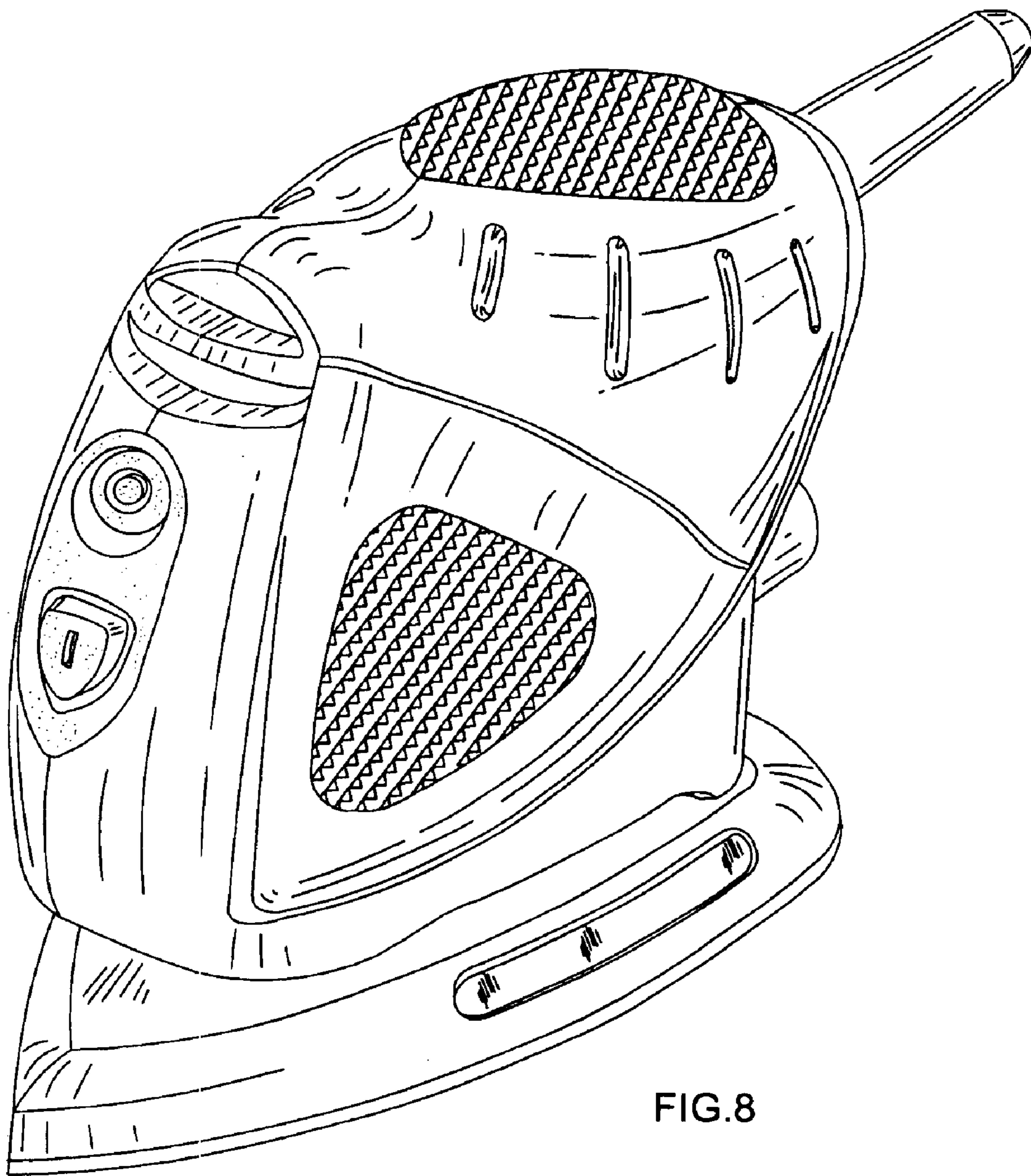

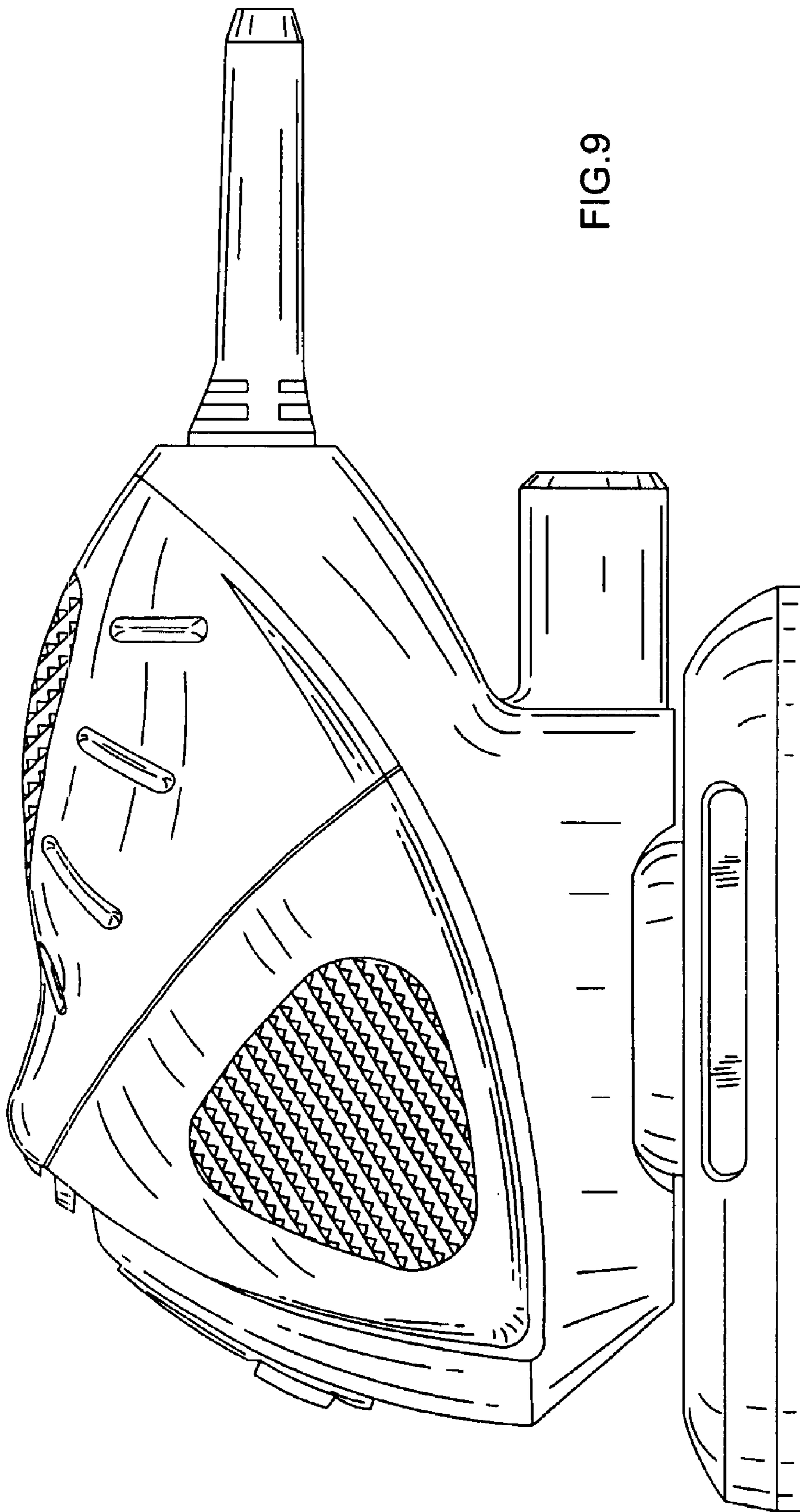

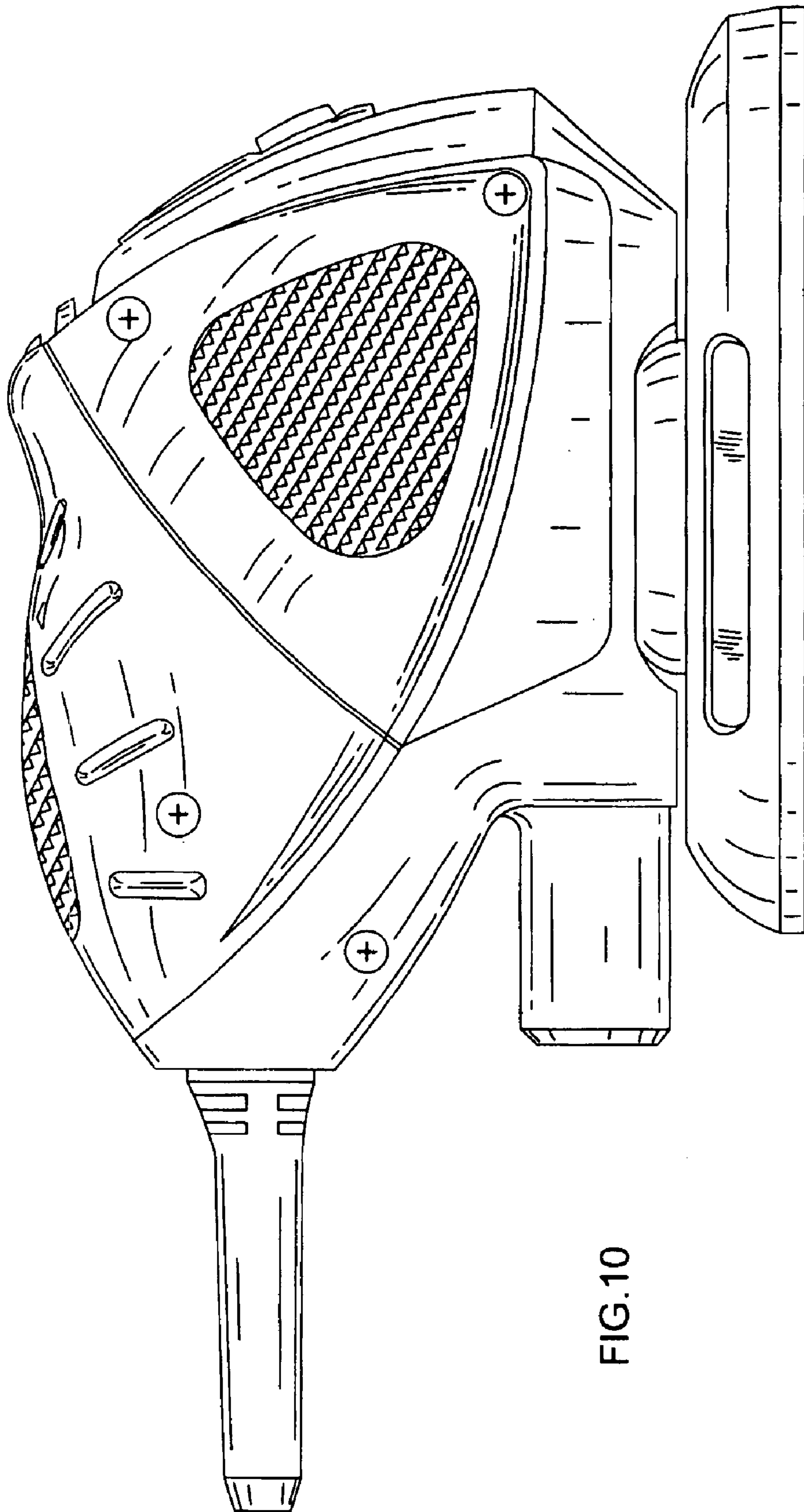

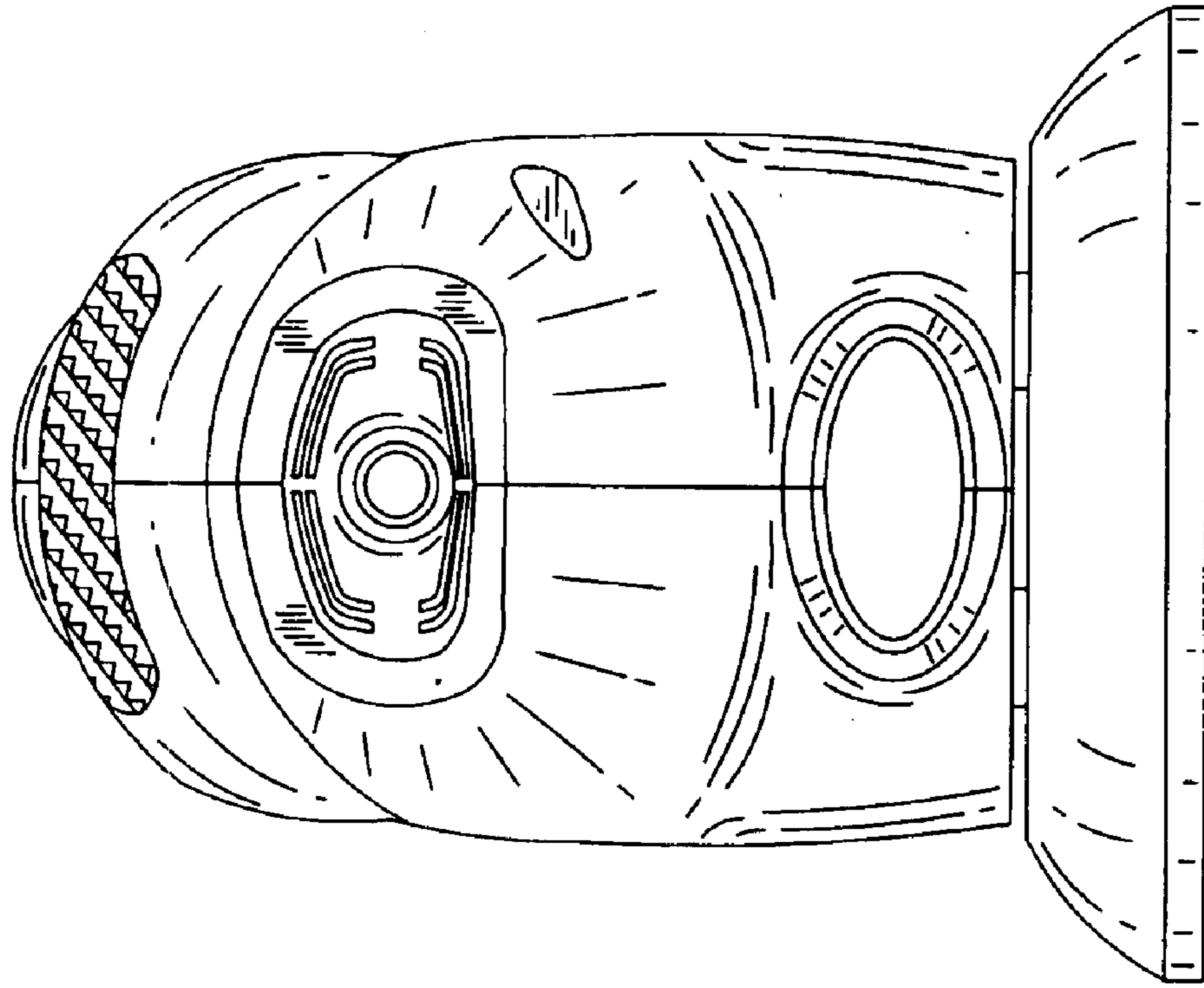

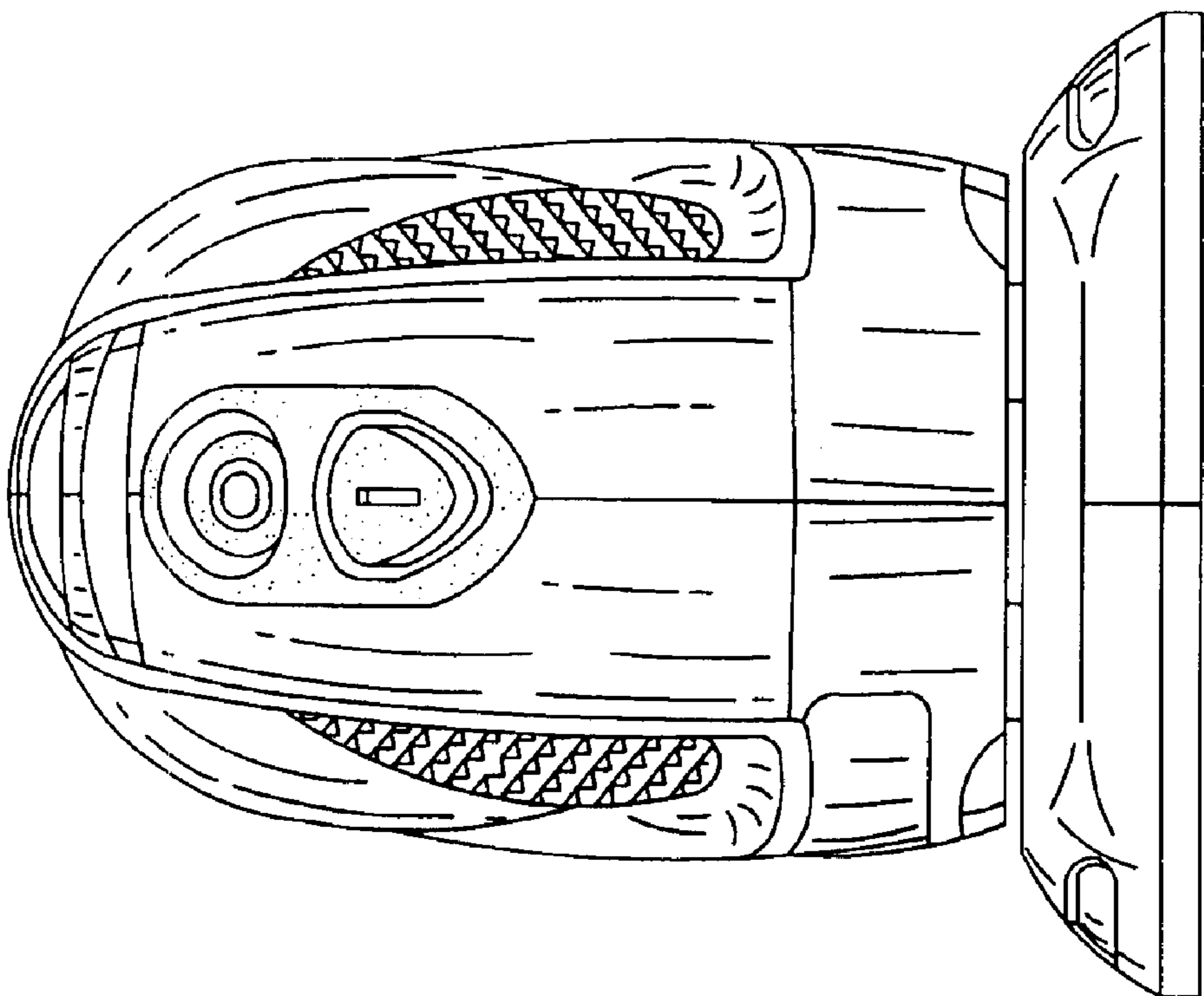

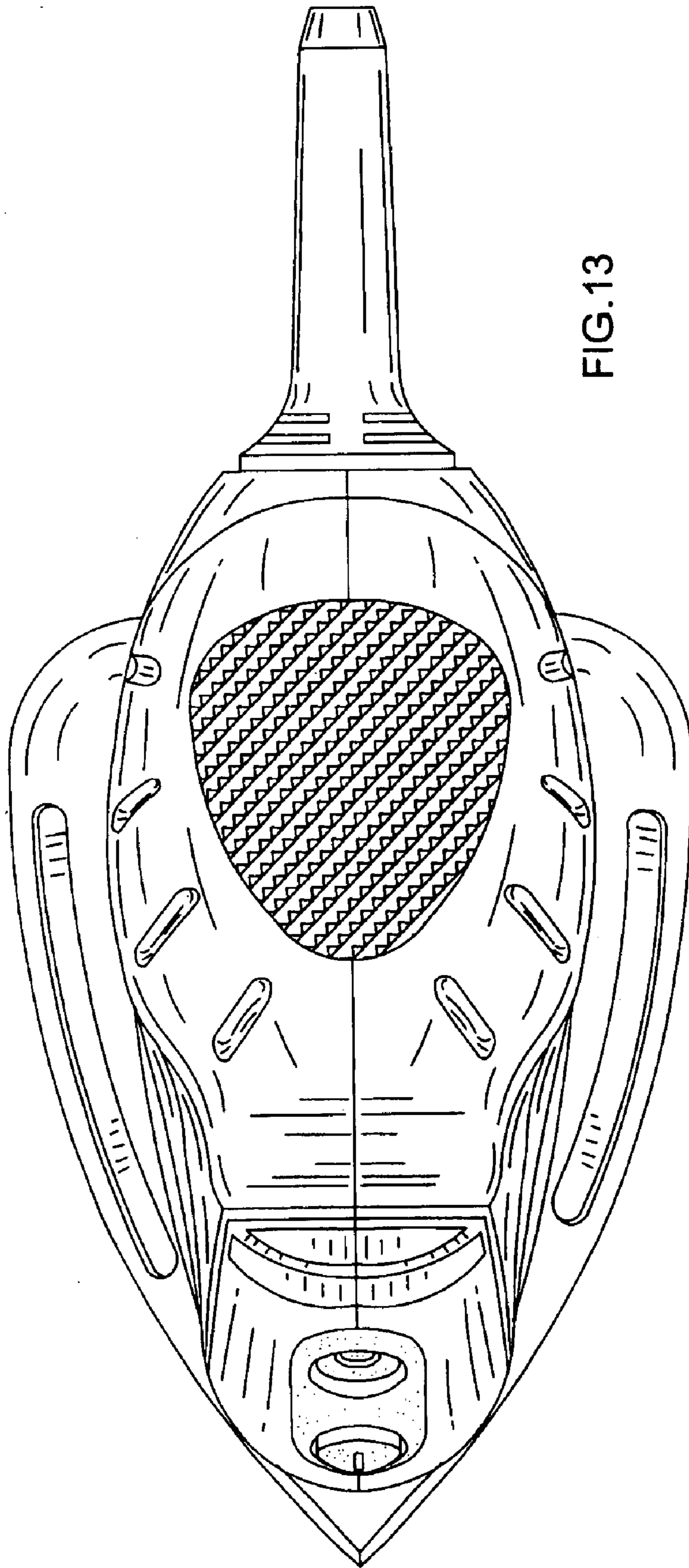

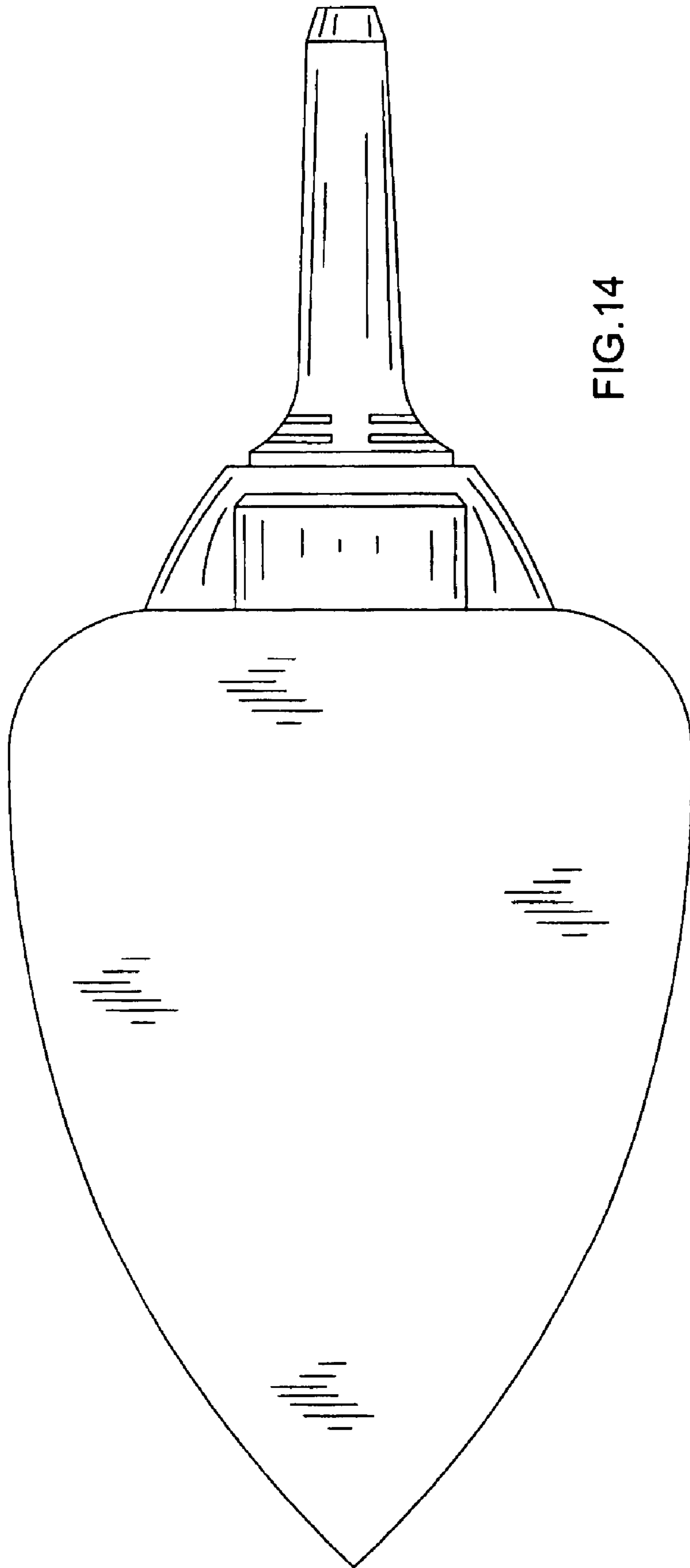
