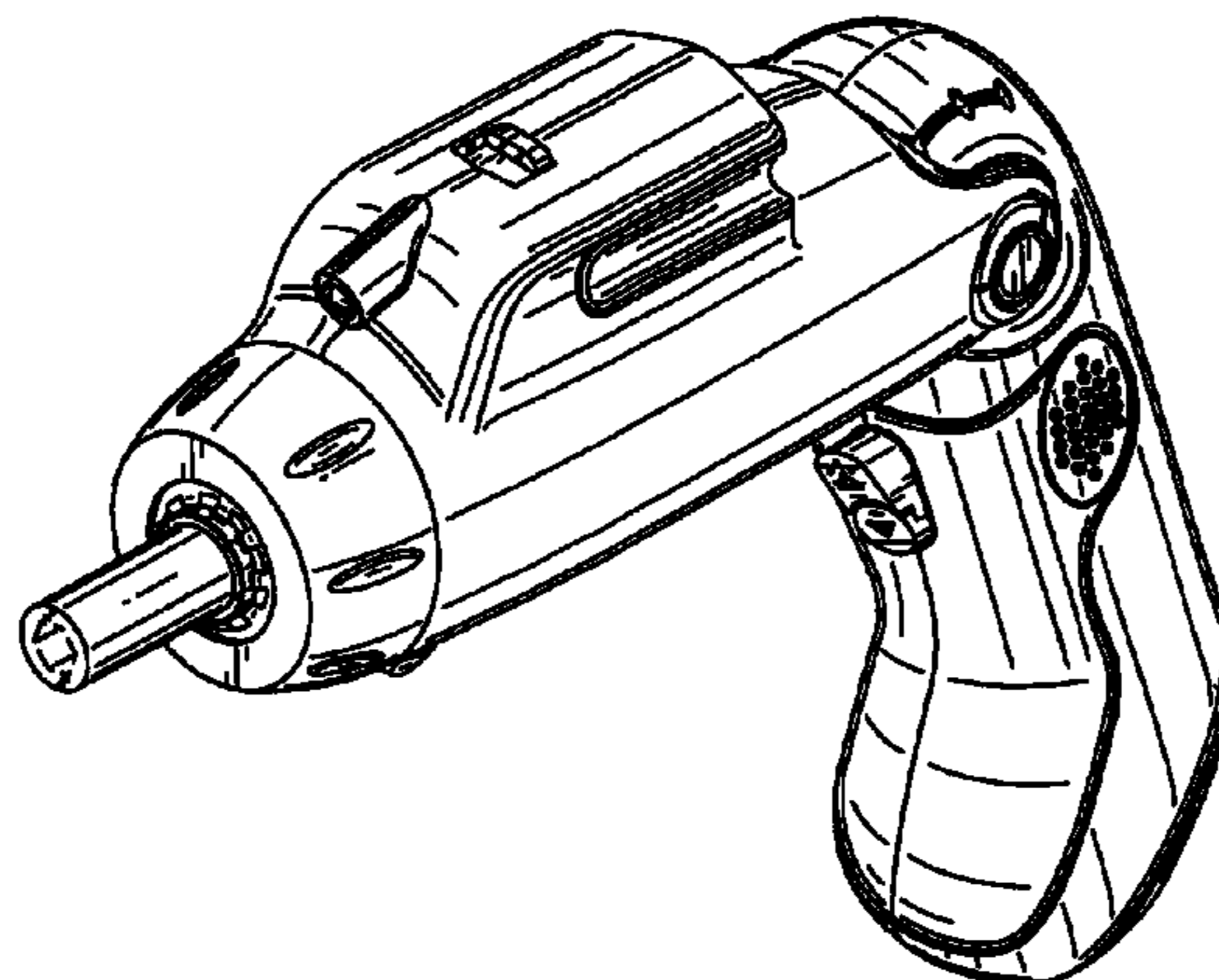
(57) **CLAIM**

DESCRIPTION

FIG. 1 shows a perspective view of a screwdriver of the present invention;
 FIG. 2 shows a front view of the screwdriver of the present invention;
 FIG. 3 shows a rear view of the screwdriver of the present invention;
 FIGS. 4 and 5 show opposite side views of the screwdriver of the present invention;
 FIG. 6 shows a top view of the screwdriver of the present invention;
 FIG. 7 shows a bottom view of the screwdriver of the present invention; and,
 FIG. 8 shows a perspective view of the screwdriver of the present invention in an alternate, extended position.

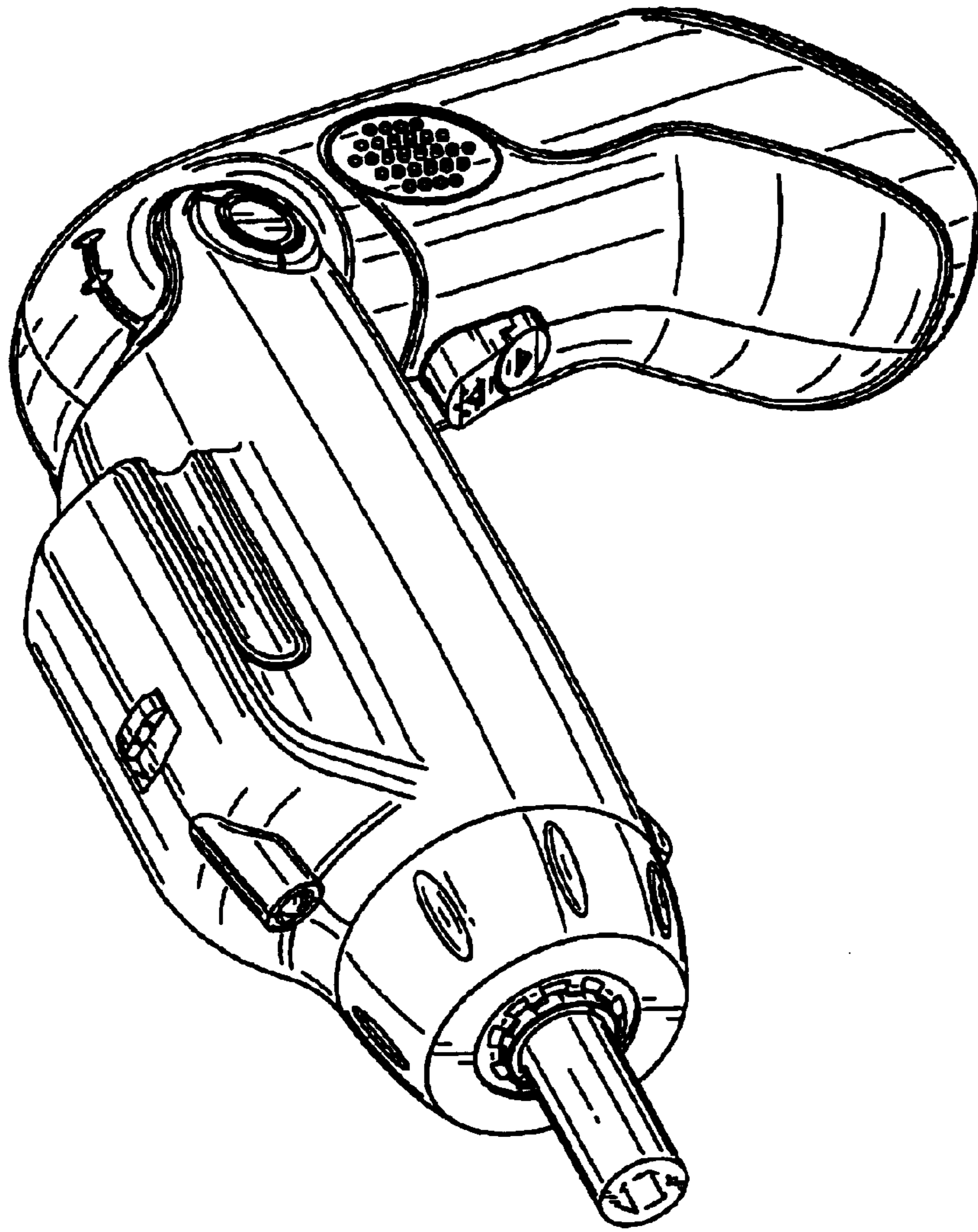

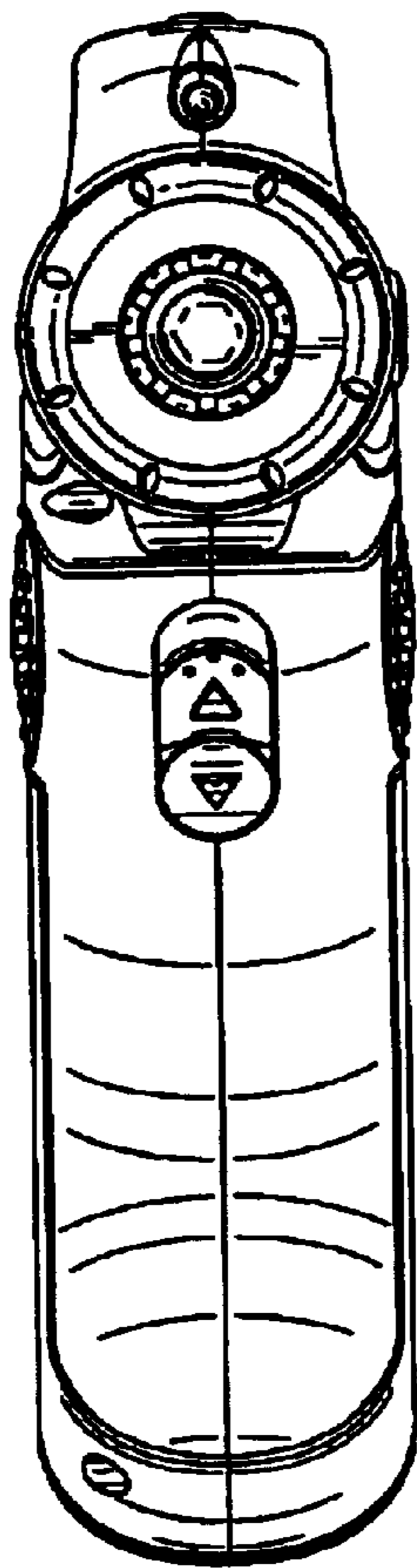

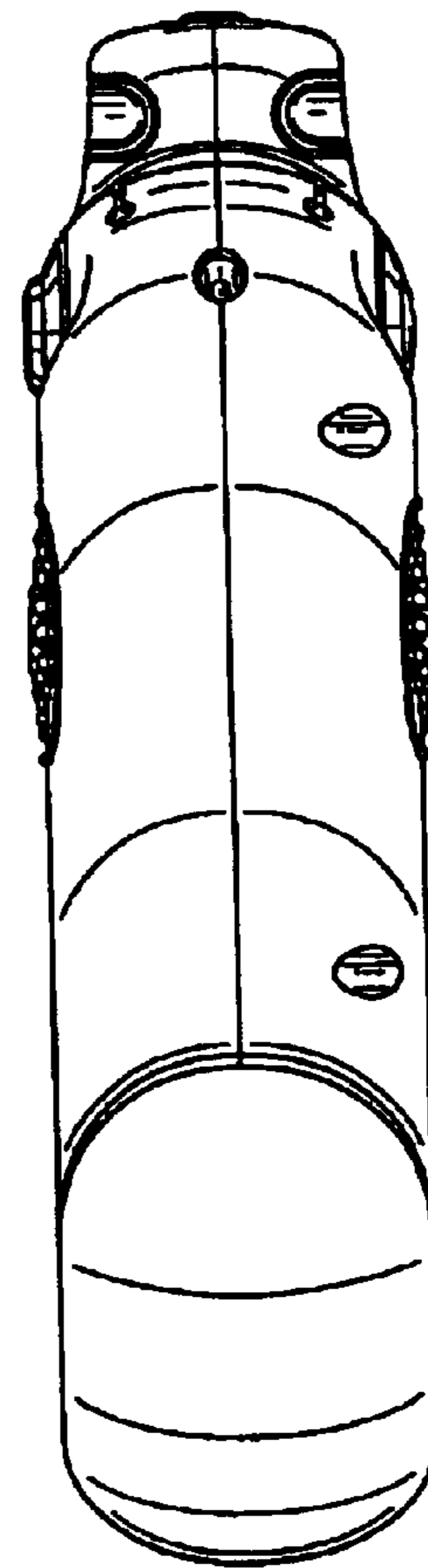

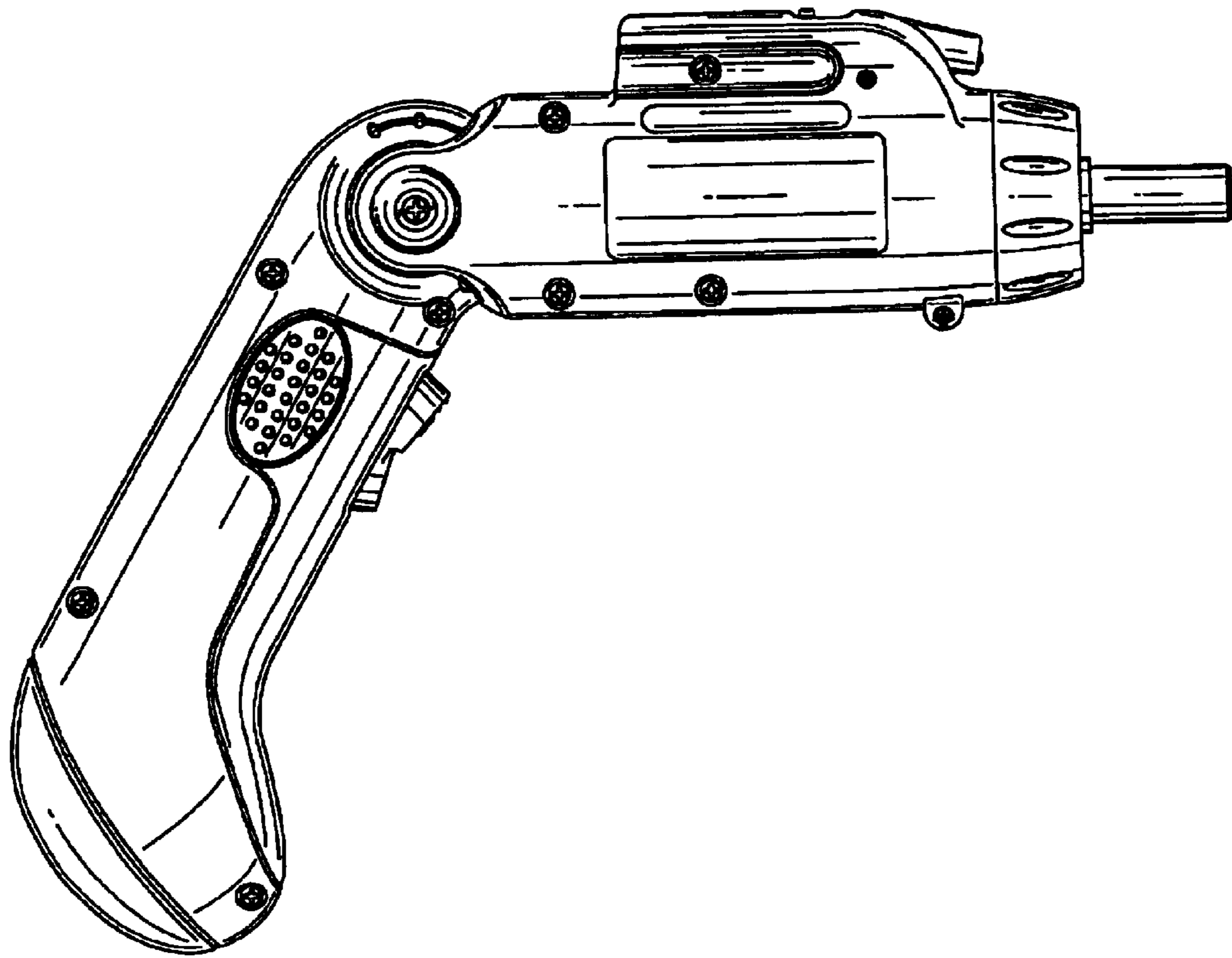

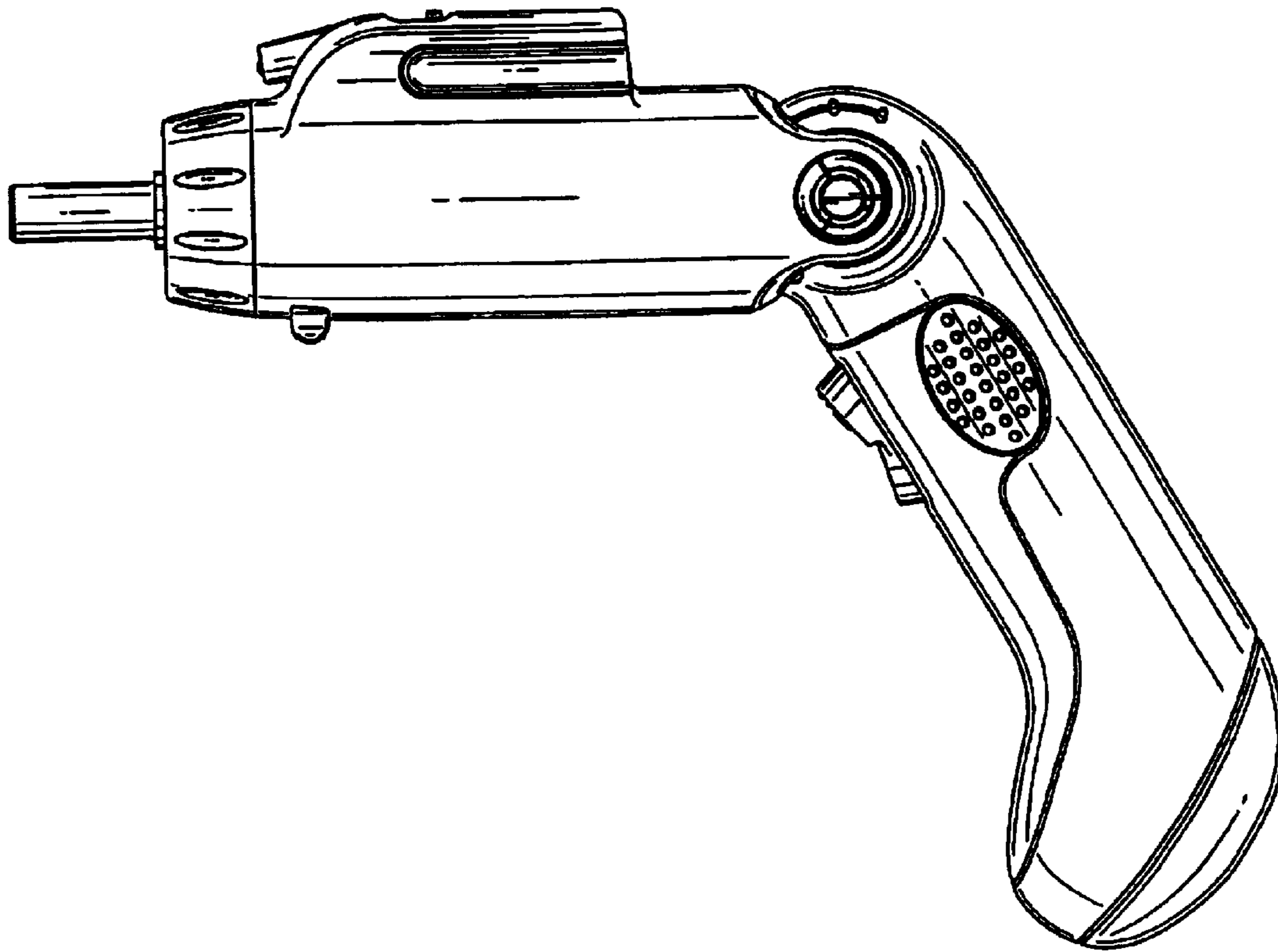

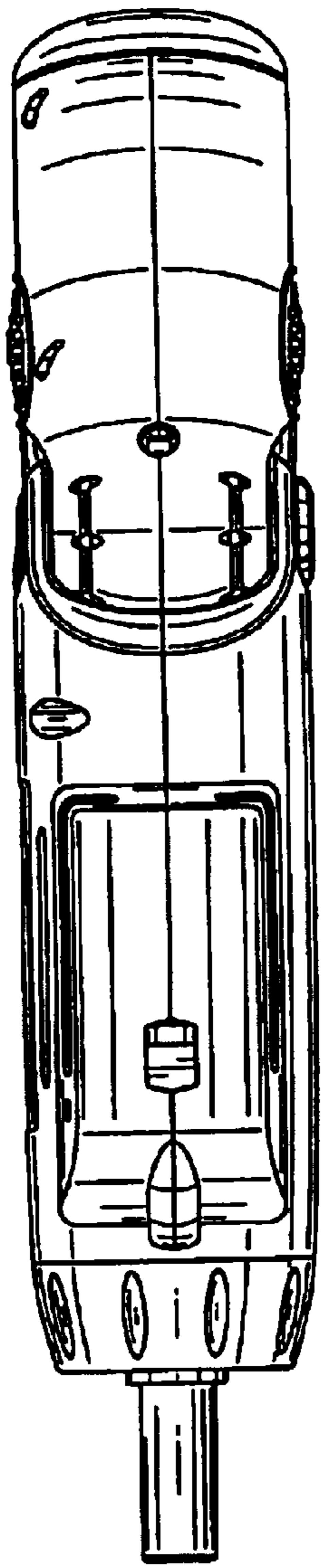

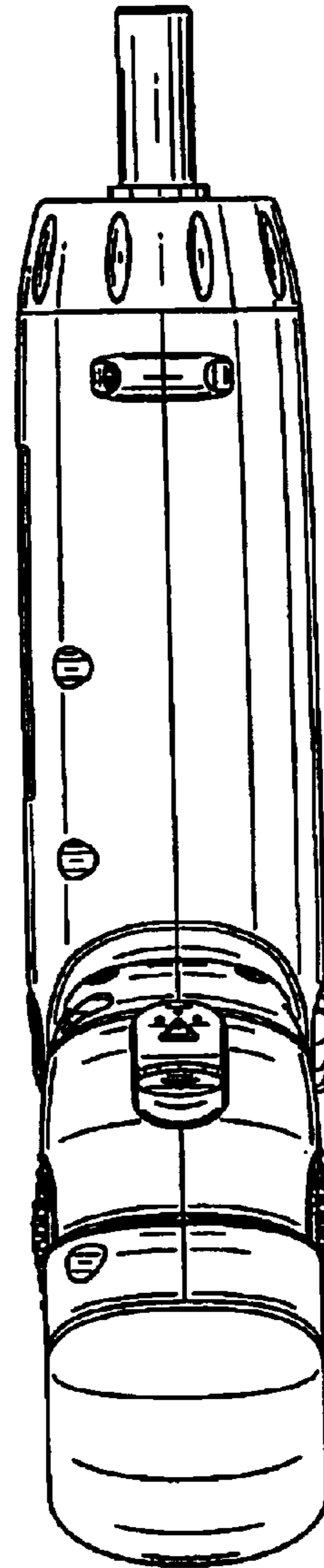

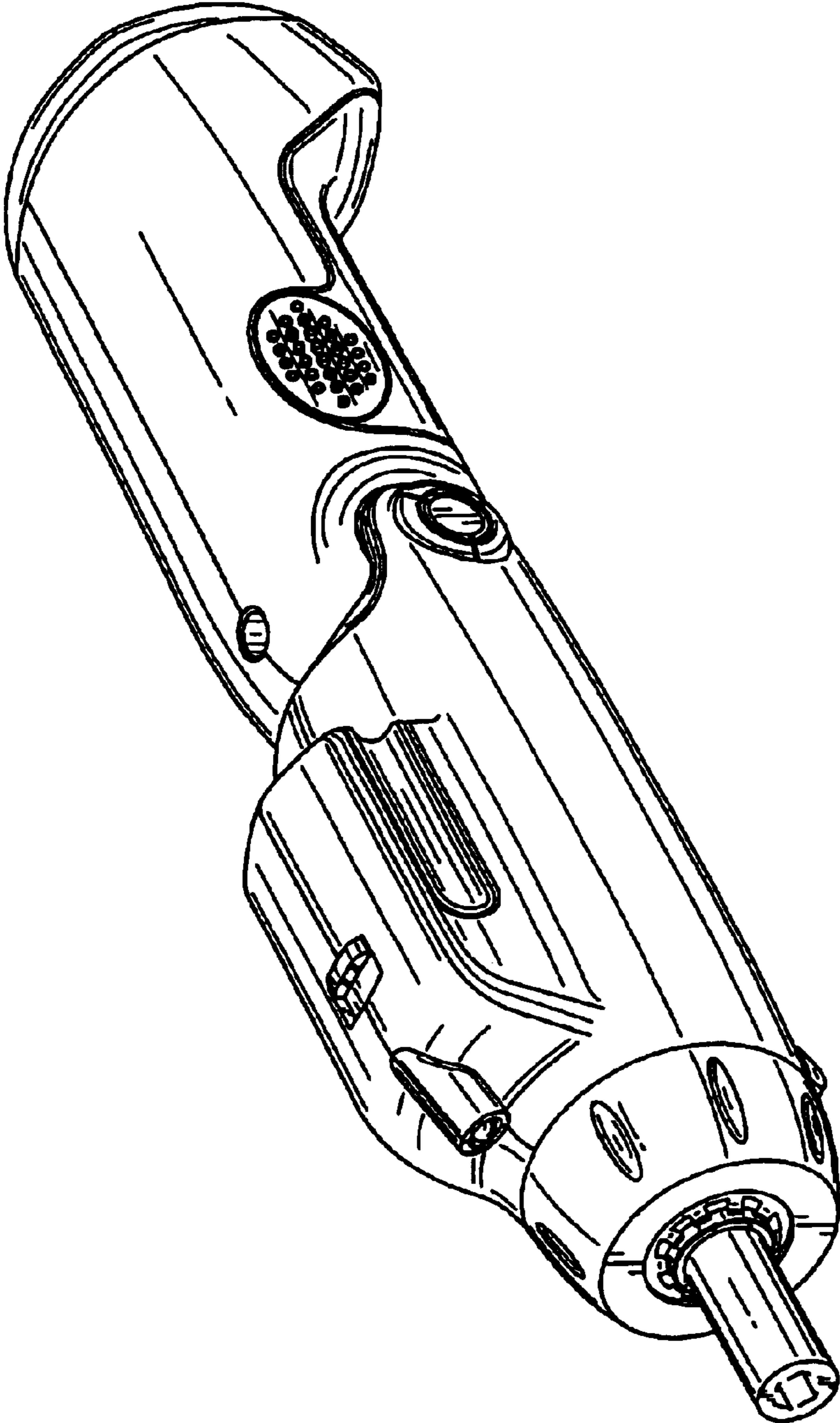
