DESCRIPTION

FIG. 1 is a perspective view of a top, front and left side of a portable nailing machine showing our new design;
FIG. 2 is a front elevational view thereof;

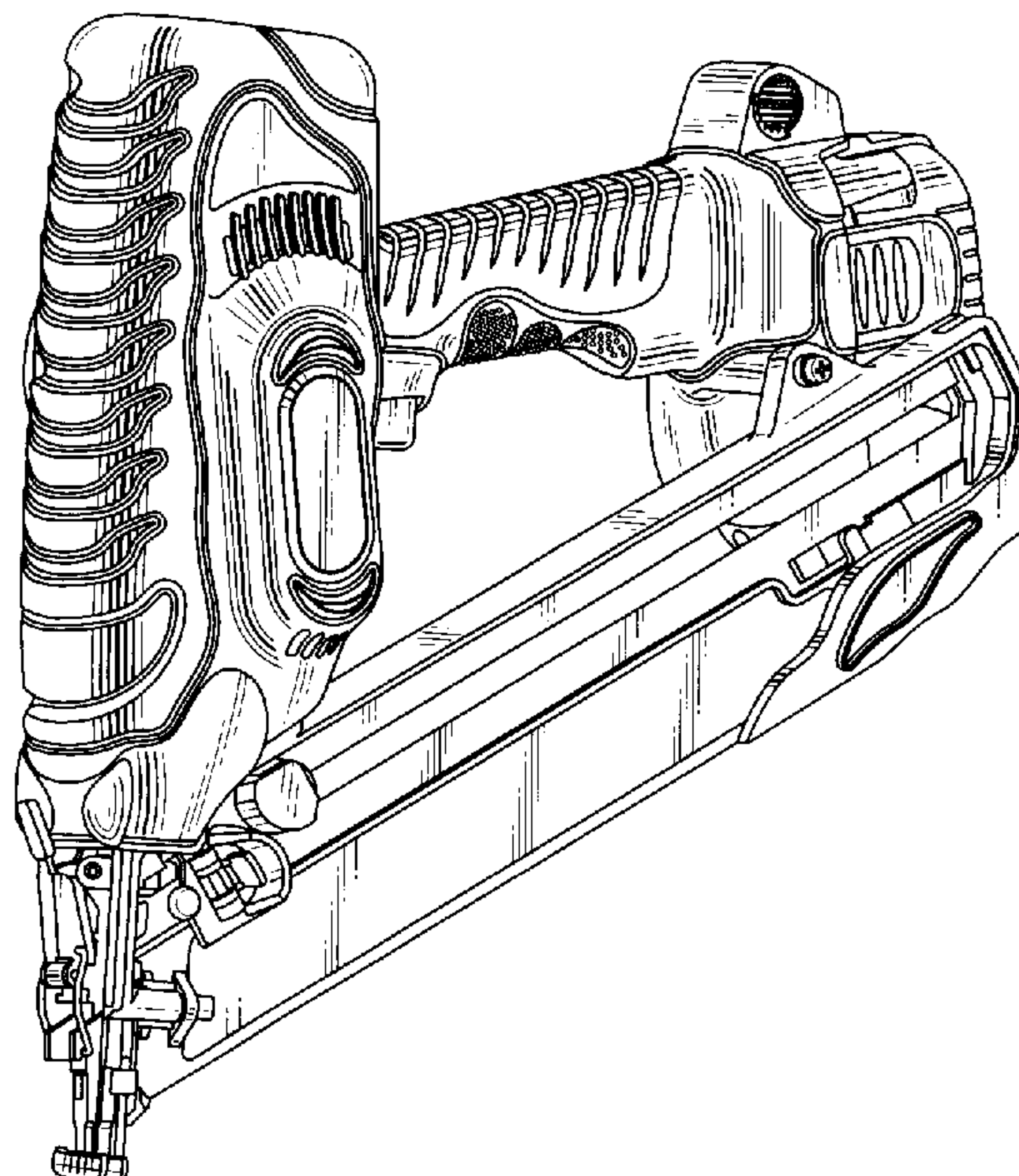

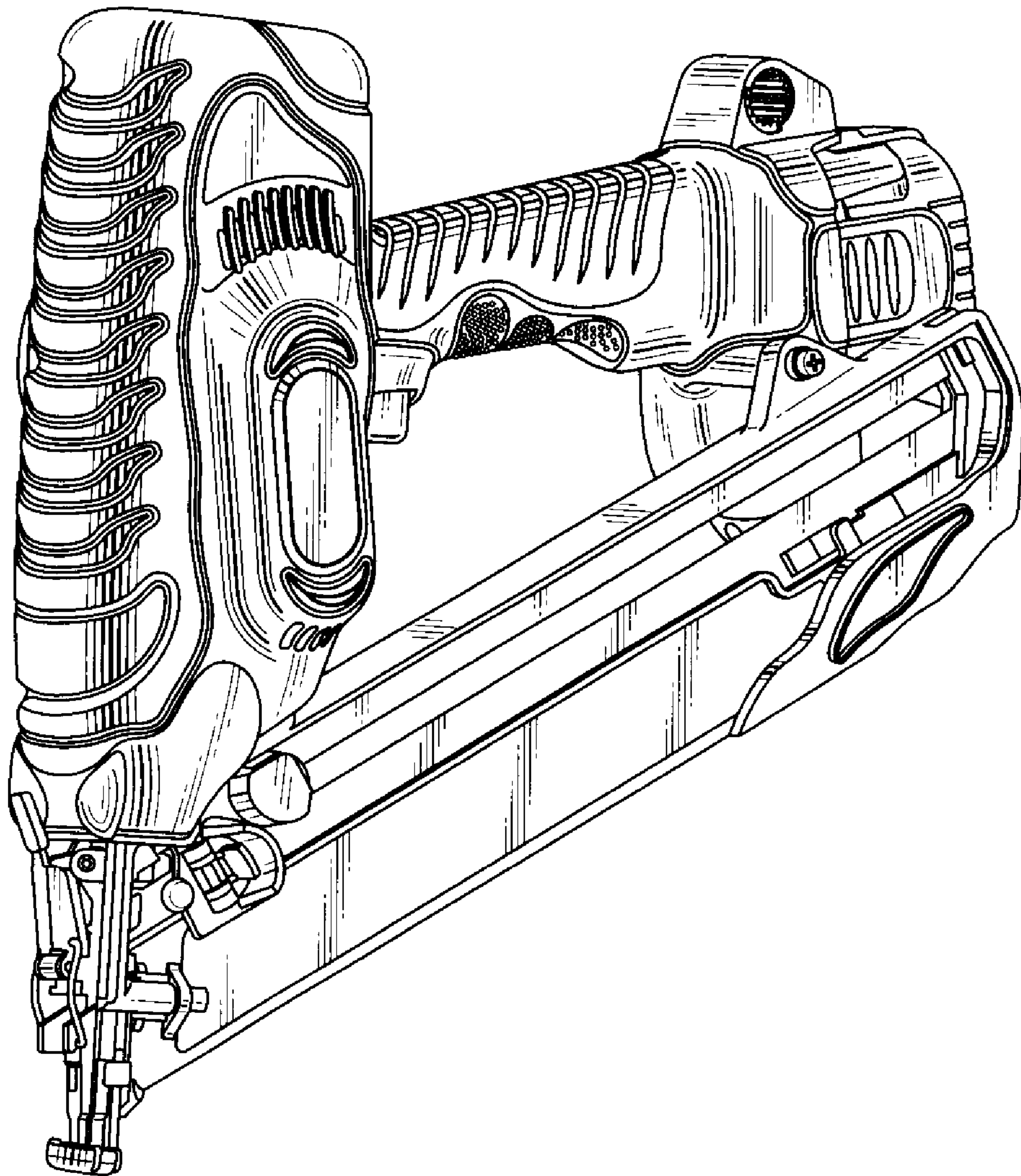

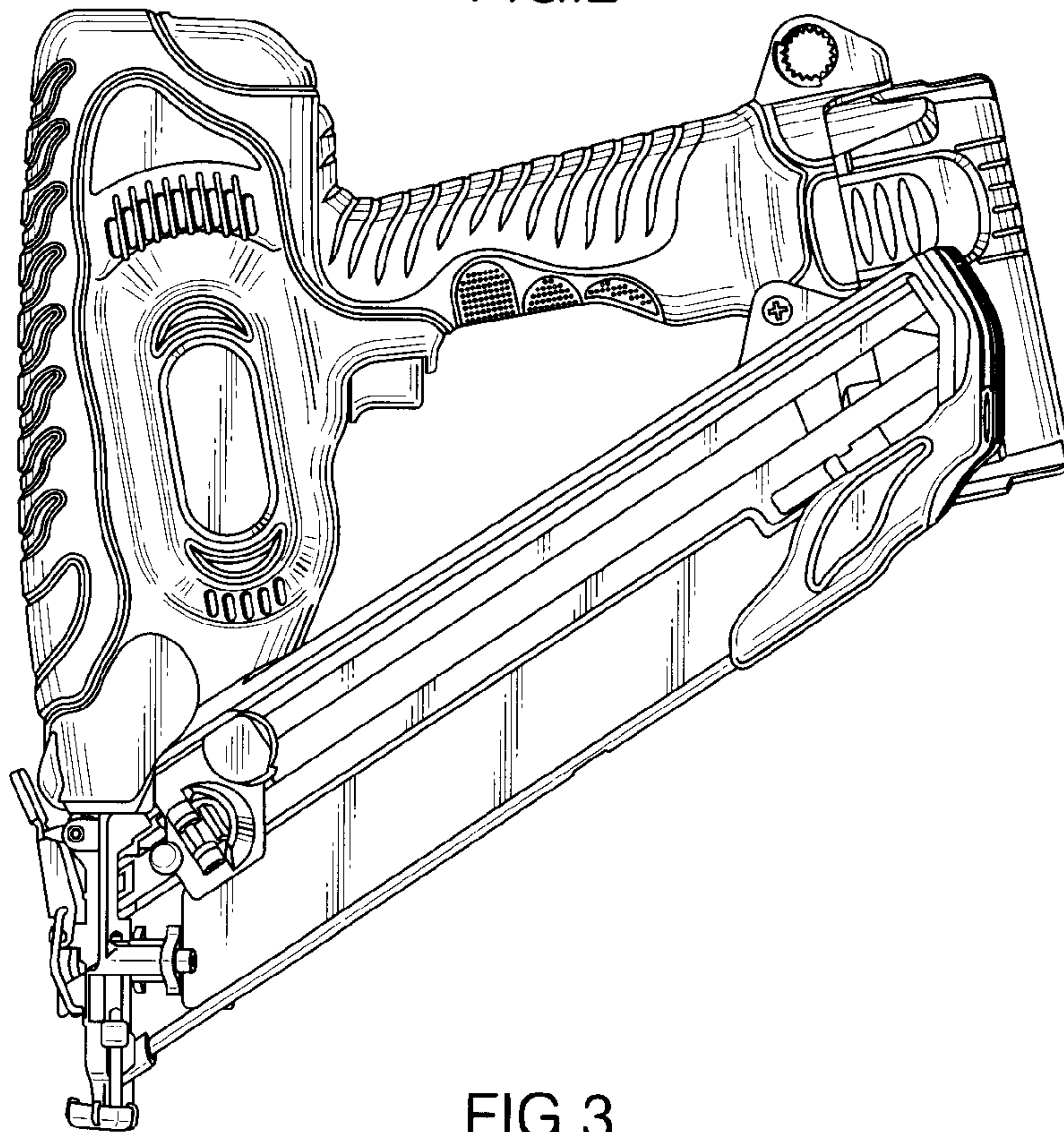

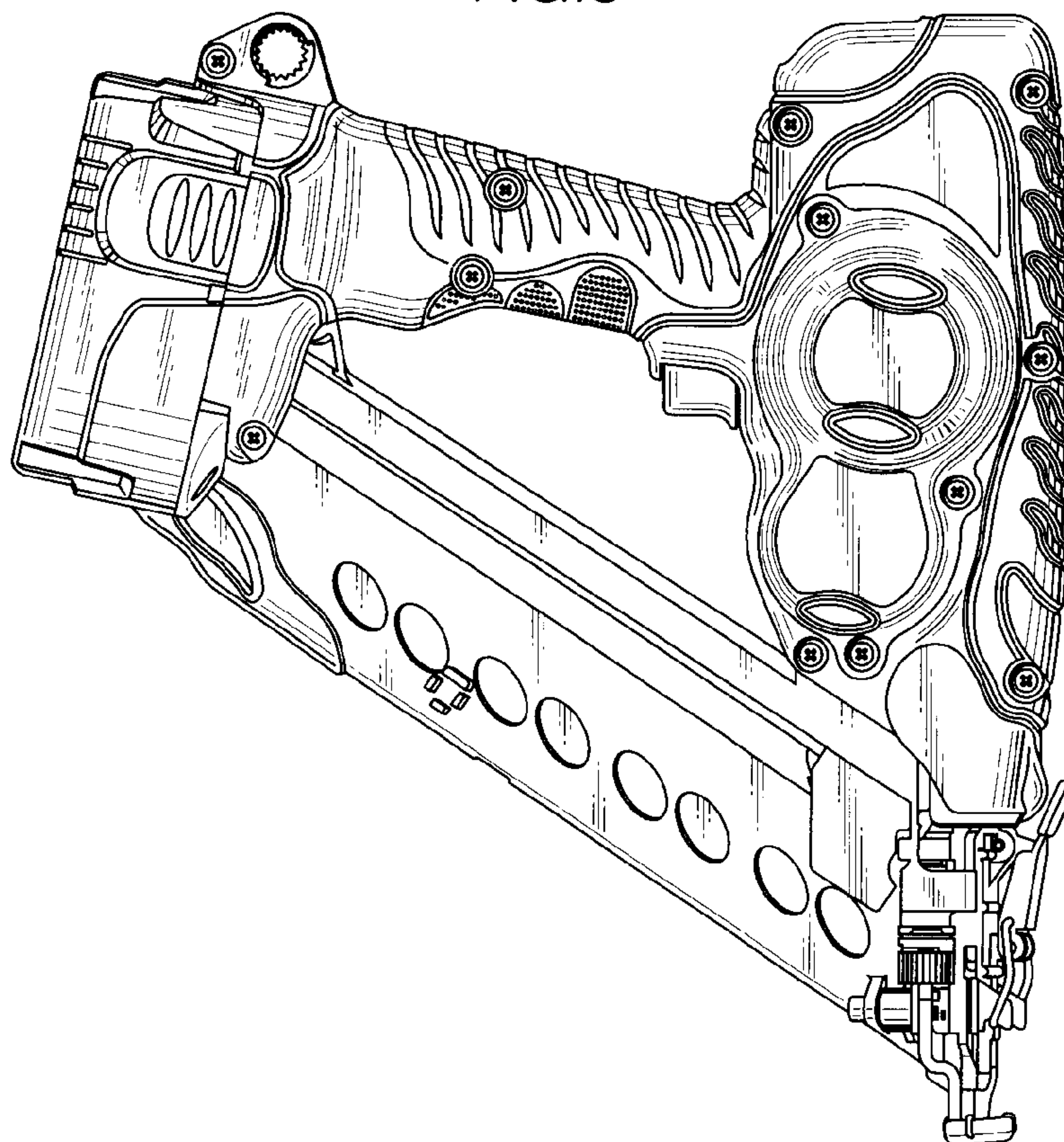

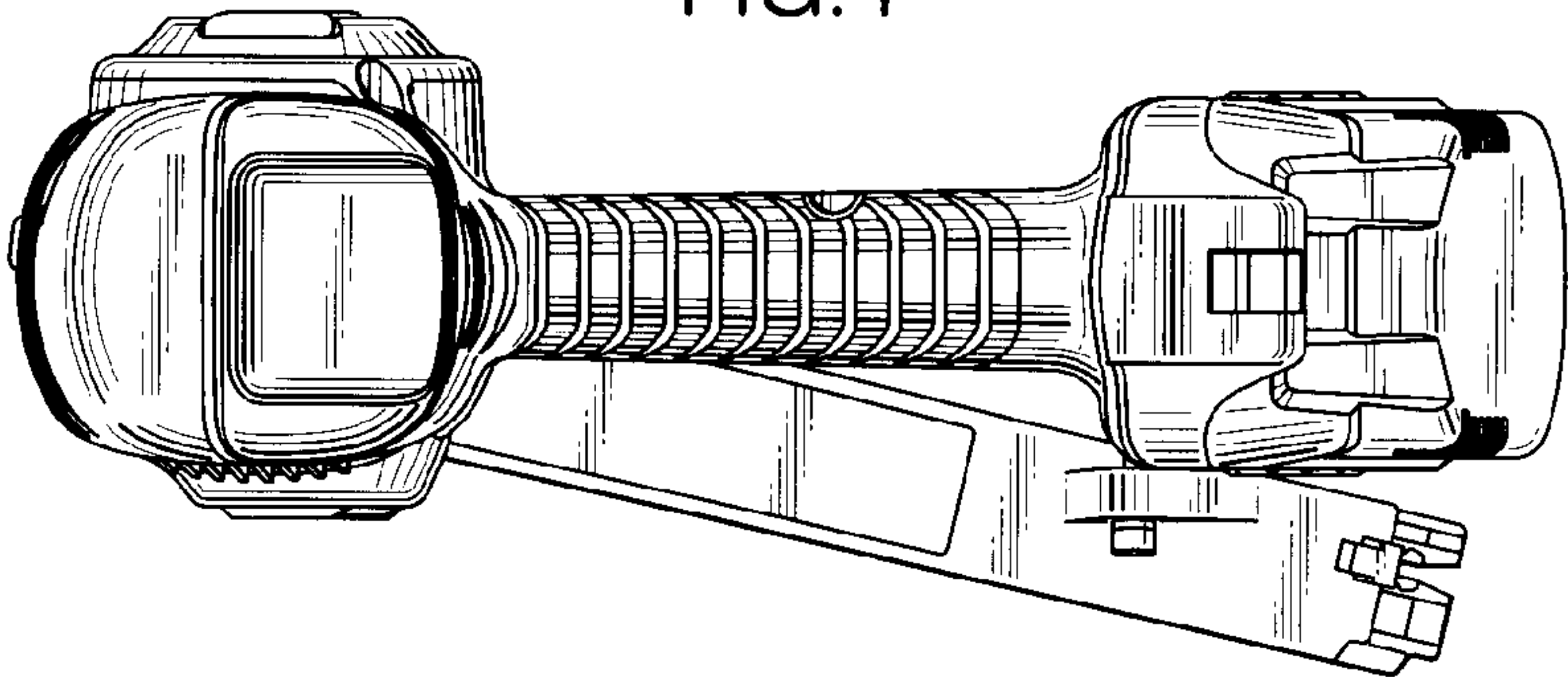

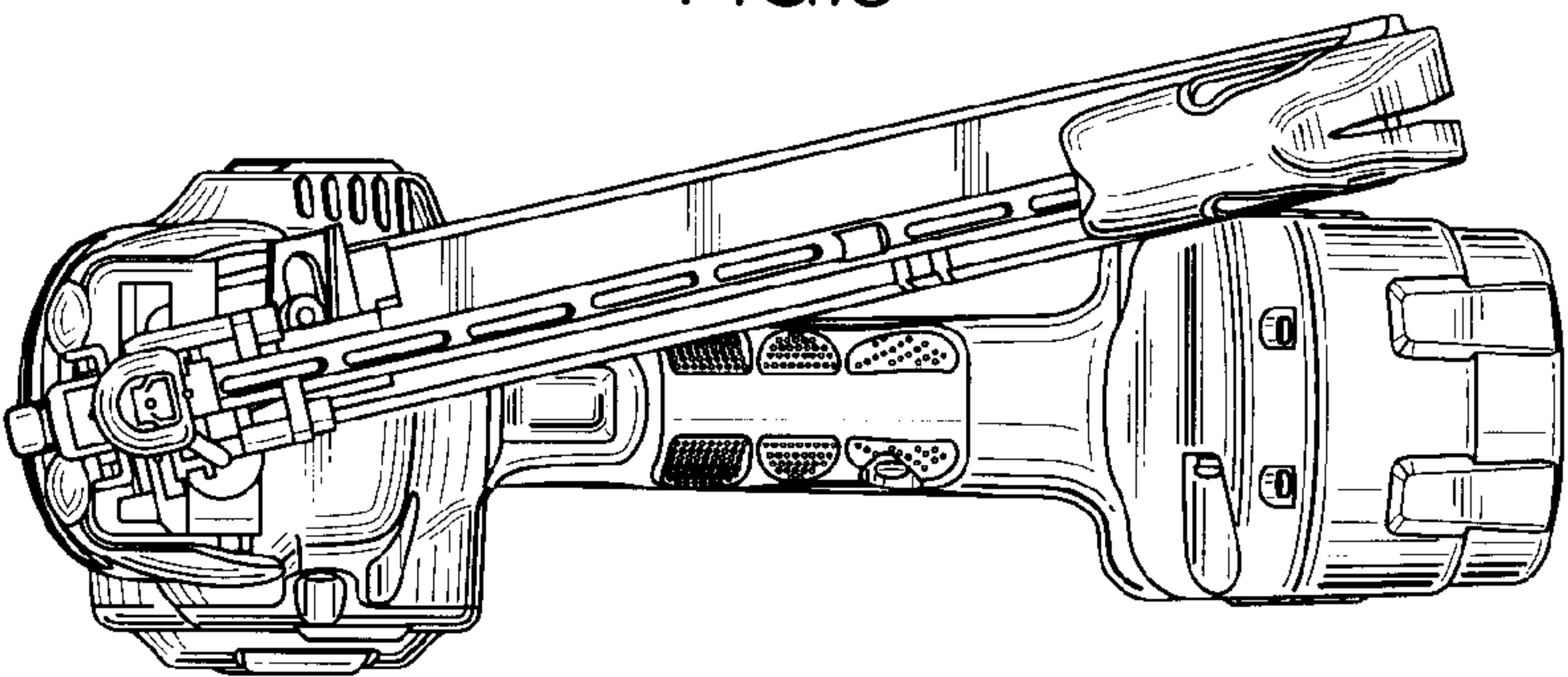

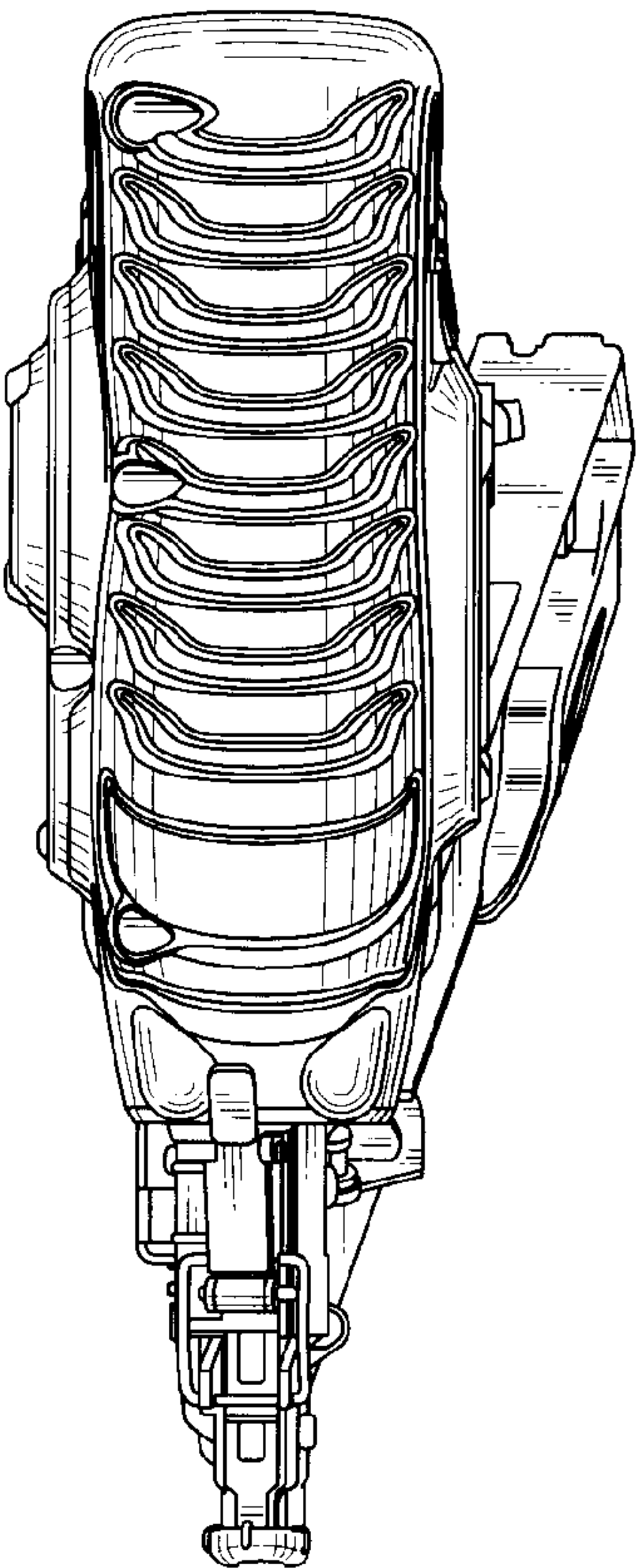
