(57) **CLAIM**

The ornamental design for a tea sachet packaging, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of a tea sachet packaging, showing our new design, the front and back view being identical;

FIG. 4 is a left side view thereof; and,

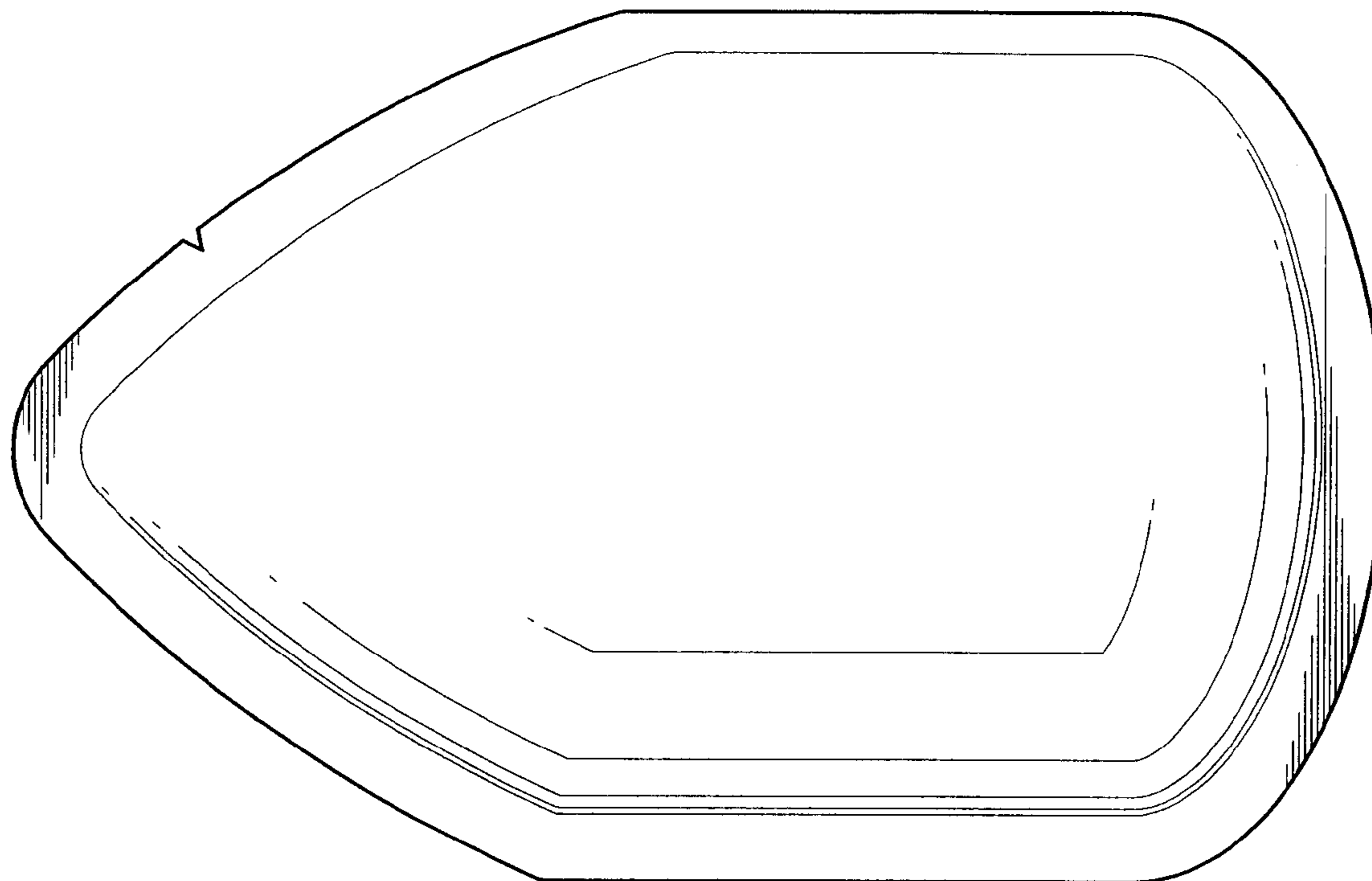

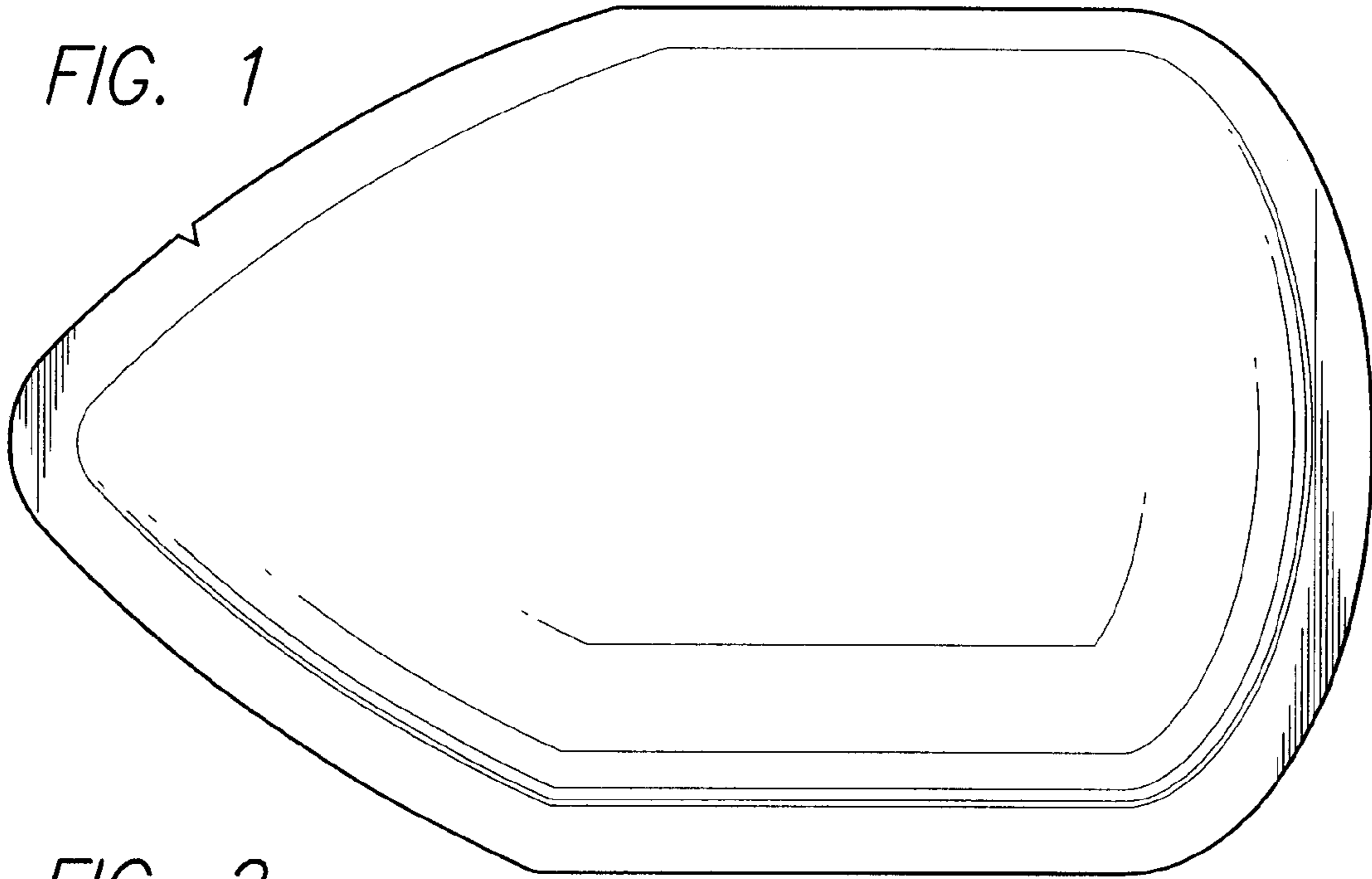

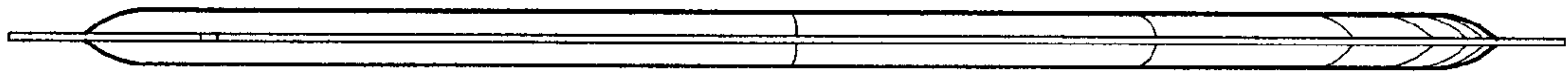

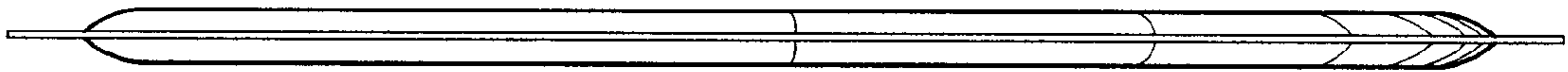
