FIG. 9 is an exploded front perspective view thereof.

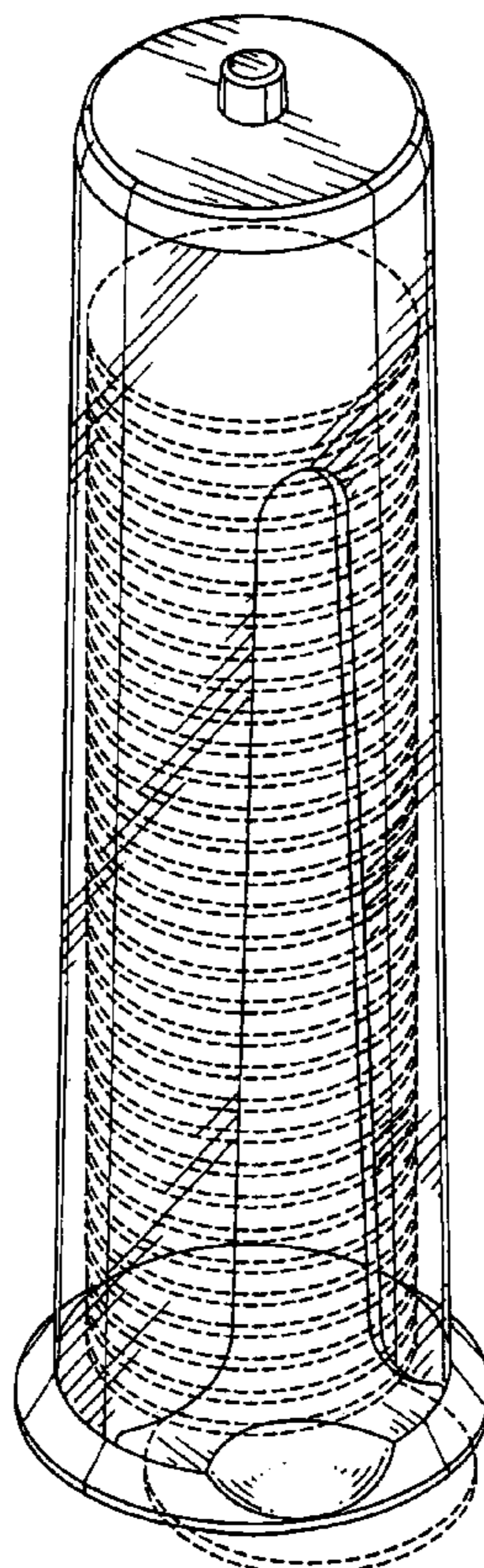

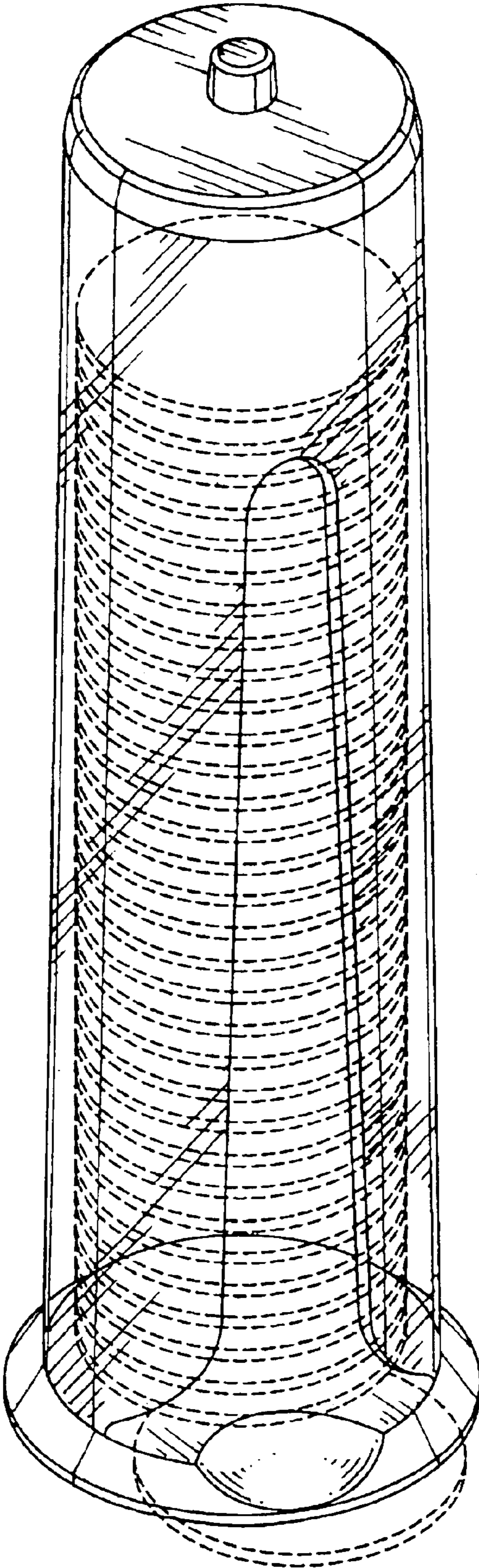

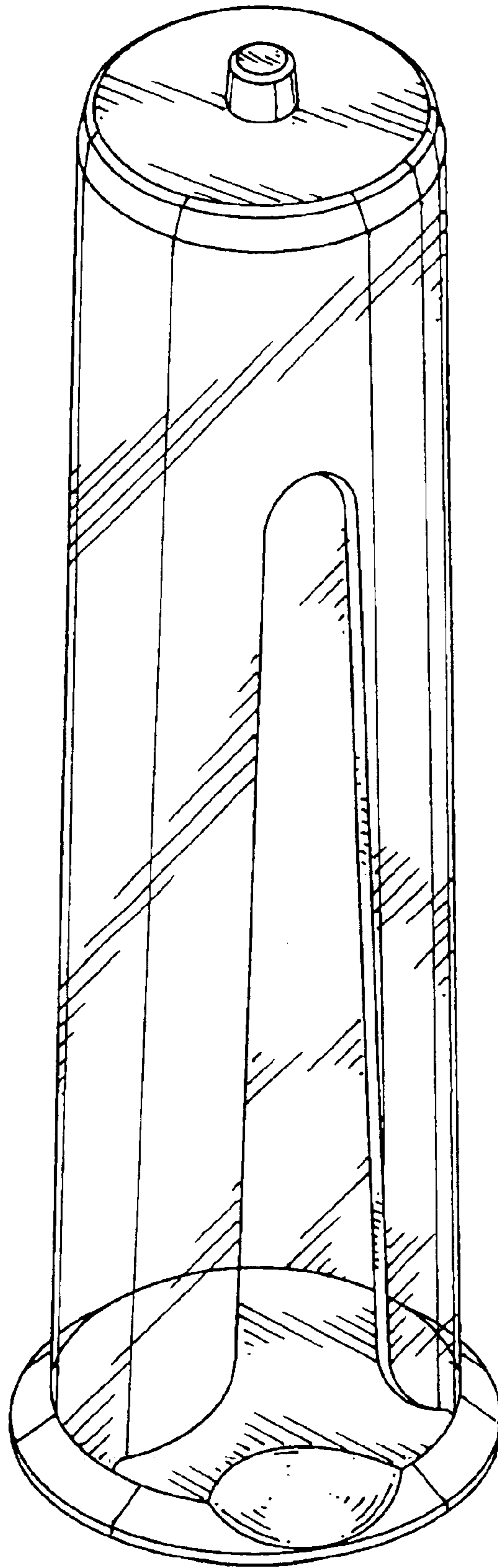

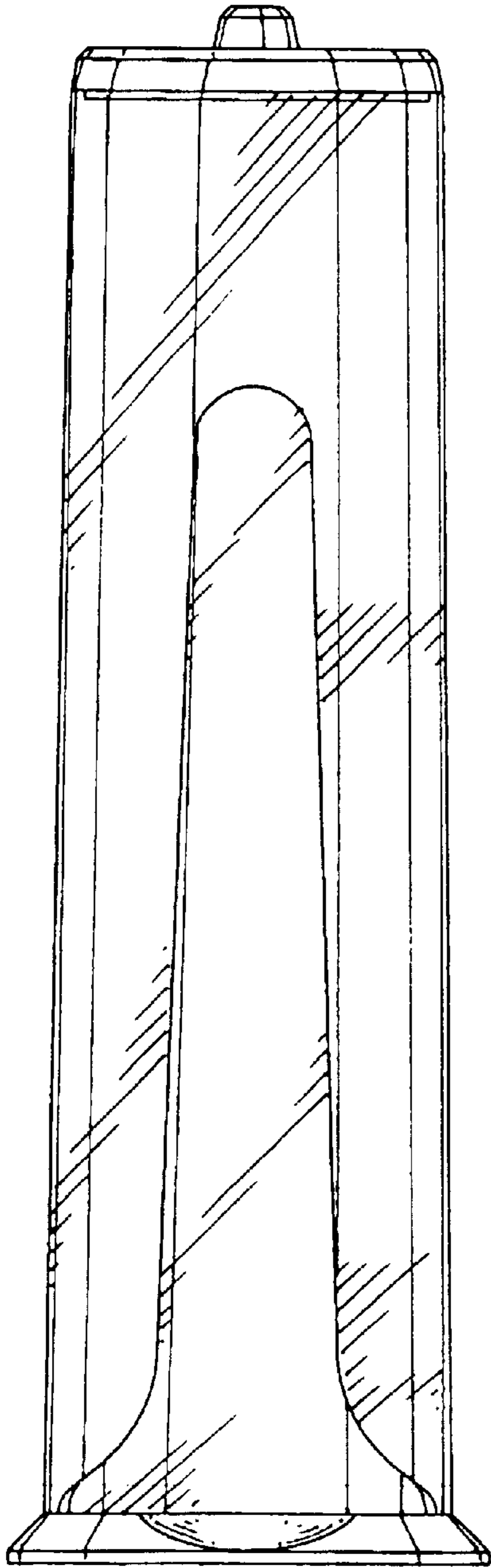

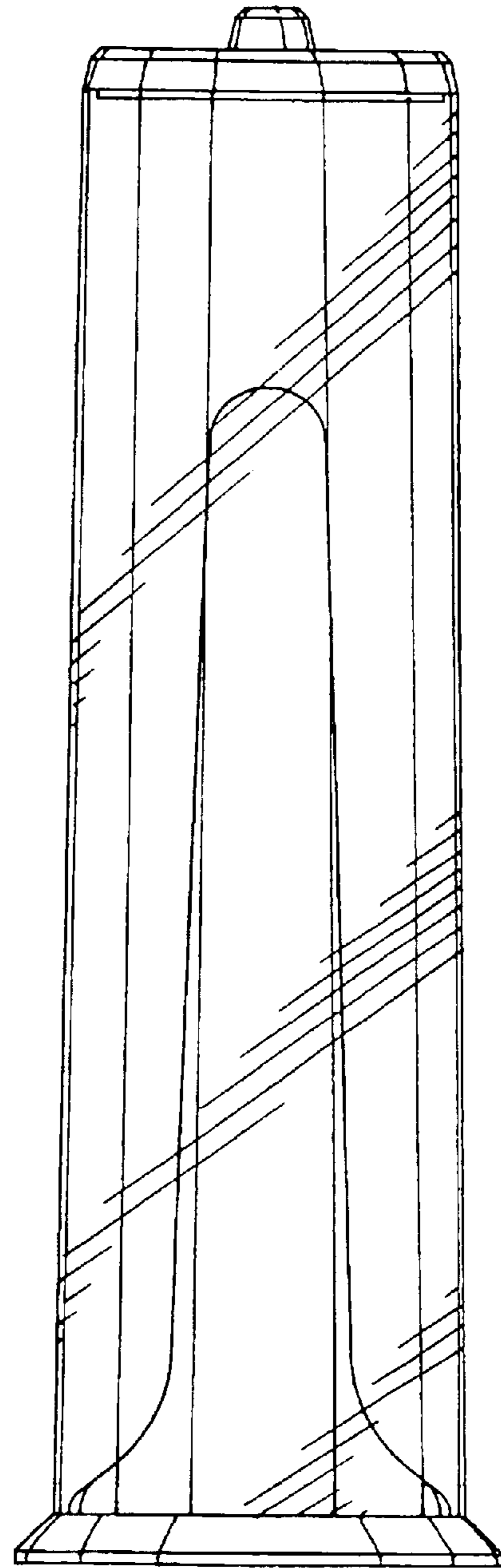

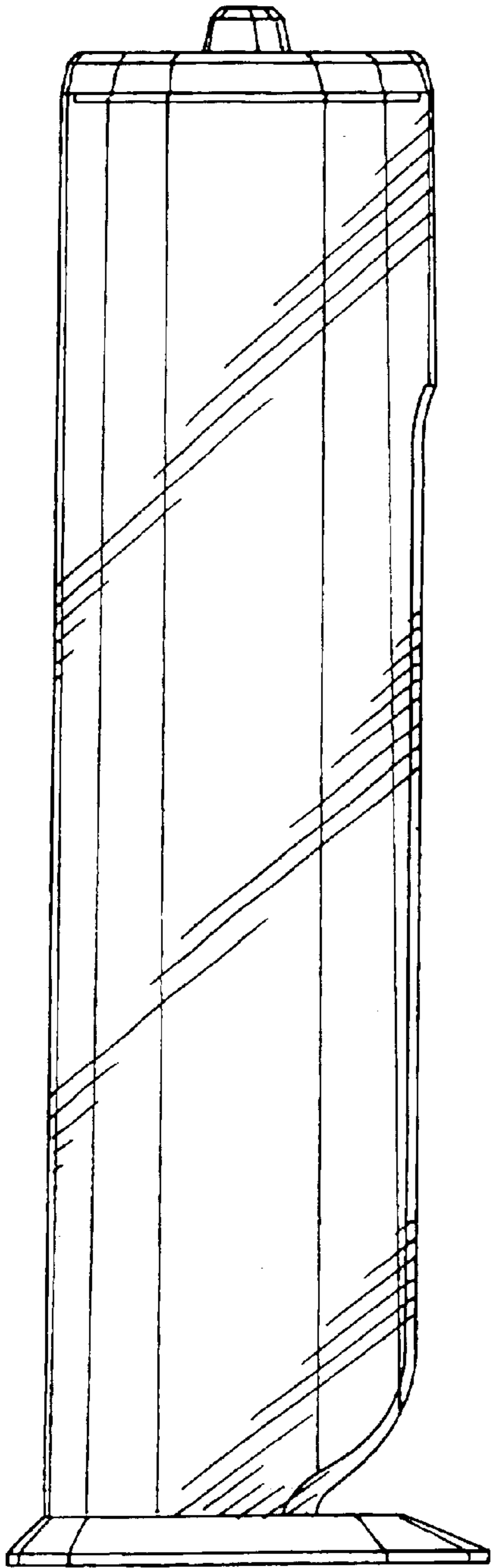

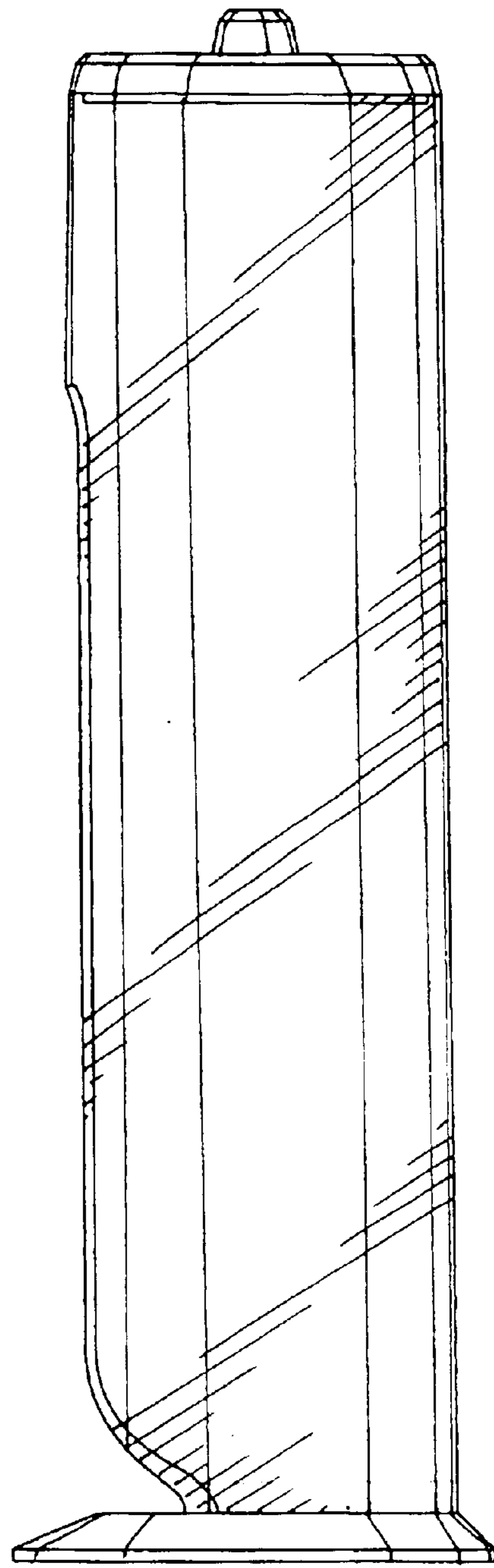

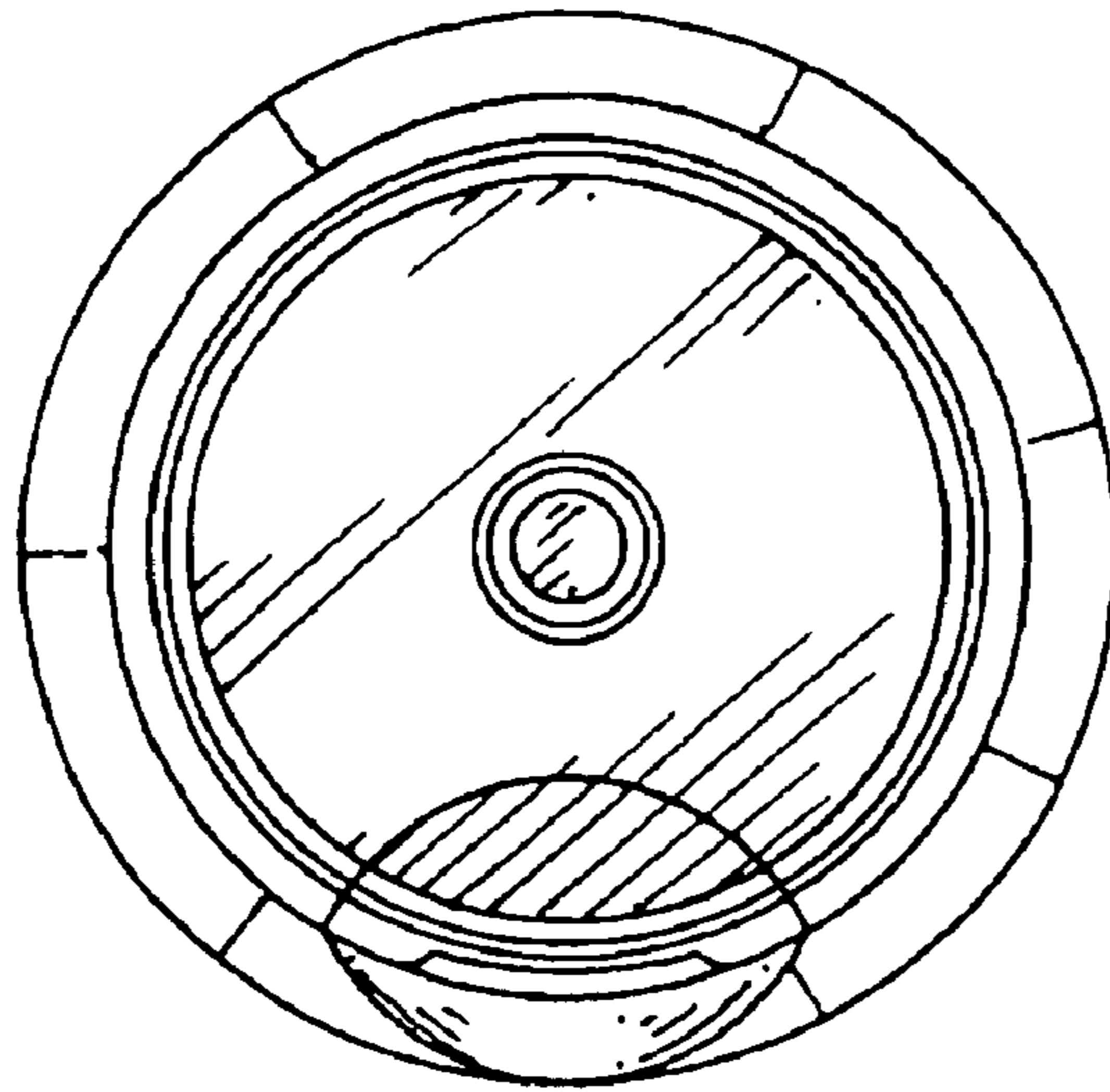

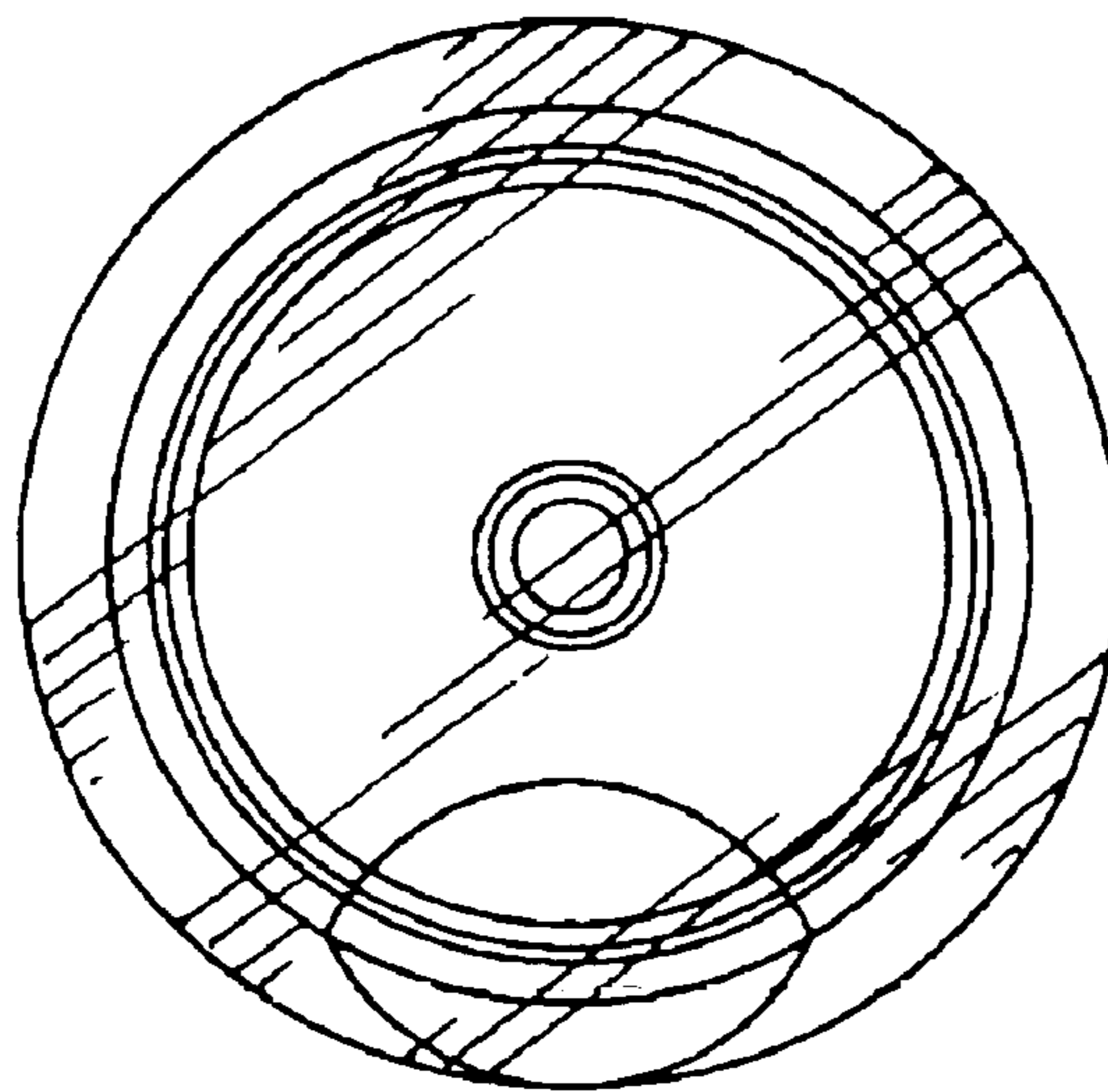

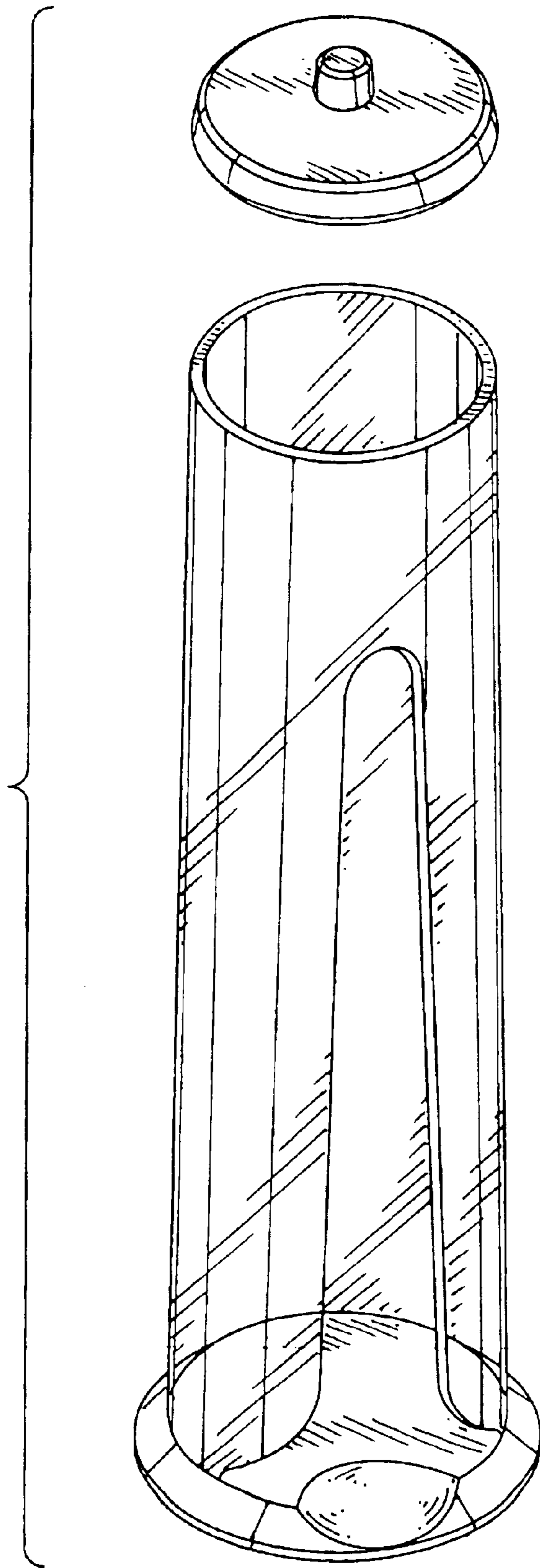
