FIG. 1 is a perspective view of a lamp according to the present invention.

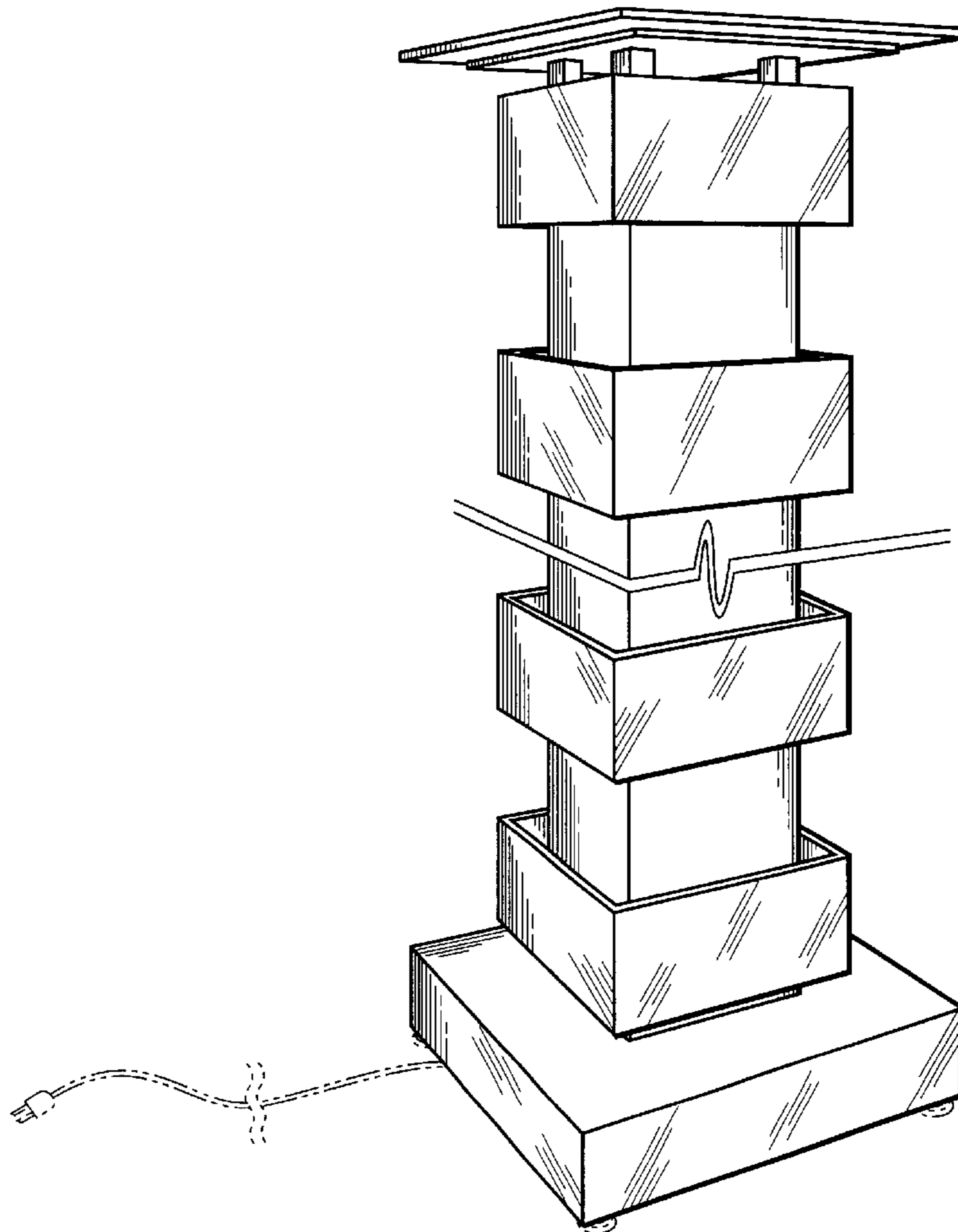
FIG. 2 is a side view of the lamp of FIG. 1; and,

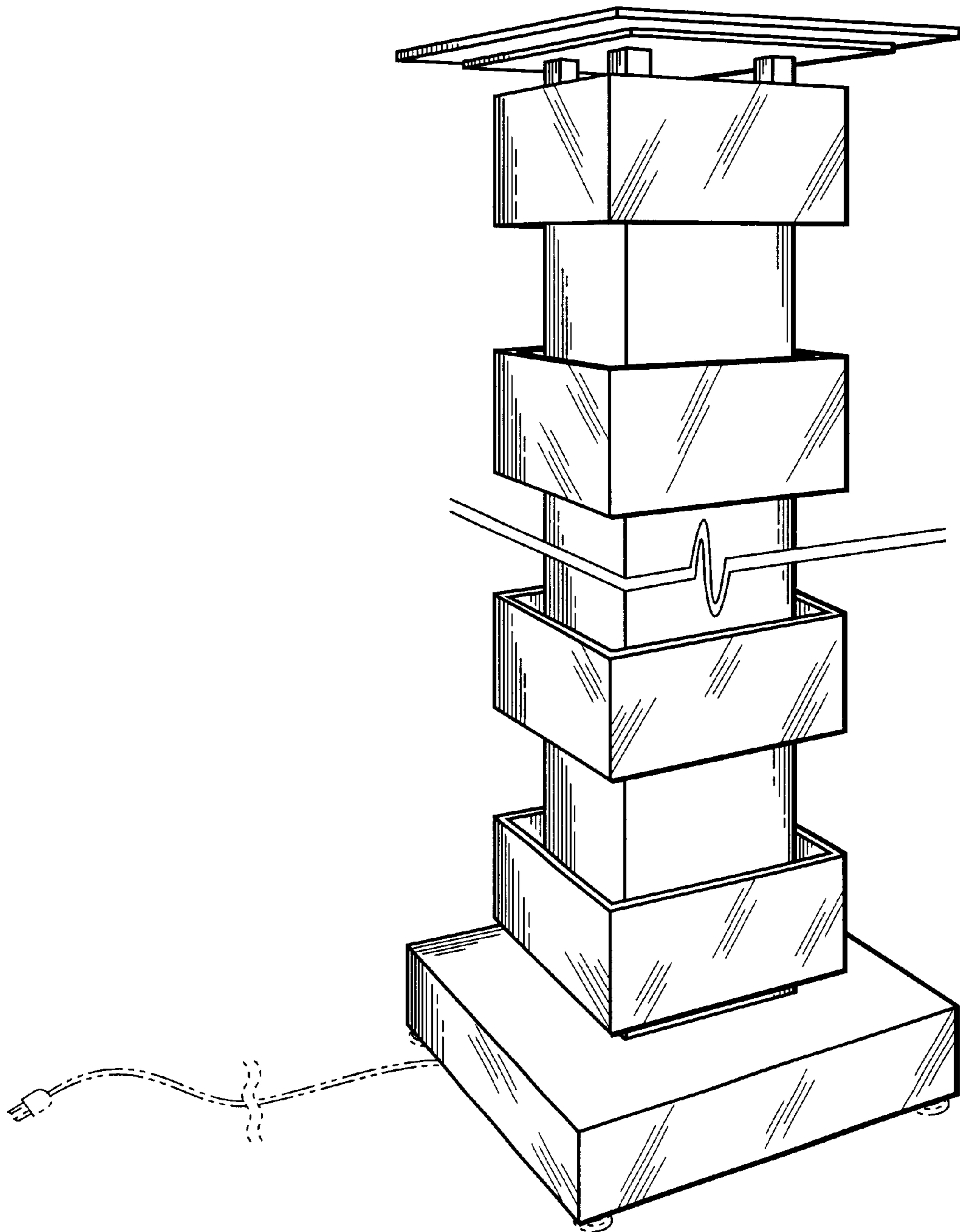

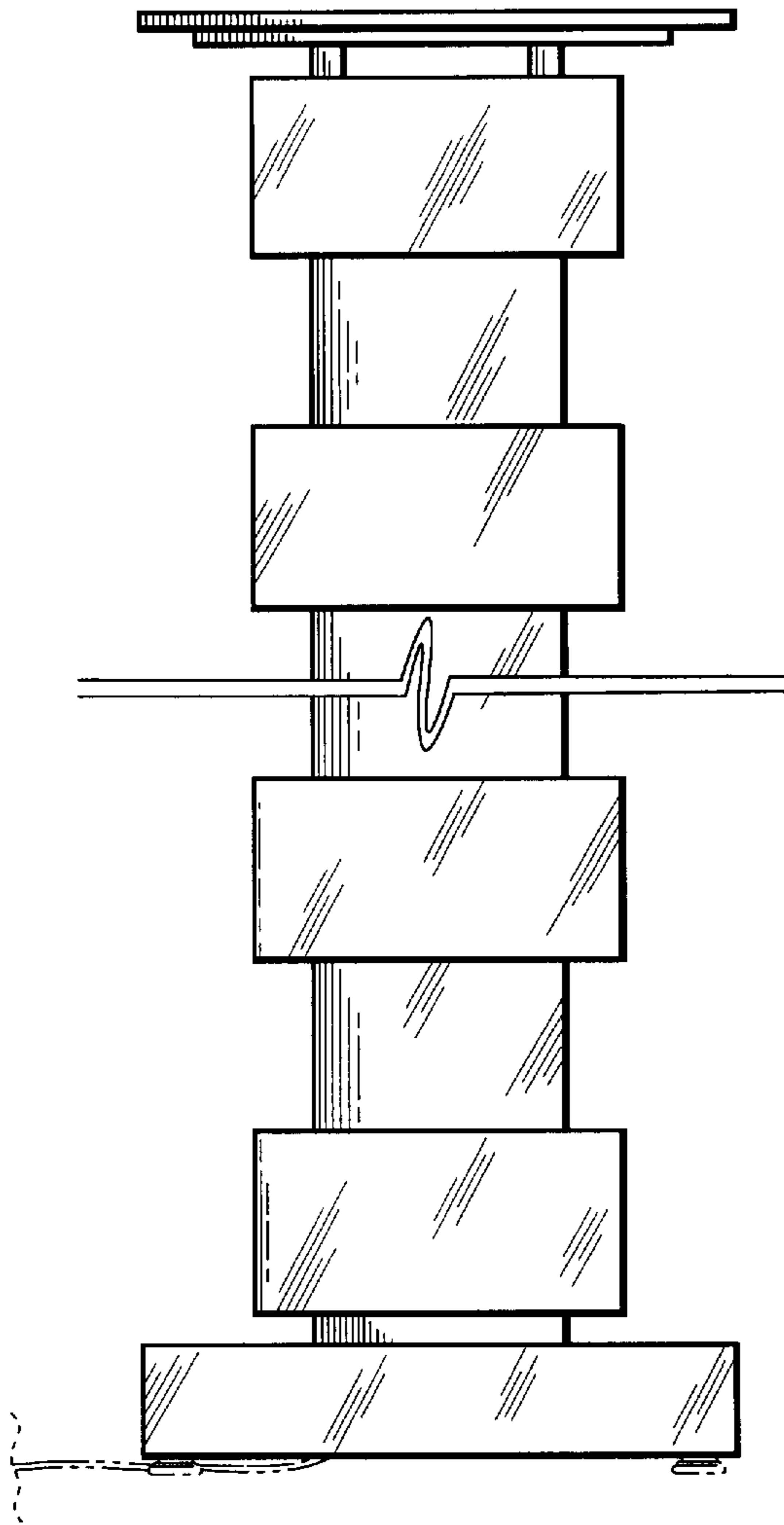
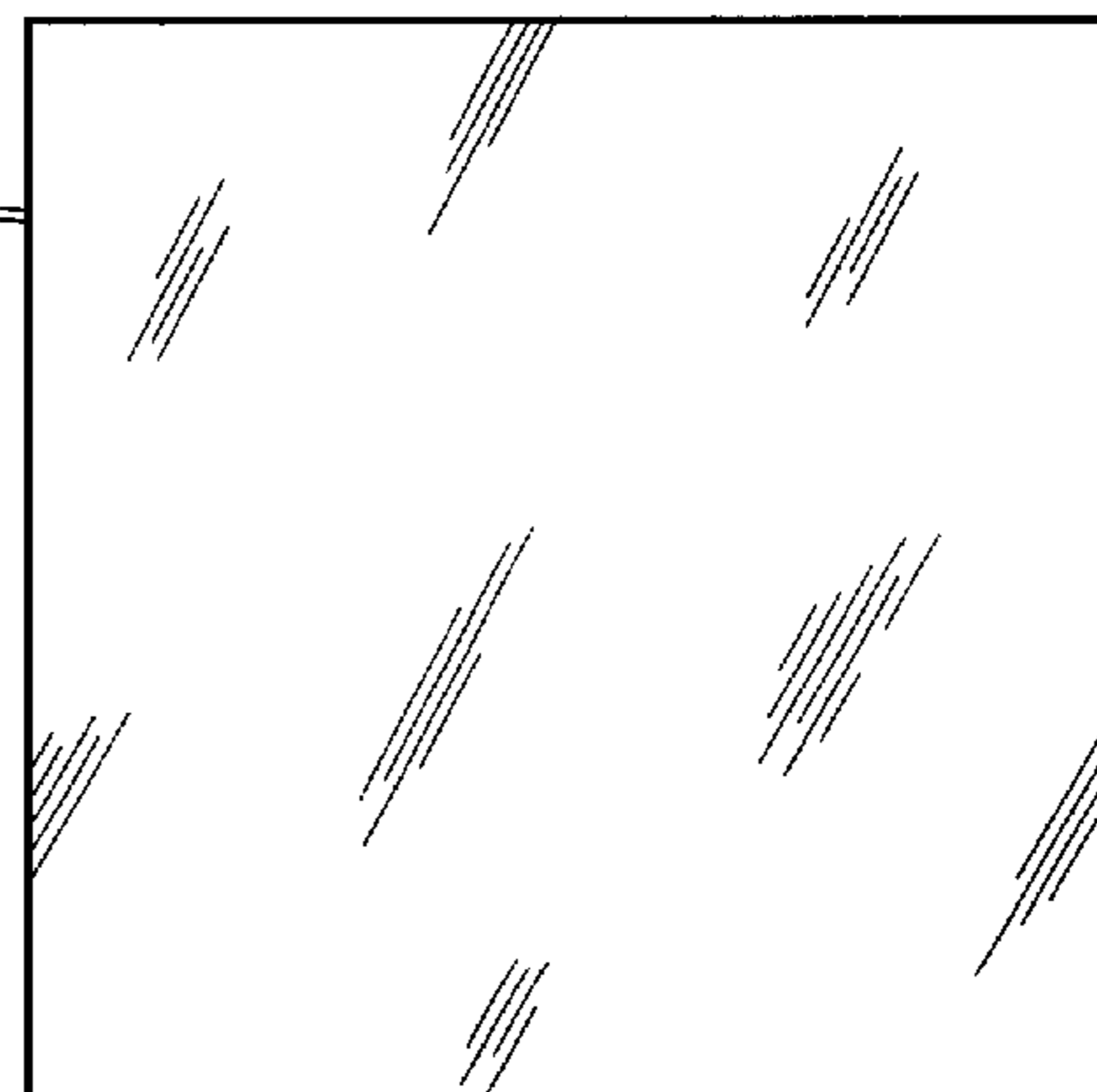
