(57) **CLAIM**

The ornamental design for a hairdryer, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of my new design for a hairdryer, the honey comb structure of the back cover underneath the back ring is shown in dotted lines which is for illustrative purposes only and is not part of the claimed design.

FIG. 2 is a right or left side elevation view, which are mirror images, of FIG. 1, the honey comb structure of the back cover underneath the back ring is shown in dotted lines which is for illustrative purposes only and is not part of the claimed design.

FIG. 3 is a bottom plan view of FIG. 1, the honey comb structure of the back cover underneath the back ring is shown in dotted lines which is for illustrative purposes only and is not part of the claimed design.

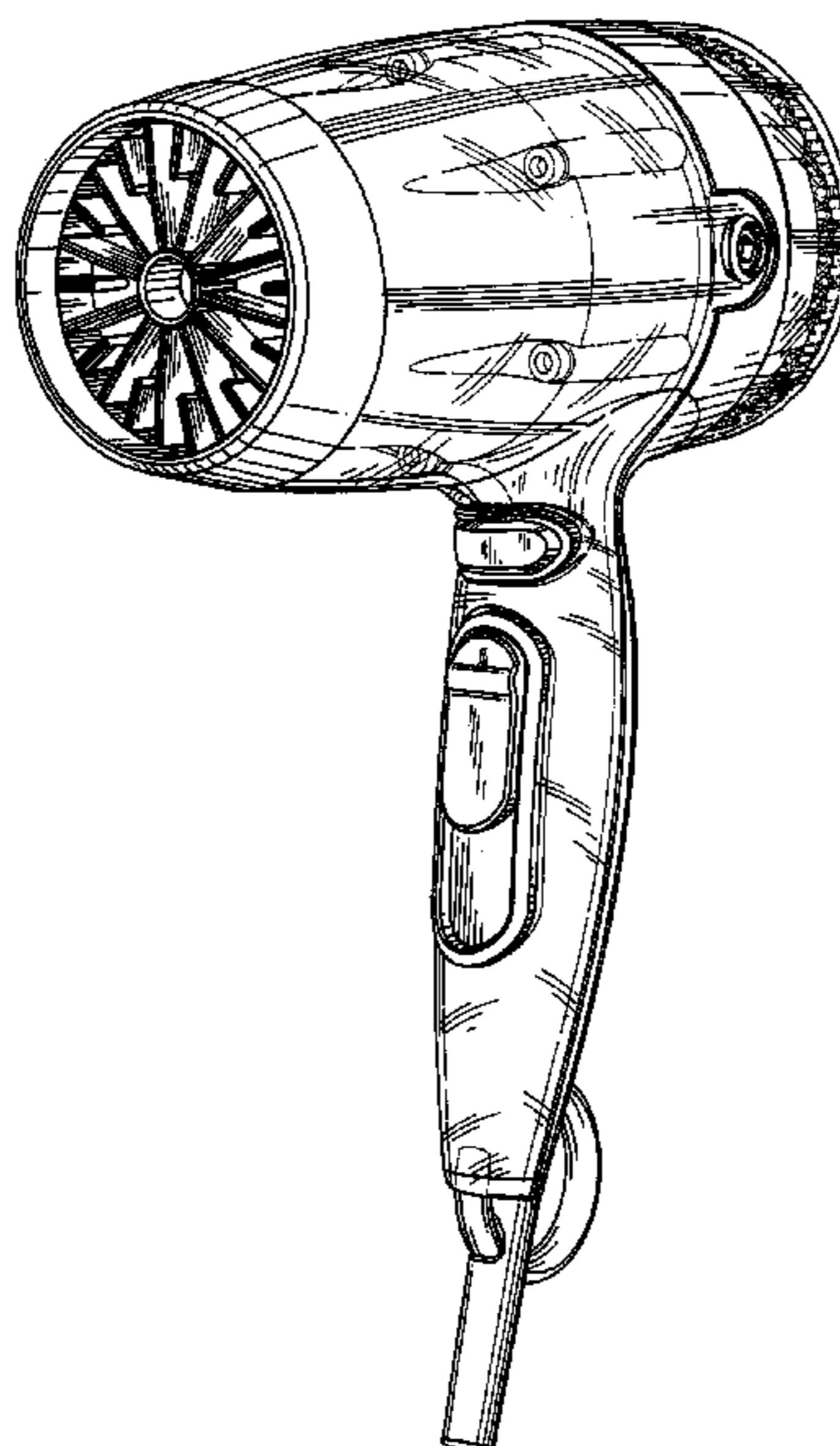
FIG. 4 is a top plan view of FIG. 1 the honey comb structure of the back cover underneath the back ring is shown in dotted lines which is for illustrative purposes only and is not part of the claimed design.

FIG. 5 is a front side elevation view of FIG. 1; and,

FIG. 6 is a back side elevation view of FIG. 1.

The claimed hairdryer has in the area of the head, front of the grip and back segment of the head a translucent or transparent shell.

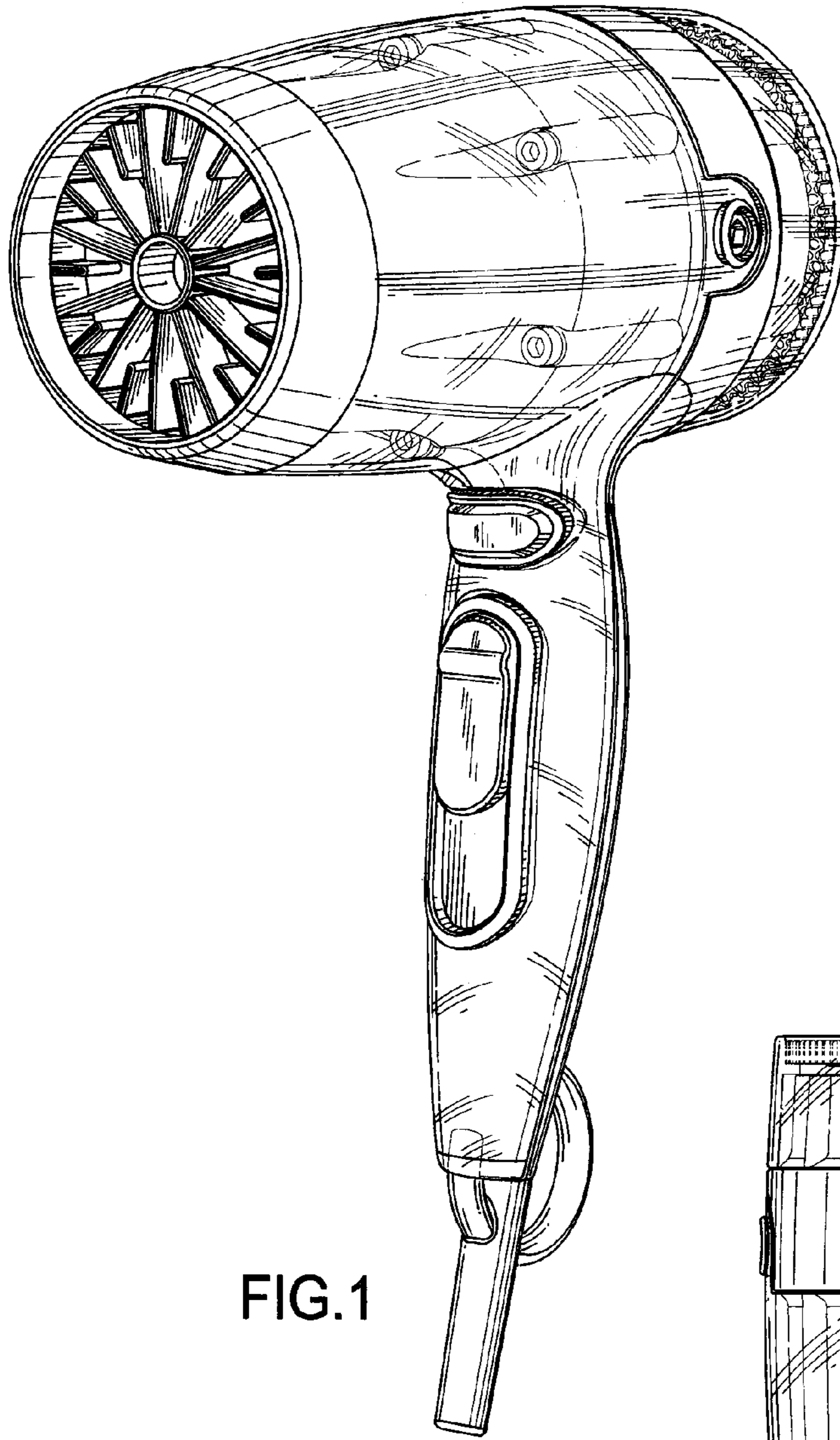

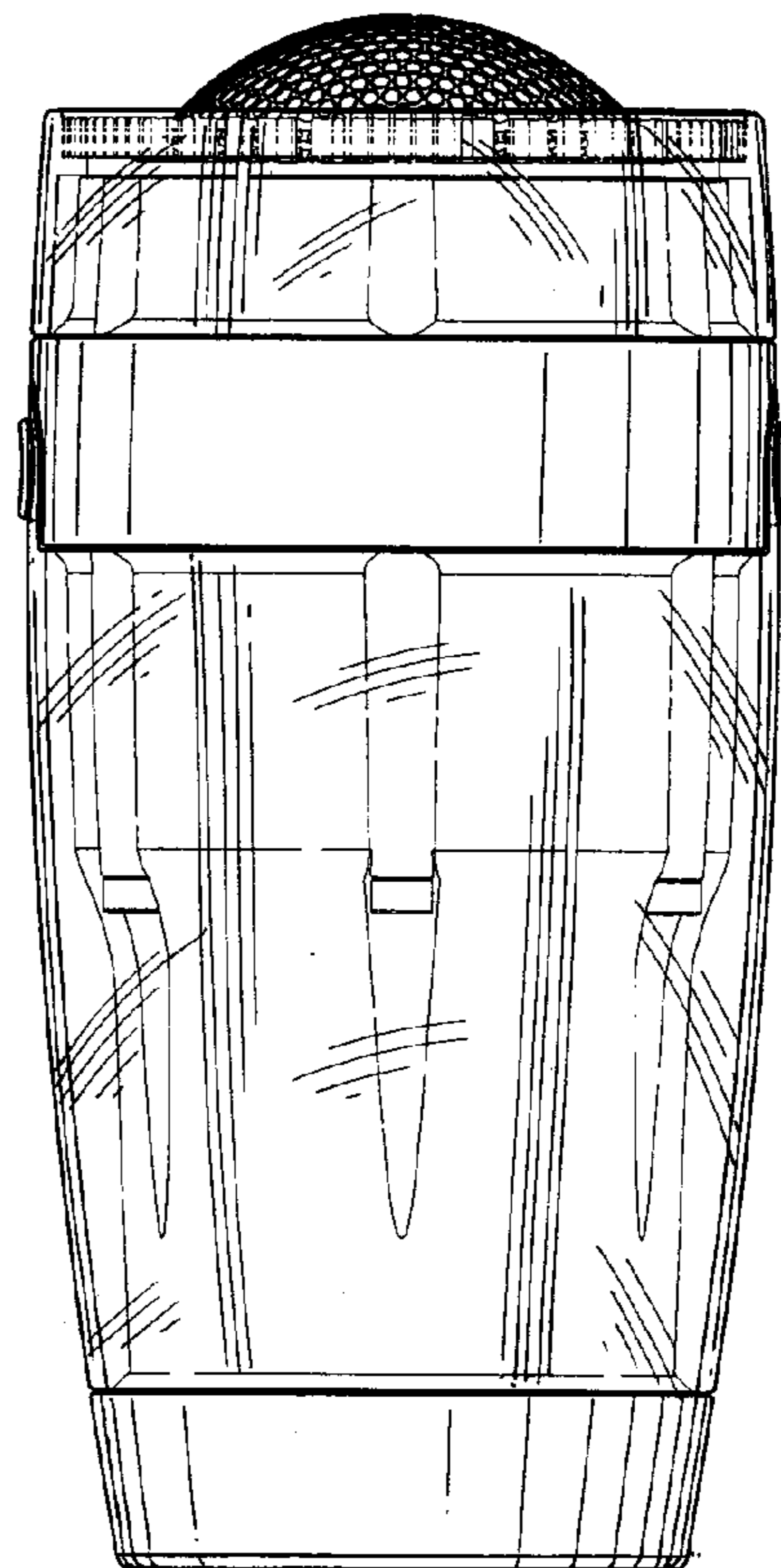

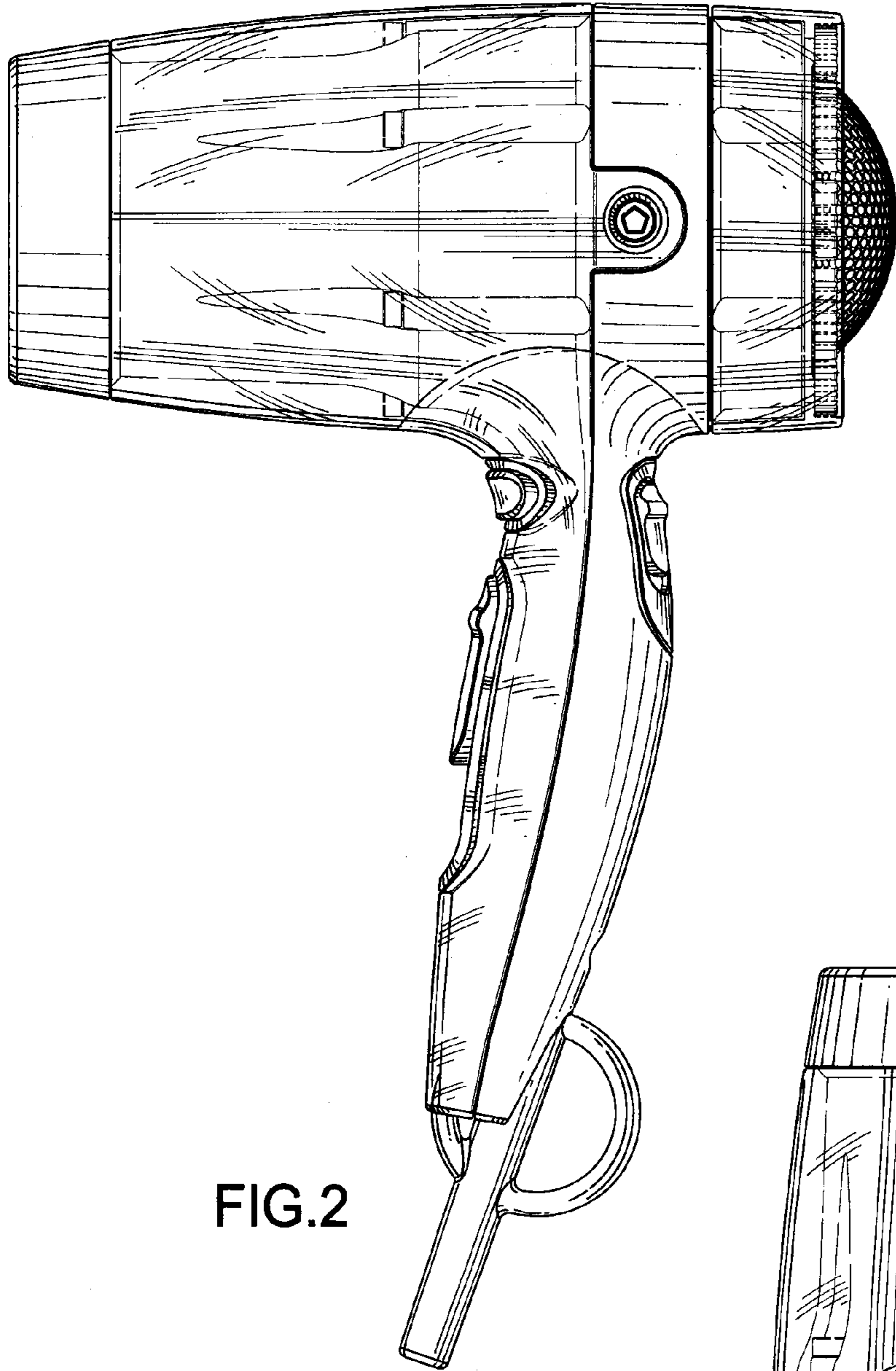

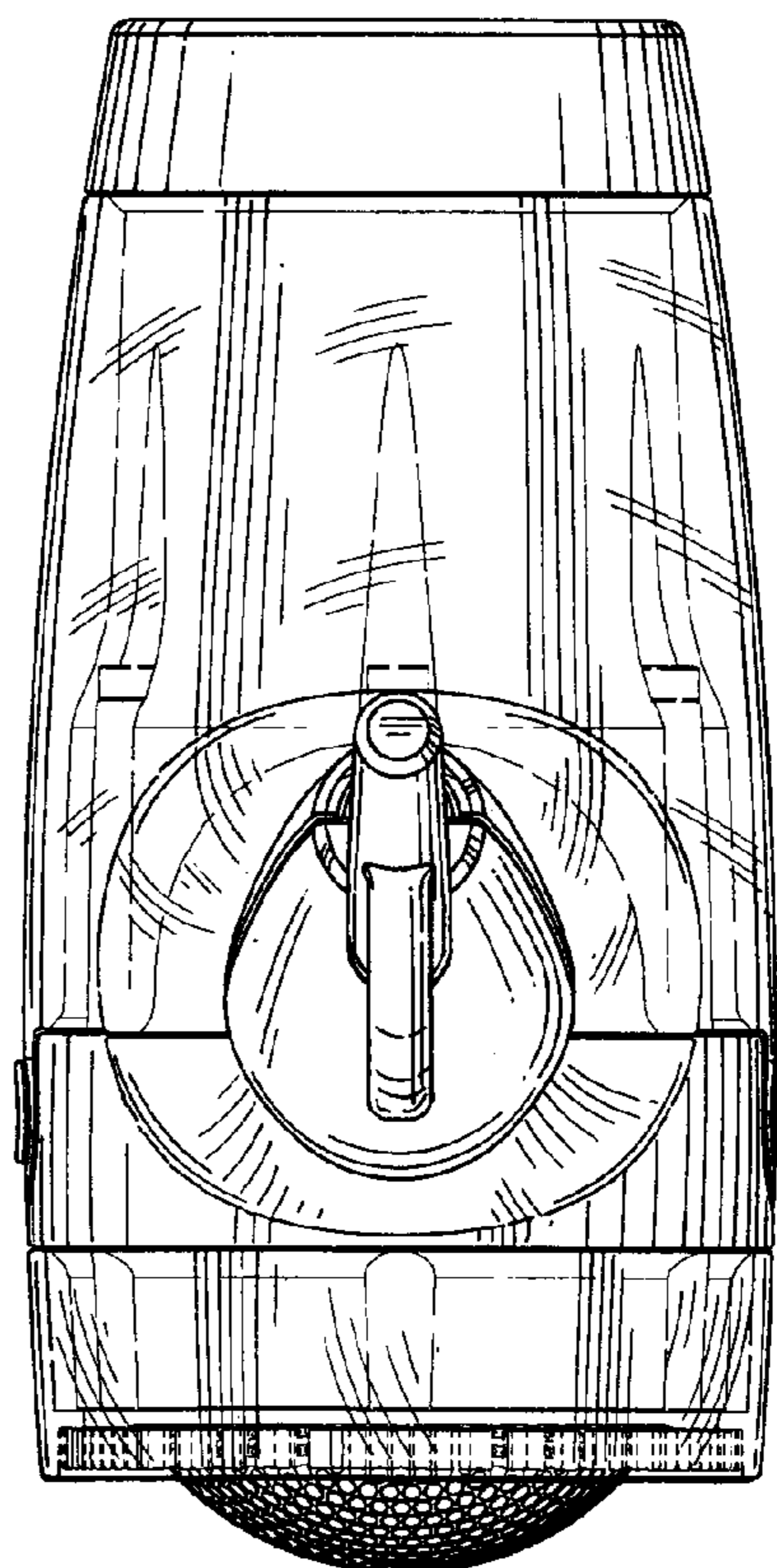

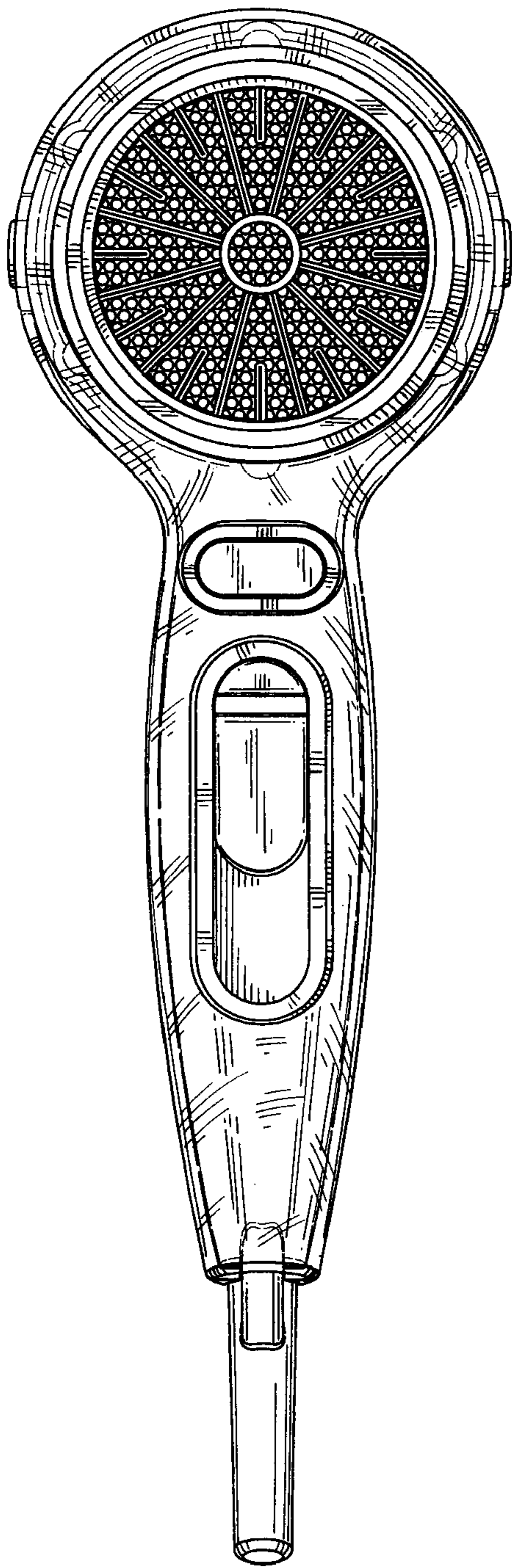

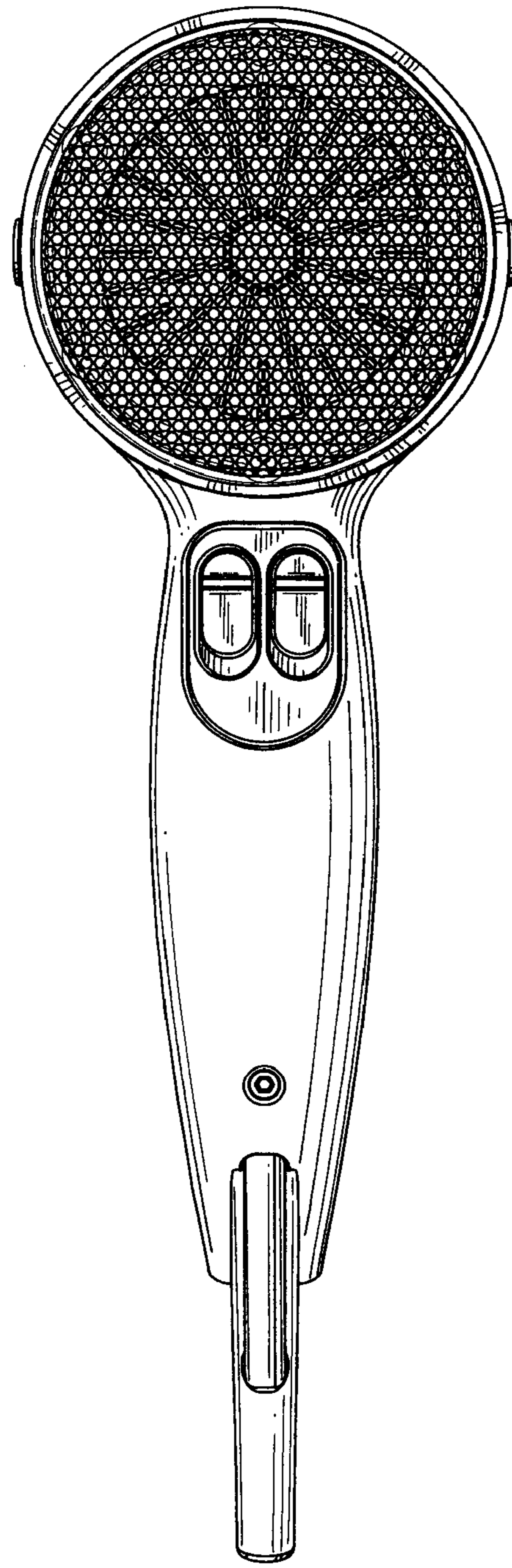
