The ornamental design for a laundry dryer, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a laundry dryer showing our new design;

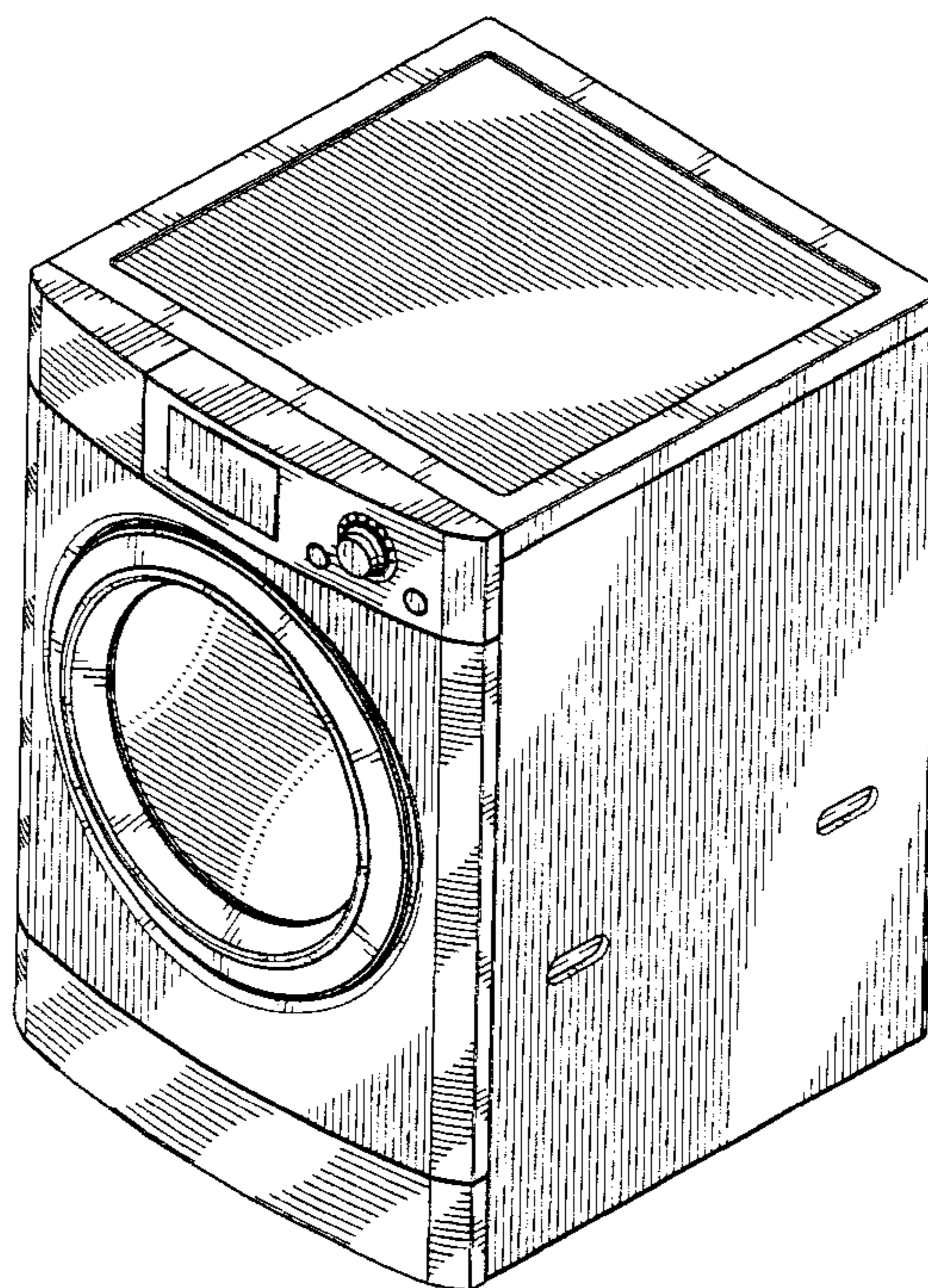

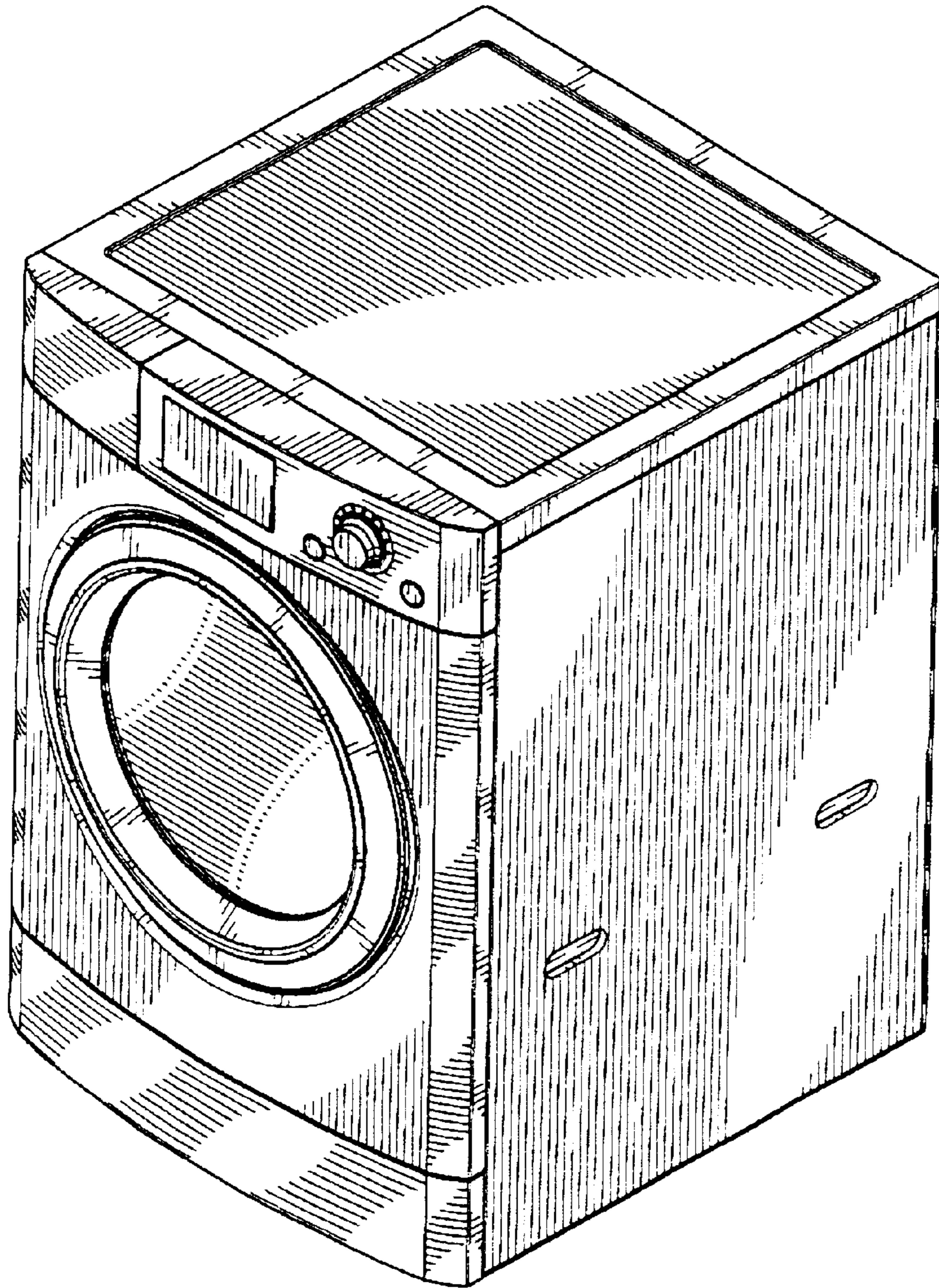
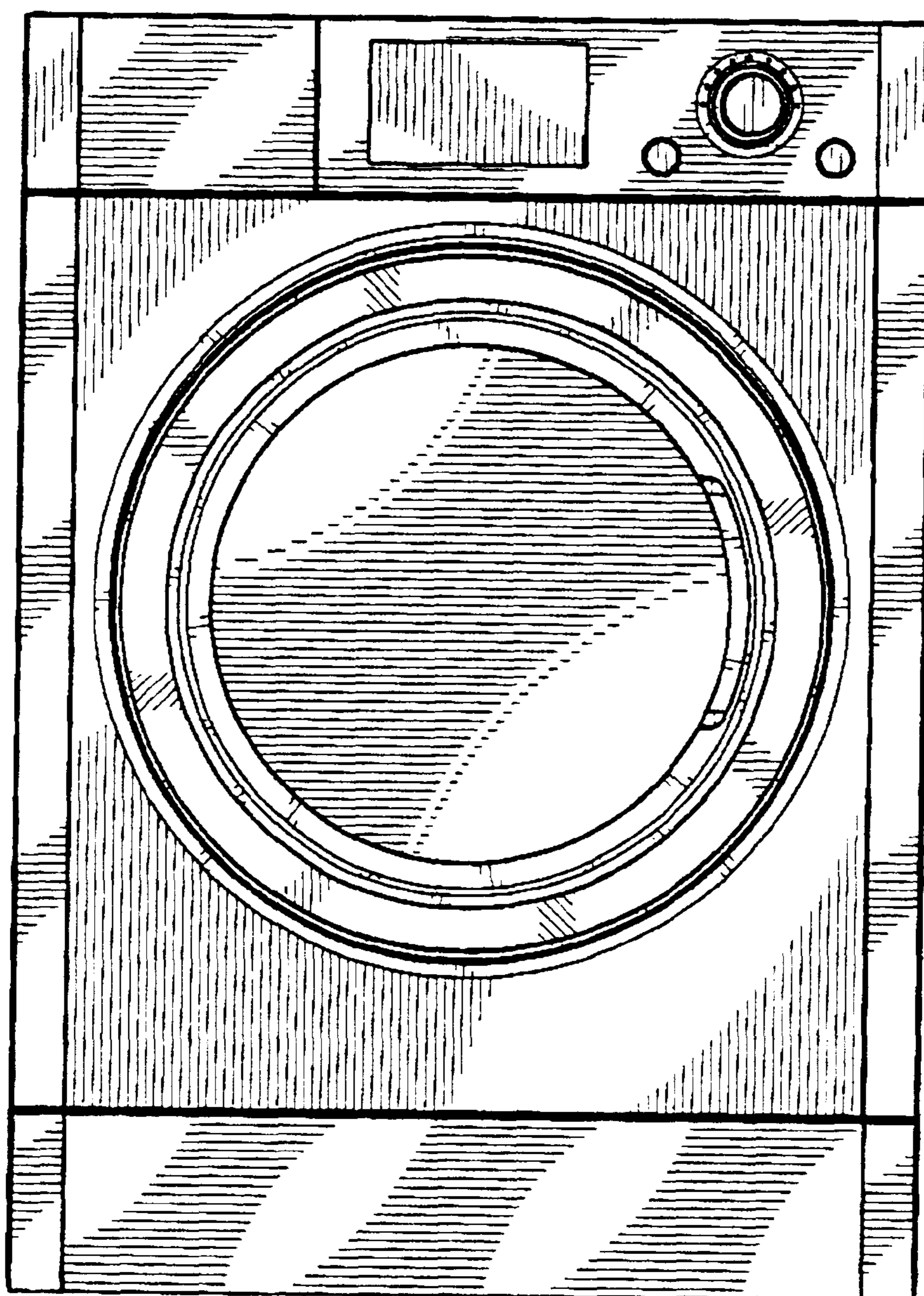

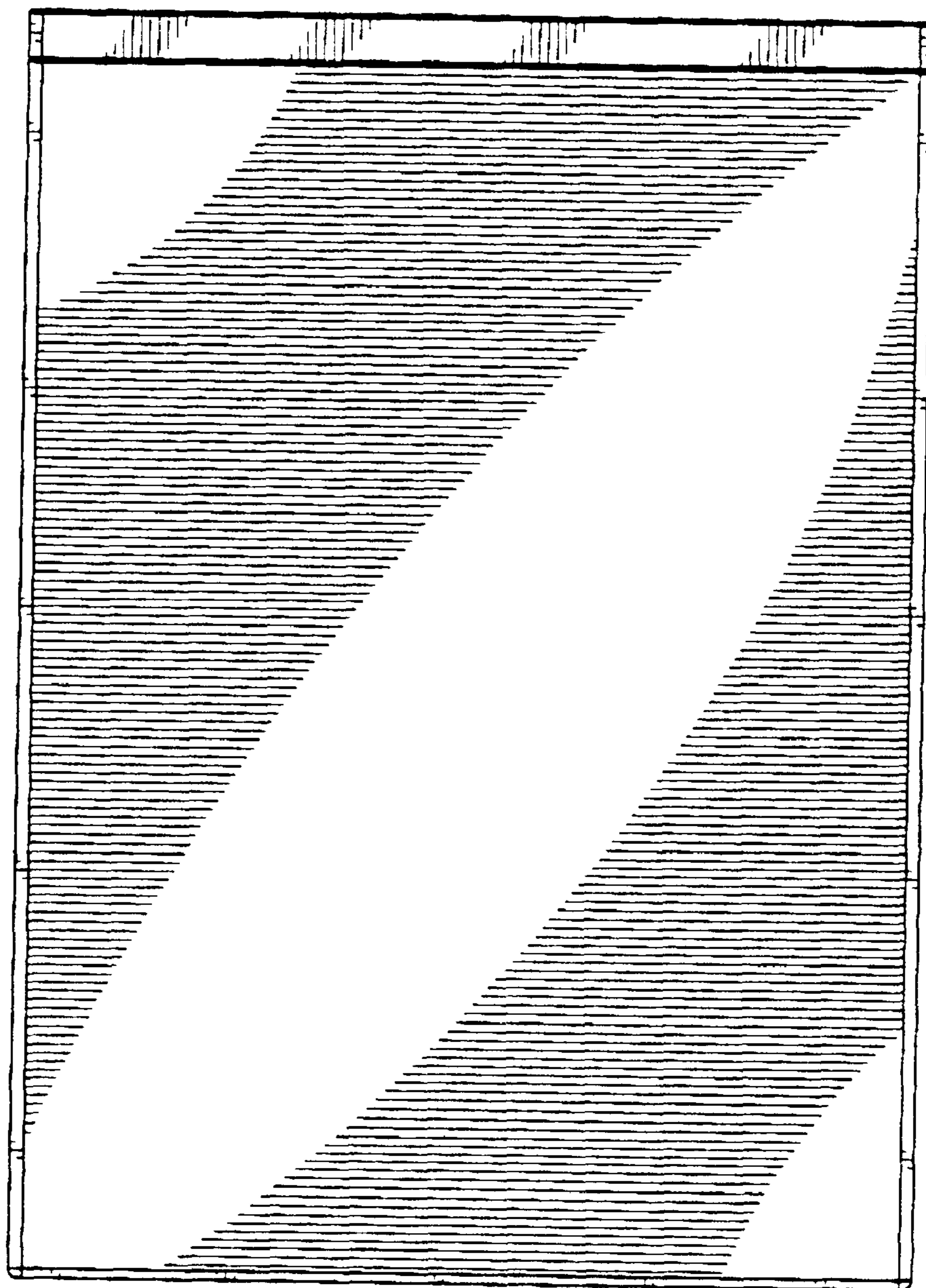

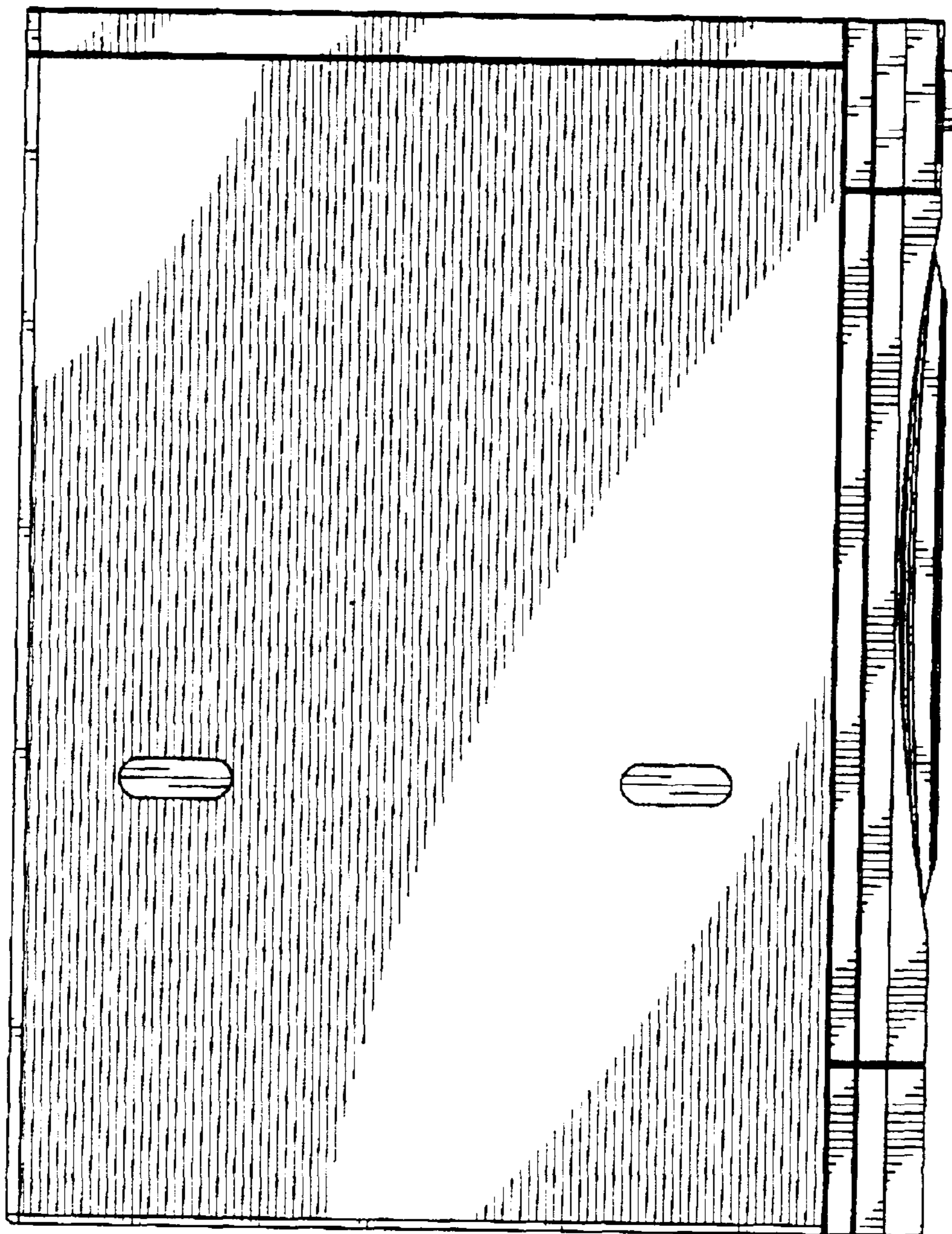

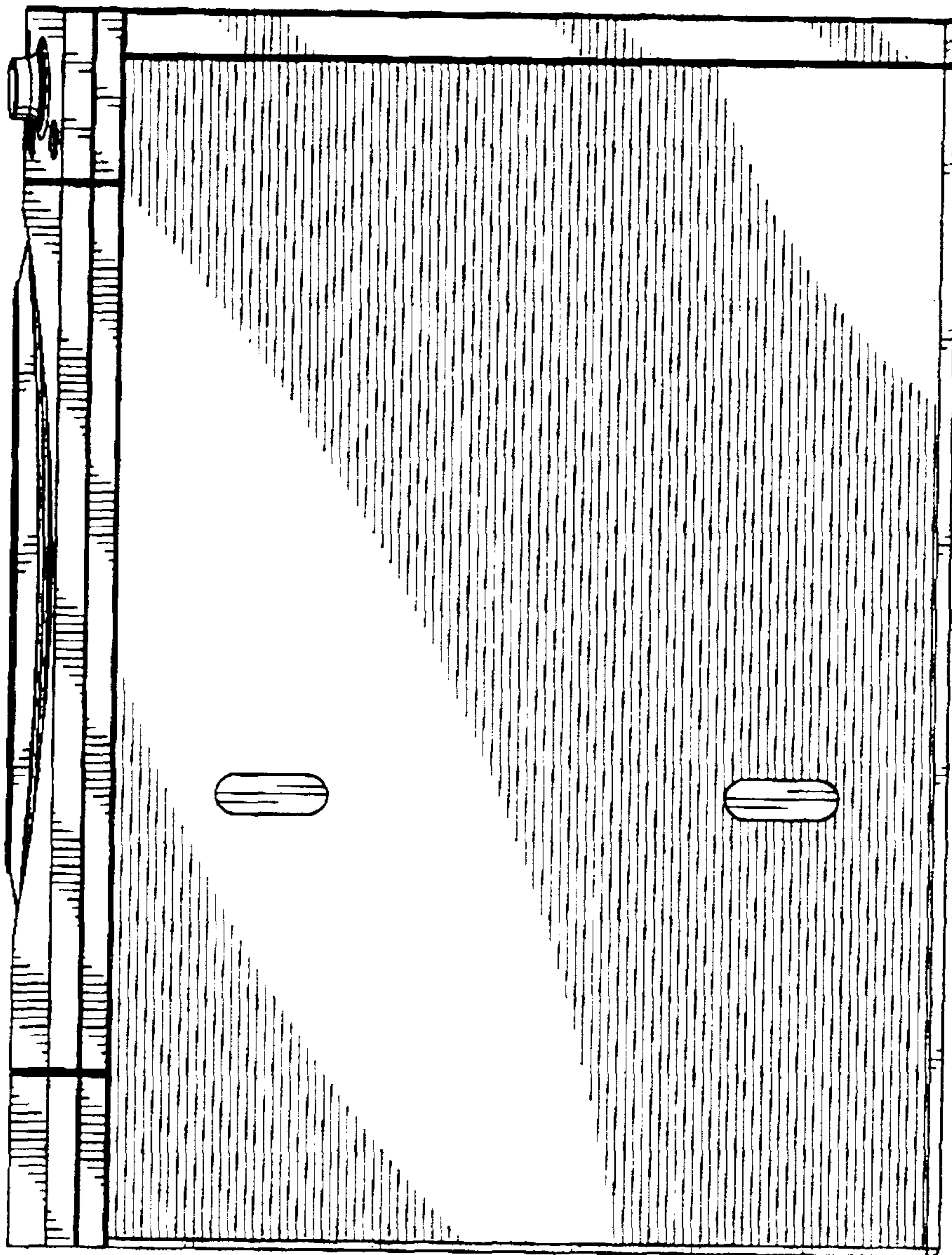

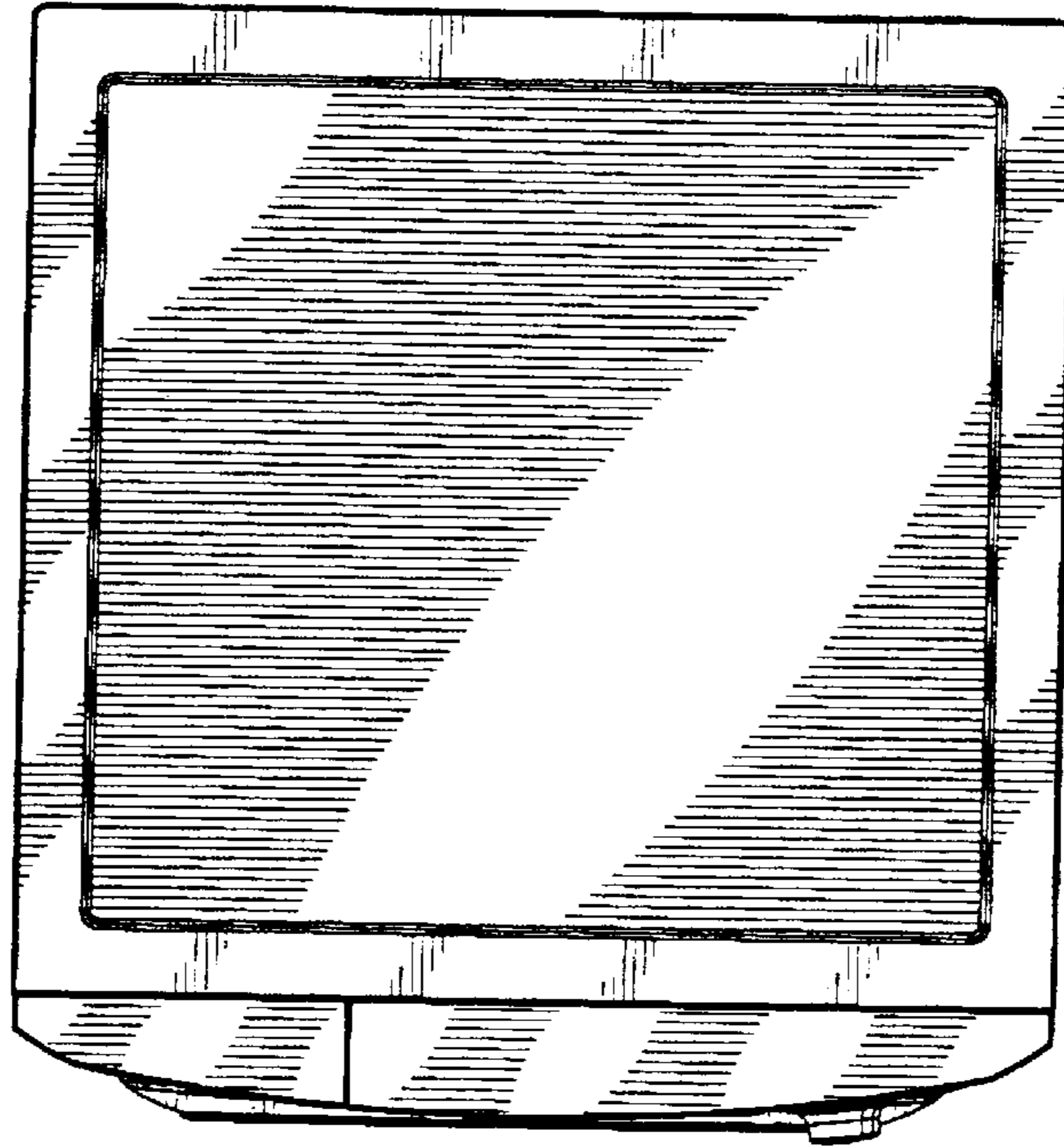

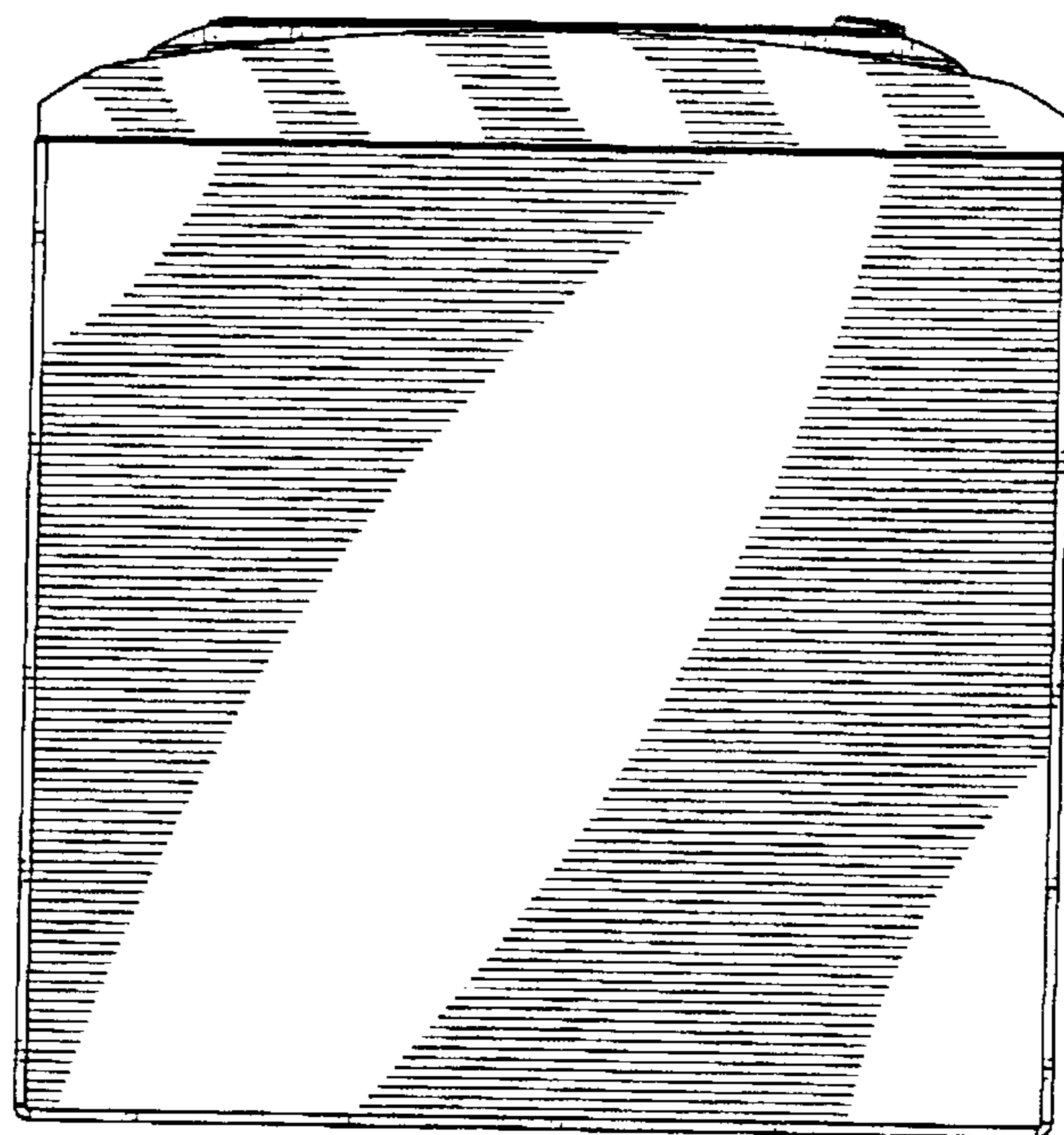

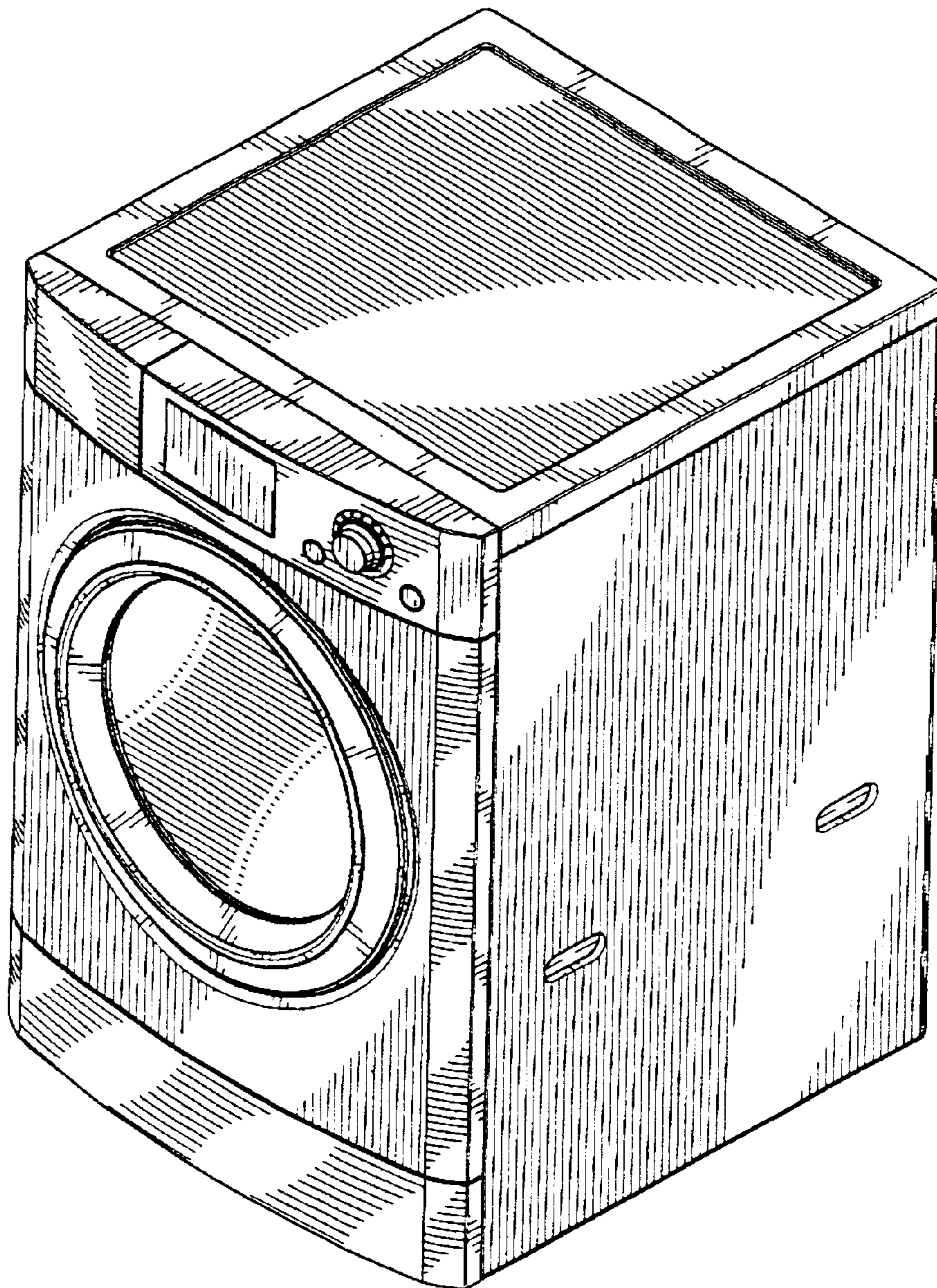
