**DESCRIPTION**

FIG. 2 is a side view thereof;

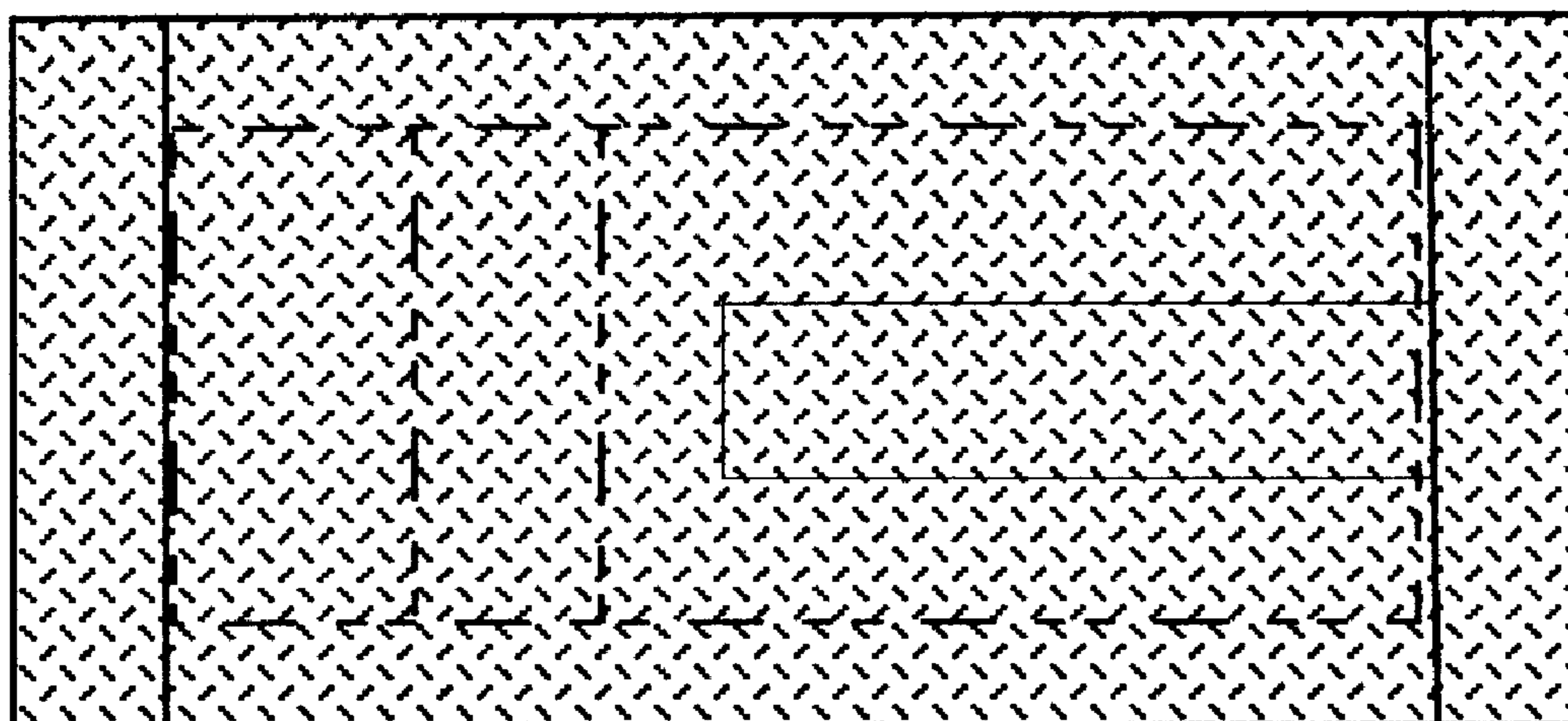
FIG. 3 is a front view, the rear view being the same thereof;

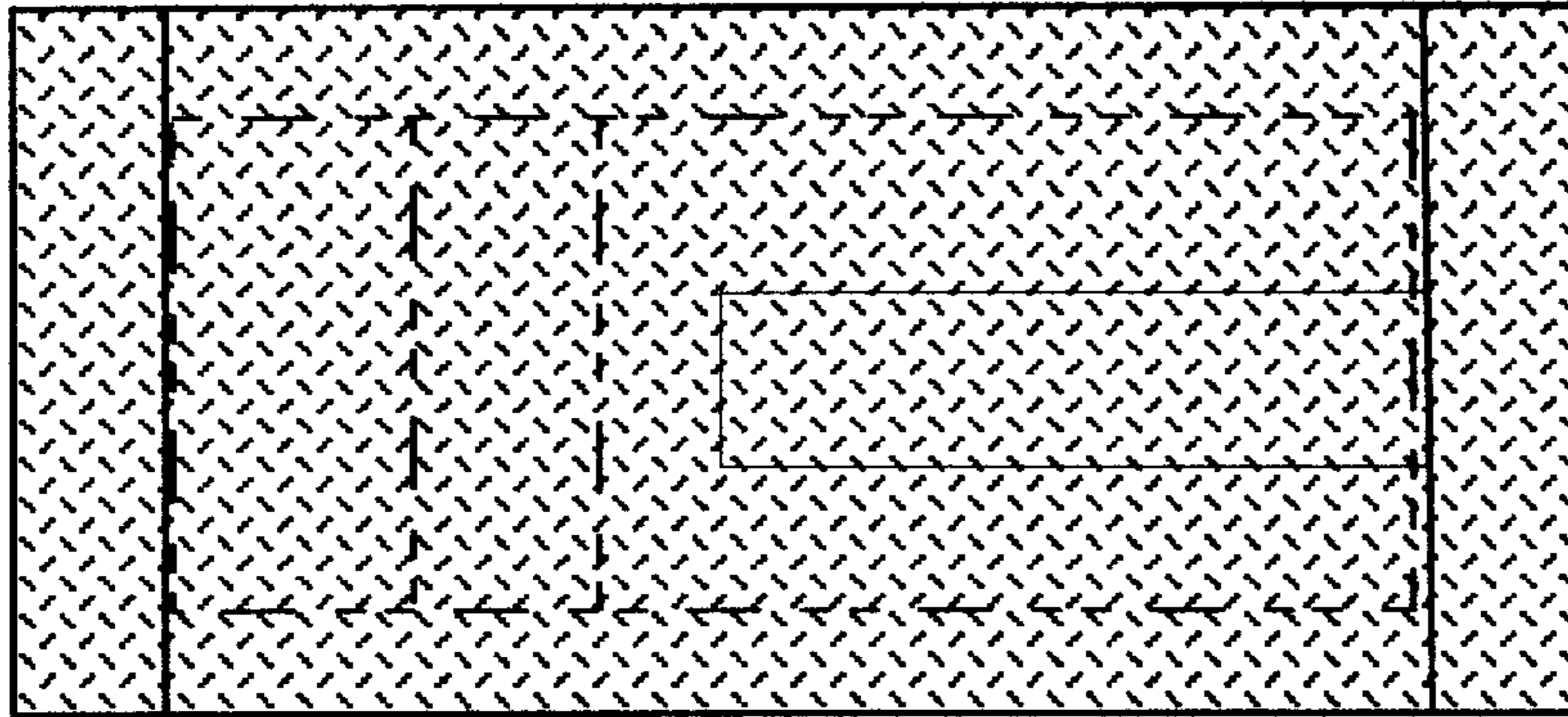

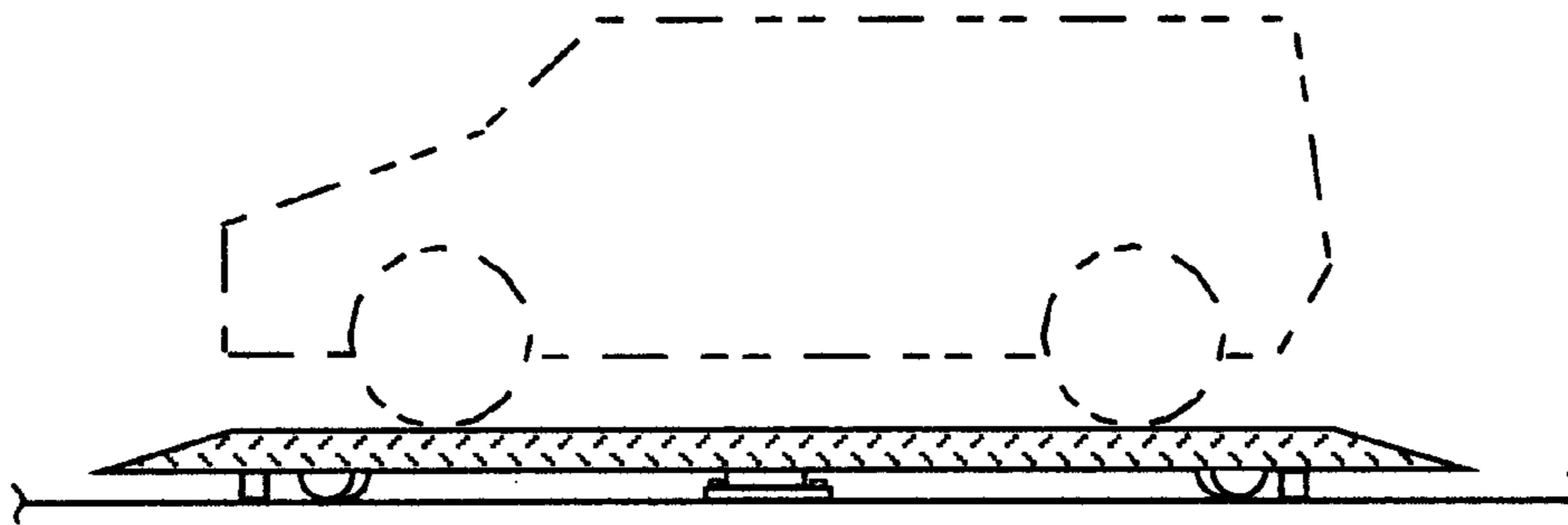

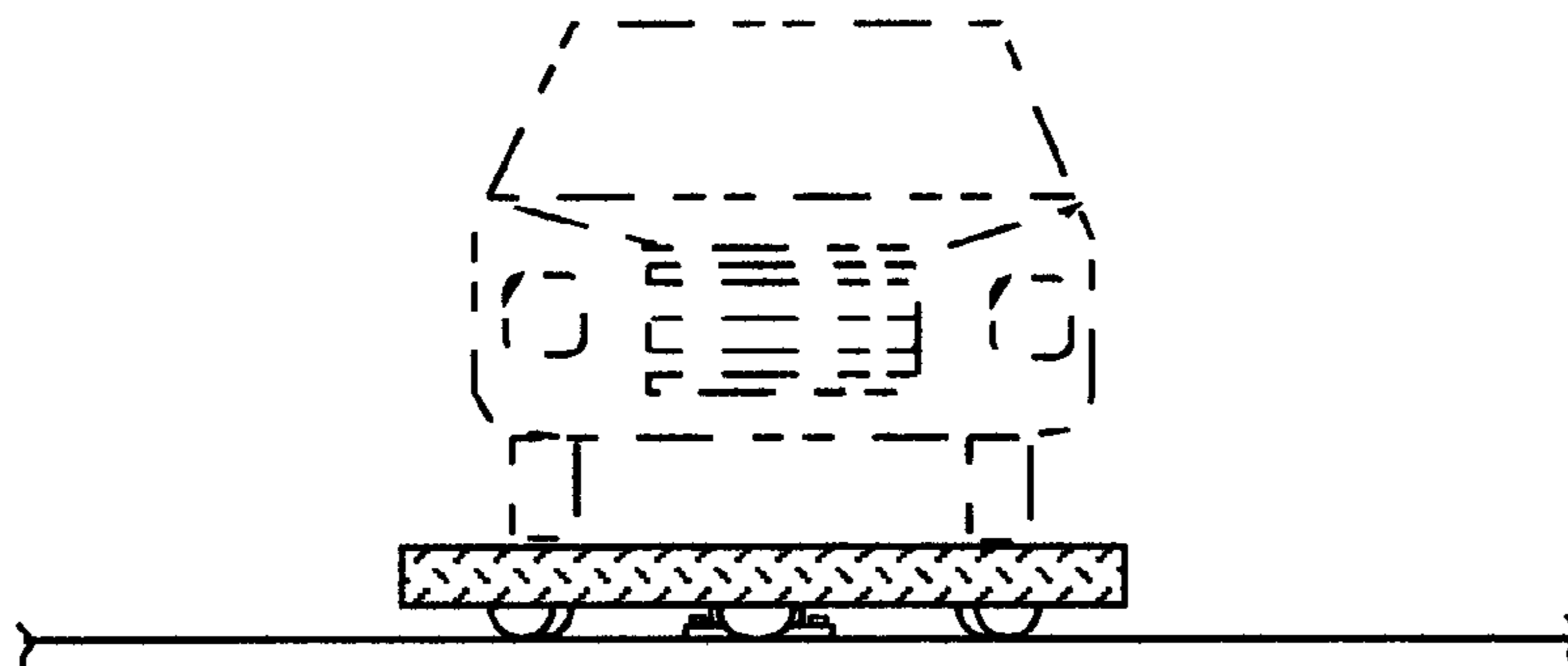

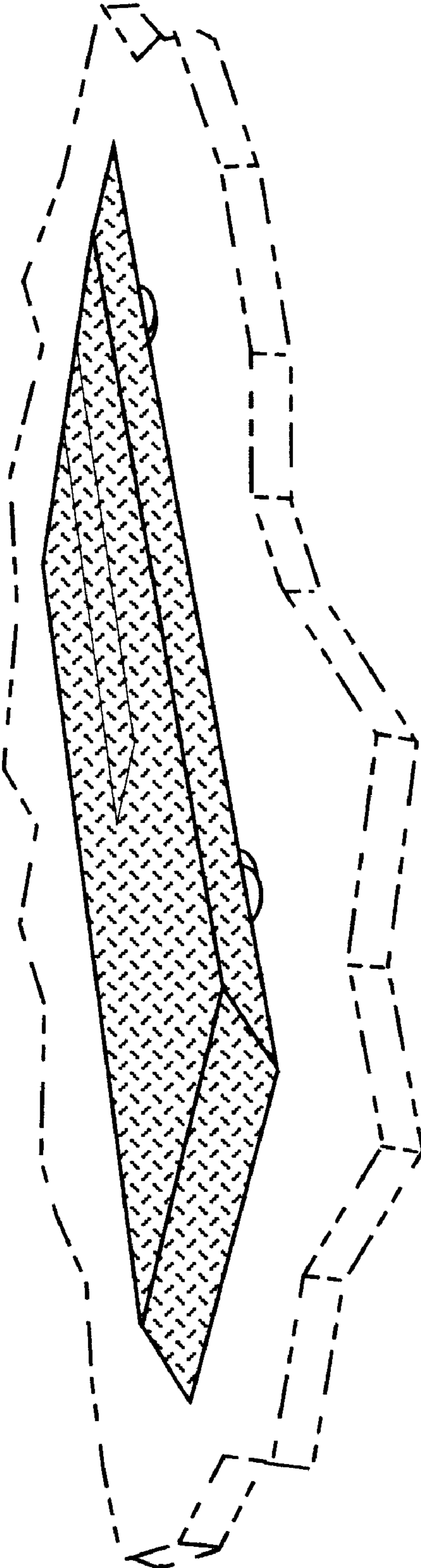

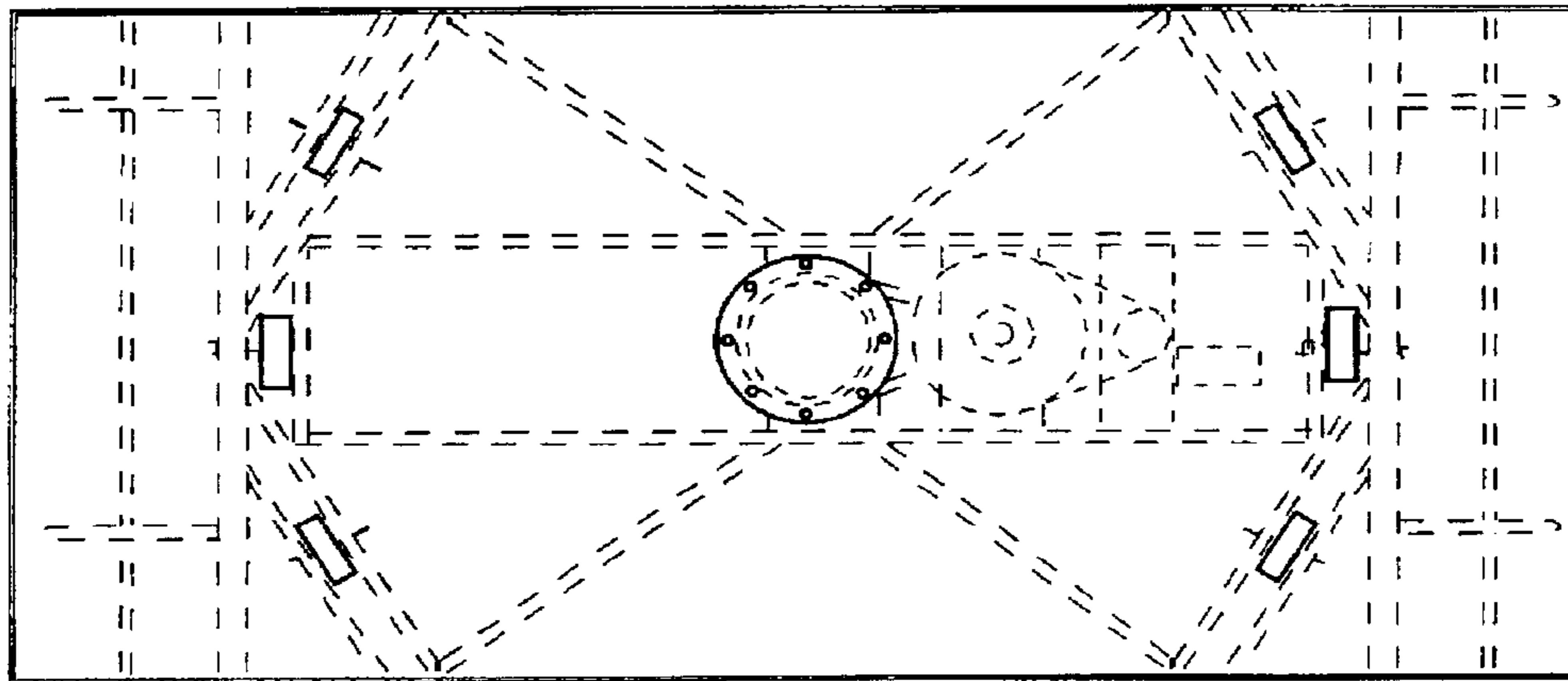
