sides of each piece having a similar appearance.

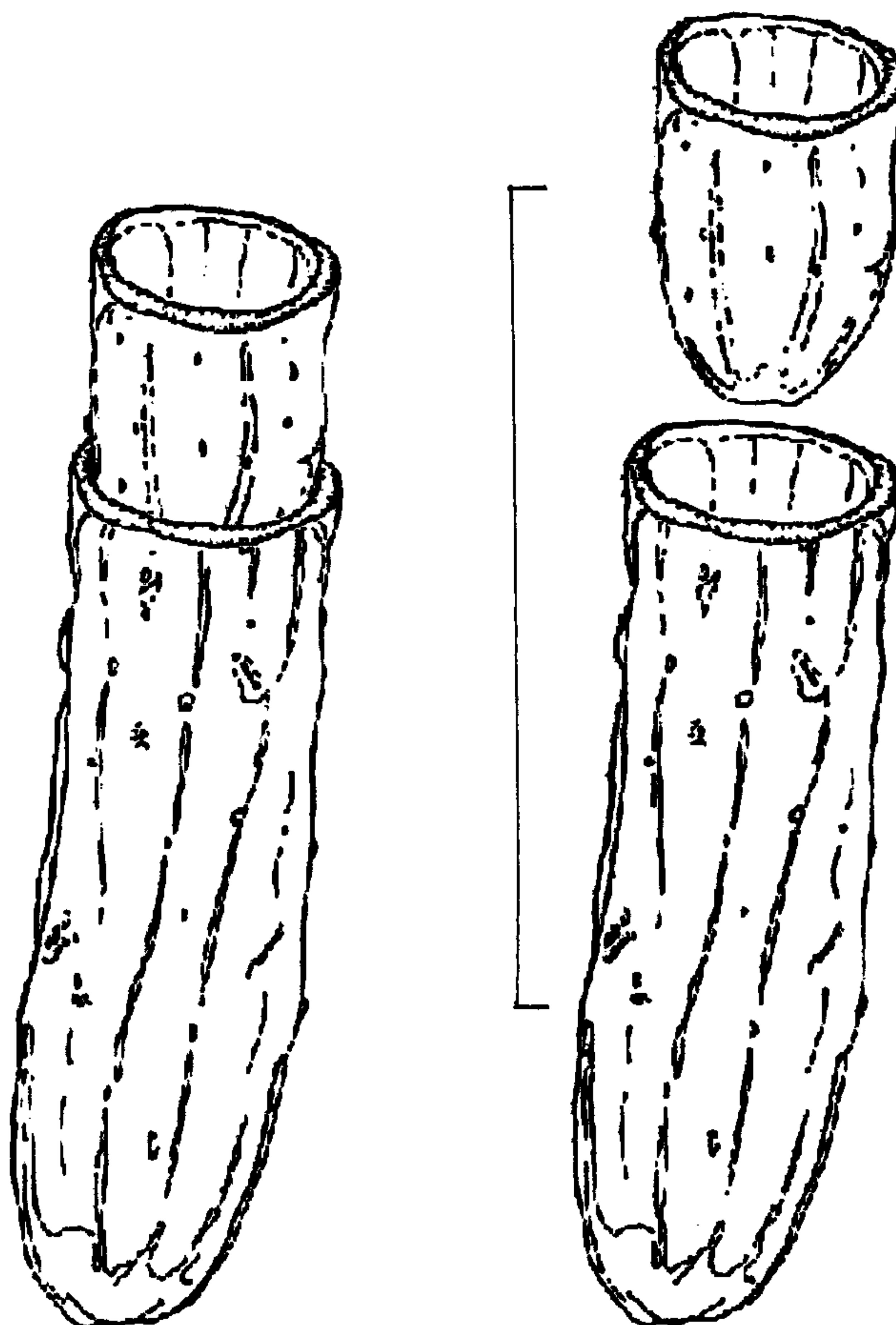
FIG. 3 is a top plan view thereof;

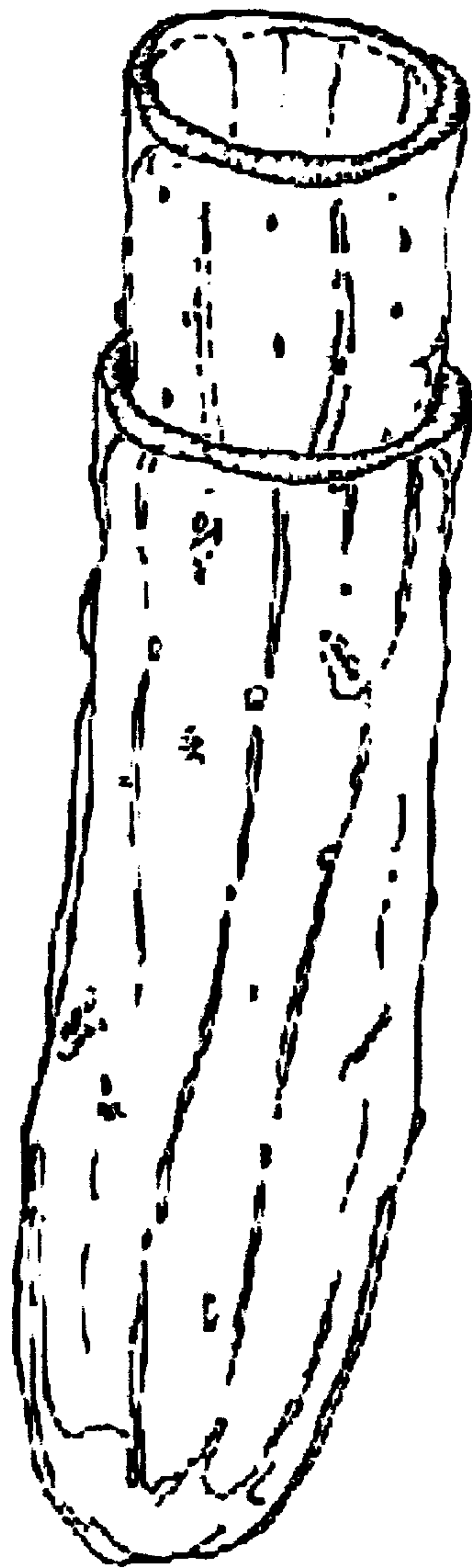

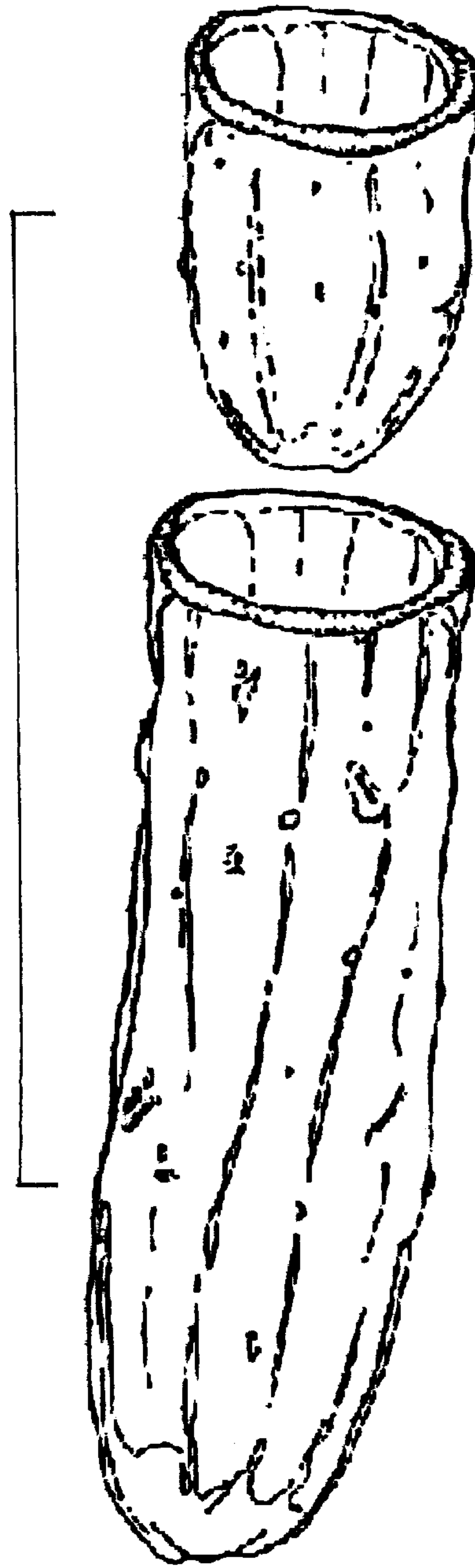

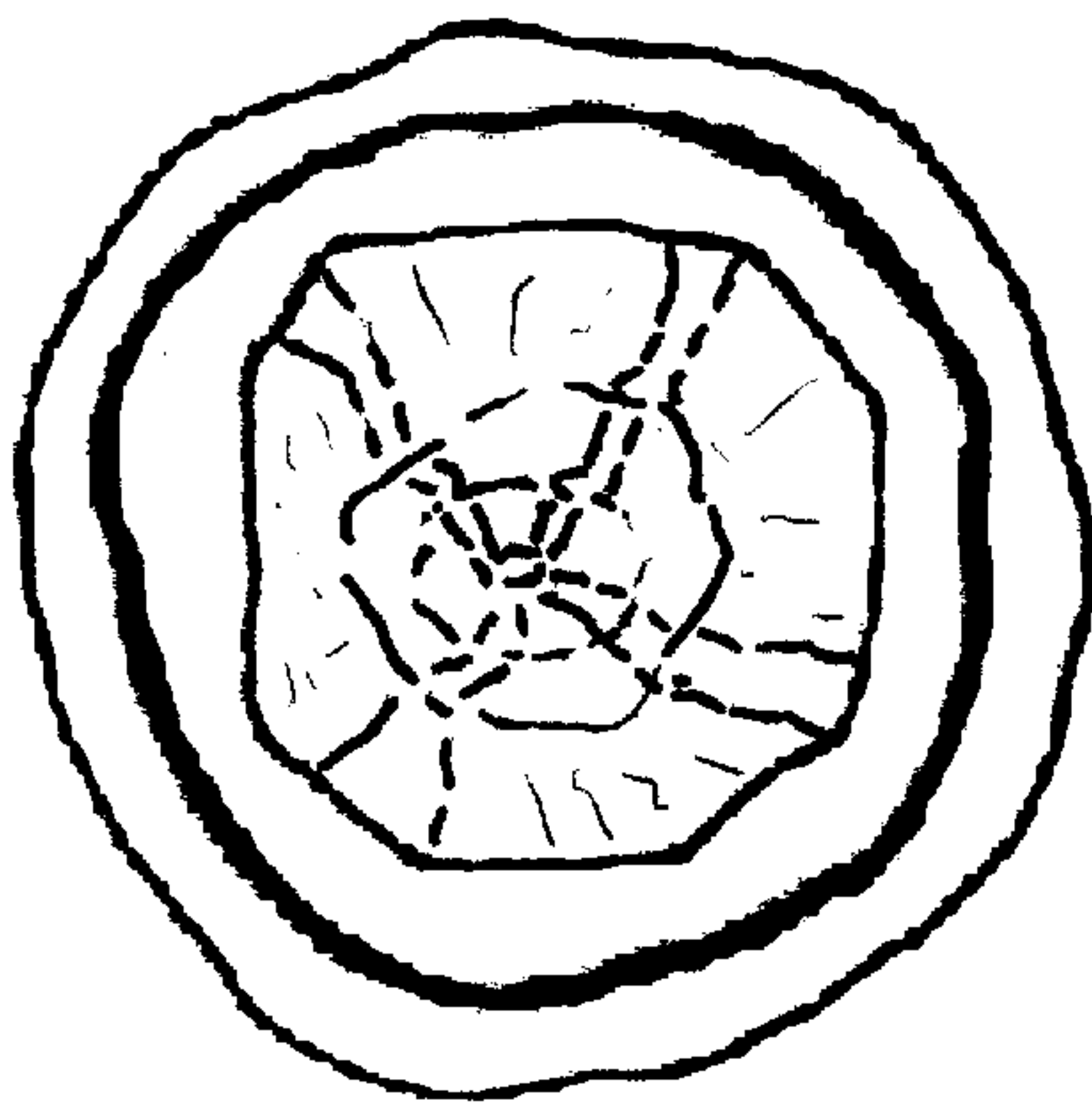

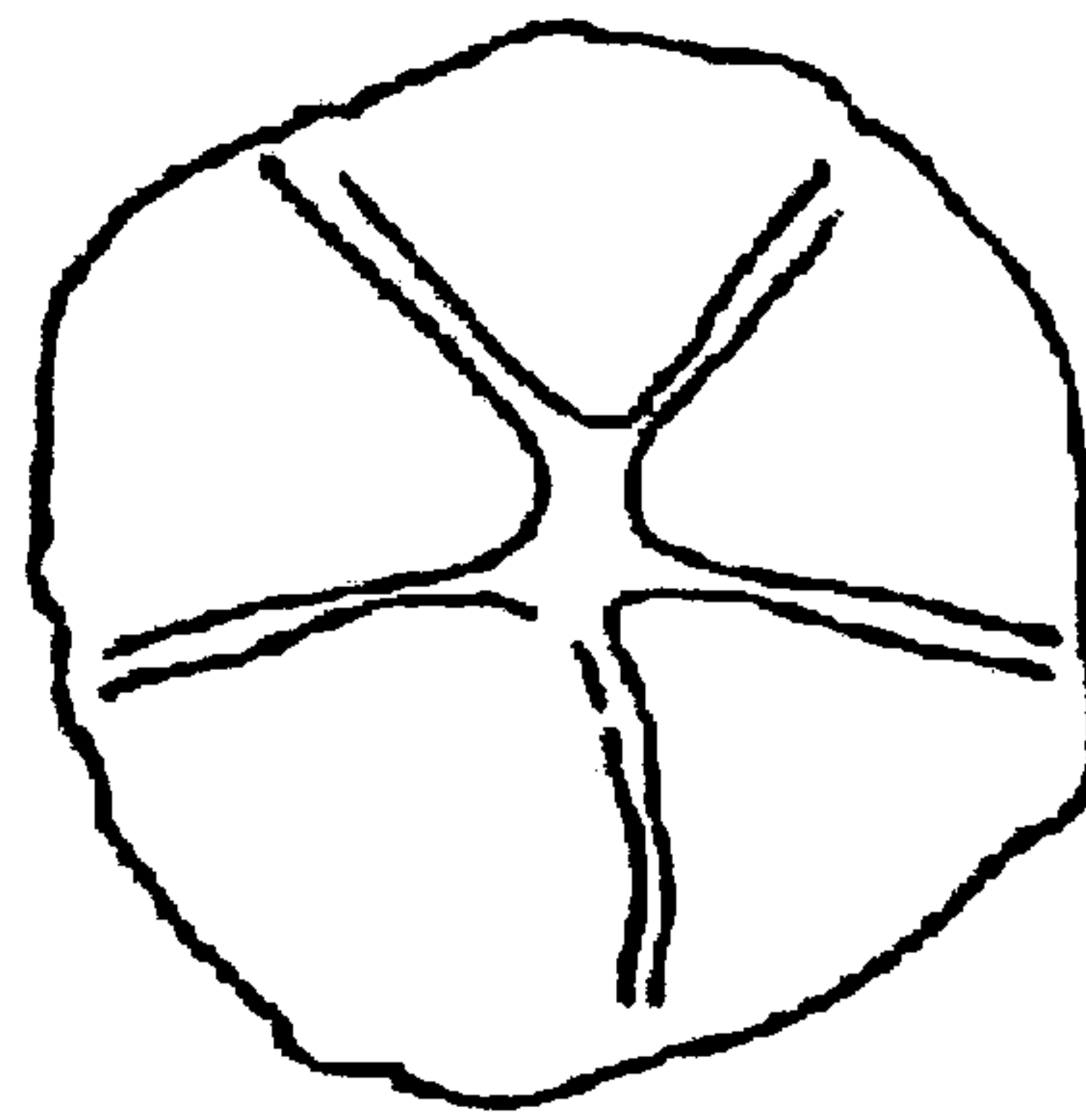

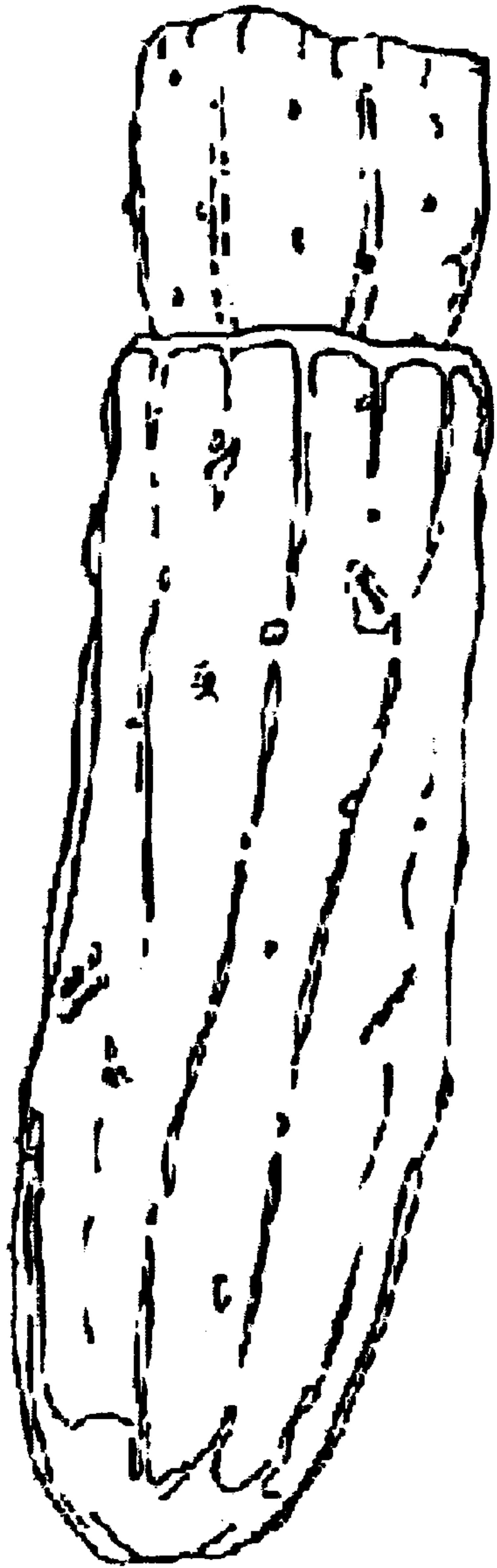

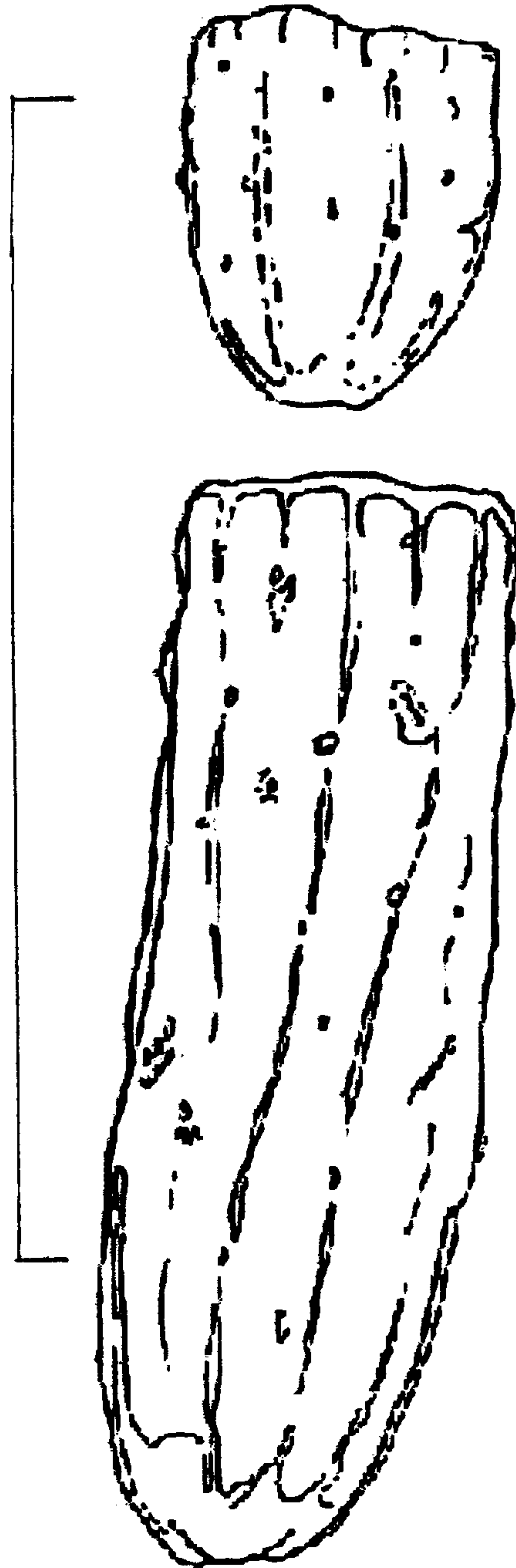
