We claim the ornamental design for the decoration for a shirt, as shown and described.

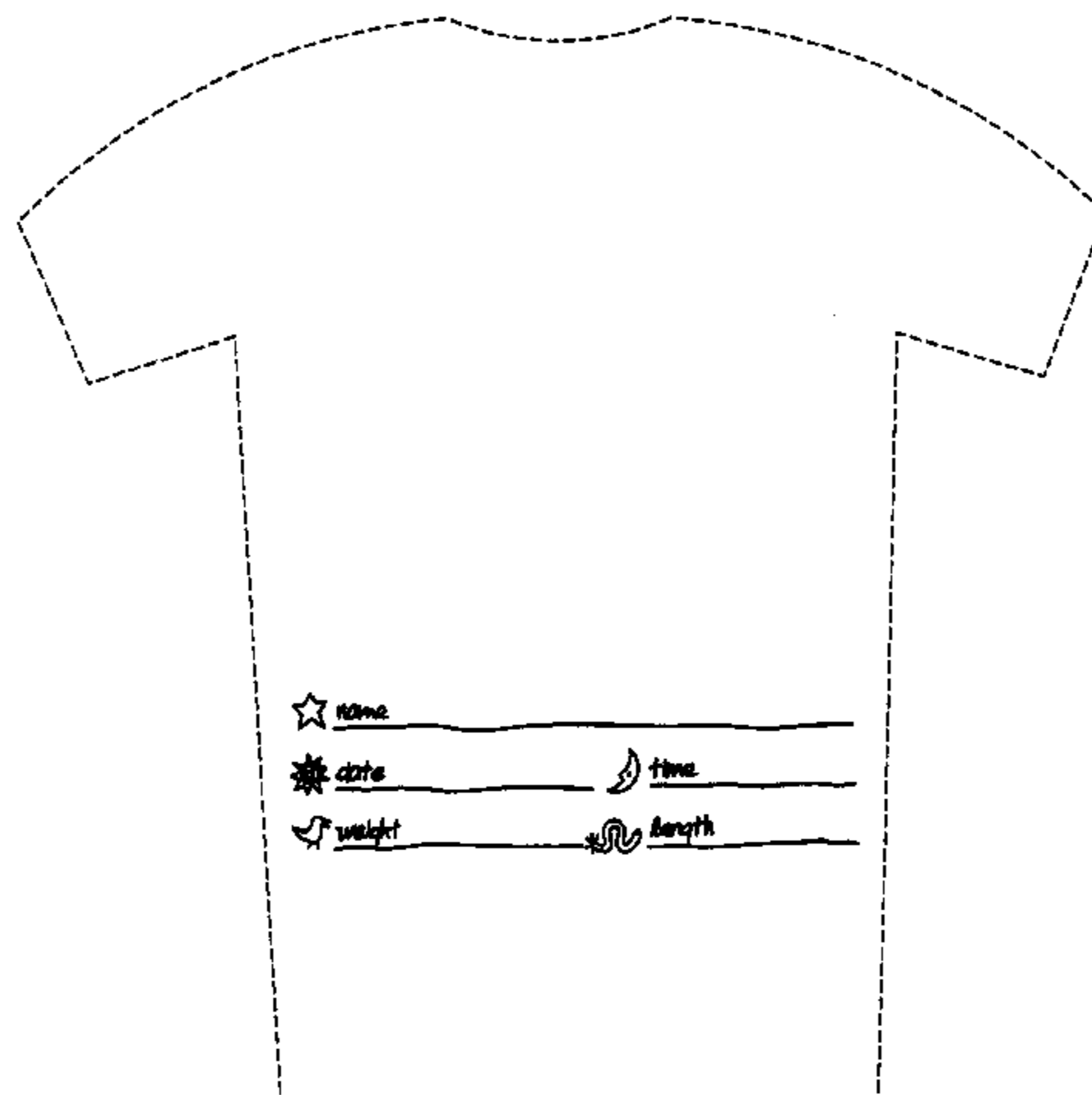
**DESCRIPTION**

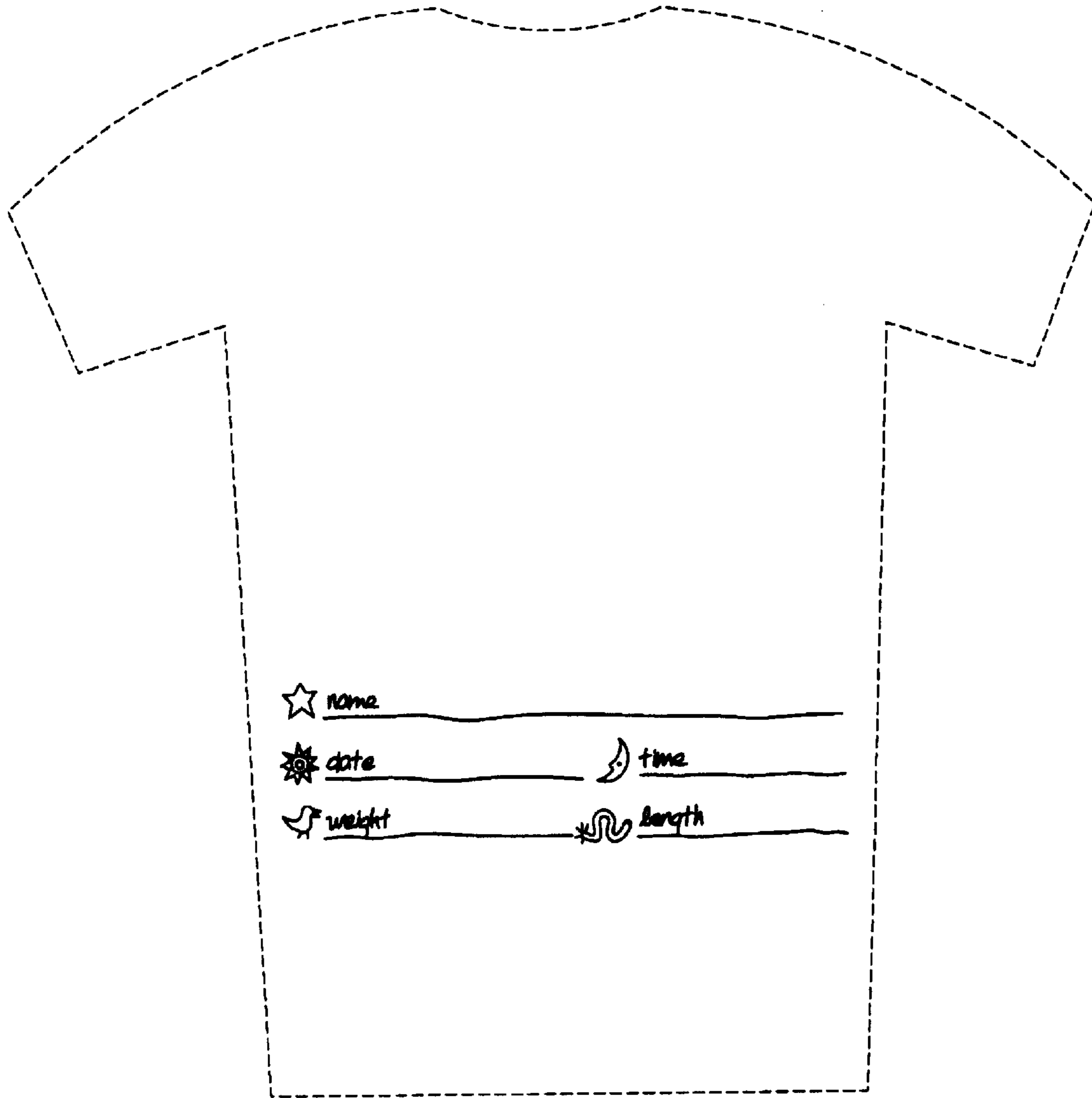

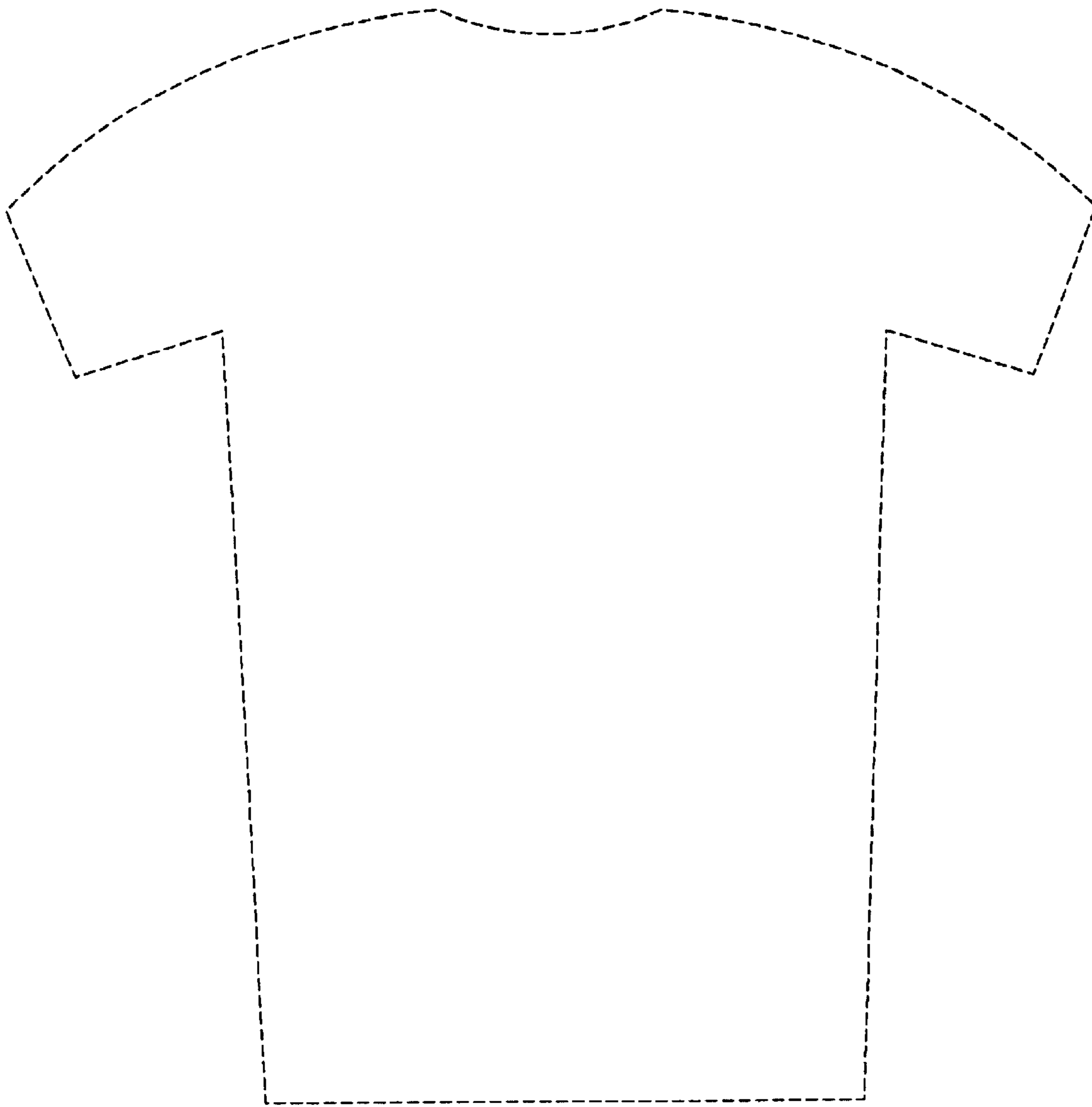
