FIG. 3 is a back view of the handbag shown in FIG. 1;

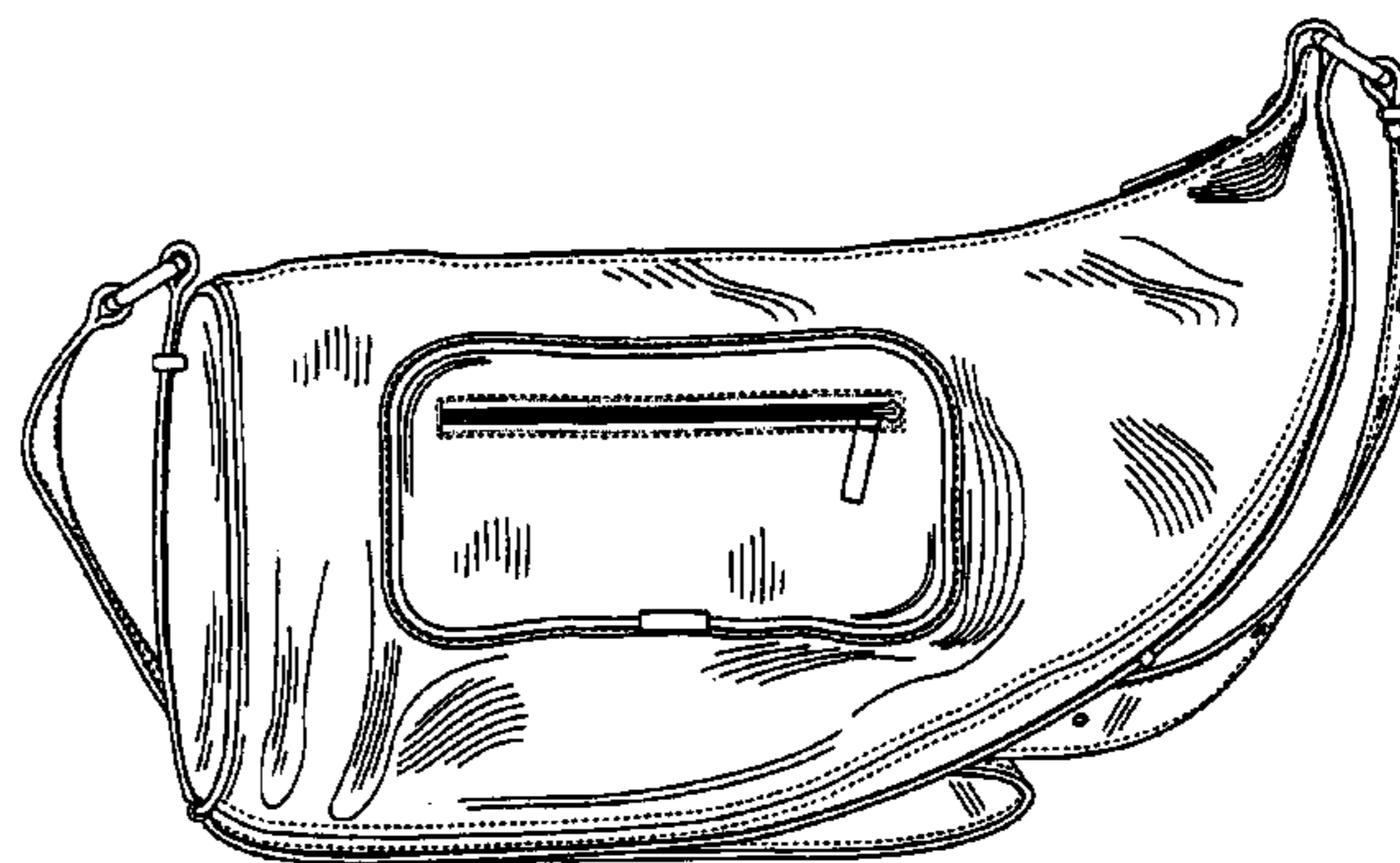
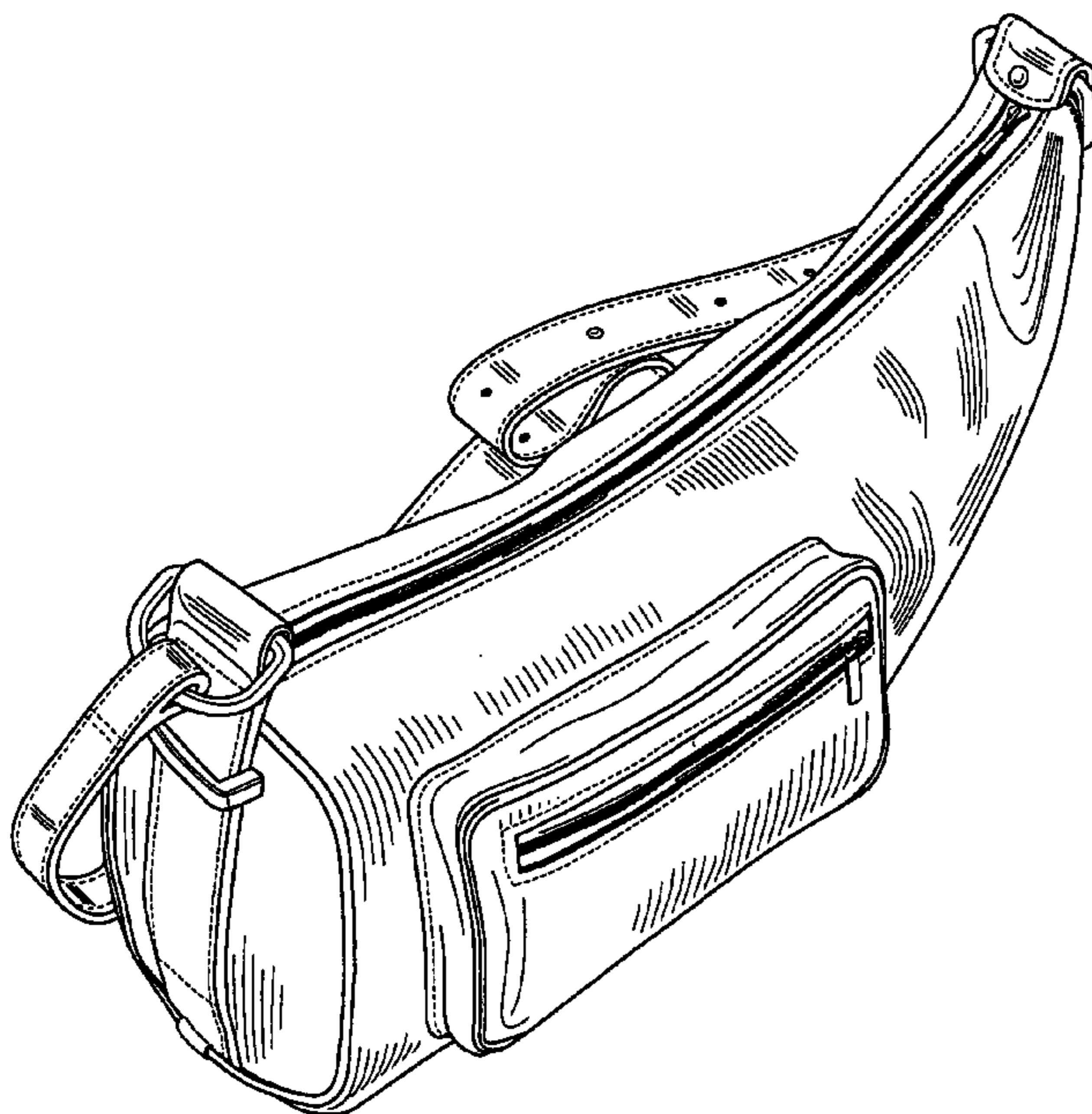
FIG. 4 is a left view of the handbag shown in FIG. 1;

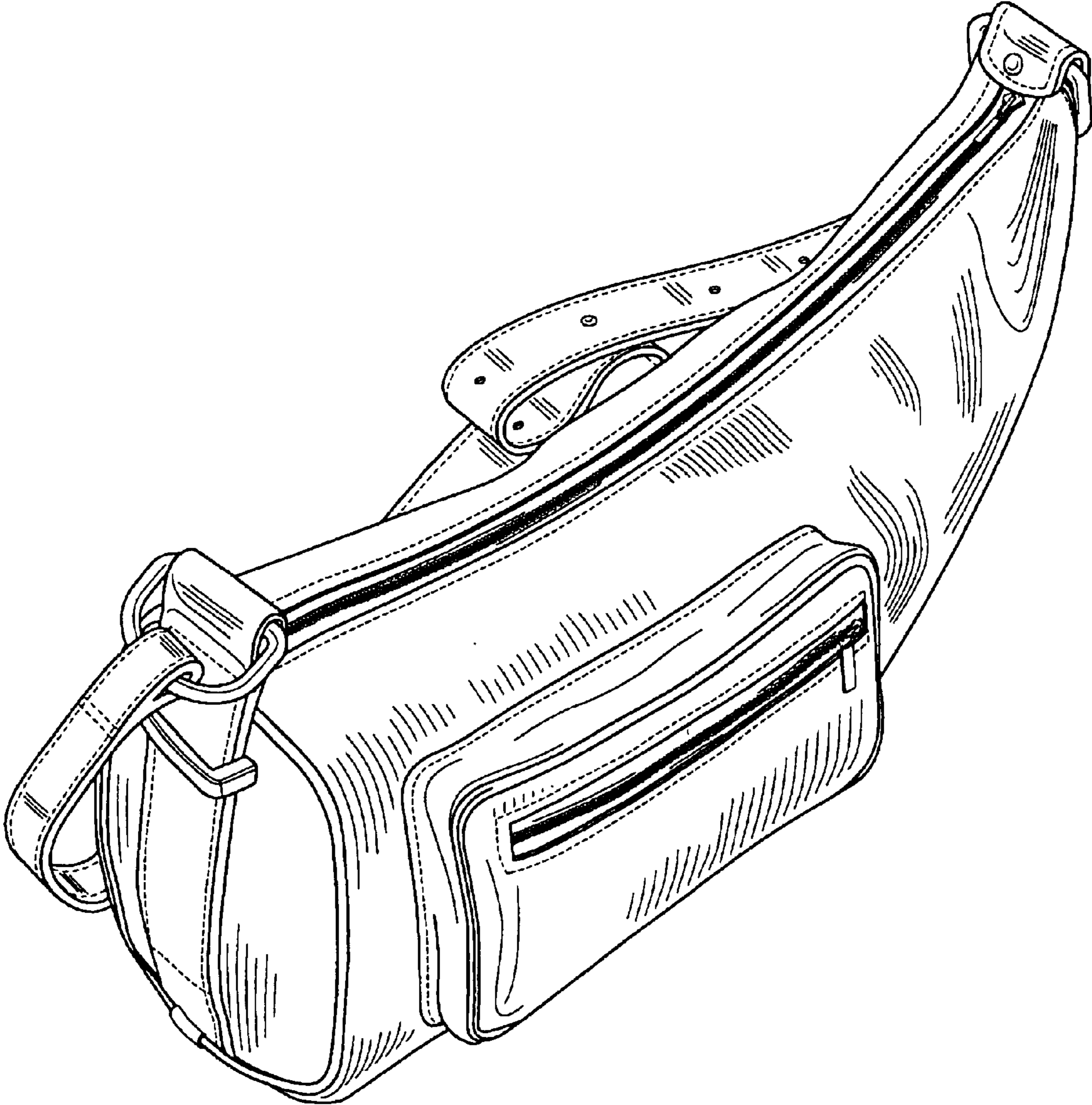

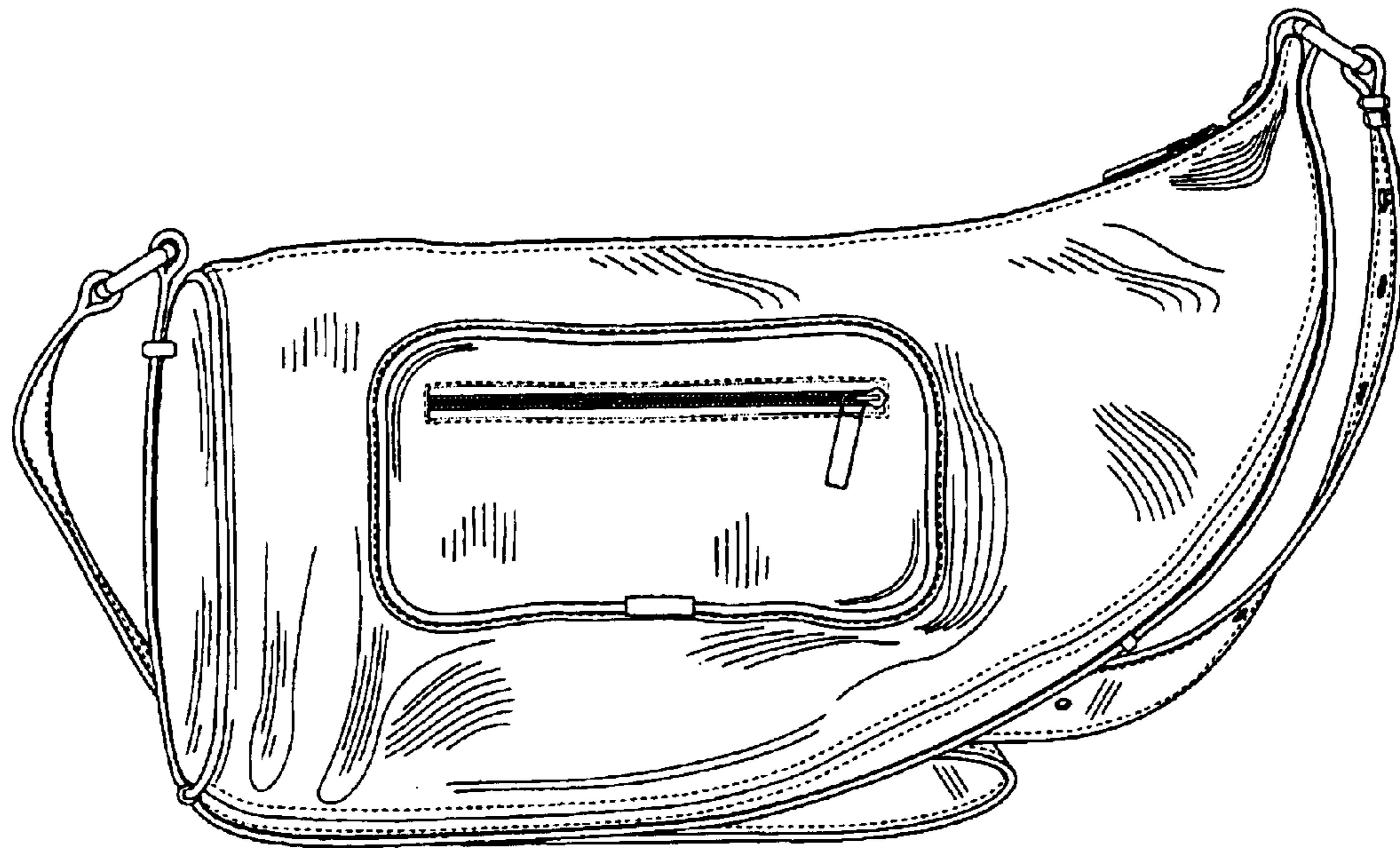

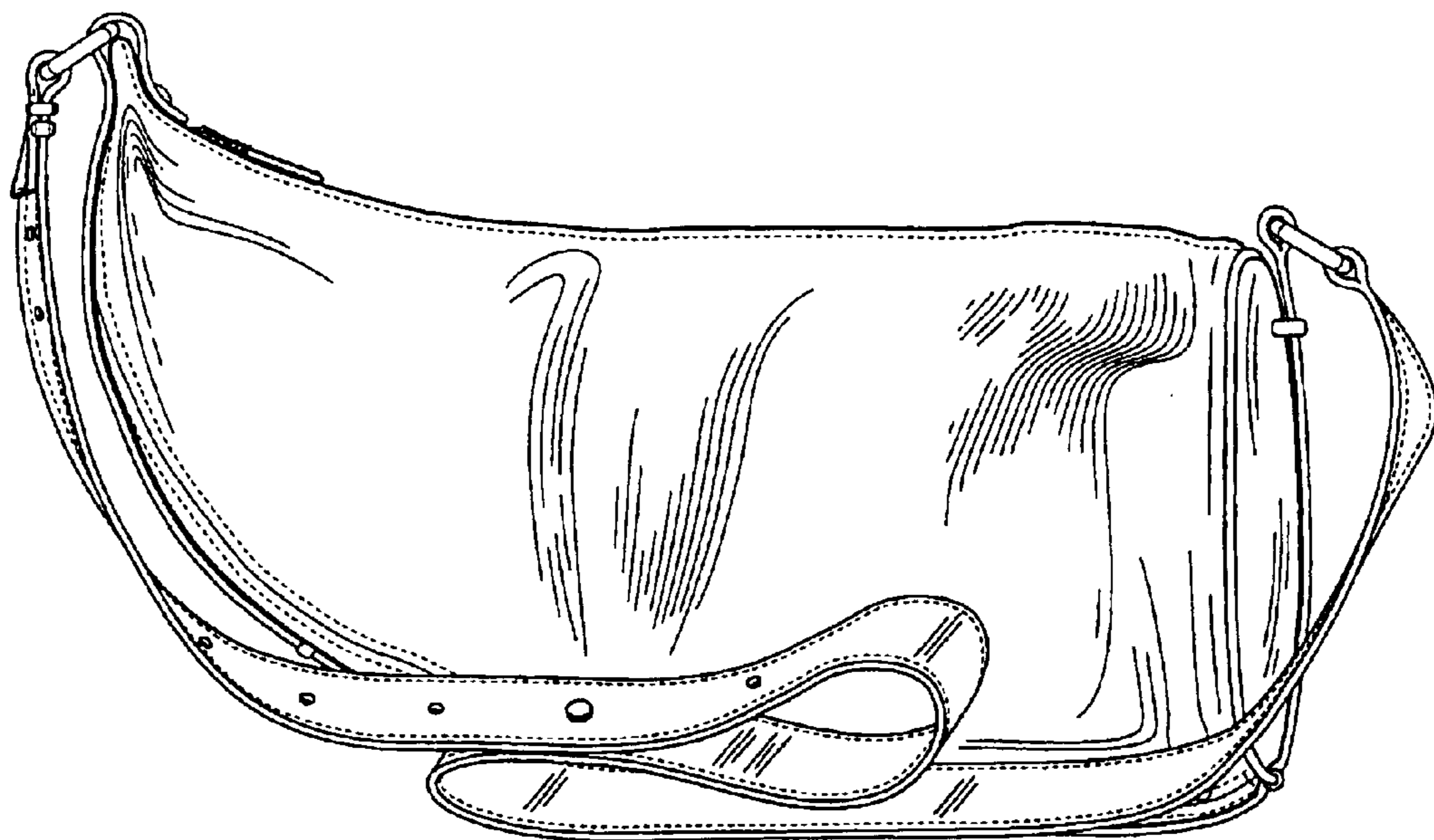

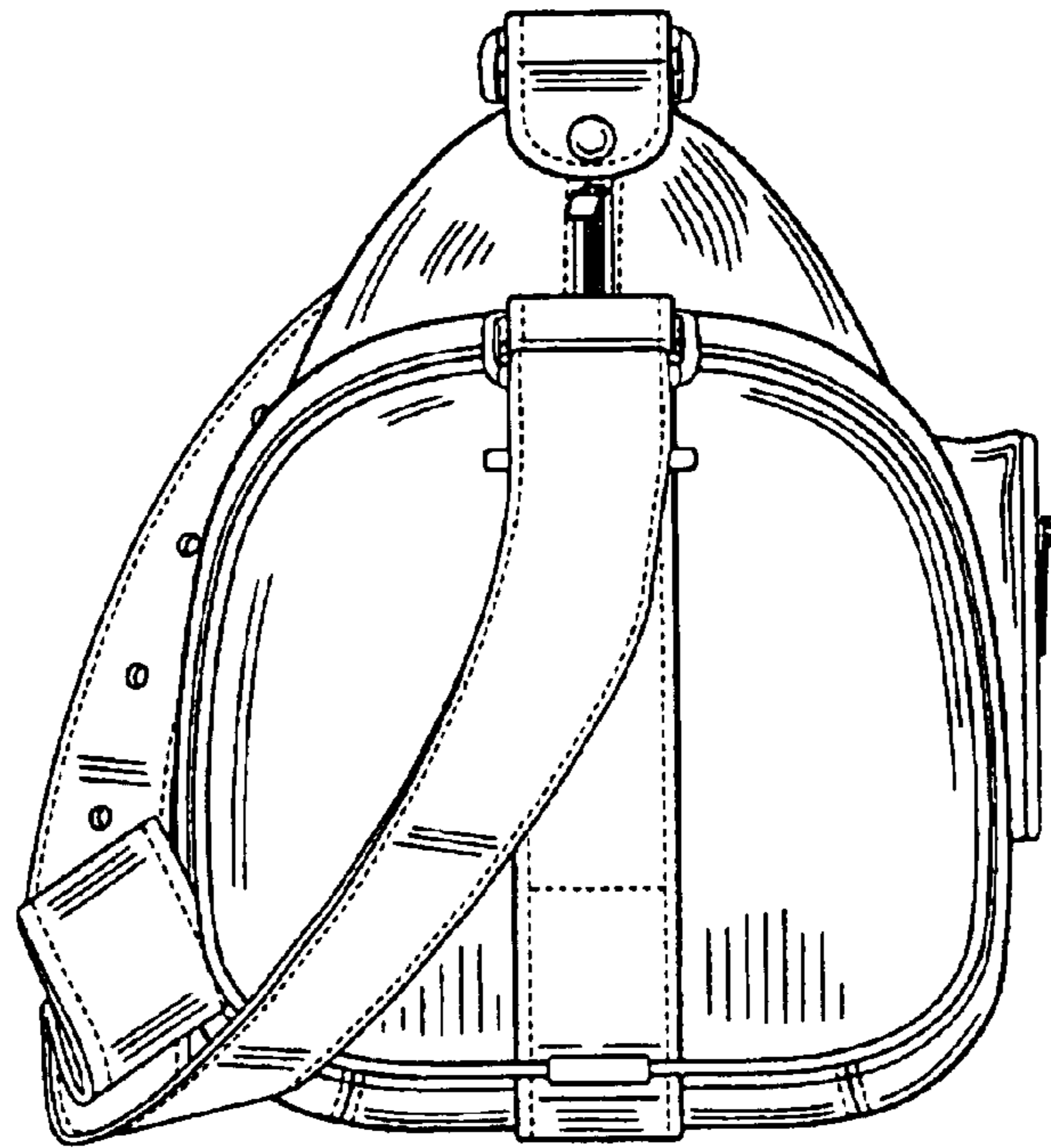

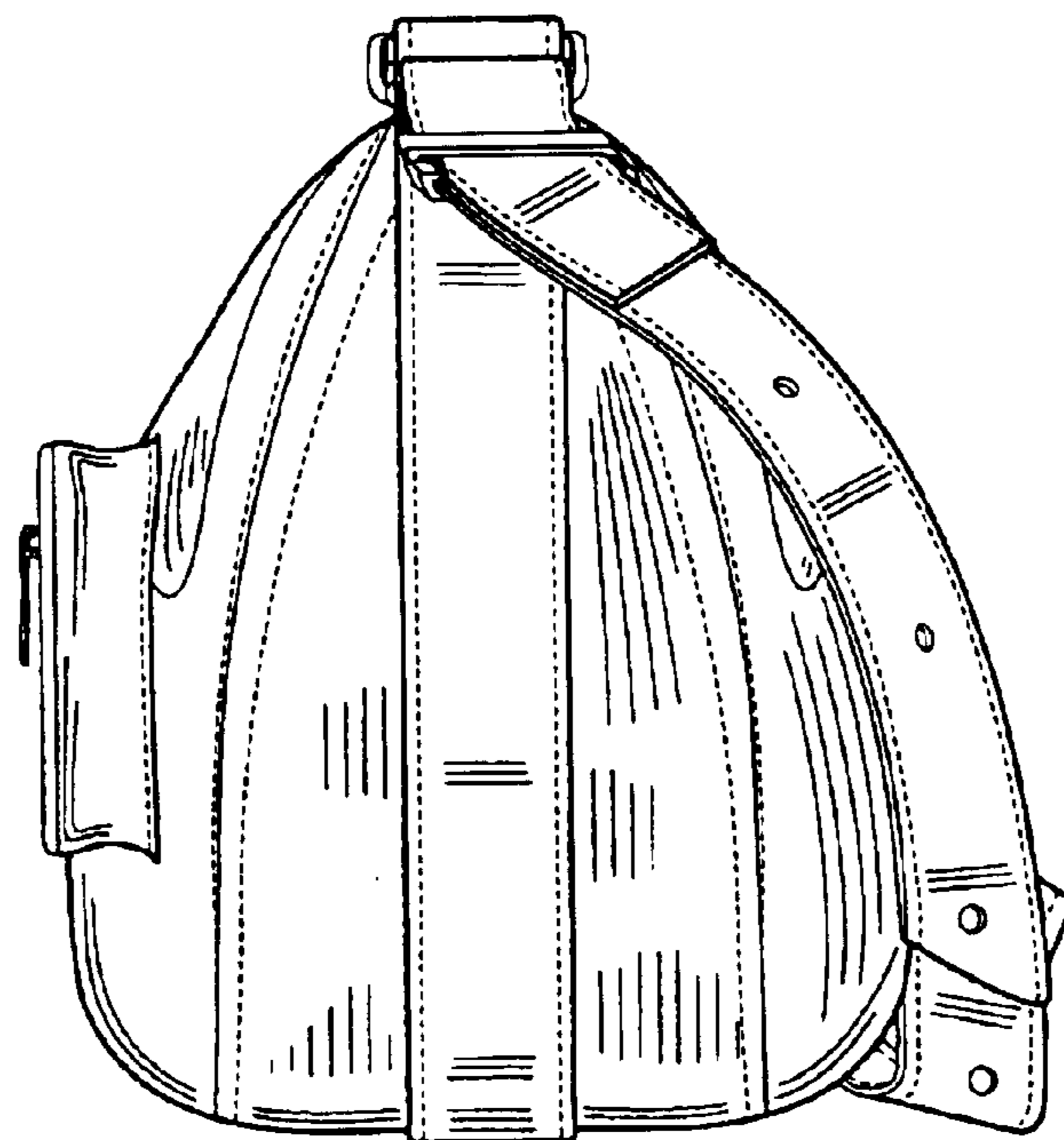

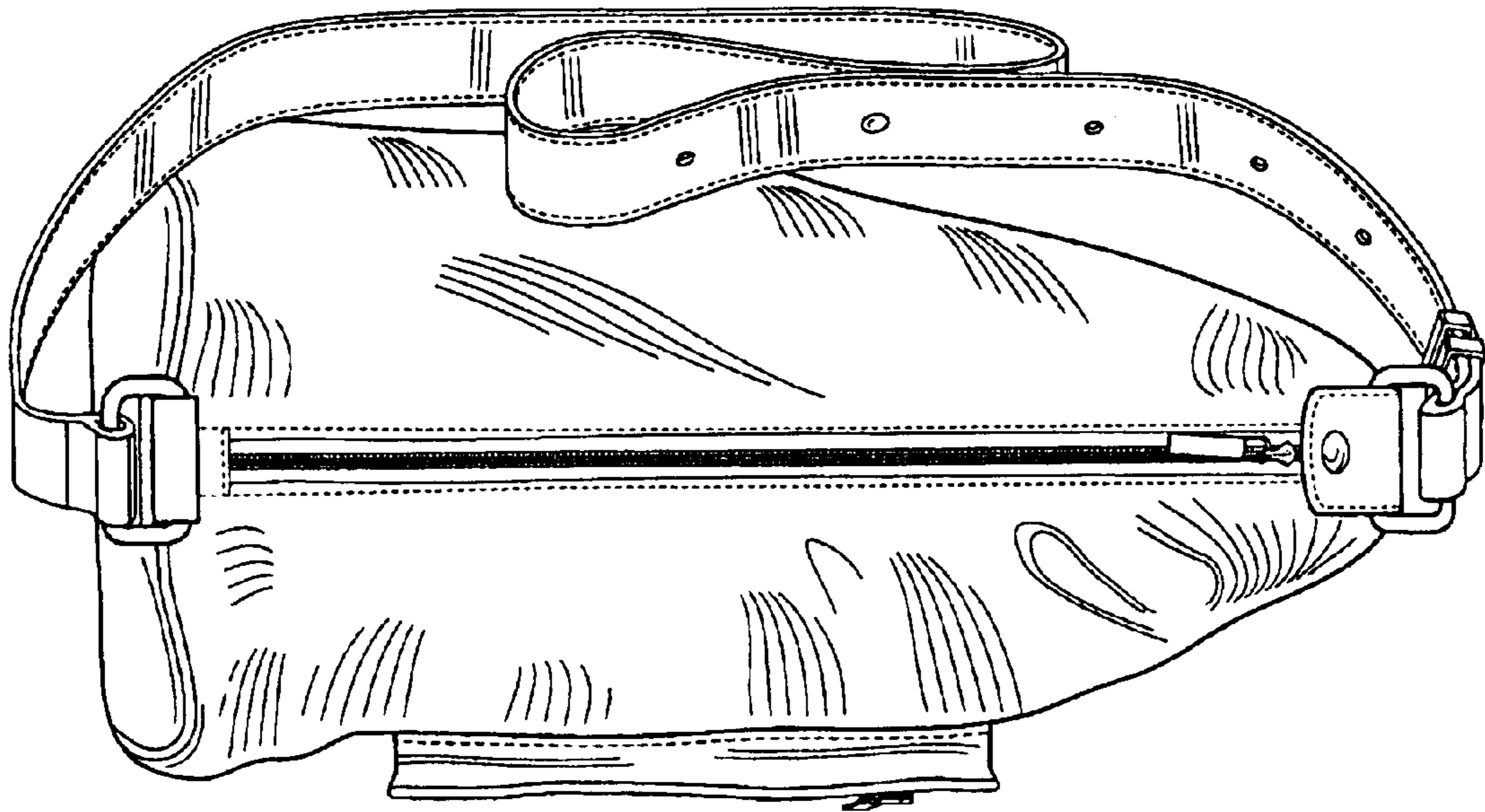

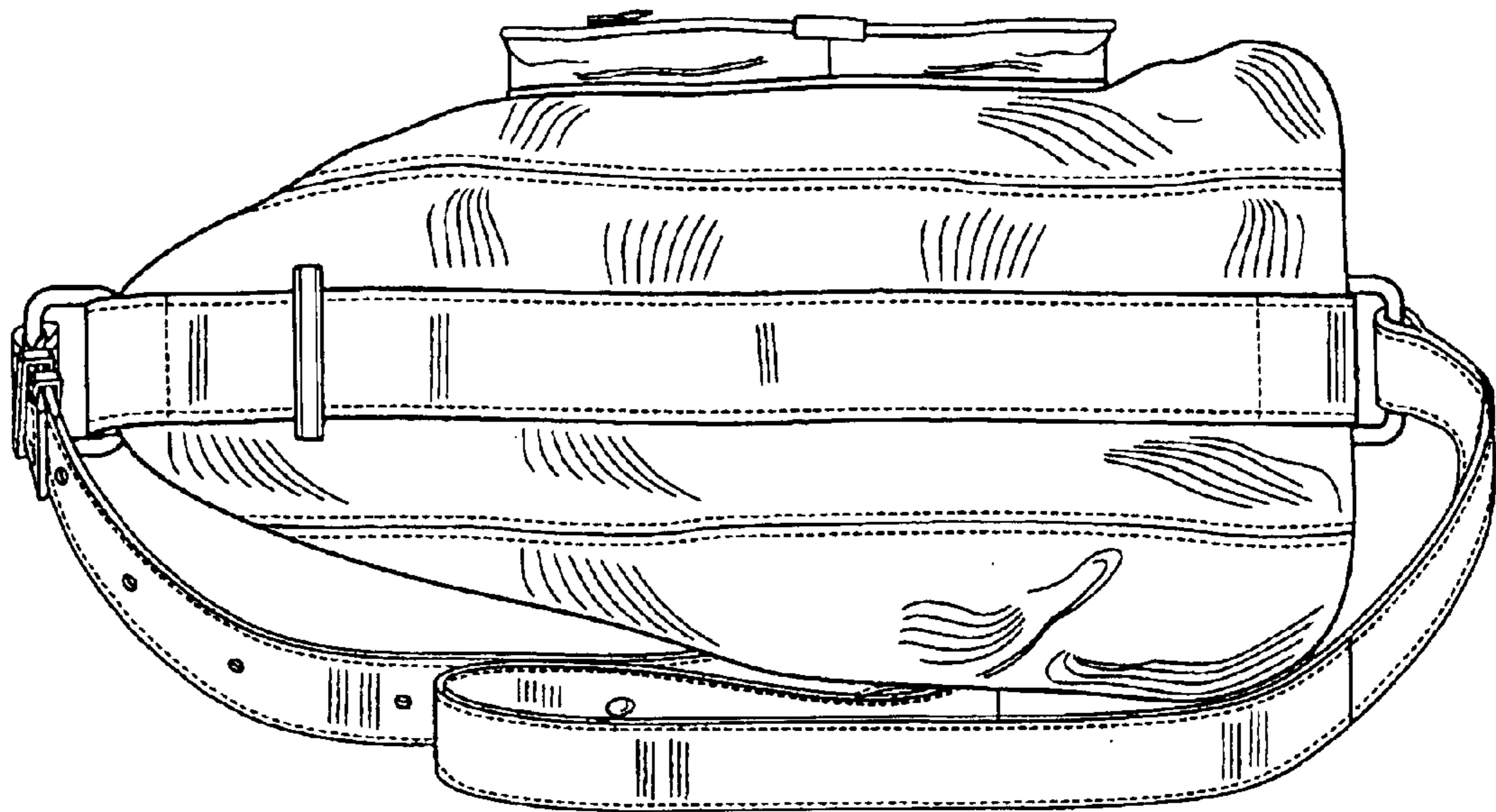
