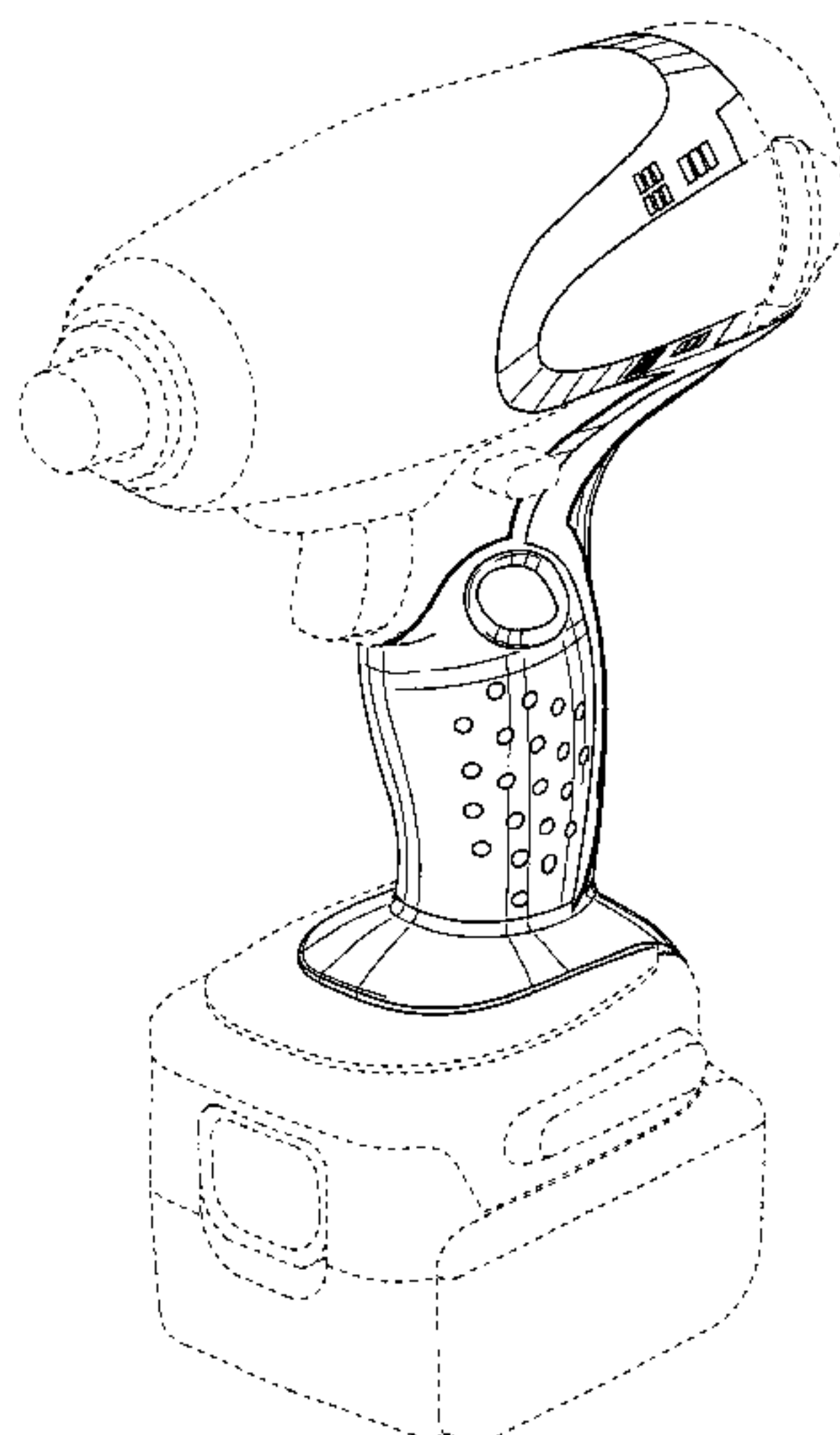
(57) **CLAIM**

The ornamental design for a portion of a portable electric driver, as shown and described.

**DESCRIPTION**

FIG. 1 is a front and left side perspective view of a portion of a portable electric driver showing our new design; FIG. 2 is a front and right side perspective view thereof; FIG. 3 is a front elevation view thereof; FIG. 4 is a rear elevation view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof. The broken lines depict unclaimed portions of the portable electric driver for illustrative purposes only, and form no part of the claimed design.

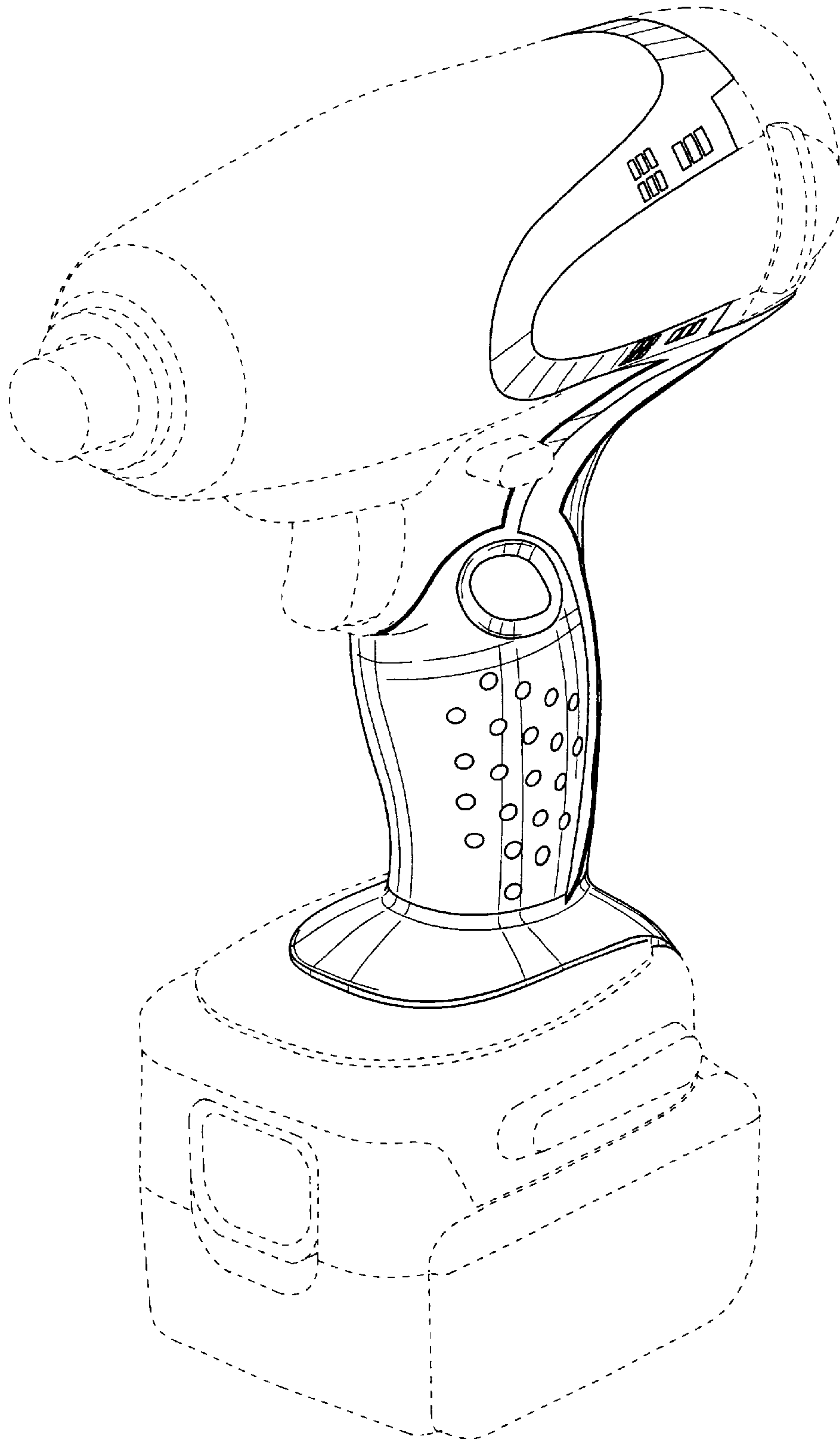

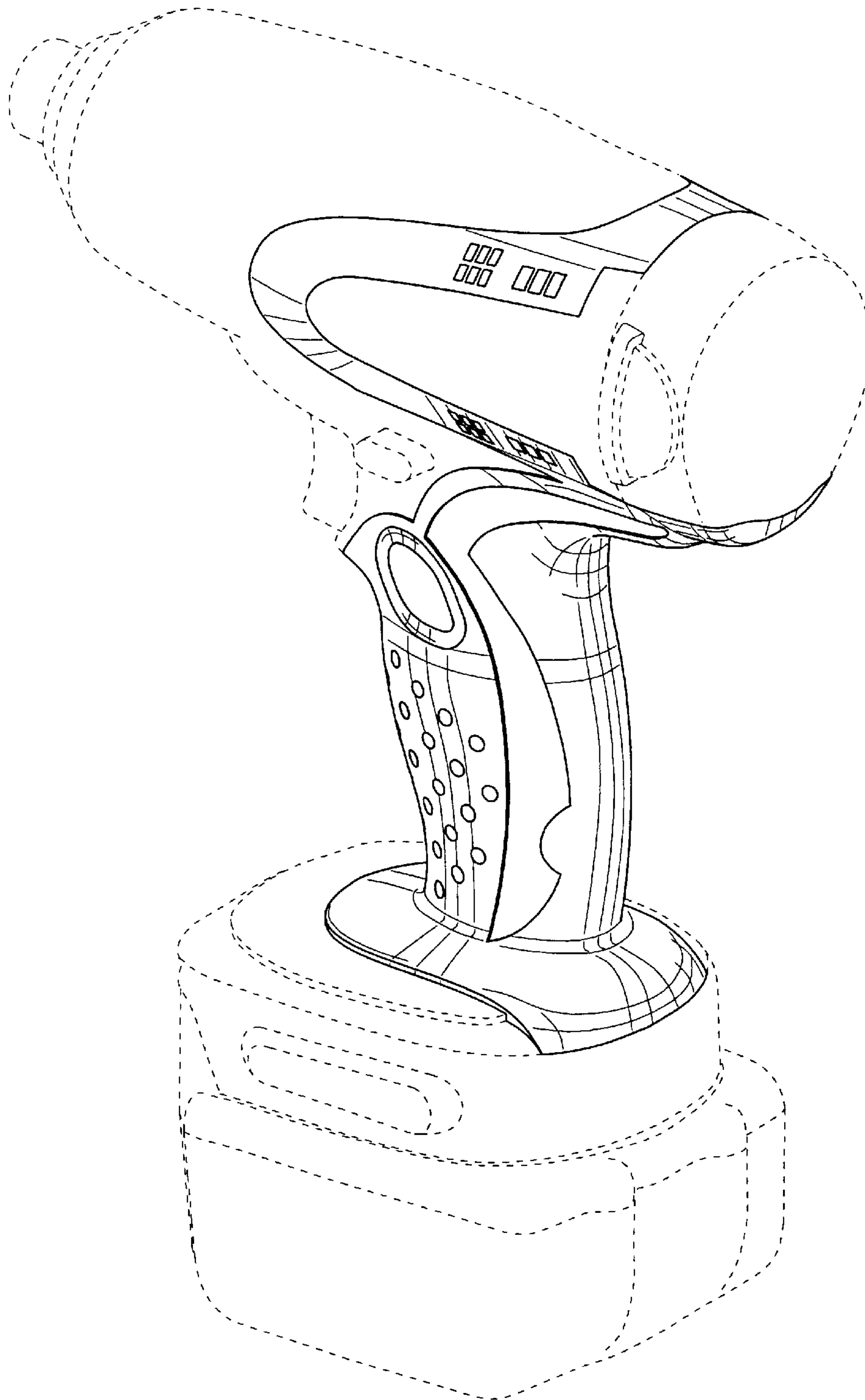

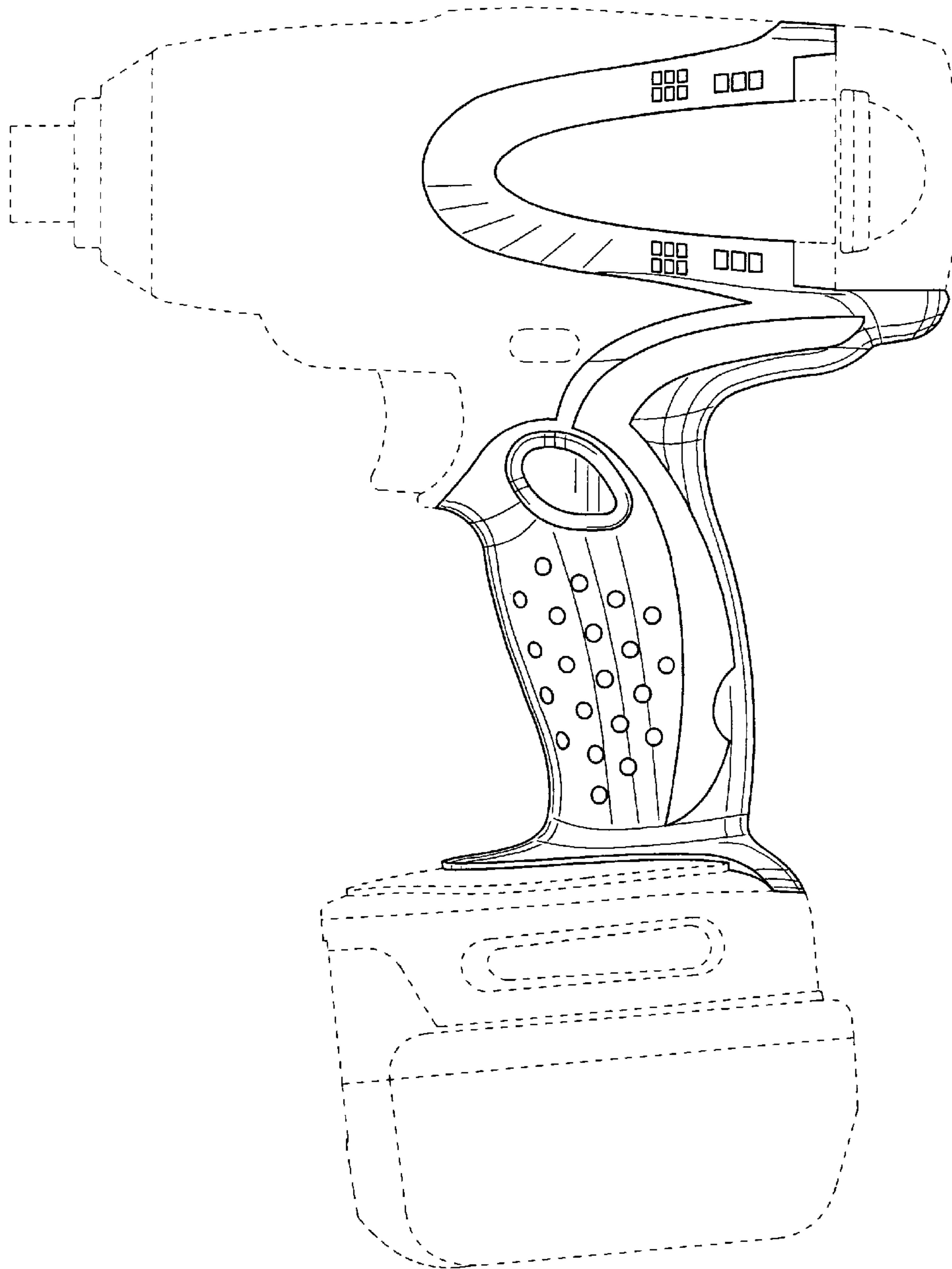

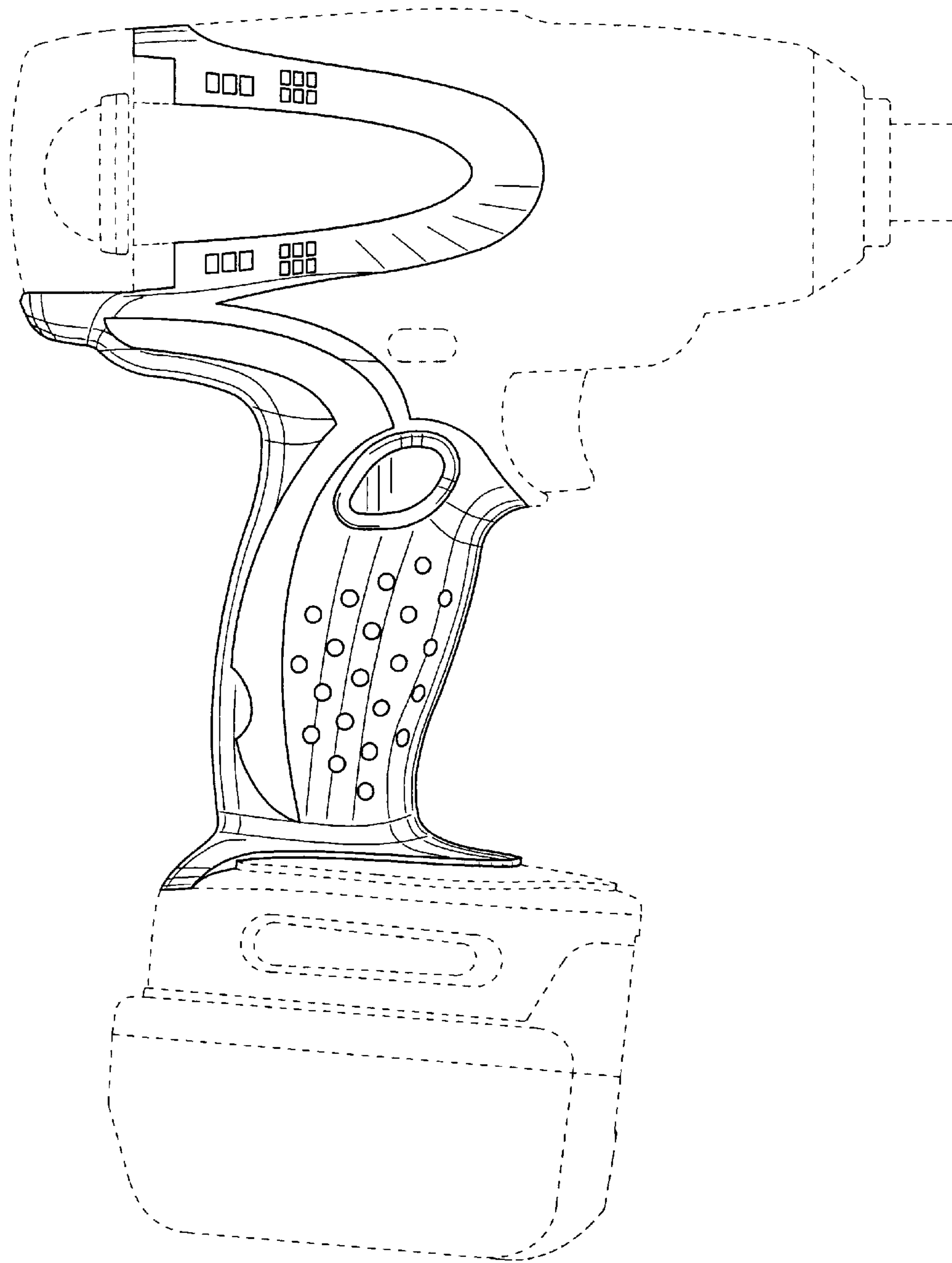

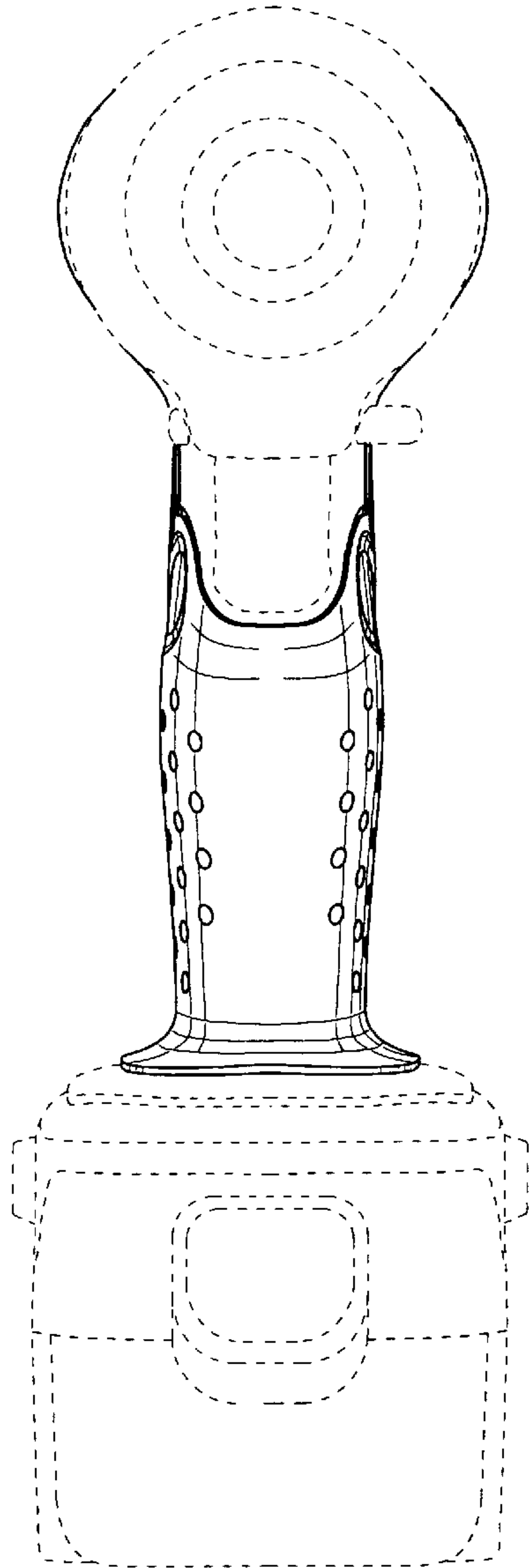

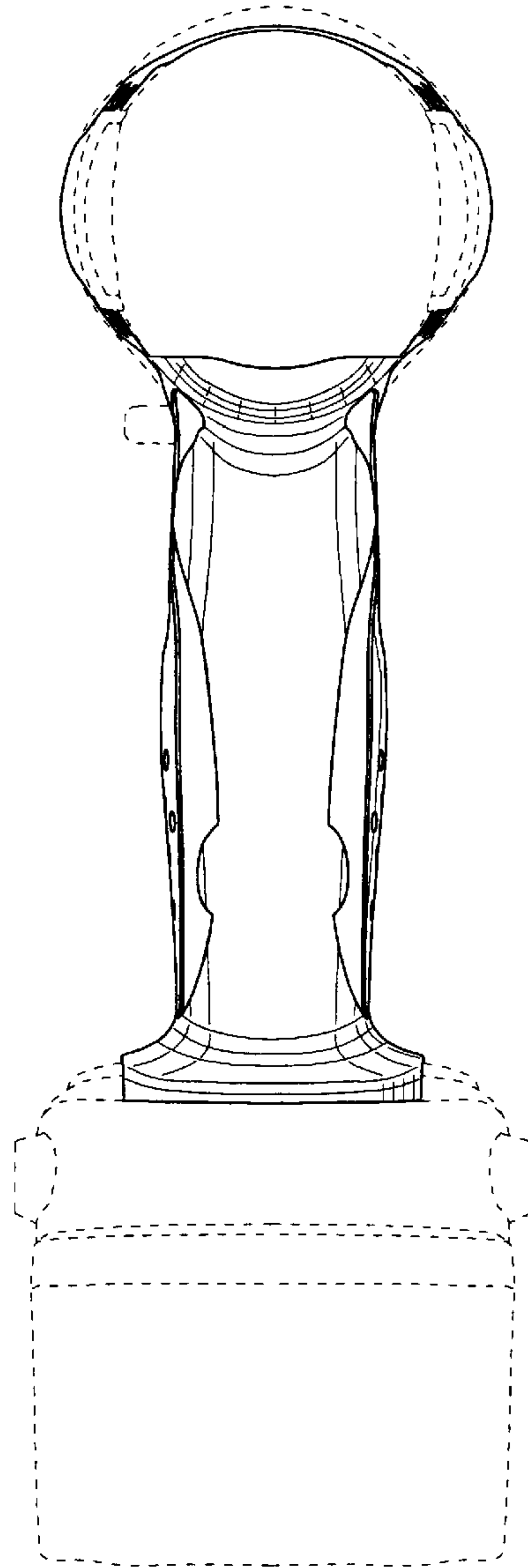

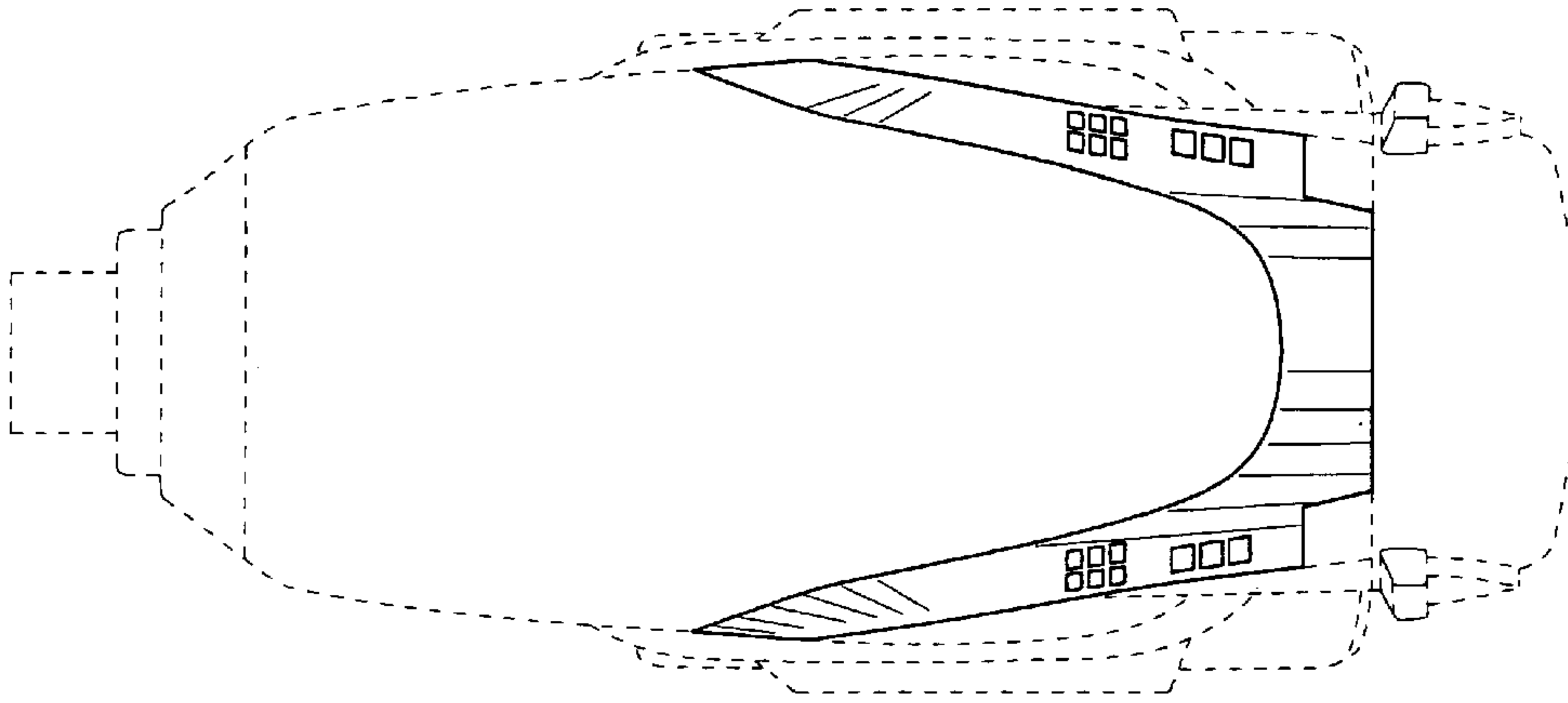

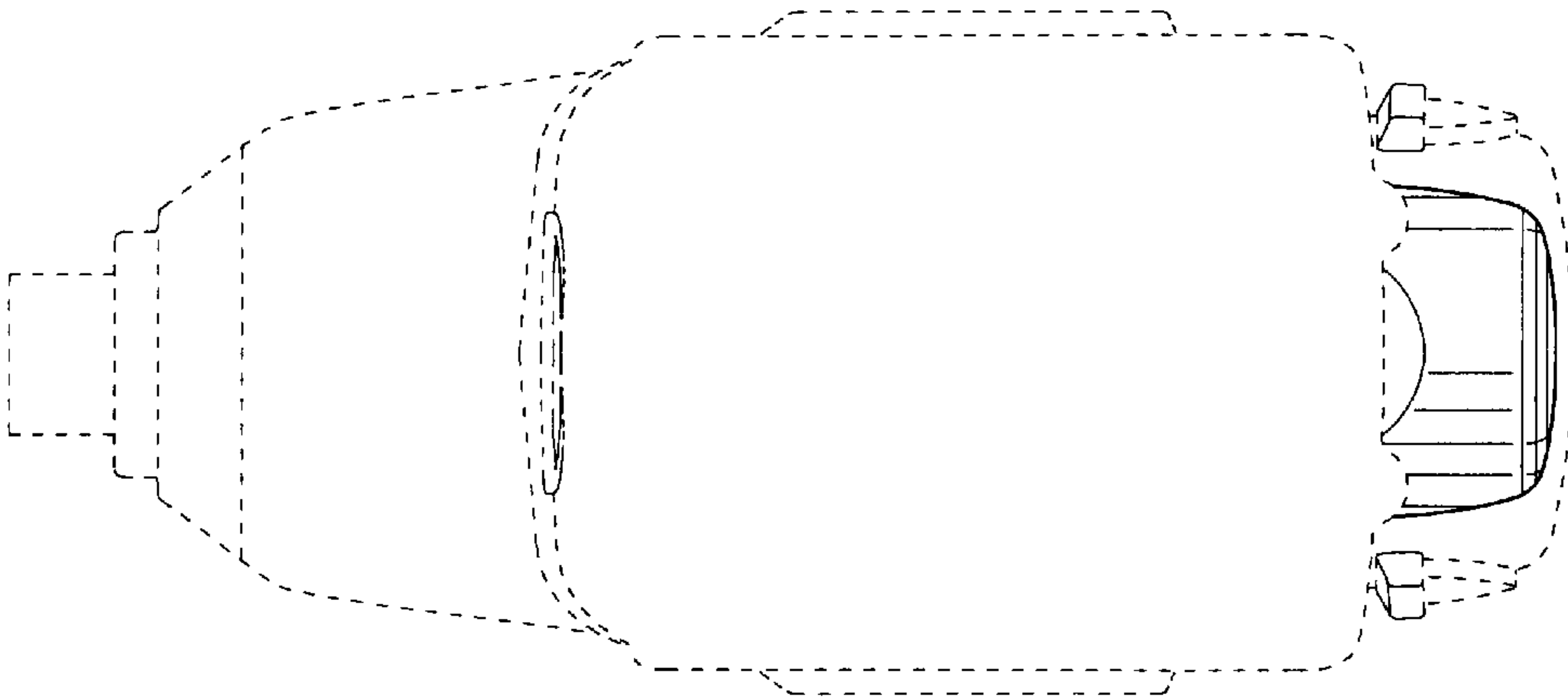
