I claim the ornamental design for a figurine, as shown and described.

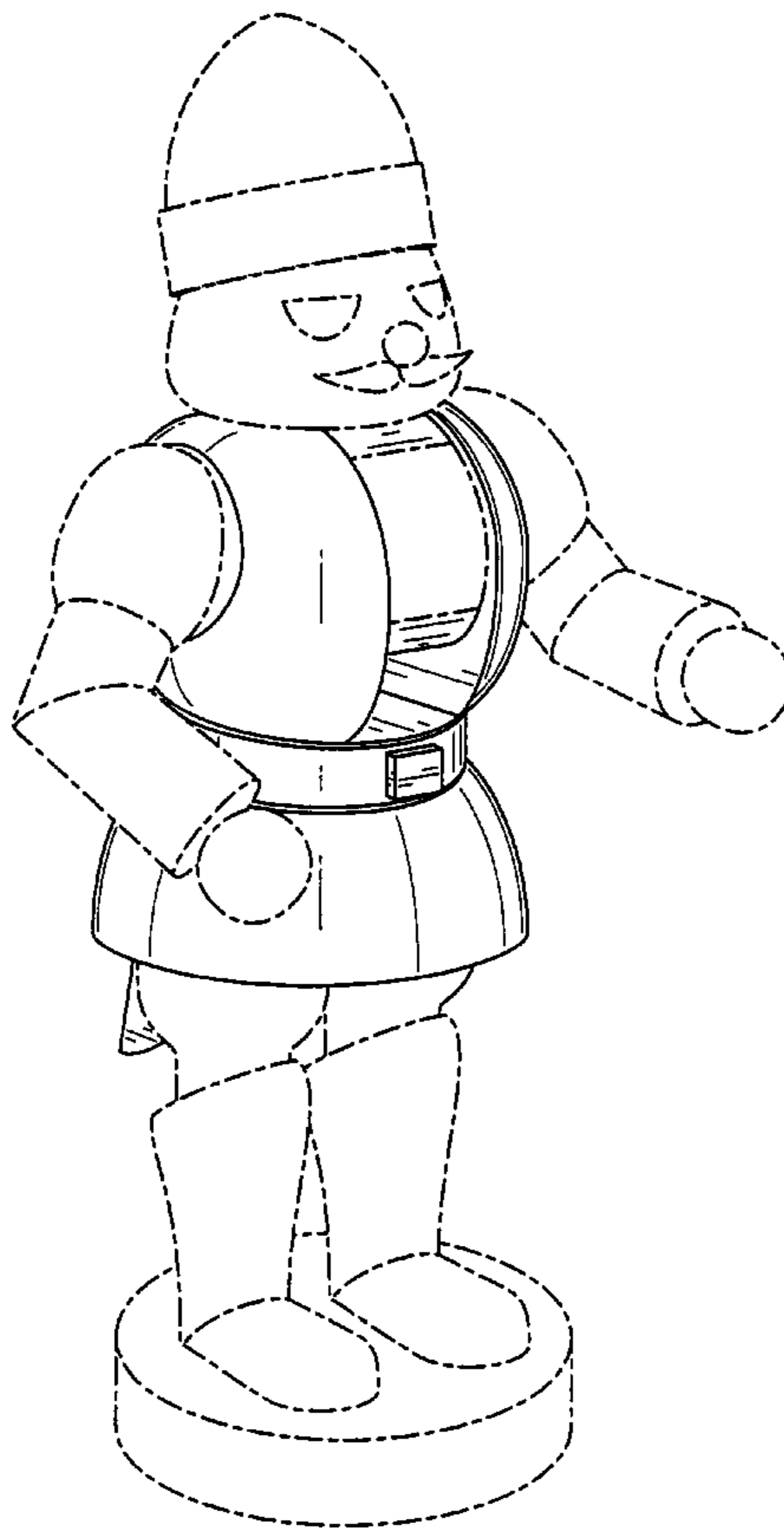

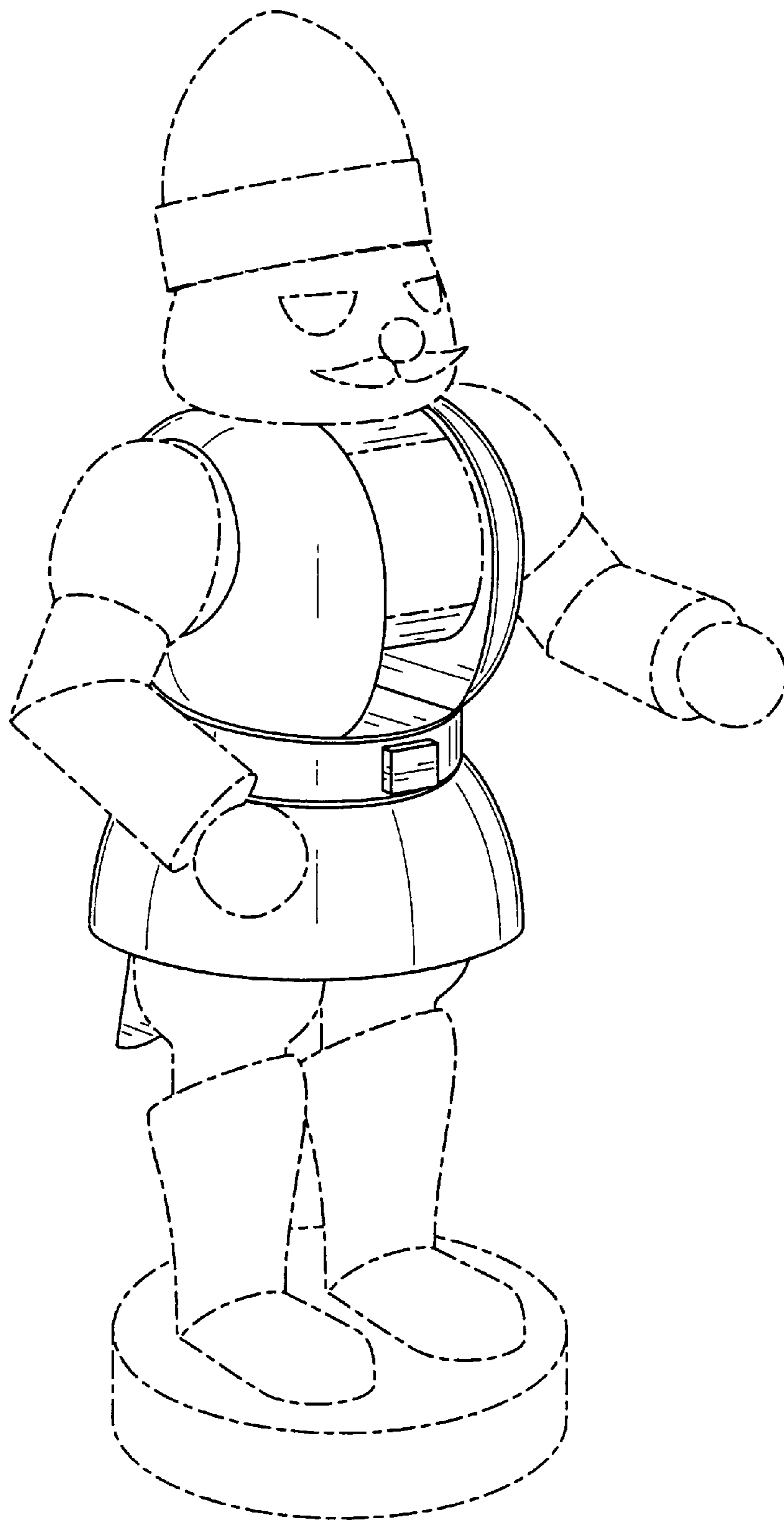

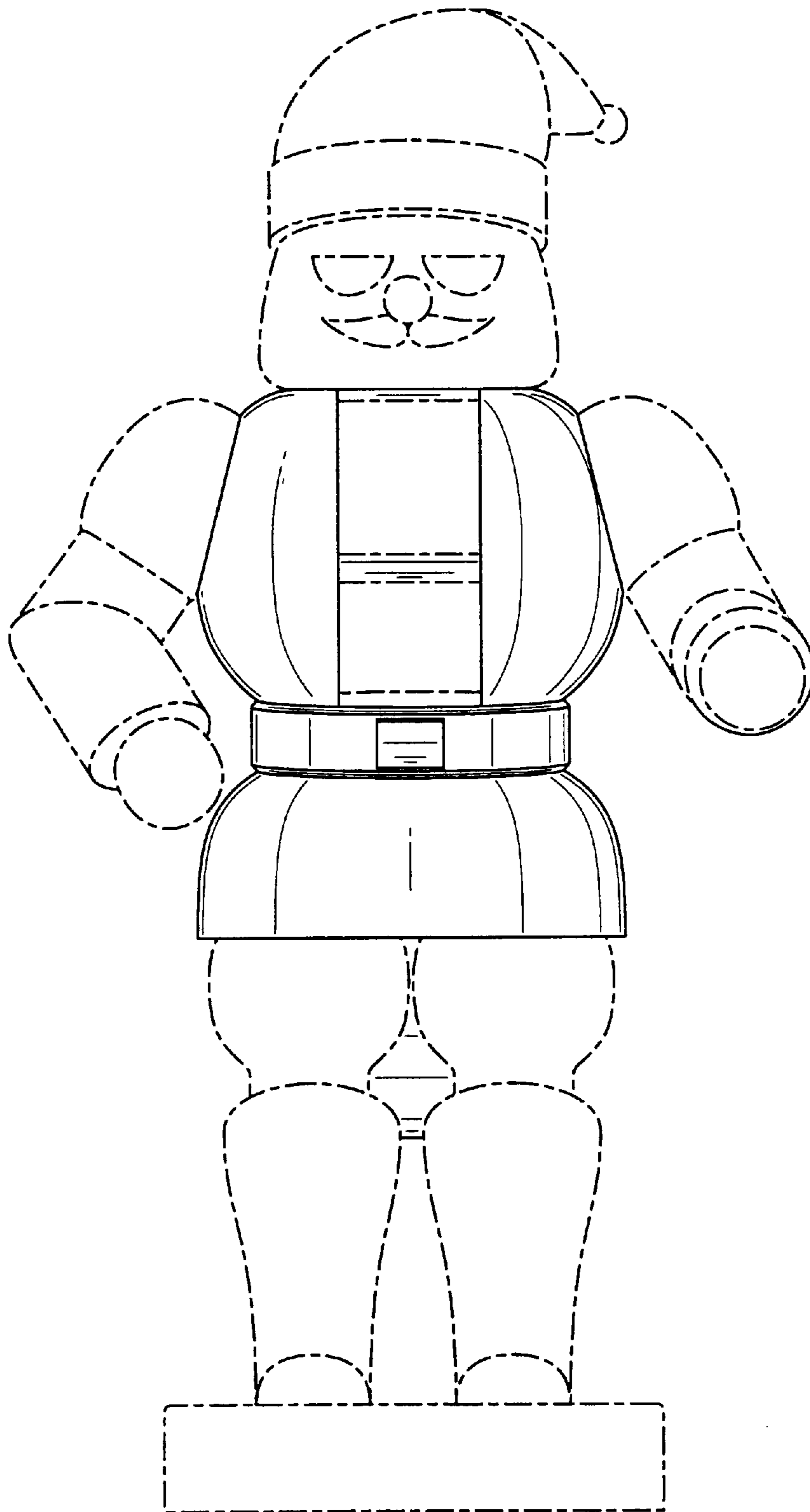

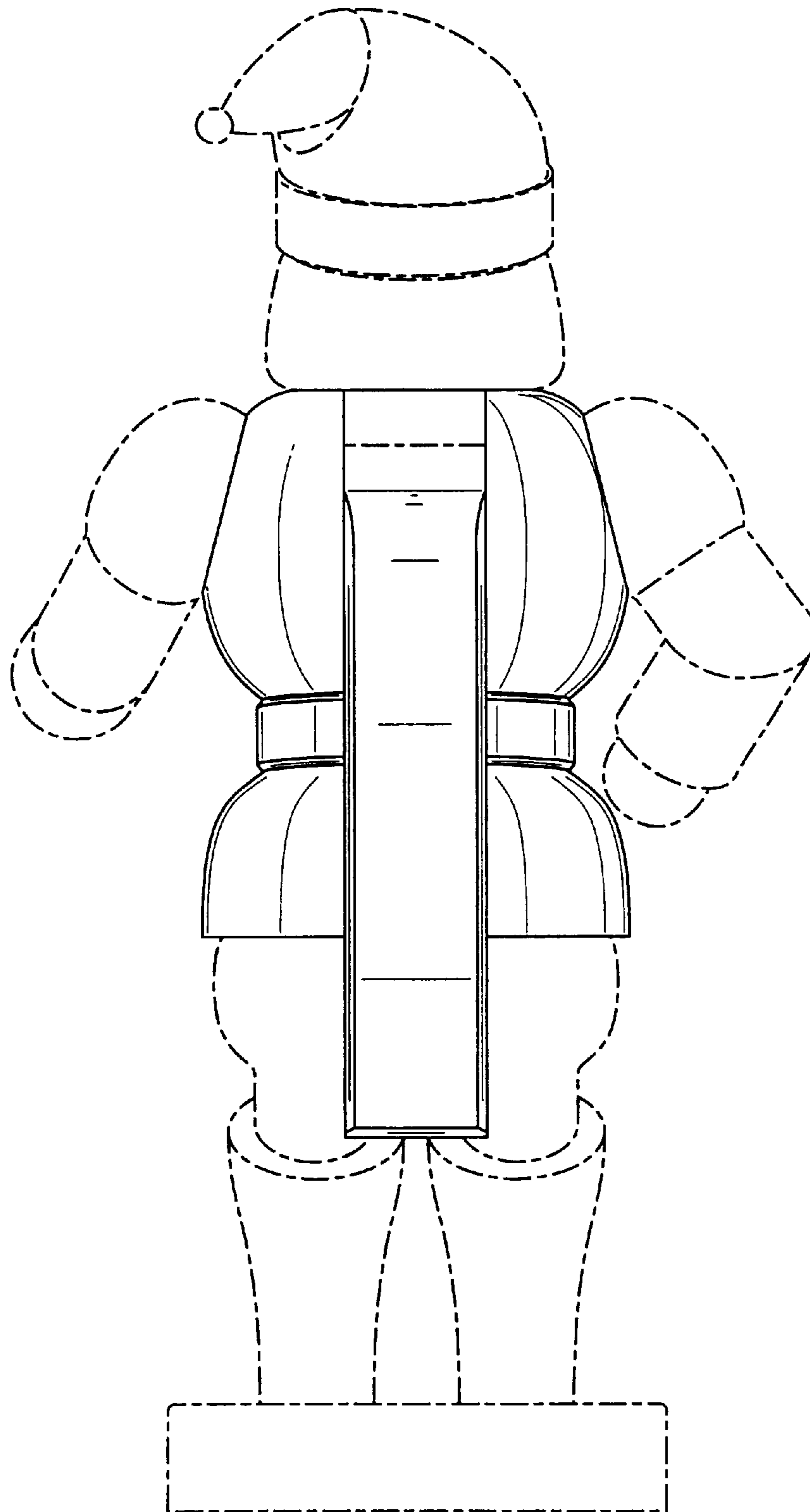

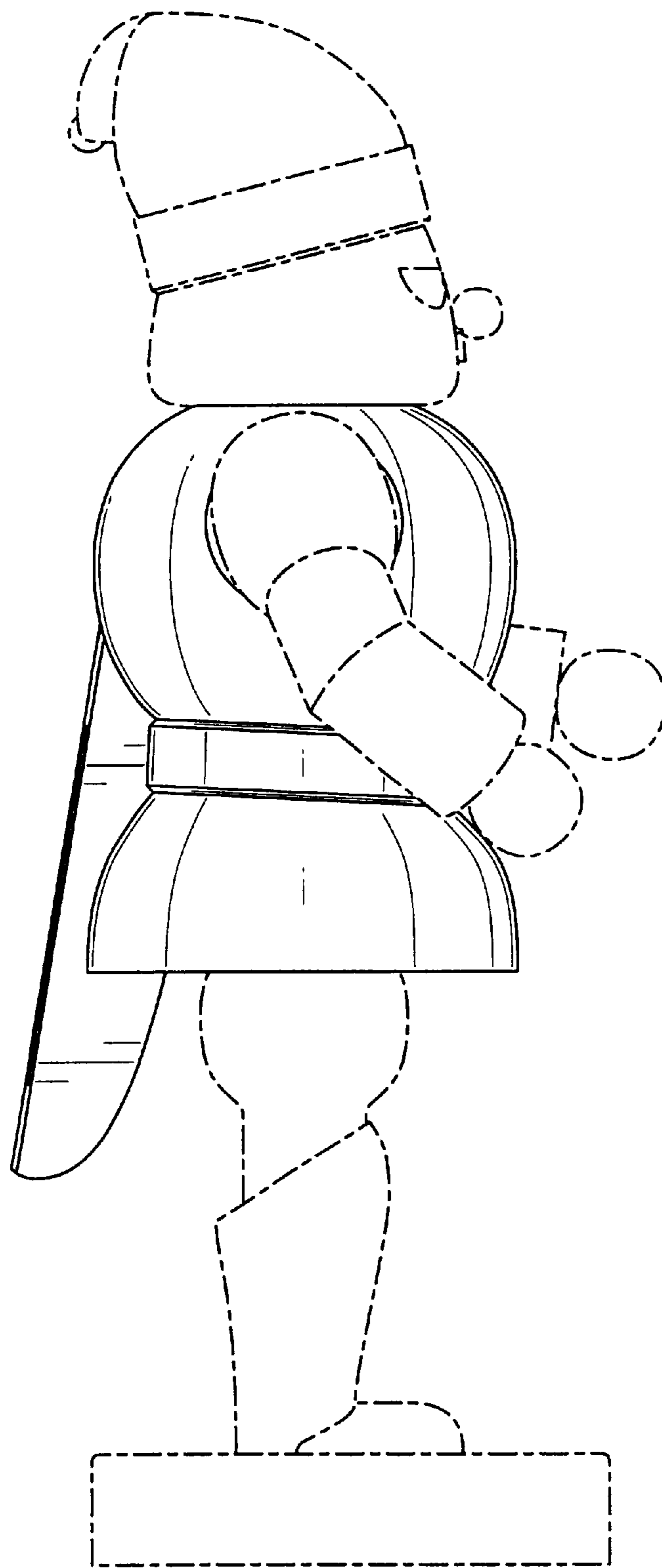

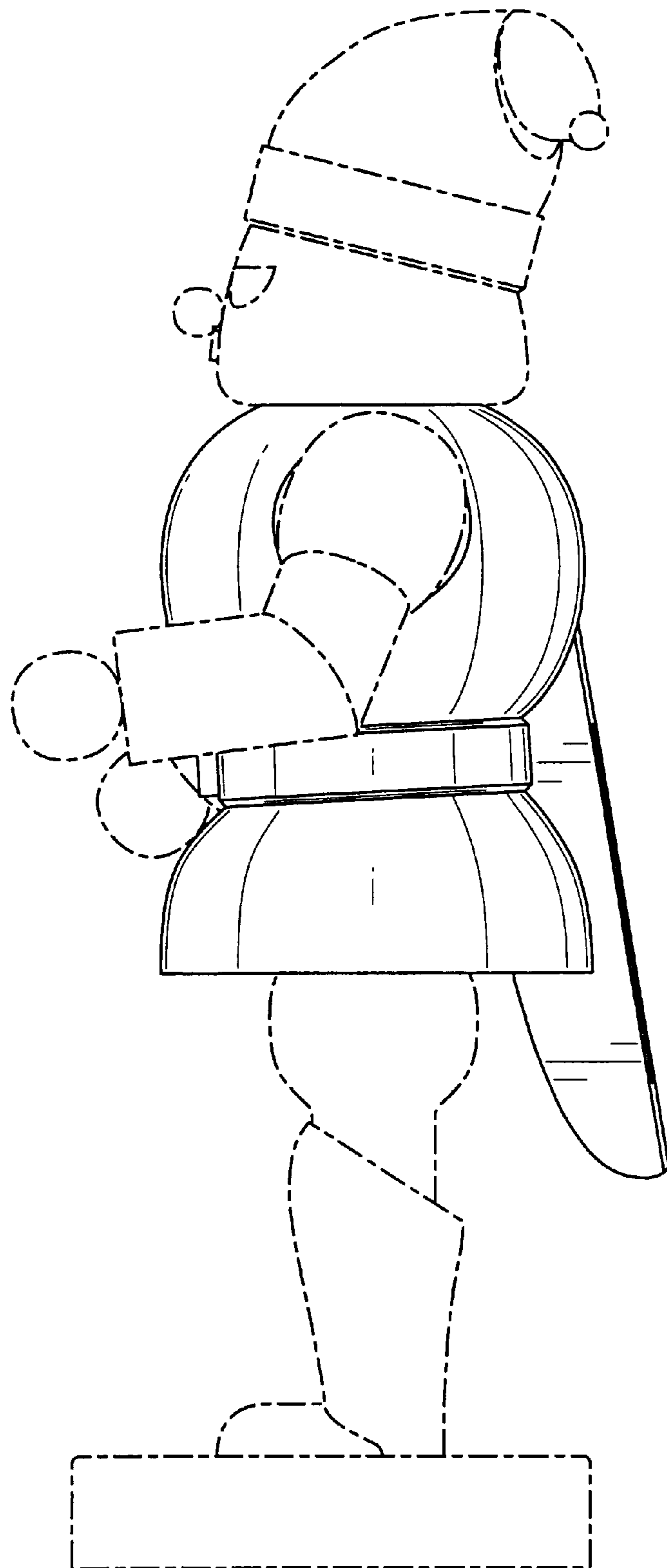

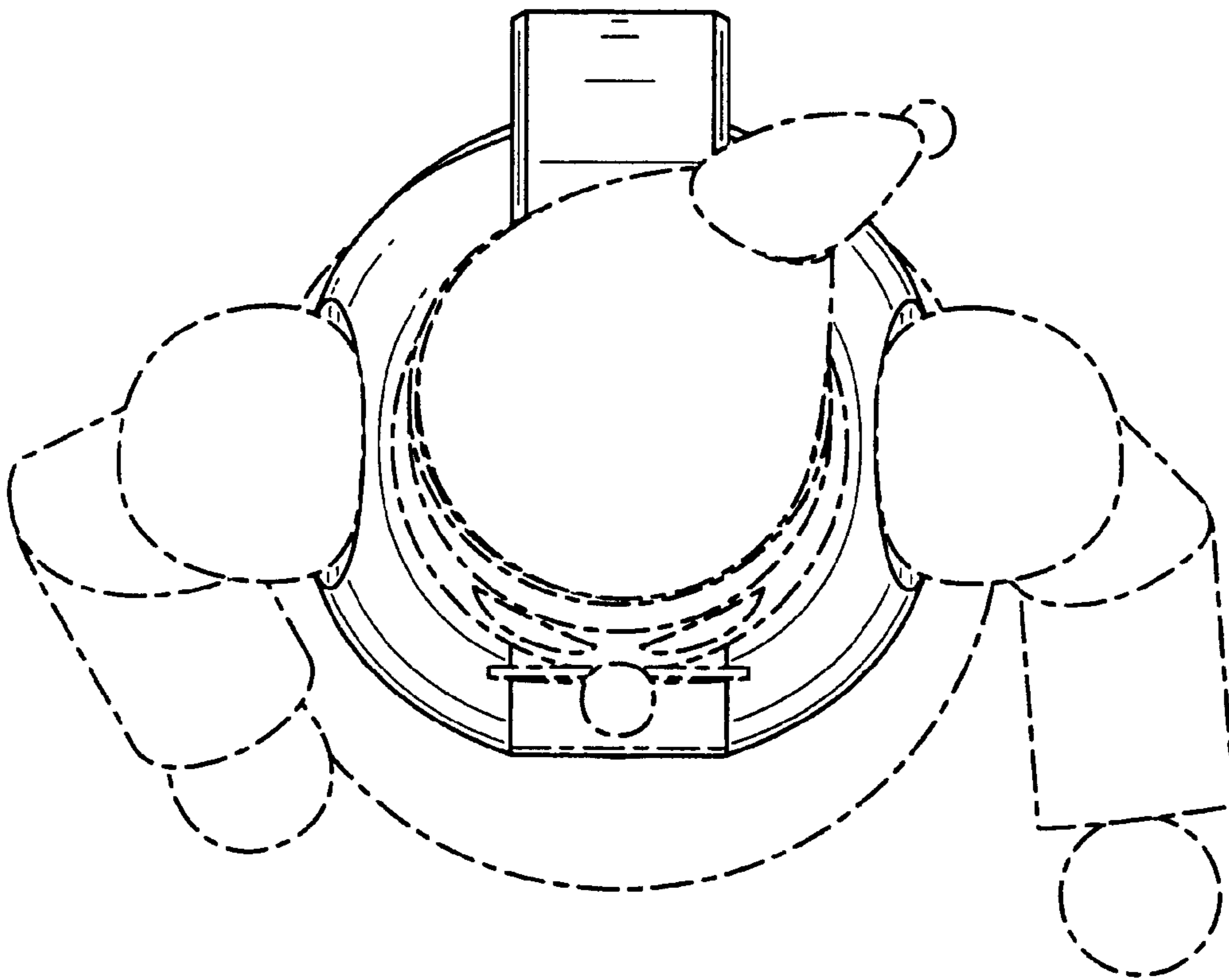

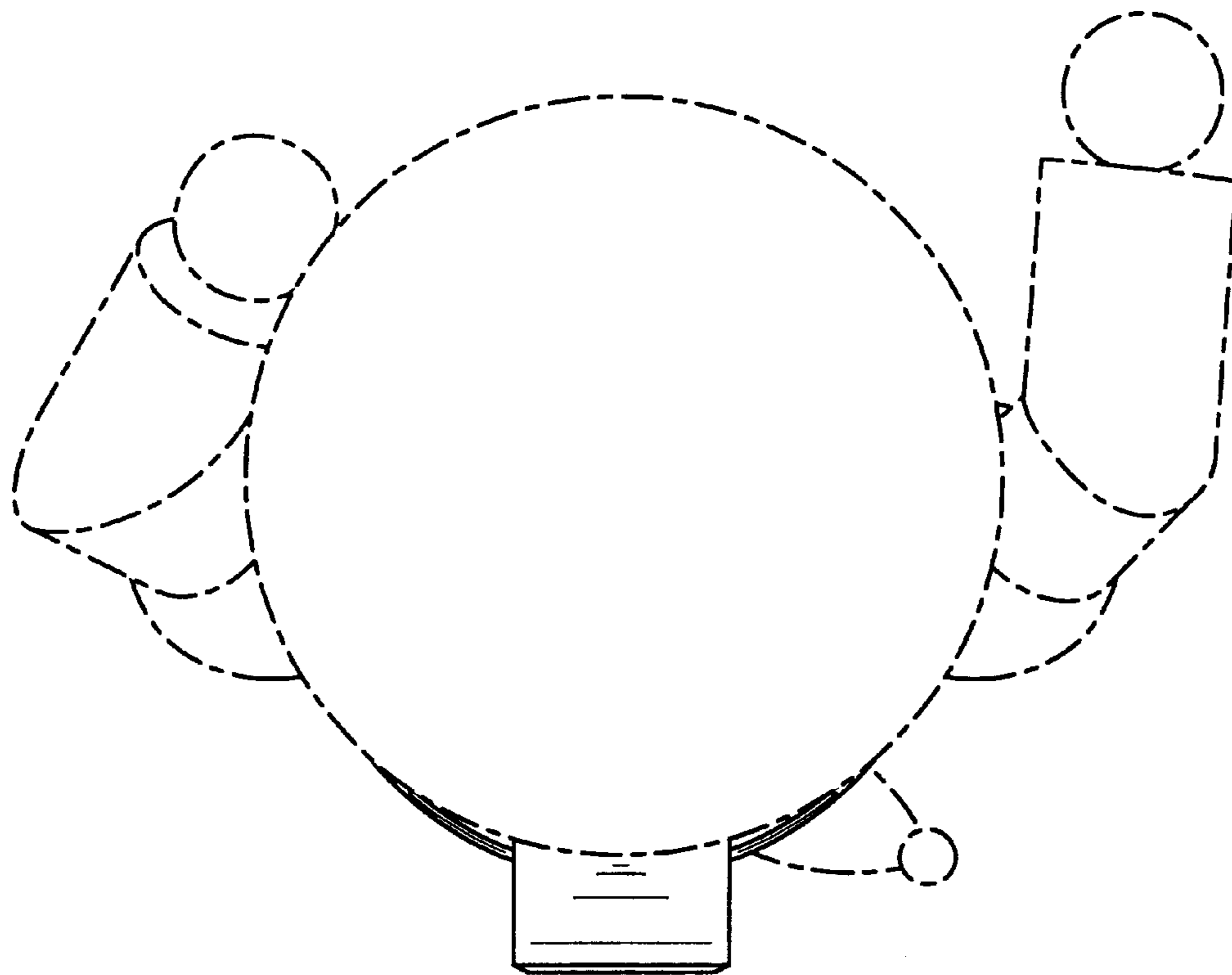
