(57) **CLAIM**

The ornamental design for a flagstaff for a motorcycle, as shown and described.

**DESCRIPTION**

FIG. 1 is an elevational view of a flagstaff for a motorcycle illustrating my design, the opposite side being a mirror image thereof;

FIG. 2 is a view as seen from the left side of FIG. 1;

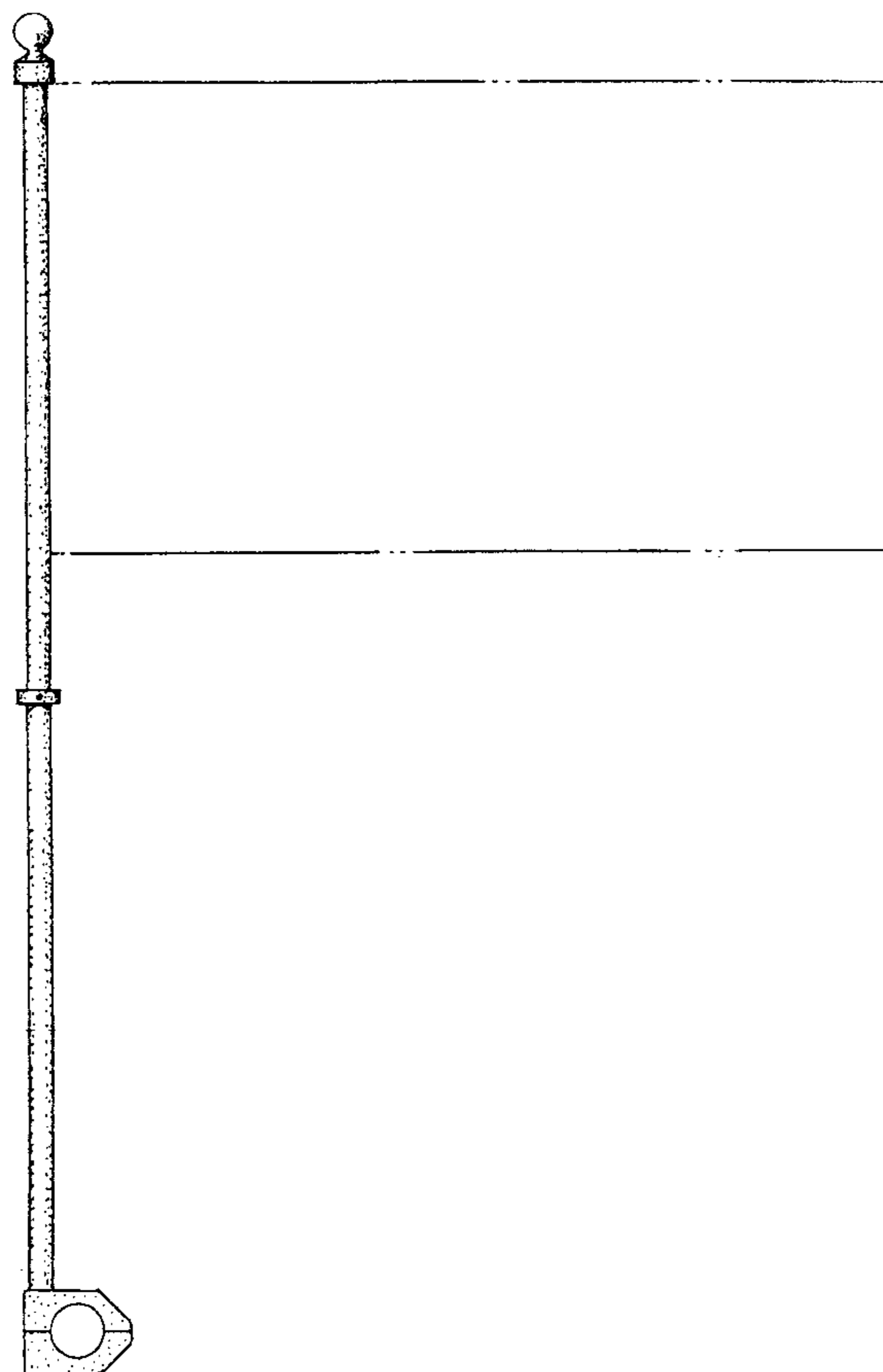
FIG. 3 is a view as seen from the right side of FIG. 1;

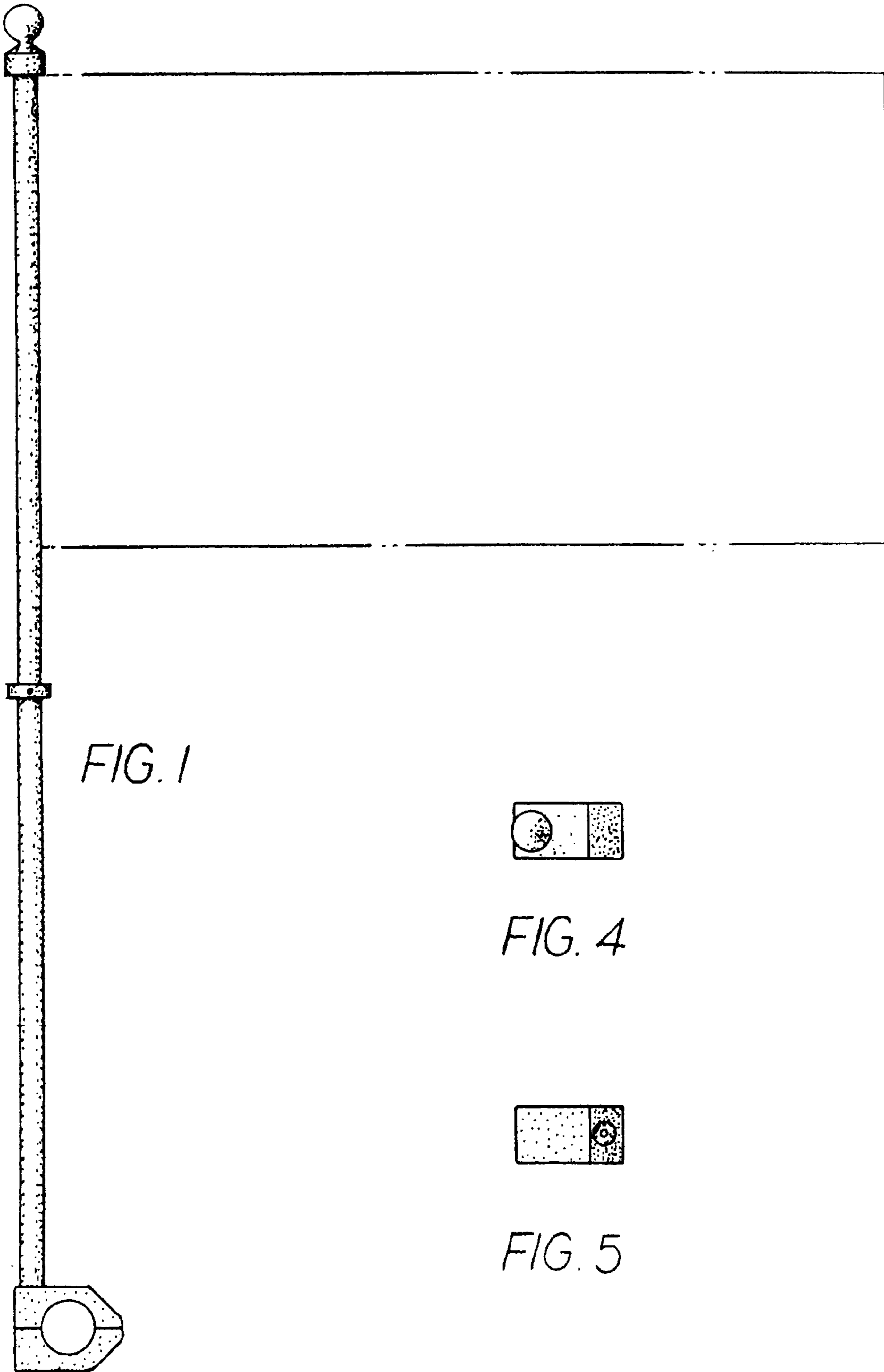
FIG. 4 is a view as seen from the top side of FIG. 1; and,

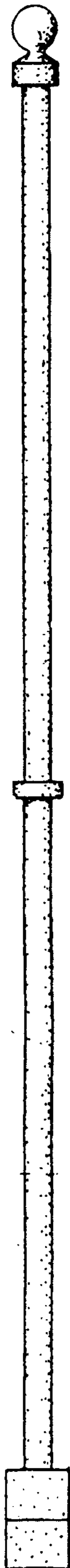
