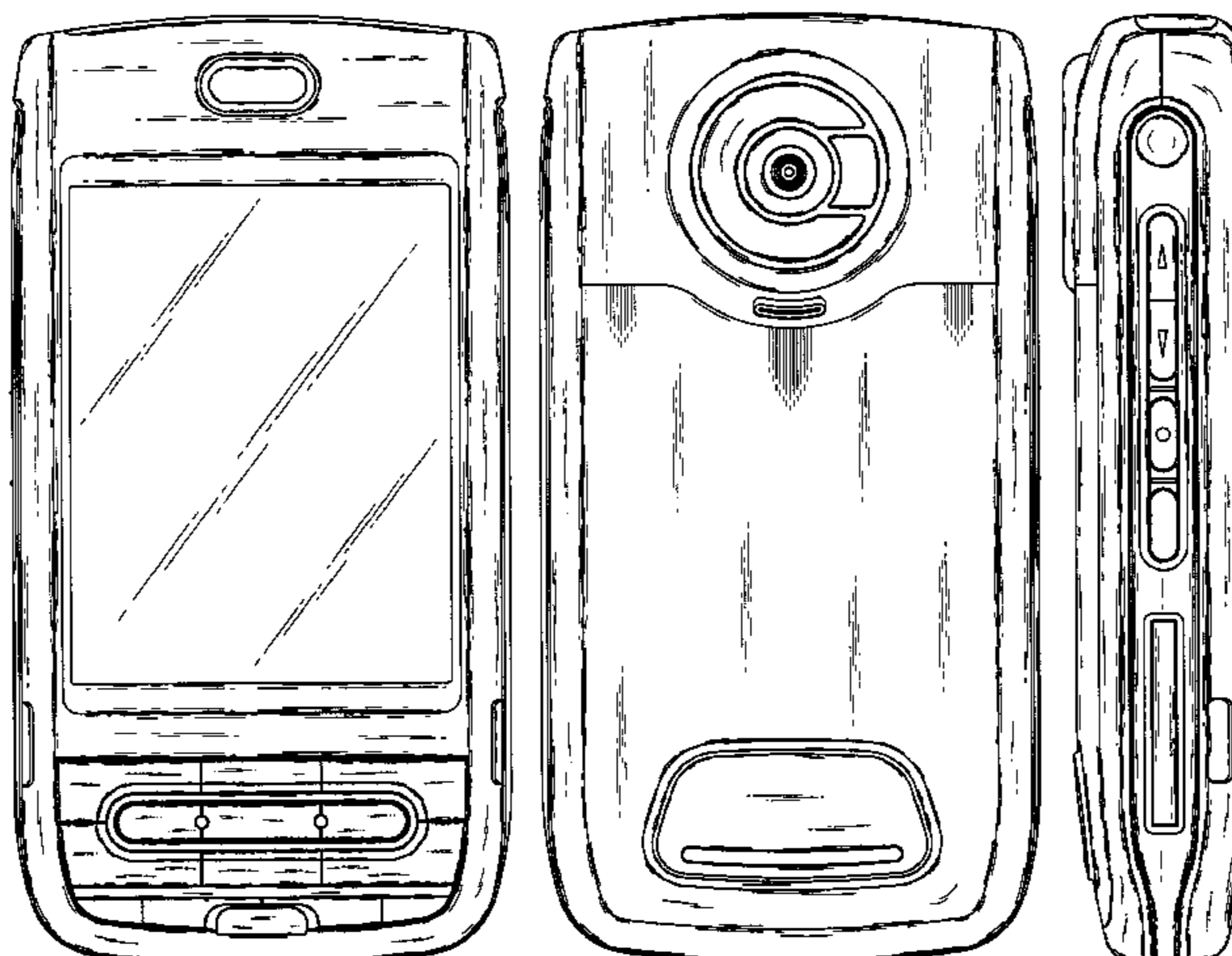
I claim the ornamental design for phone-combined personal digital assistant, as shown and described.

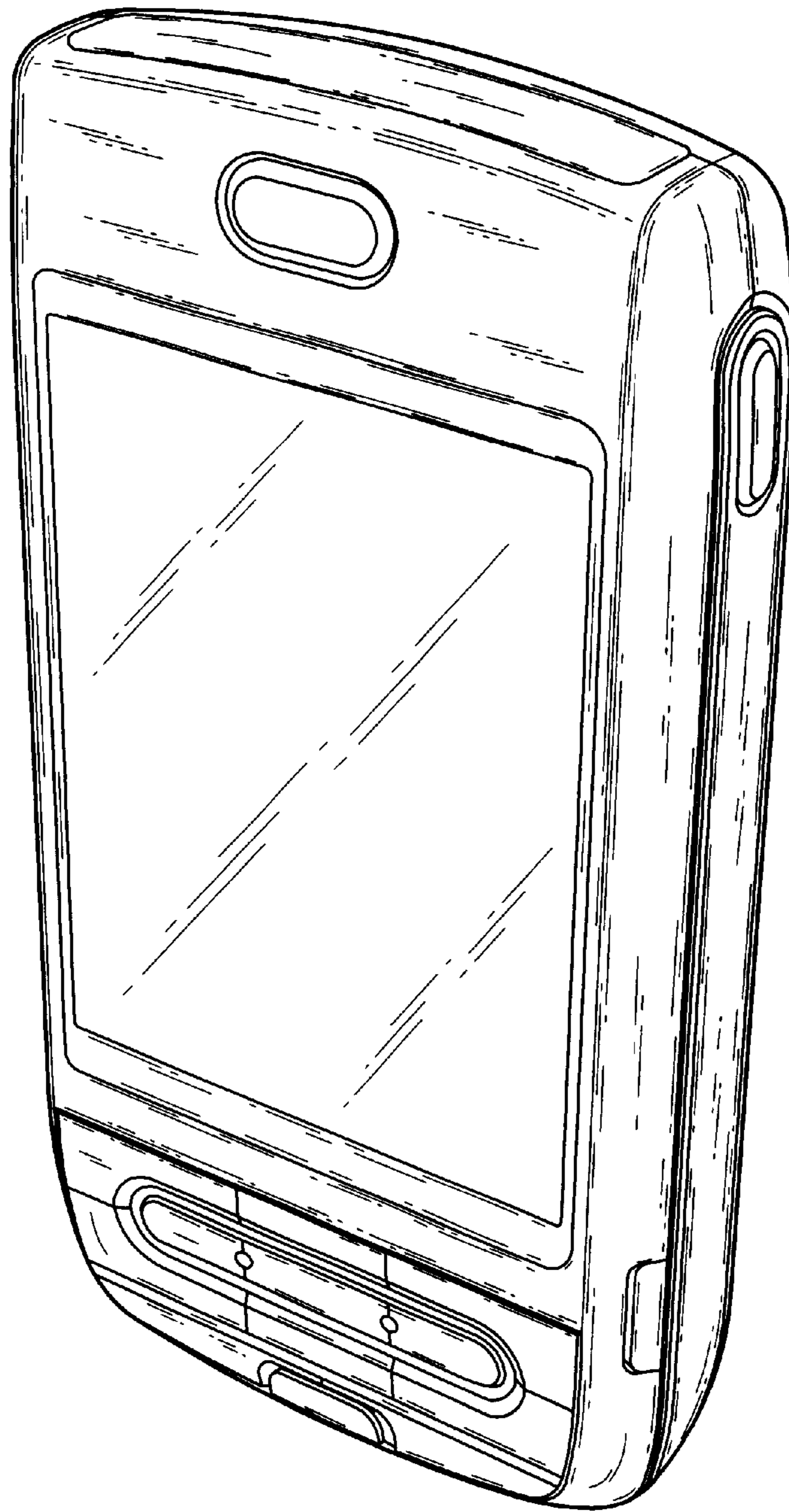

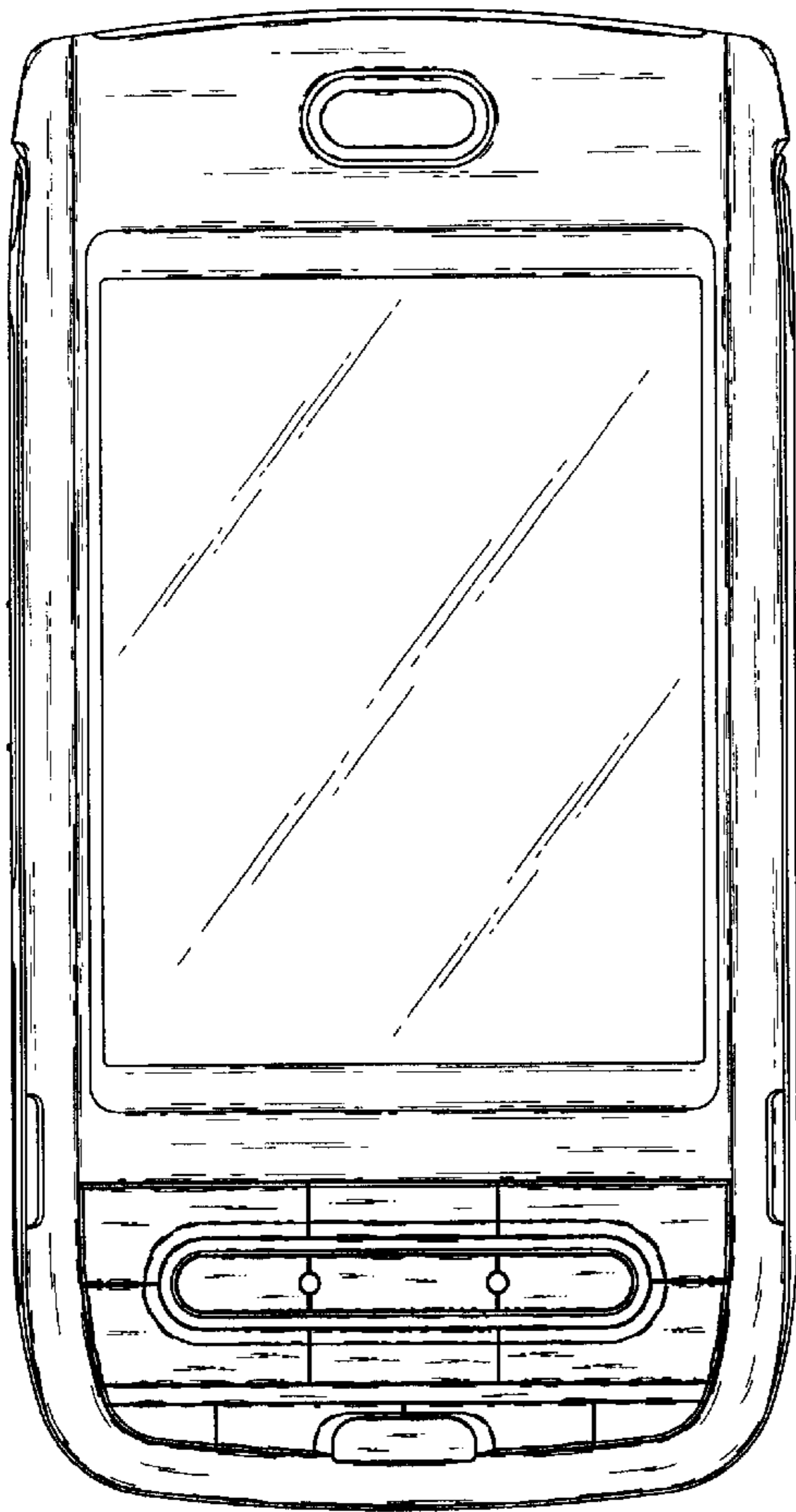

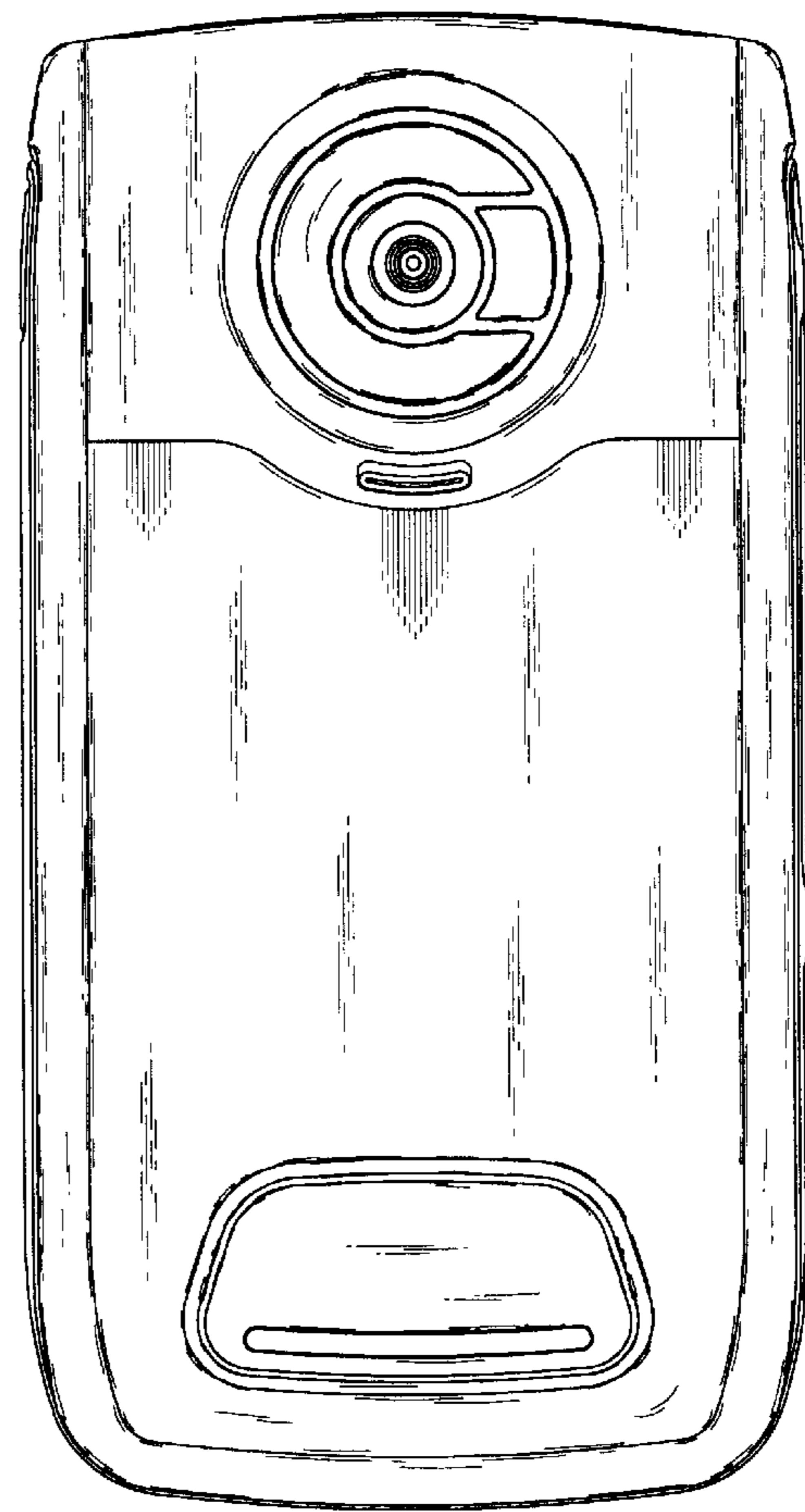

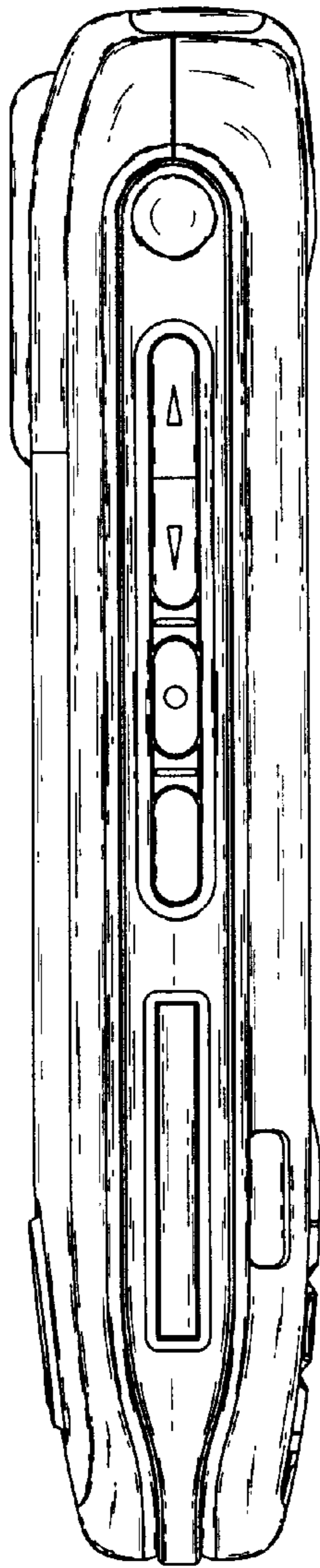

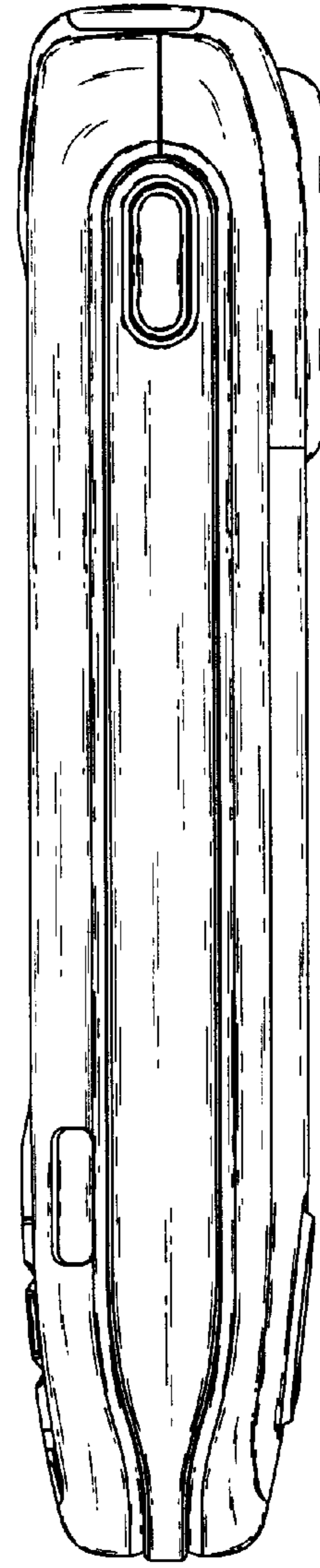

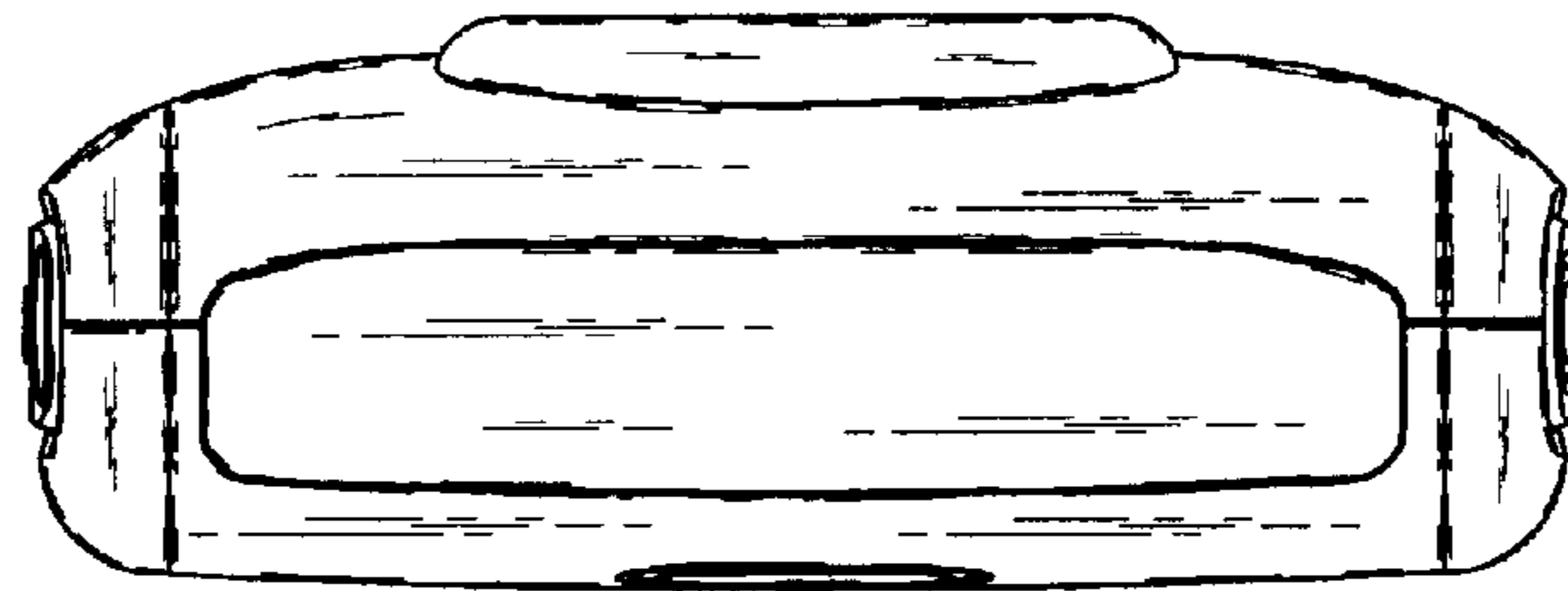
