FIG. 2 is a right side view of the design for a right side panel for a combine of FIG. 1.

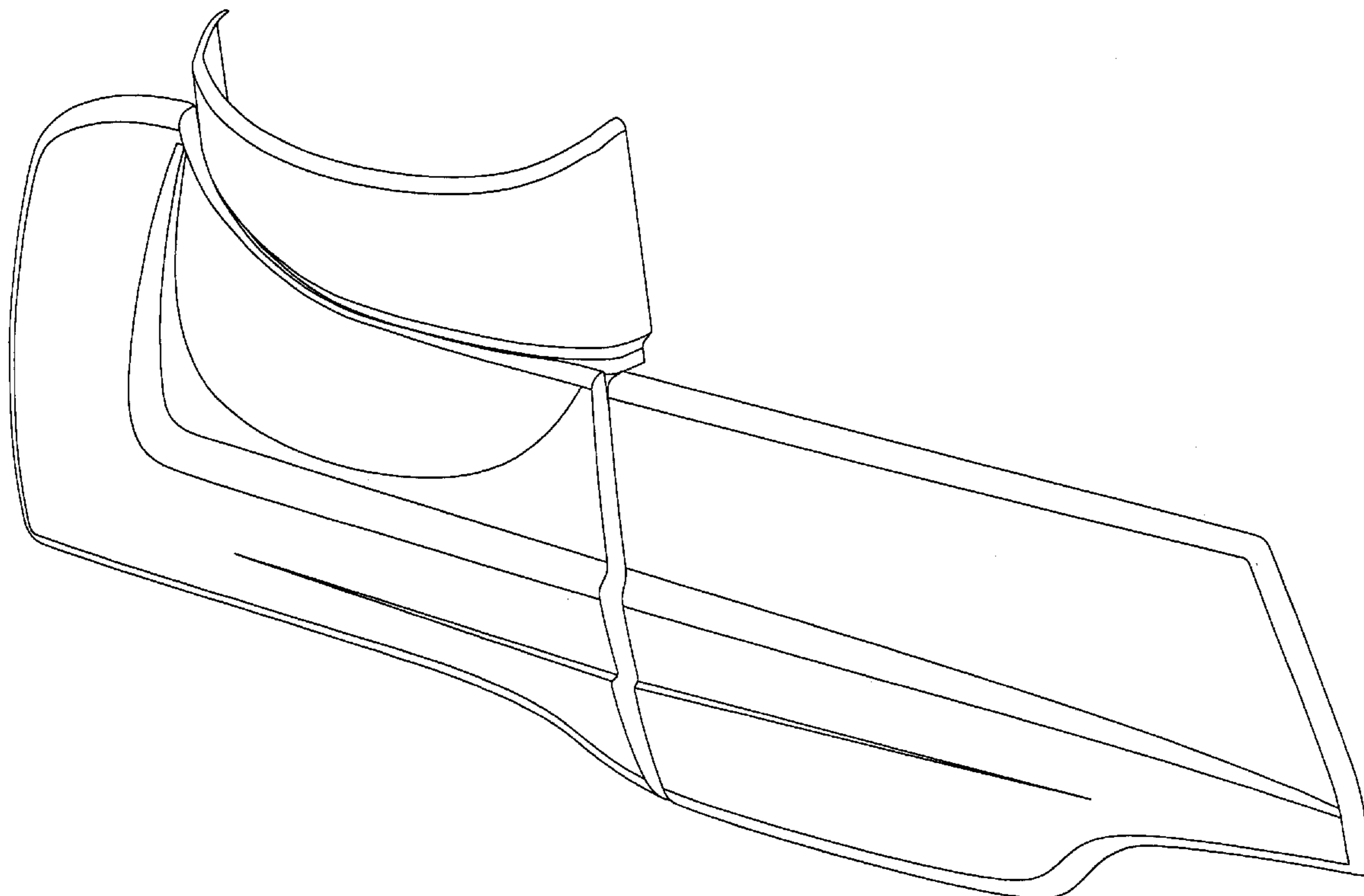
FIG. 3 is a front view of the design for a right side panel for a combine of FIG. 1.

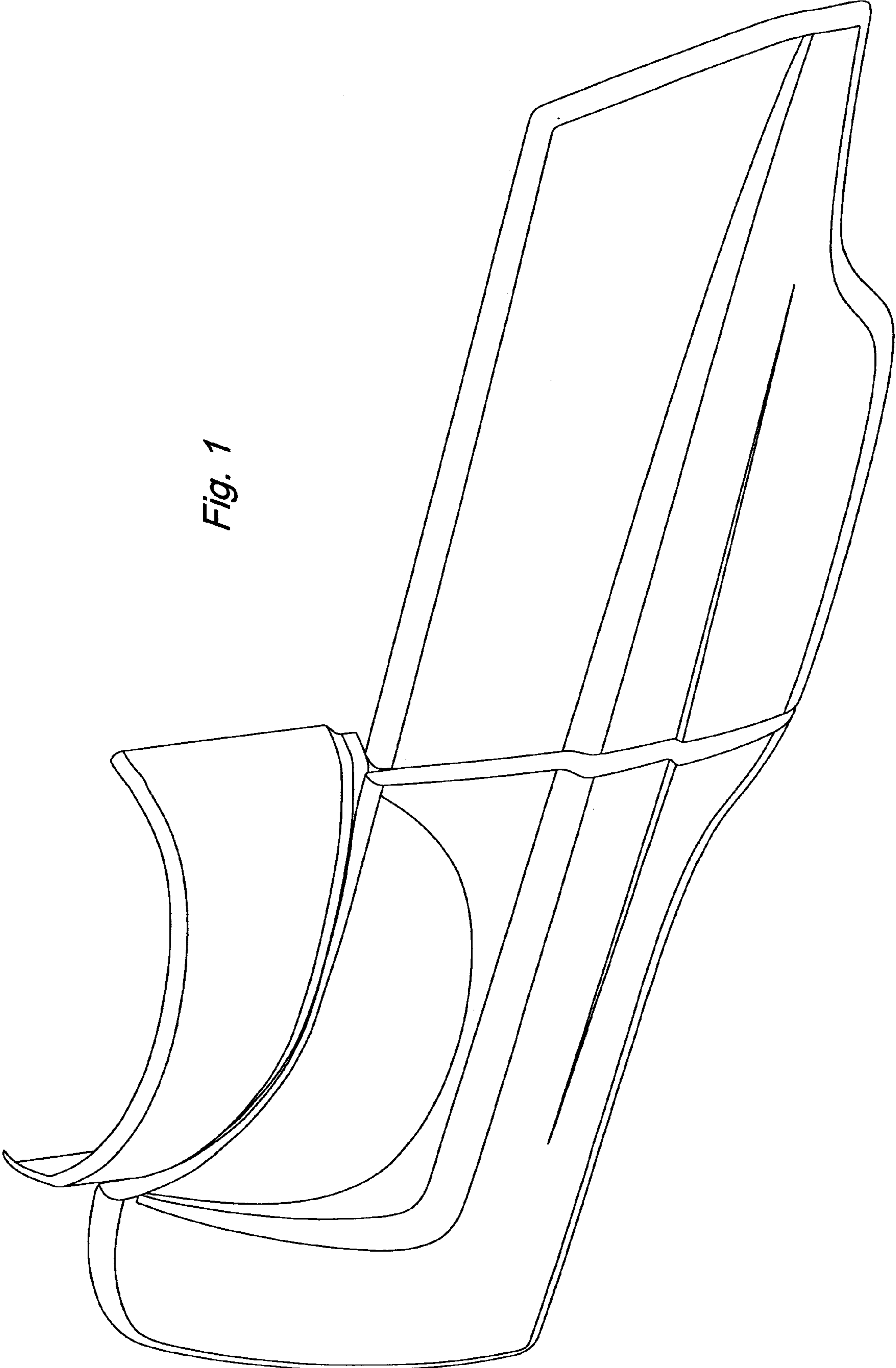

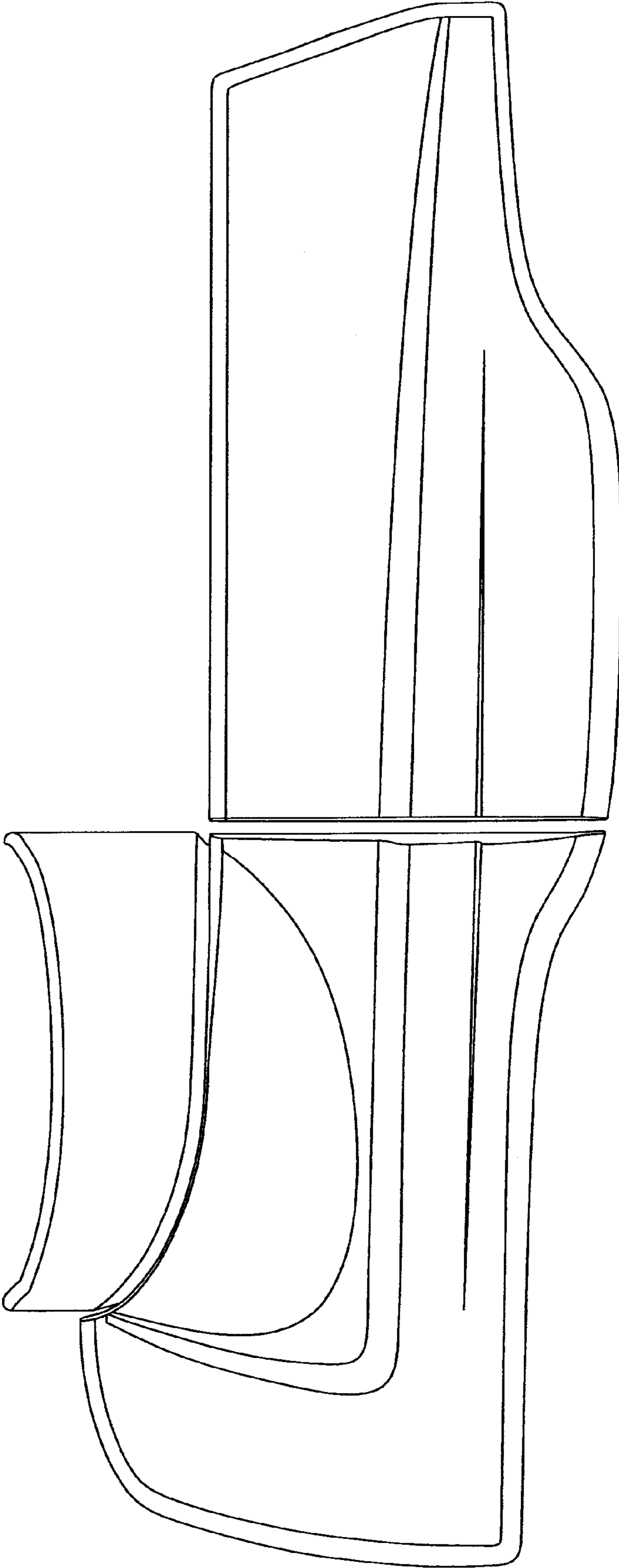

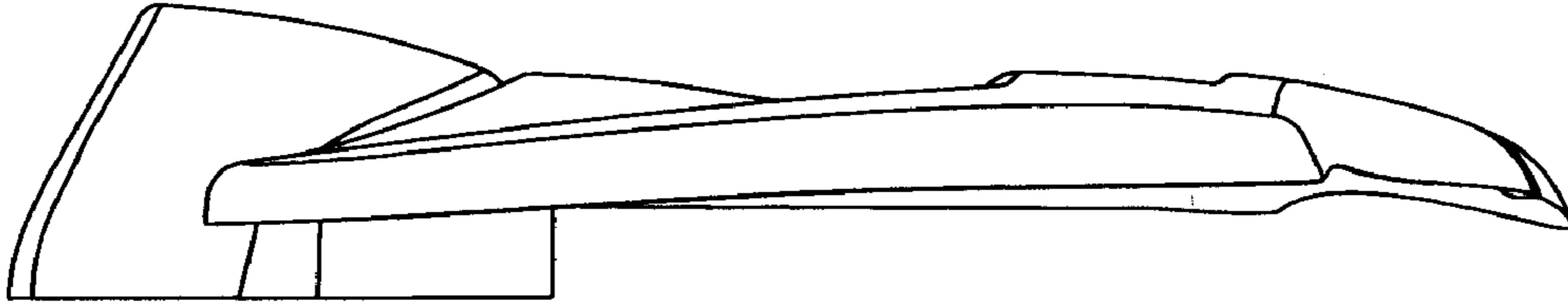

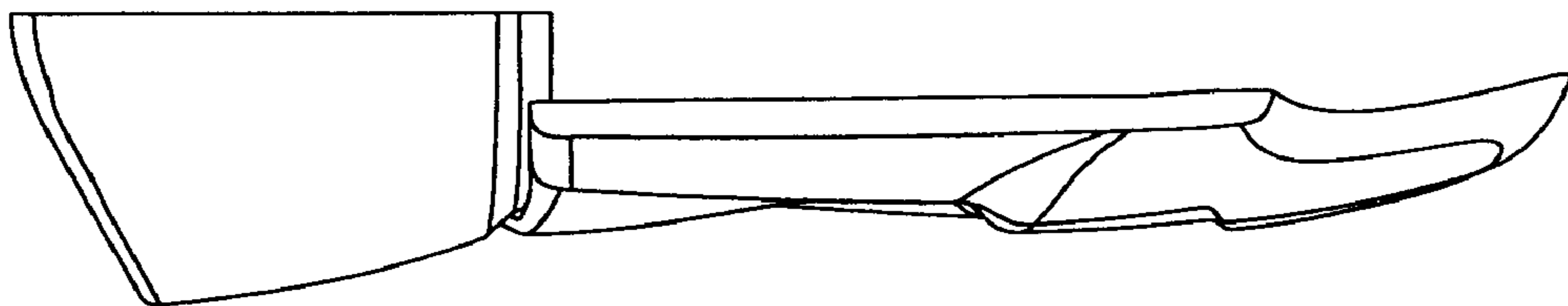

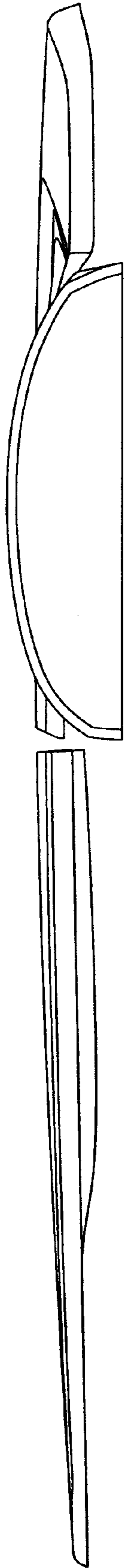

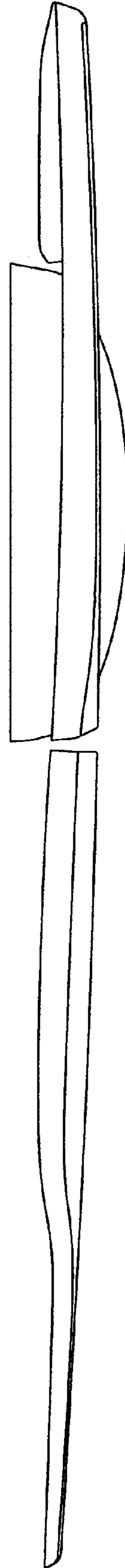
