I claim the ornamental design for a cutting insert, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cutting insert showing my new design;

FIG. 2 is a side elevational view of the cutting insert shown in FIG. 1;

FIG. 3 is a top plan view of the cutting insert shown in FIG. 1;

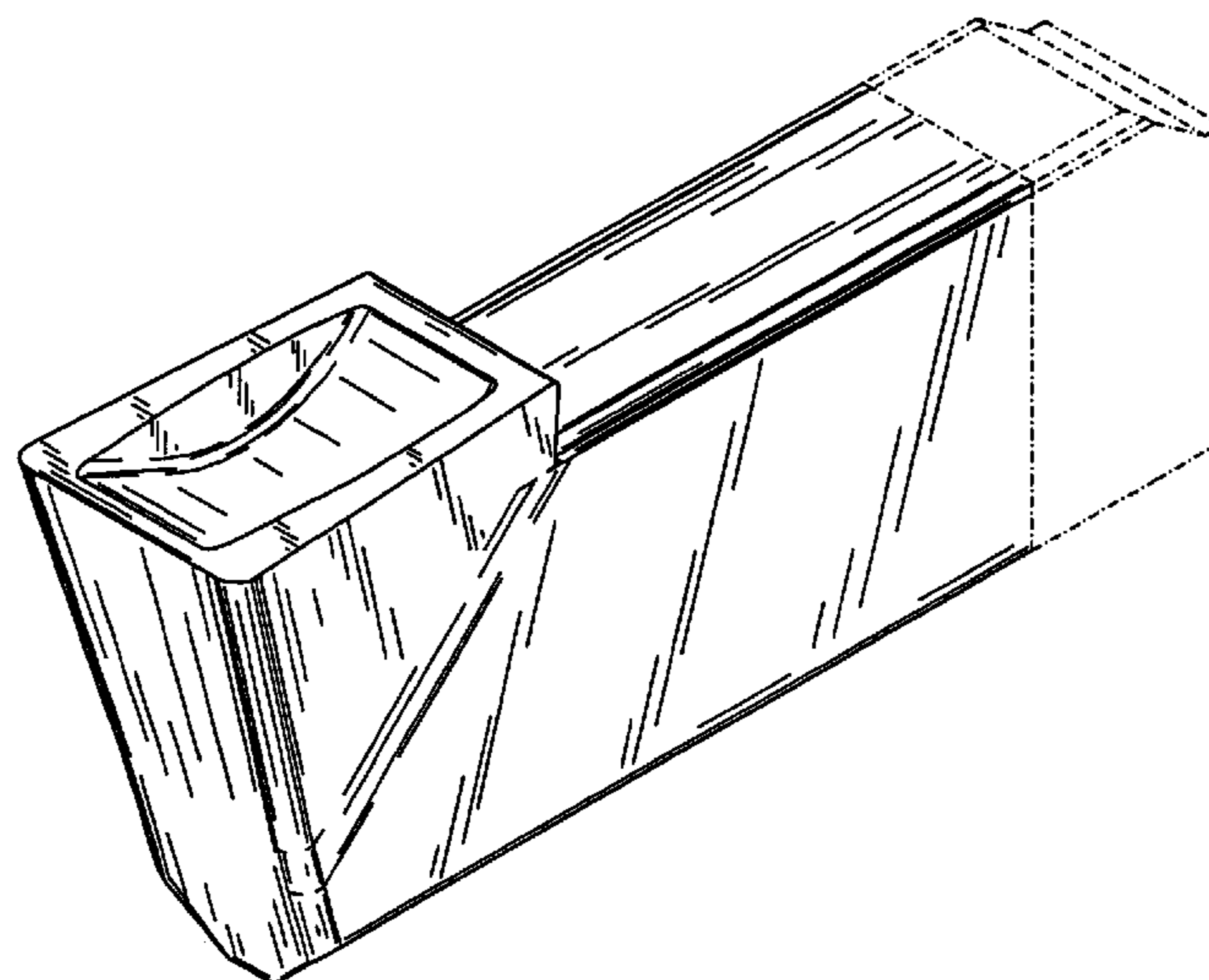
FIG. 4 is a bottom plan view of the cutting insert shown in FIG. 1.

FIG. 5 is a left end view of the cutting insert shown in FIG. 1; and,

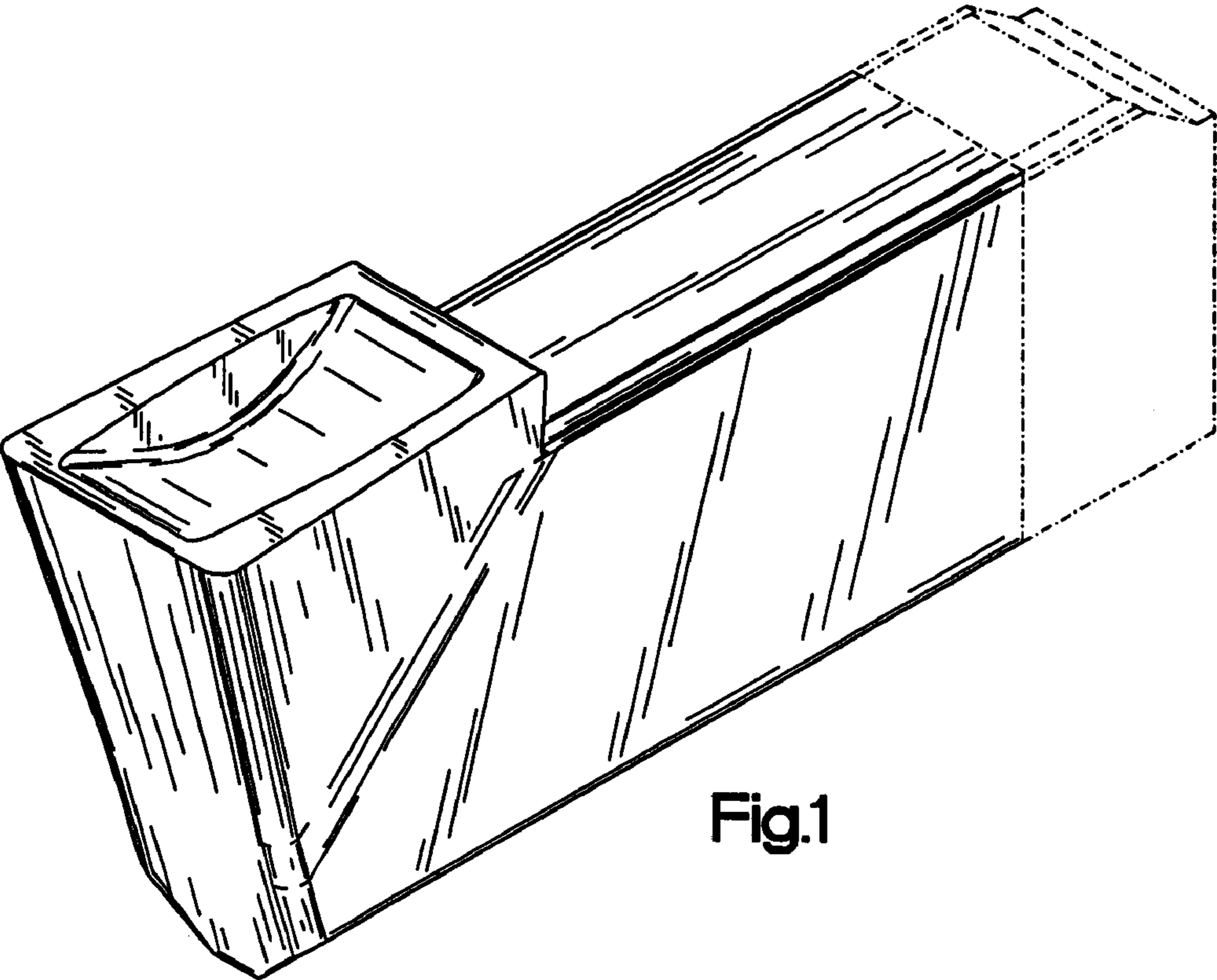

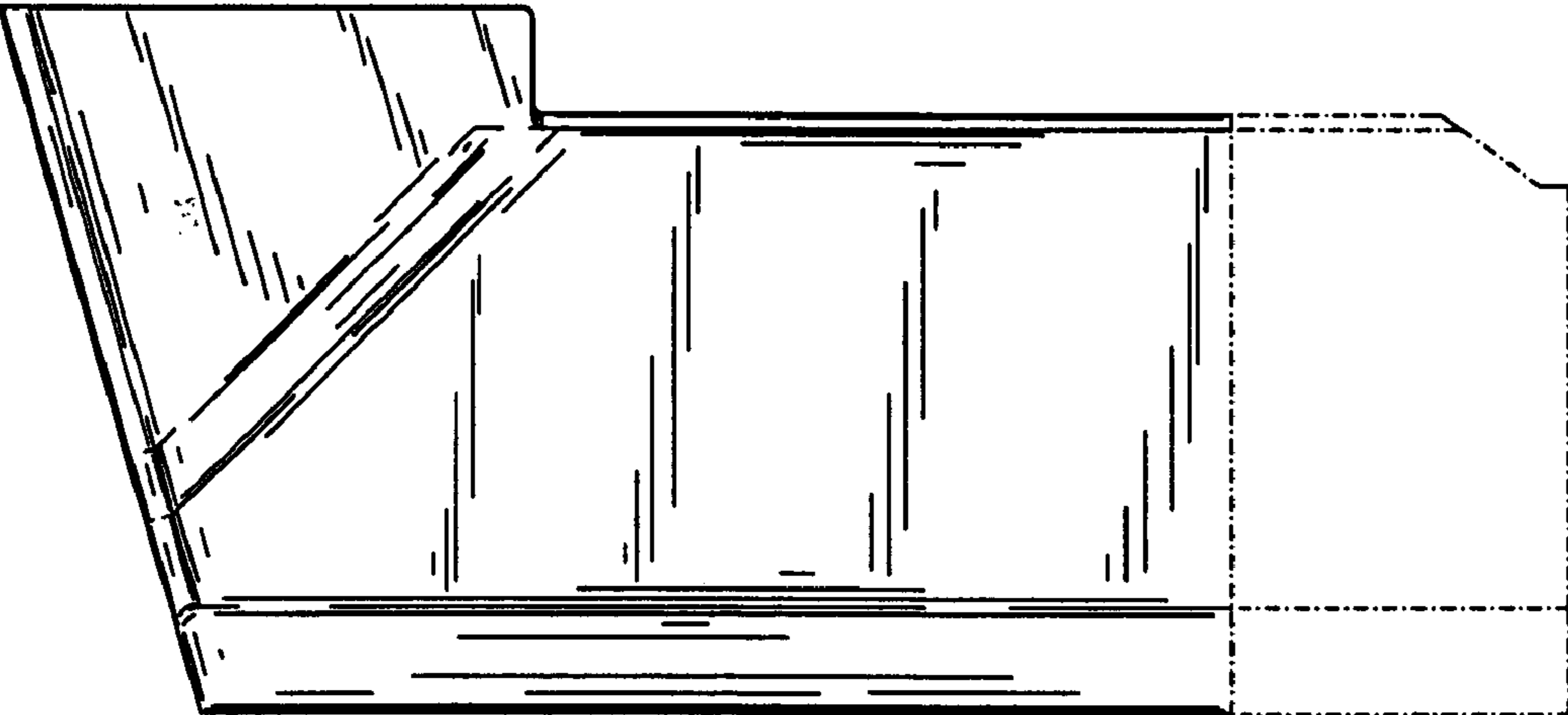

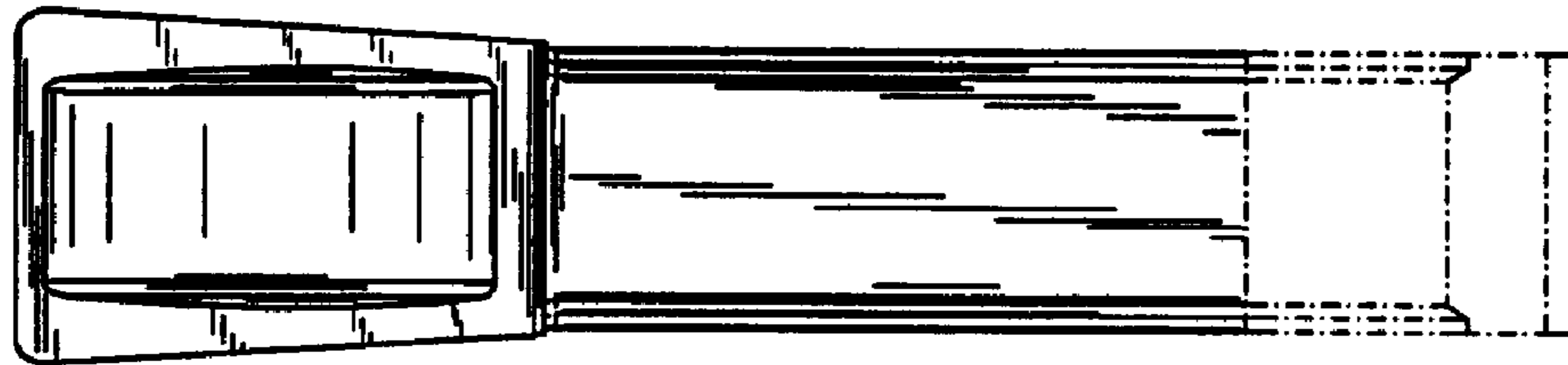

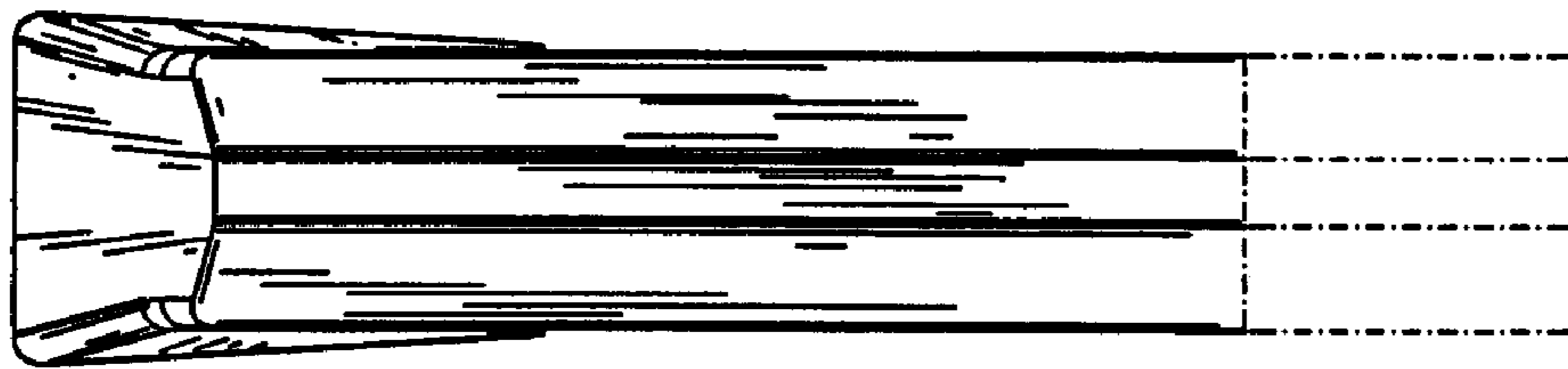

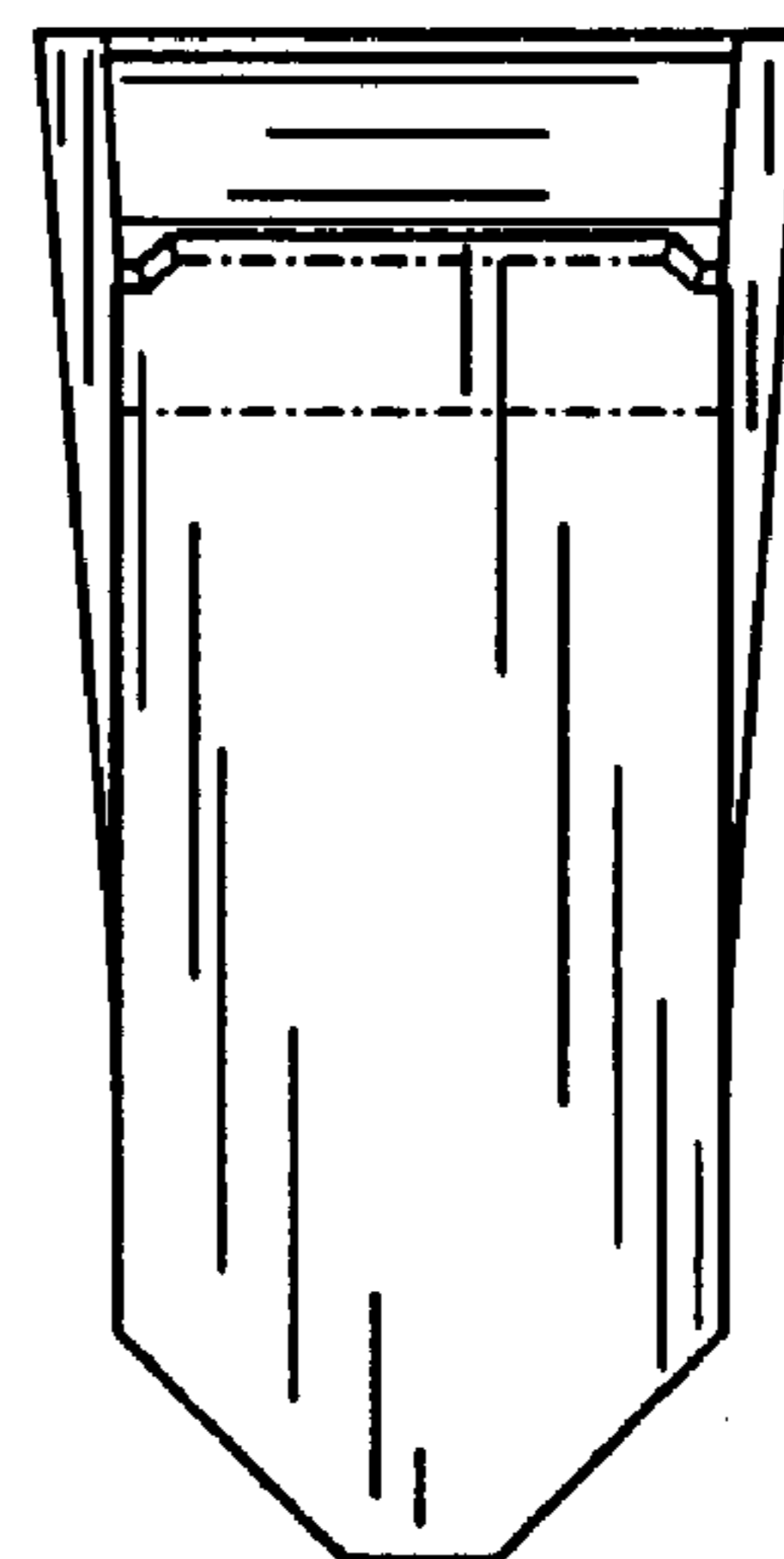
