FIG. 3 is a left view thereof;

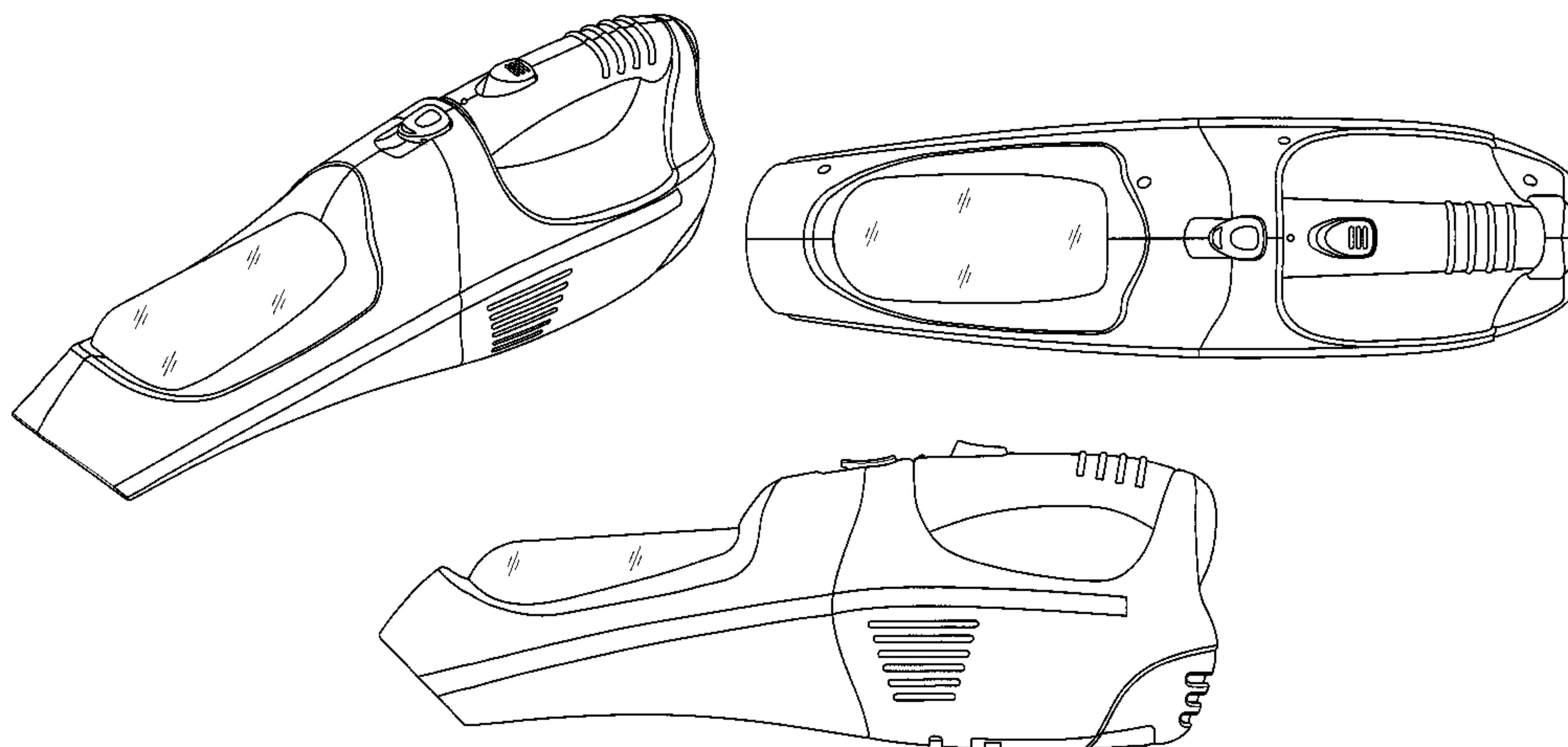
FIG. 4 is a front end view thereof;

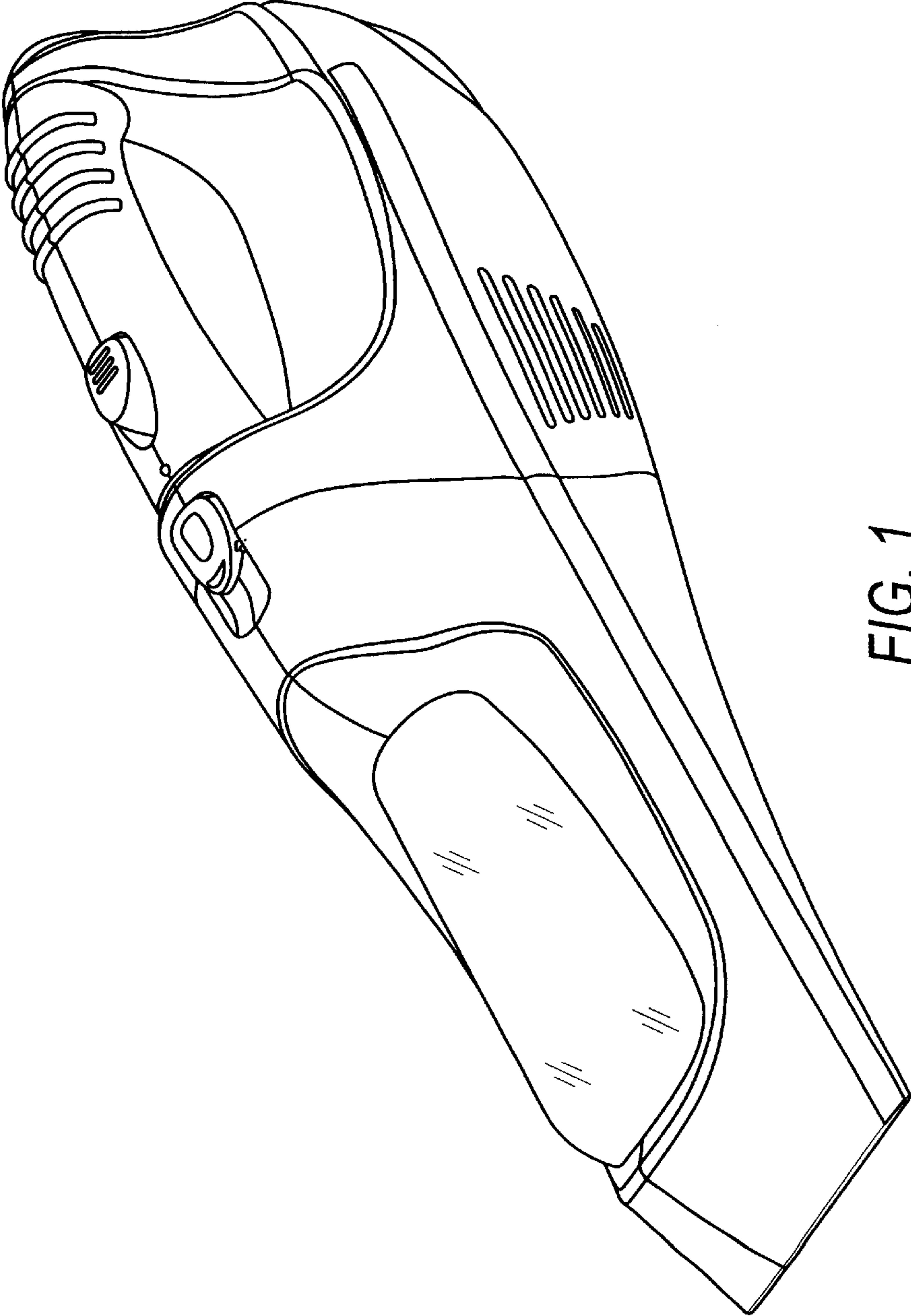

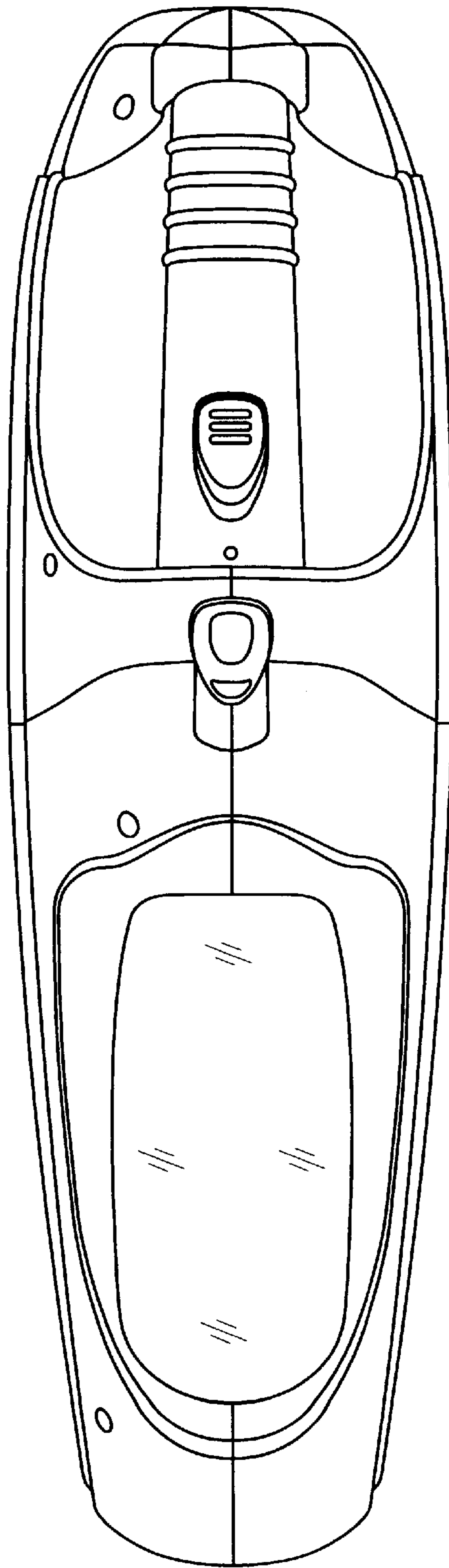

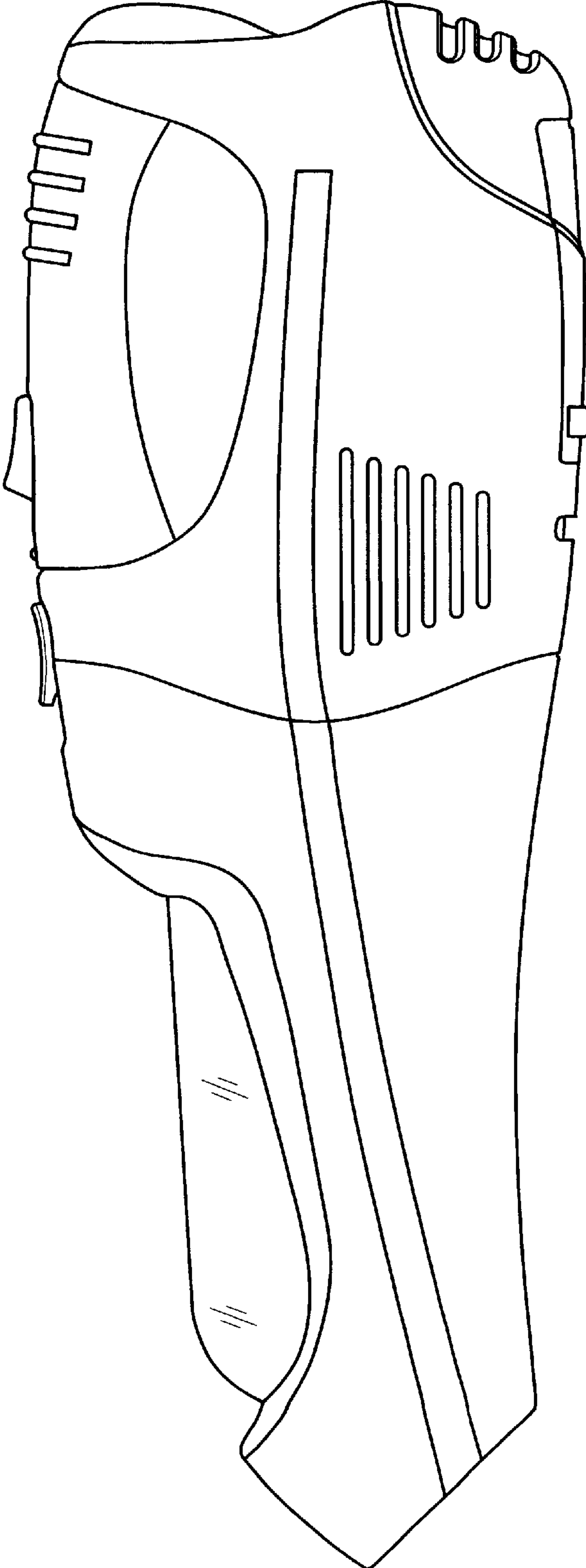

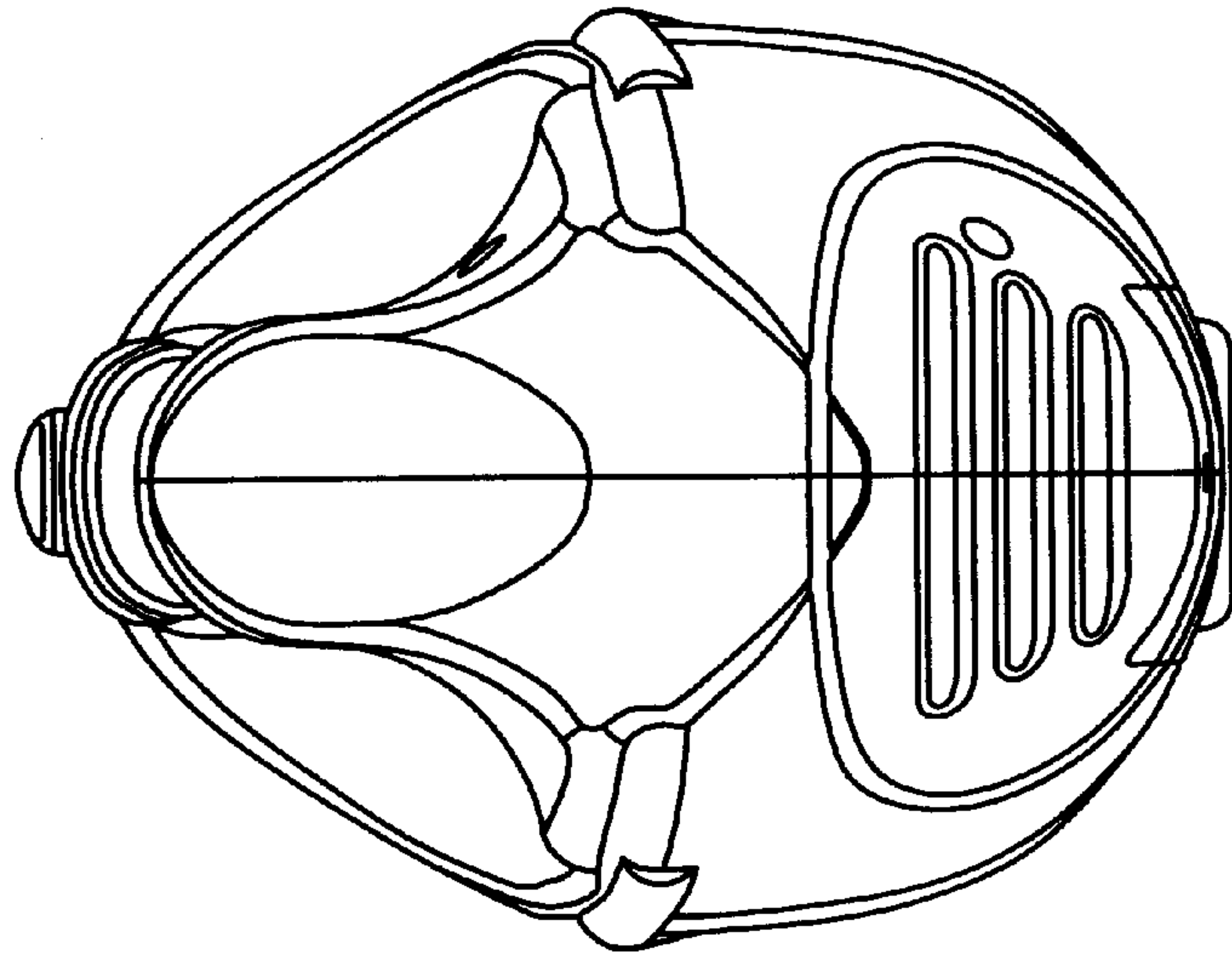

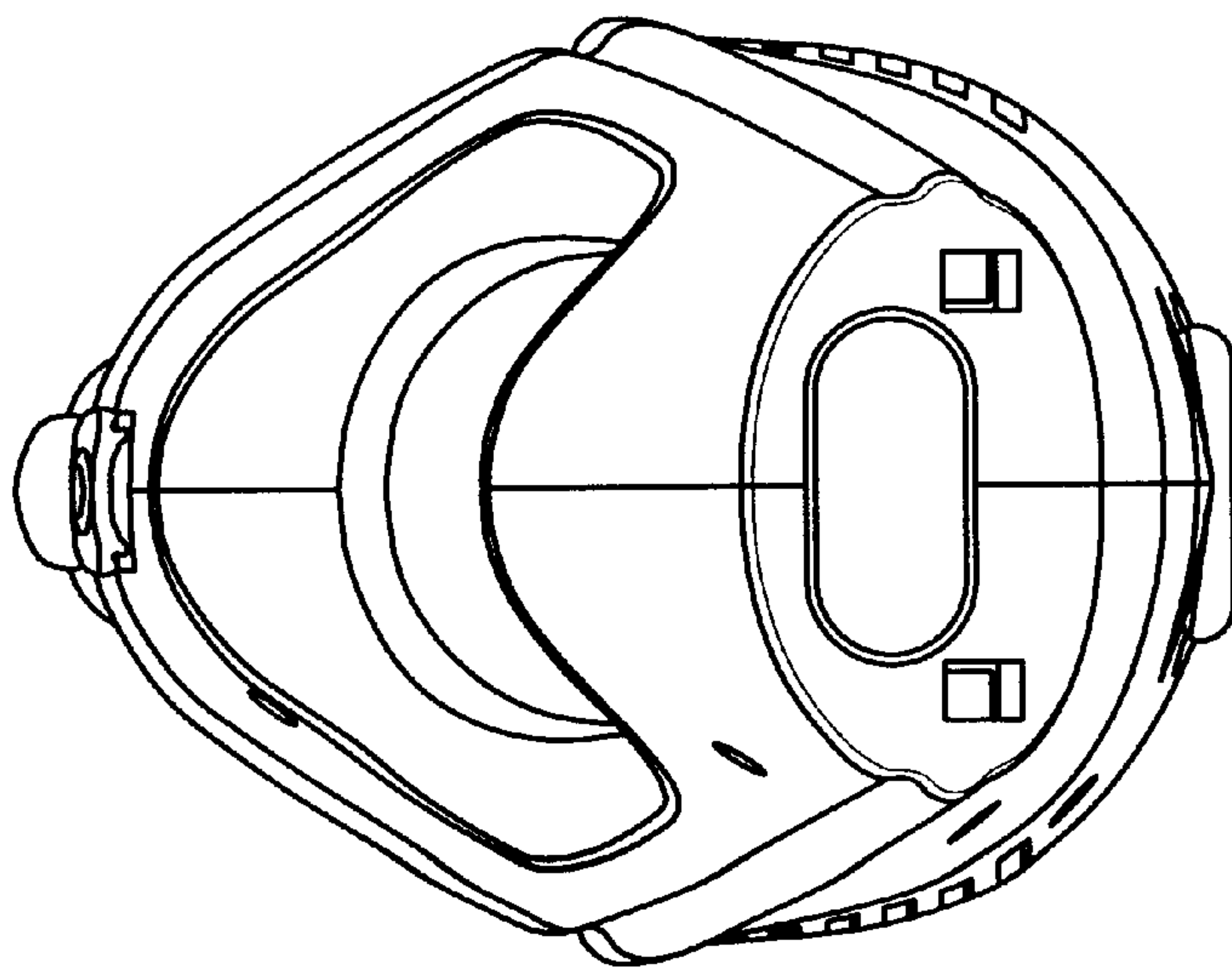

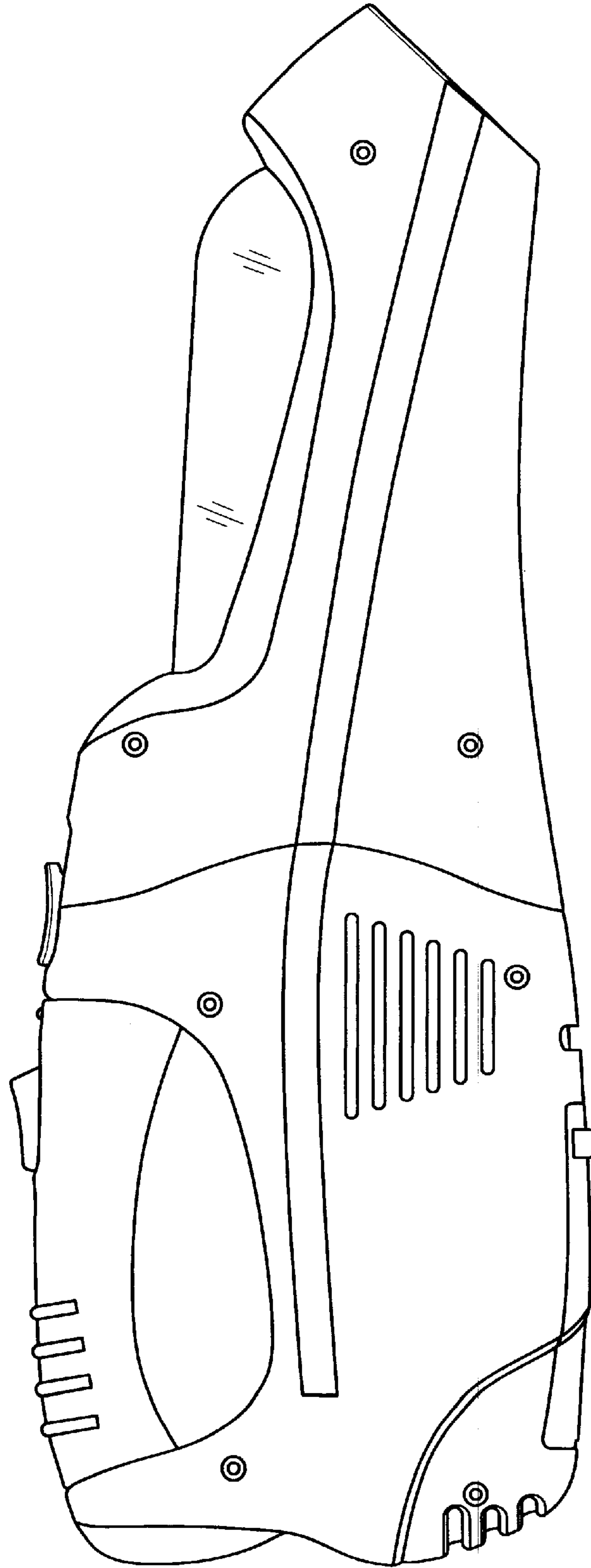

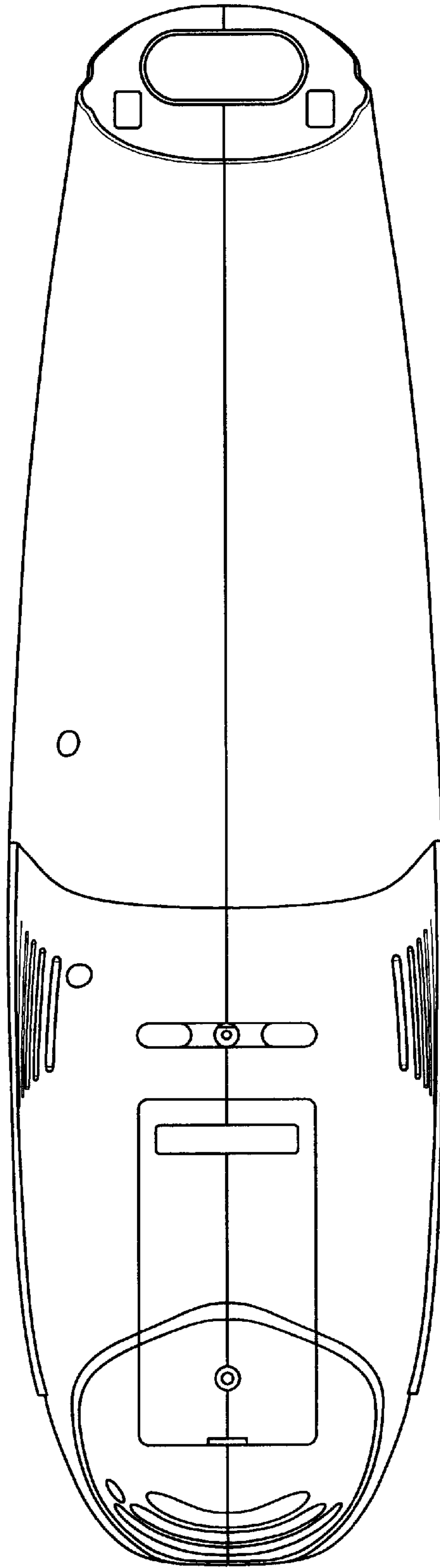
