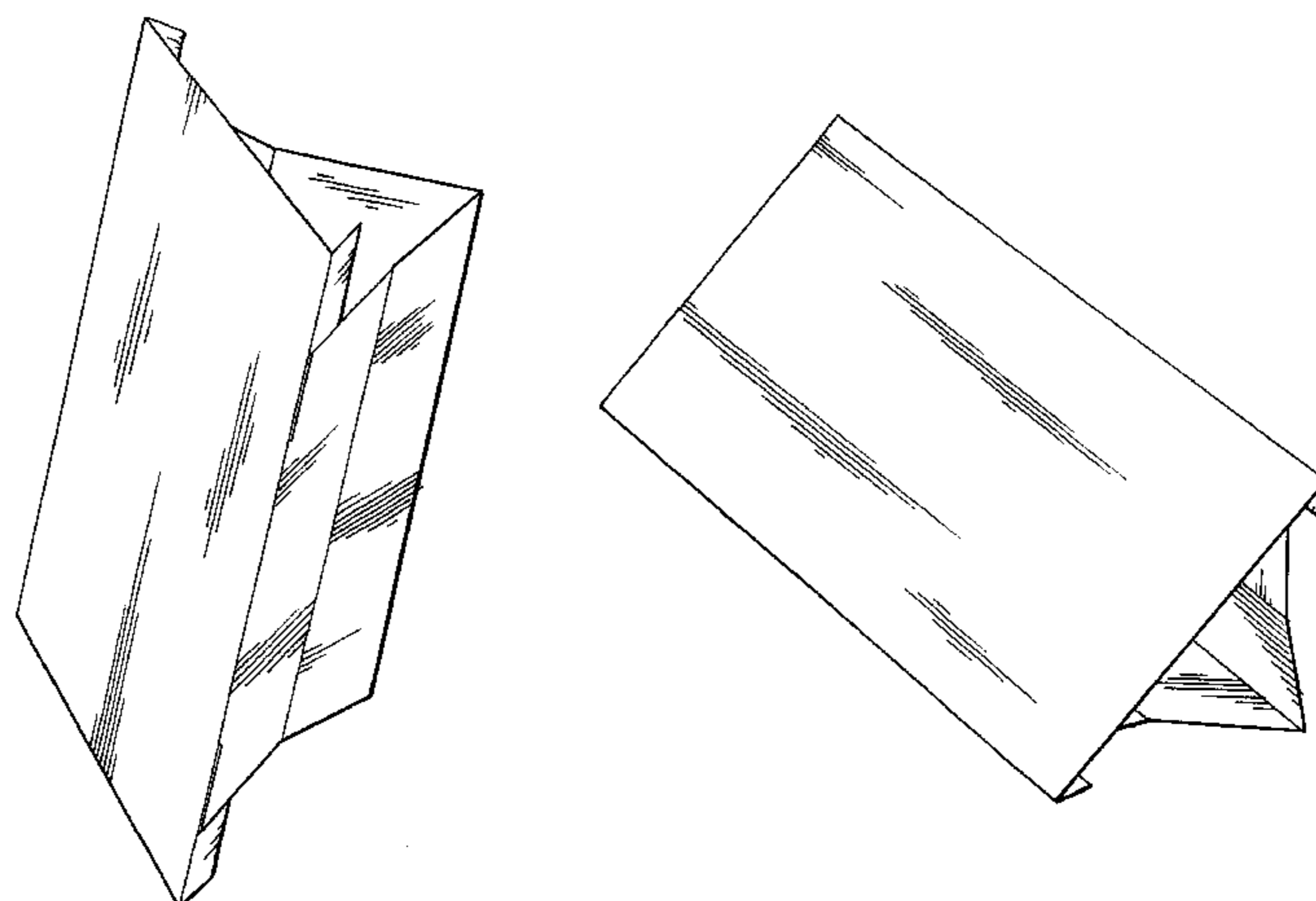
(57) **CLAIM**

The ornamental design for a folded picture frame, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the folded picture frame of the present invention in a portrait orientation; FIG. 2 is a perspective view of the folded picture frame shown in FIG. 1 in a landscape orientation; FIG. 3 is a left side elevation view thereof; FIG. 4 is a front elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a rear elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

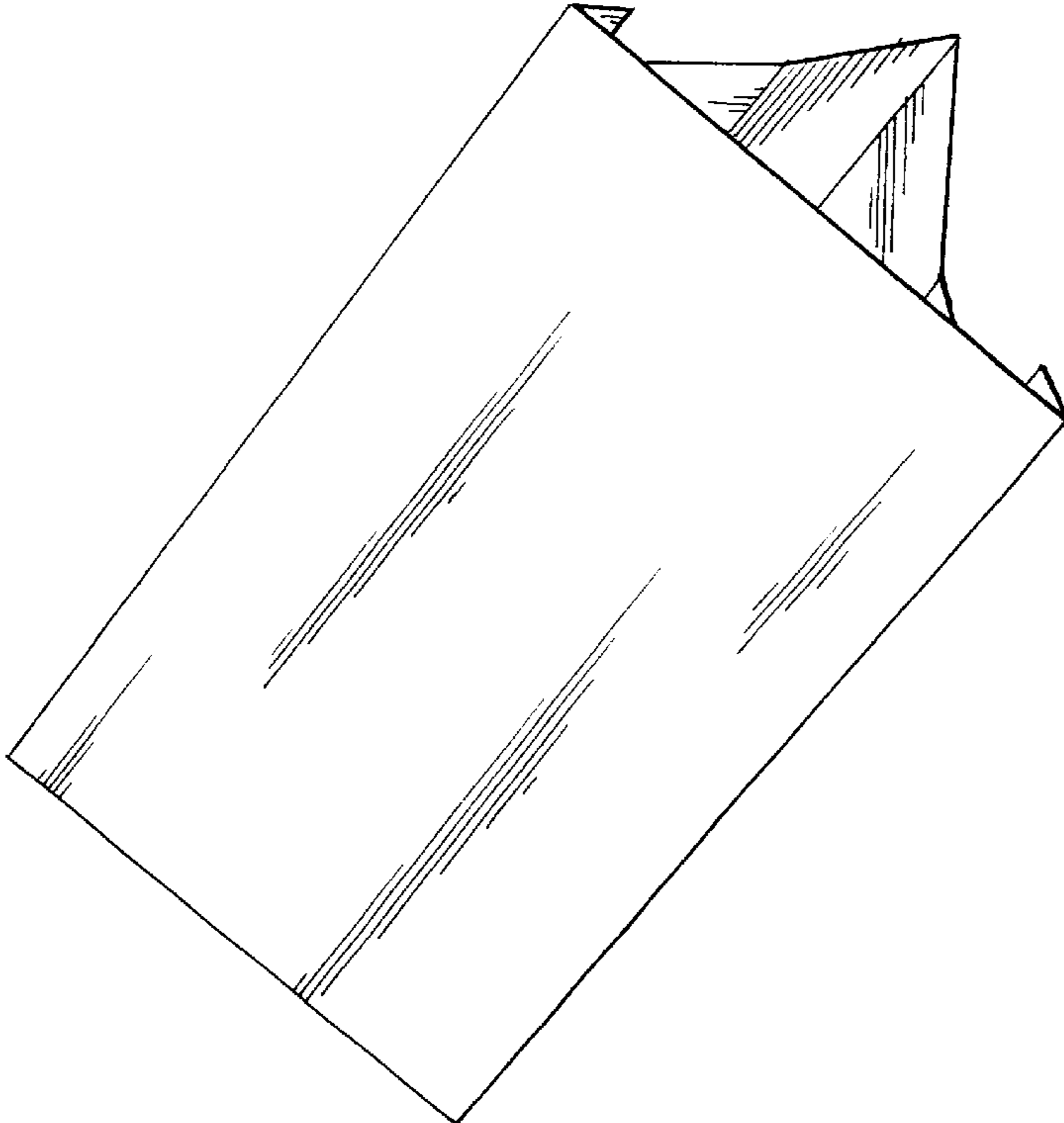

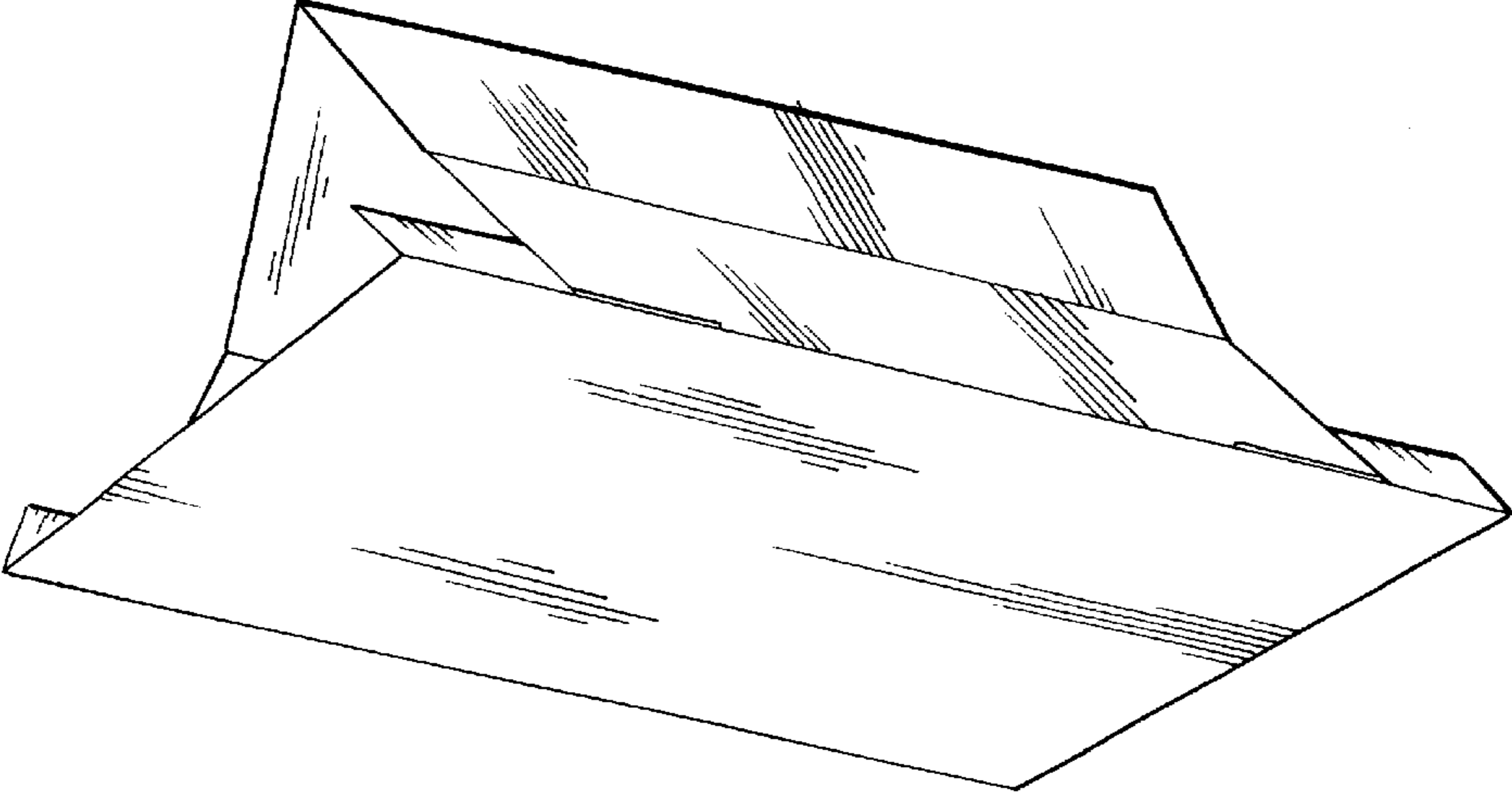

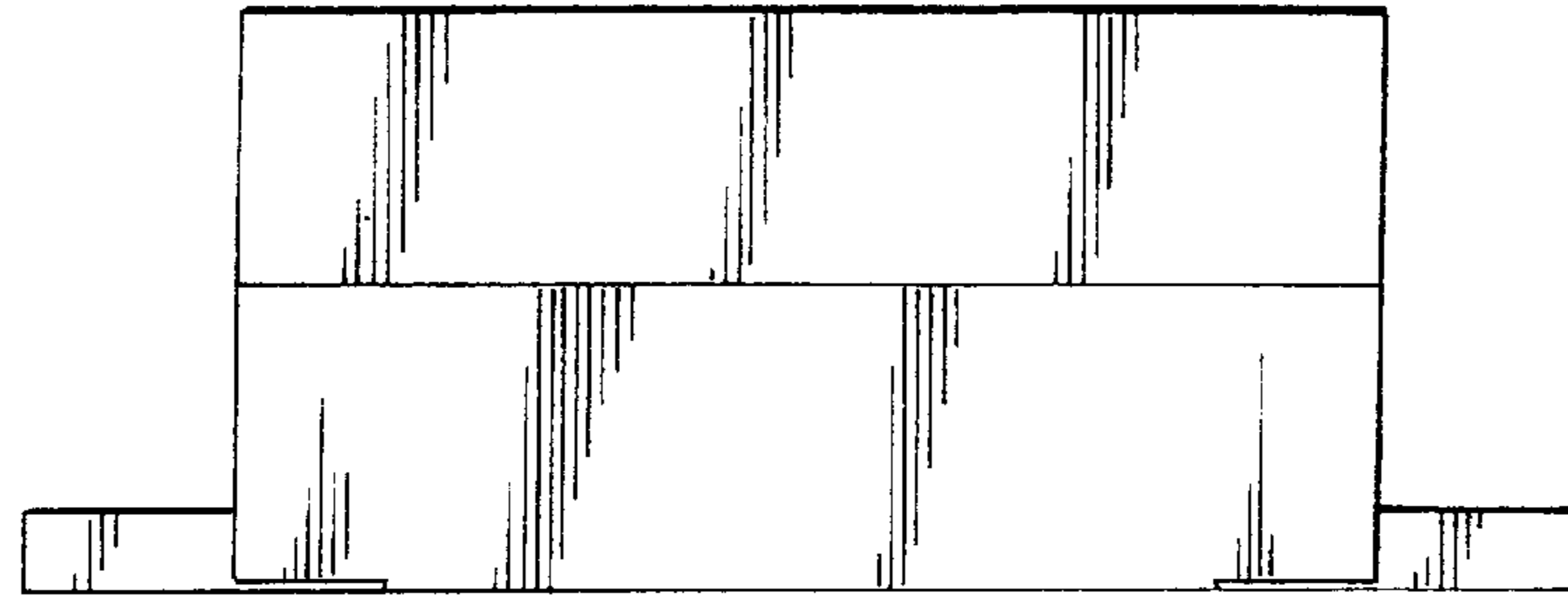

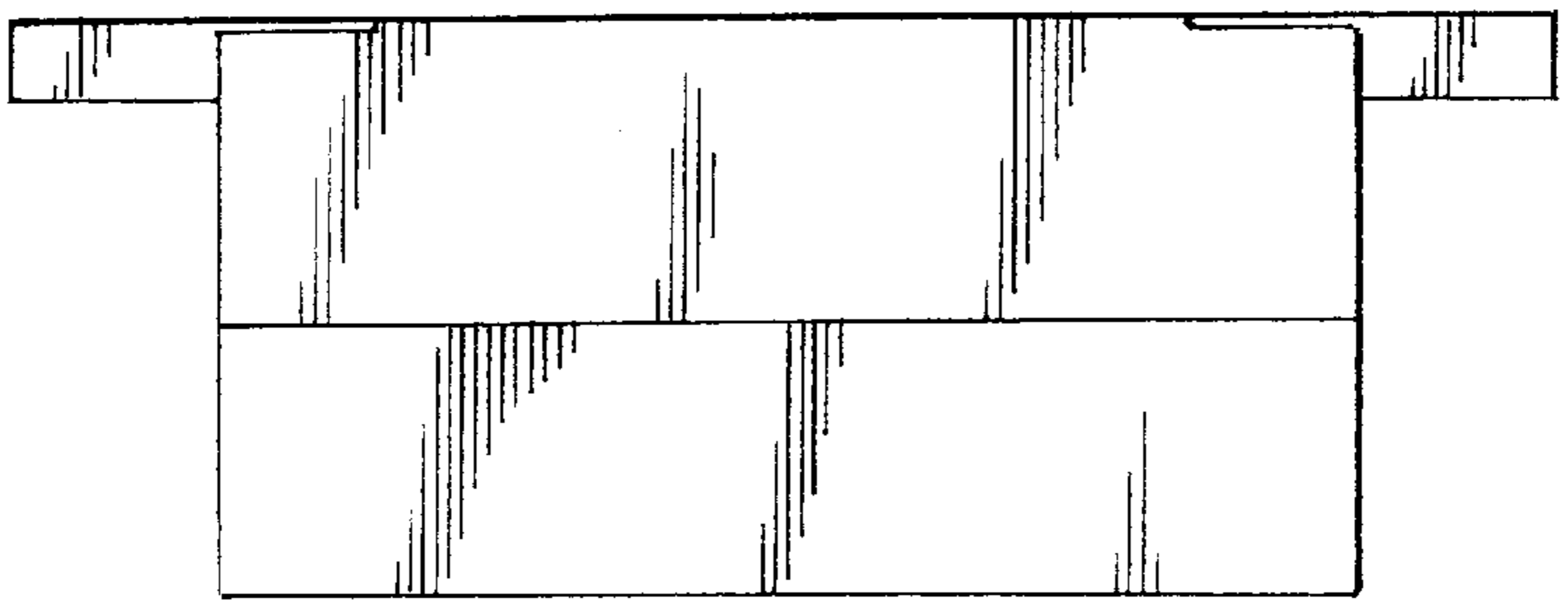

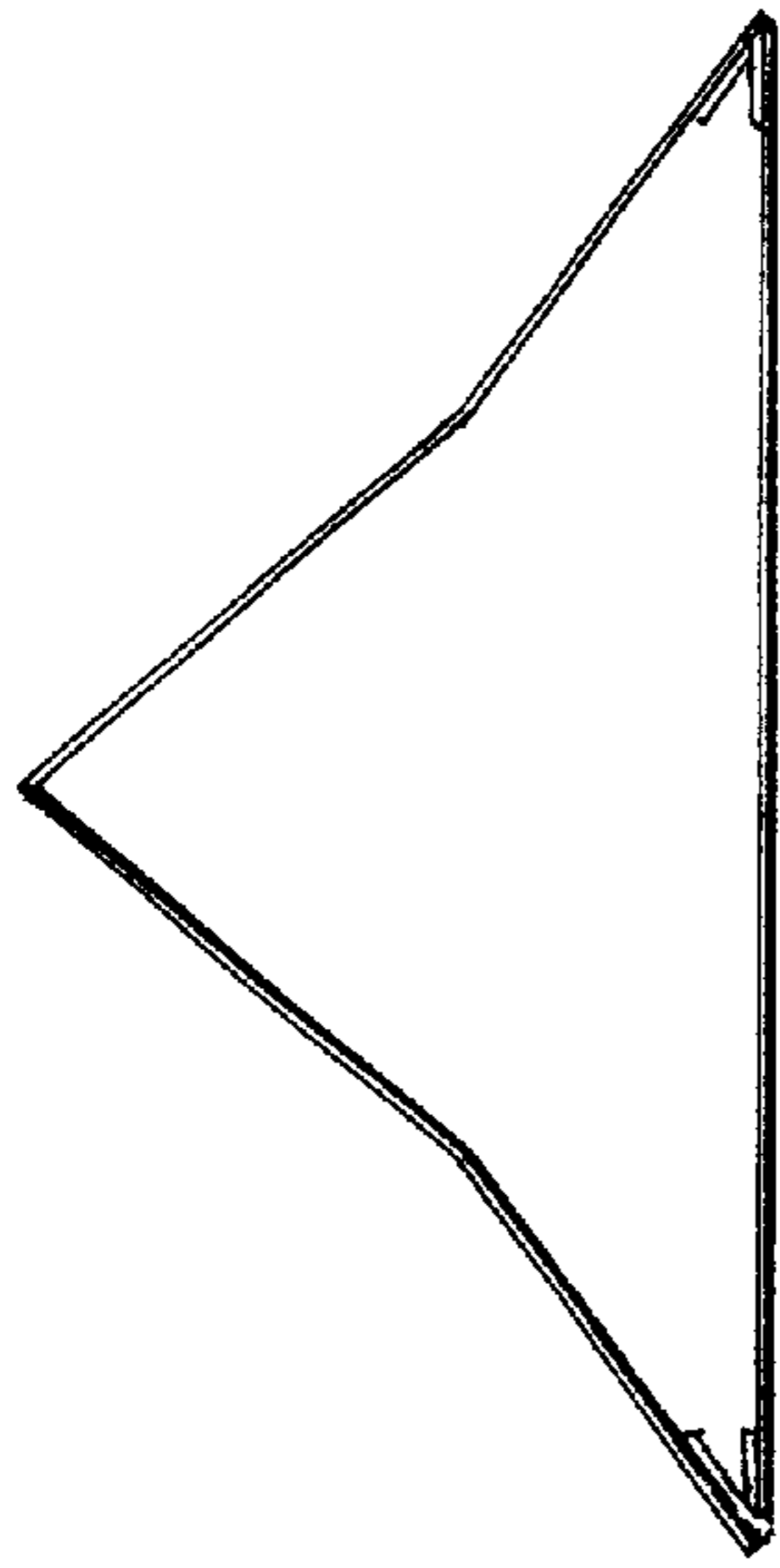

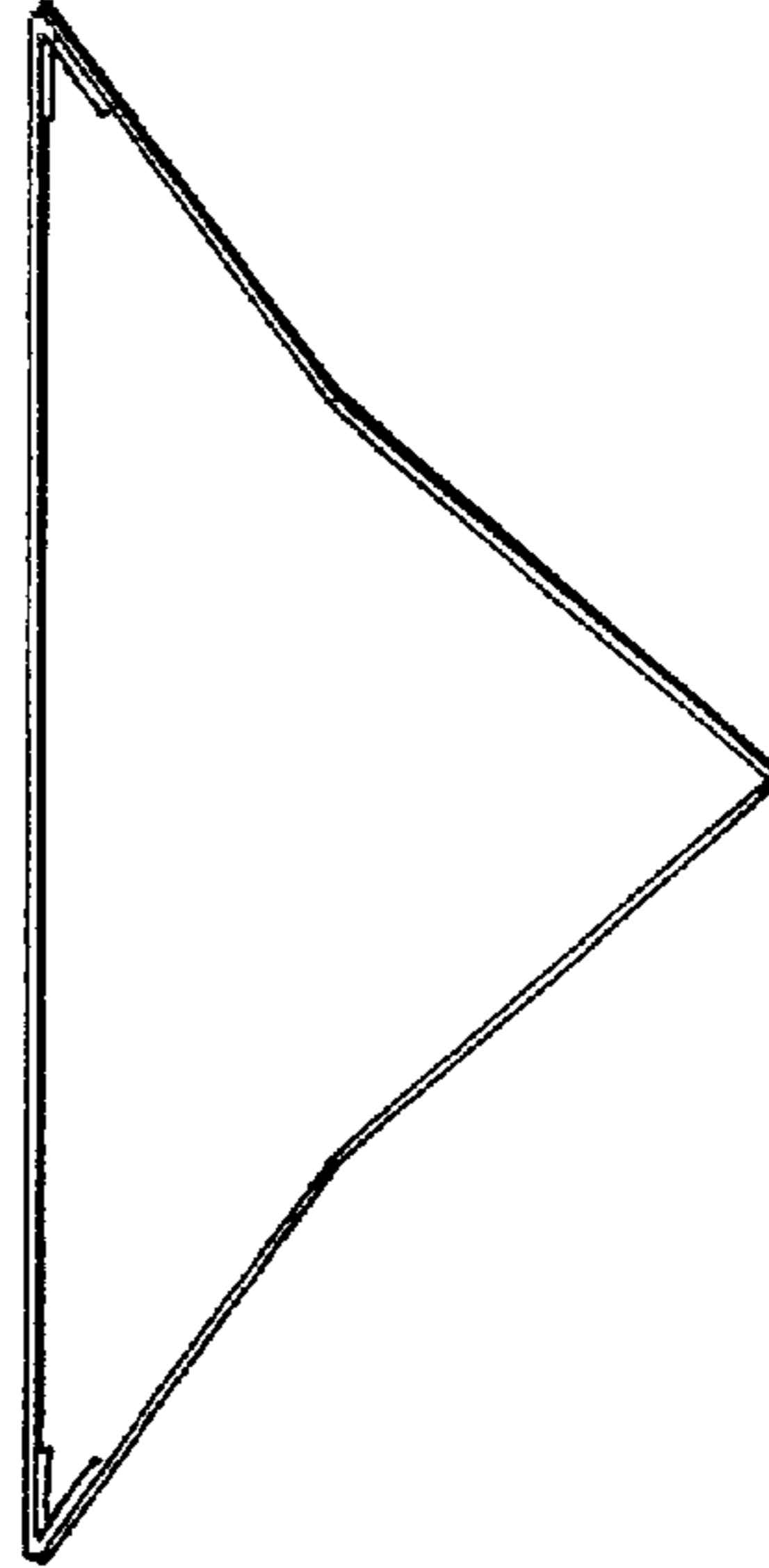

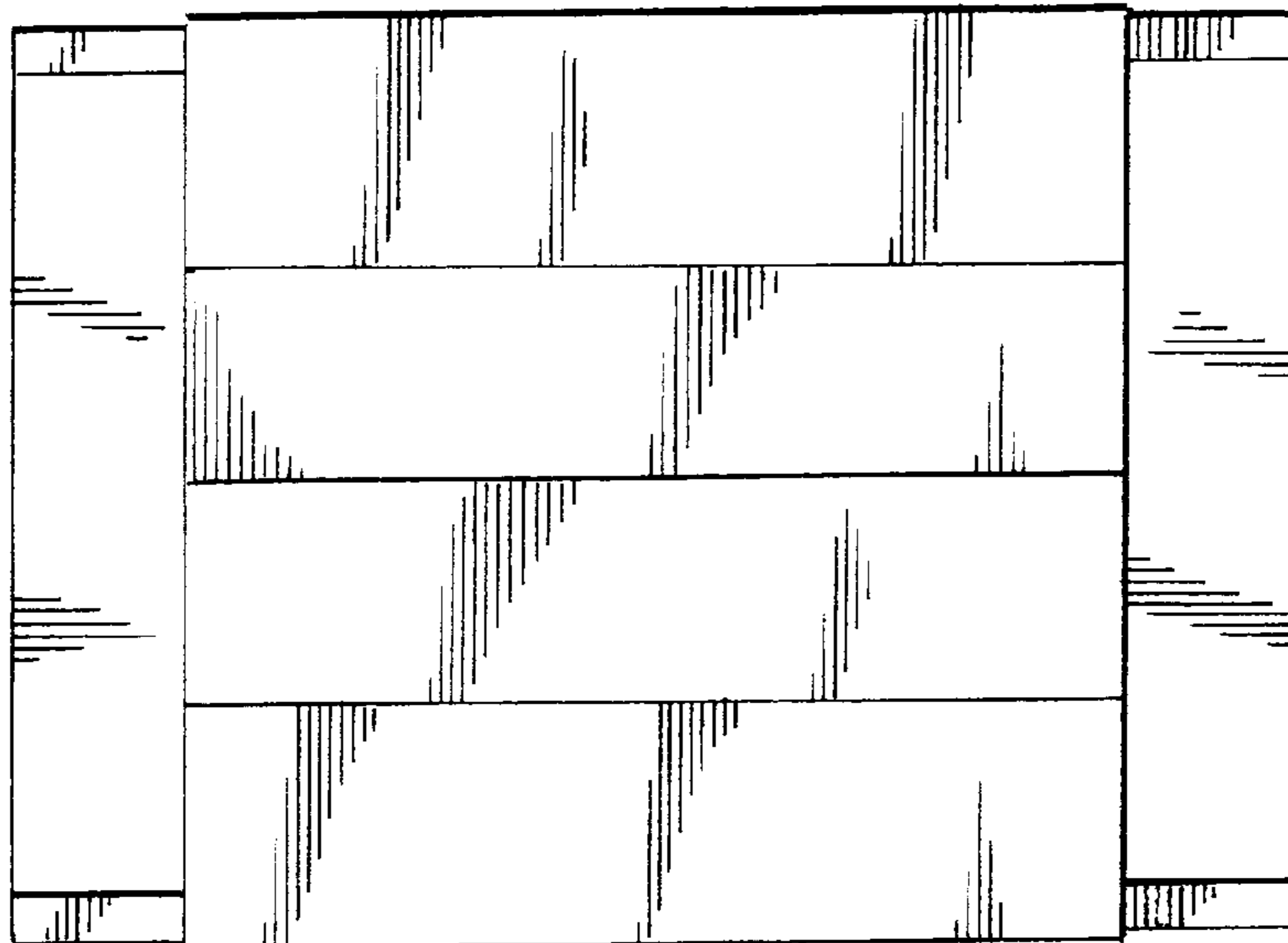
