FIG. 4 is another bottom perspective view thereof;

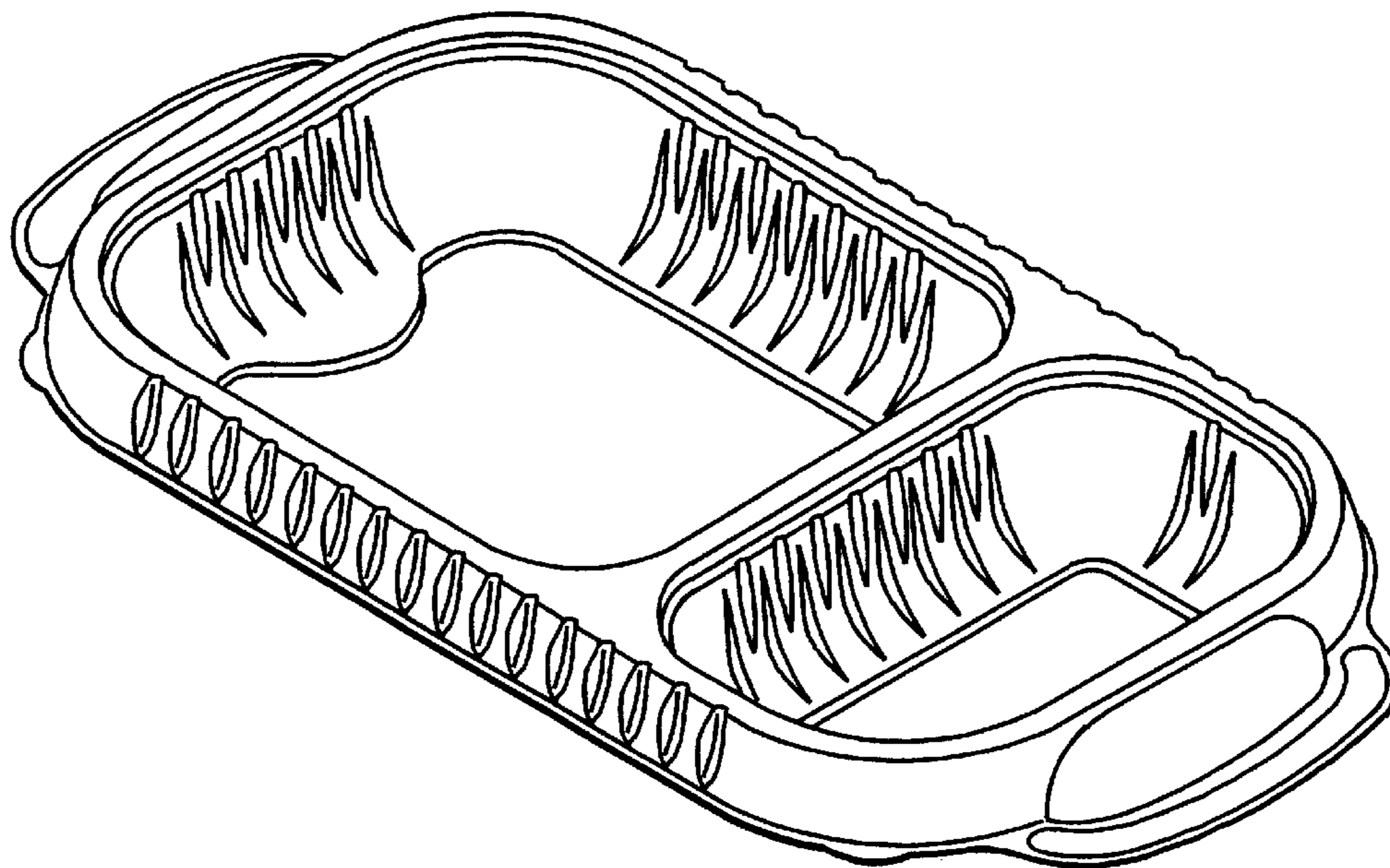
FIG. 5 is a top plan view thereof;

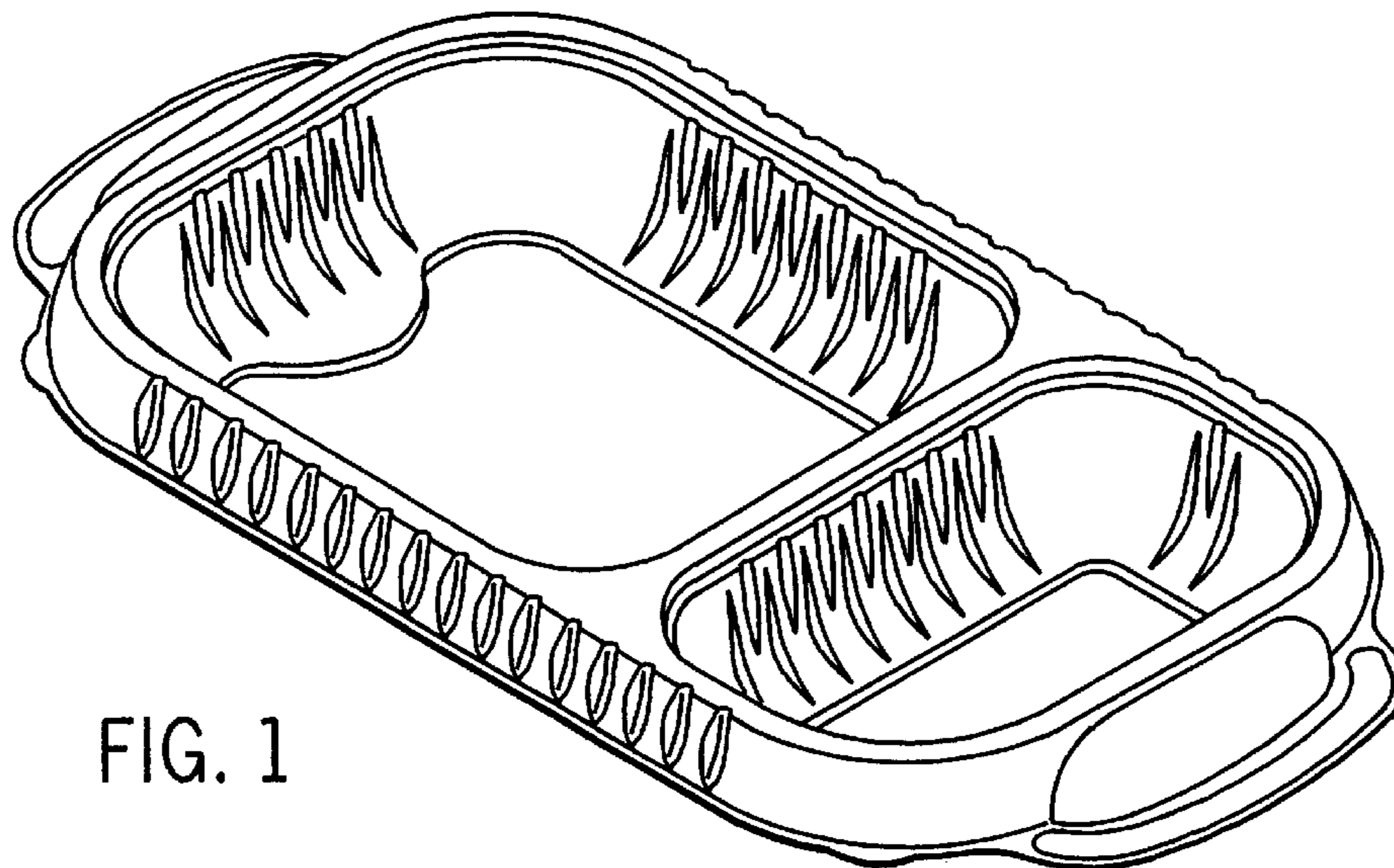

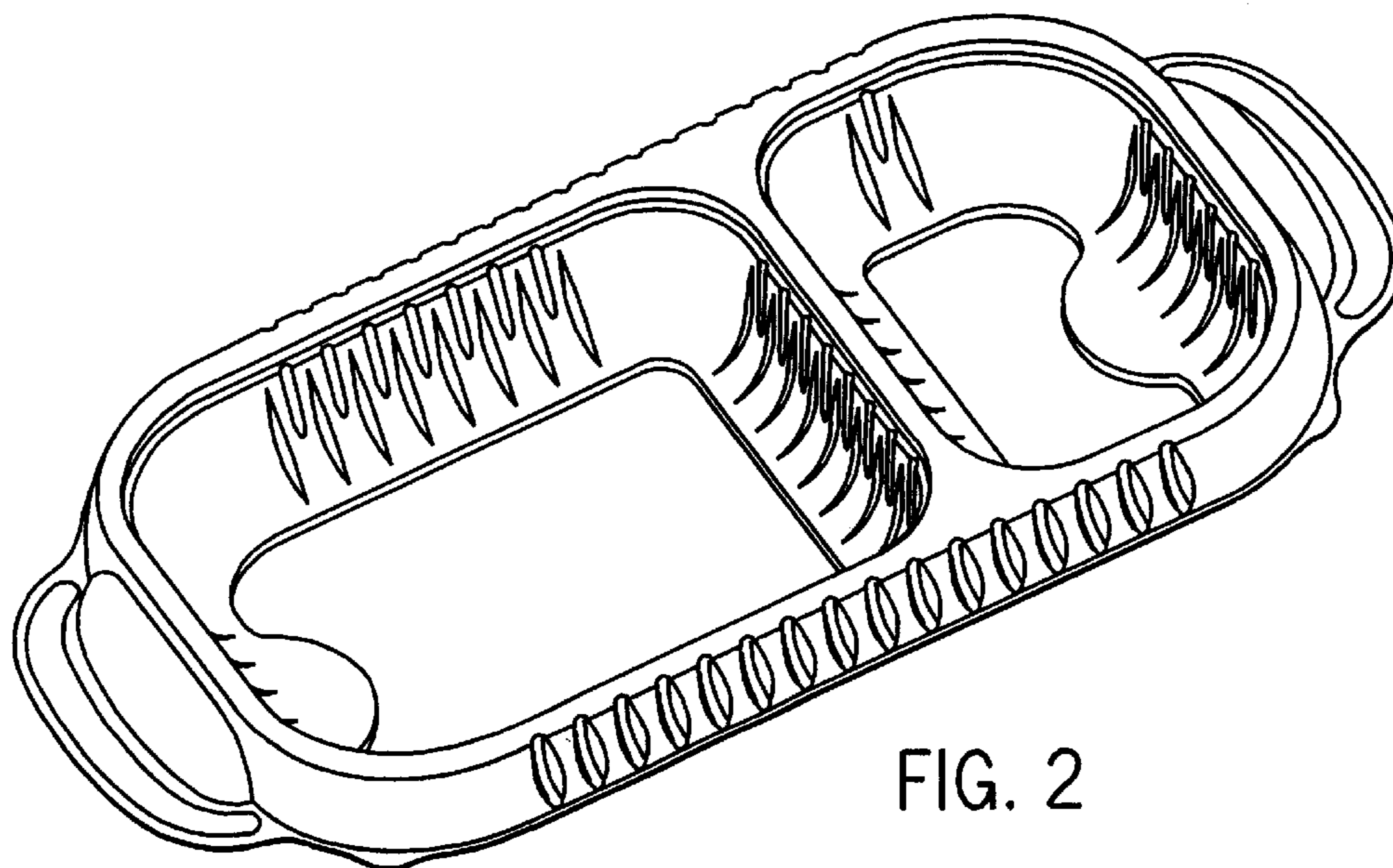

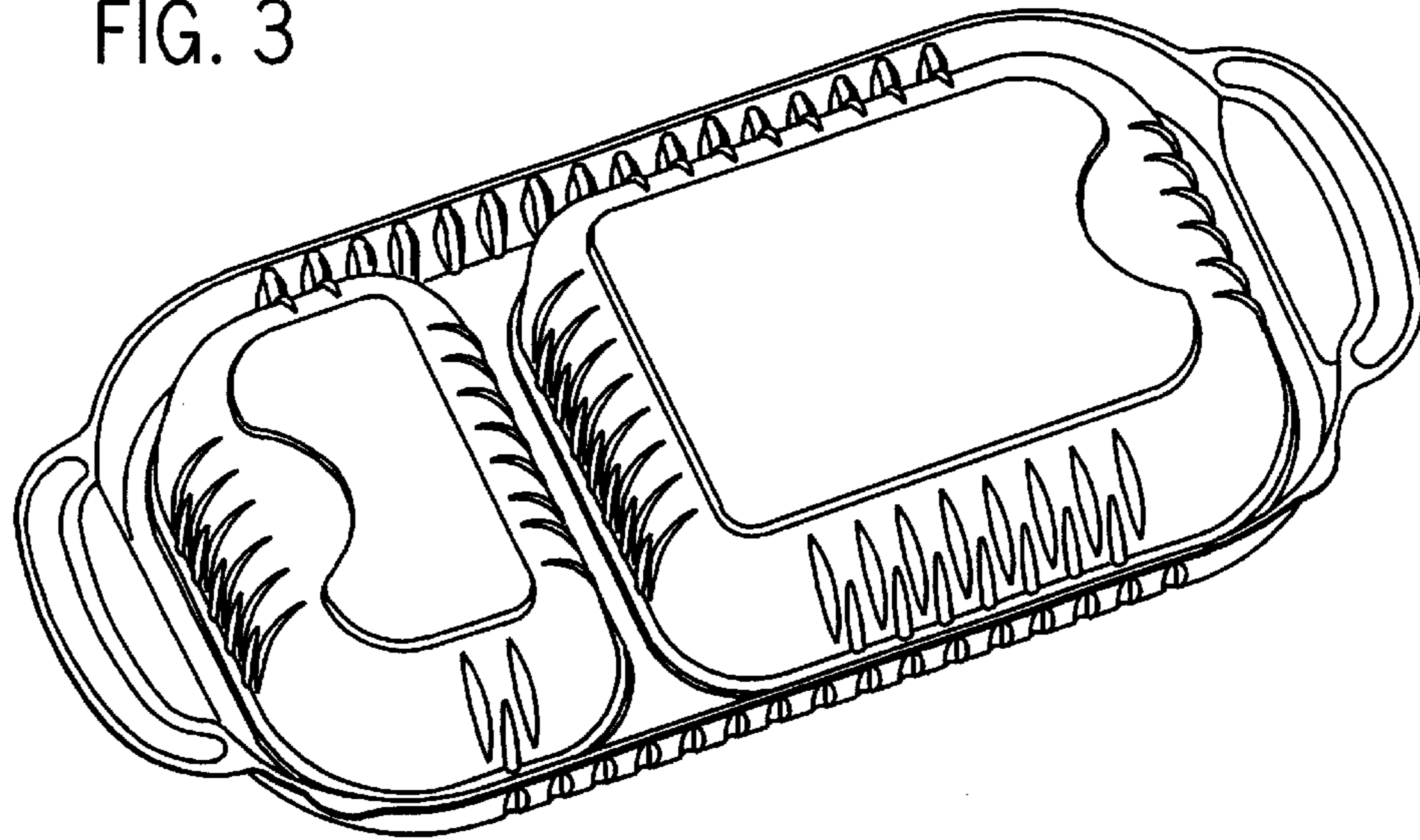
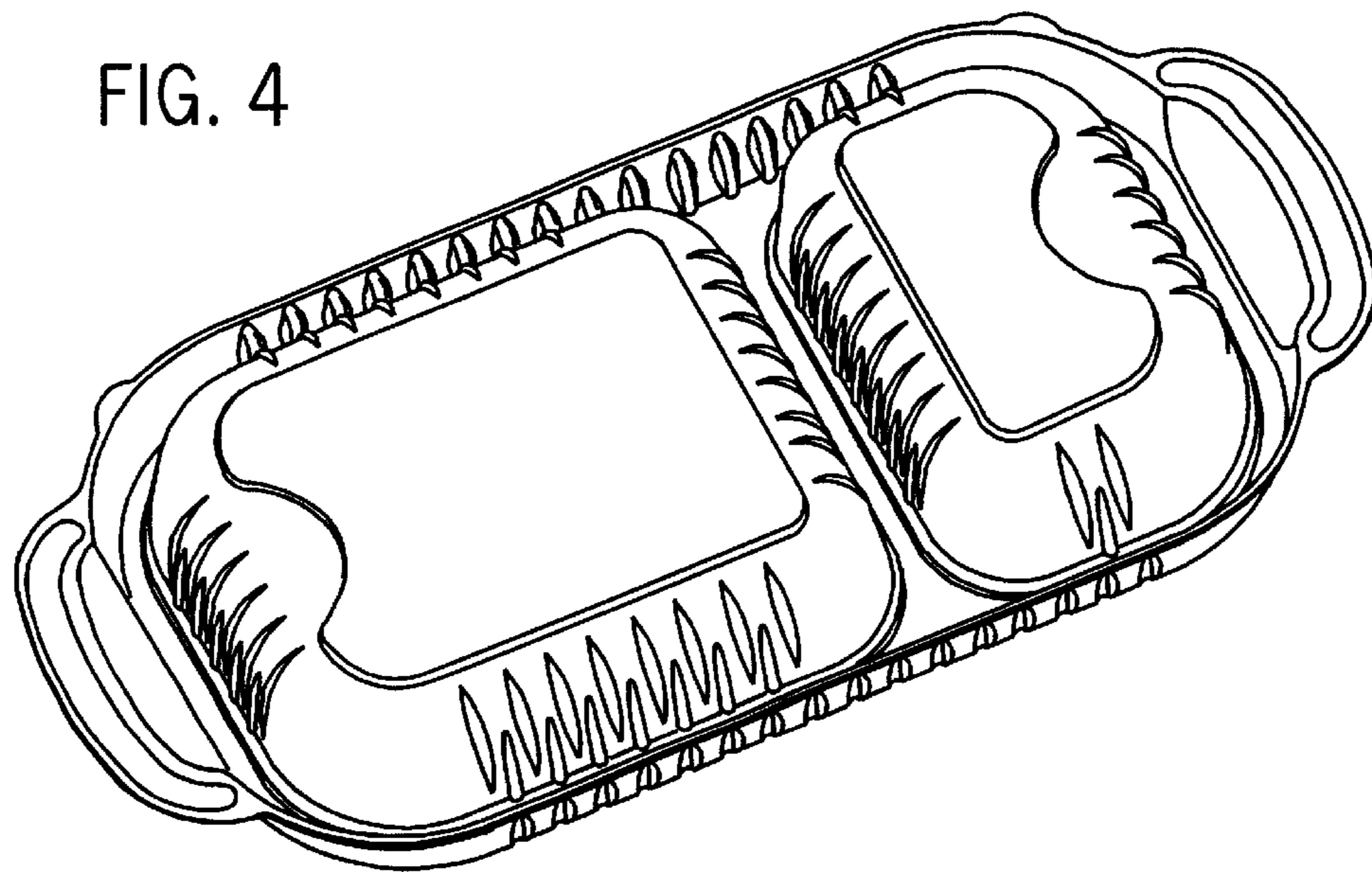

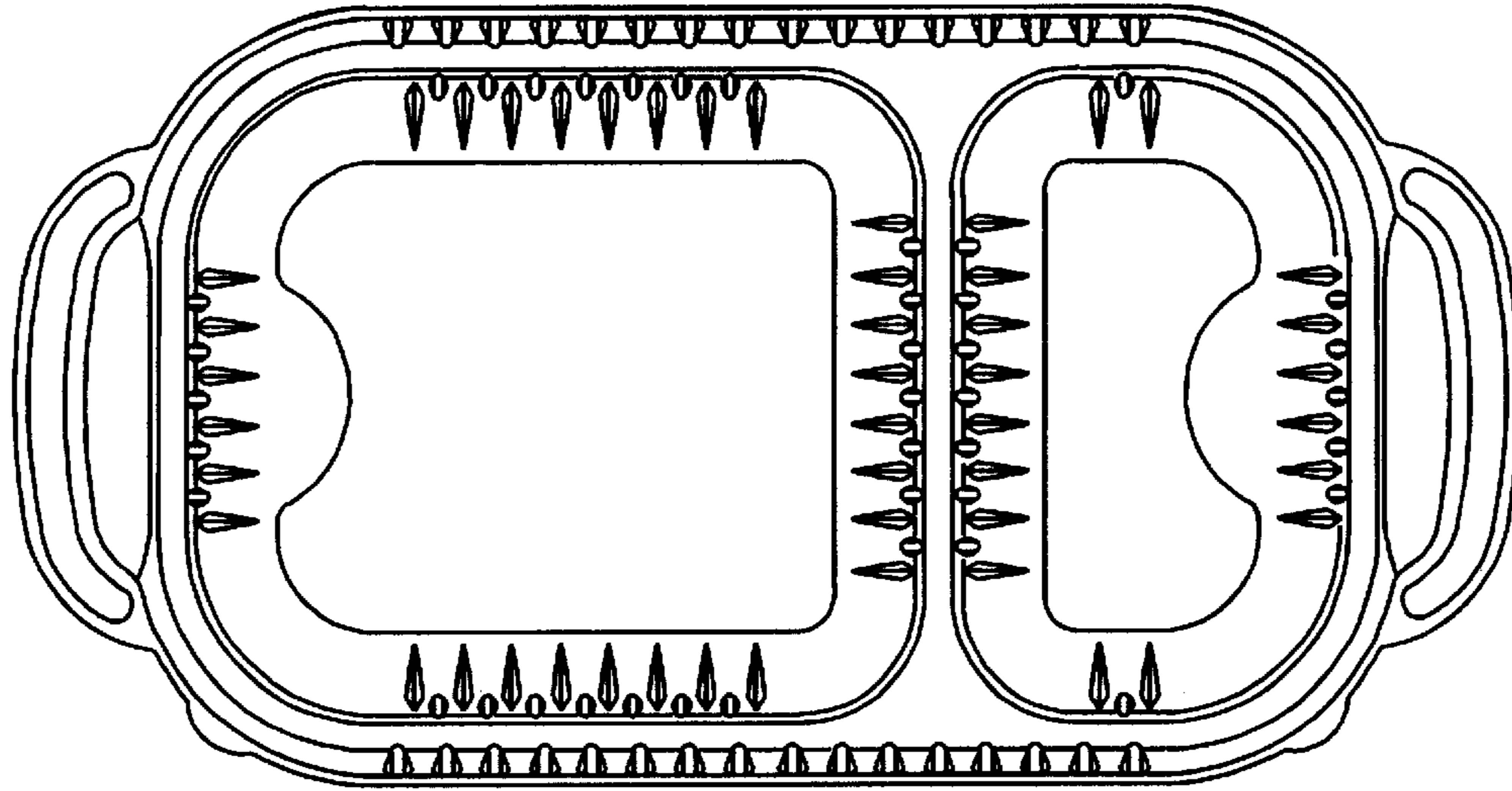

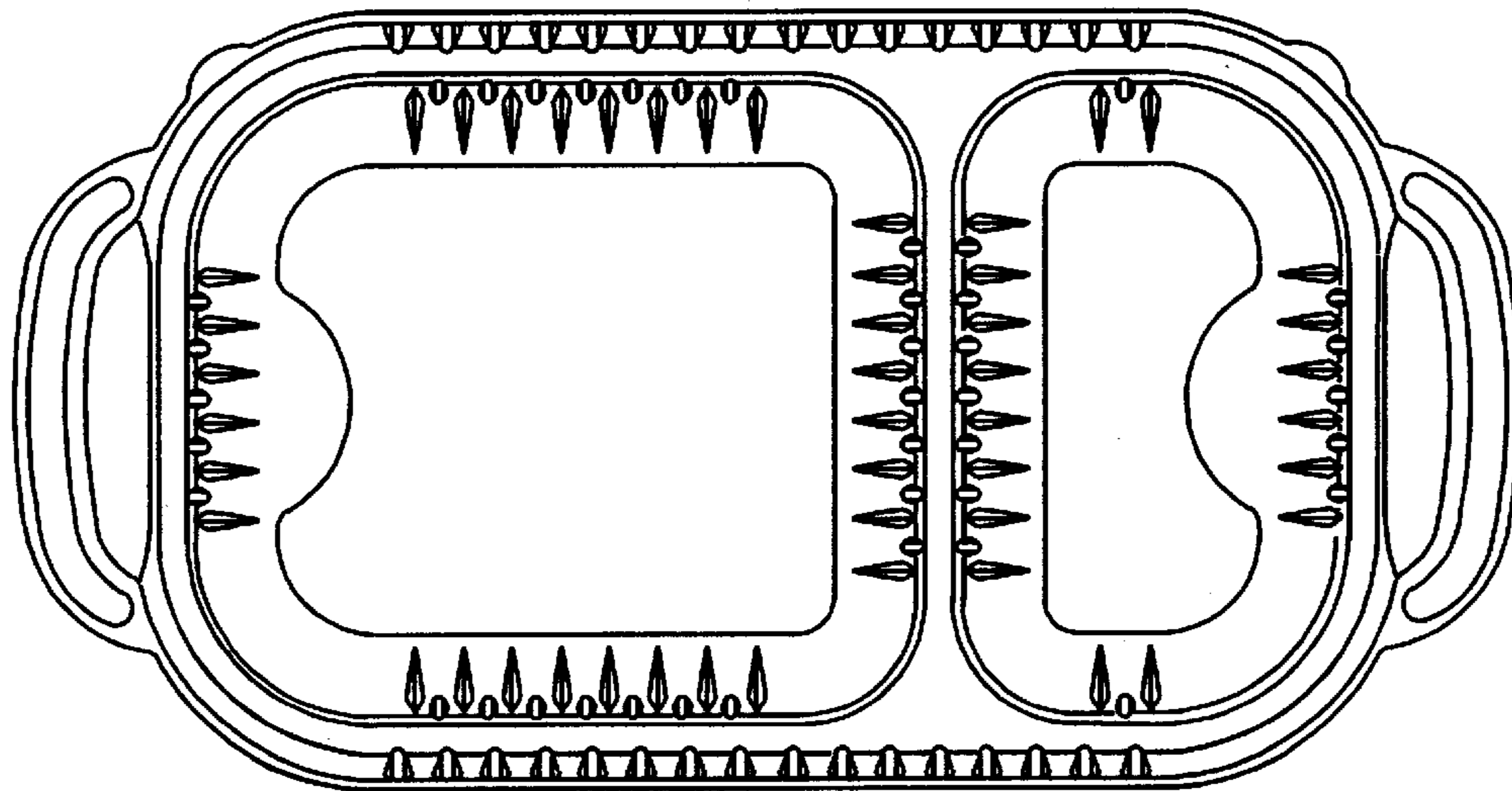

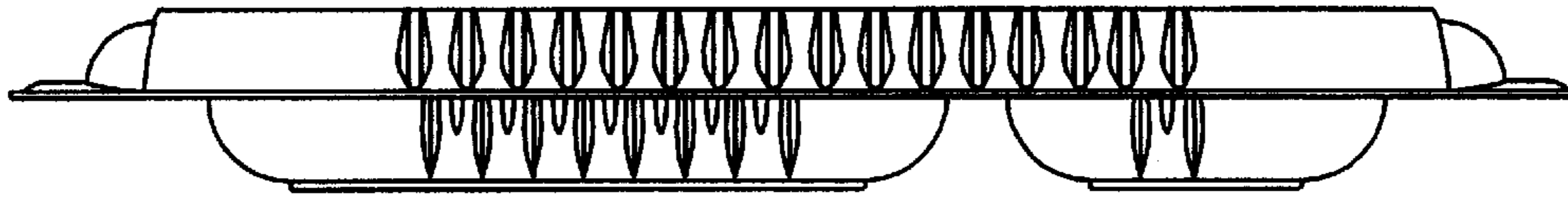

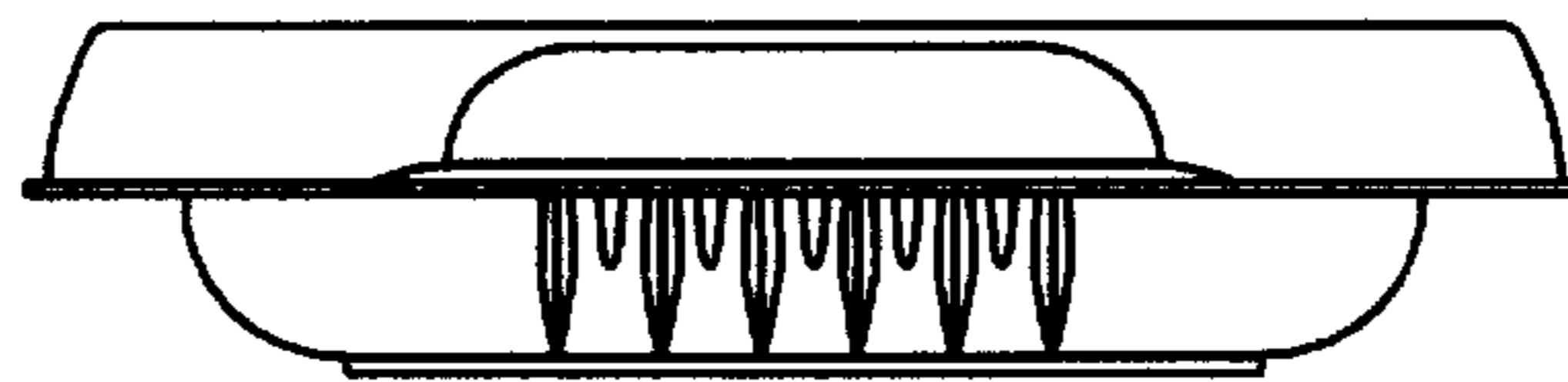
