FIG. 10 is a top view thereof.

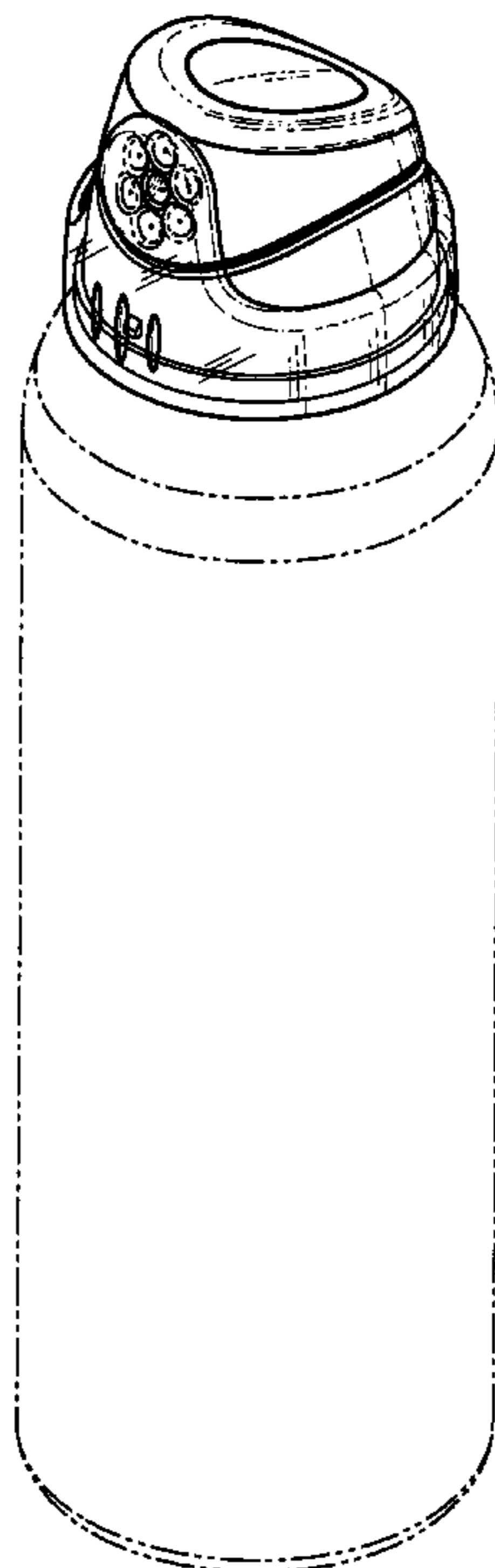

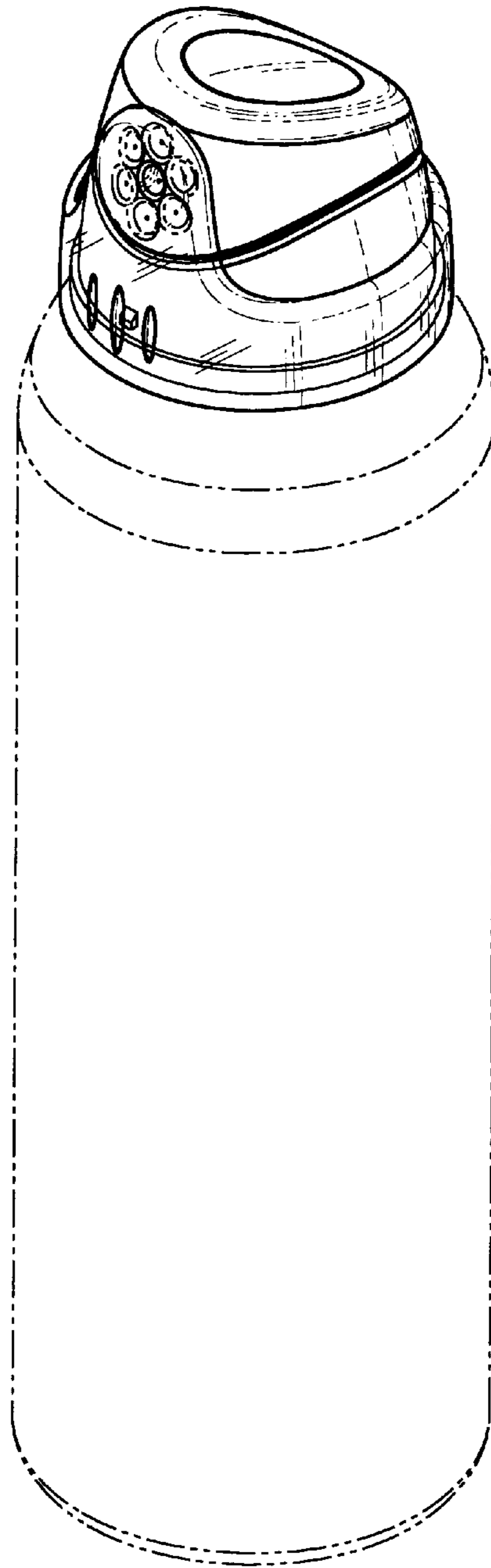

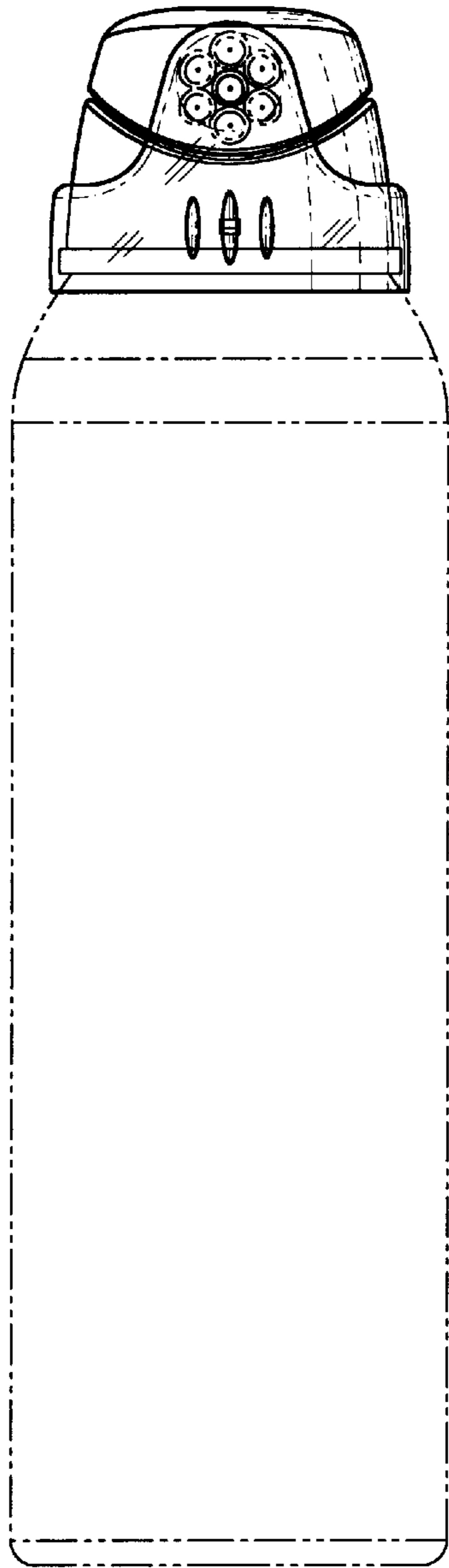

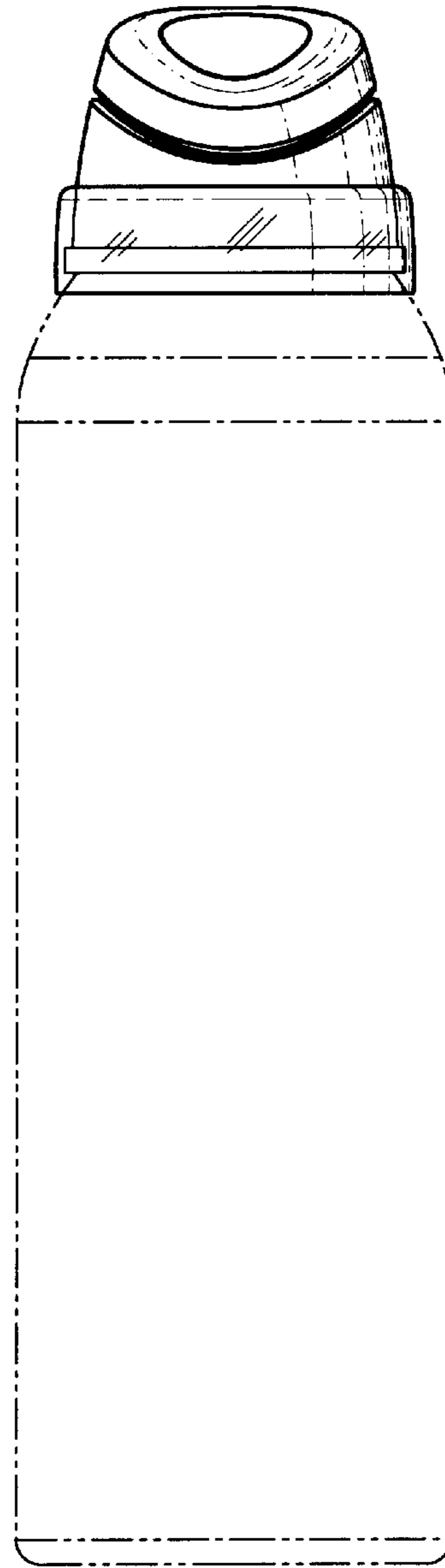

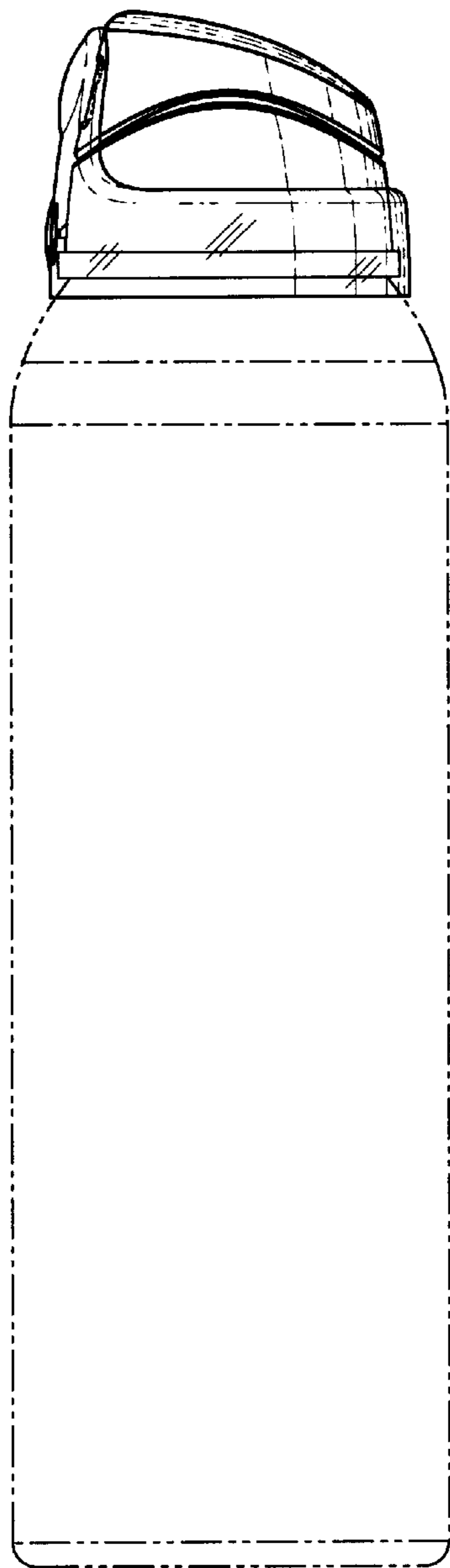

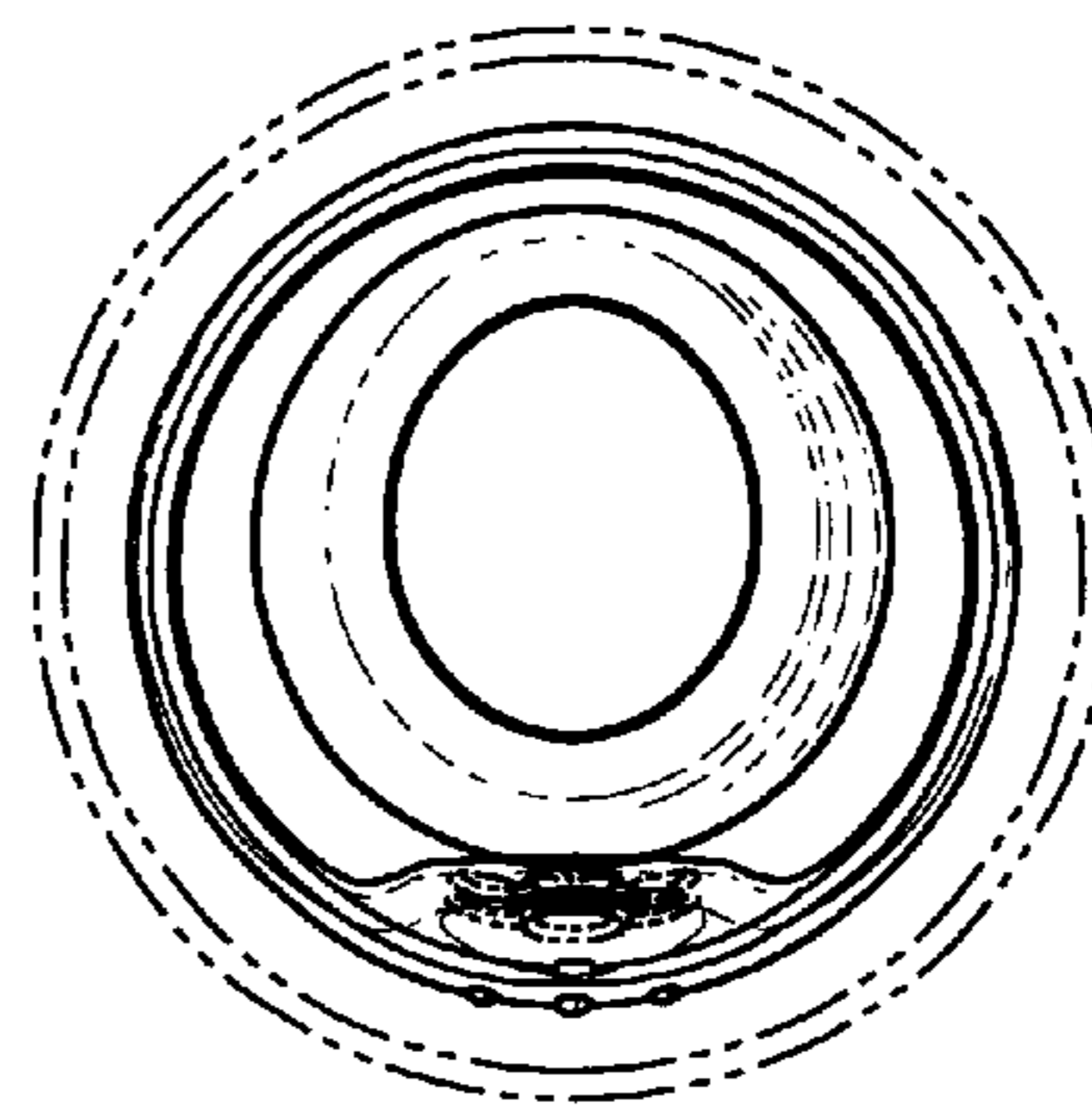

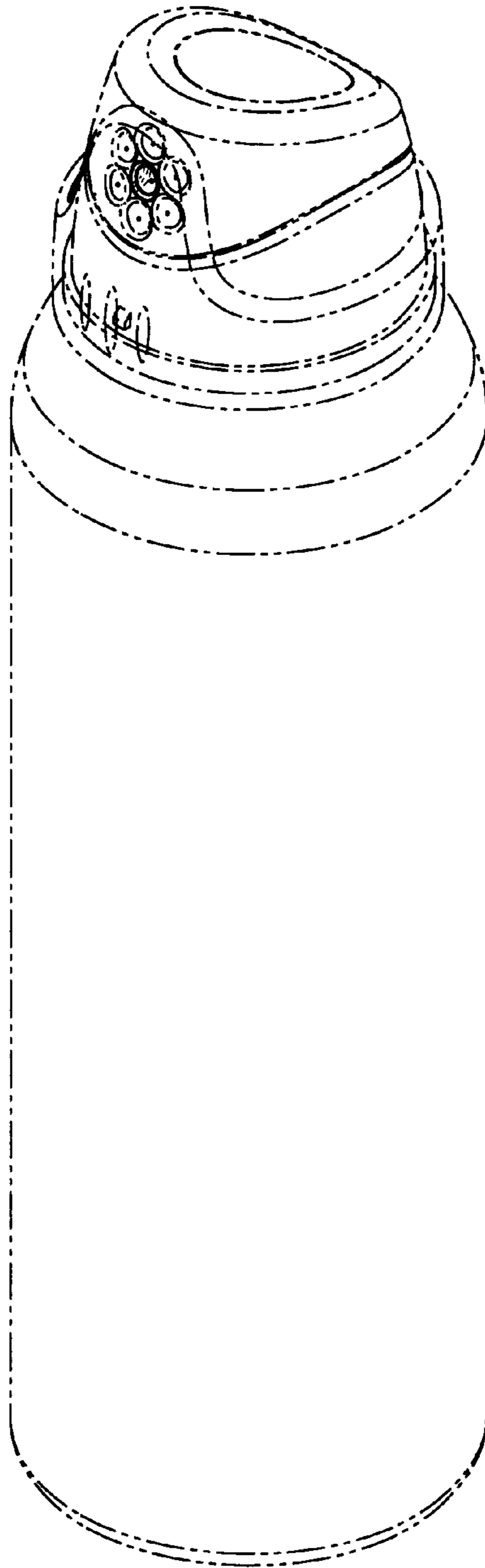

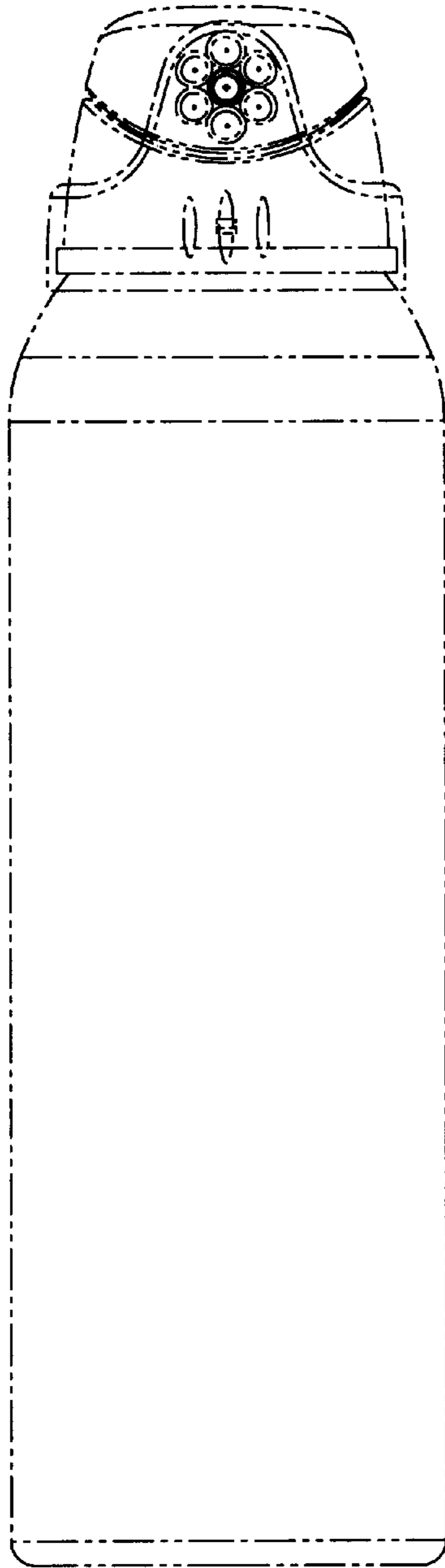

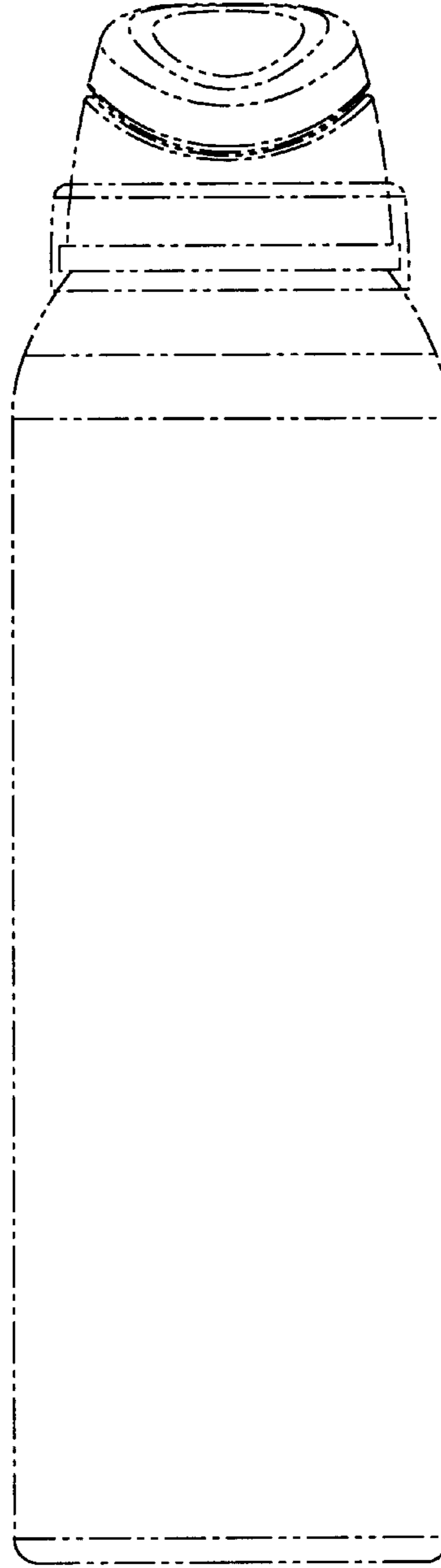

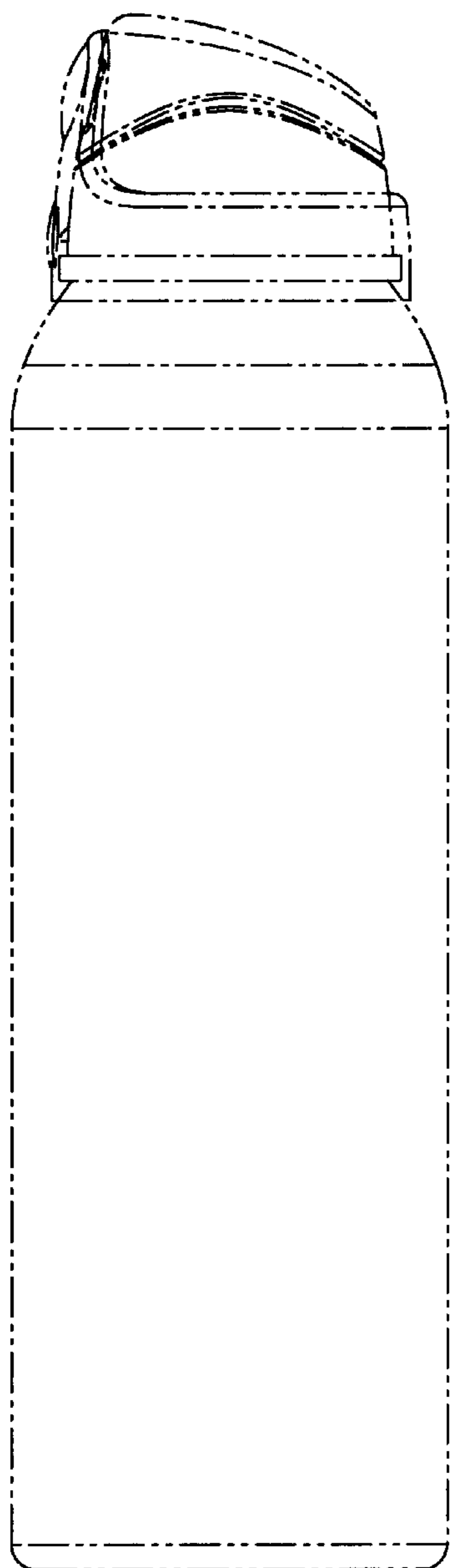

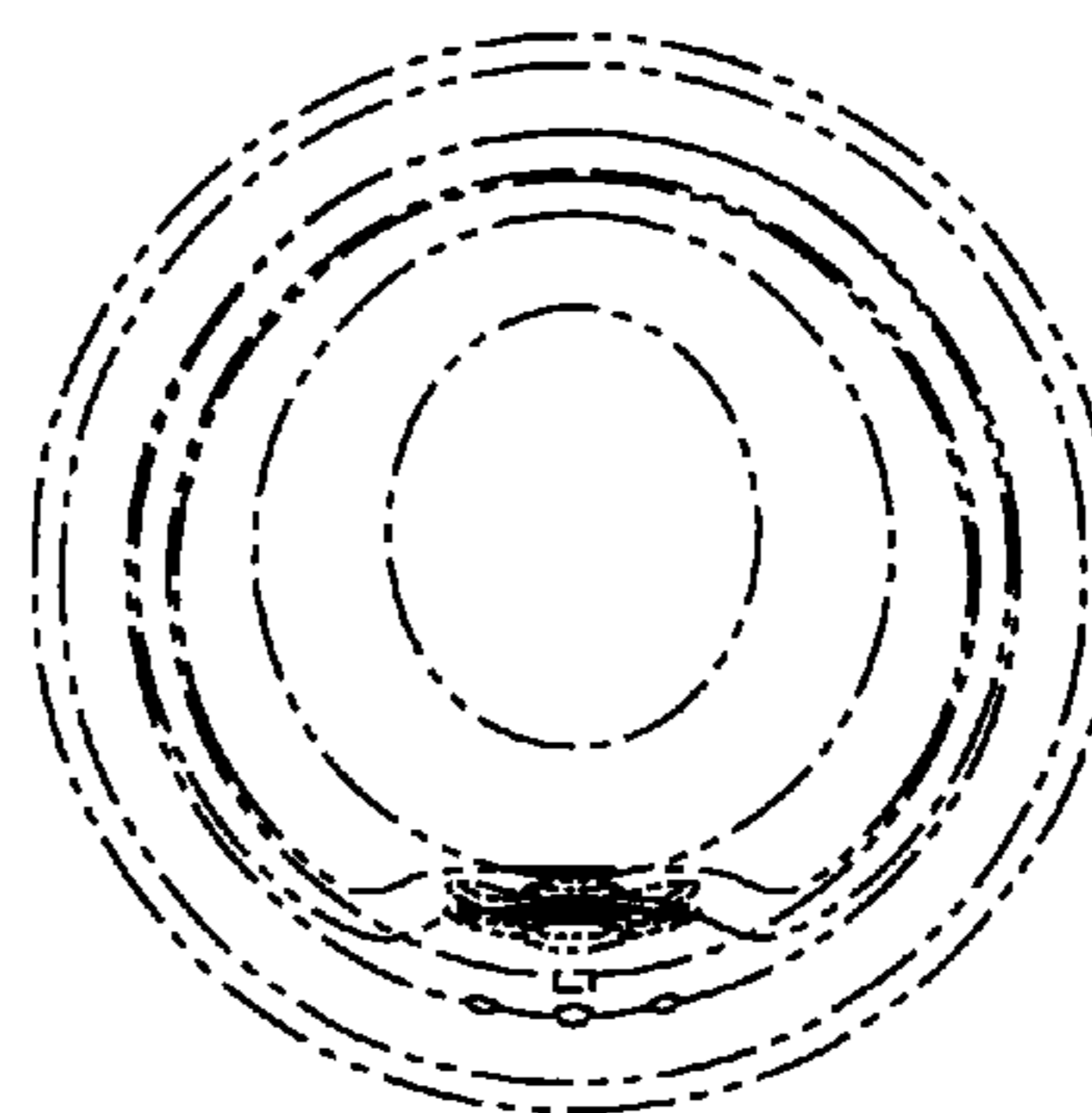
