(57) **CLAIM**

The ornamental design for a weight display, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a weight display according to our novel design;

FIG. 2 is a front view of the weight display of FIG. 1;

FIG. 3 is a rear view of the weight display of FIG. 1;

FIG. 4 is a right side view of the weight display of FIG. 1;

FIG. 5 is a left side view of the weight display of FIG. 1;

FIG. 6 is a plan view of the weight display of FIG. 1;

FIG. 7 is a bottom view of the weight display of FIG. 1;

FIG. 8 is a plan view of the weight display in FIG. 6 with the display being switched on;

FIG. 9 is an enlarged view of the weight display in FIG. 6 with English legend being put on the top surface of the operating keys or the body; and,

FIG. 10 is an enlarged view of the weight display in FIG. 6 with English legend being put on the top surface of the operating keys or the body and with the display being switched on.

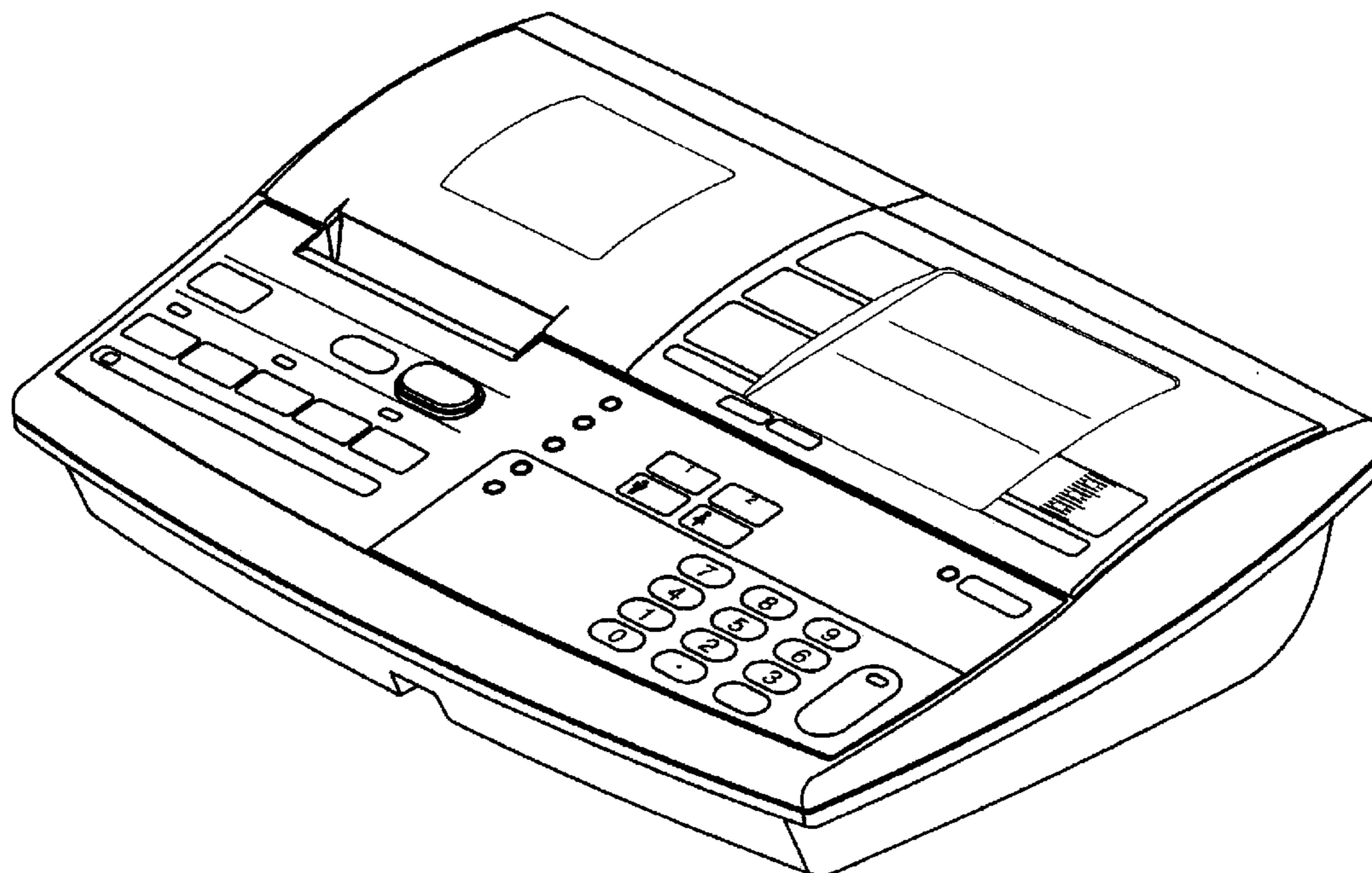

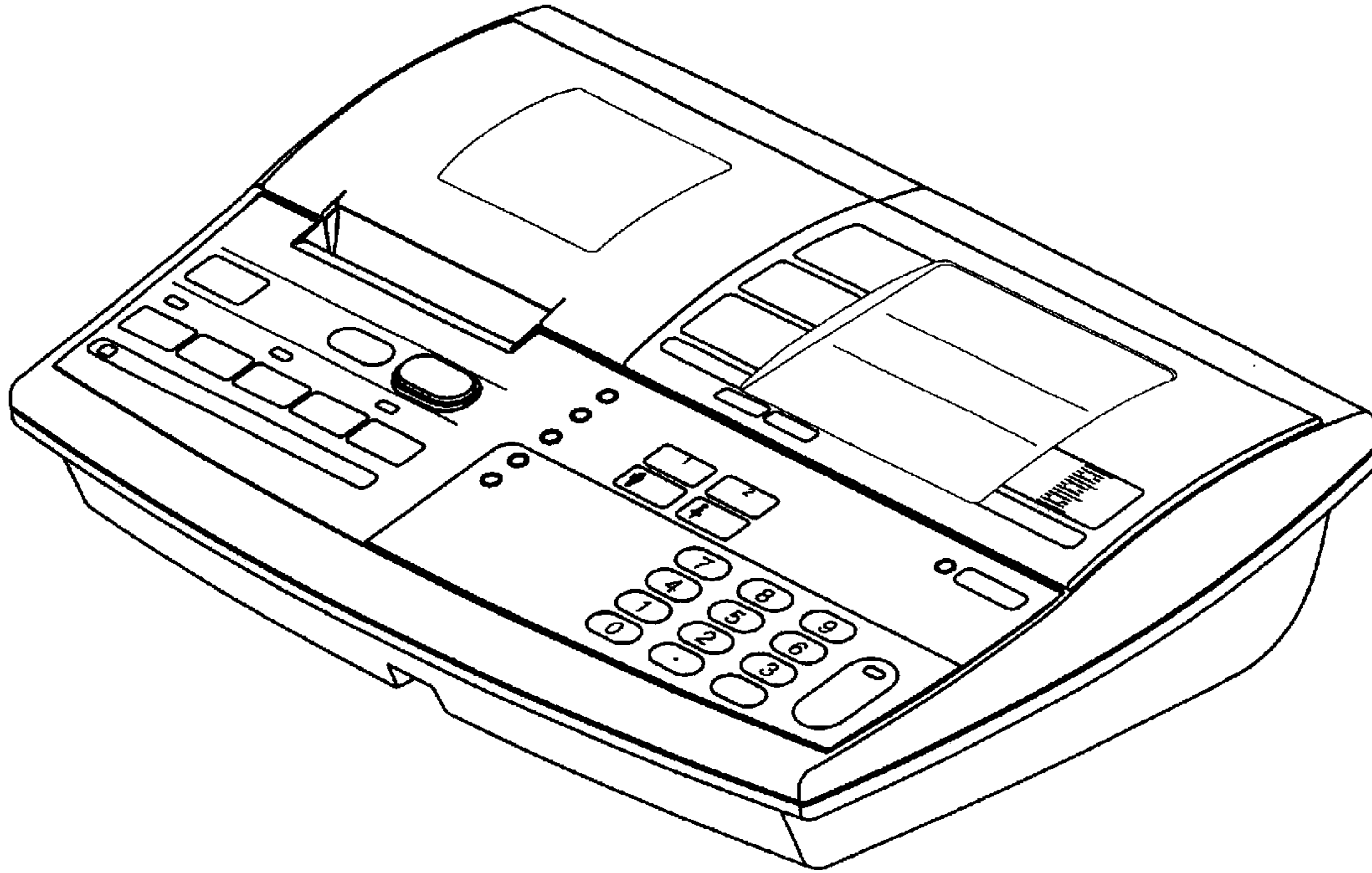

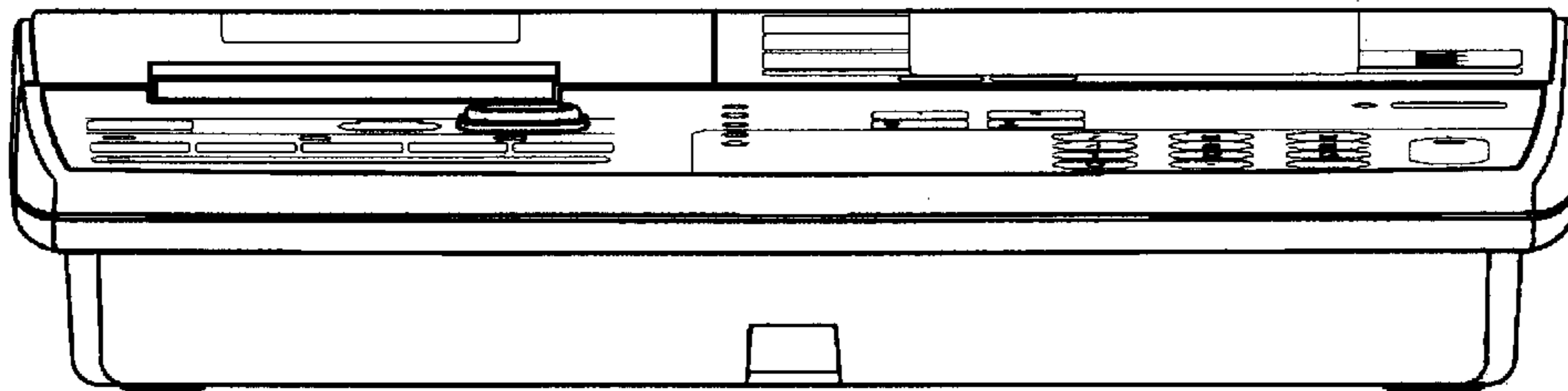

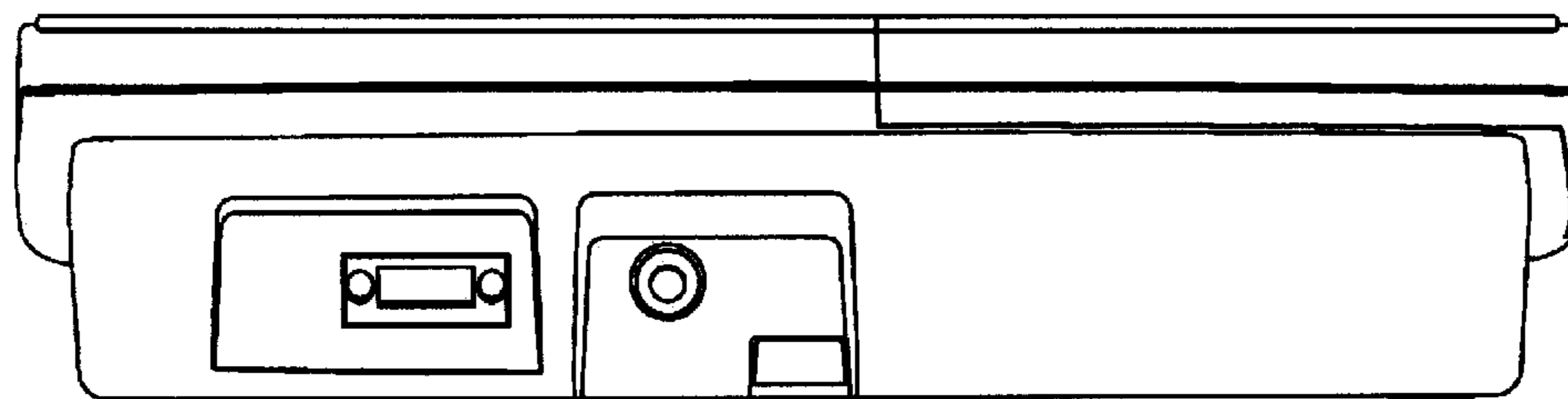

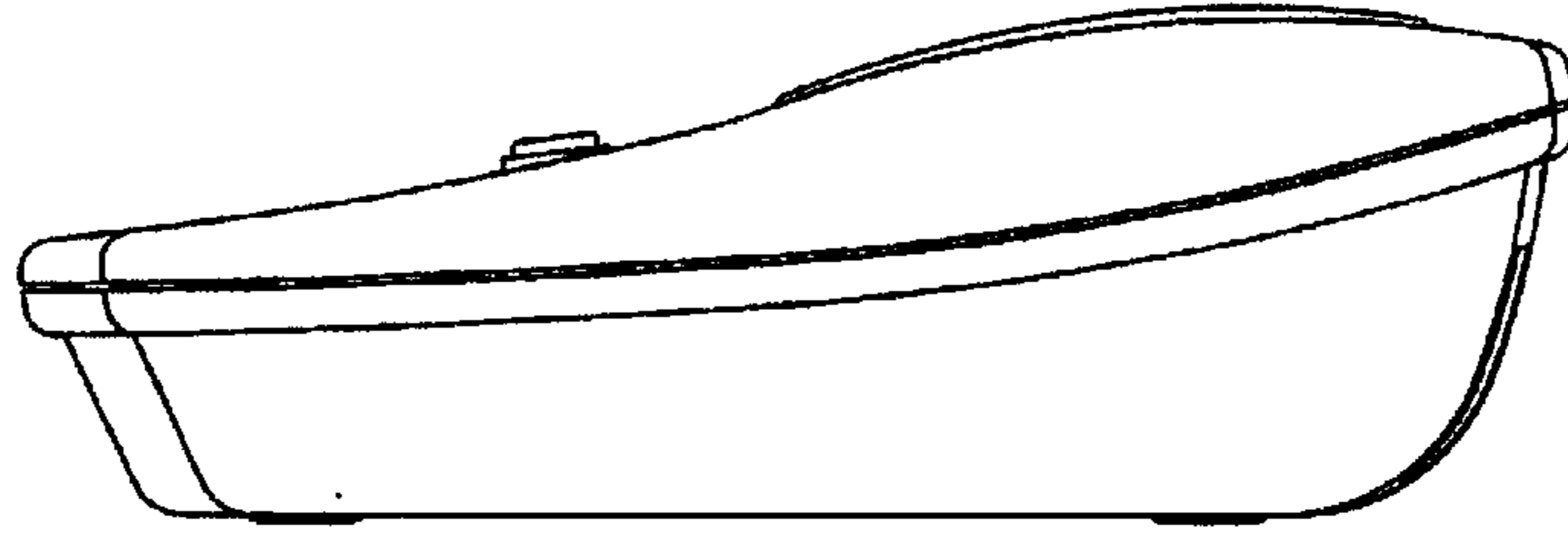

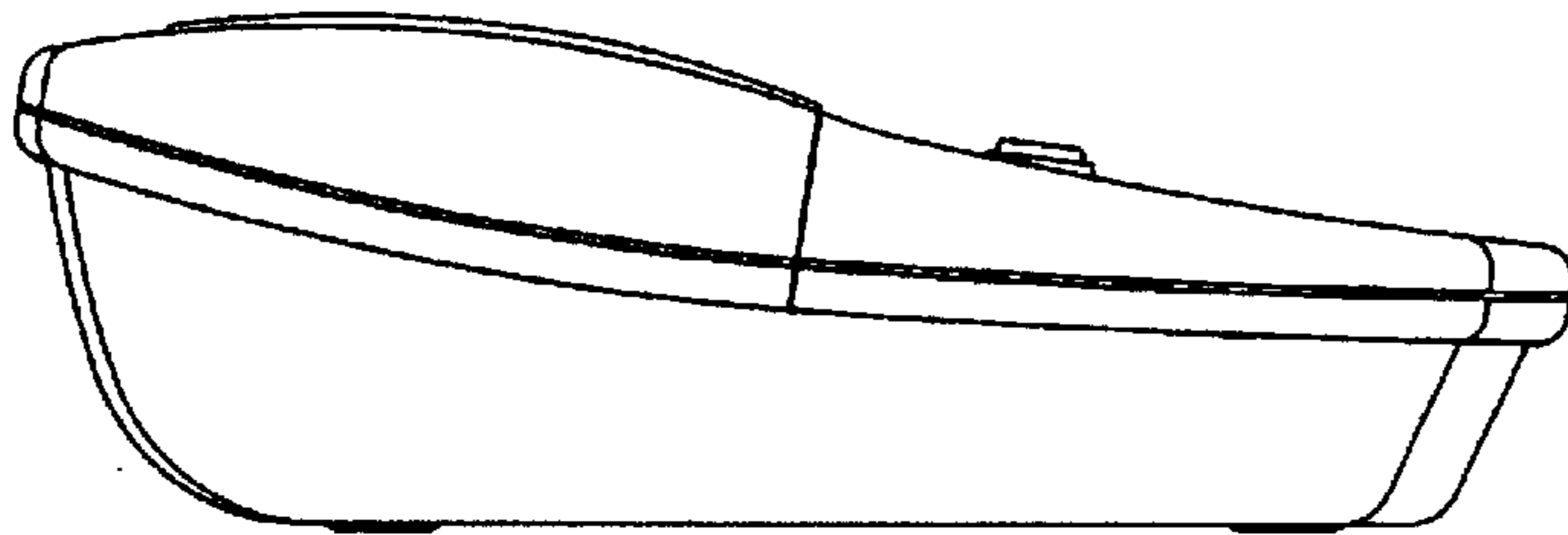

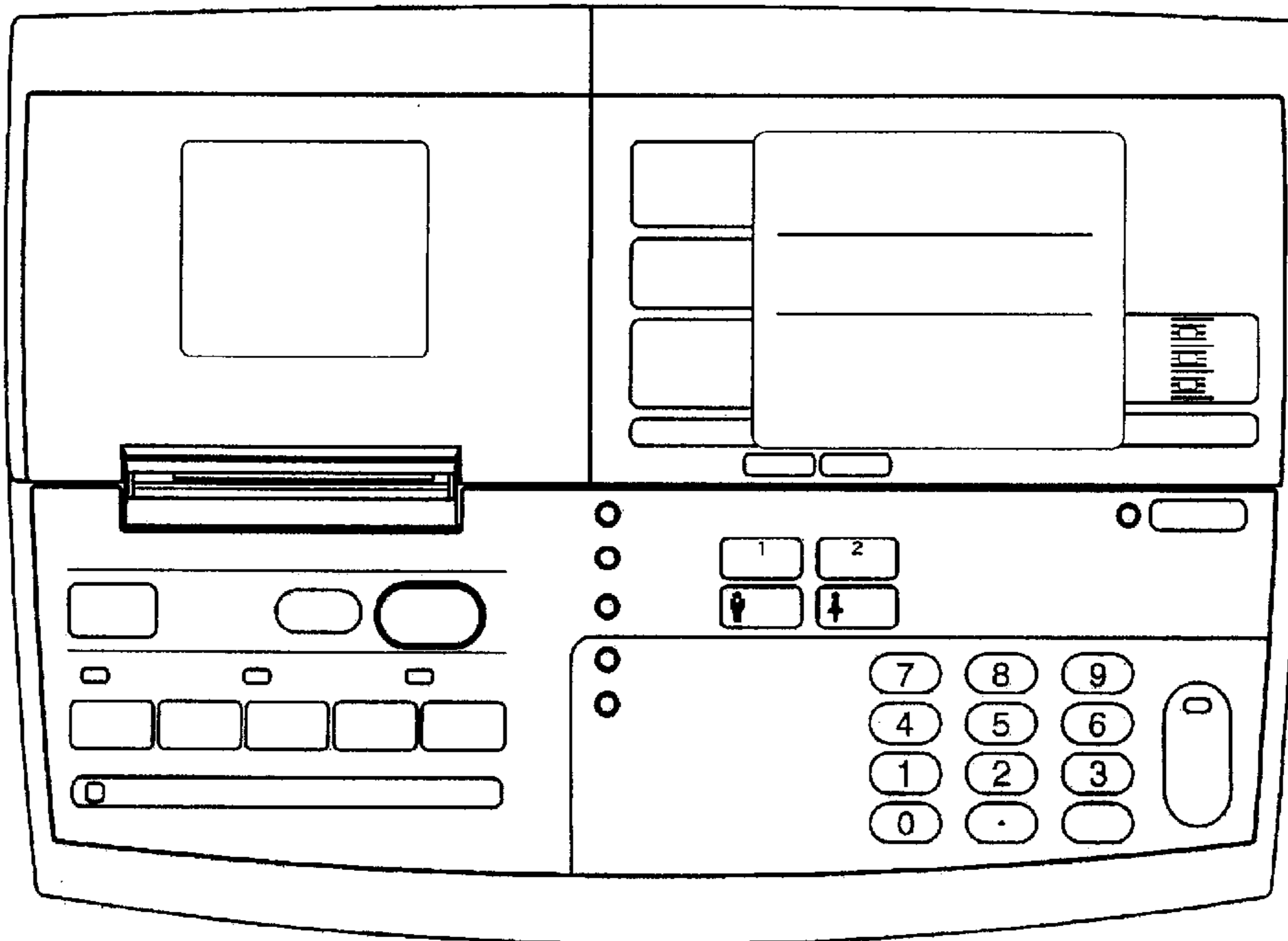

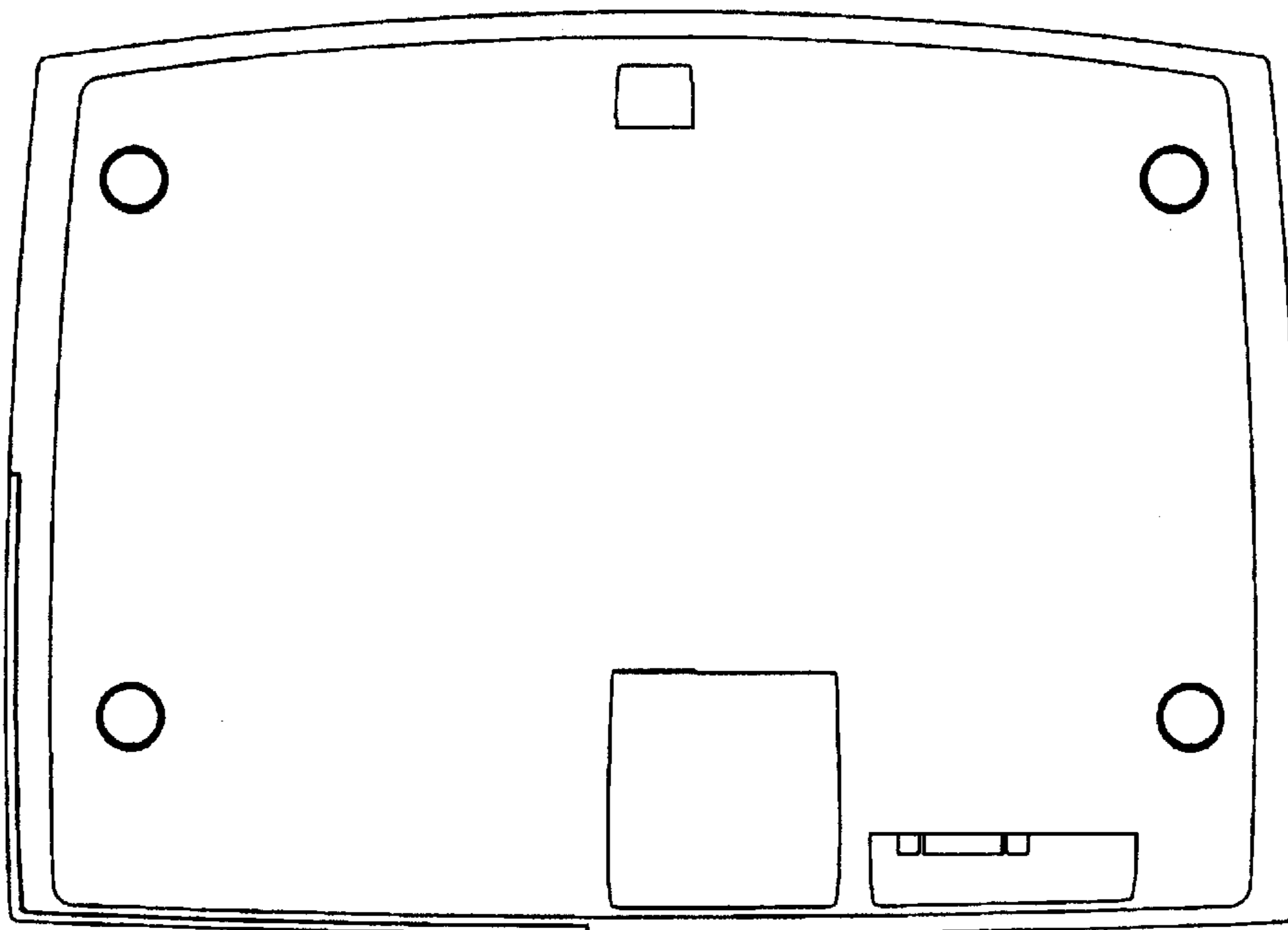

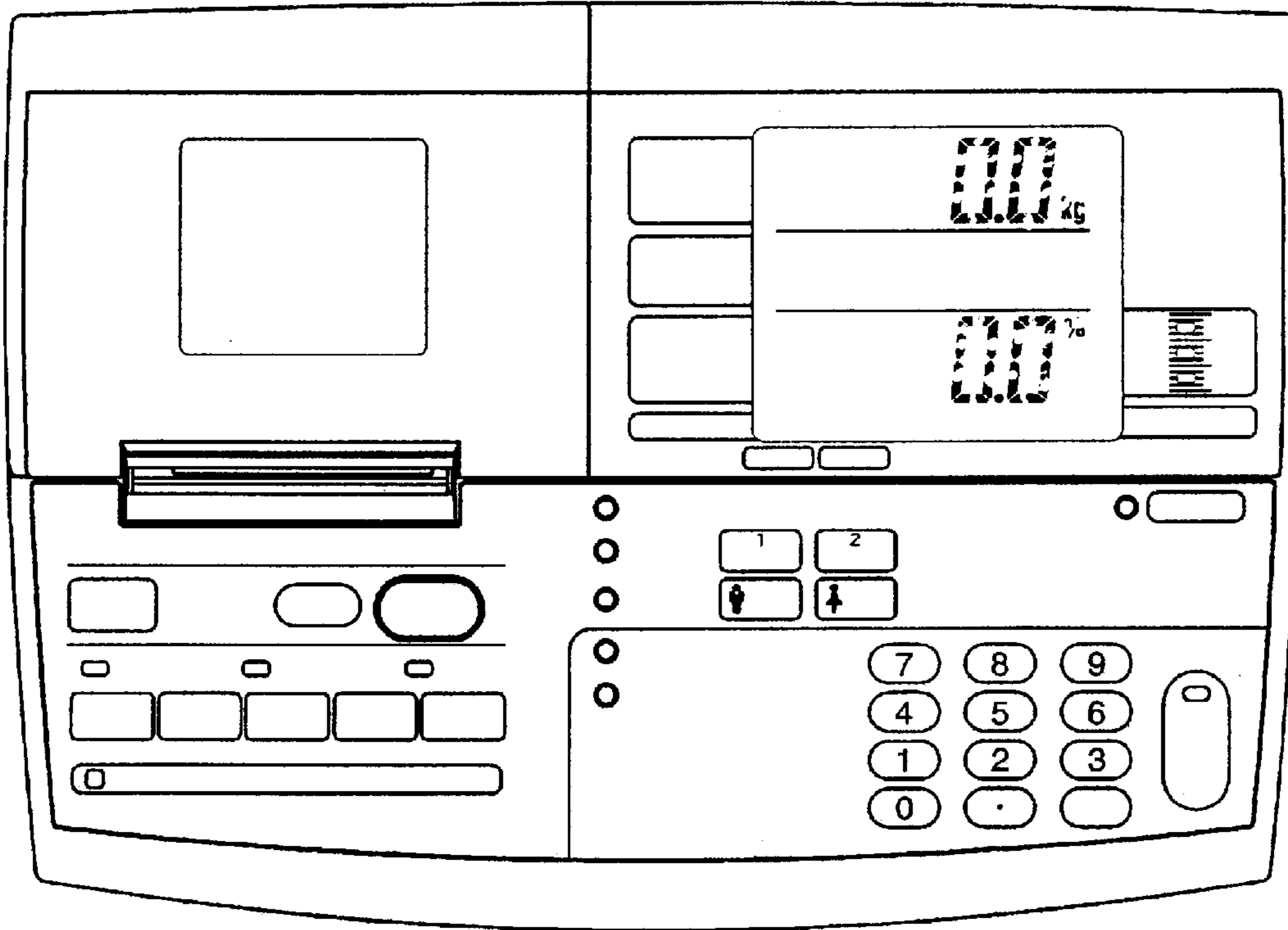

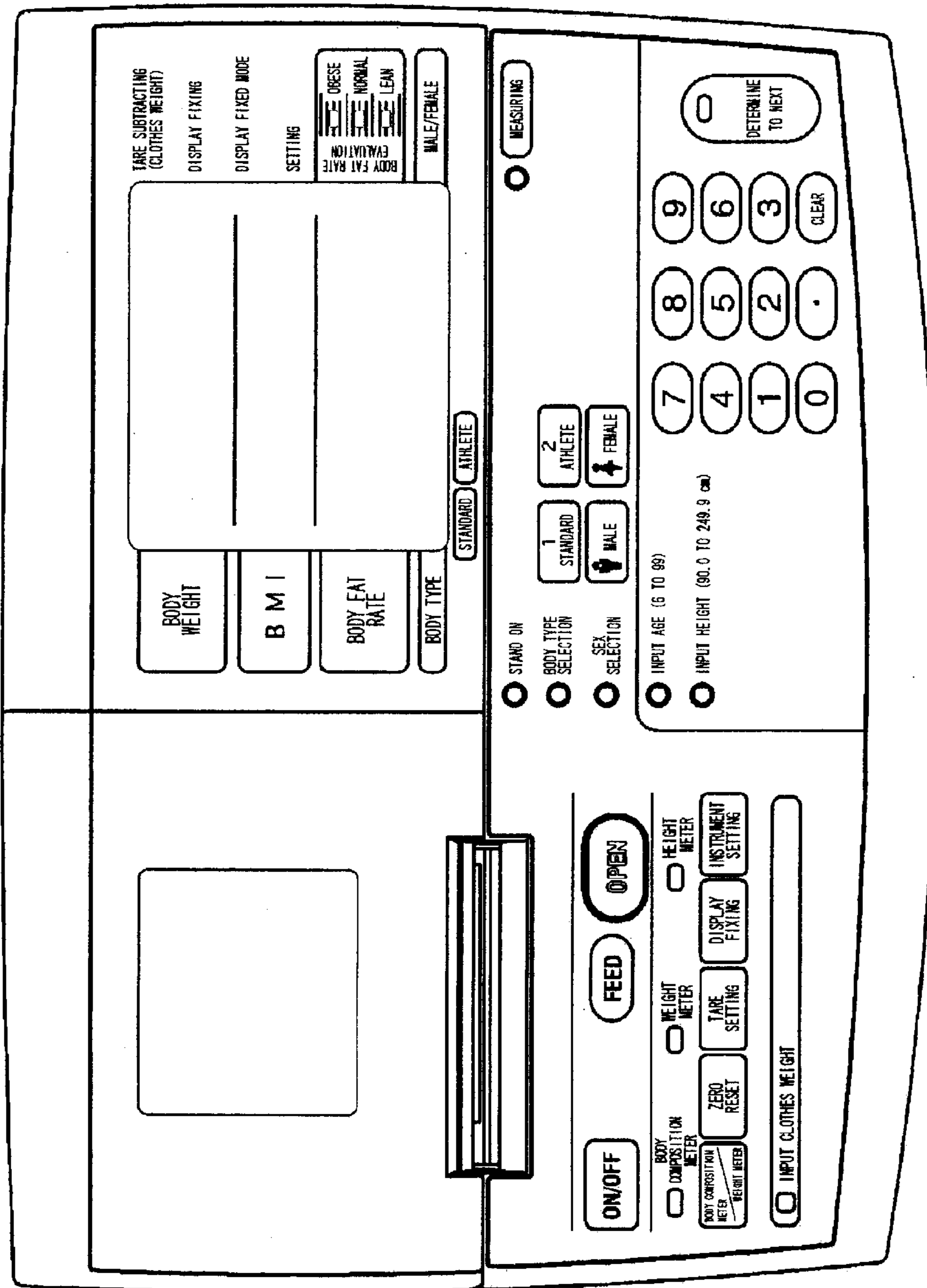
