FIG. 3 is a right side elevational view thereof;

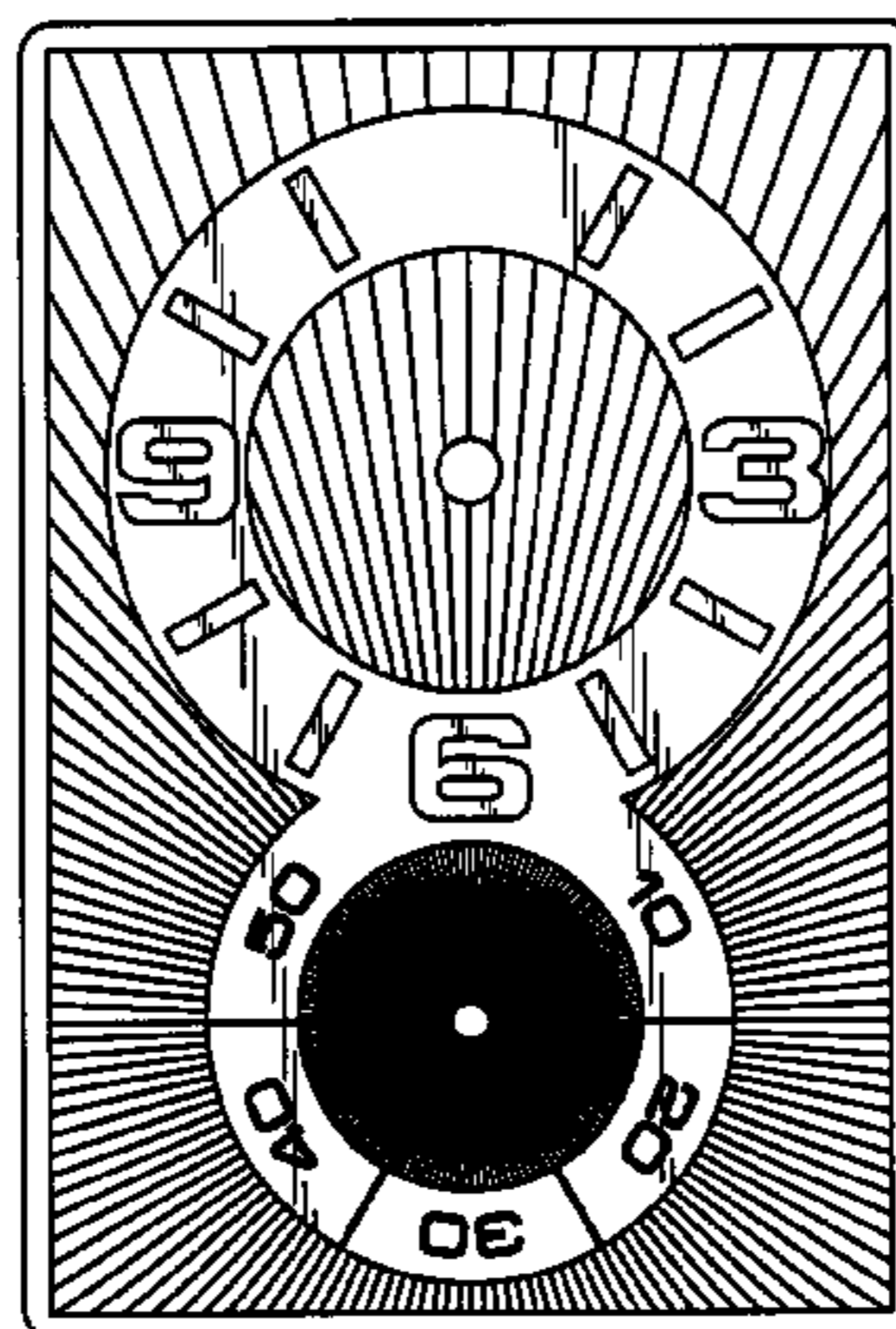
FIG. 4 is a bottom plan view thereof;

FIG. 7 is a perspective view of the top, front and right side thereof.

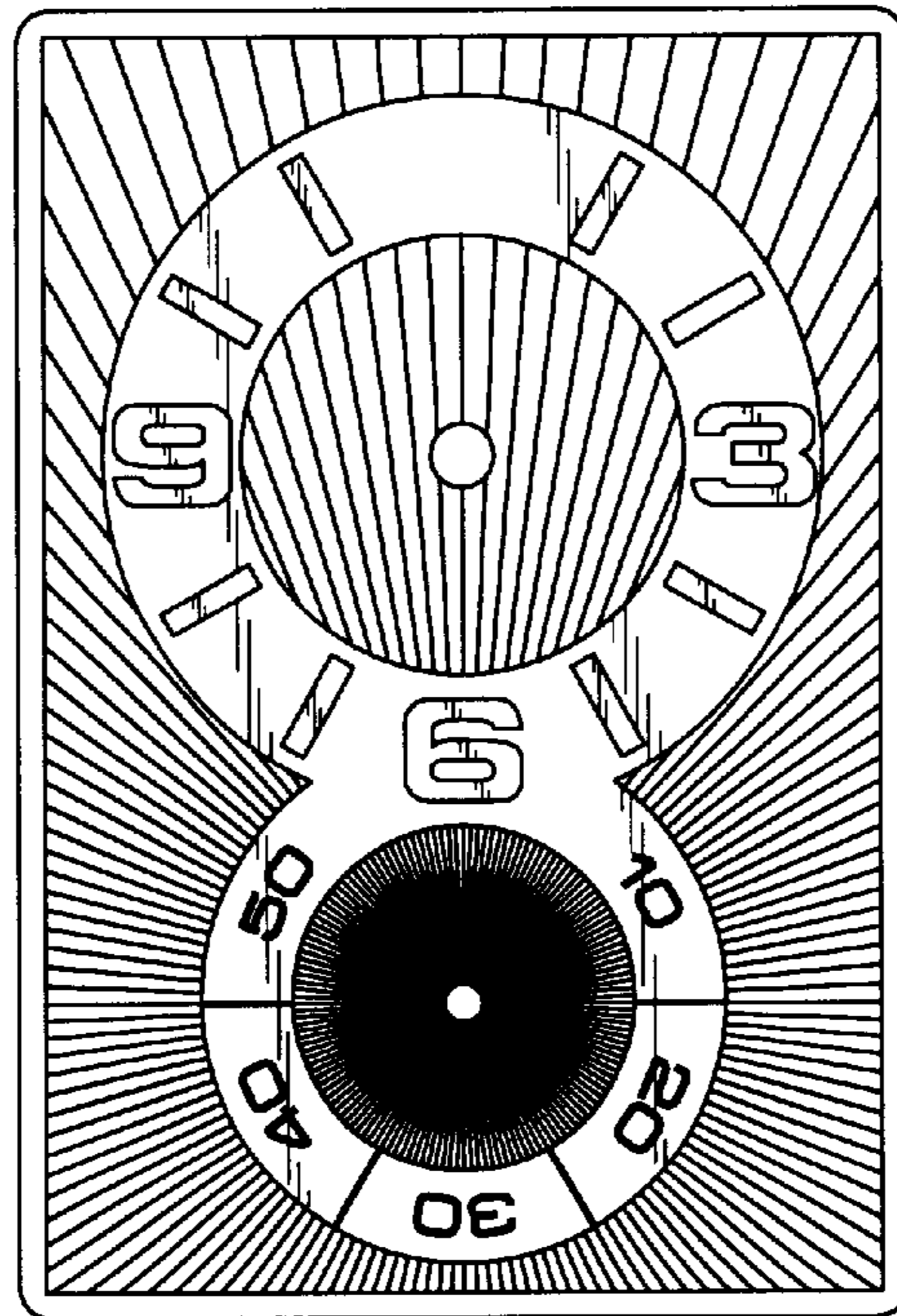

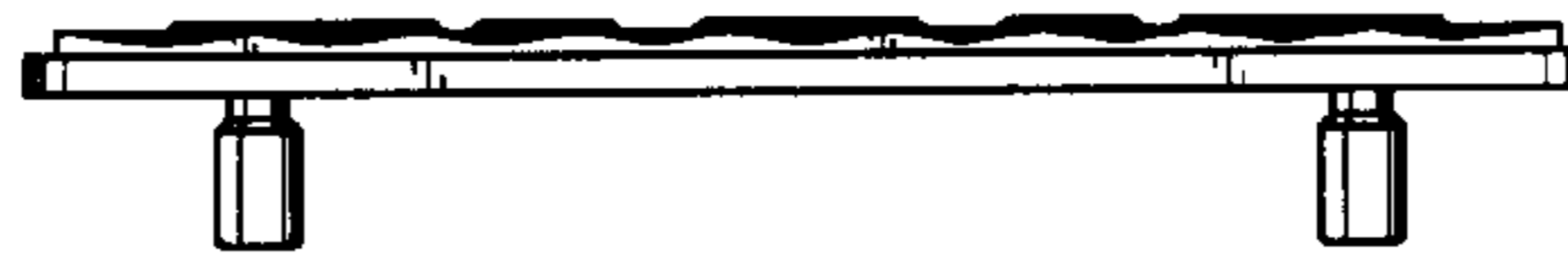

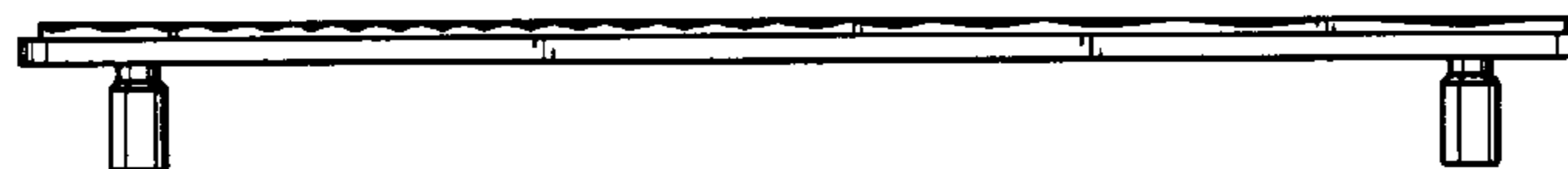

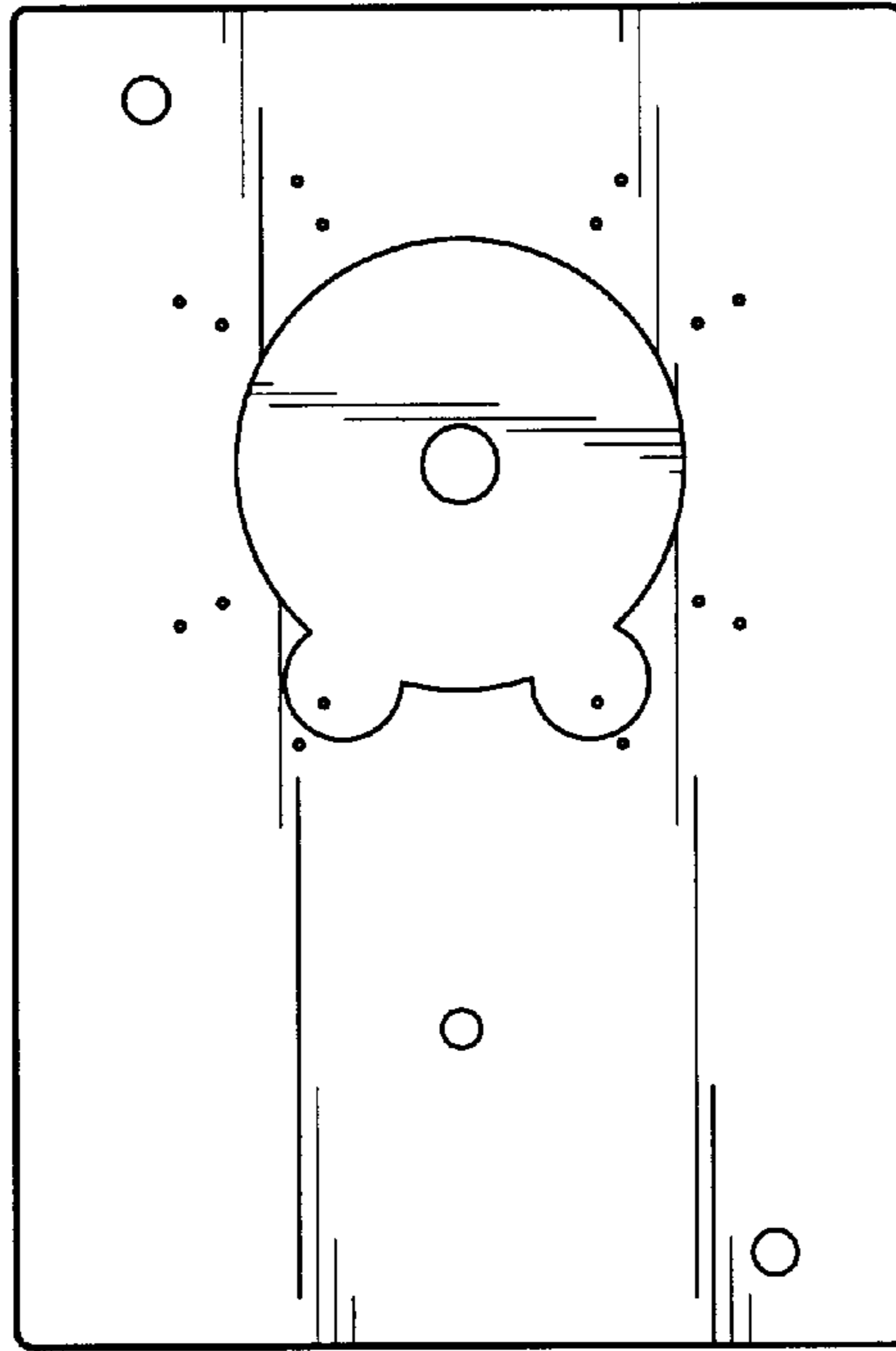

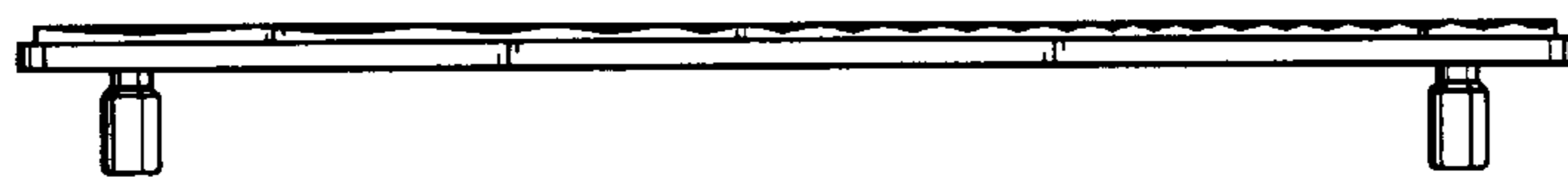

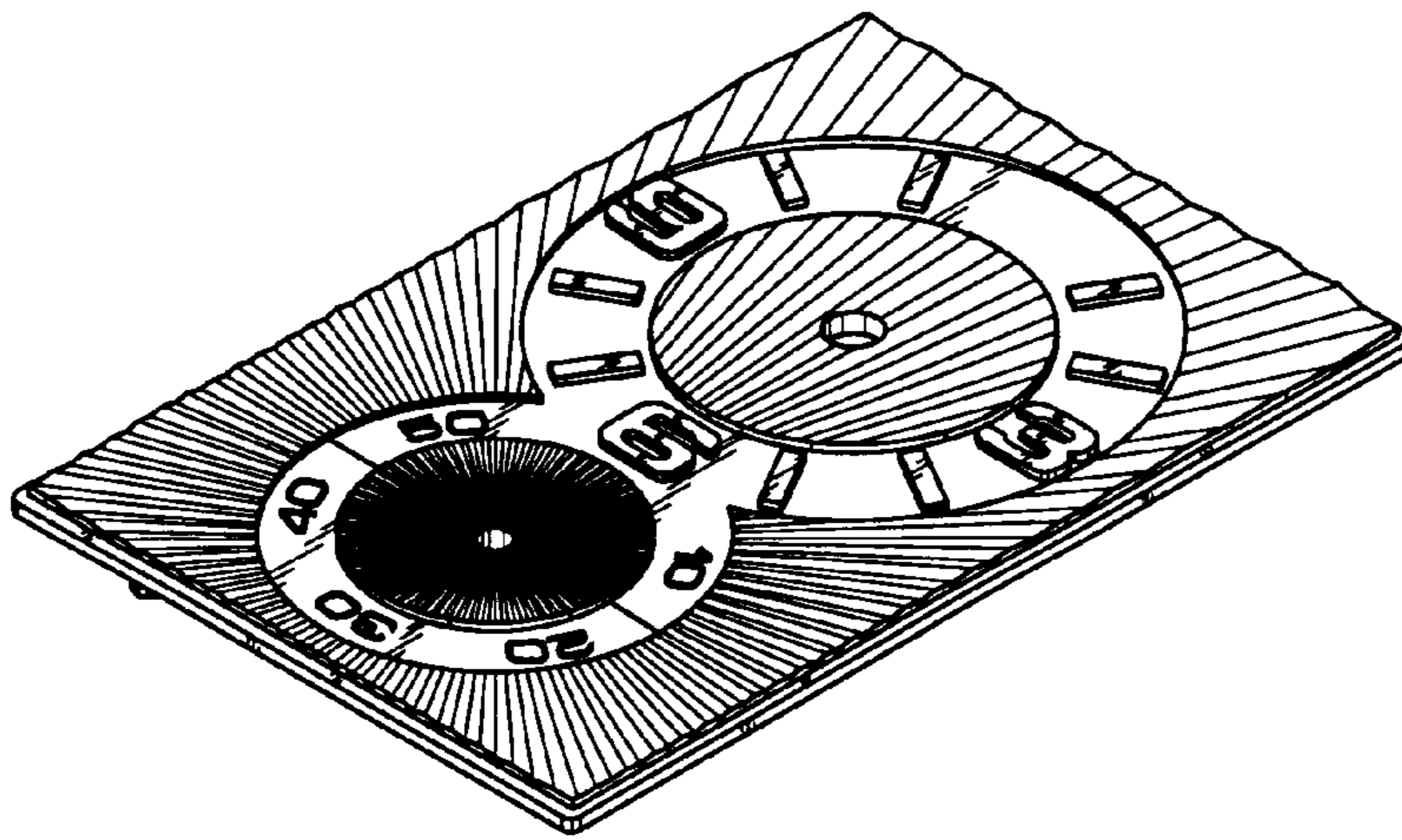
