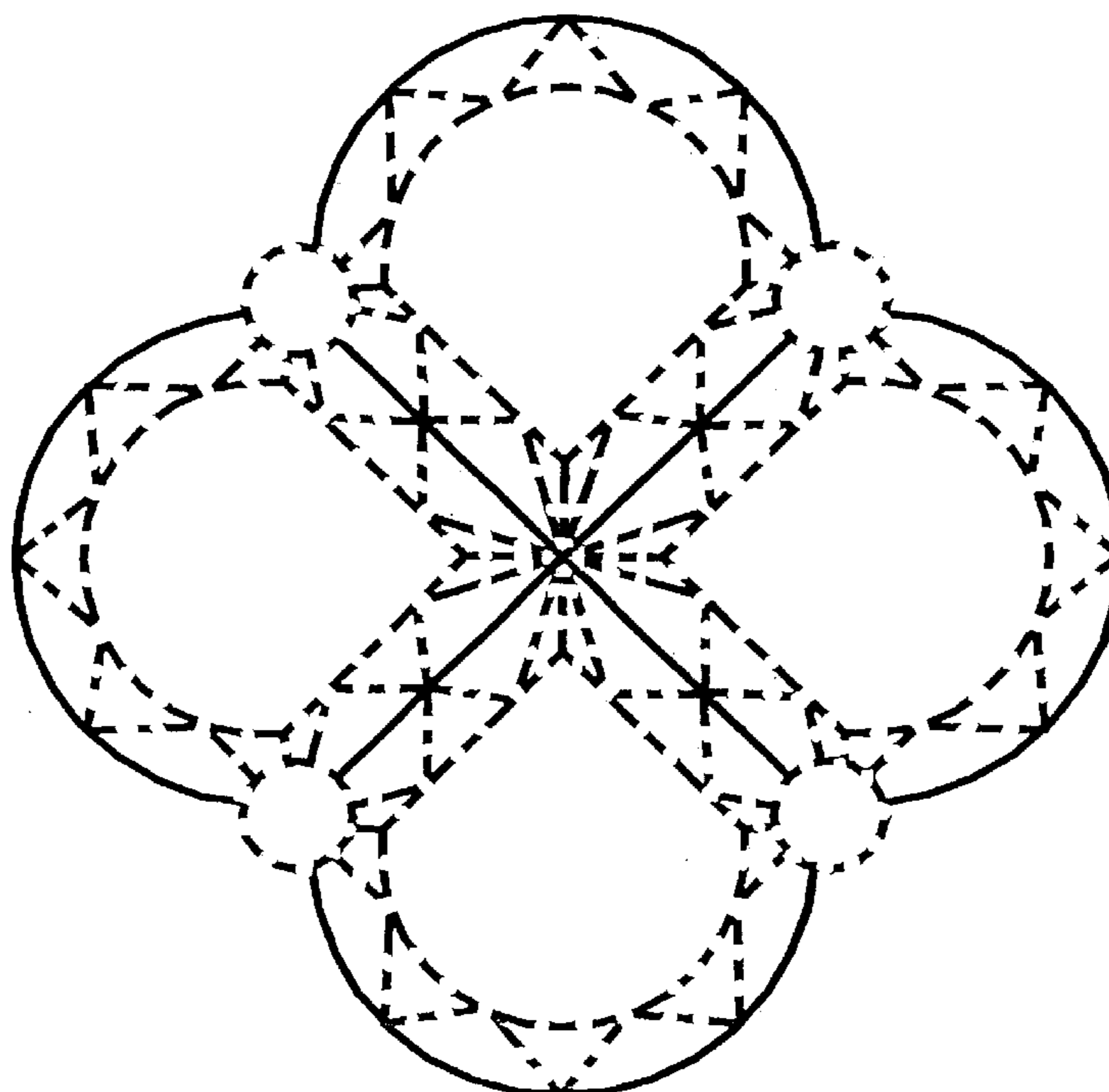
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top view of a jewelry setting/gemstone arrangement showing my new design;
FIG. 2 is a bottom view of the jewelry setting/gemstone arrangement of FIG. 1;

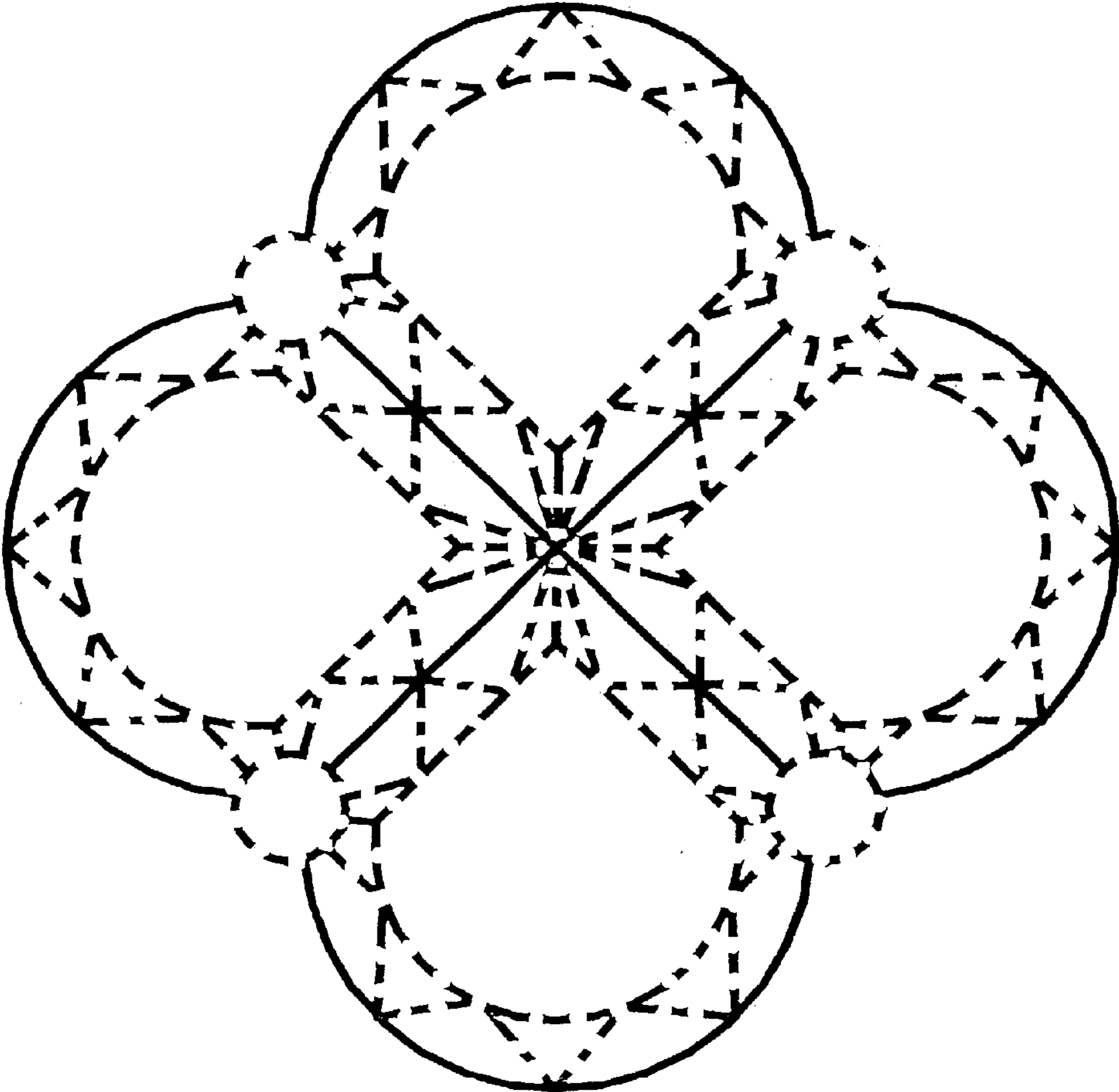

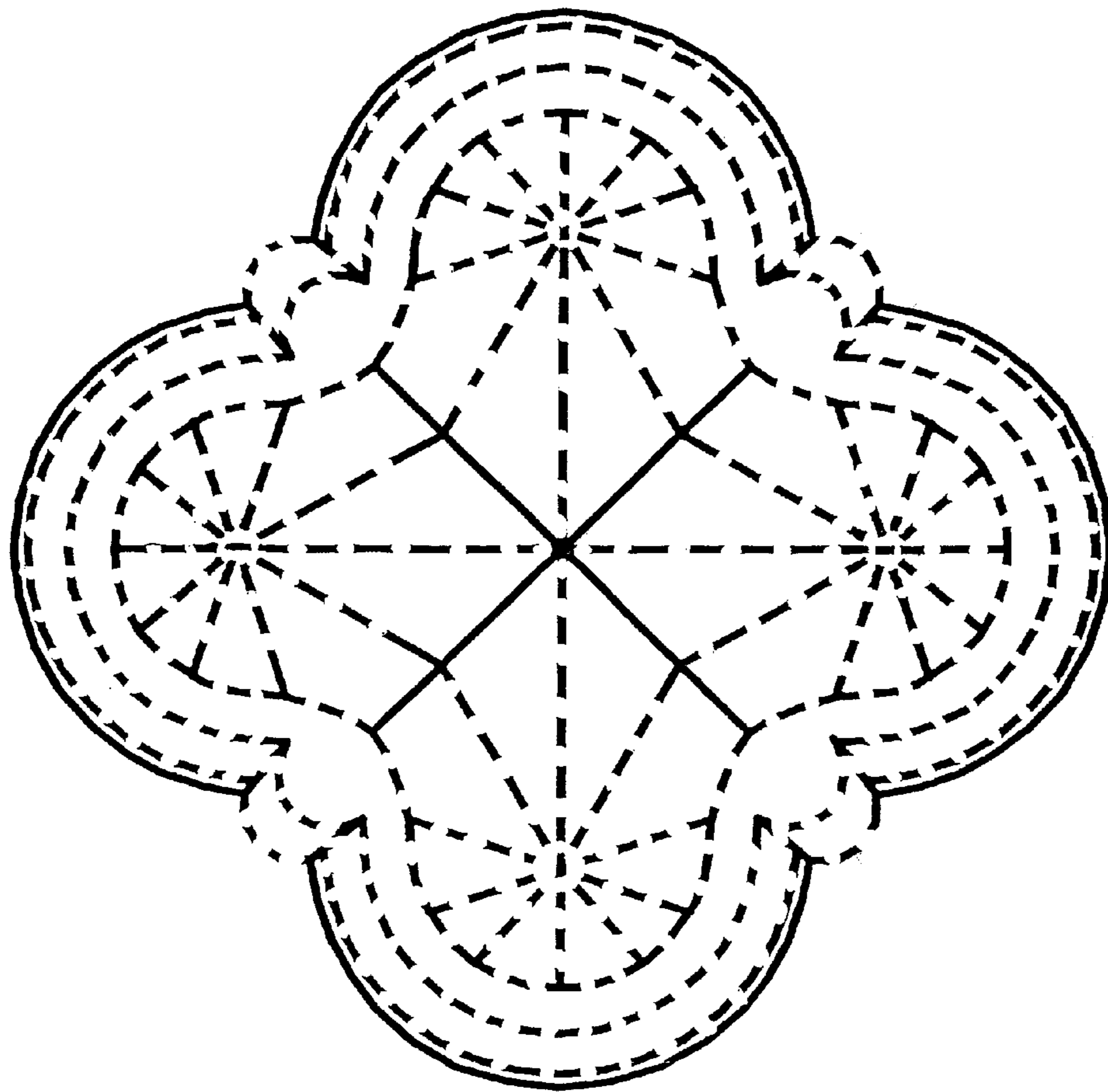

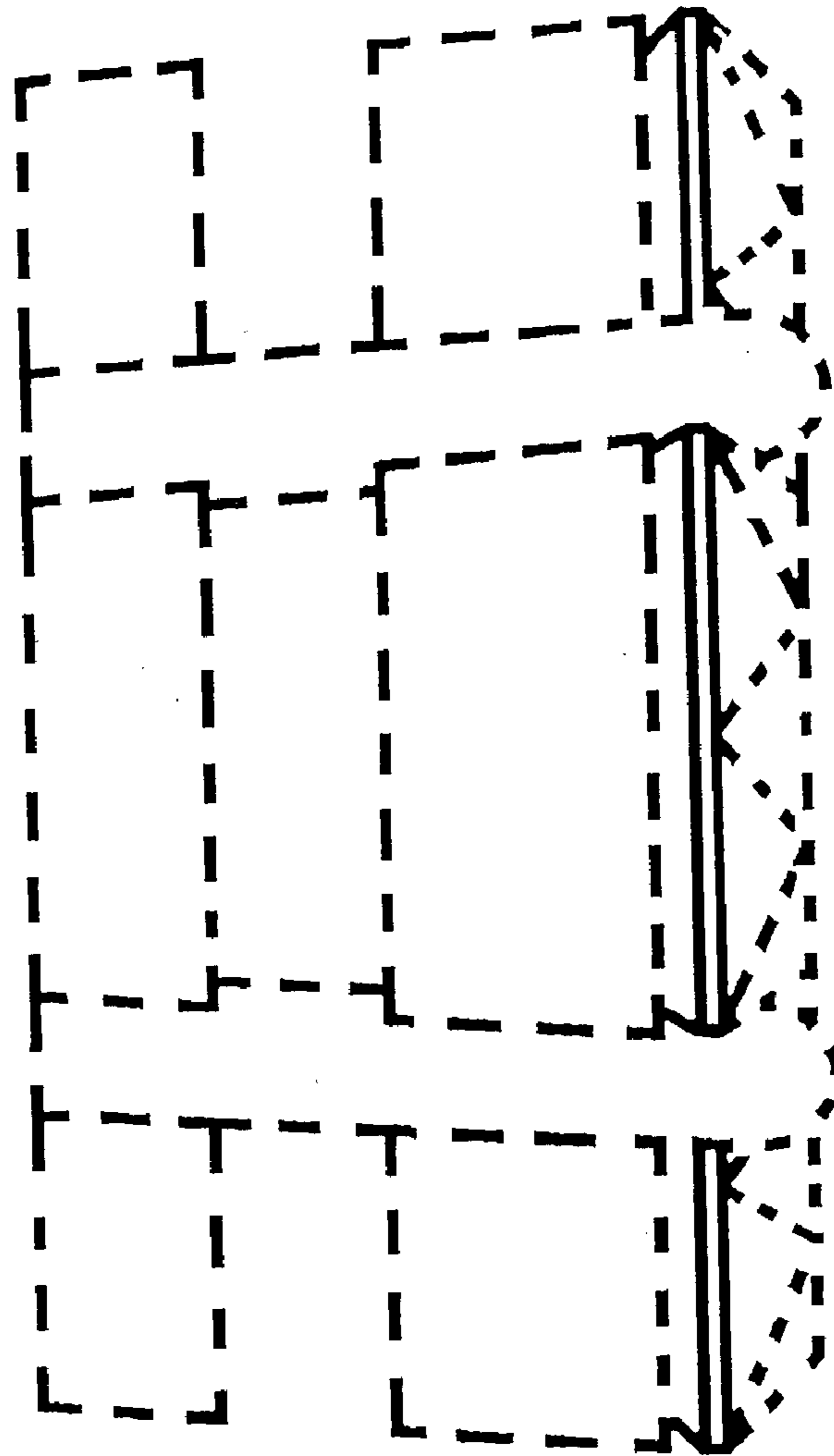

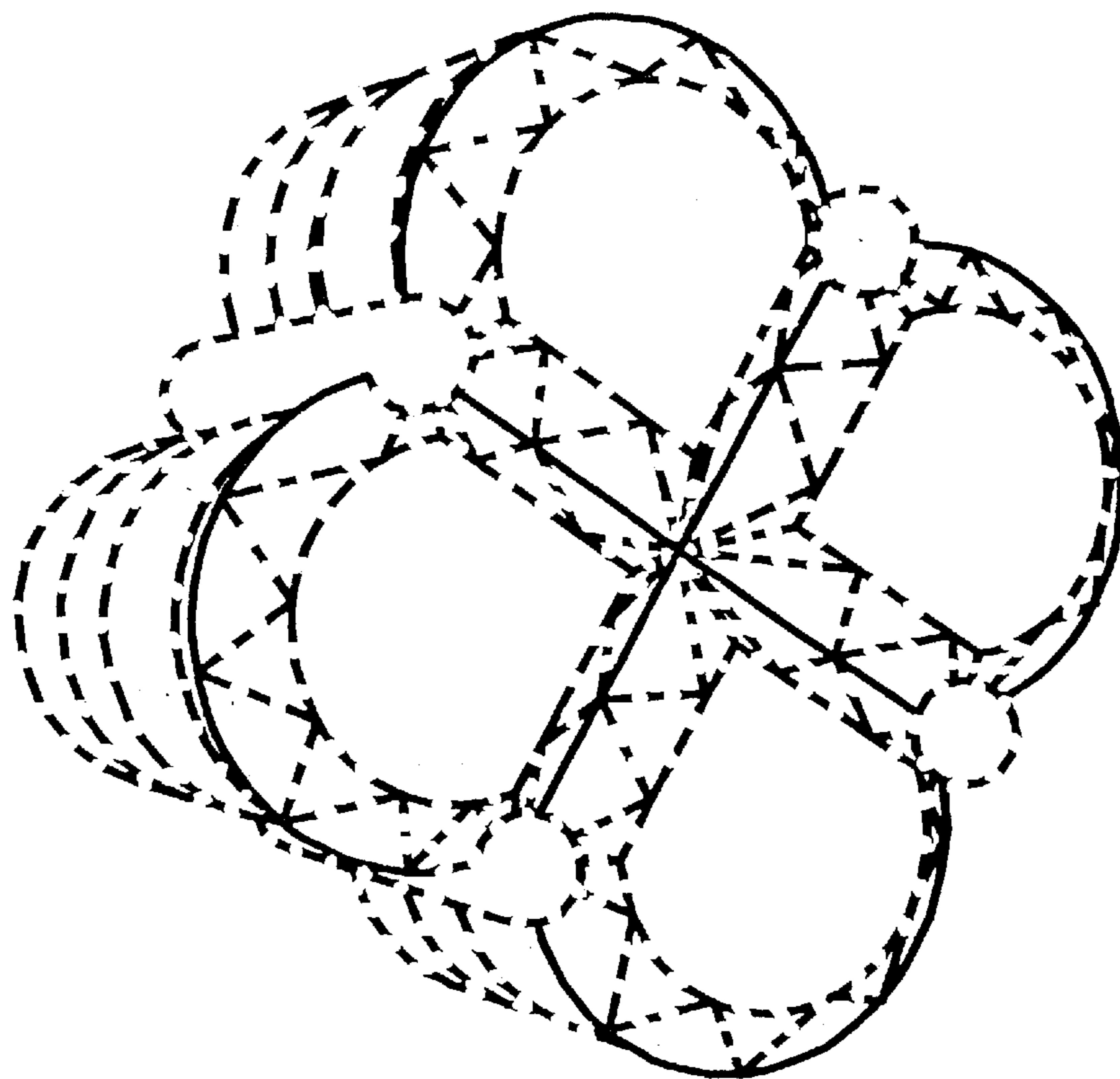
