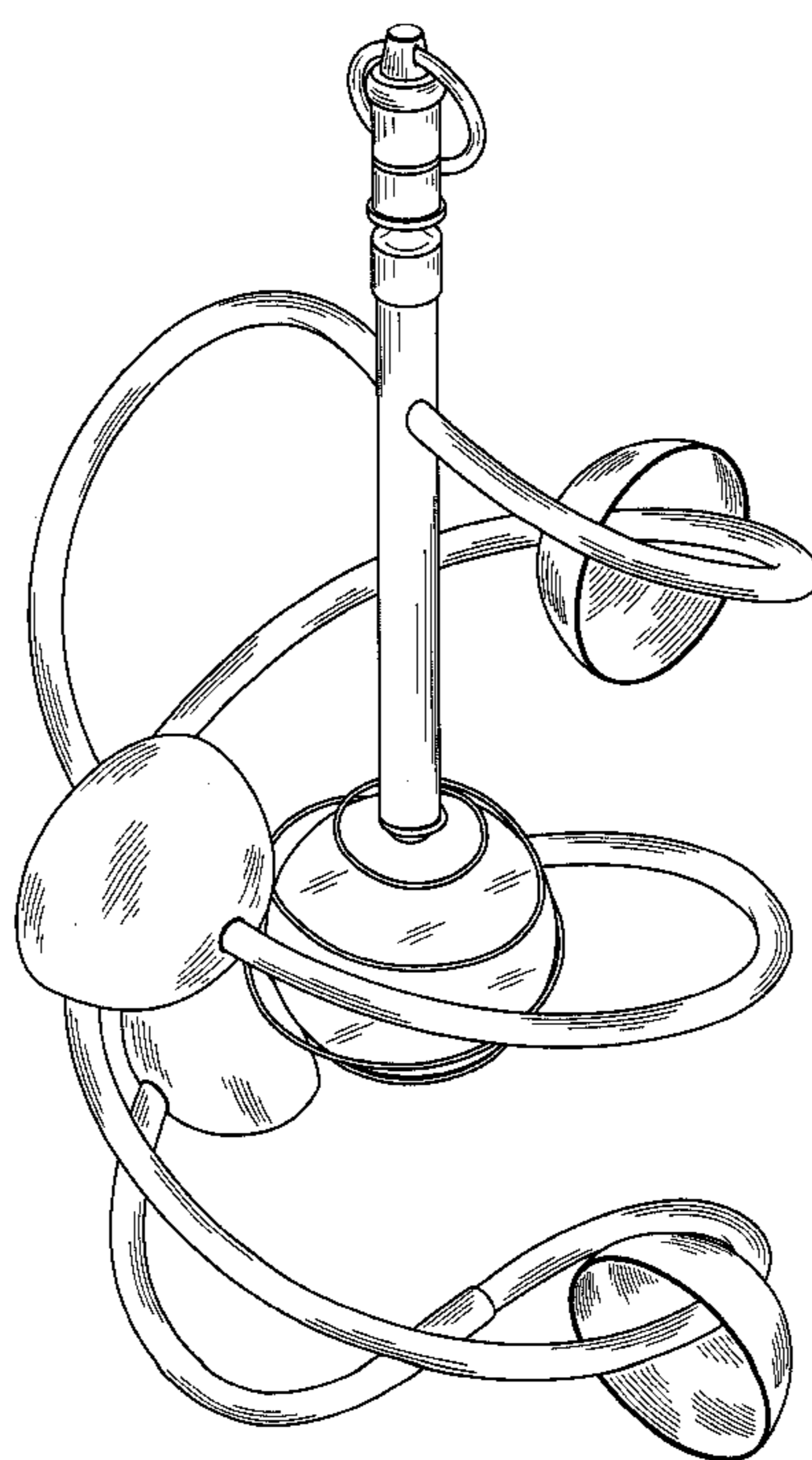
(57) **CLAIM**

I claim the ornamental design for a twirler novelty, as shown and described.

DESCRIPTION

FIG. 1 Is a top perspective view of our twirler novelty;
 FIG. 2 Is a side view thereof;
 FIG. 3 Is a side view thereof rotated 180 degrees from FIG. 2;
 FIG. 4 Is a side view thereof rotated 90 degrees from FIG. 3;
 FIG. 5 Is a side view thereof rotated 180 degrees from FIG. 4;
 FIG. 6 Is a top plan view; and,
 FIG. 7 Is a bottom plan view.

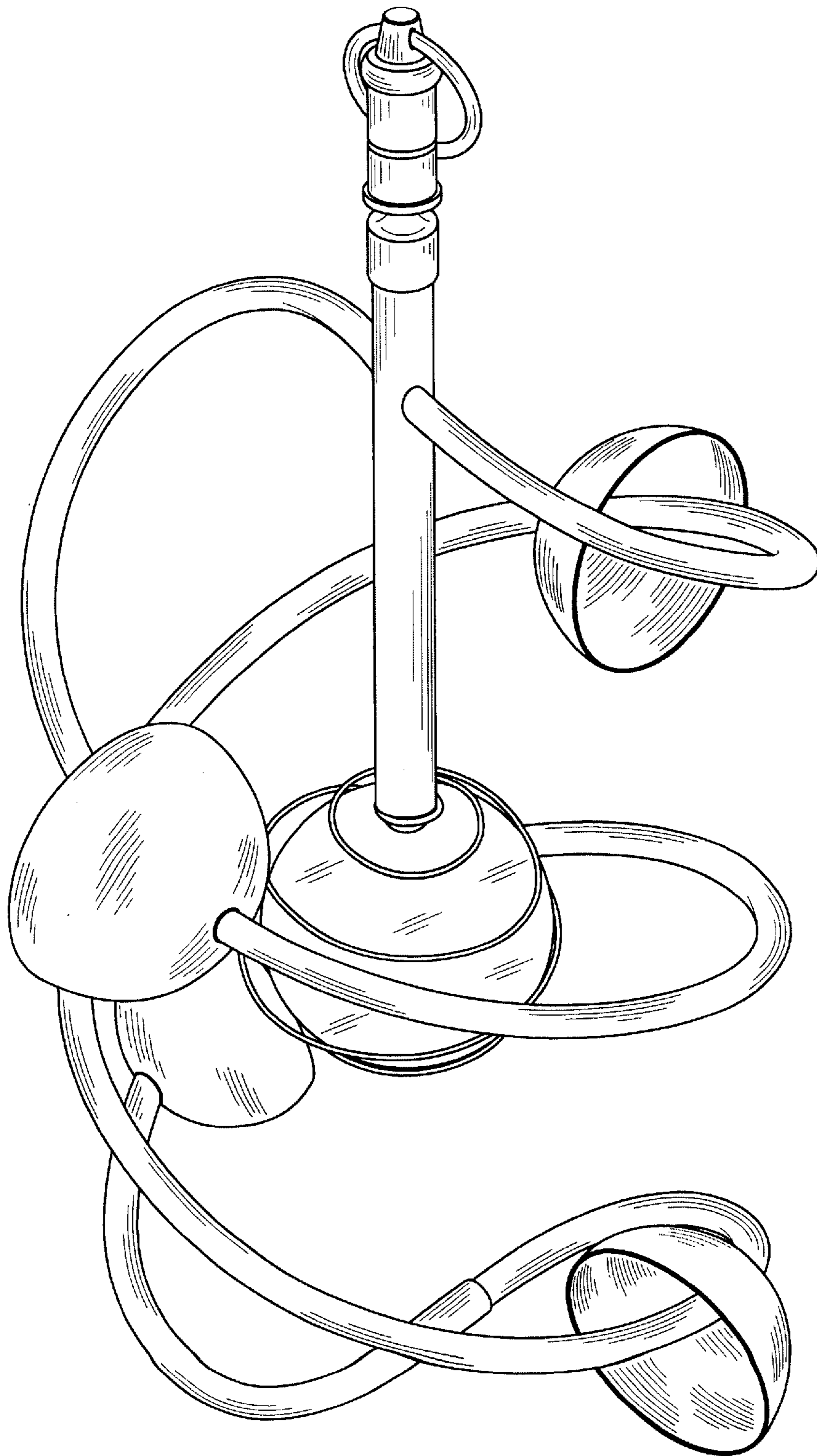

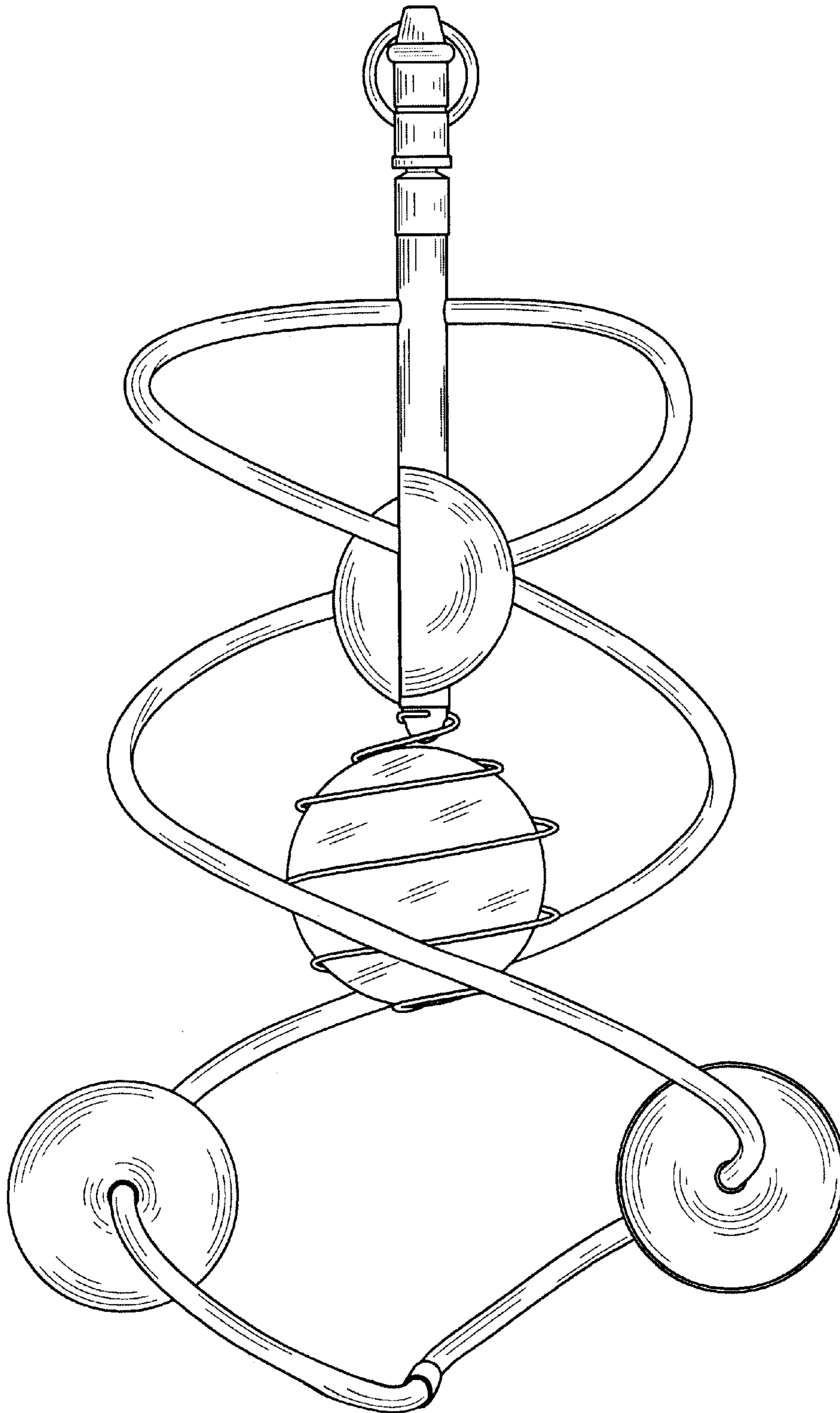

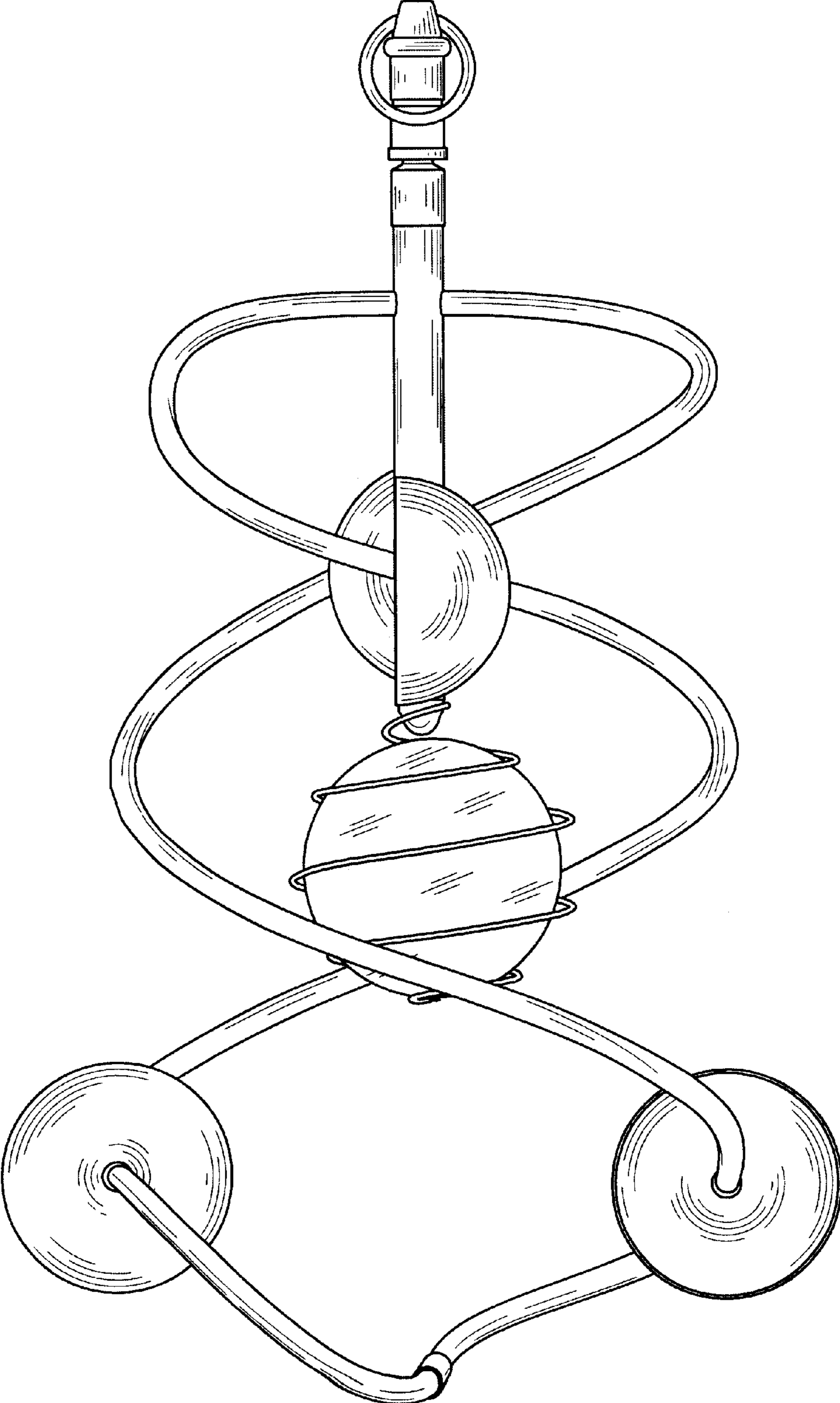

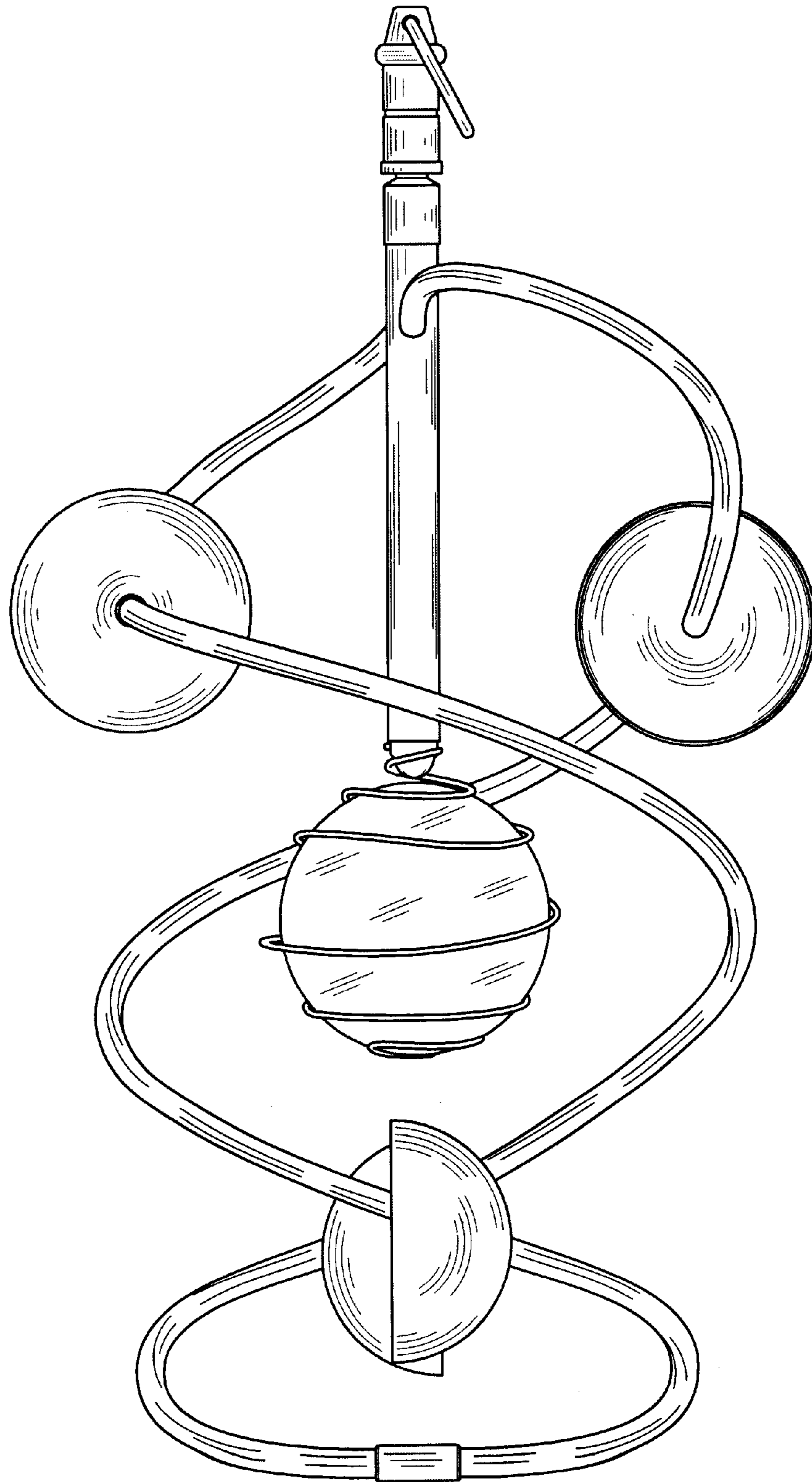

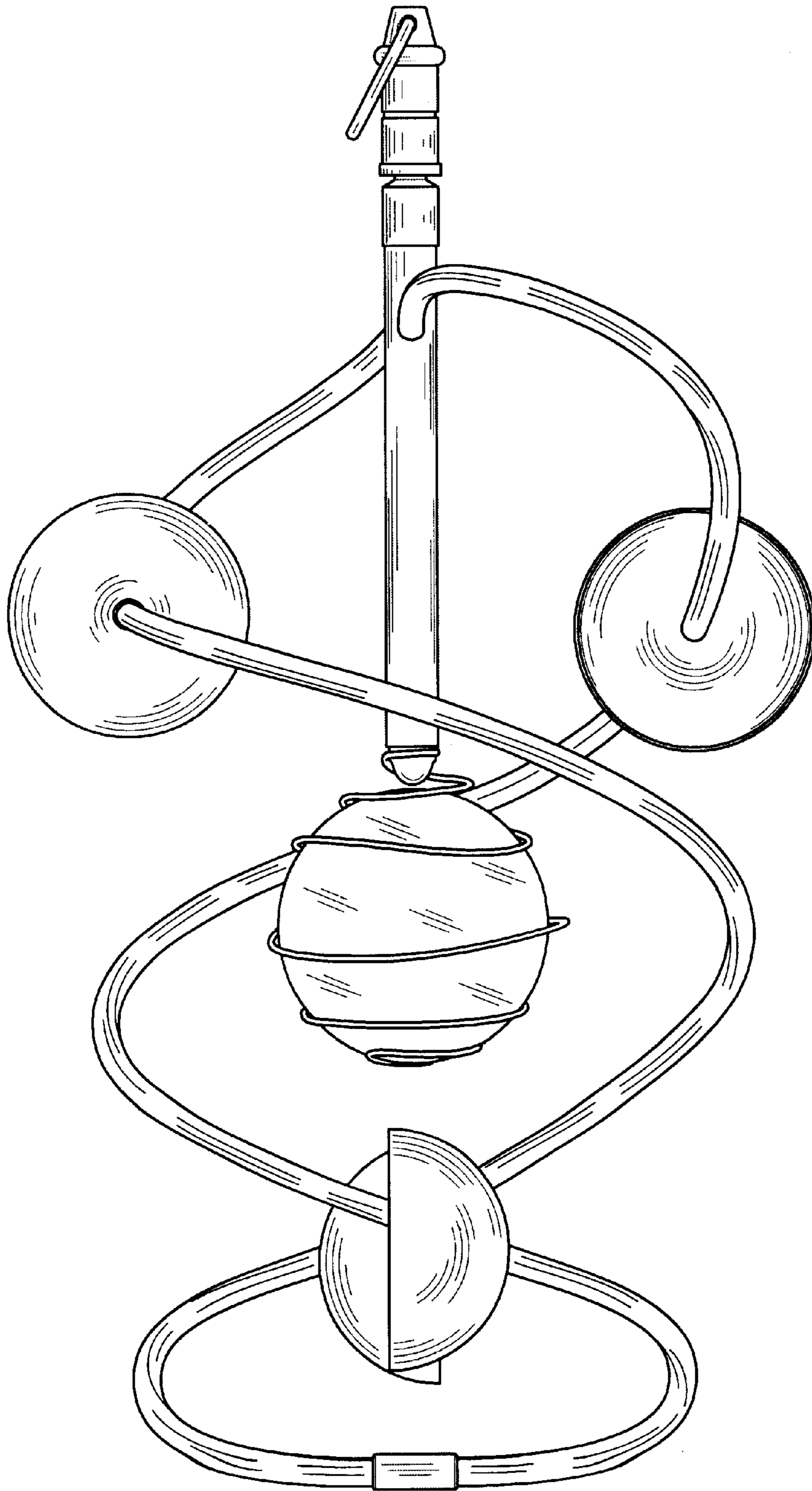

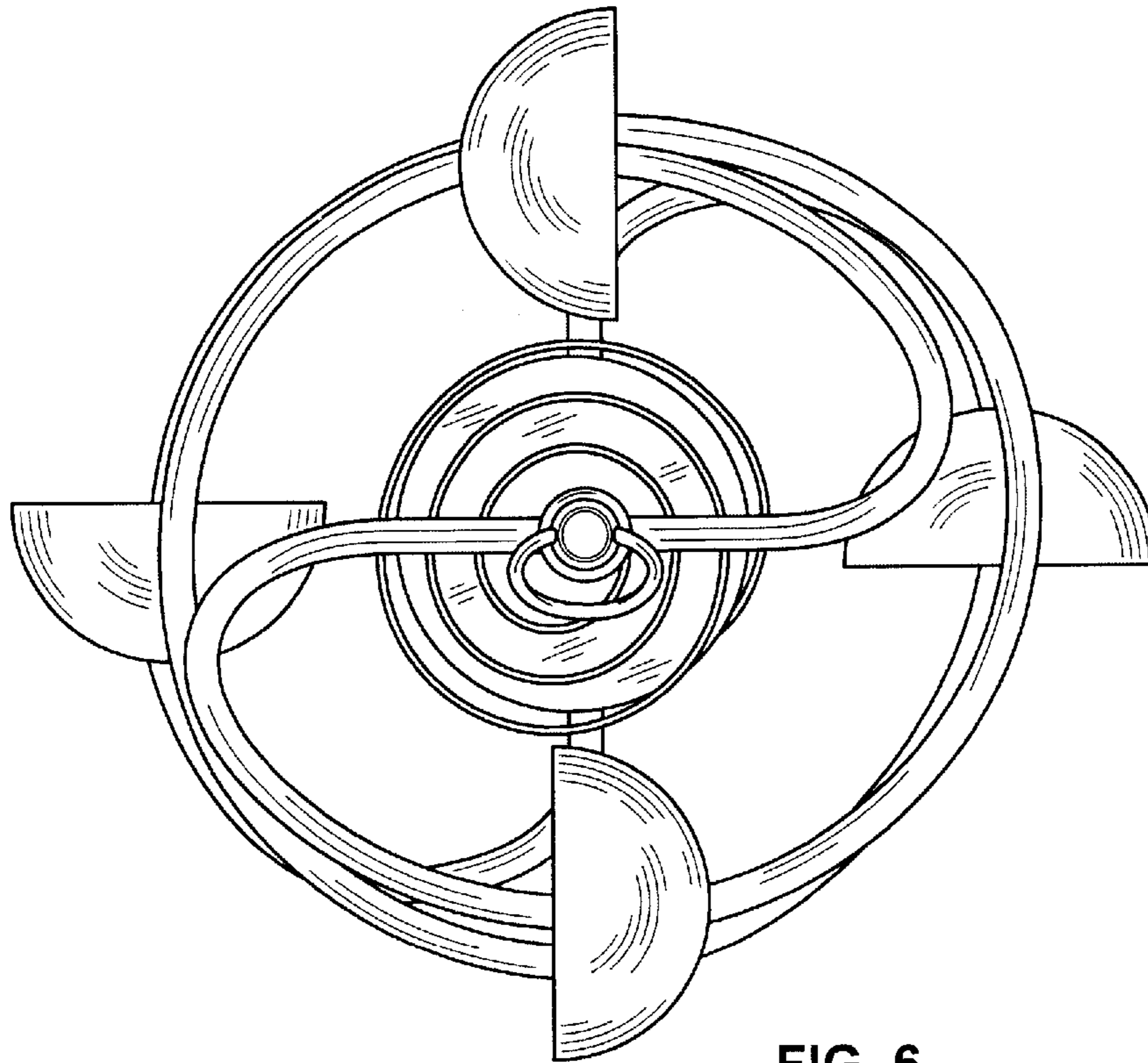

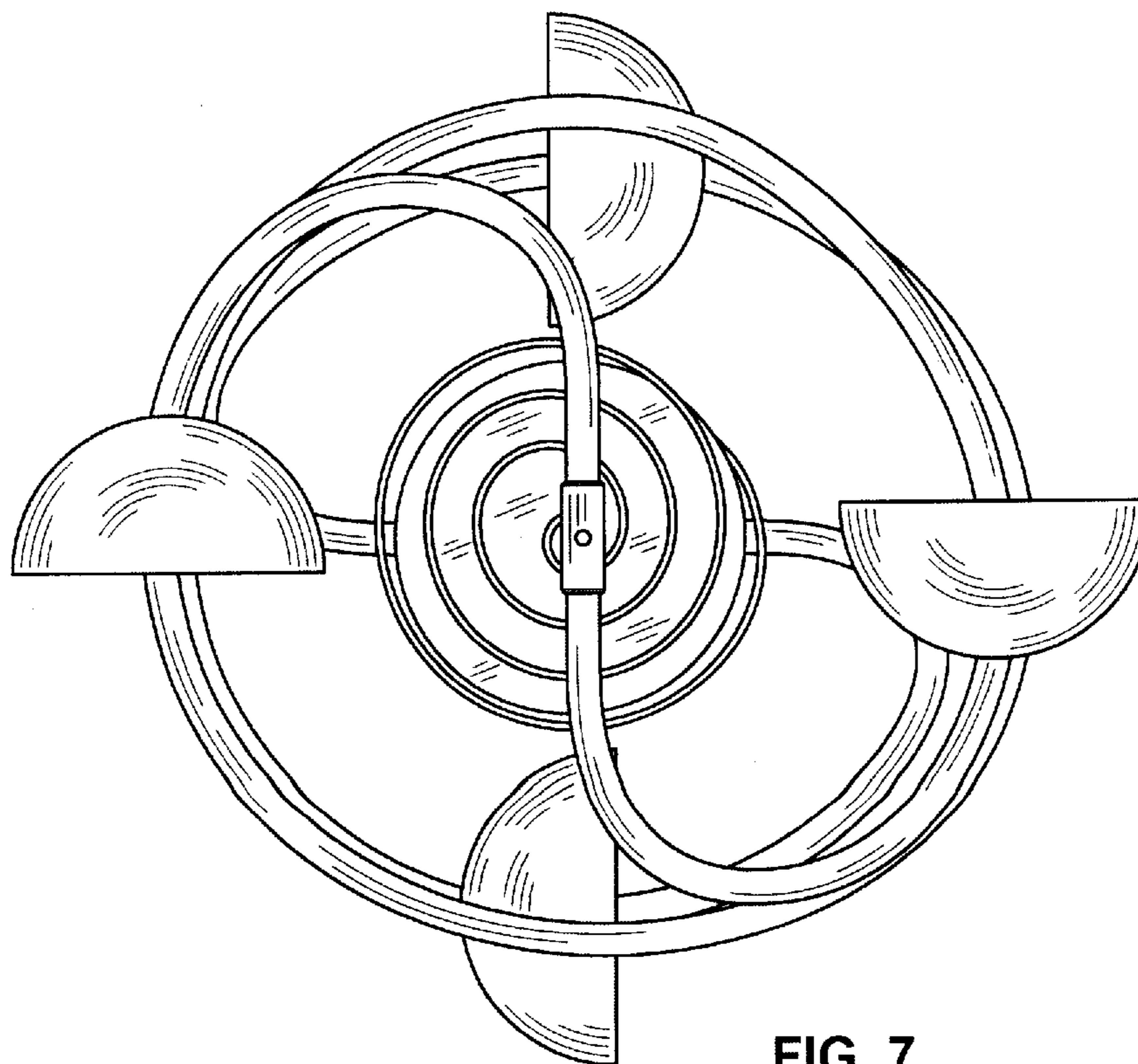
