FIG. 9 is a perspective view, showing the faucet handle engaged with a faucet assembly.

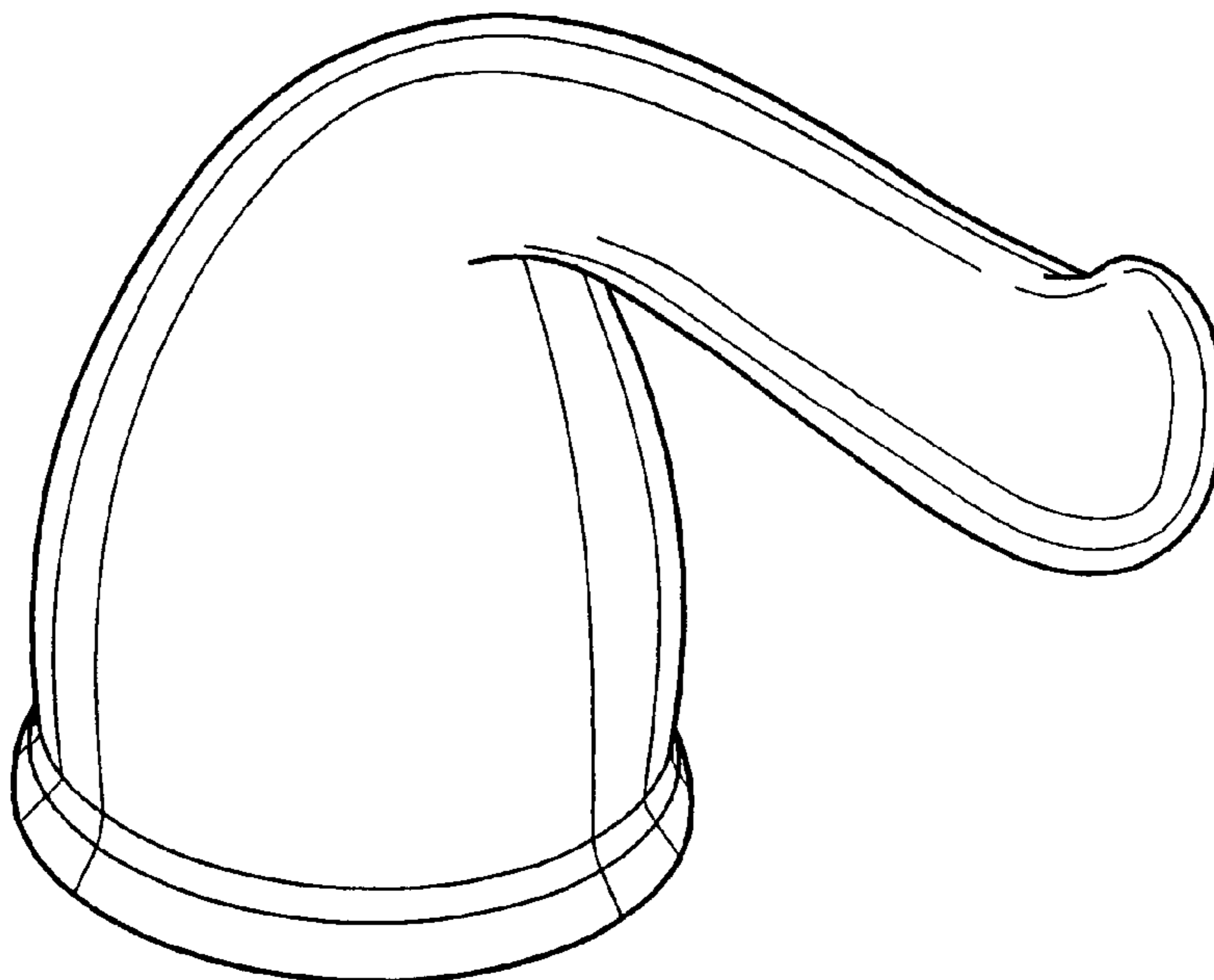

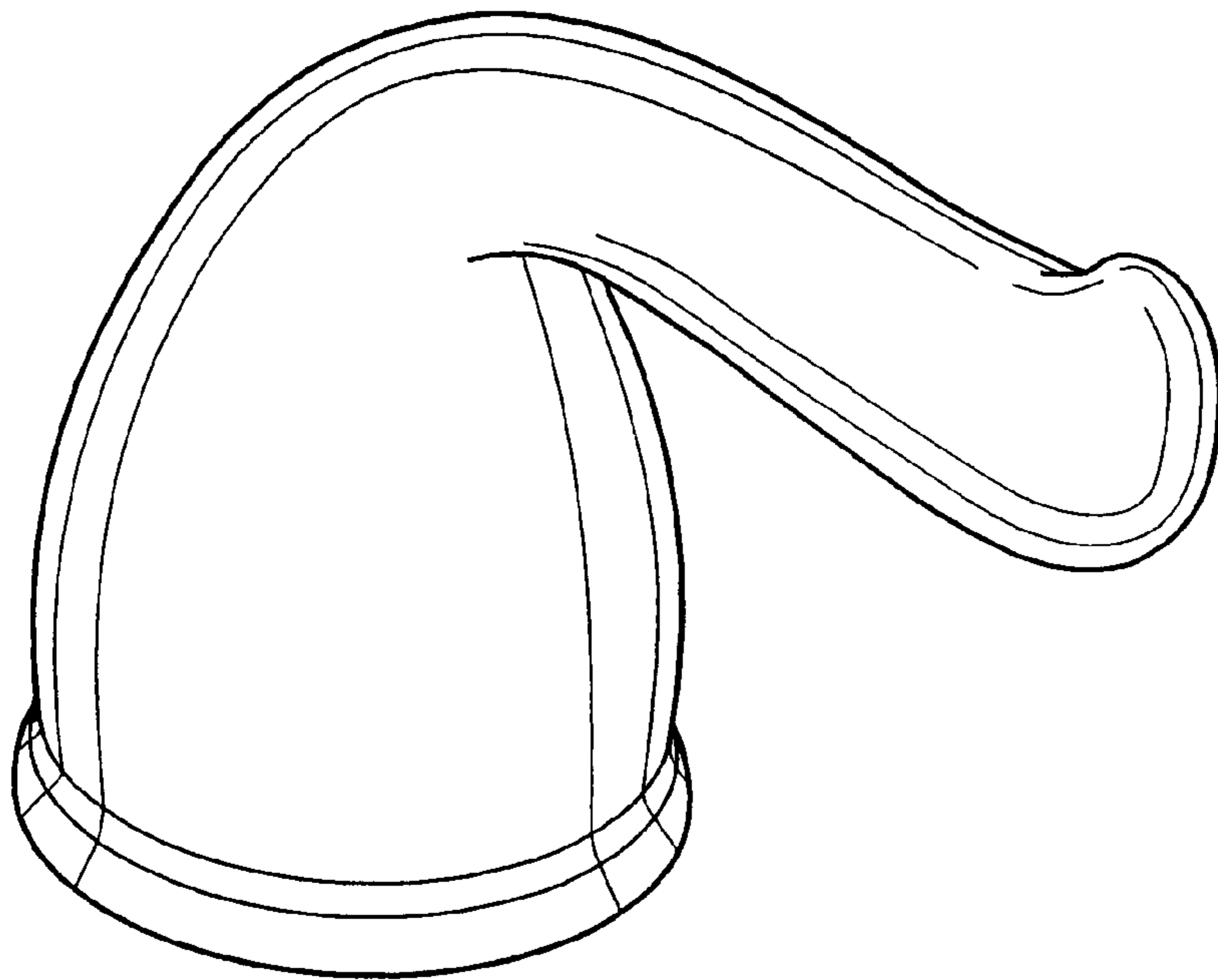

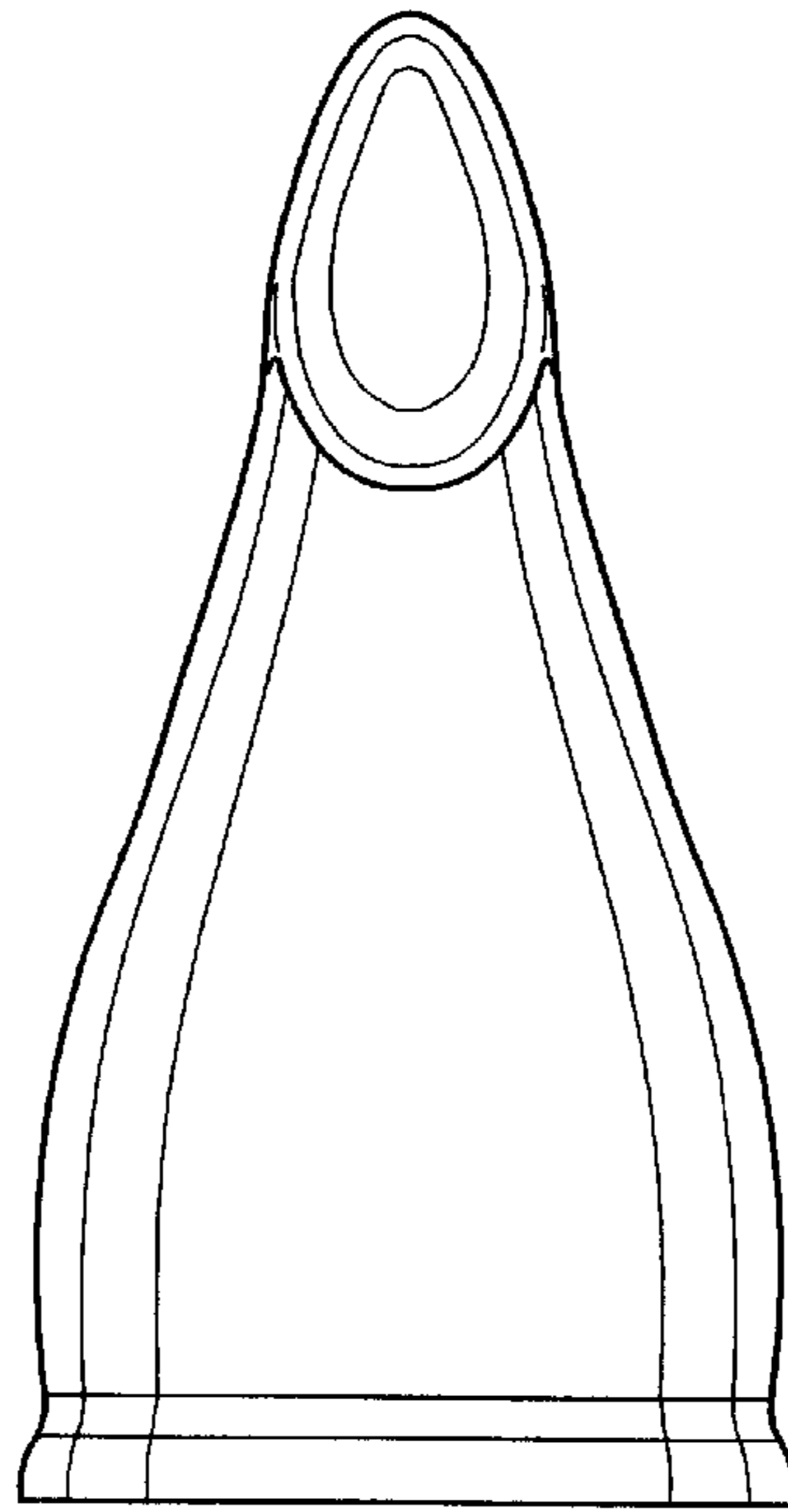

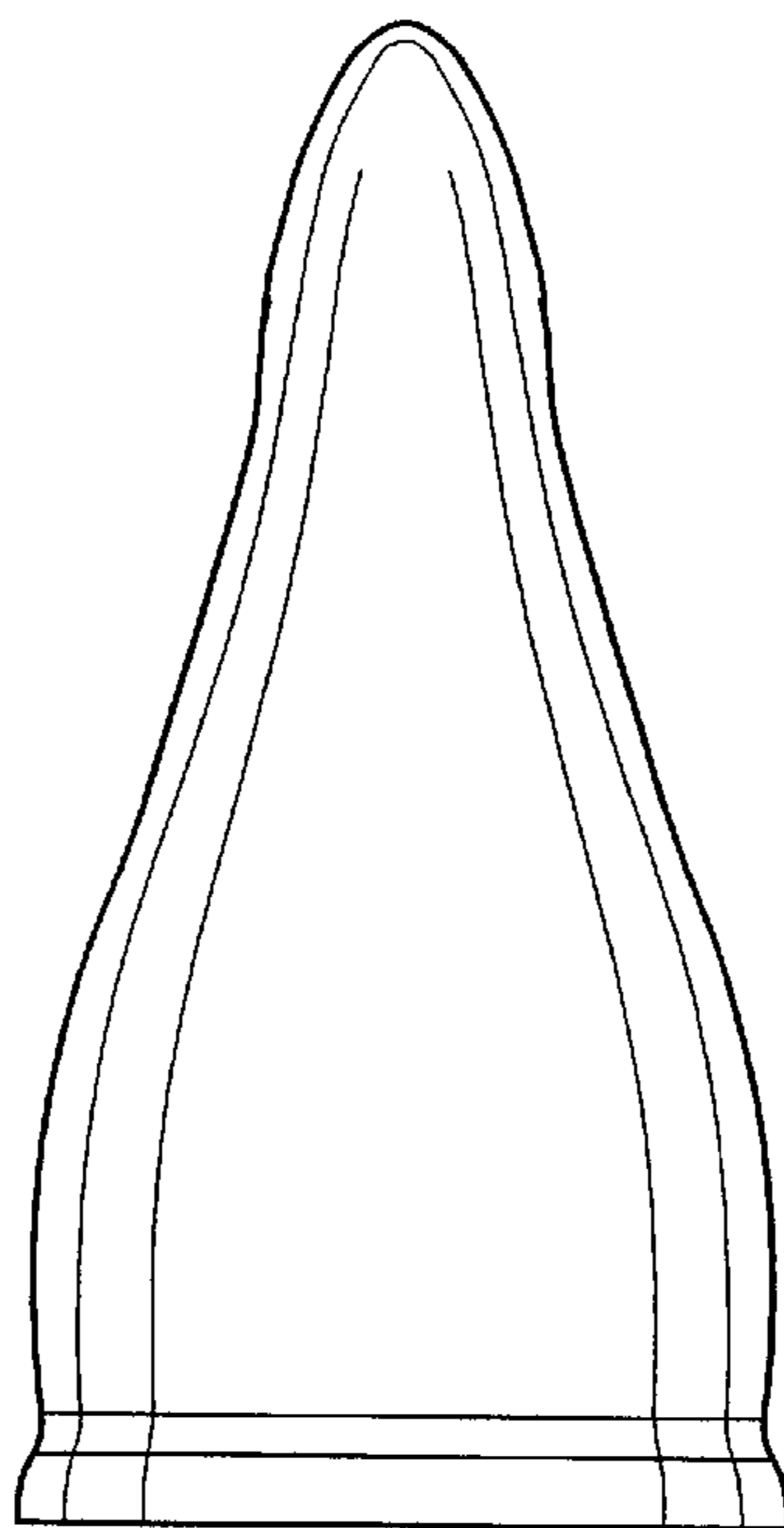

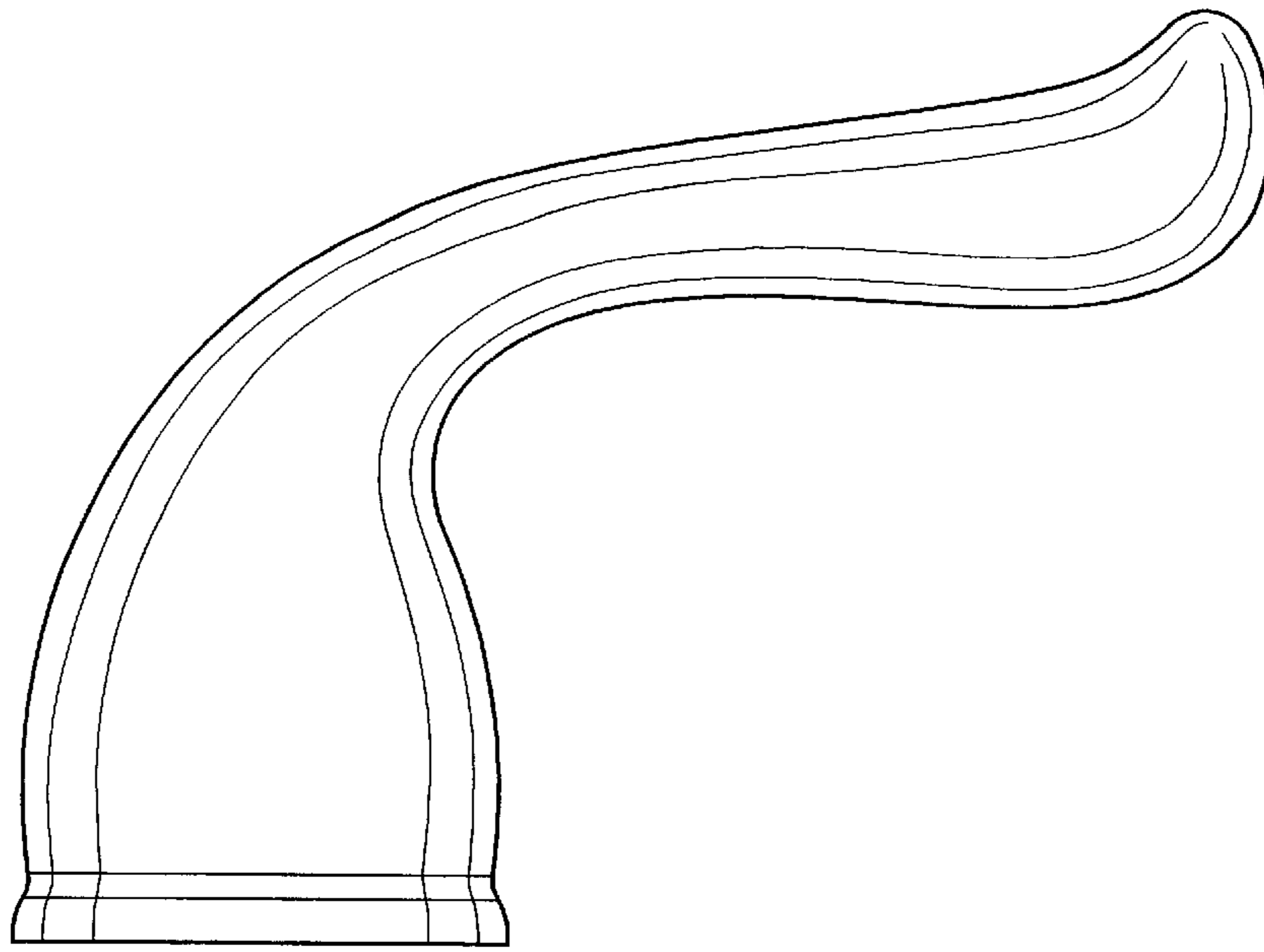

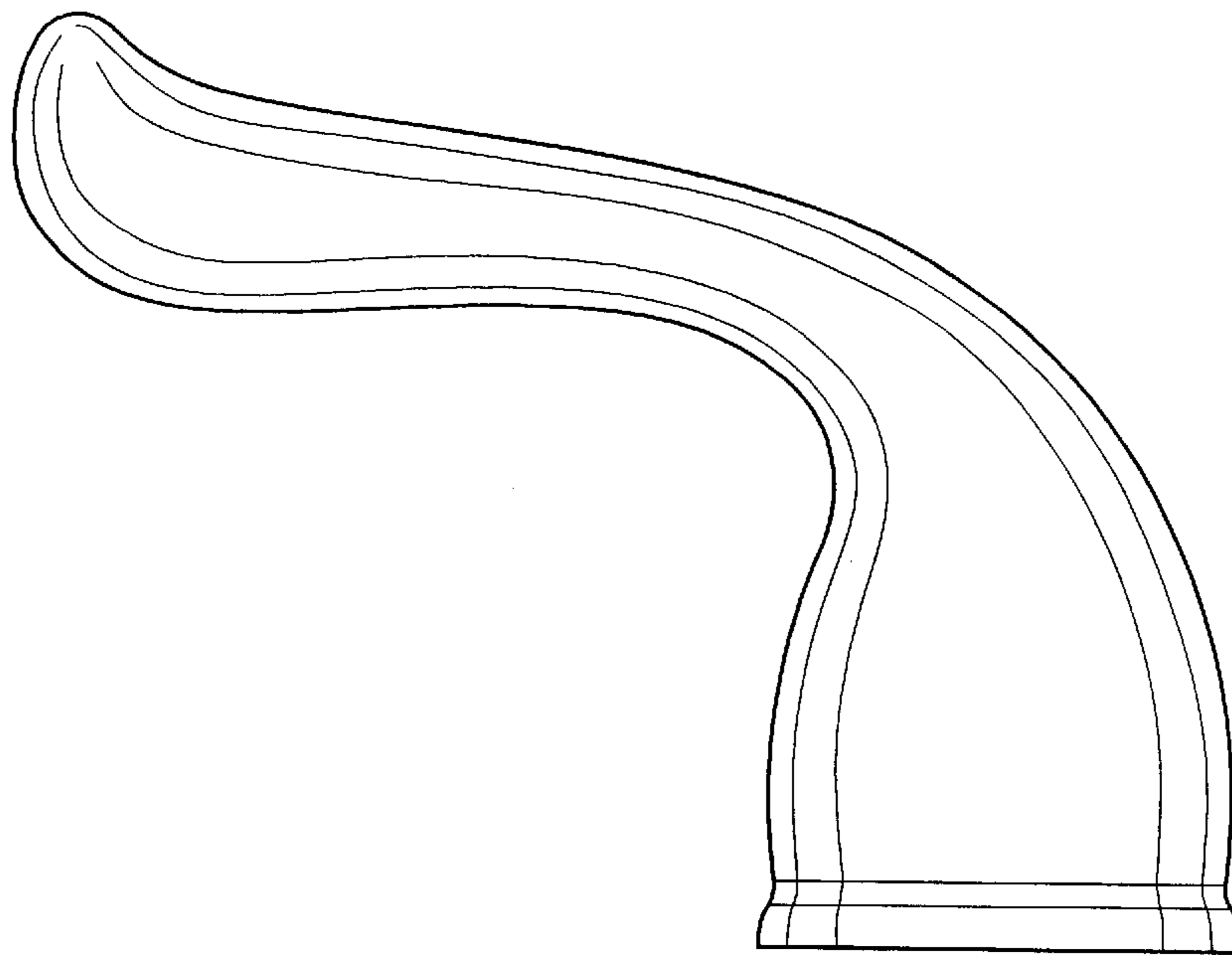

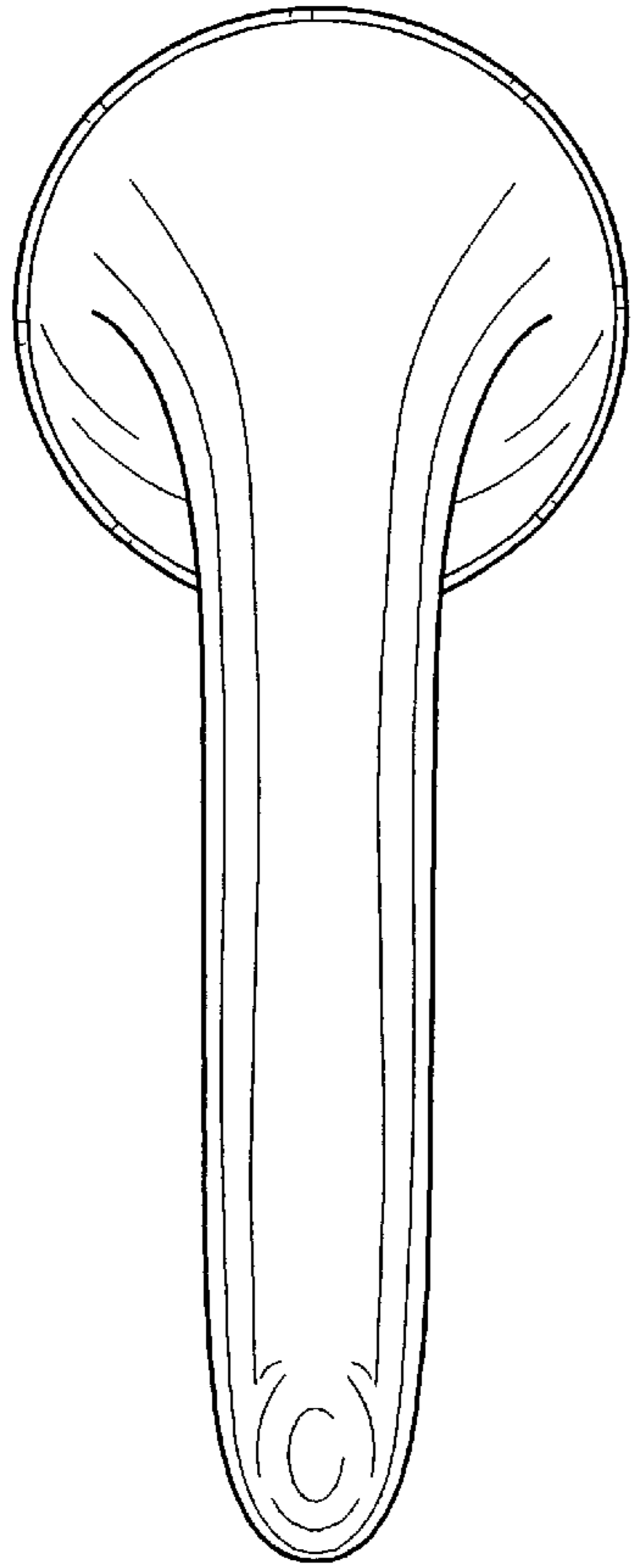

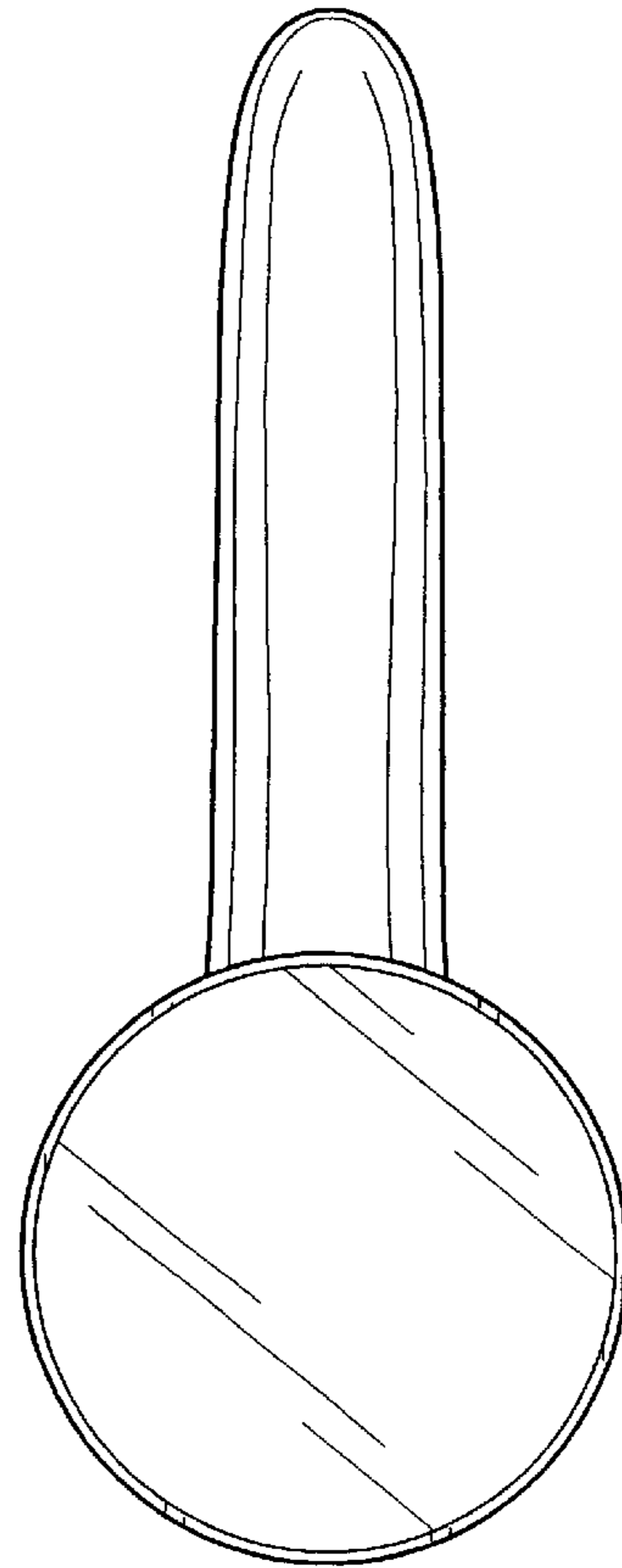

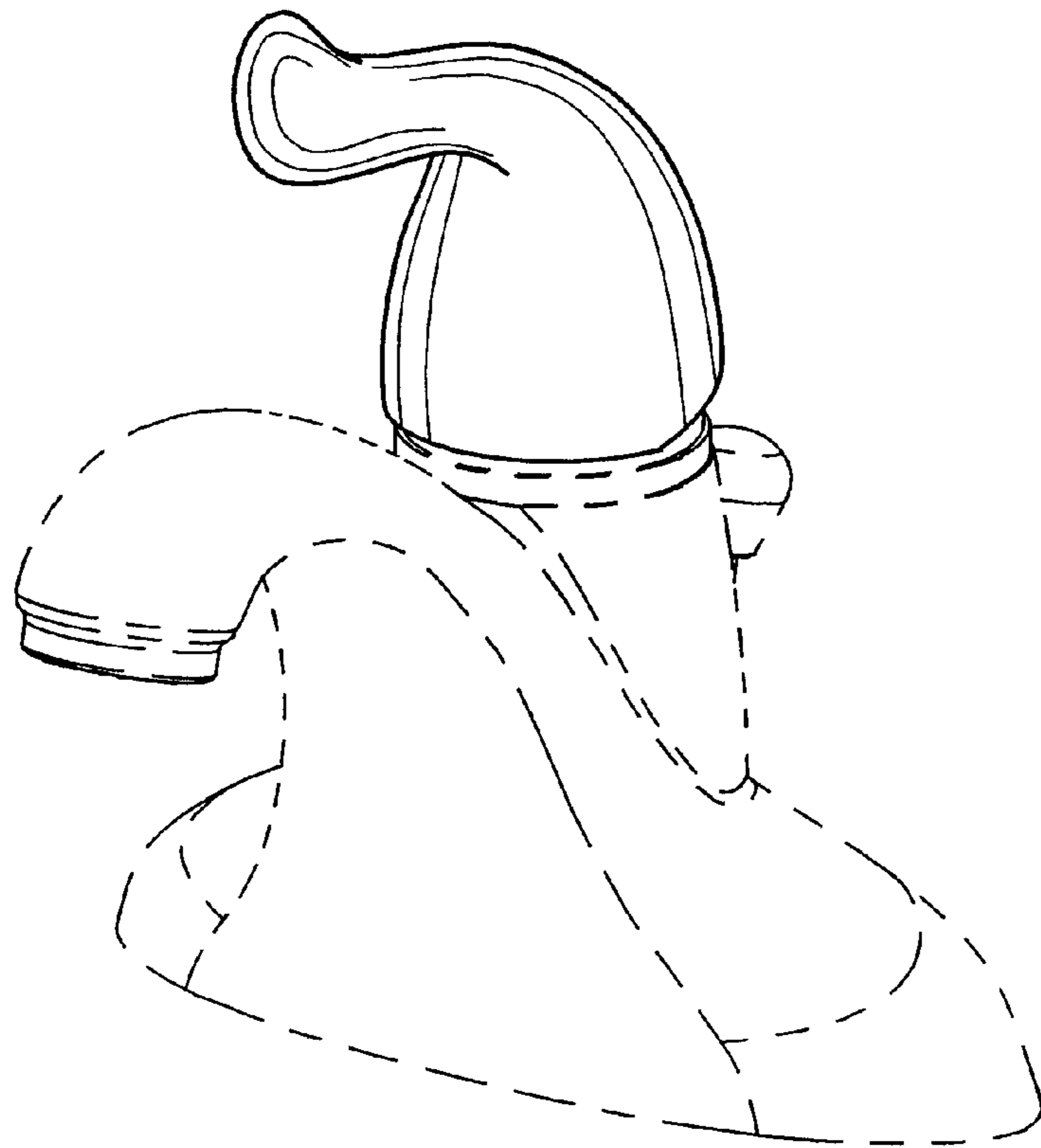

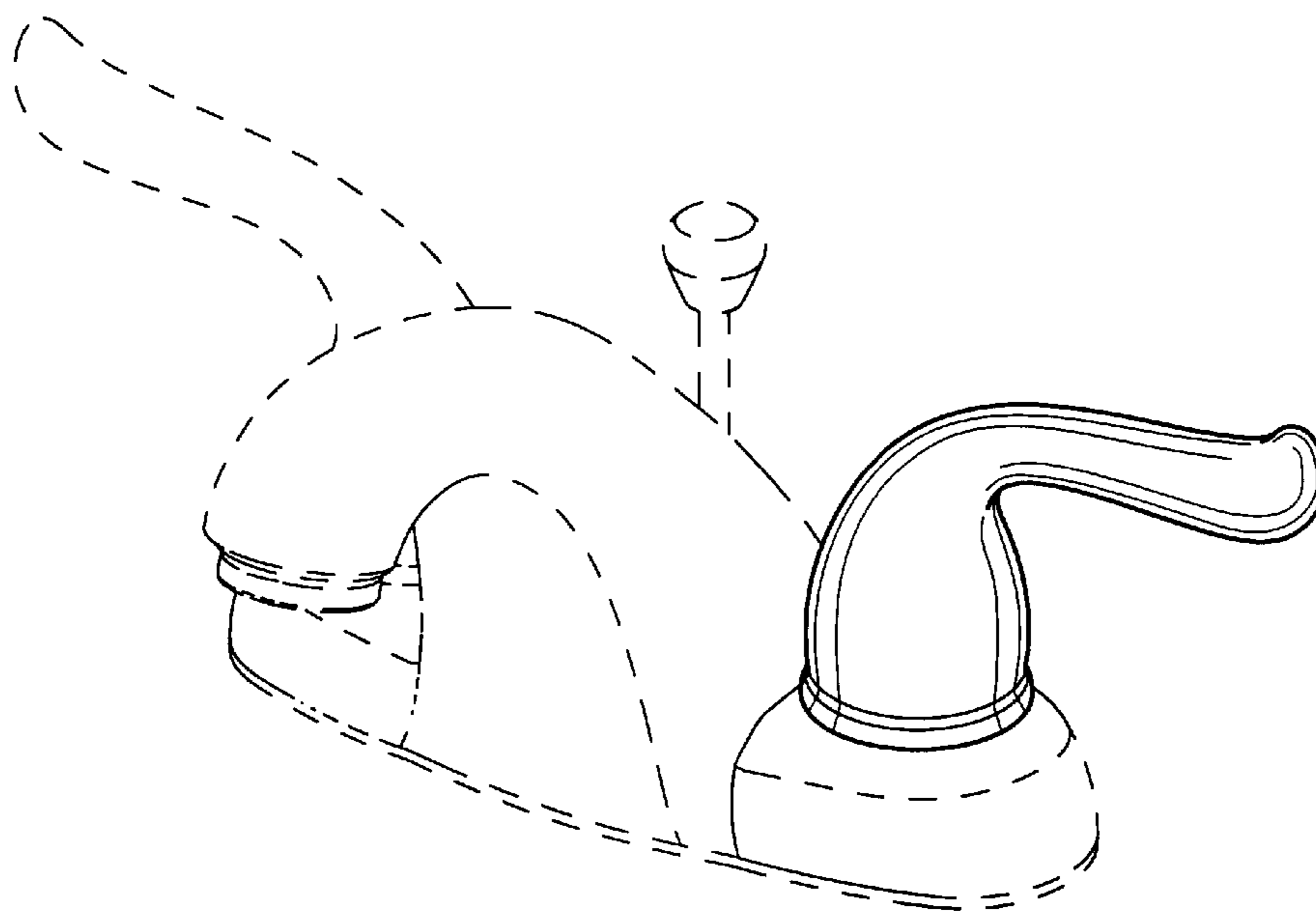
