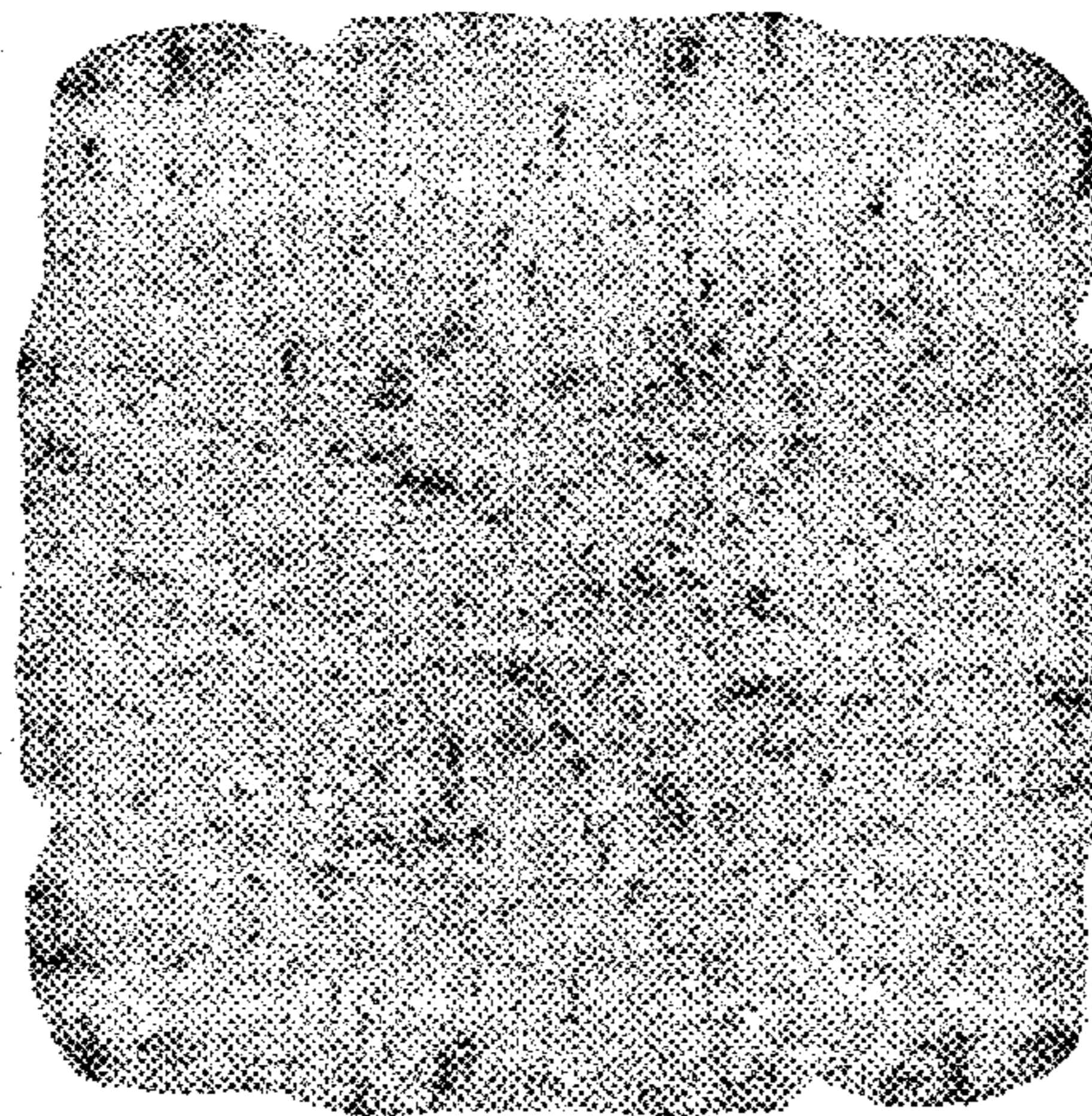
(57) **CLAIM**

The ornamental design for a pizza product crust with an irregularly-shaped edge, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a pizza product crust with an irregularly-shaped edge showing my new design; FIG. 2 is a top plan view thereof; FIG. 3 is a bottom plan view thereof; and, FIG. 4 is a side elevational view thereof.

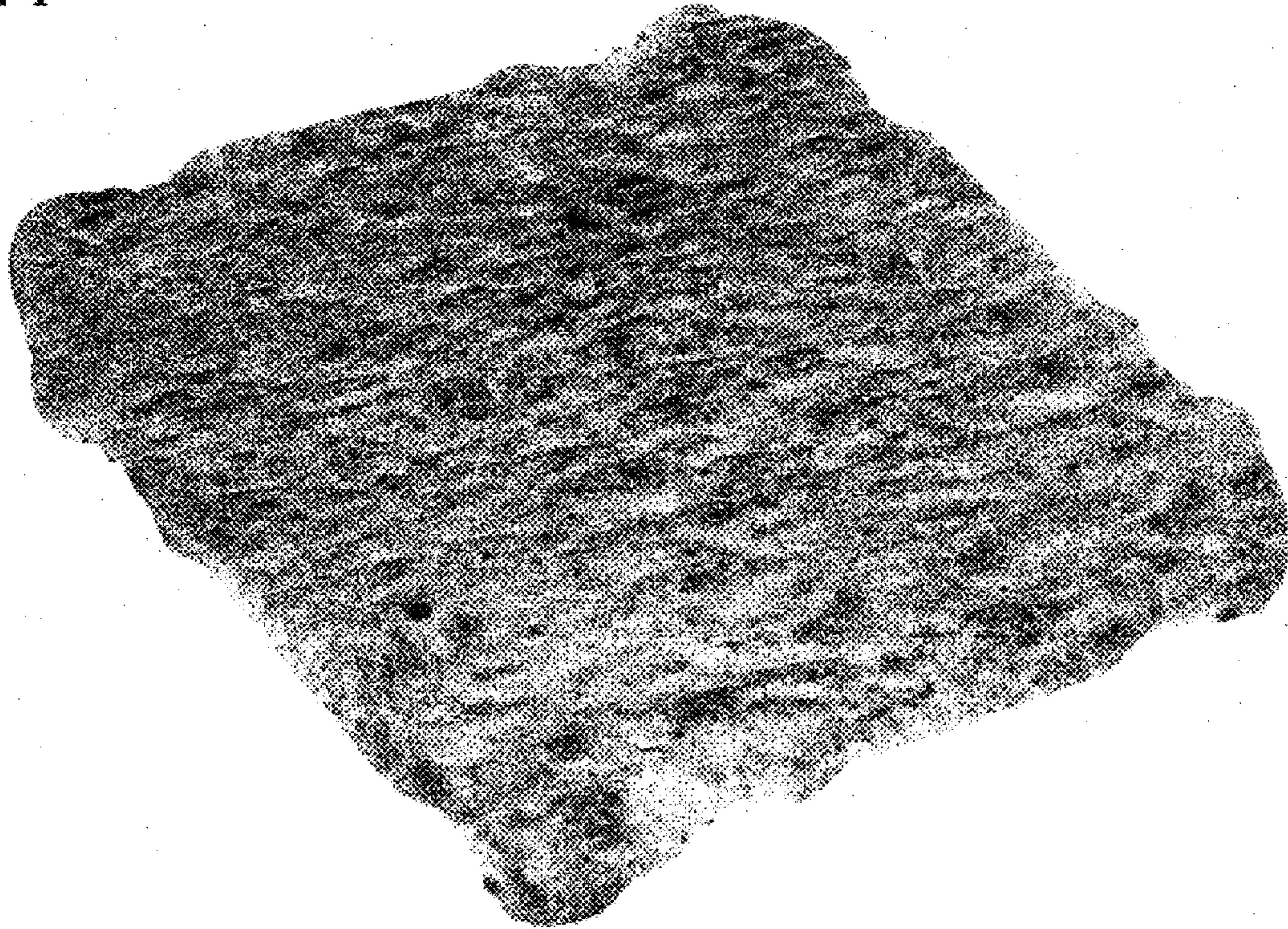

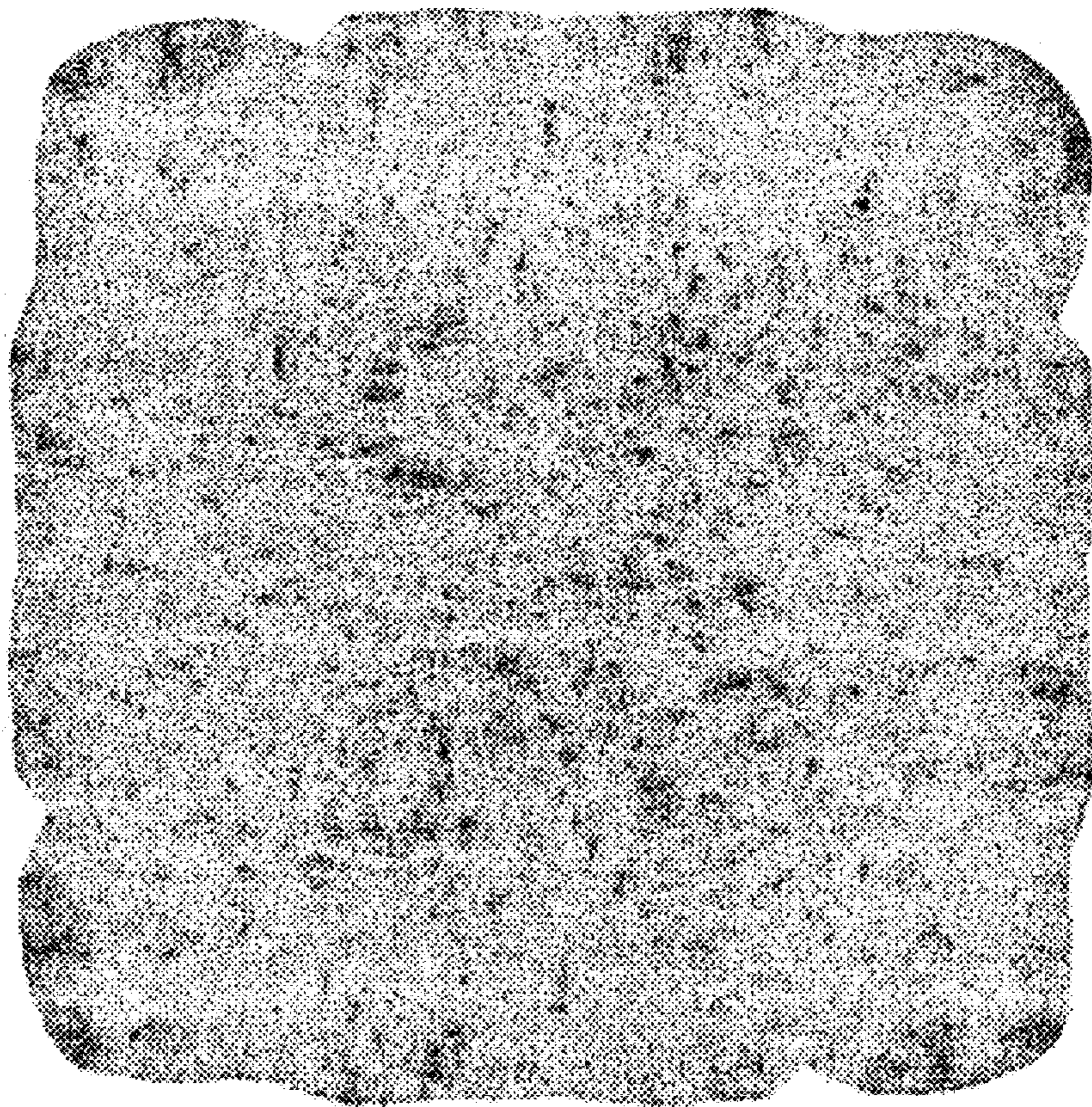

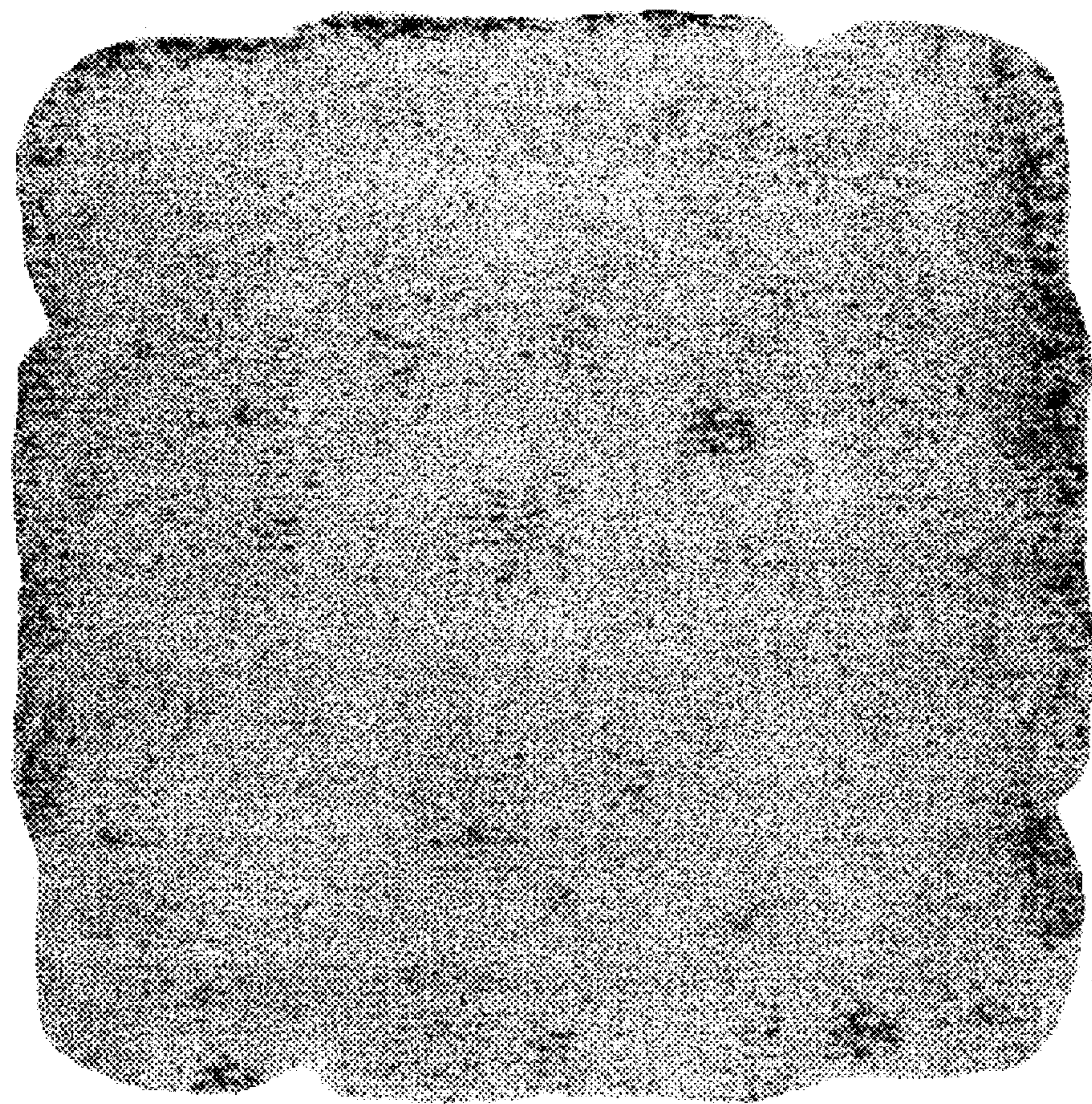
