FIG. 3 is a bottom plan view of the visored cap design of FIG. 1;

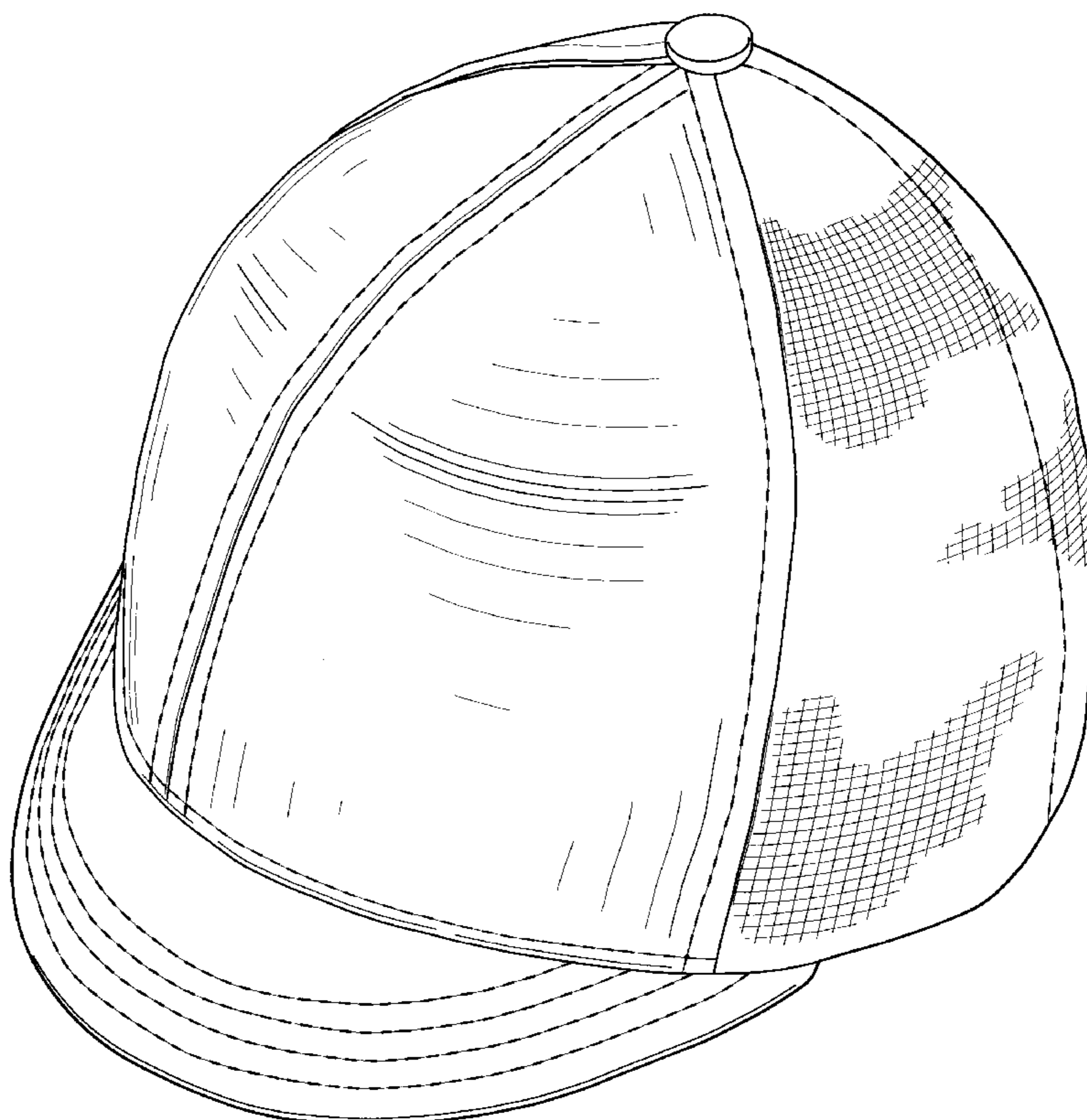
FIG. 4 is a front elevation view of the visored cap design of FIG. 1;

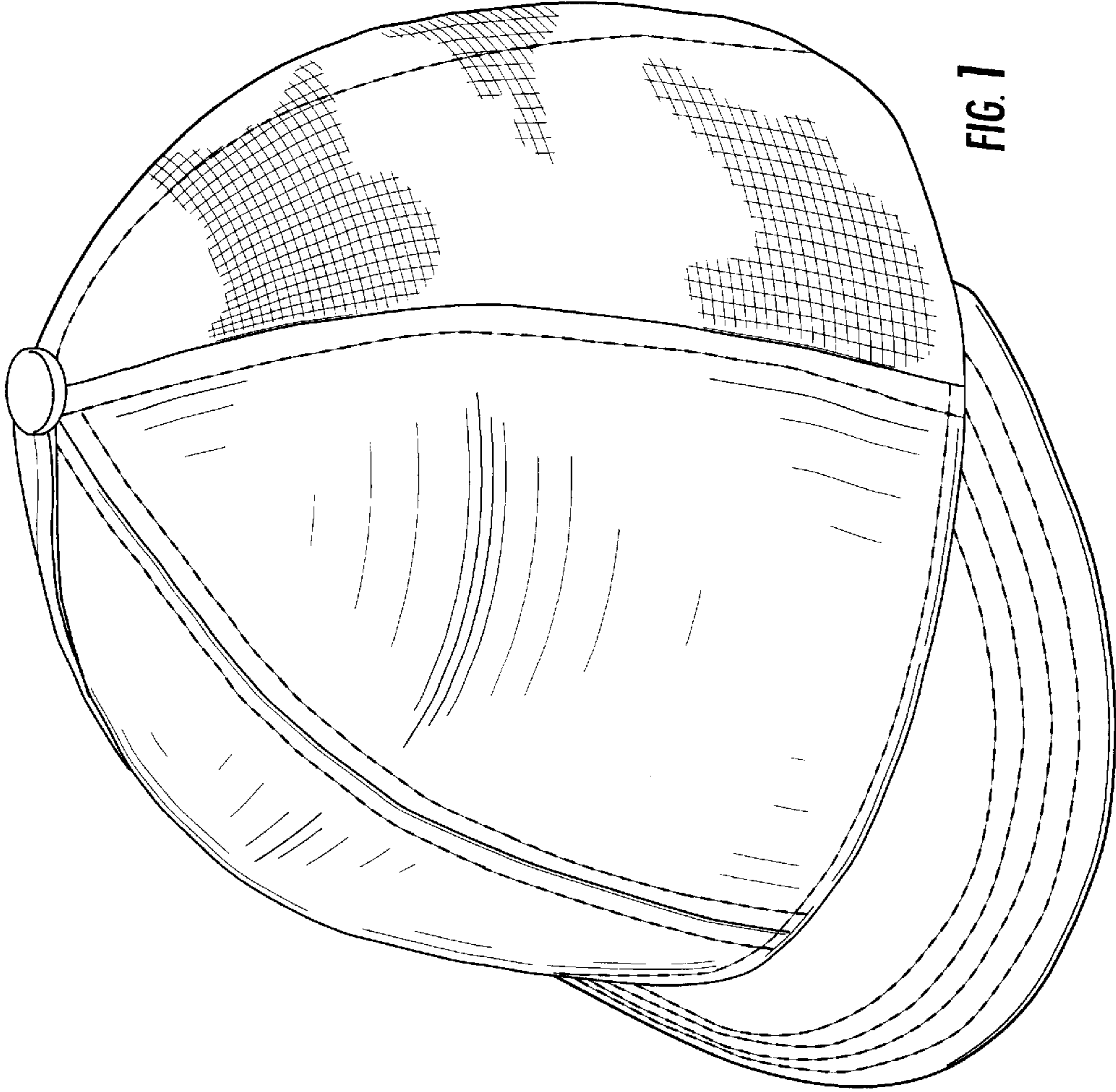

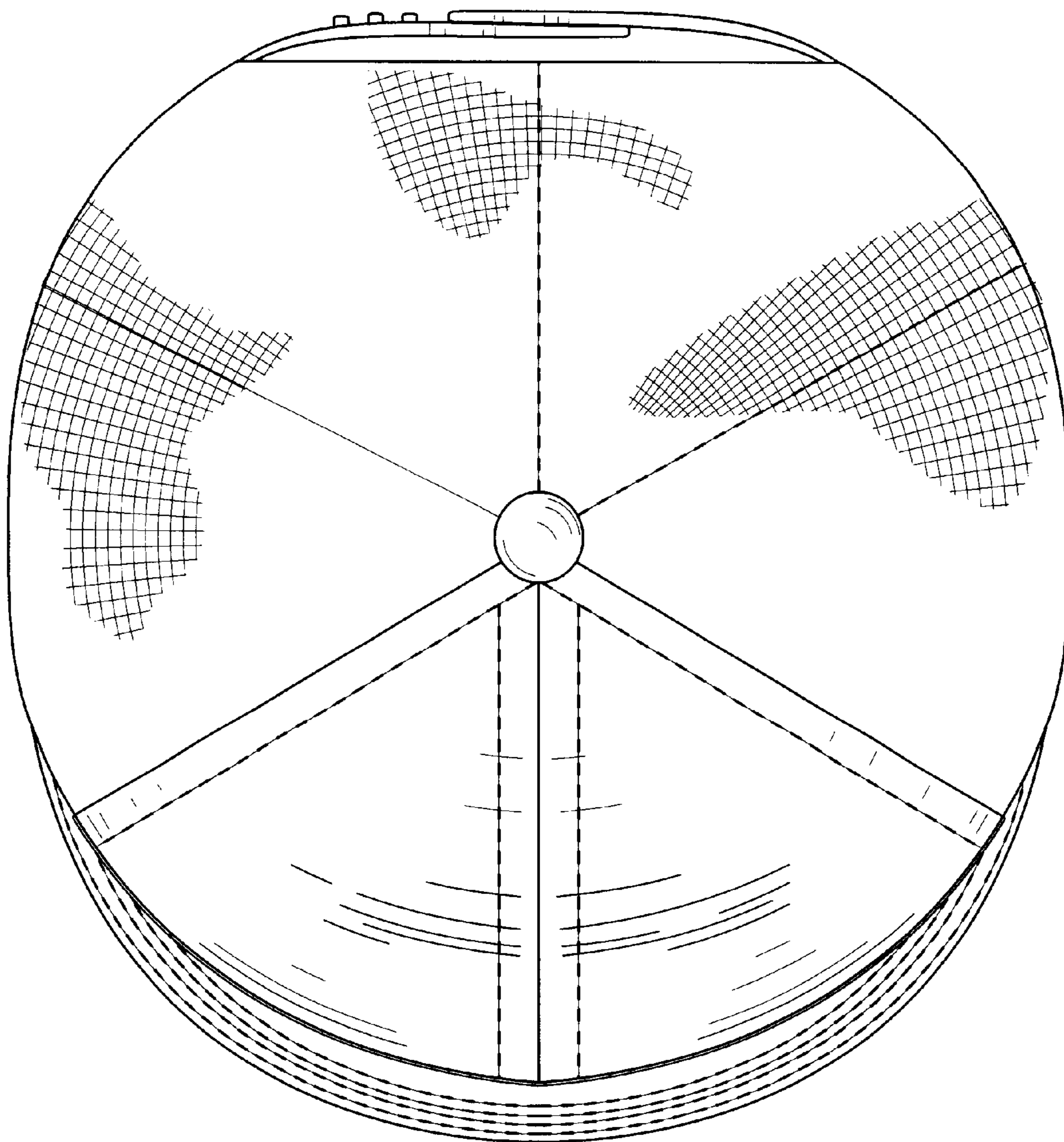

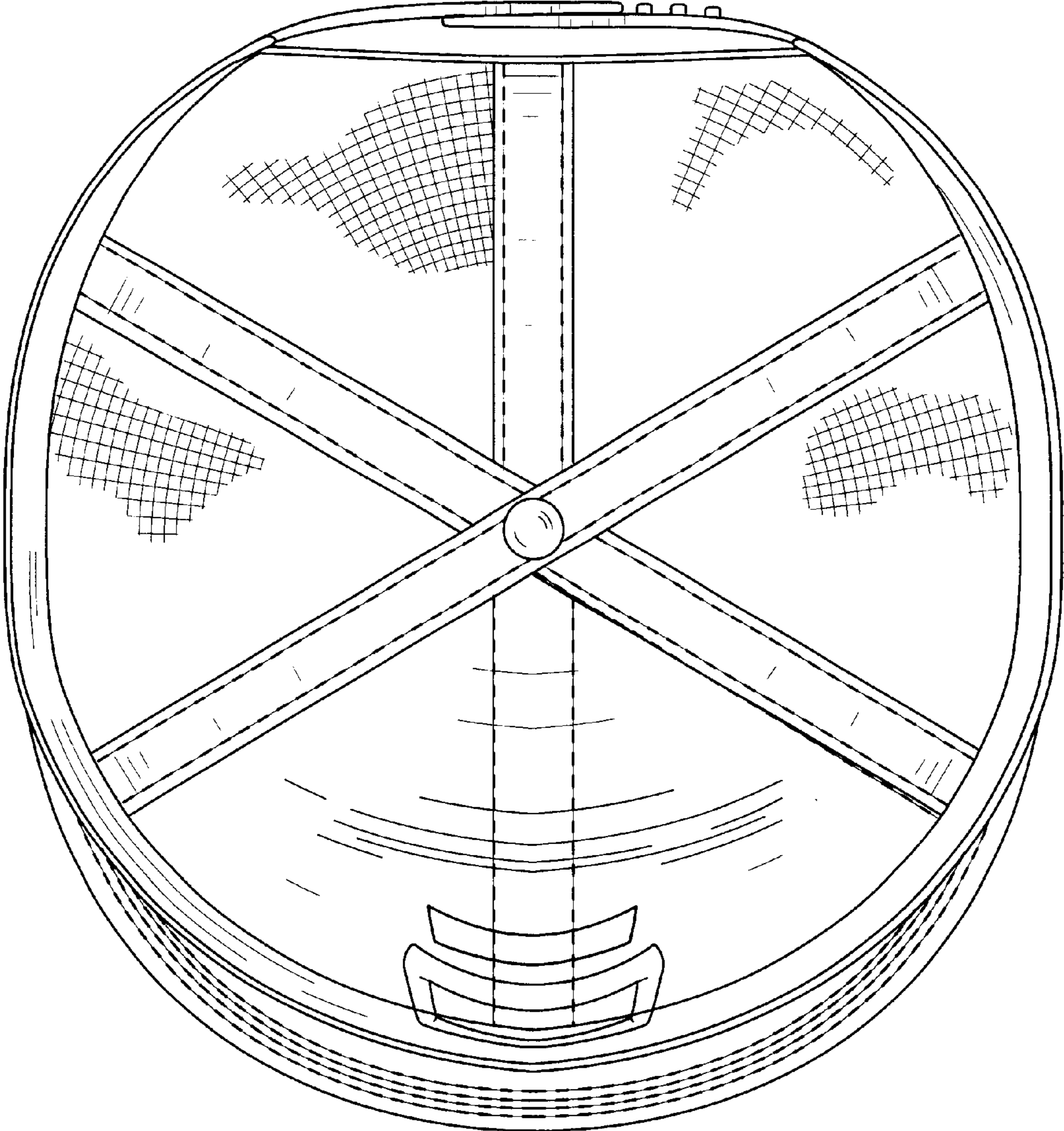

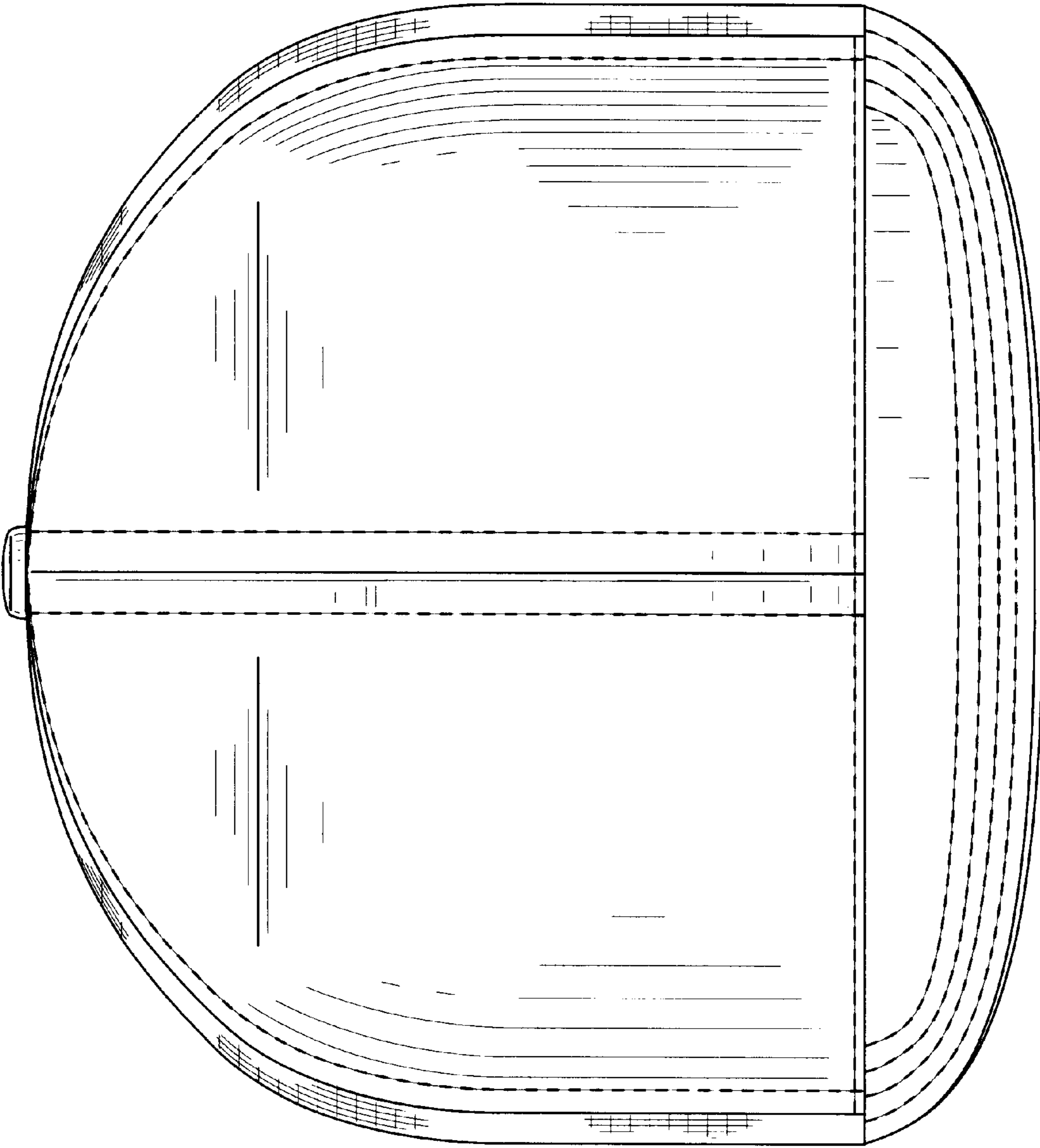

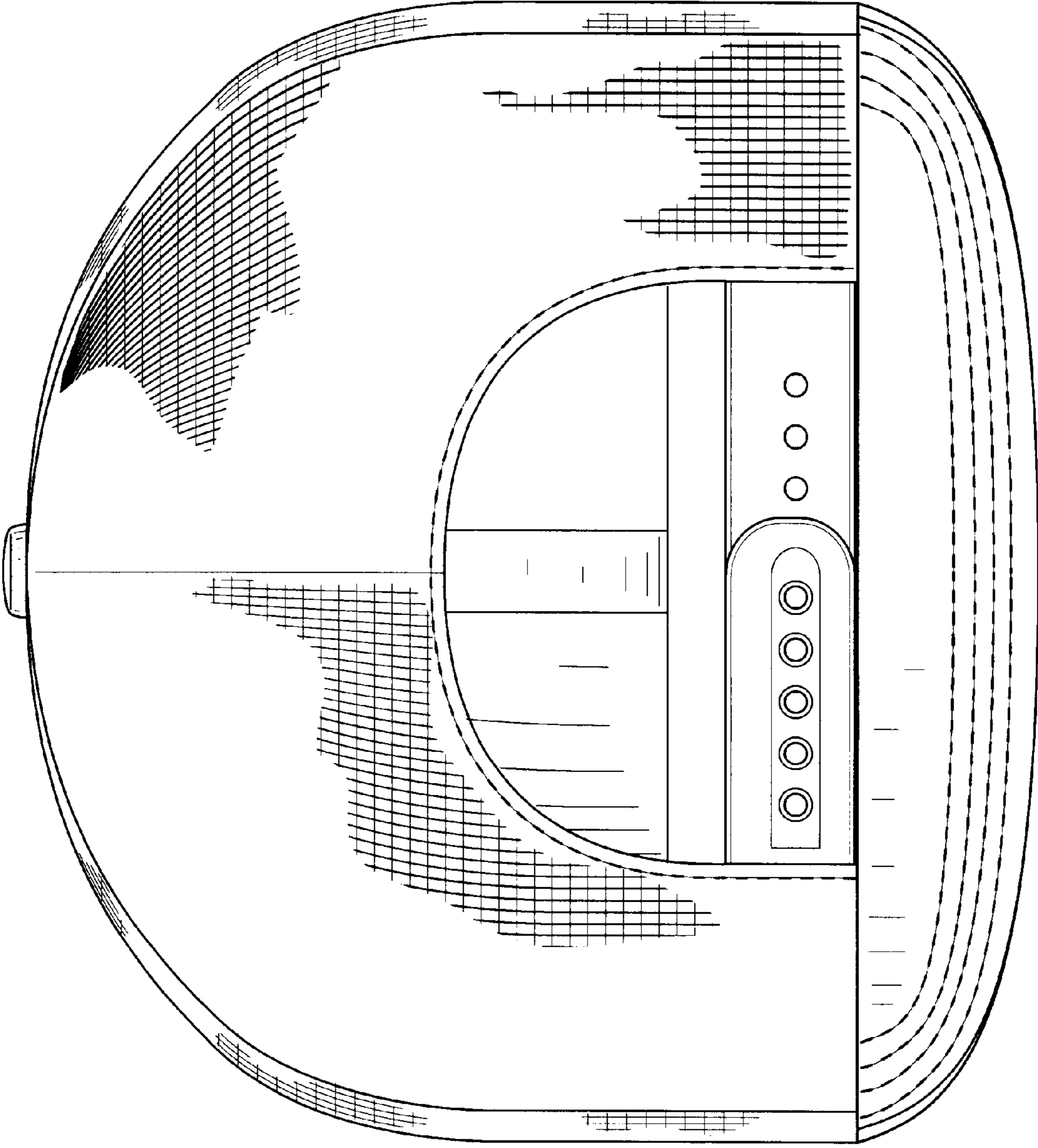

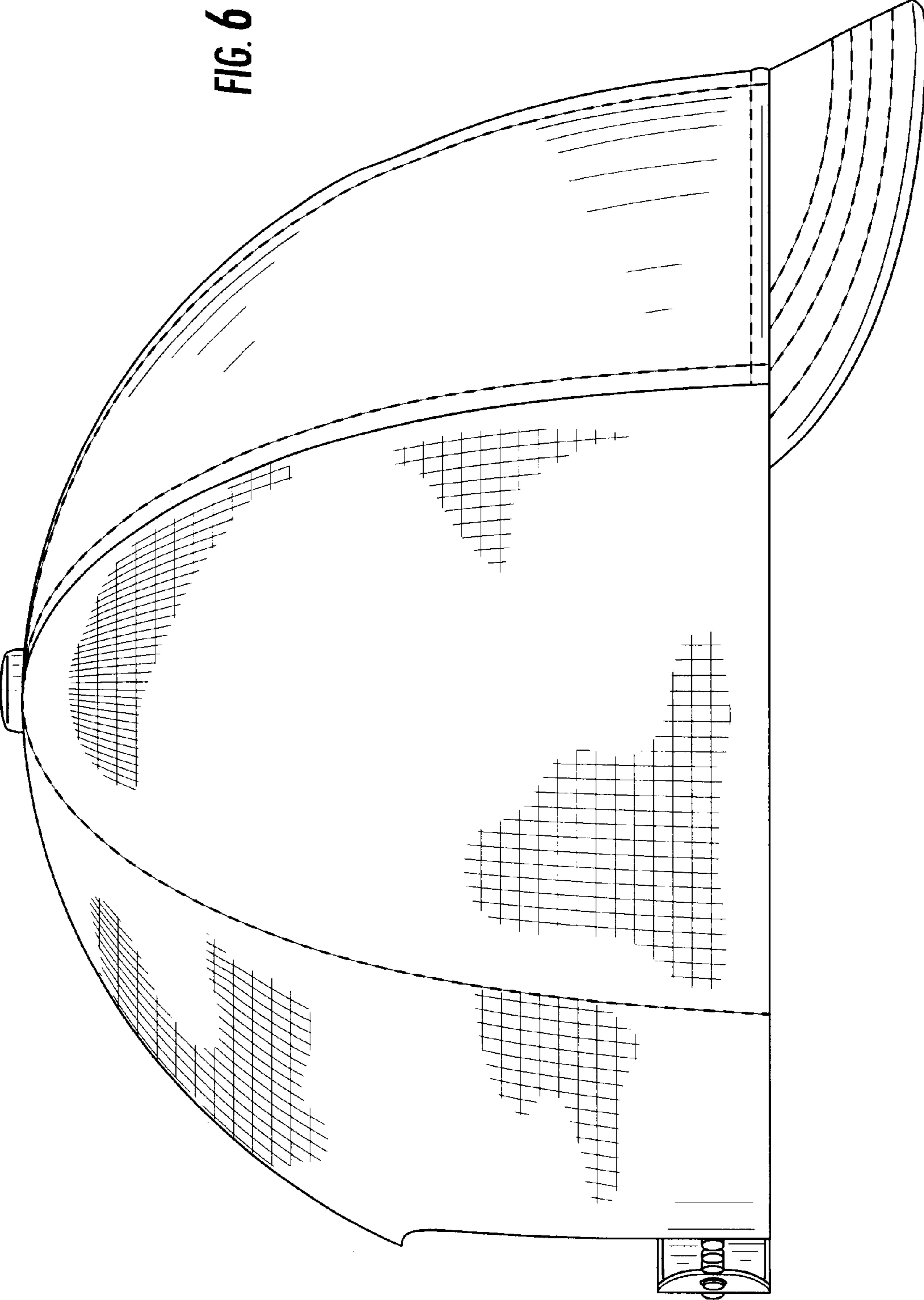
