(57) **CLAIM**

The ornamental design for a portion of a shoe upper, as
shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a portion of a shoe upper
showing my new design;

FIG. 2 is a side view of the portion of a shoe upper shown
in FIG. 1;

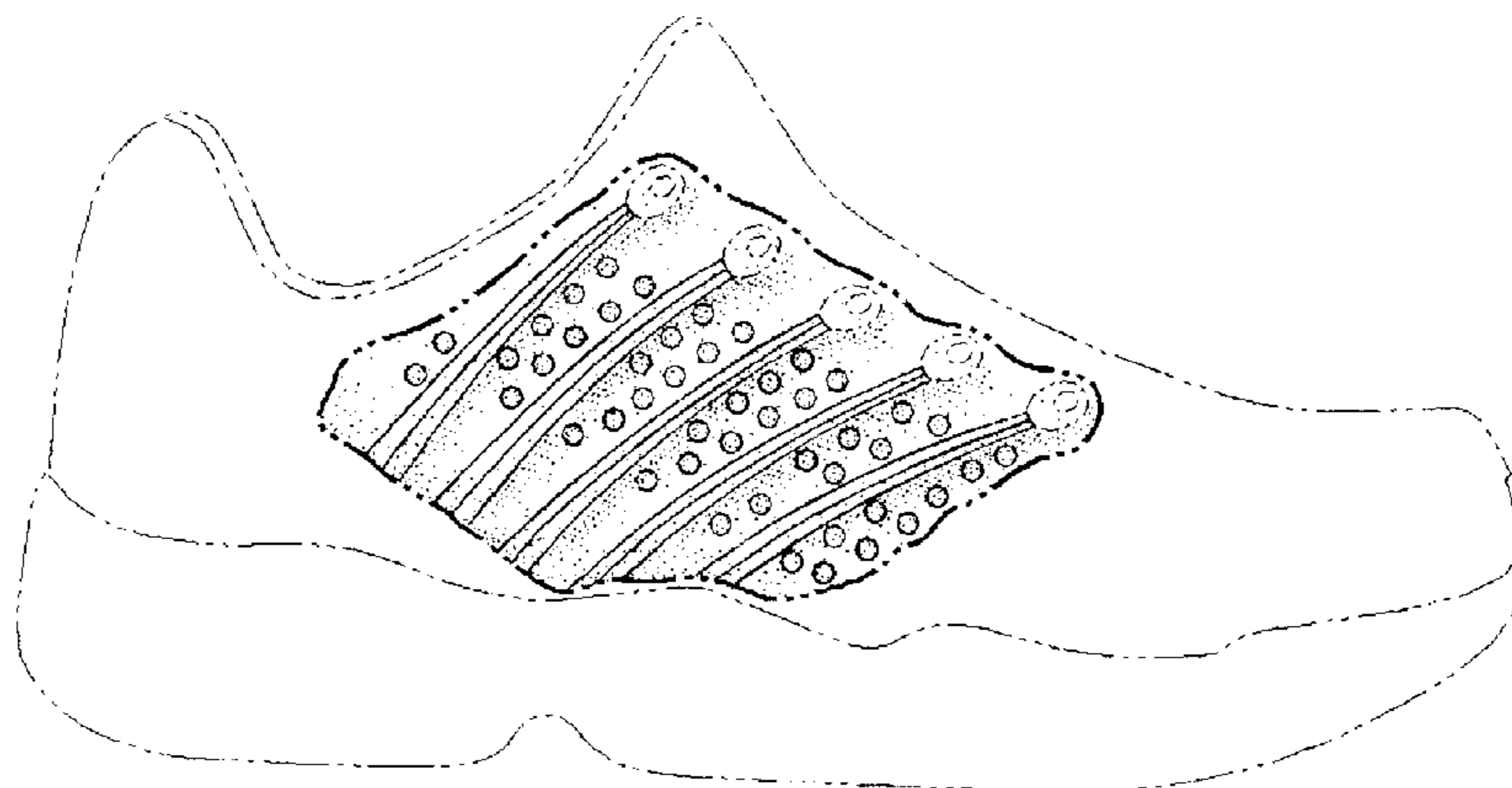
FIG. 3 is a front view of the portion of a shoe upper shown

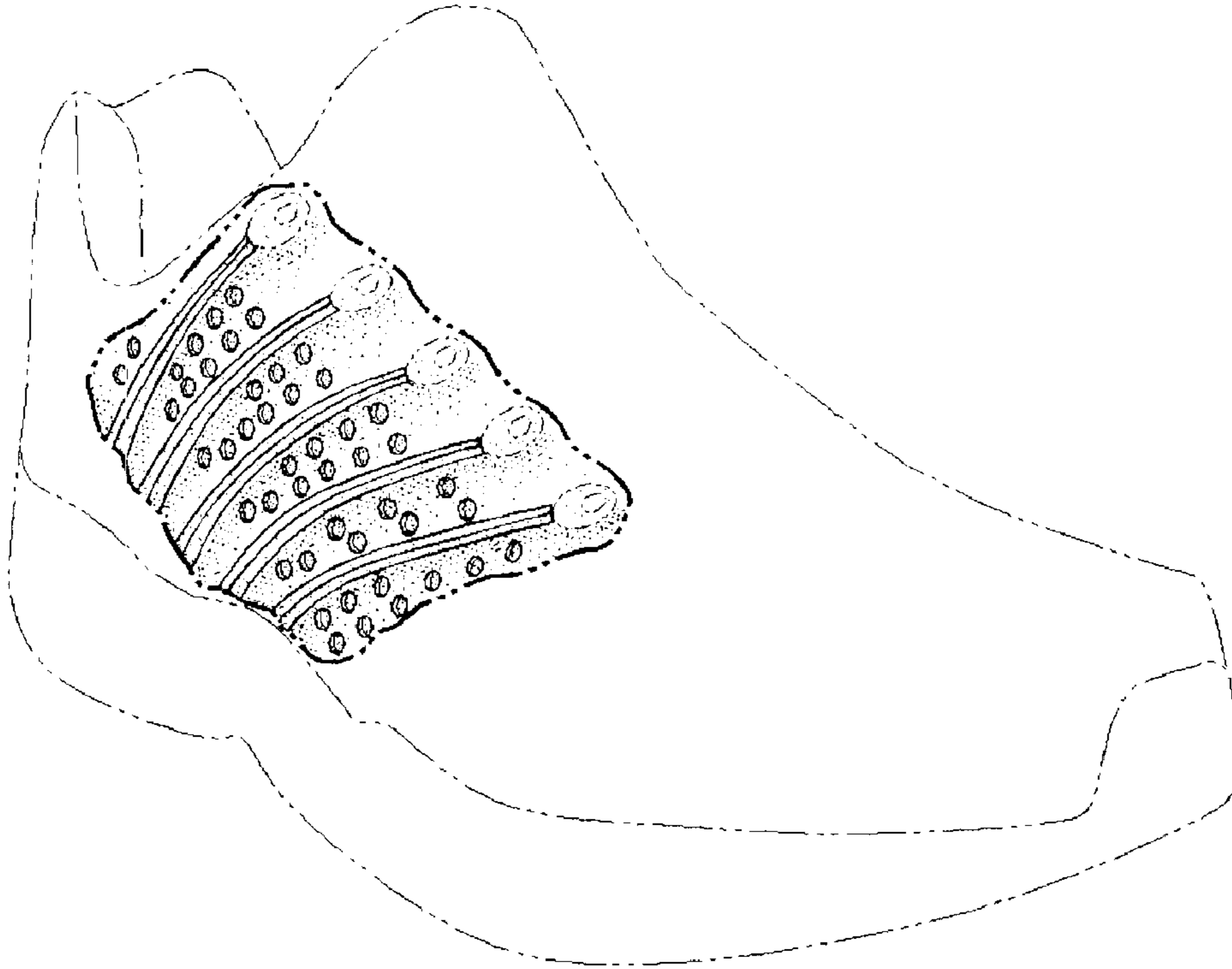

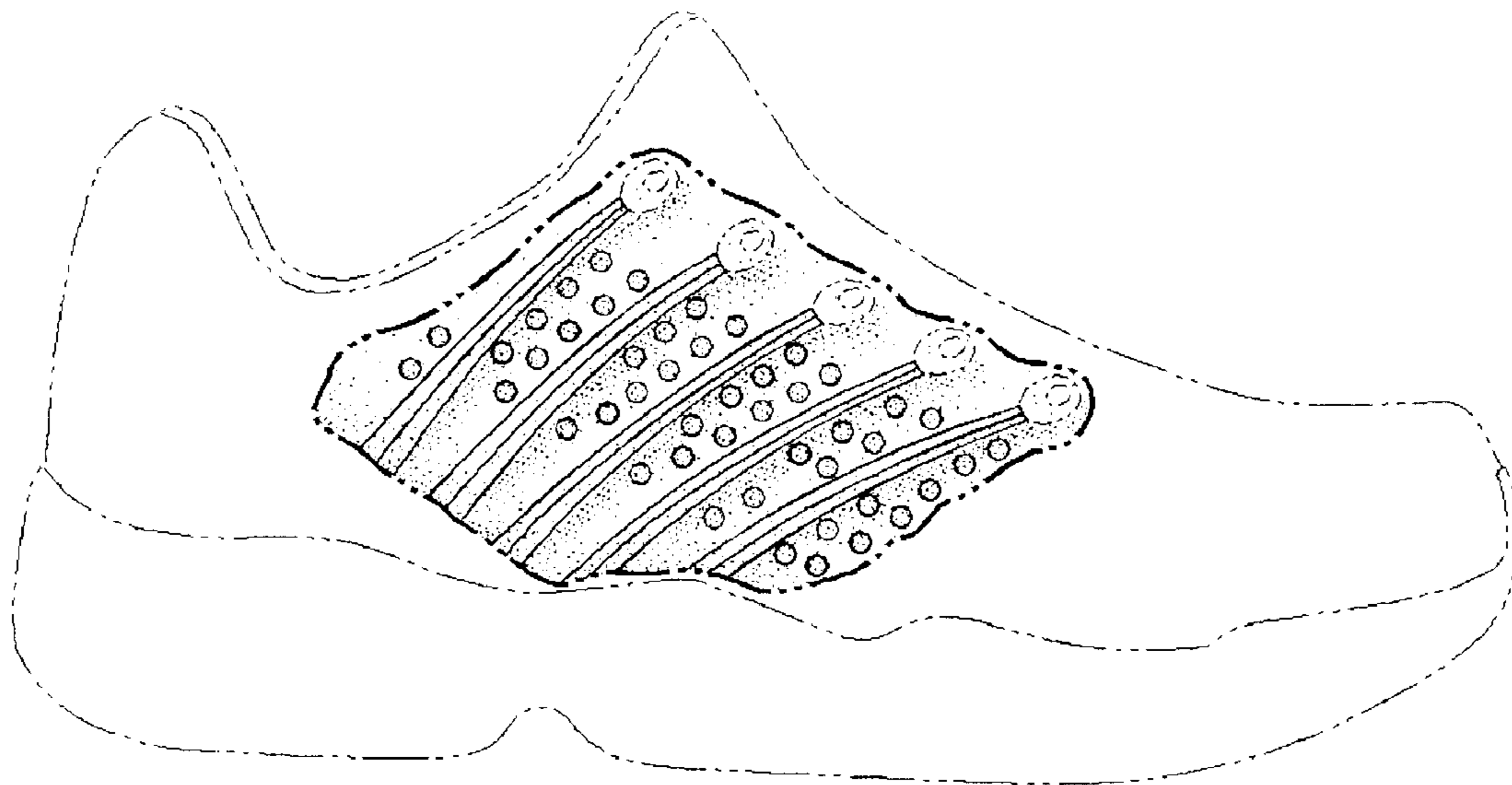

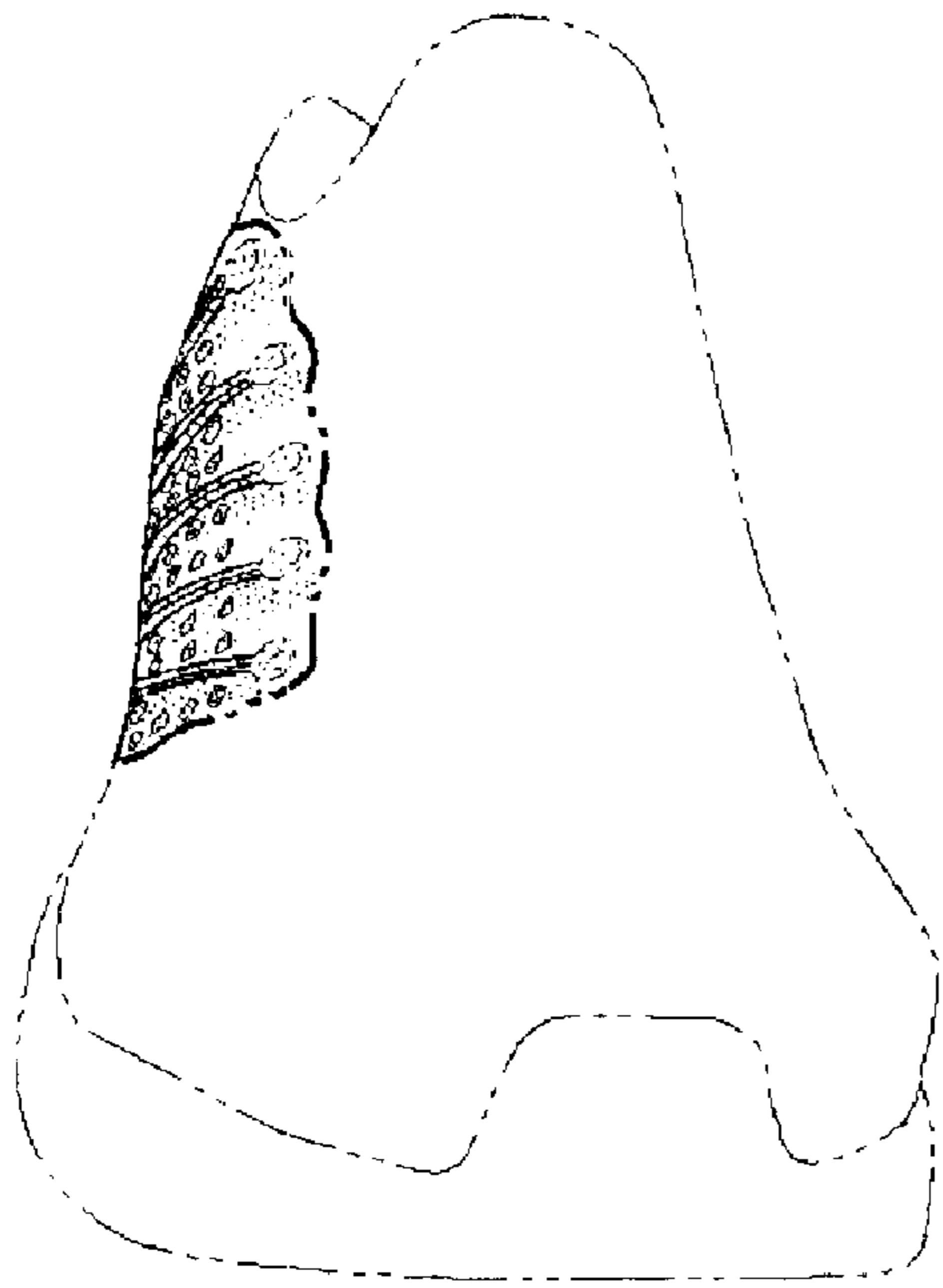

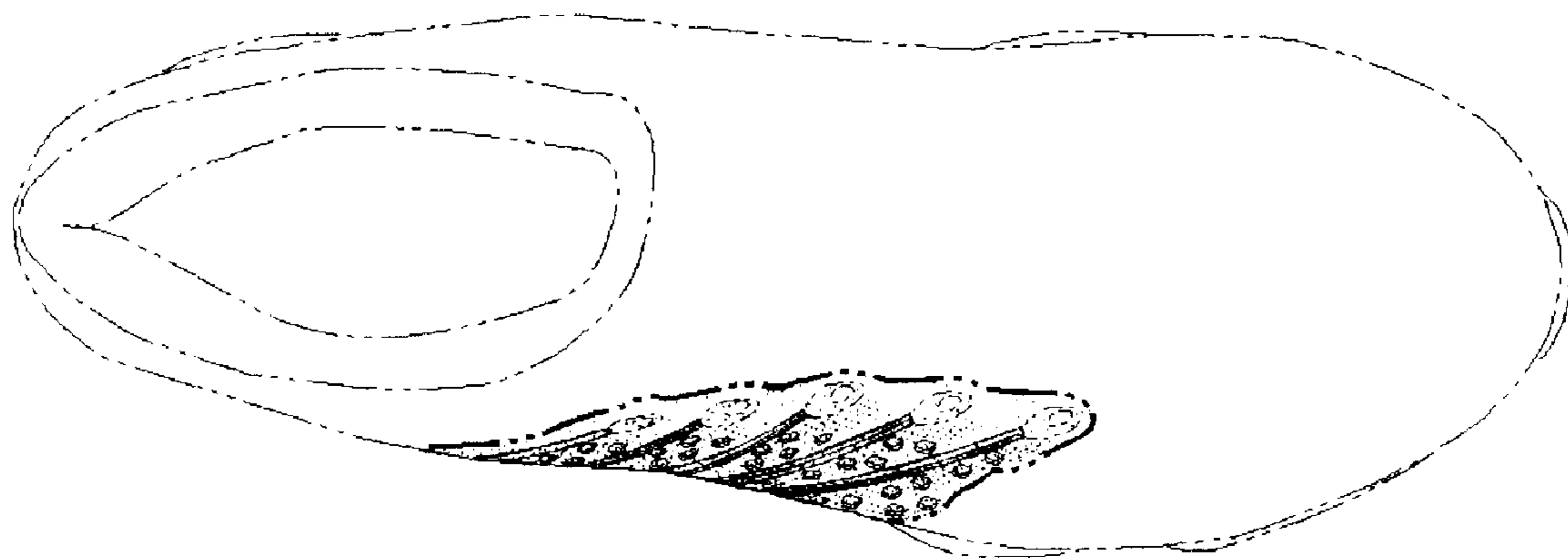
