The ornamental design for a portion of a shoe upper, as shown and described.

DESCRIPTION

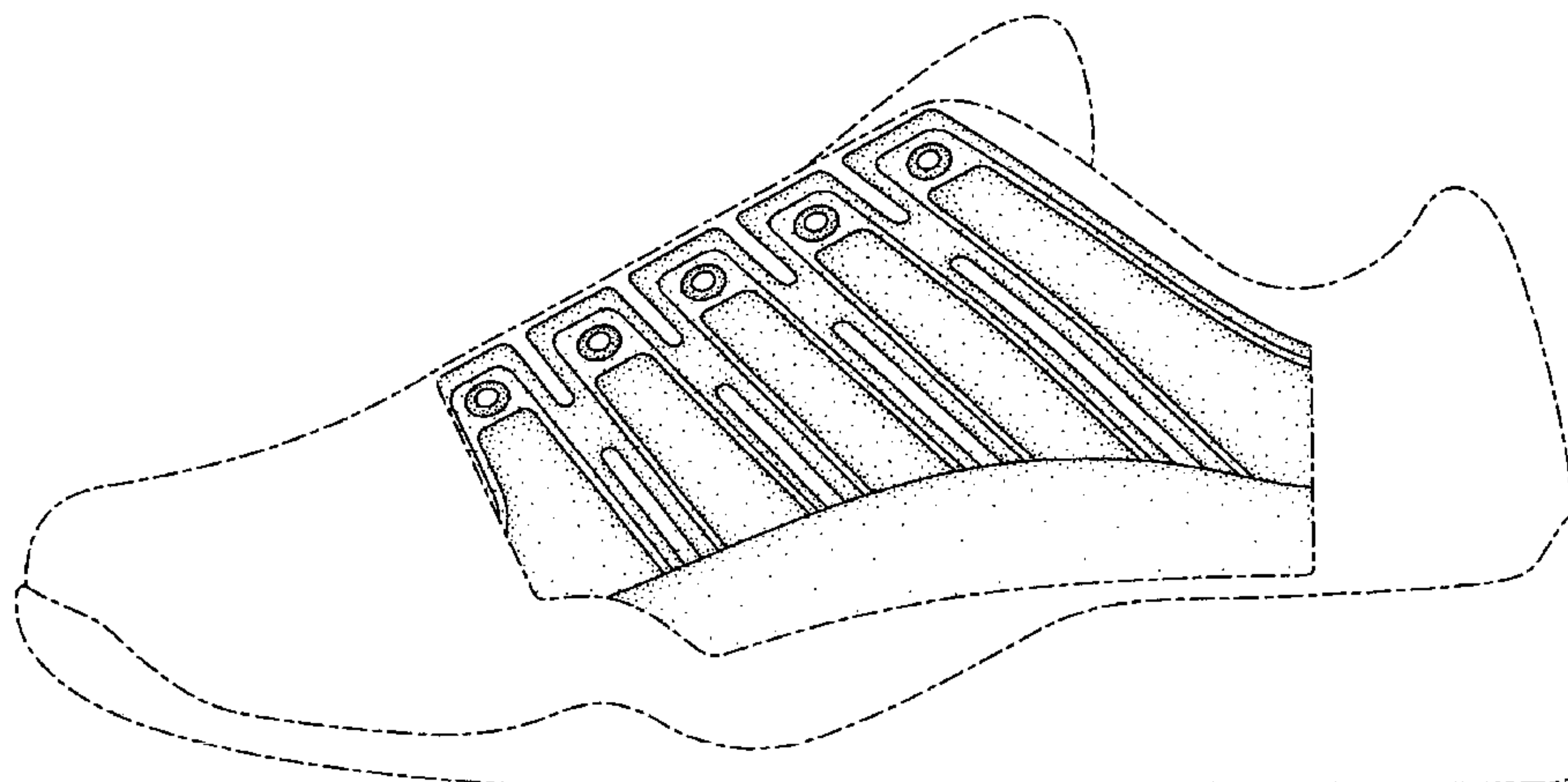
FIG. 1 is a front perspective view of a portion of a shoe upper showing my new design;

FIG. 2 is a rear perspective view thereof; and,

FIG. 3 is a side elevational view of one side thereof.

The uneven broken lines immediately adjacent to the shaded area represent unclaimed boundaries of the design. The unshaded circular shaped areas within the eyelet features are for illustrative purposes only and form no part of the claimed design. The broken line showing of the remainder of the shoe upper and the shoe sole is for illustrative purposes only and forms no part of the claimed design.

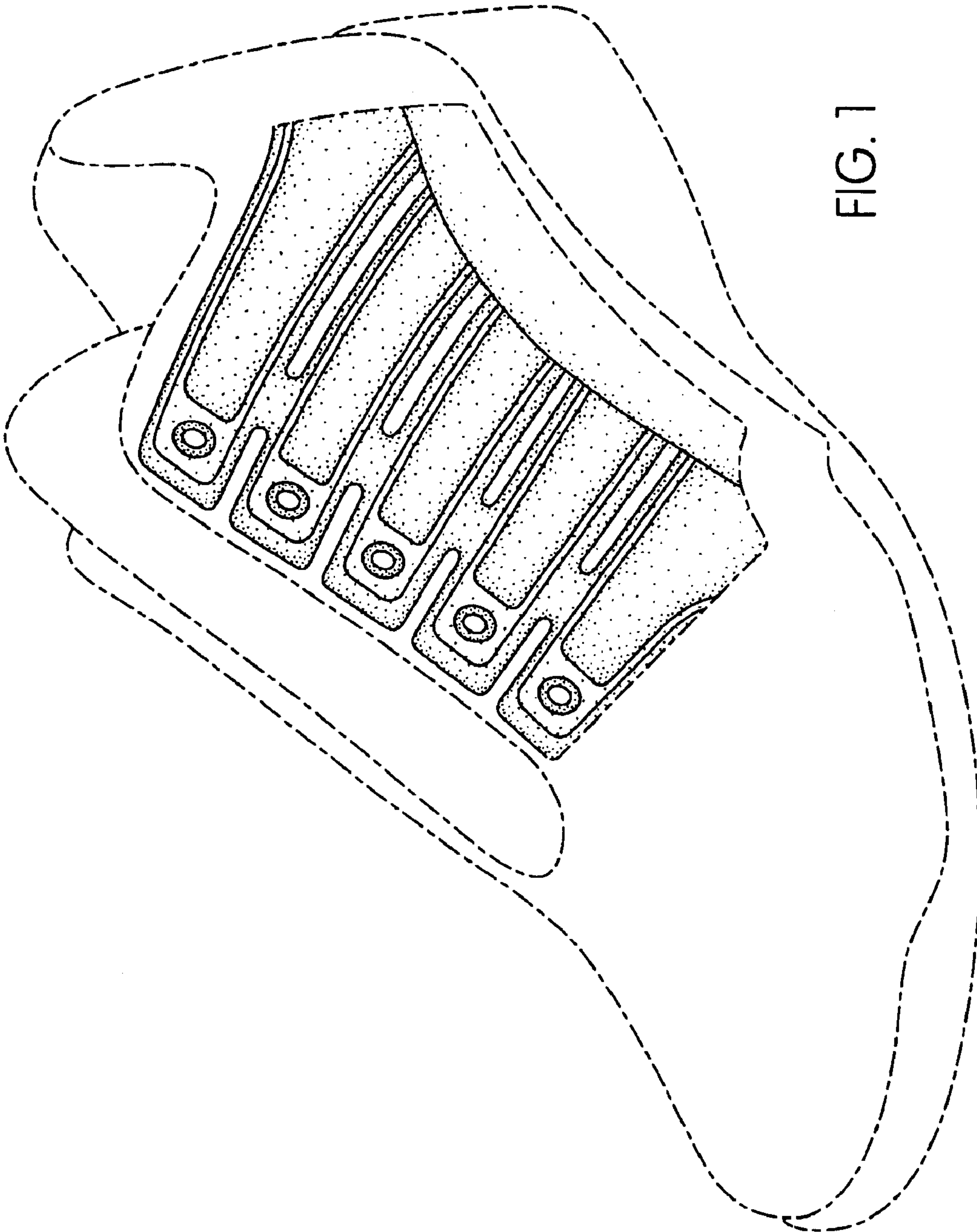

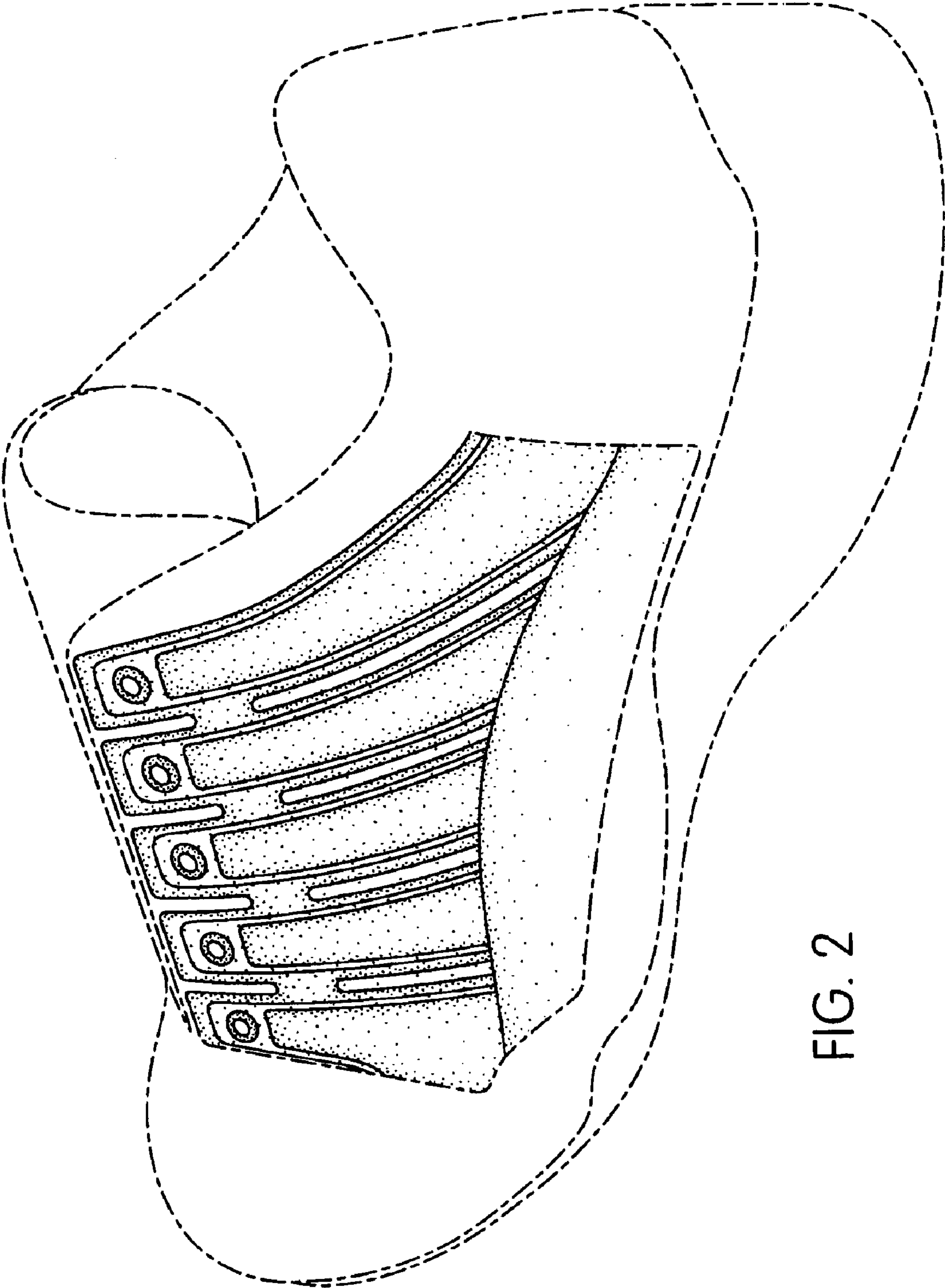

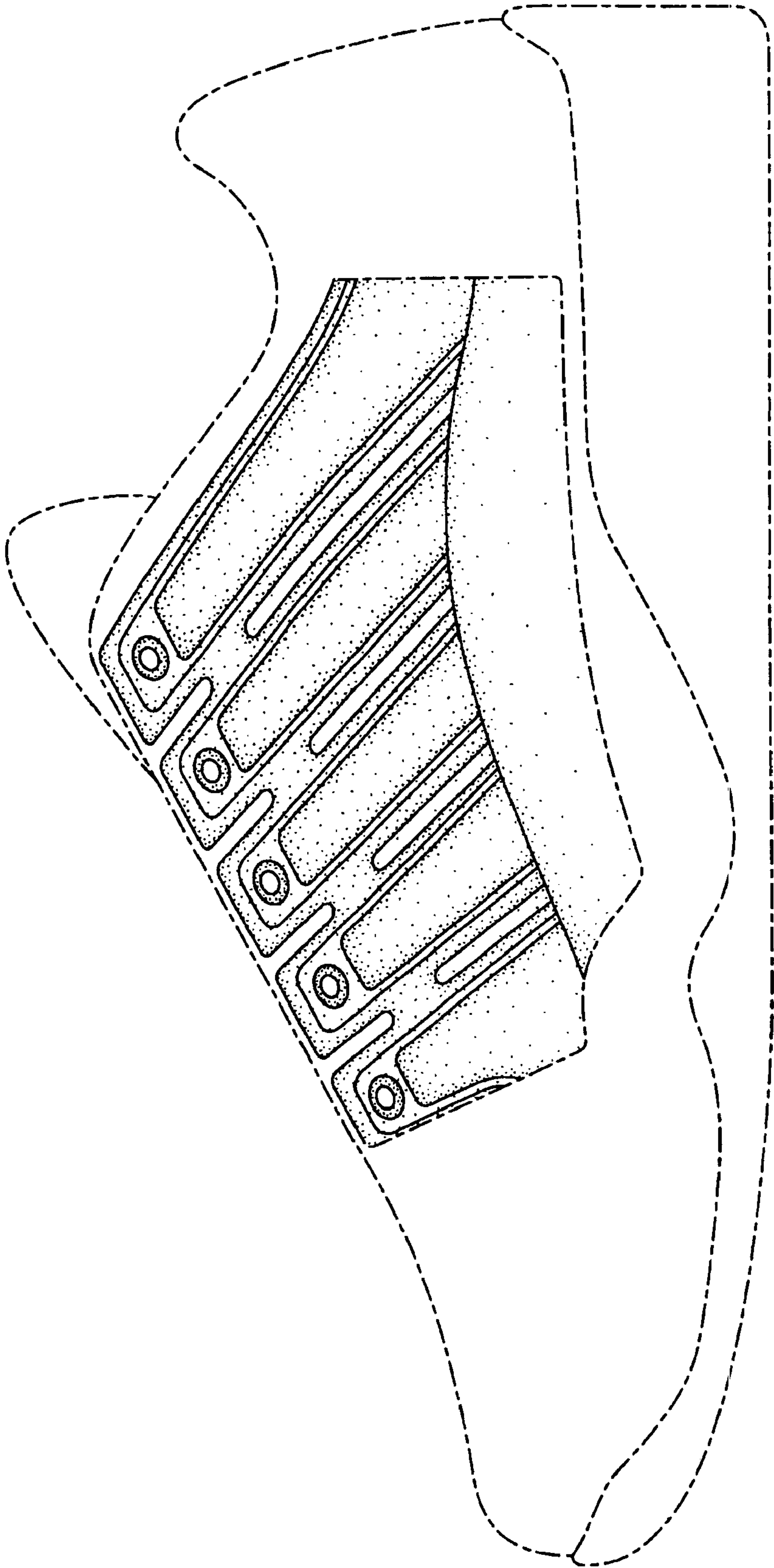
