DESCRIPTION

FIG. 1 is a front elevational view of a sofa according to an embodiment of the invention.

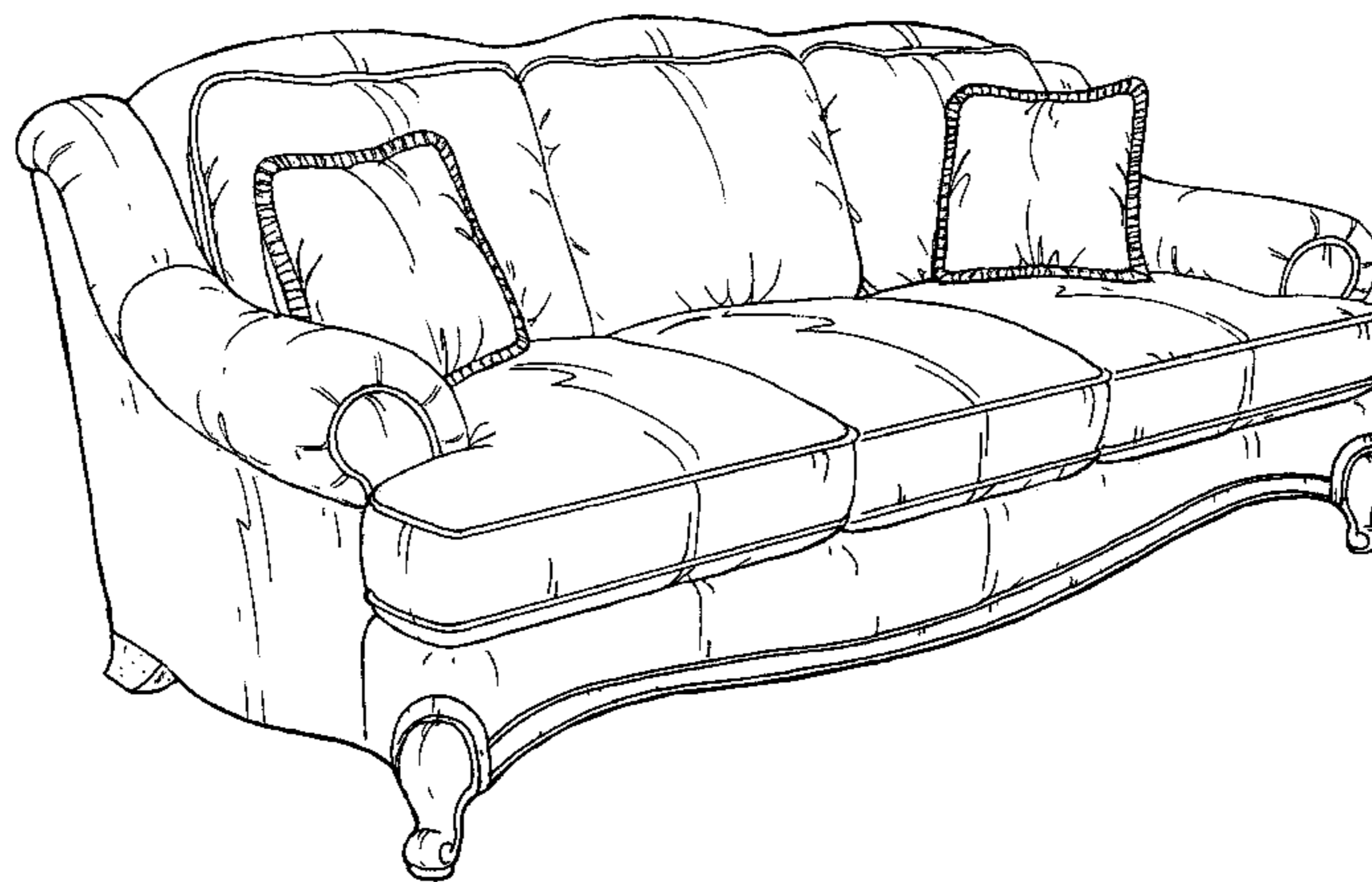
FIG. 2 is a back elevational view of a sofa according to an embodiment of the invention.

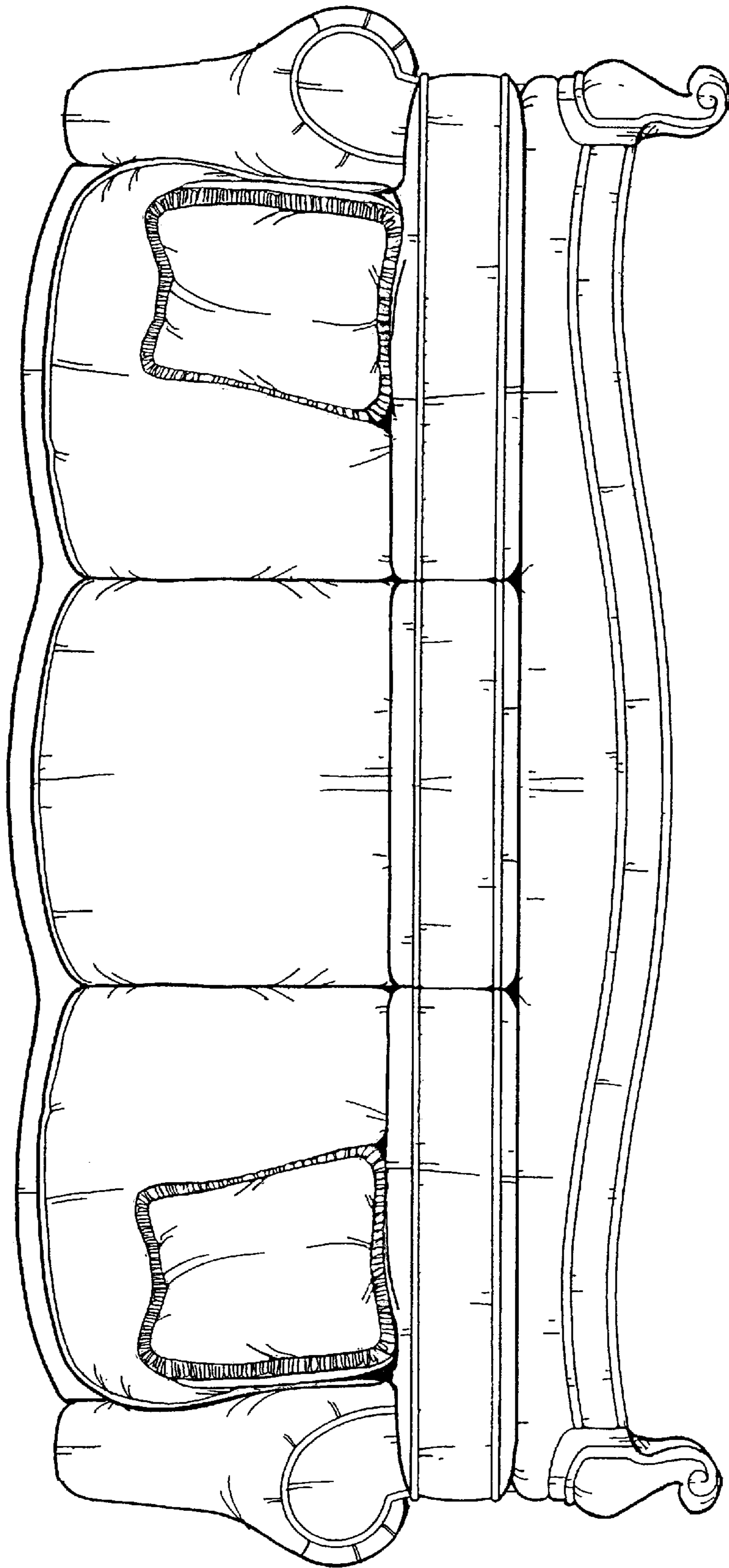

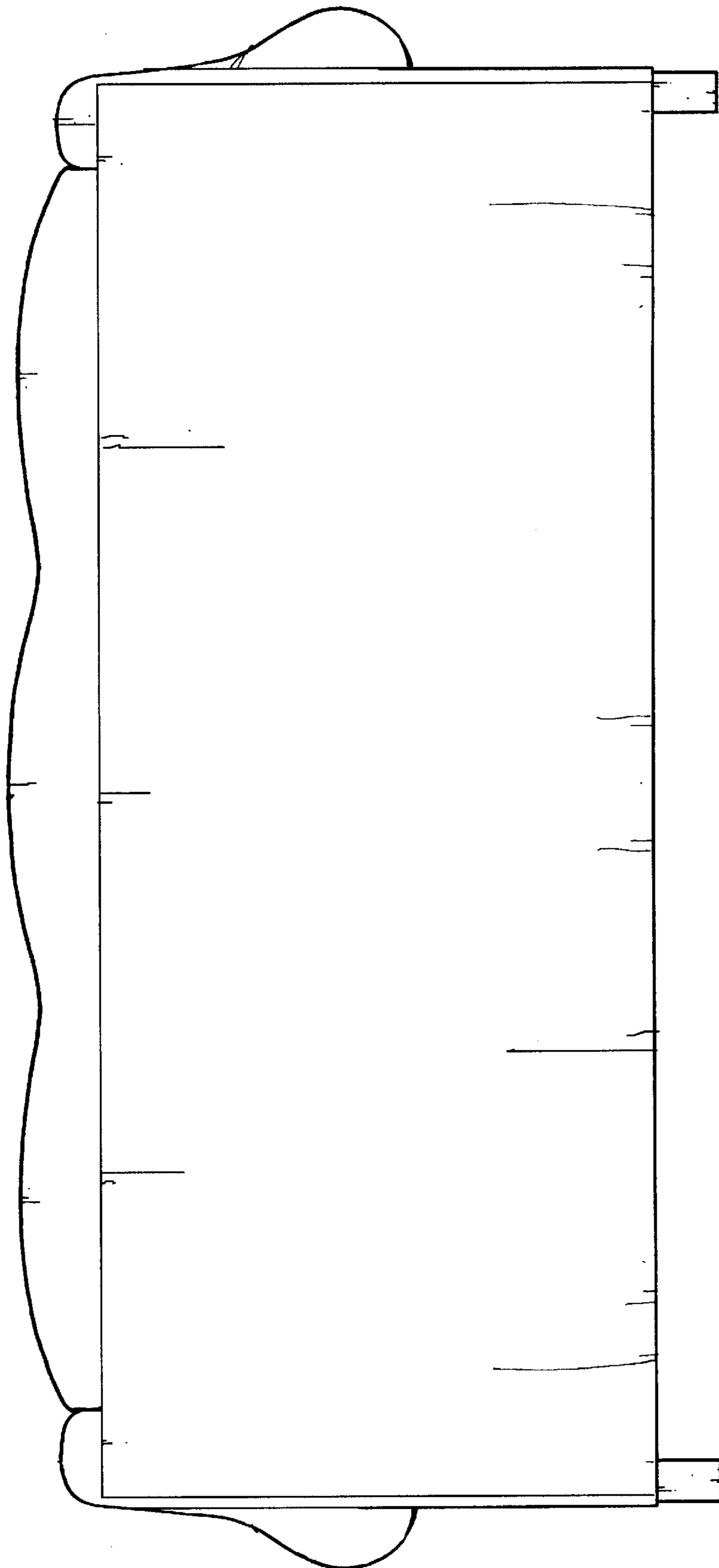

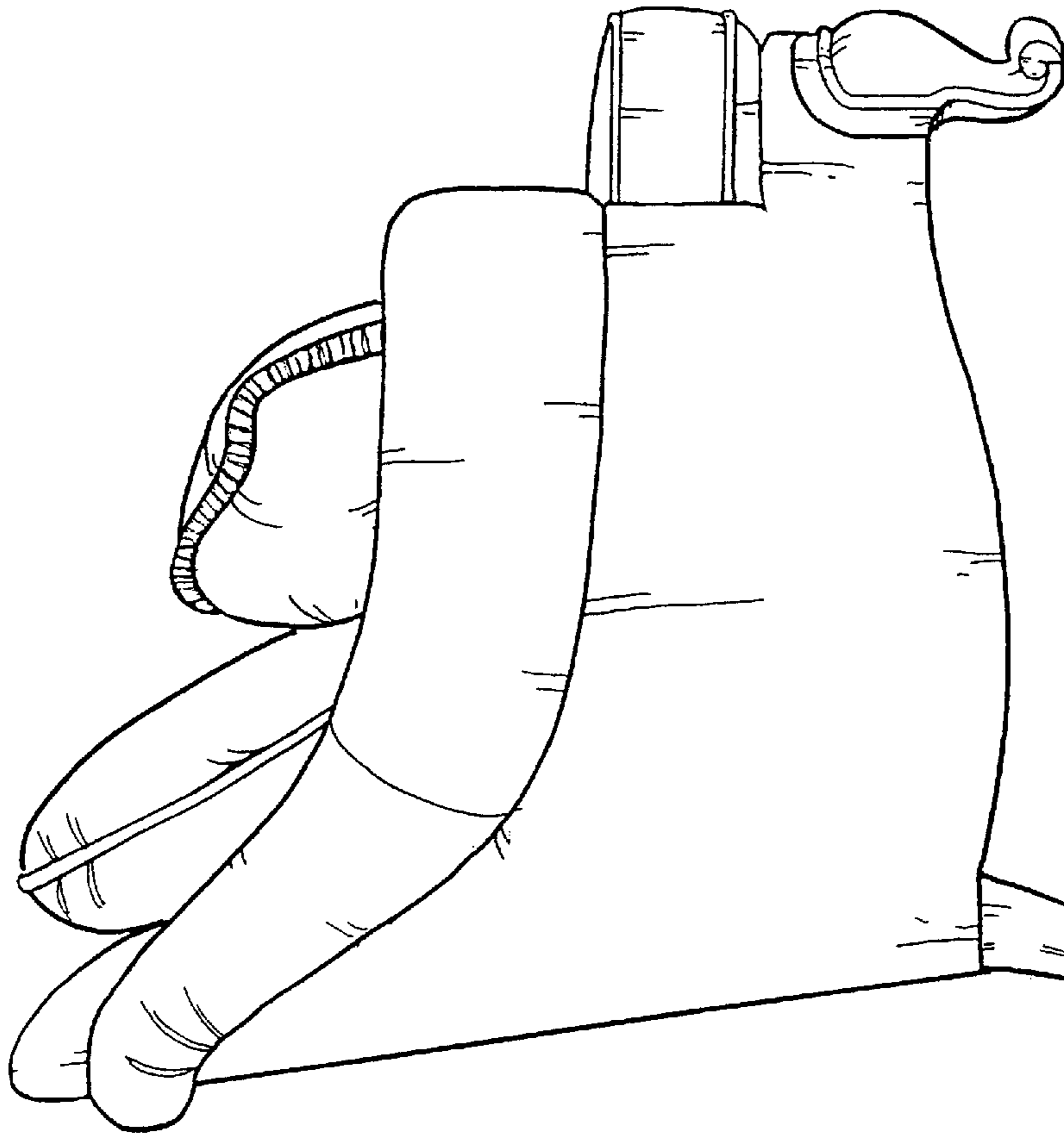

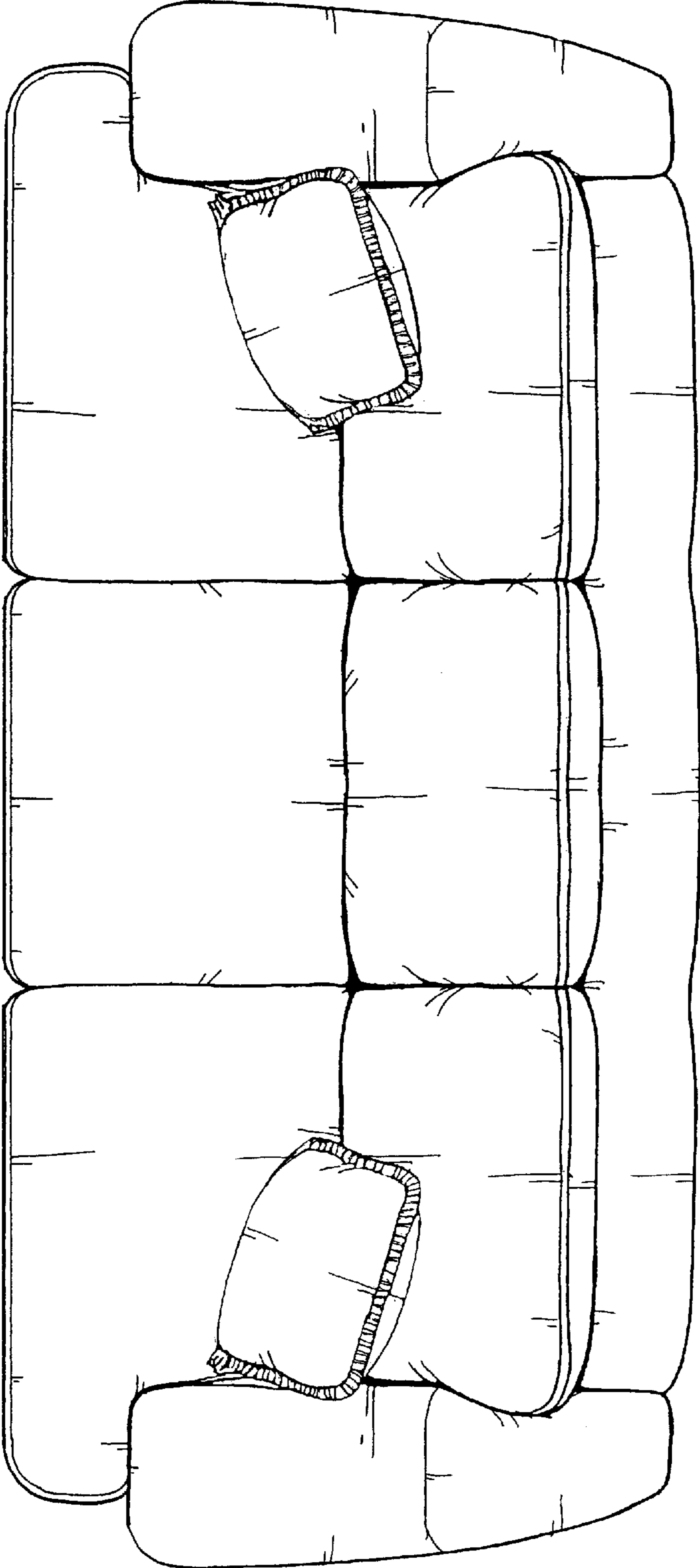

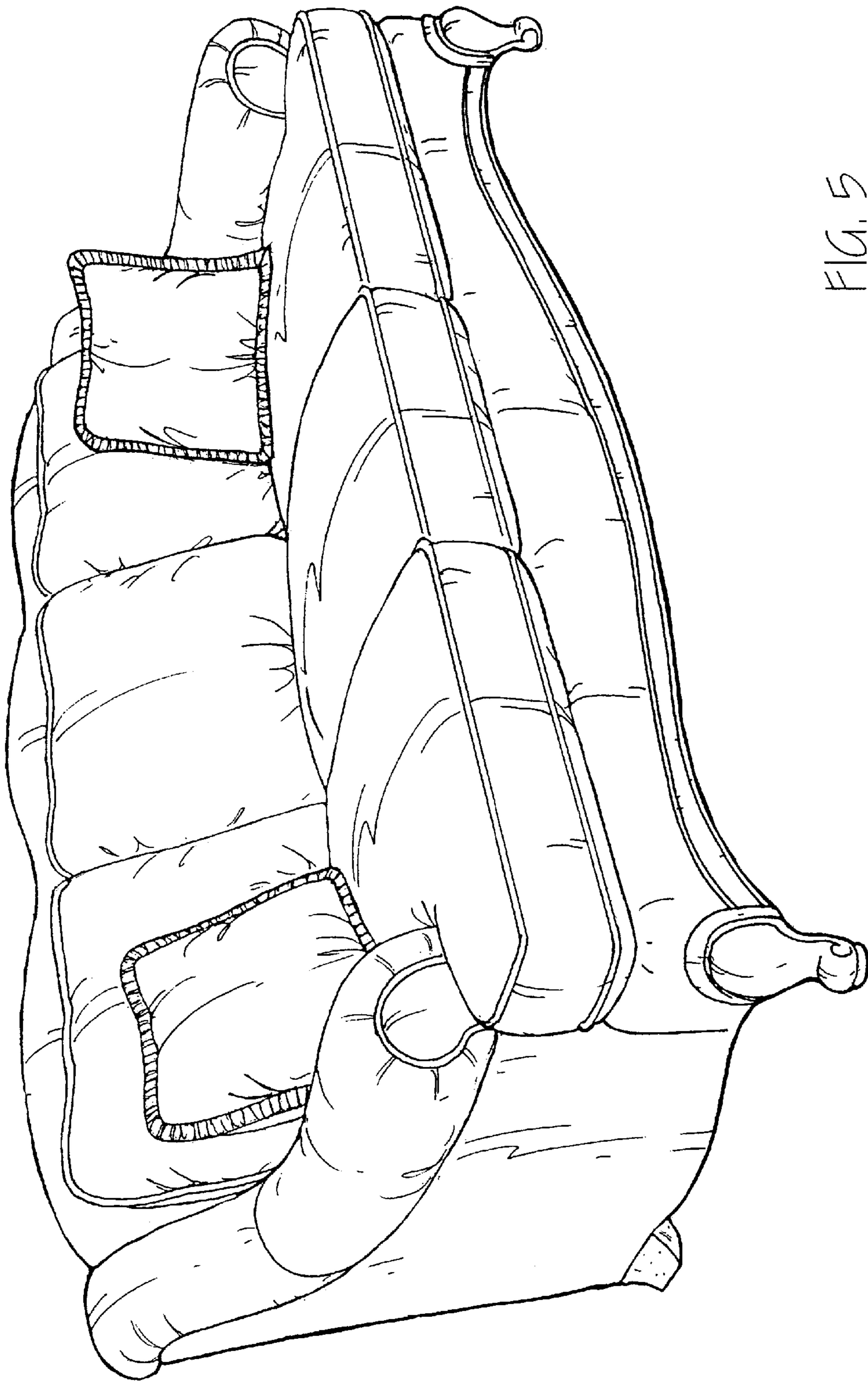
