DESCRIPTION

FIG. 1 is a front elevational view of a handle and trim
showing my new design, the undisclosed rear is not part of
the claimed design;

FIG. 2 is a side elevational view thereof, the opposite side
is a mirror image; and,

FIG. 3 is an end elevational view thereof, the opposite end
is a mirror image.

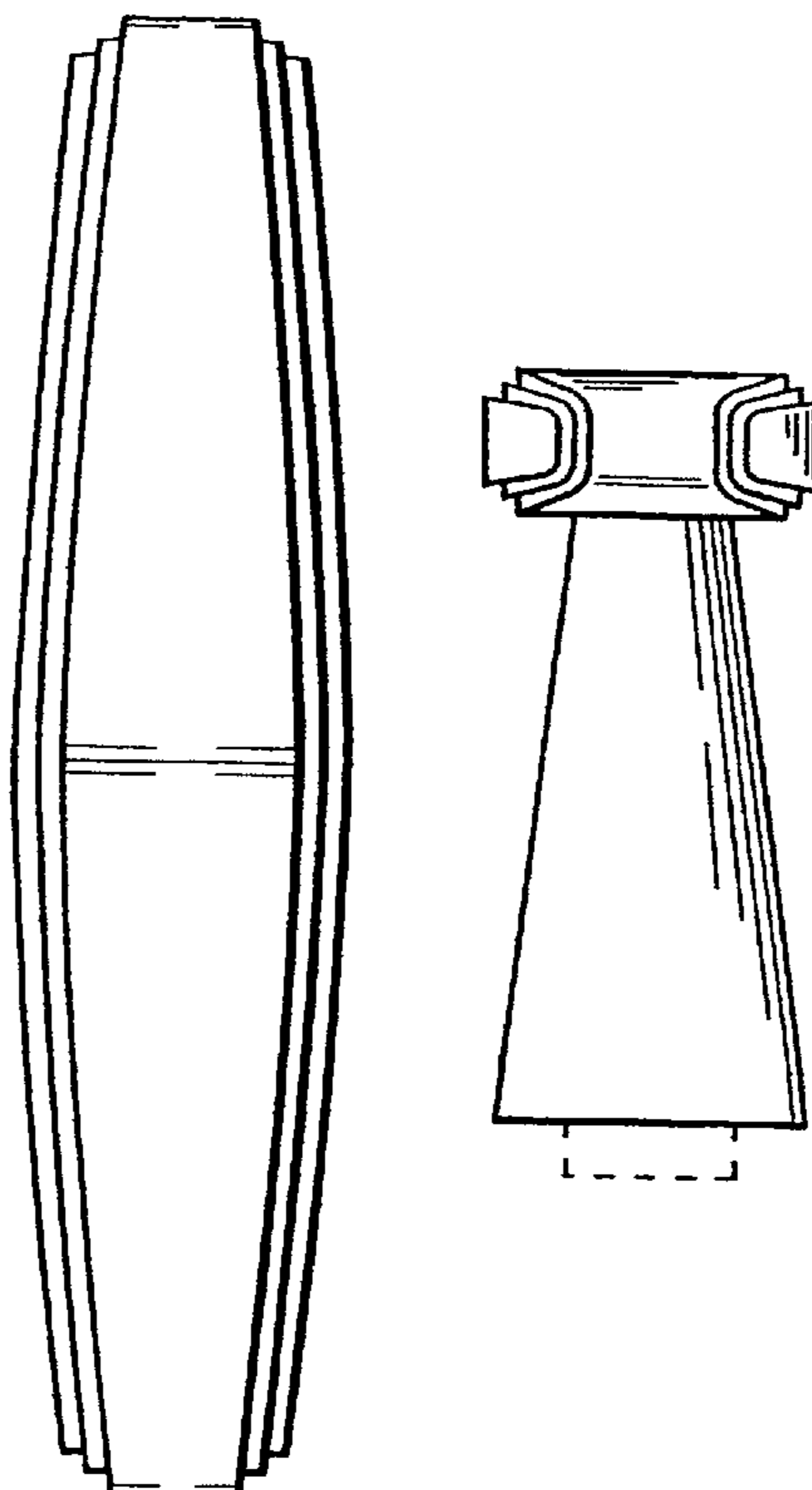

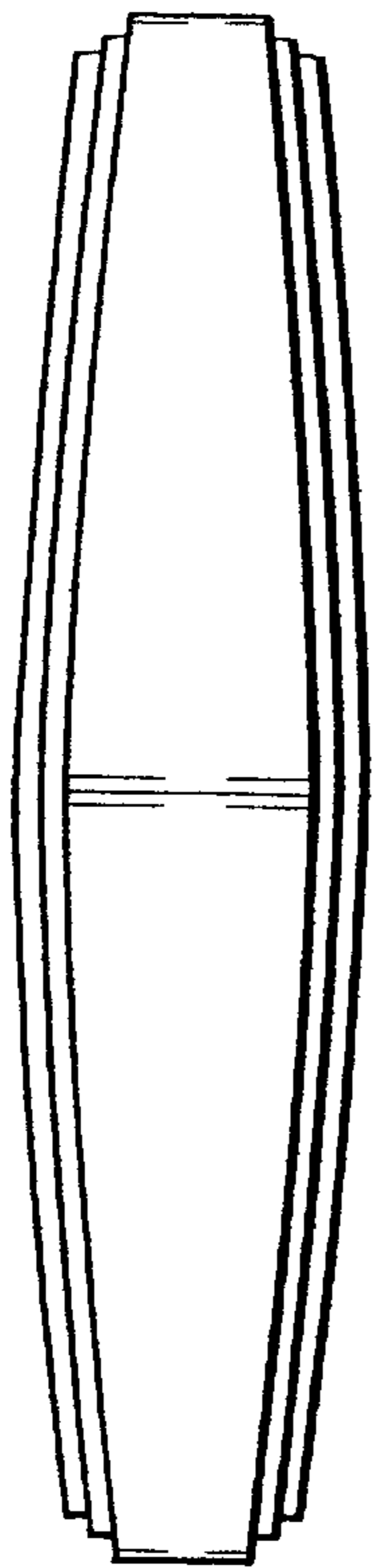

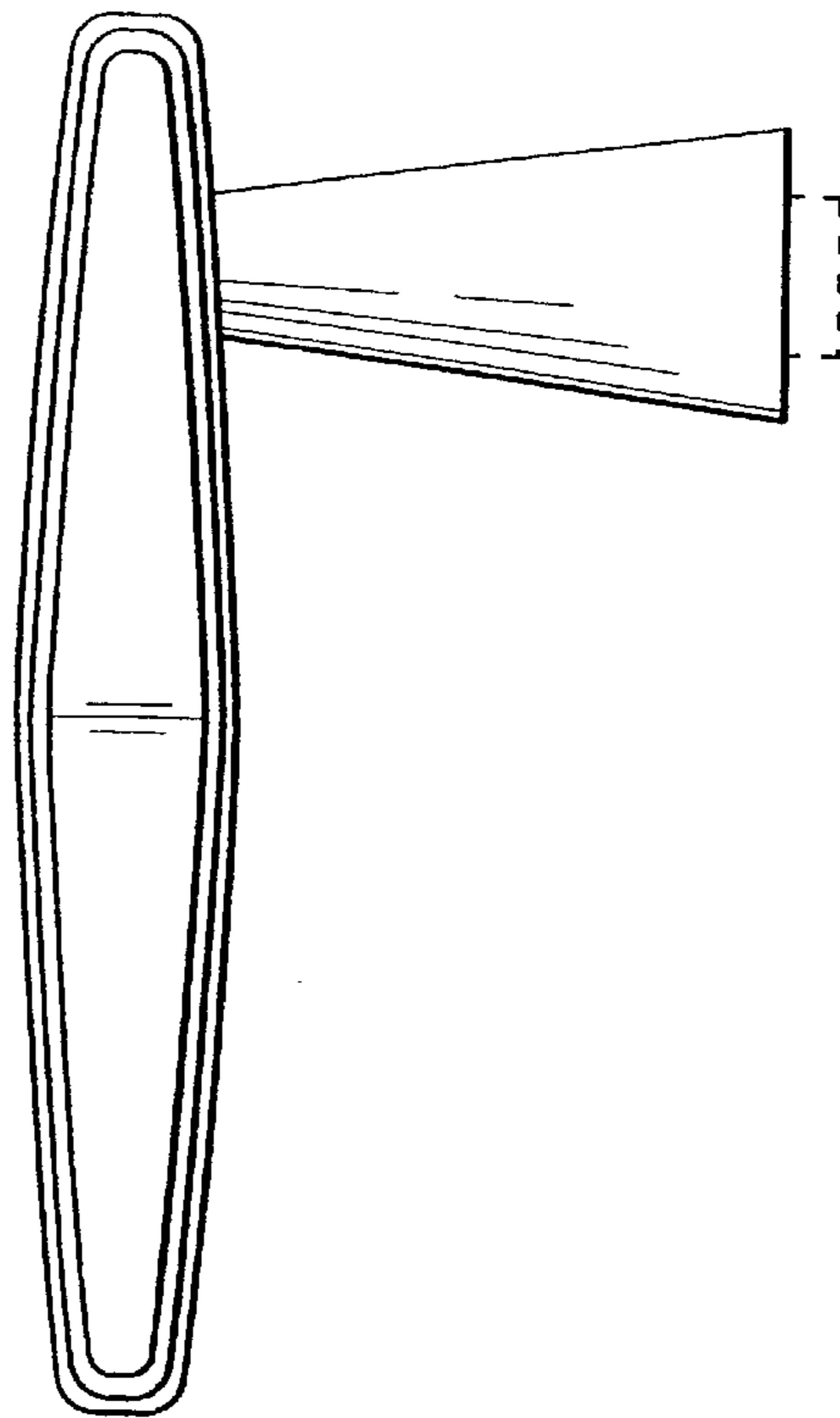
