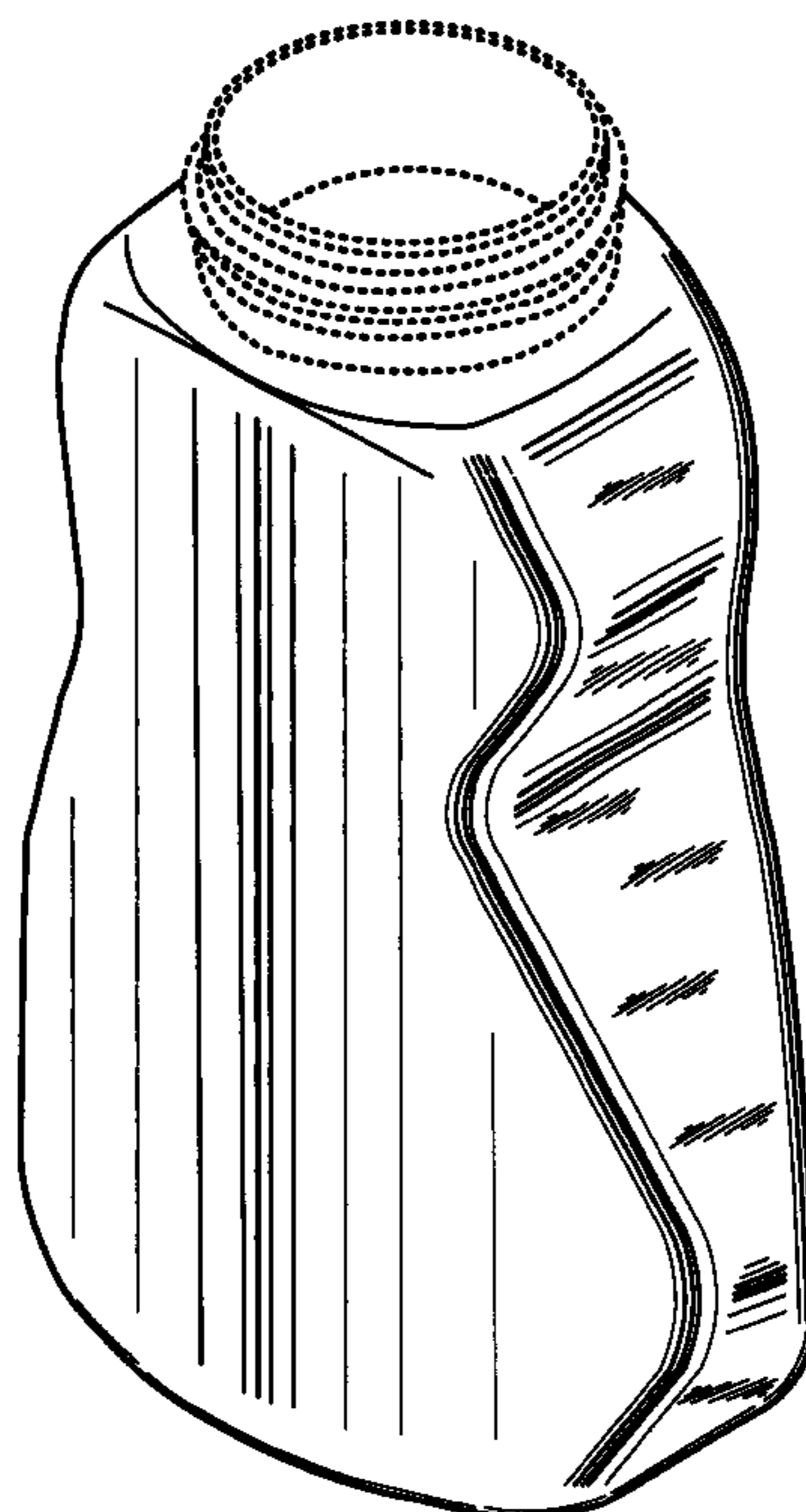
(57) **CLAIM**

The ornamental design for a “bottle,” as shown and described.

DESCRIPTION

FIG. 1 is a perspective view showing our new design; FIG. 2 is a top plan view of the bottle of FIG. 1; FIG. 3 is a bottom plan view of the bottle of FIG. 1; FIG. 4 is a left side elevational view of the bottle of FIG. 1; FIG. 5 is a right side elevational view of the bottle of FIG. 1; FIG. 6 is a front elevational view of the bottle of FIG. 1; and, FIG. 7 is a rear elevational view of the bottle of FIG. 1. The dashed lines are for illustrative purposes only and form no part of the claimed design.

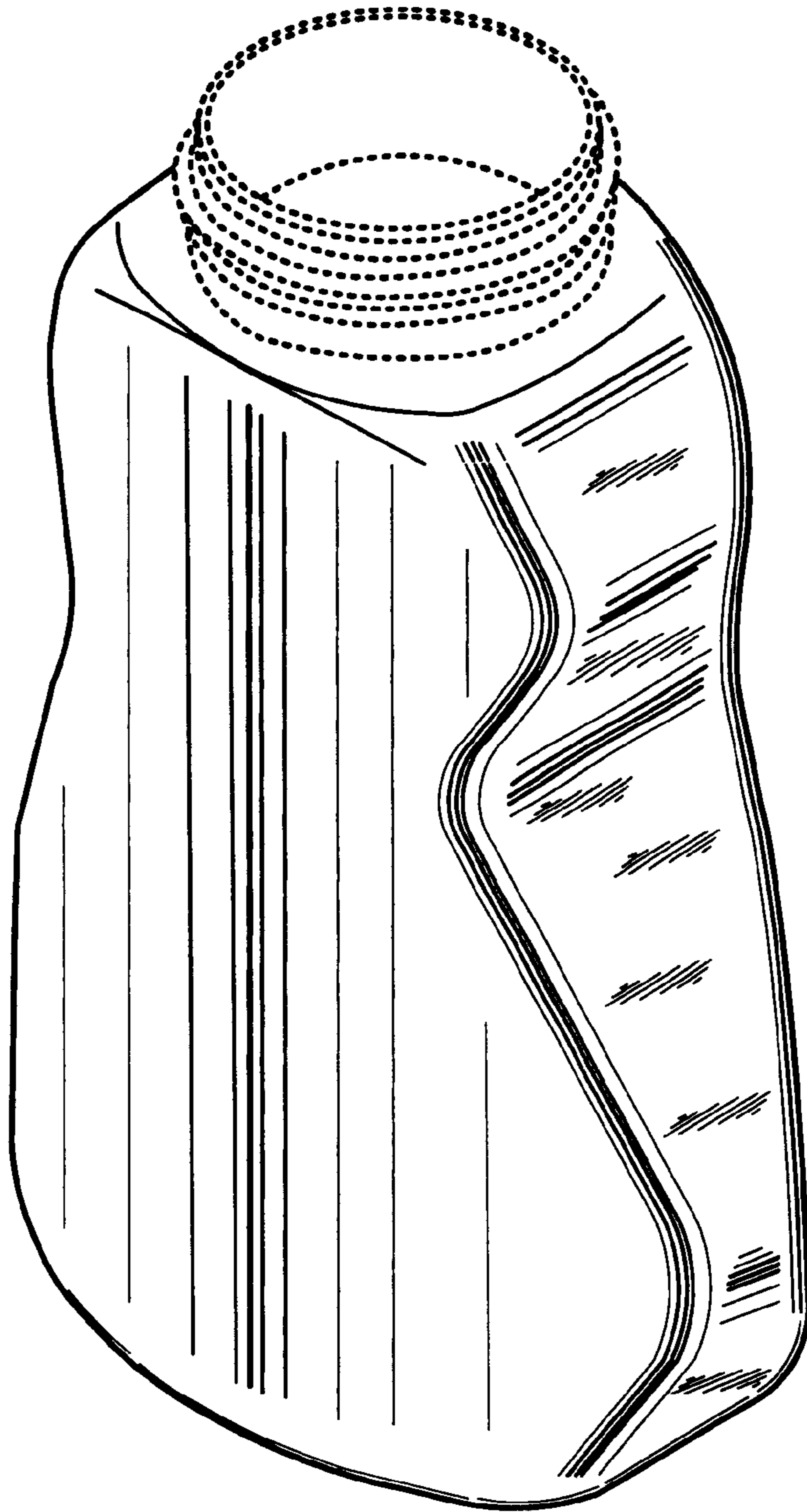

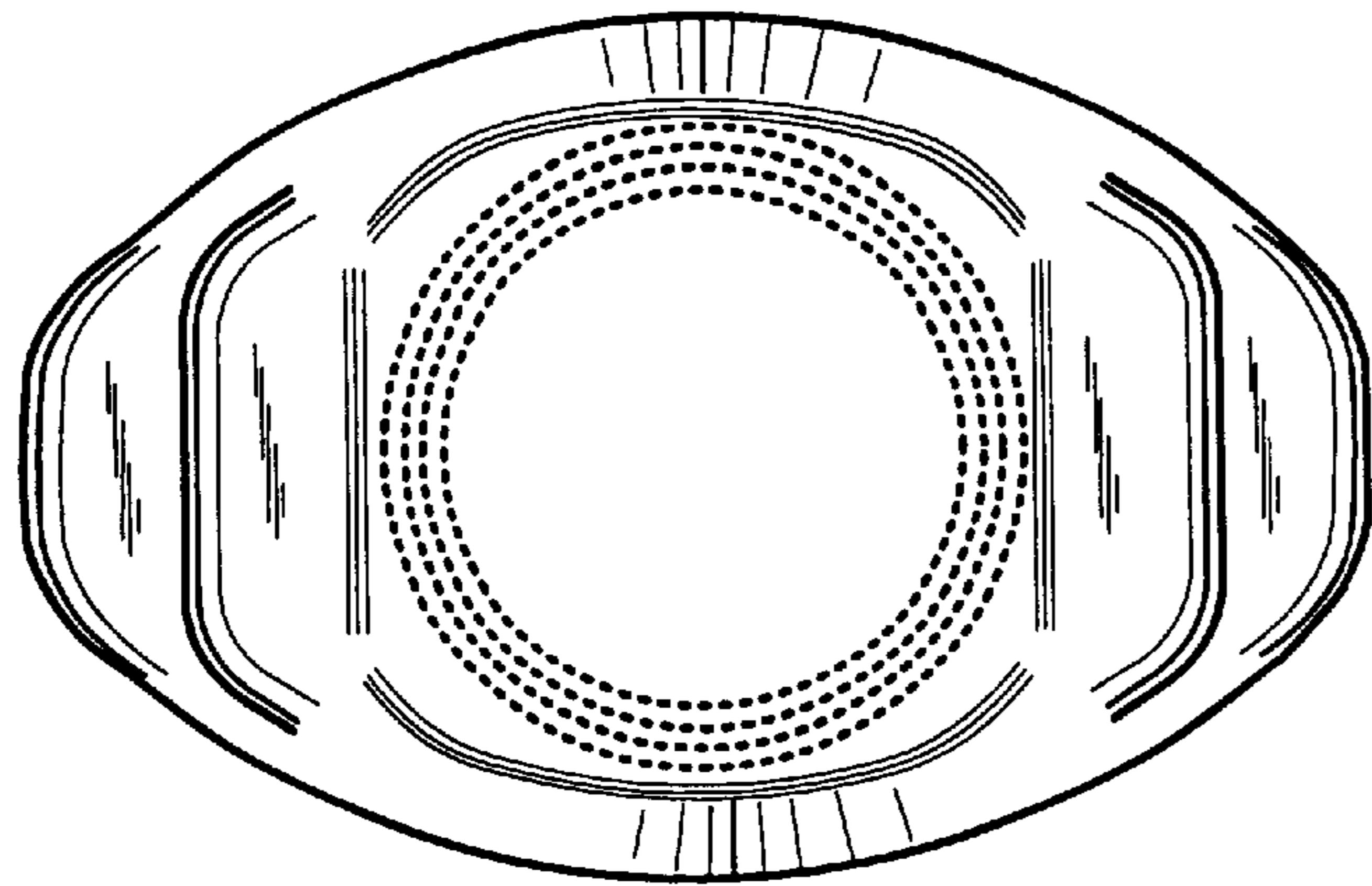

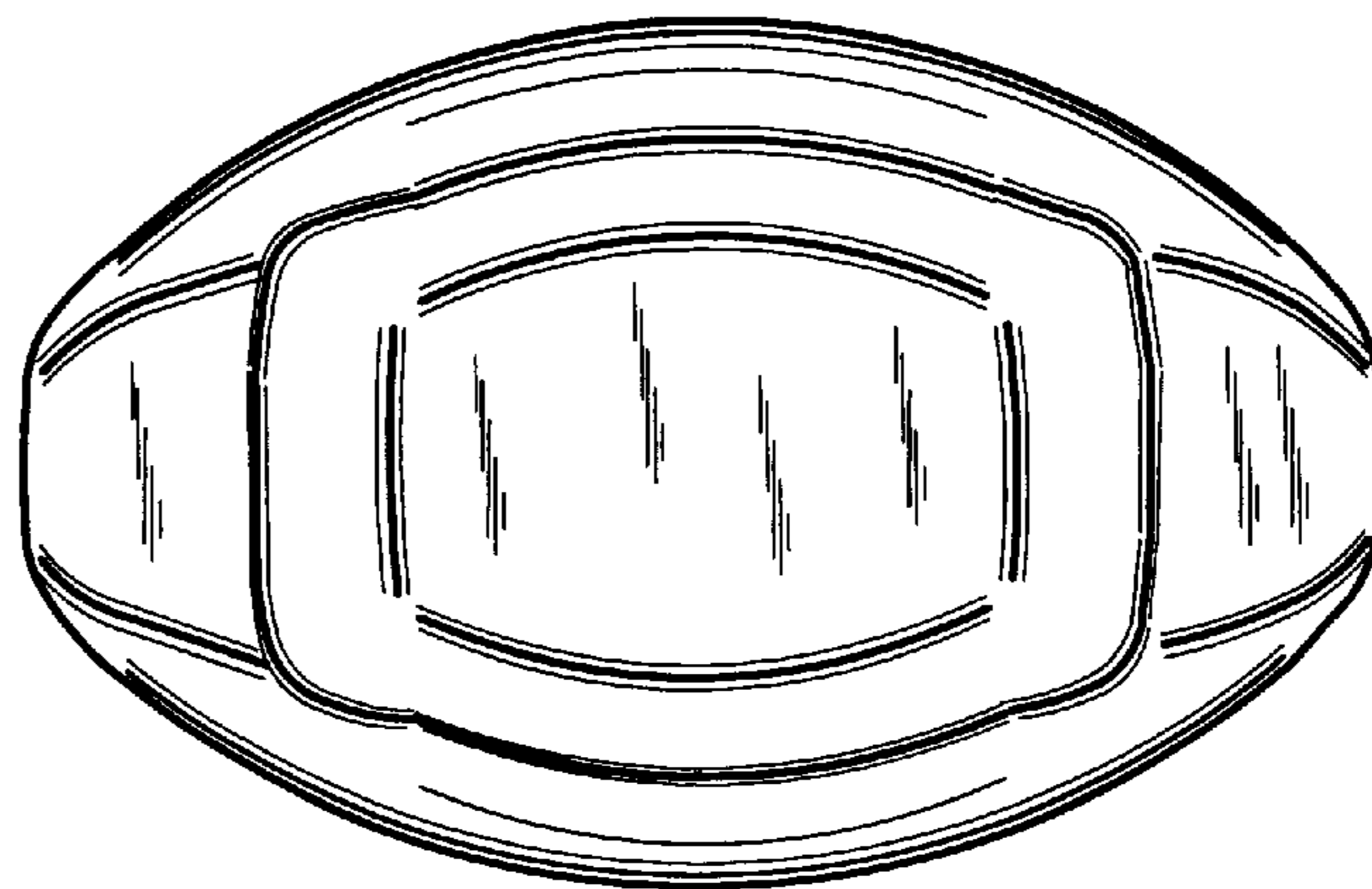

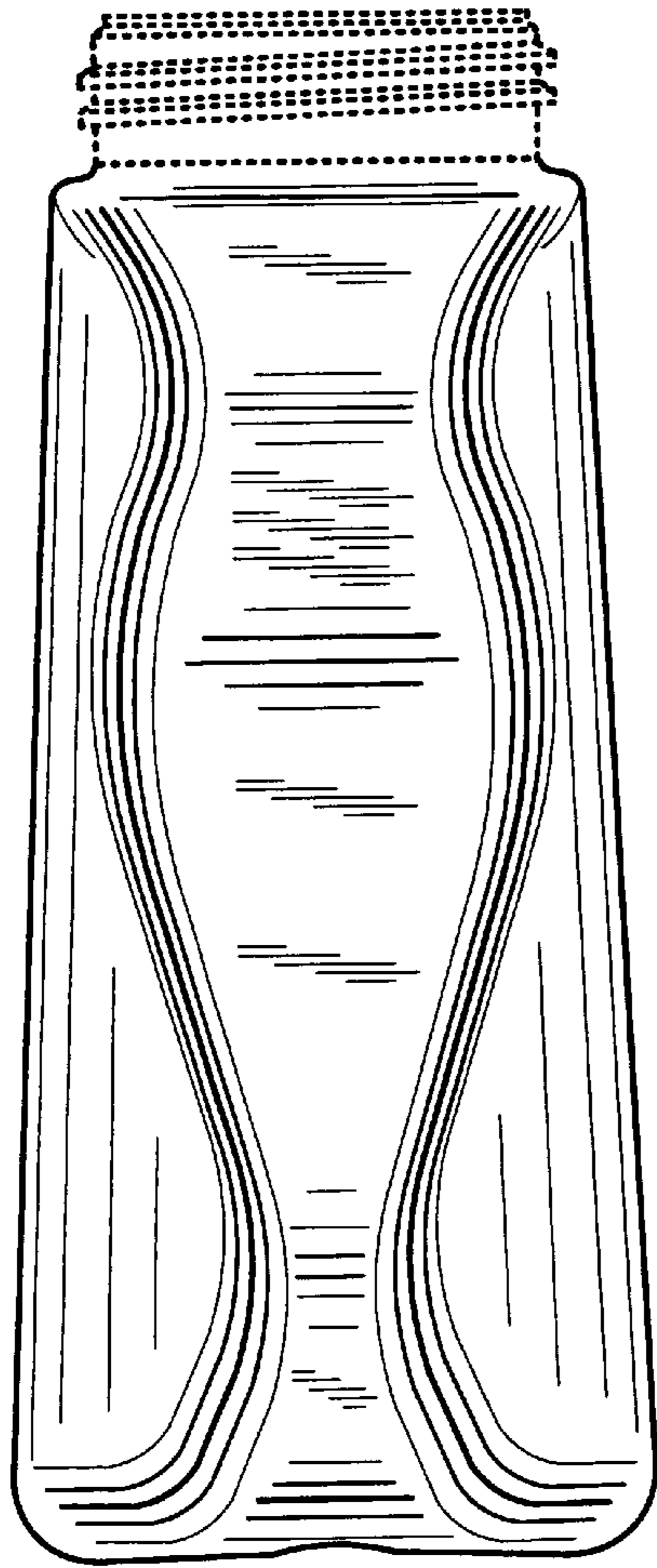

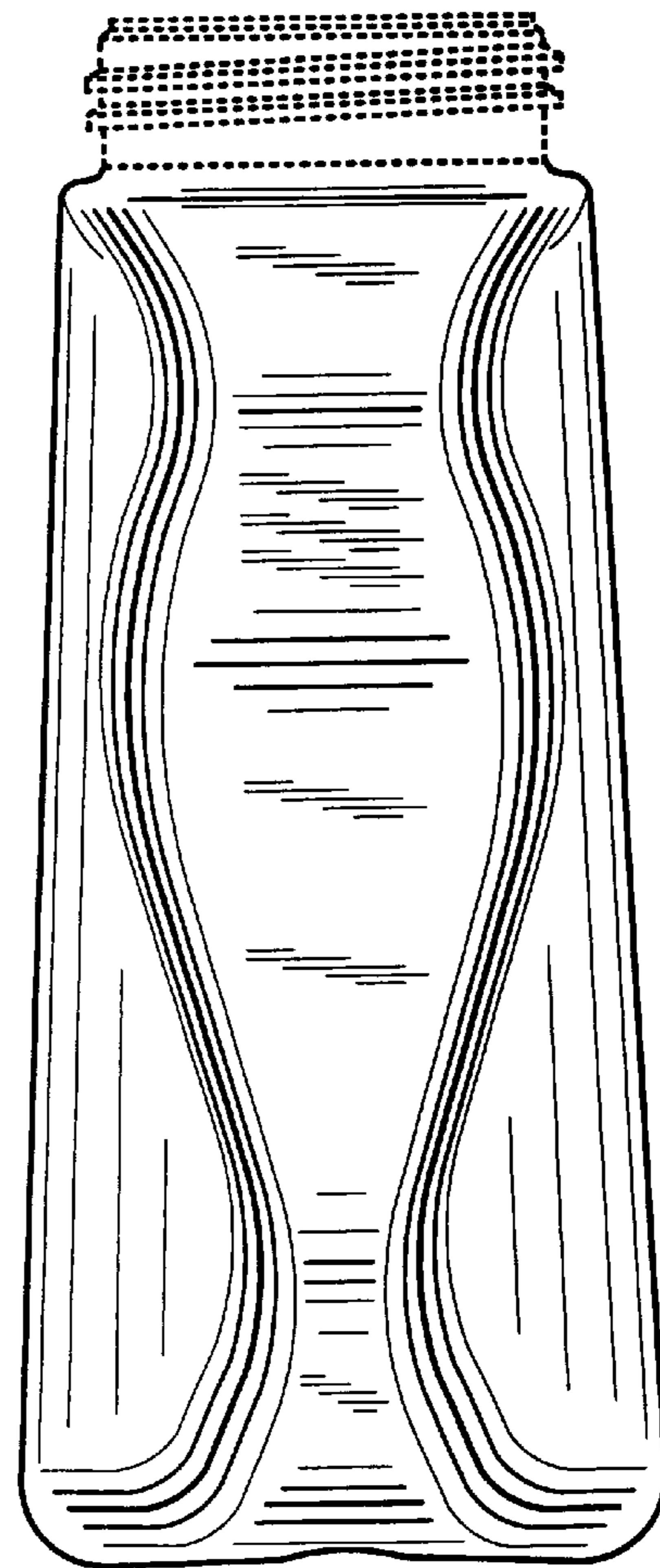

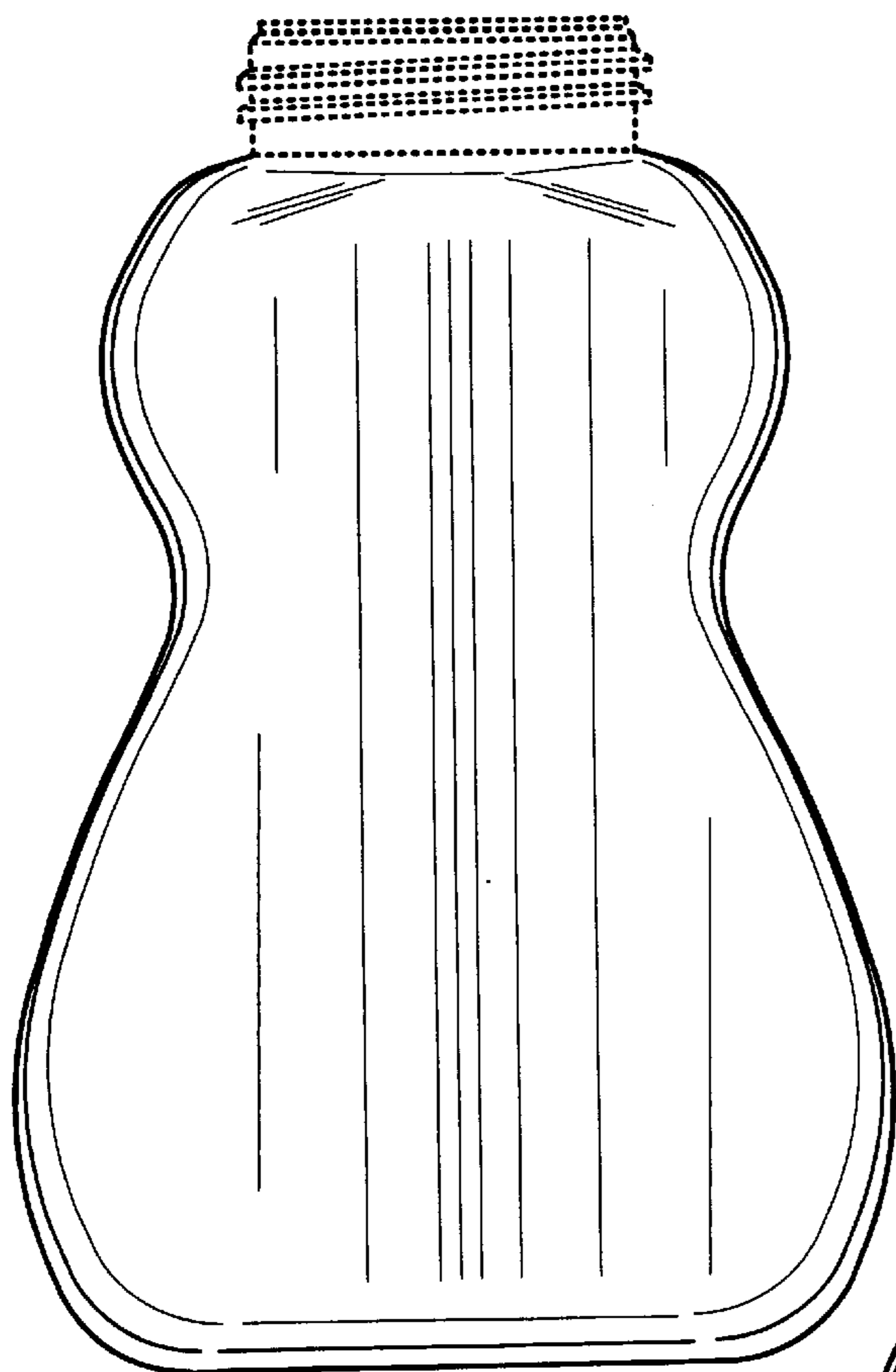

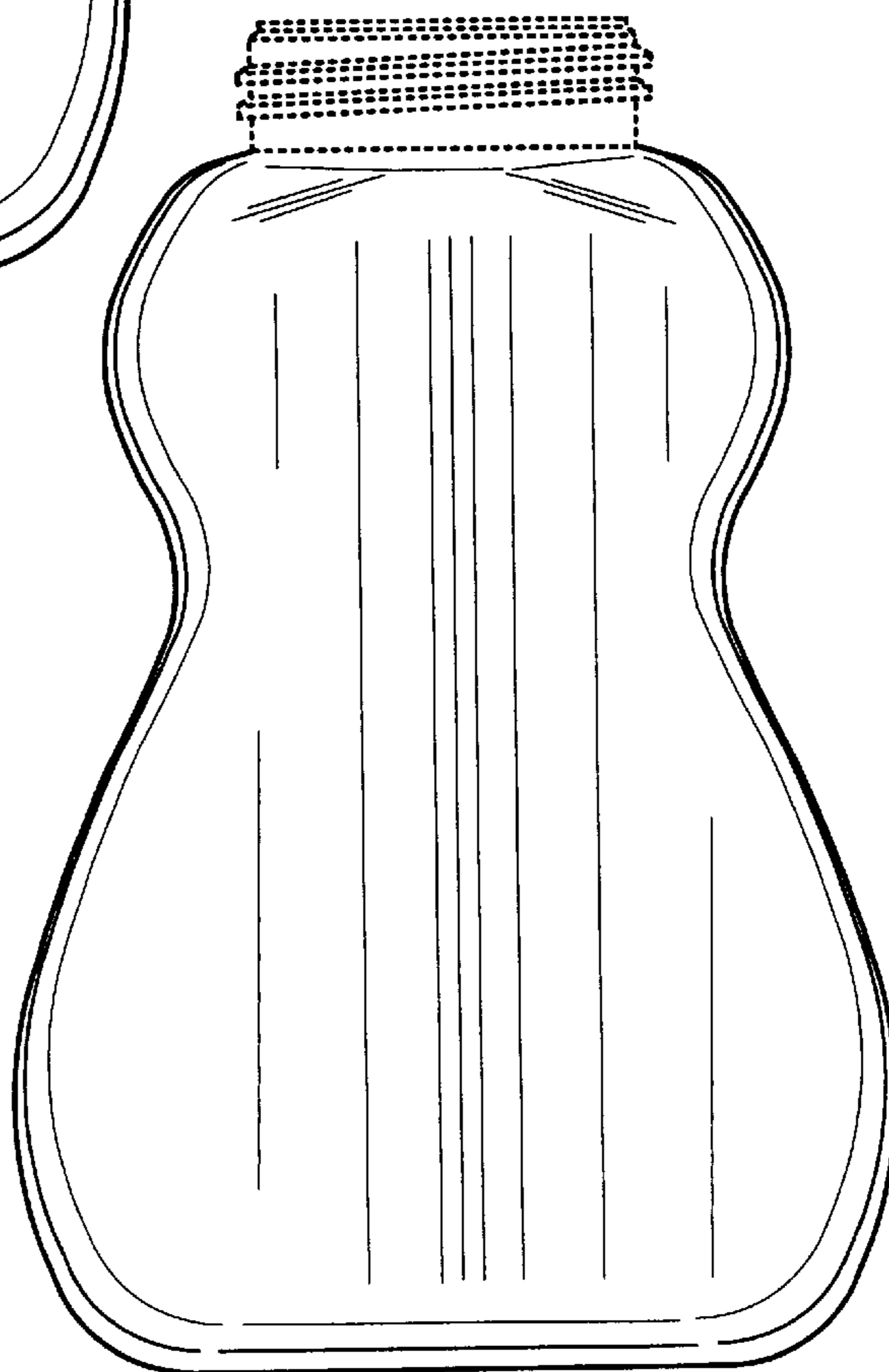
