FIG. 3 is a right side front top perspective view thereof;

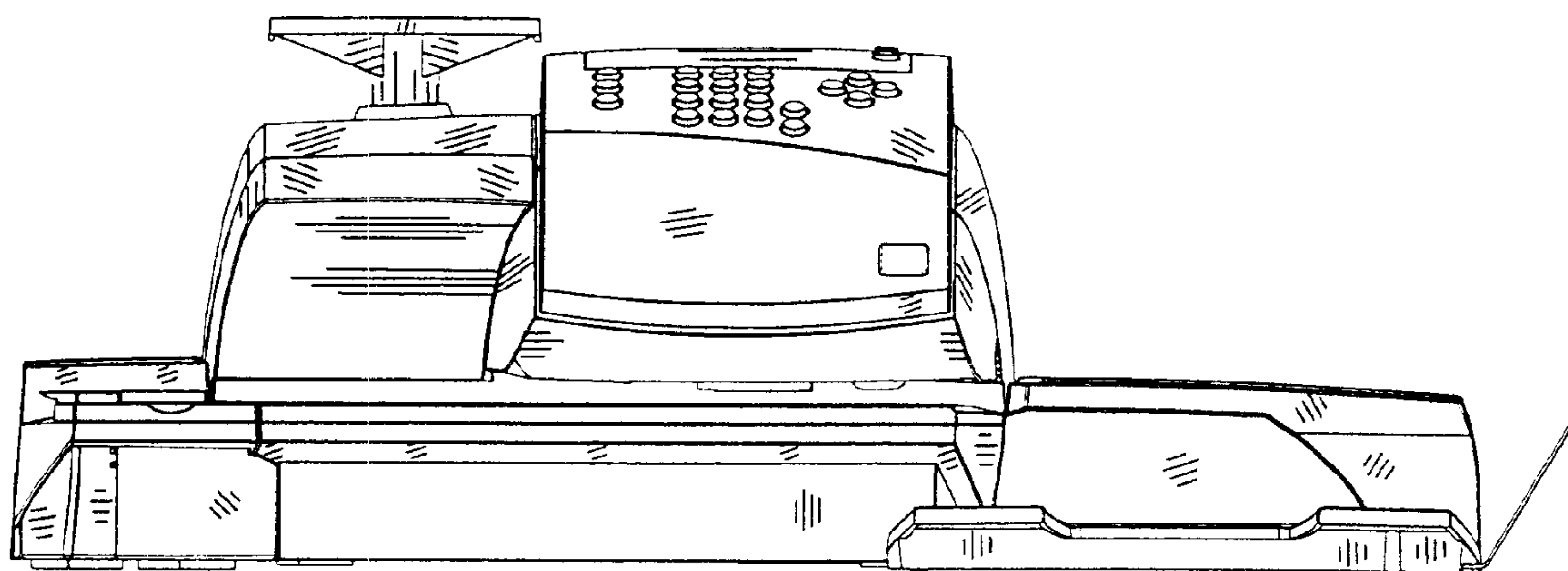
FIG. 4 is a right side view thereof;

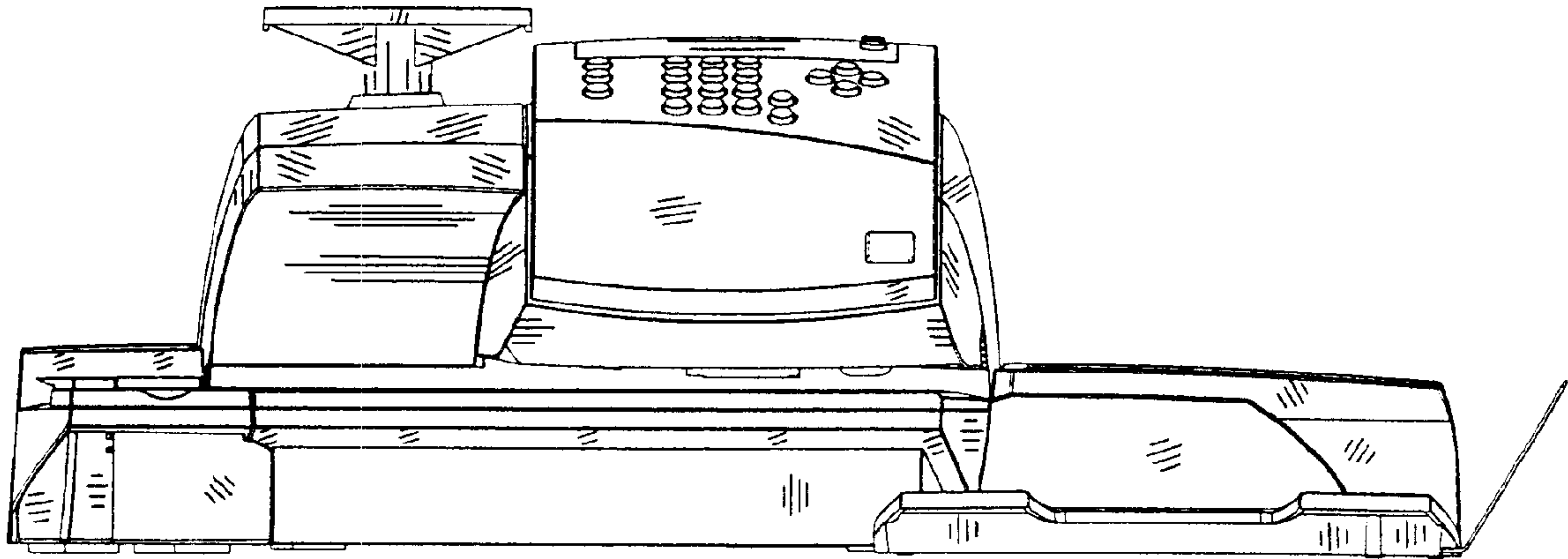

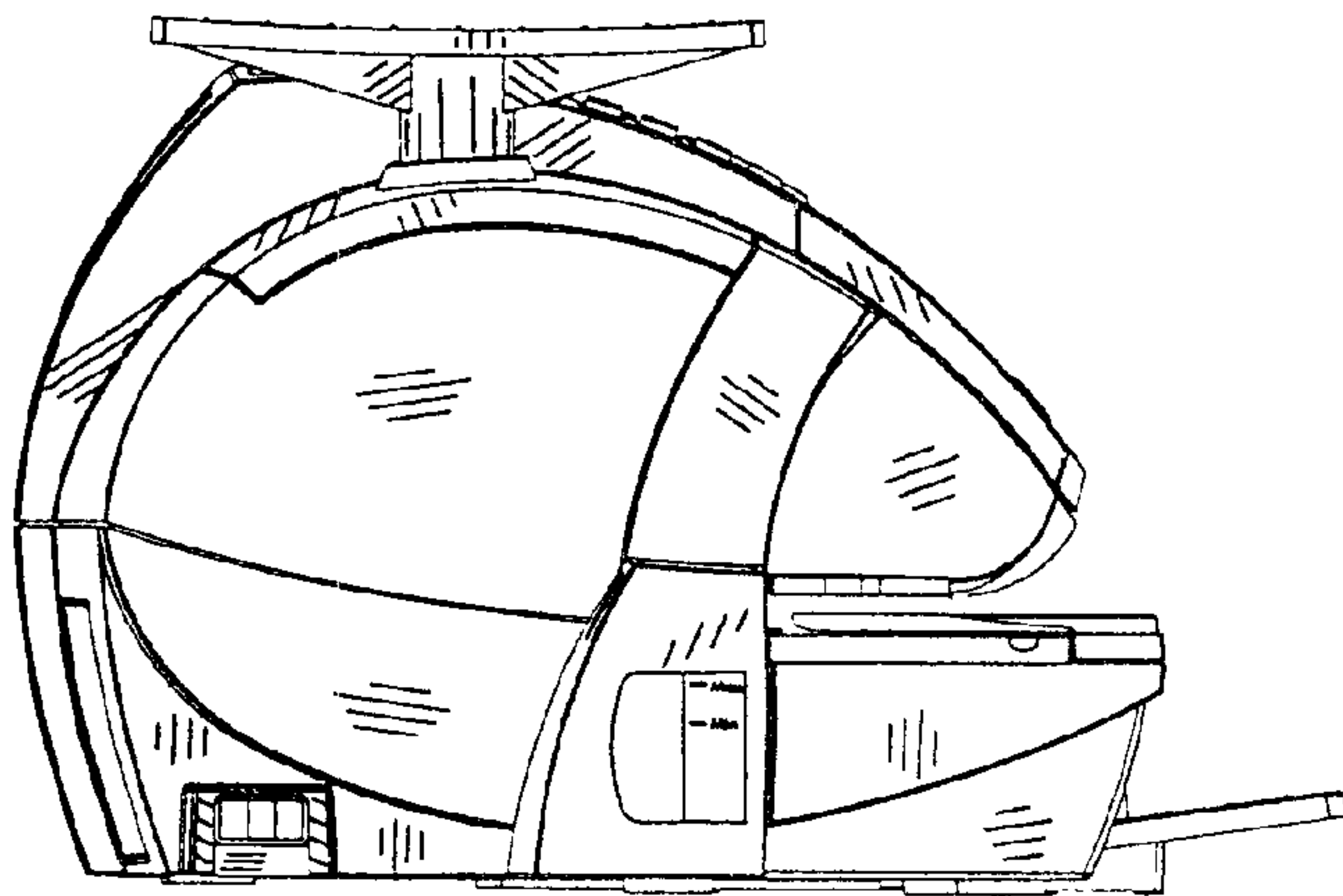

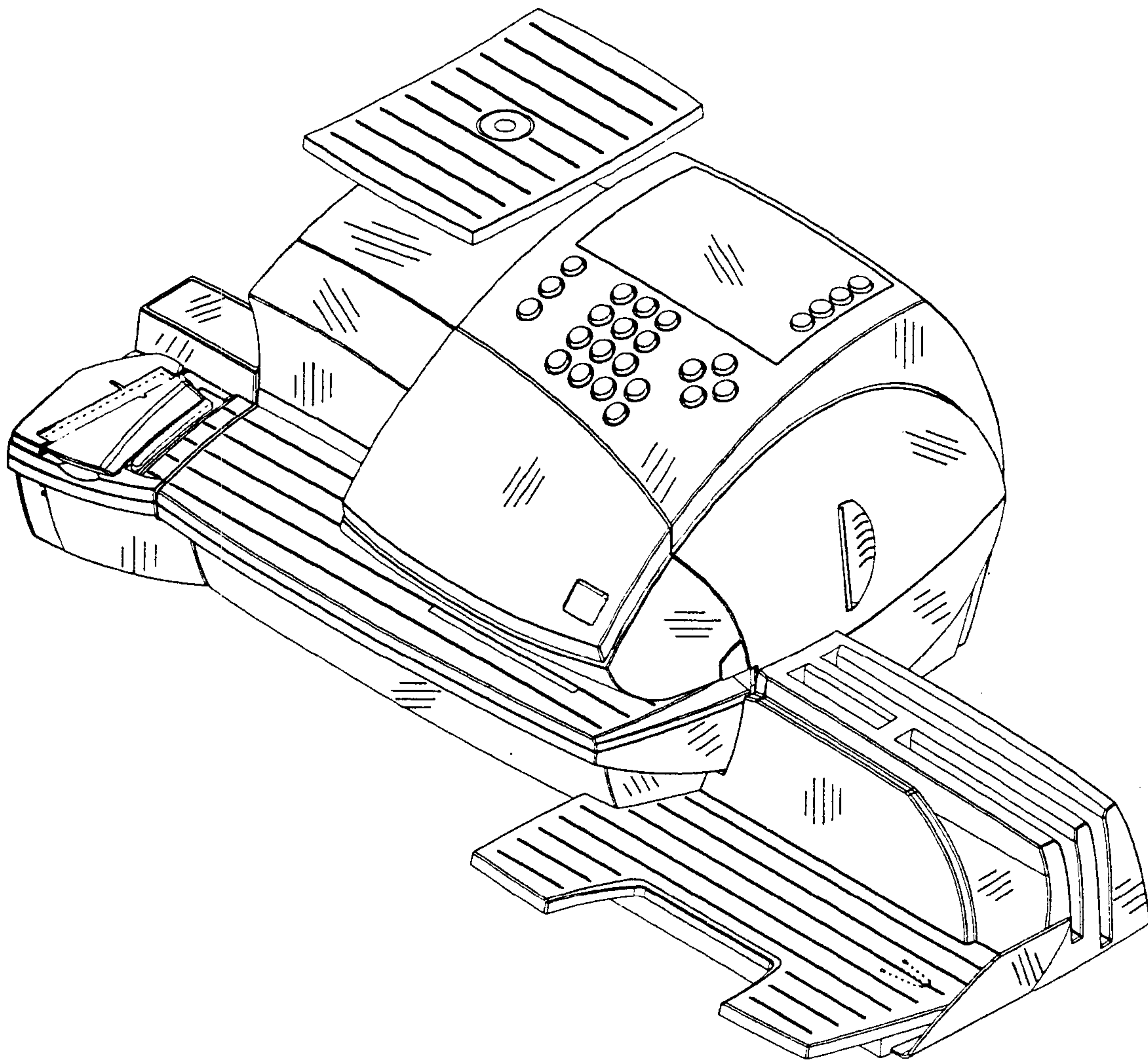

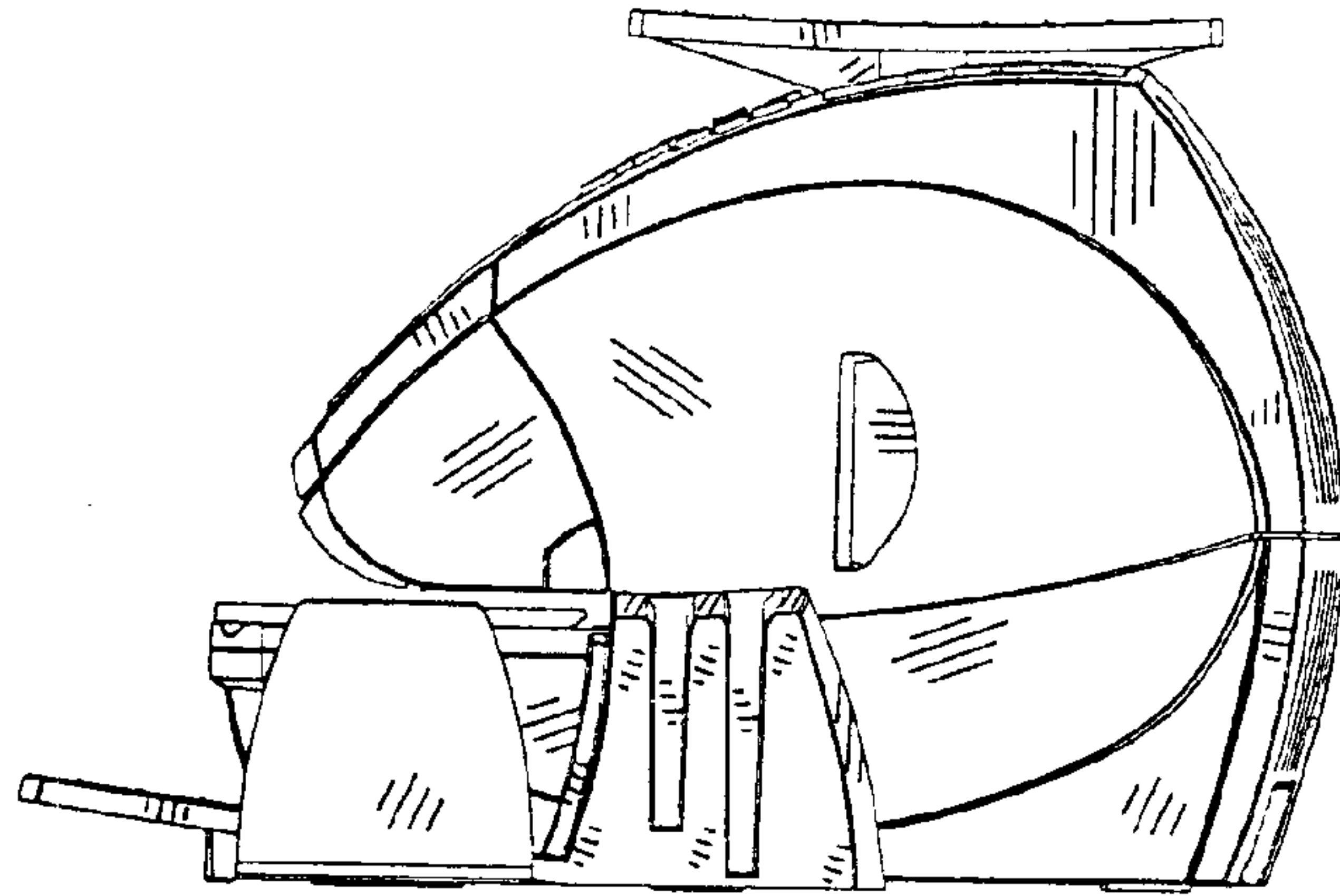

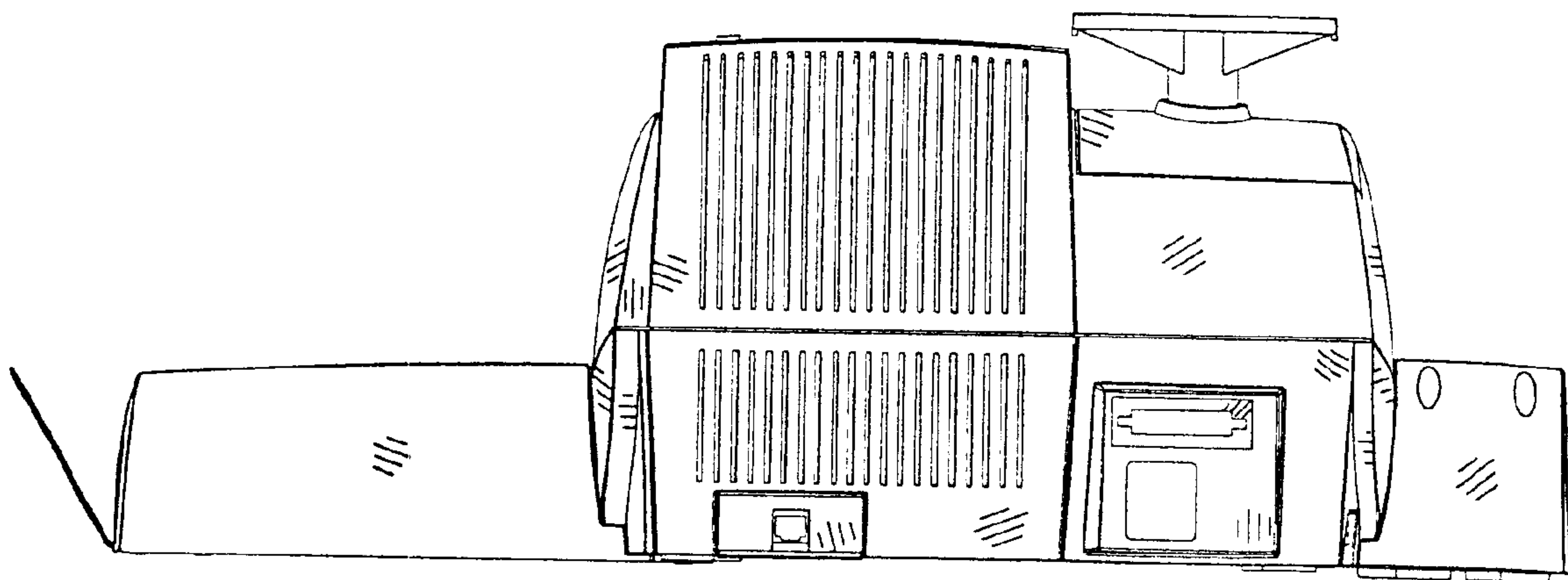

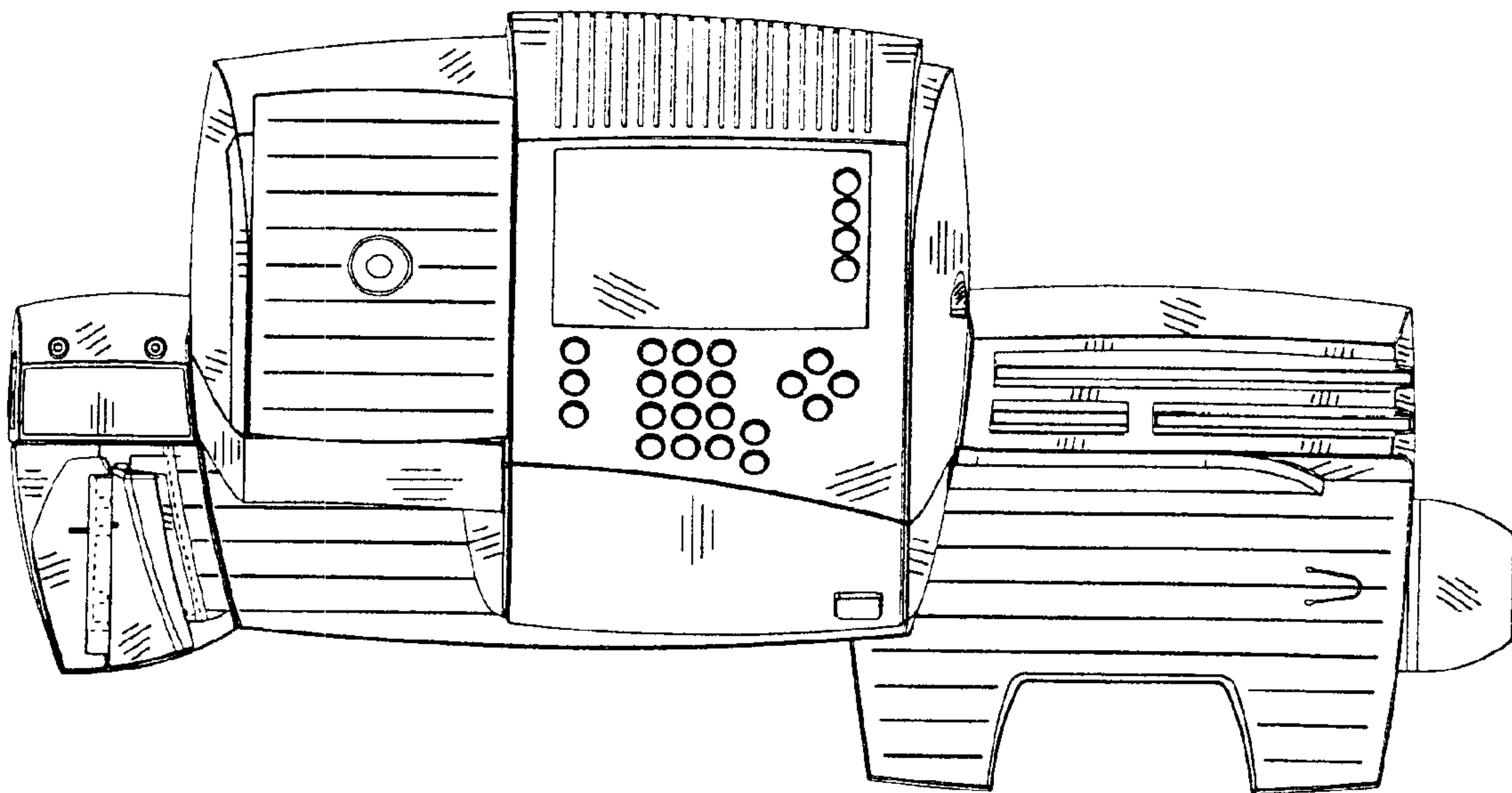
