FIG. 2 is a top plan view, the bottom plan view being identical;

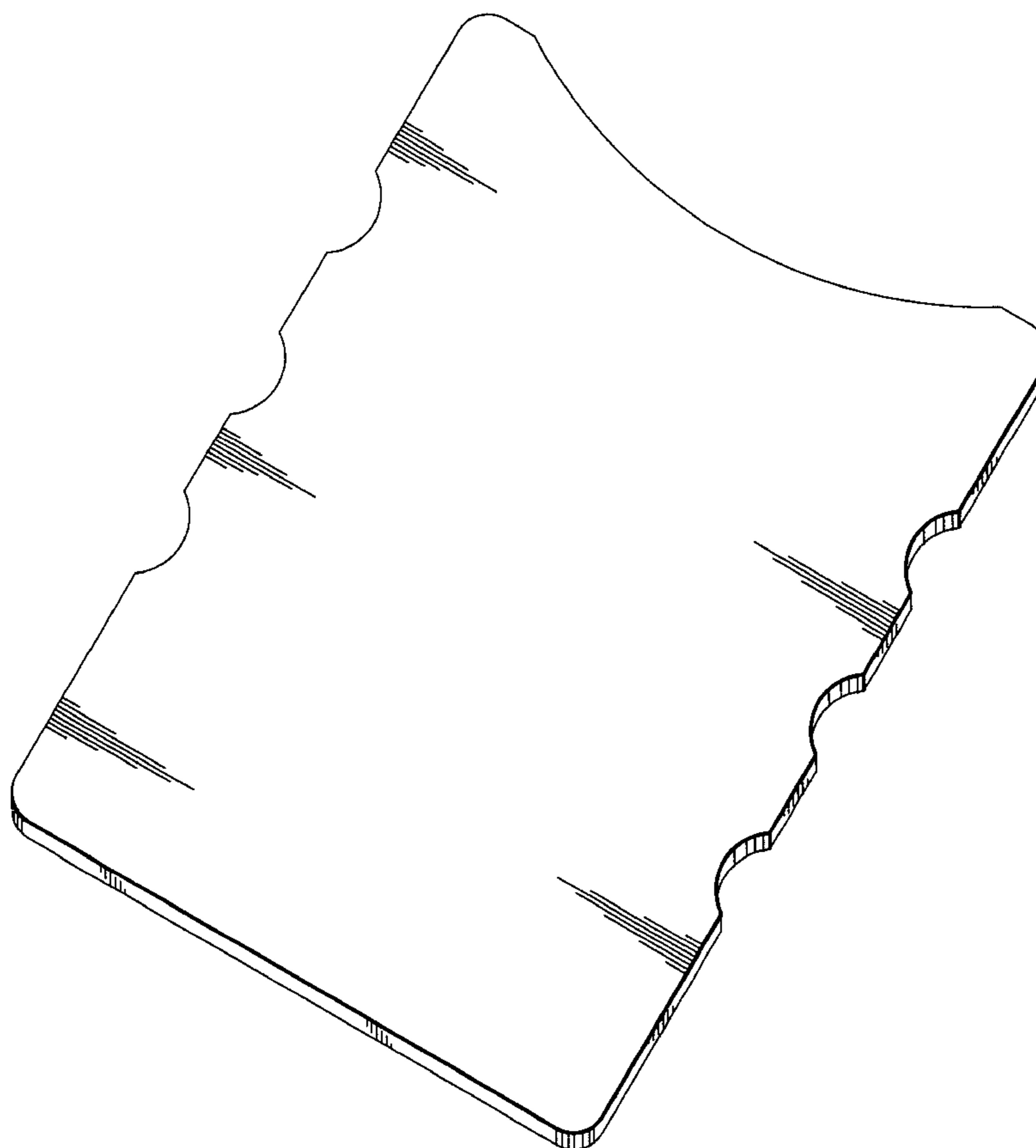
FIG. 3 is a right elevational view;

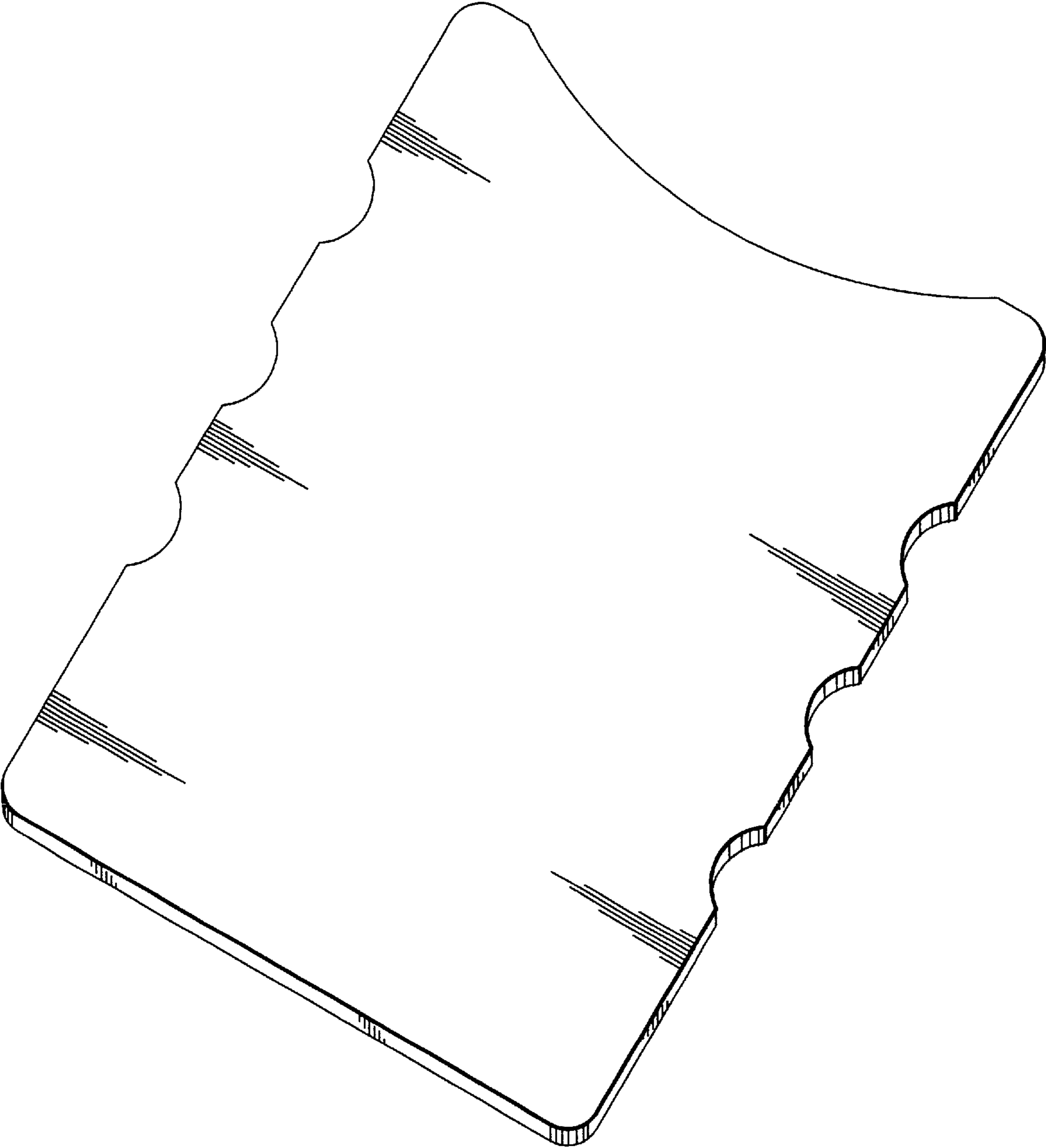

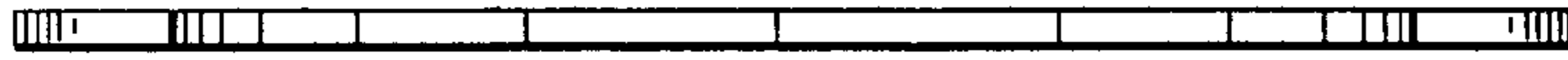

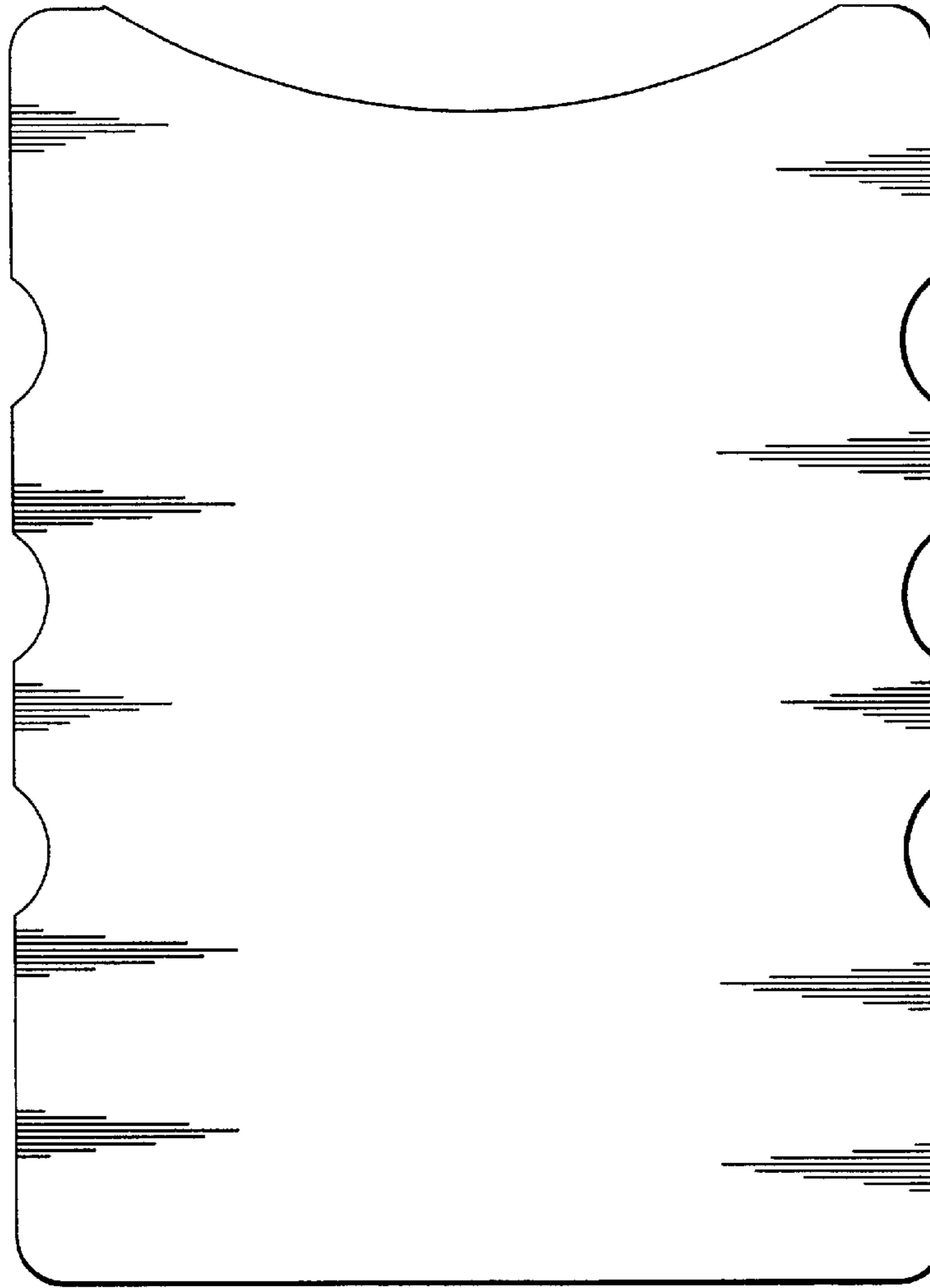

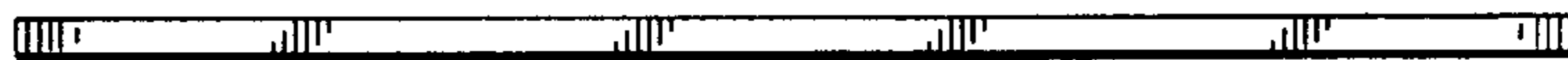
