FIG. 3 is a front plan view of the glove;

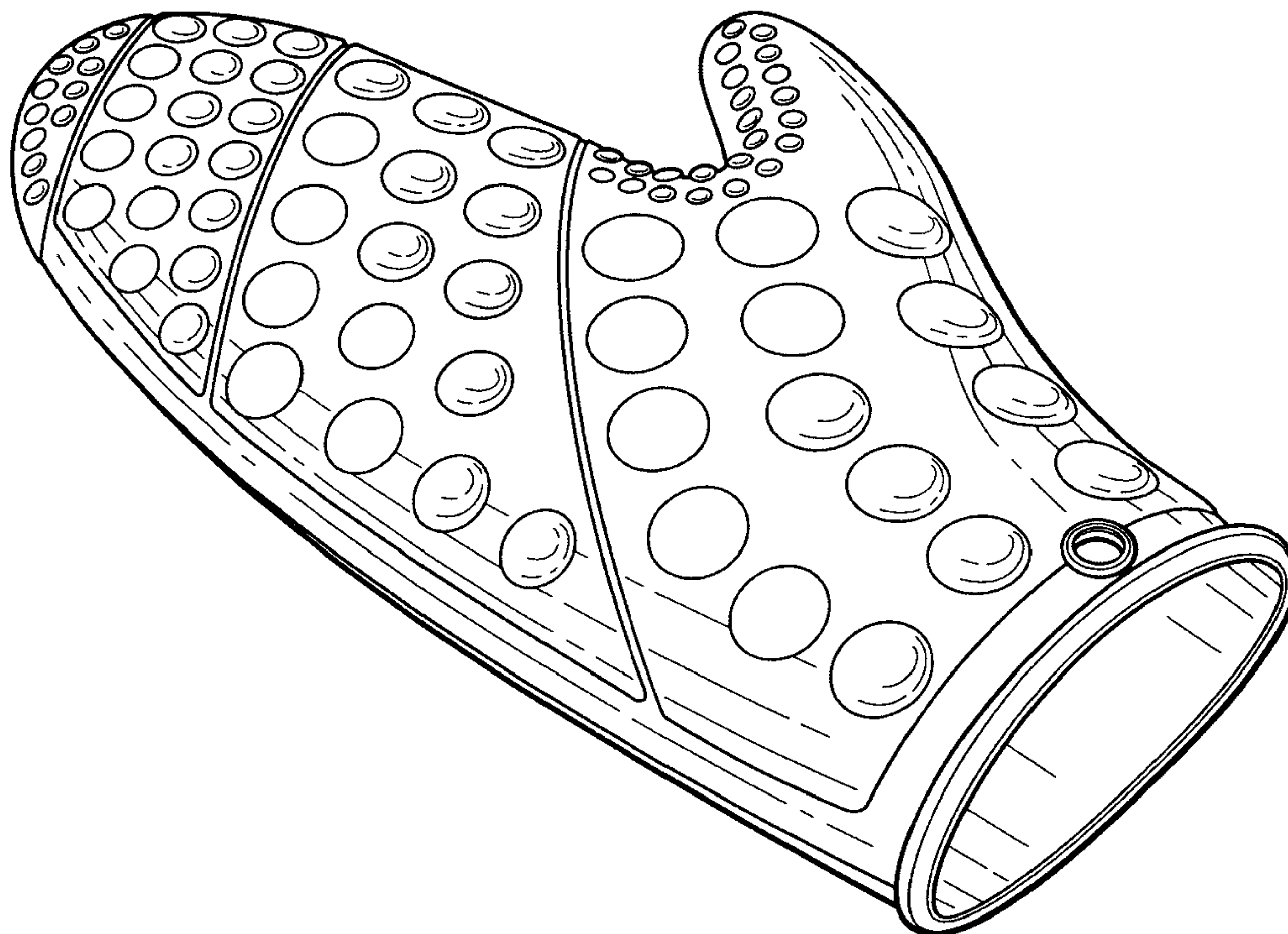
FIG. 4 is a left side view of the glove;

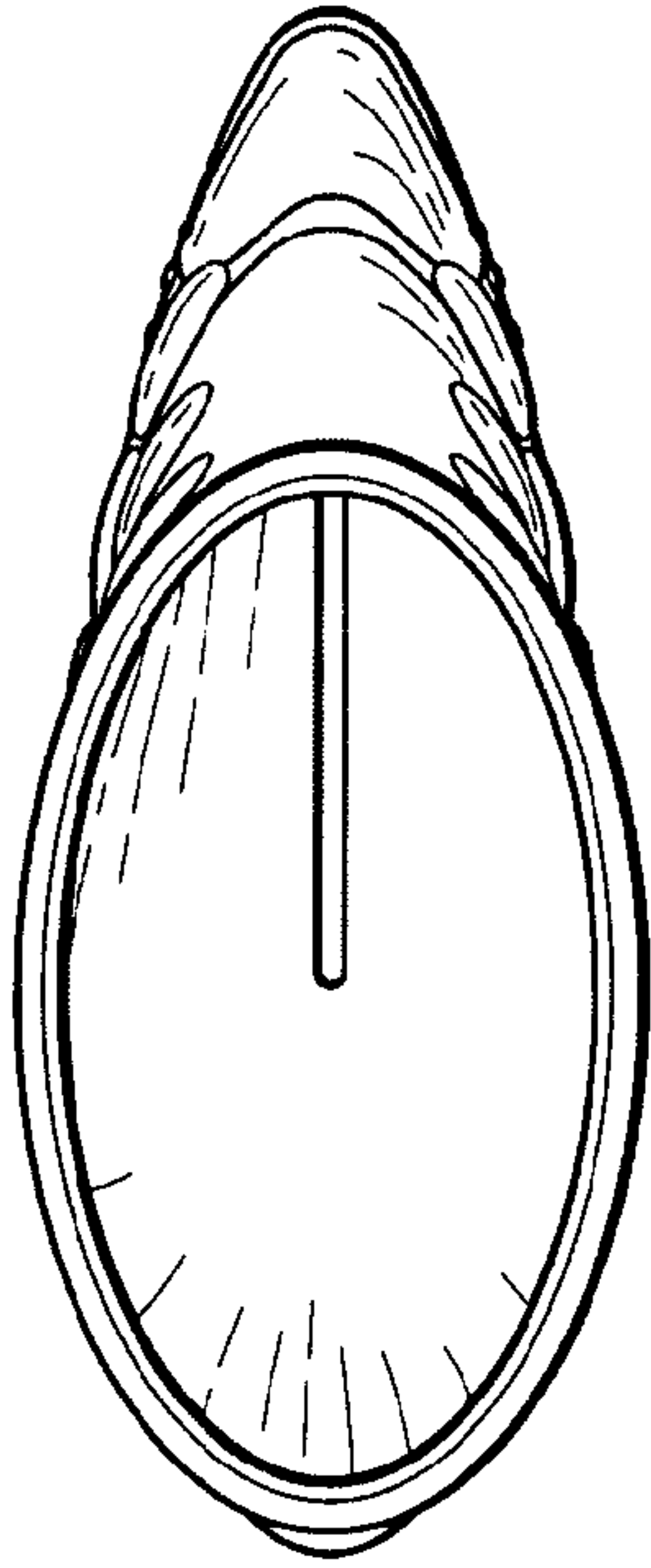

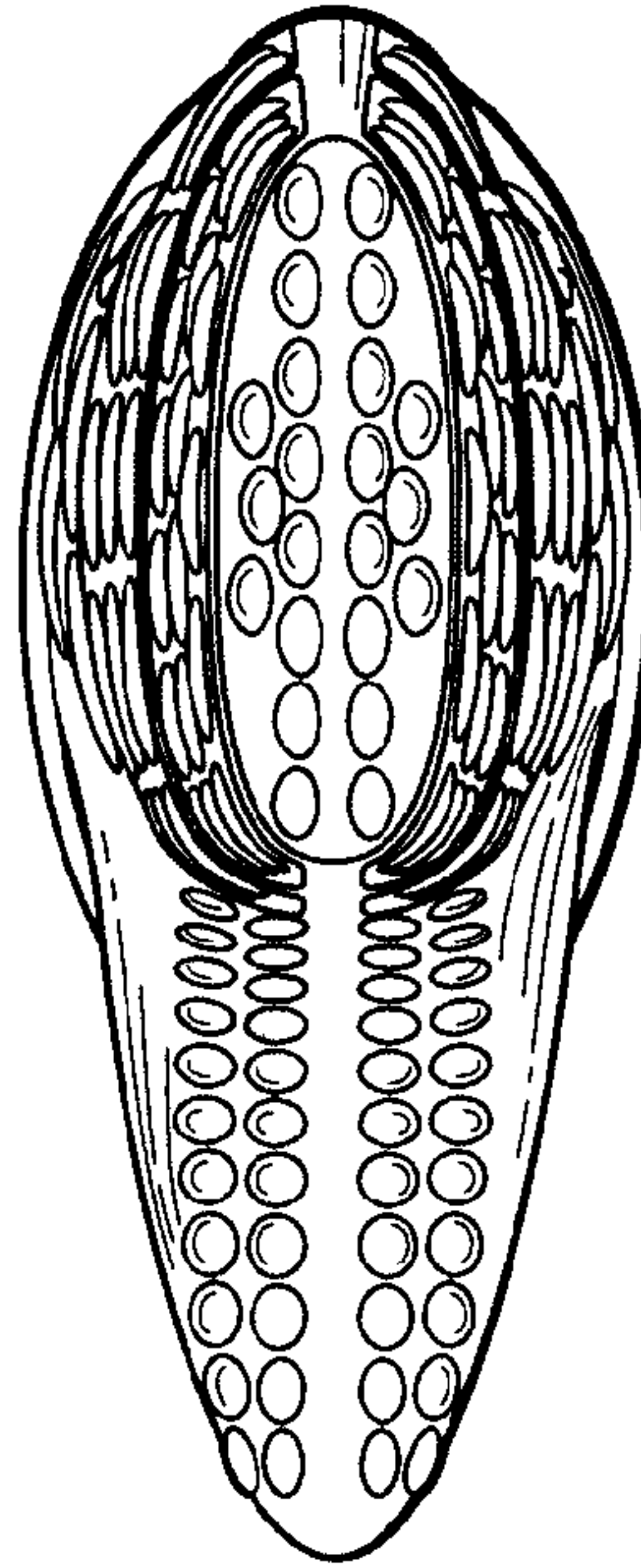

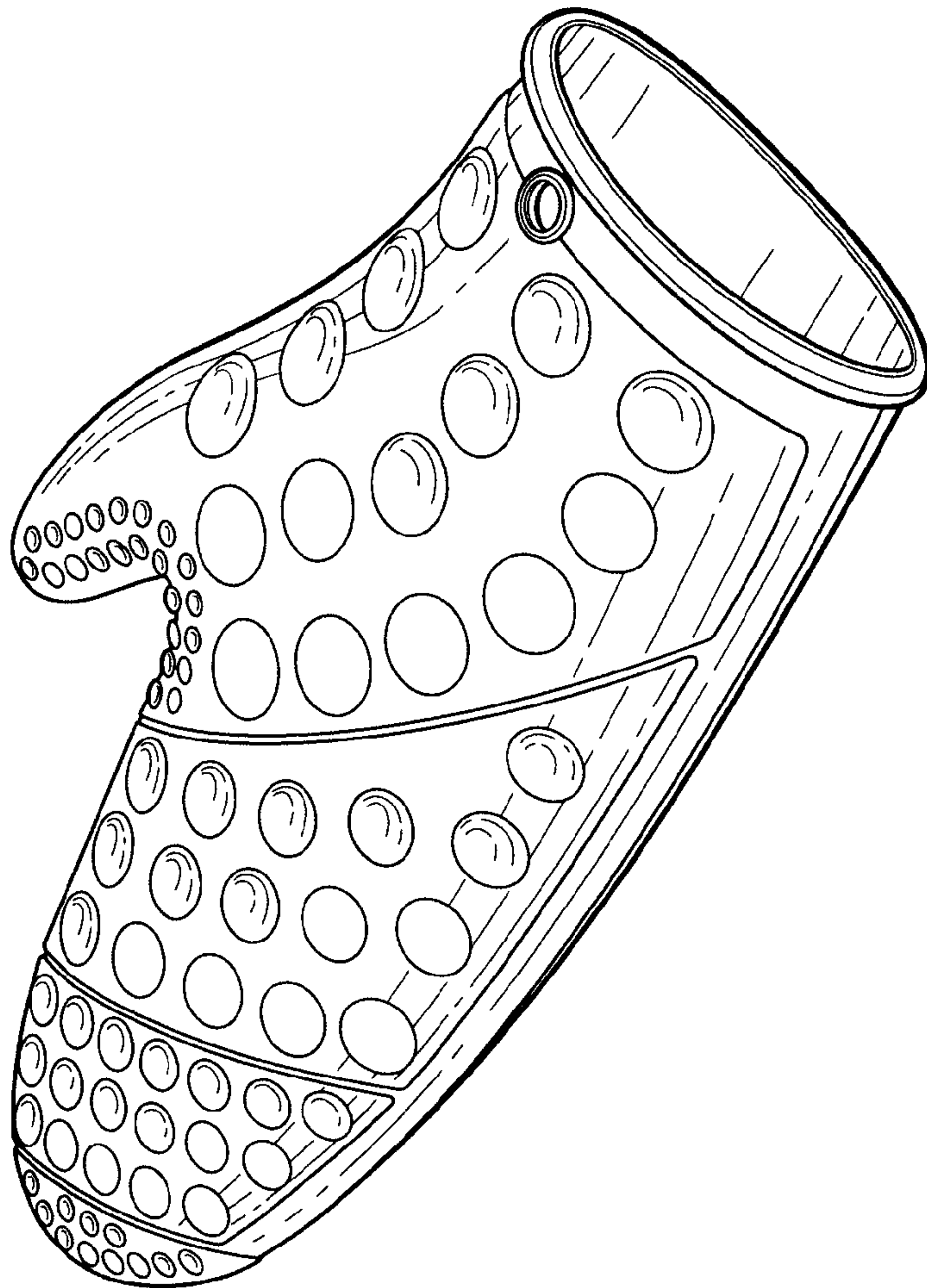

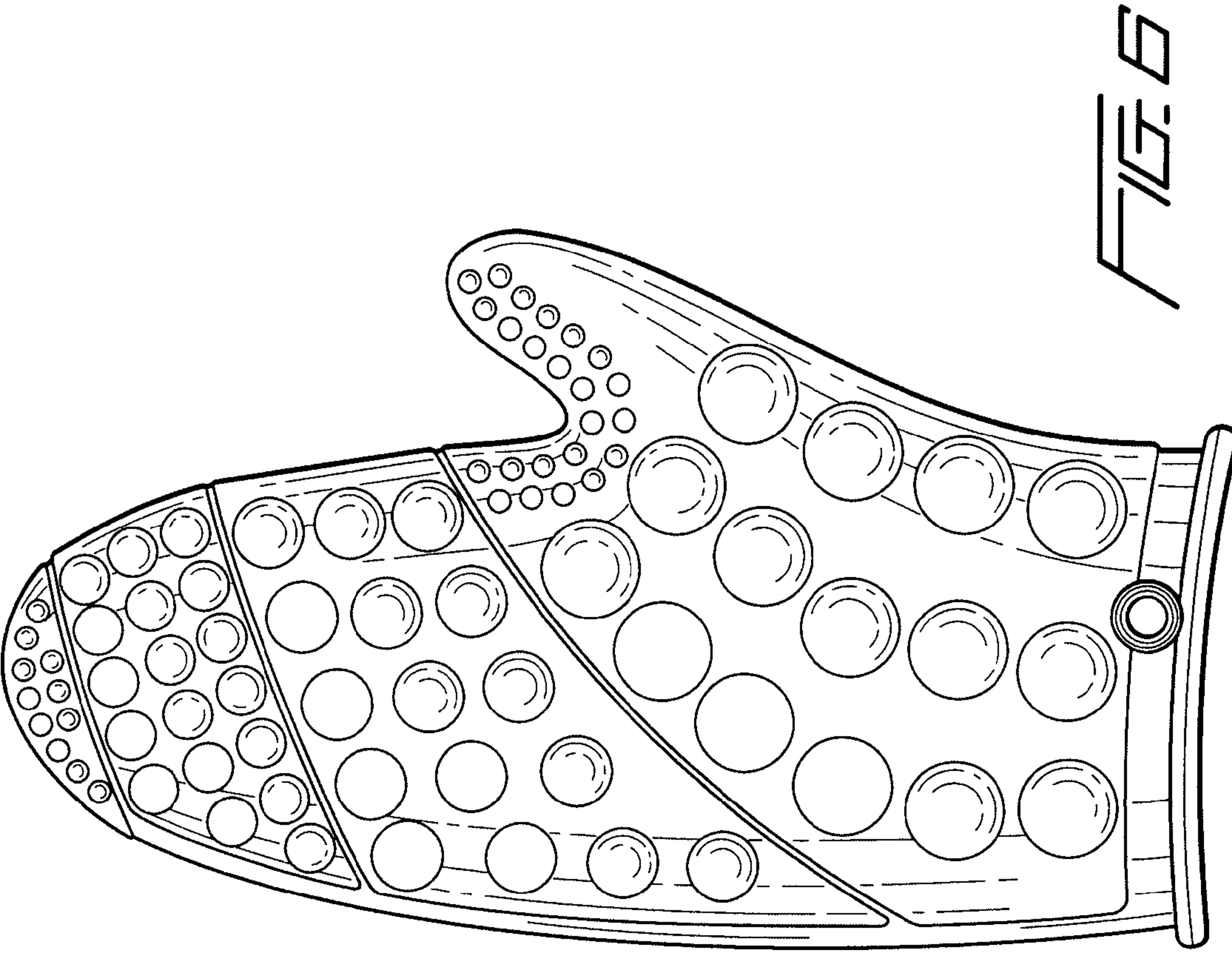

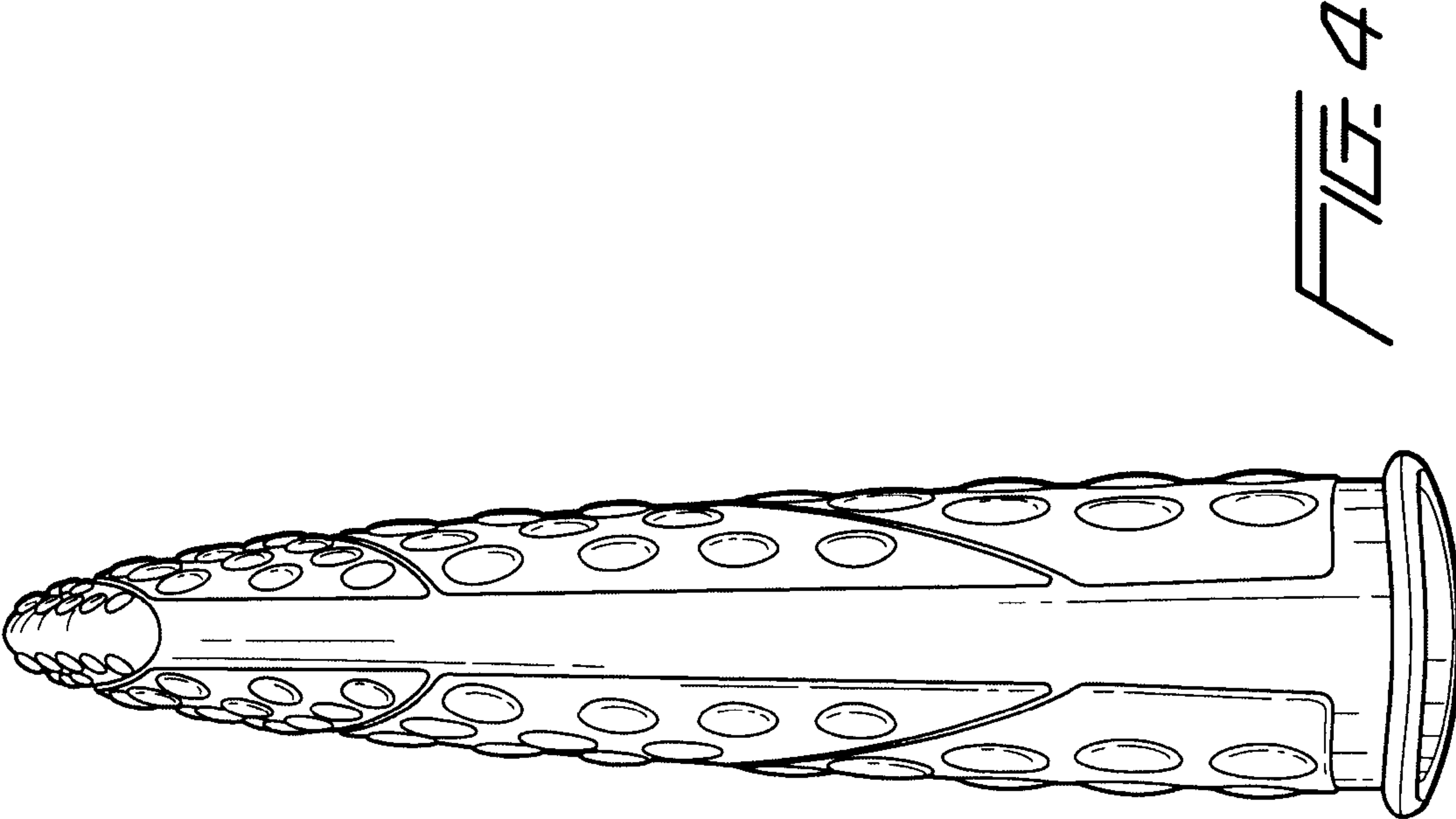
