**DESCRIPTION**

FIG. 3 is a back elevation view;

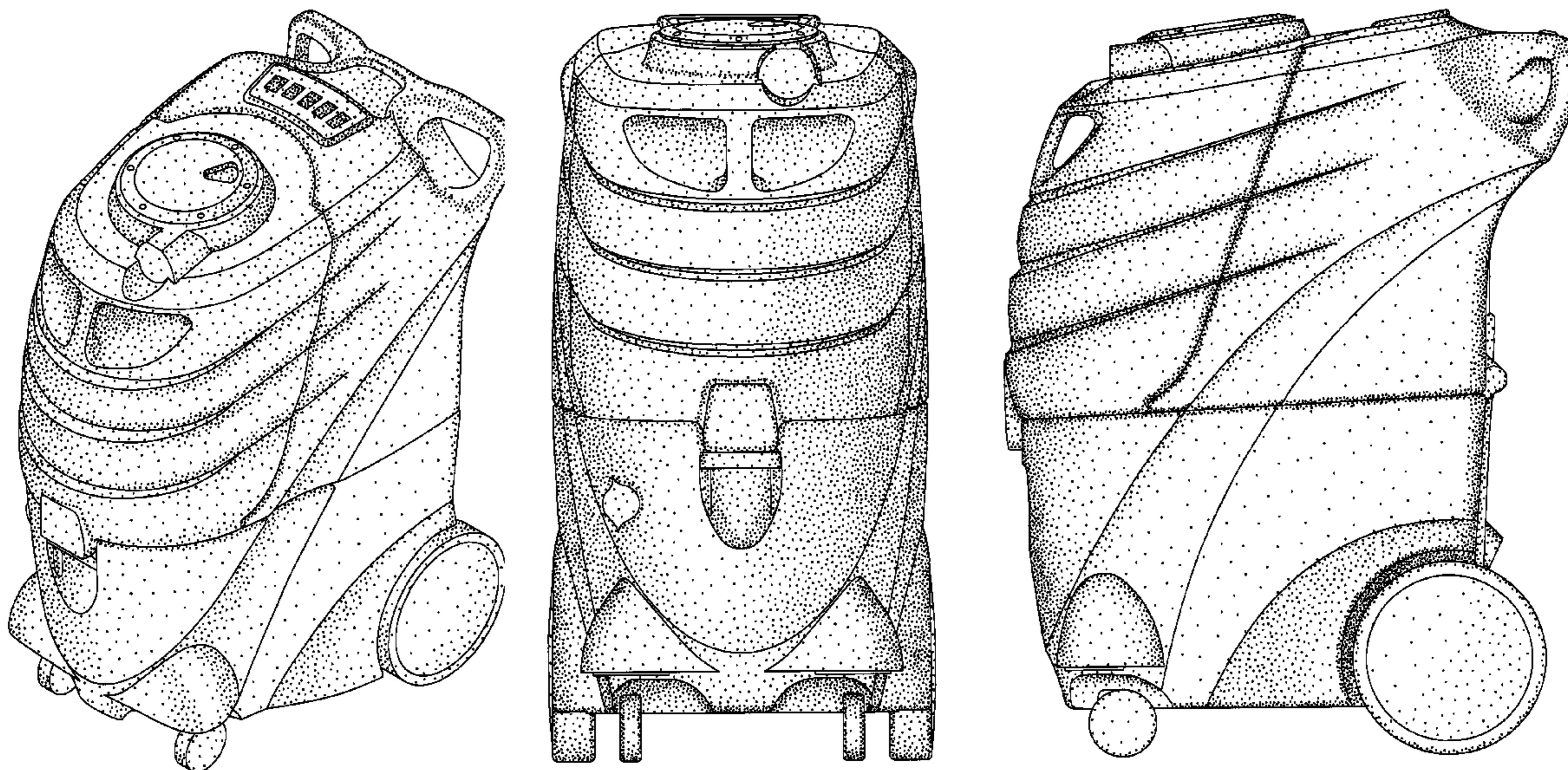
FIG. 4 is a side elevation view;

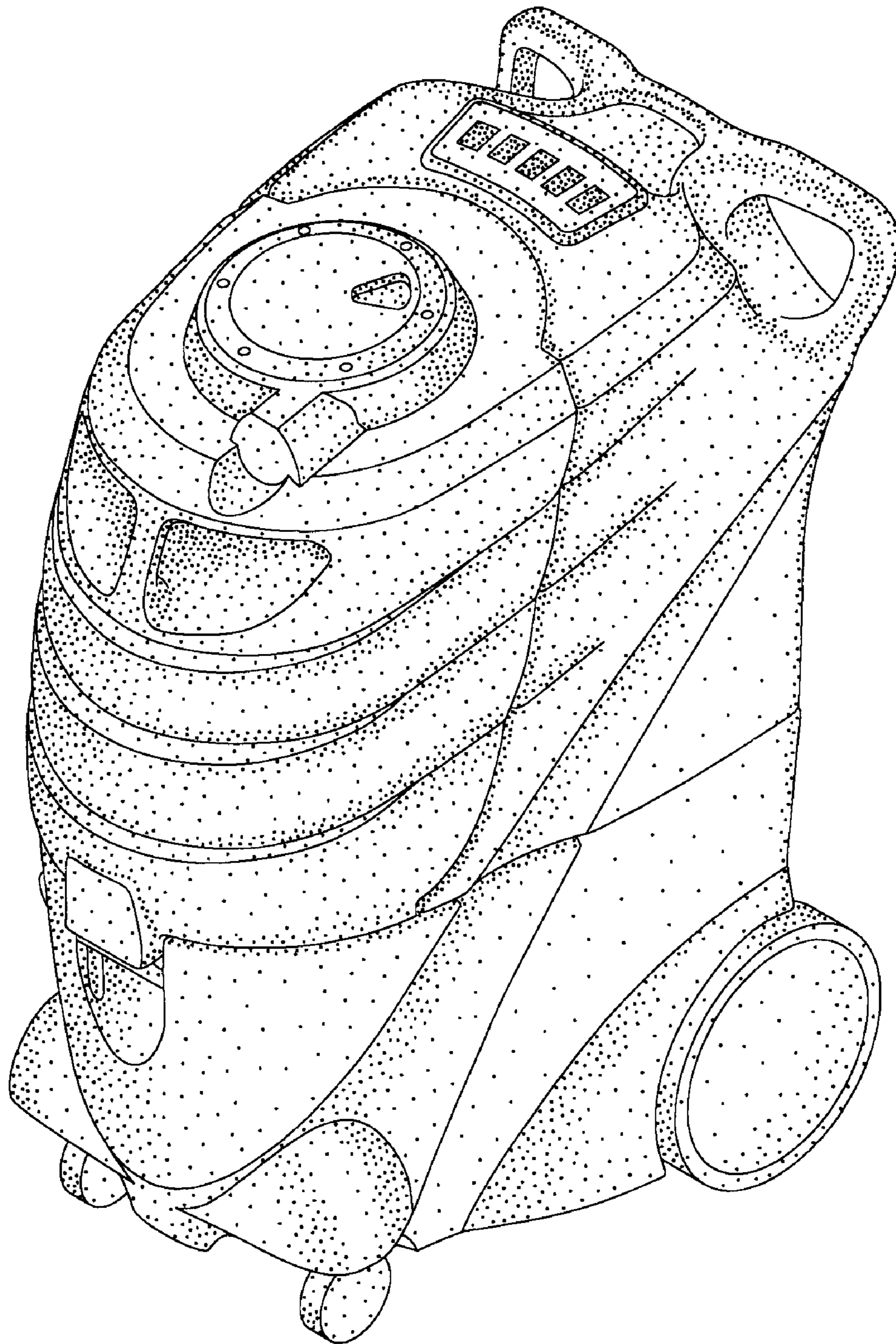

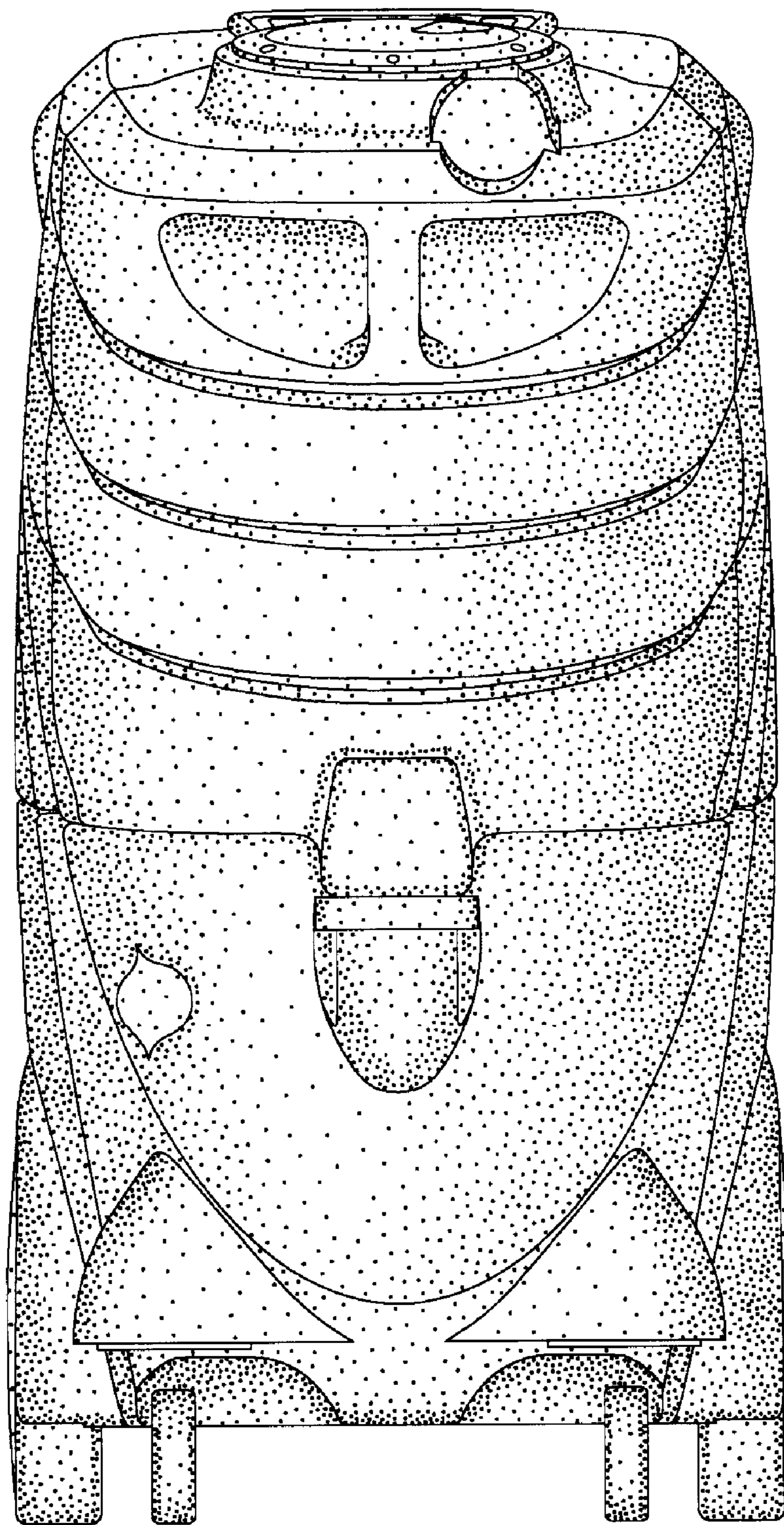

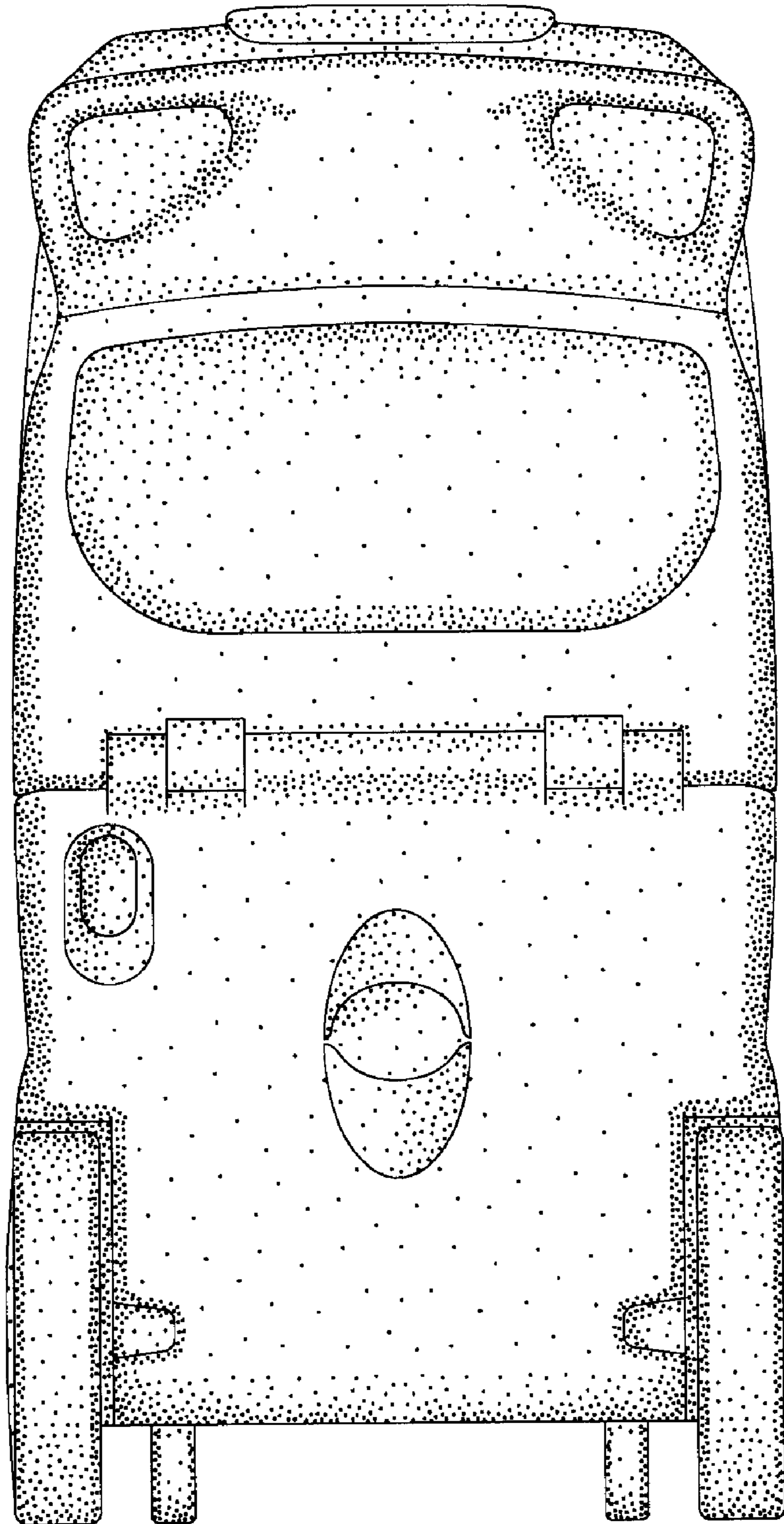

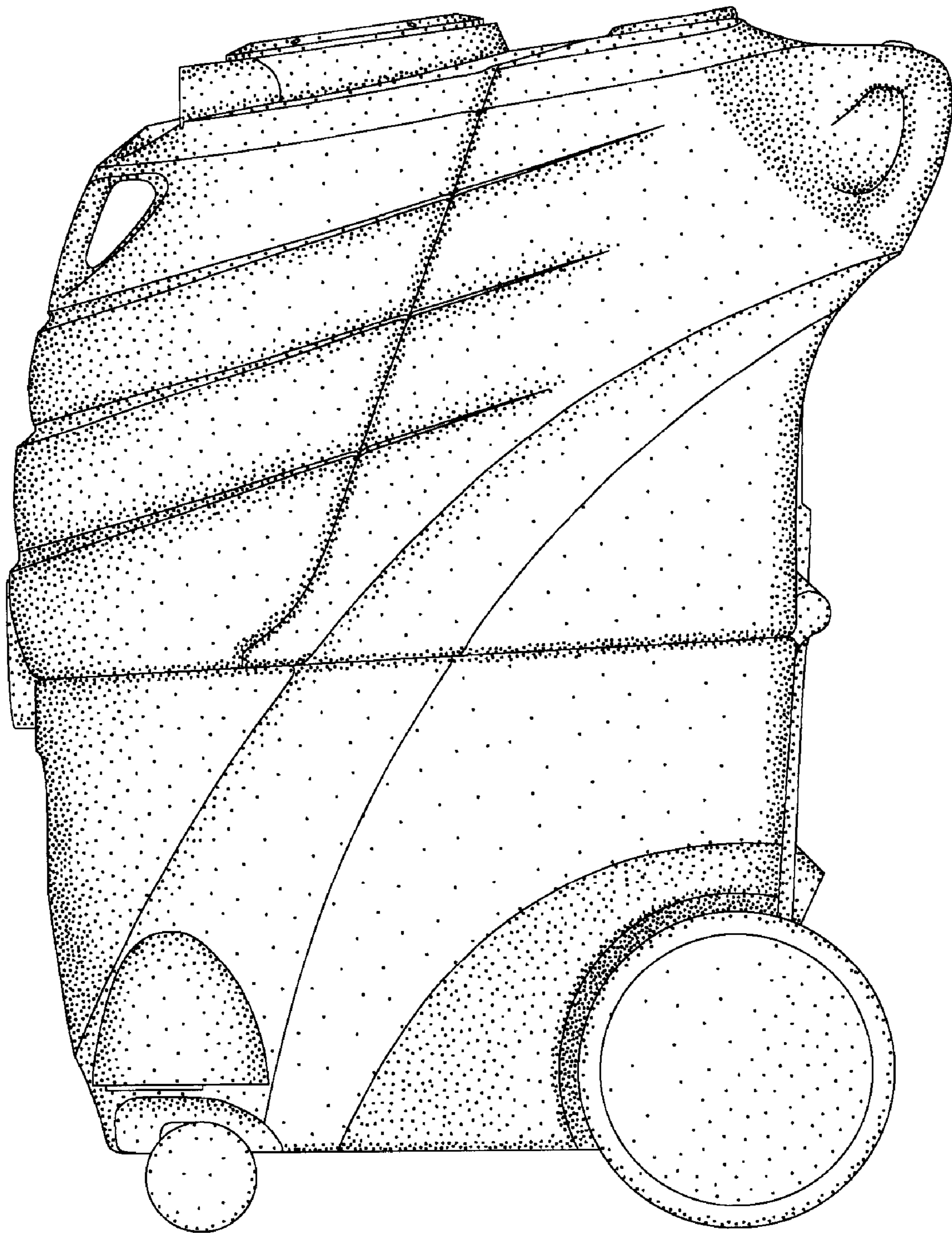

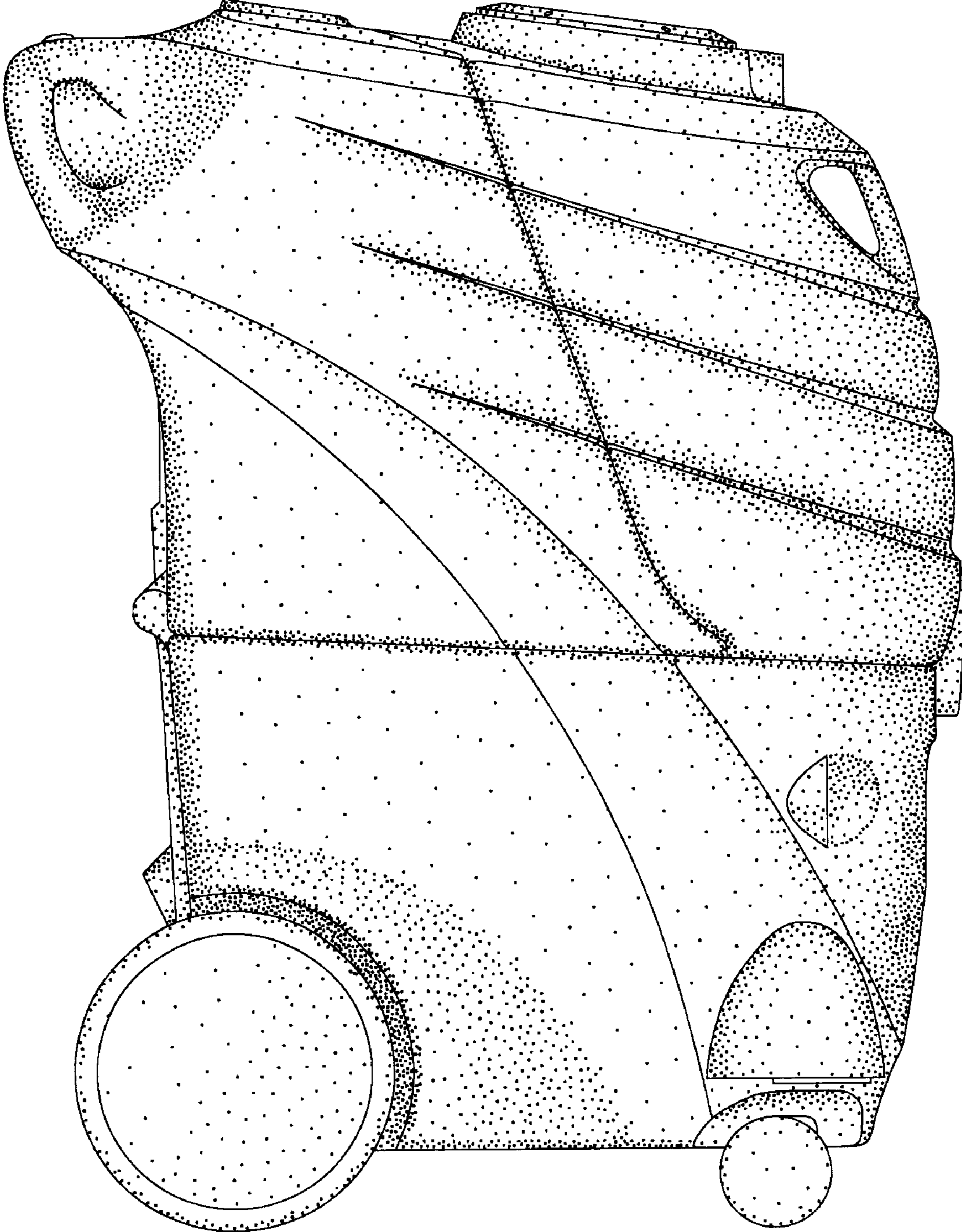

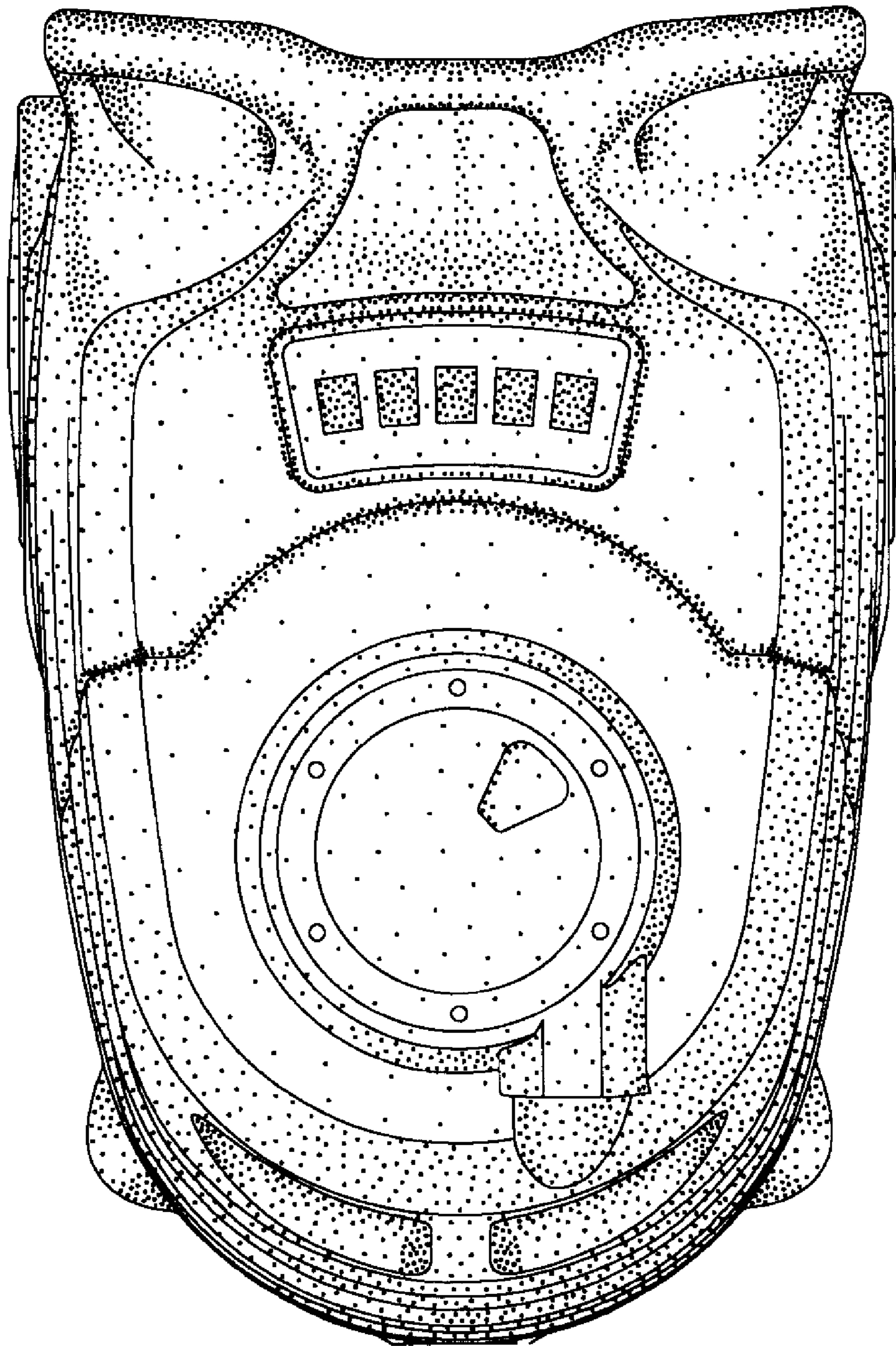

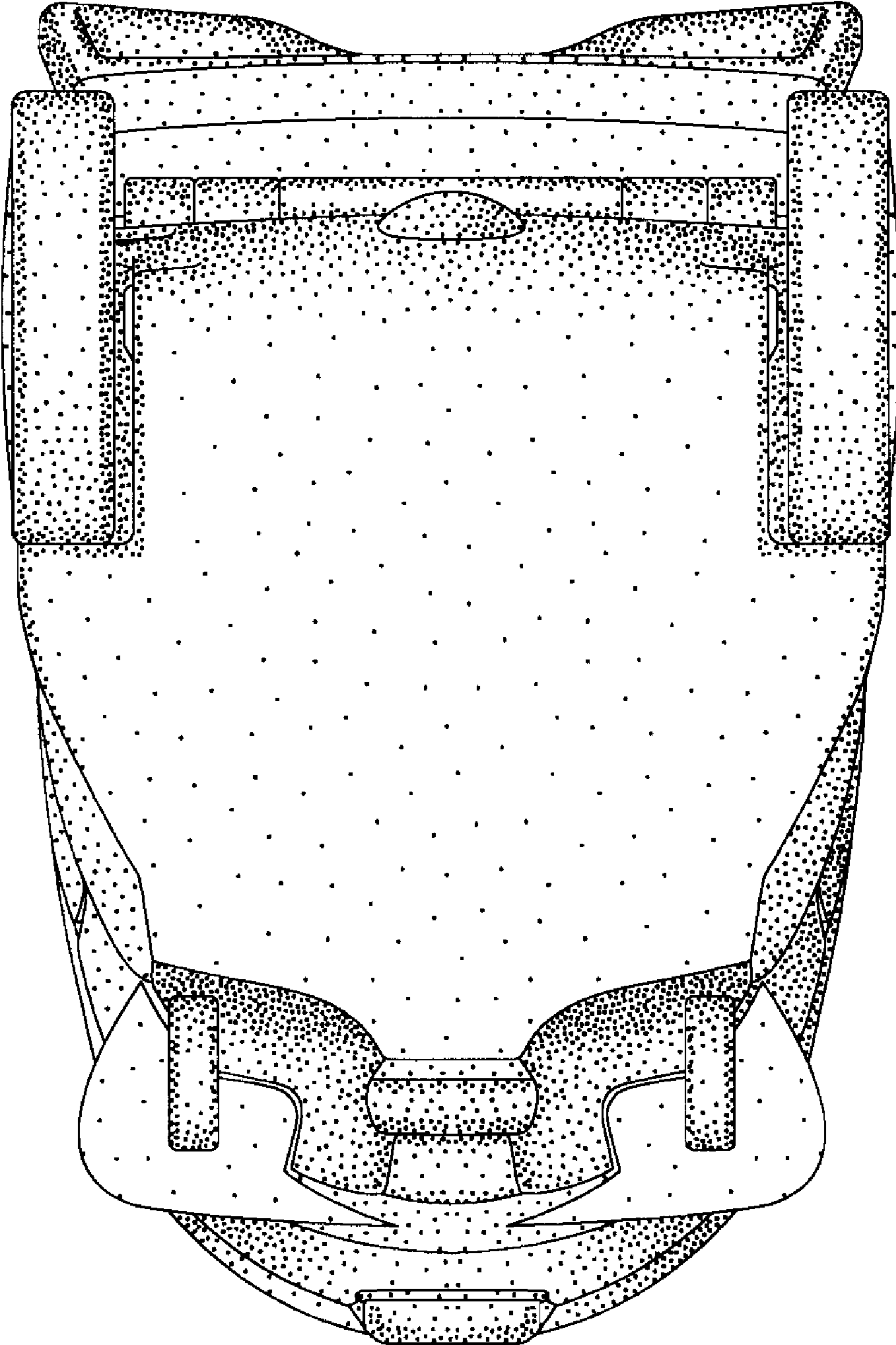
