DESCRIPTION

FIG. 4 is a back elevation view;

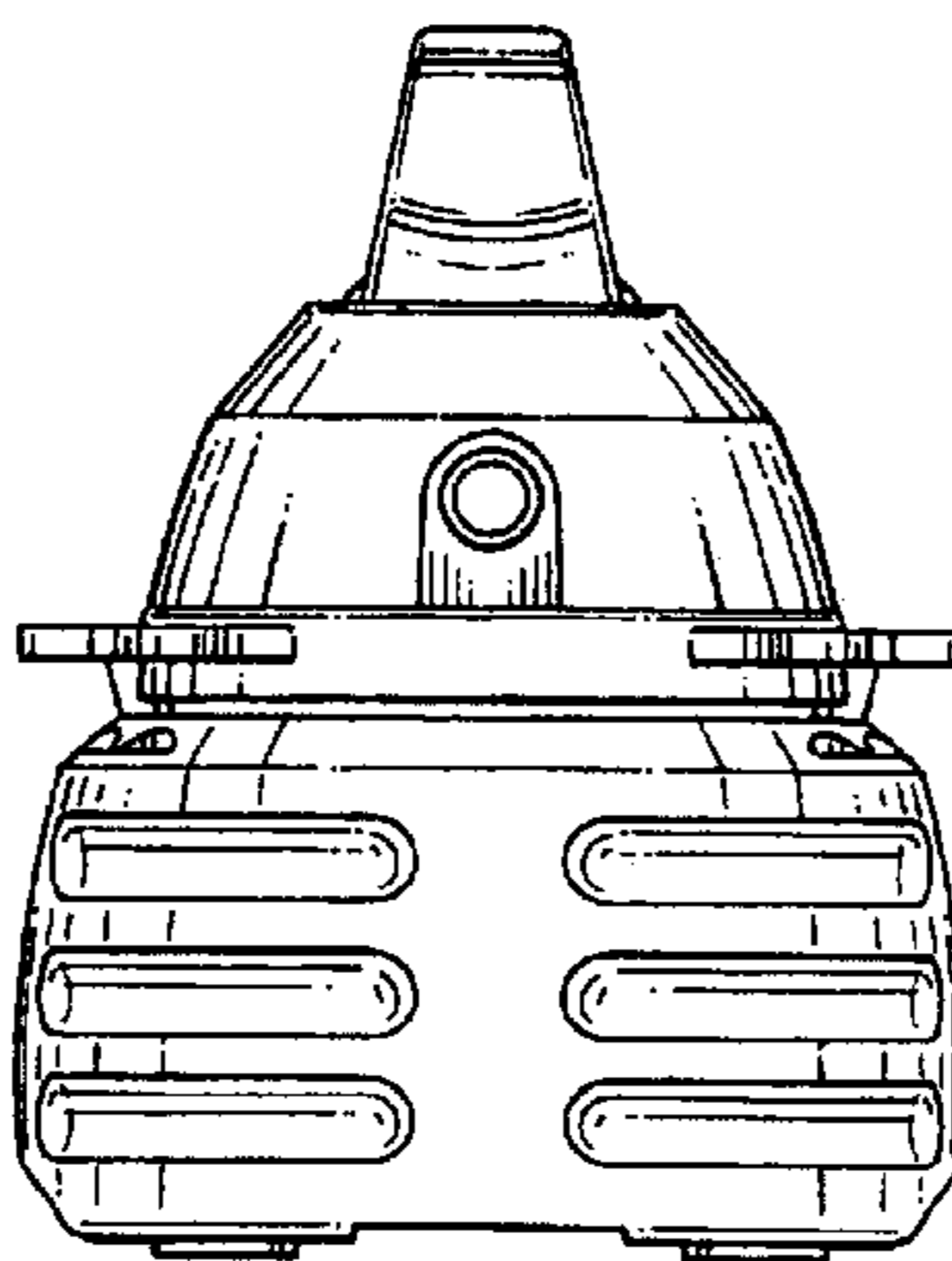
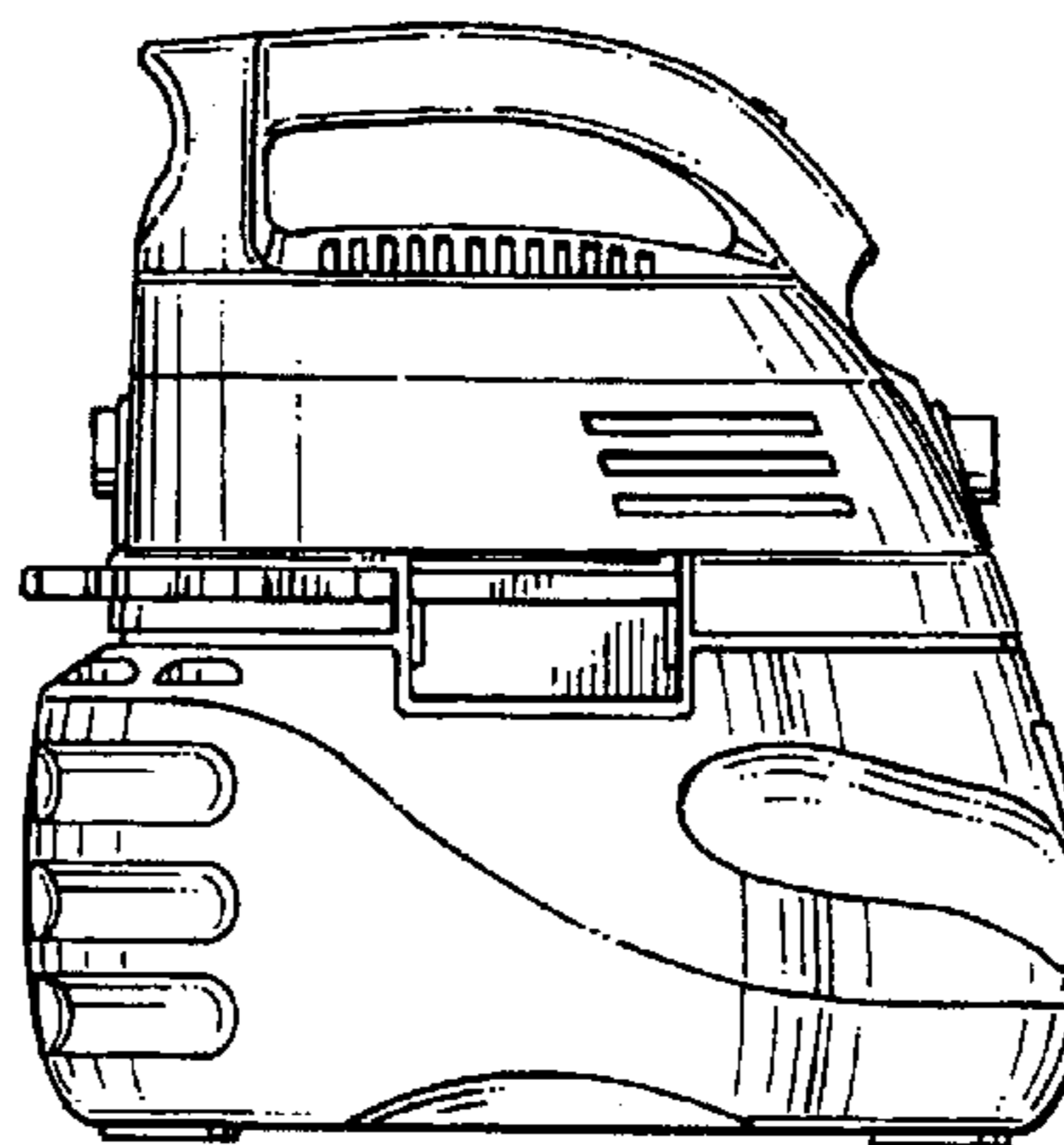
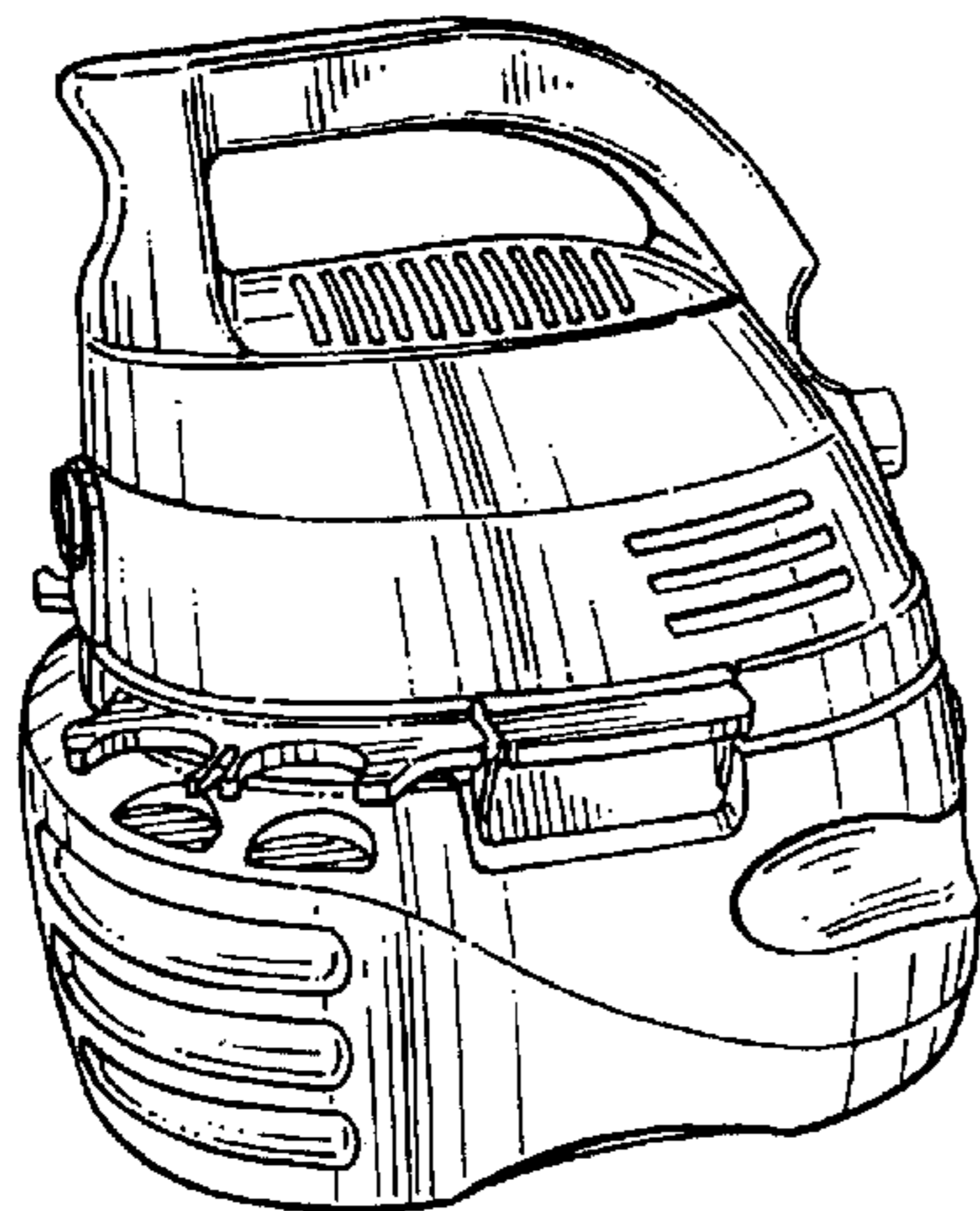
FIG. 5 is a front elevation view;

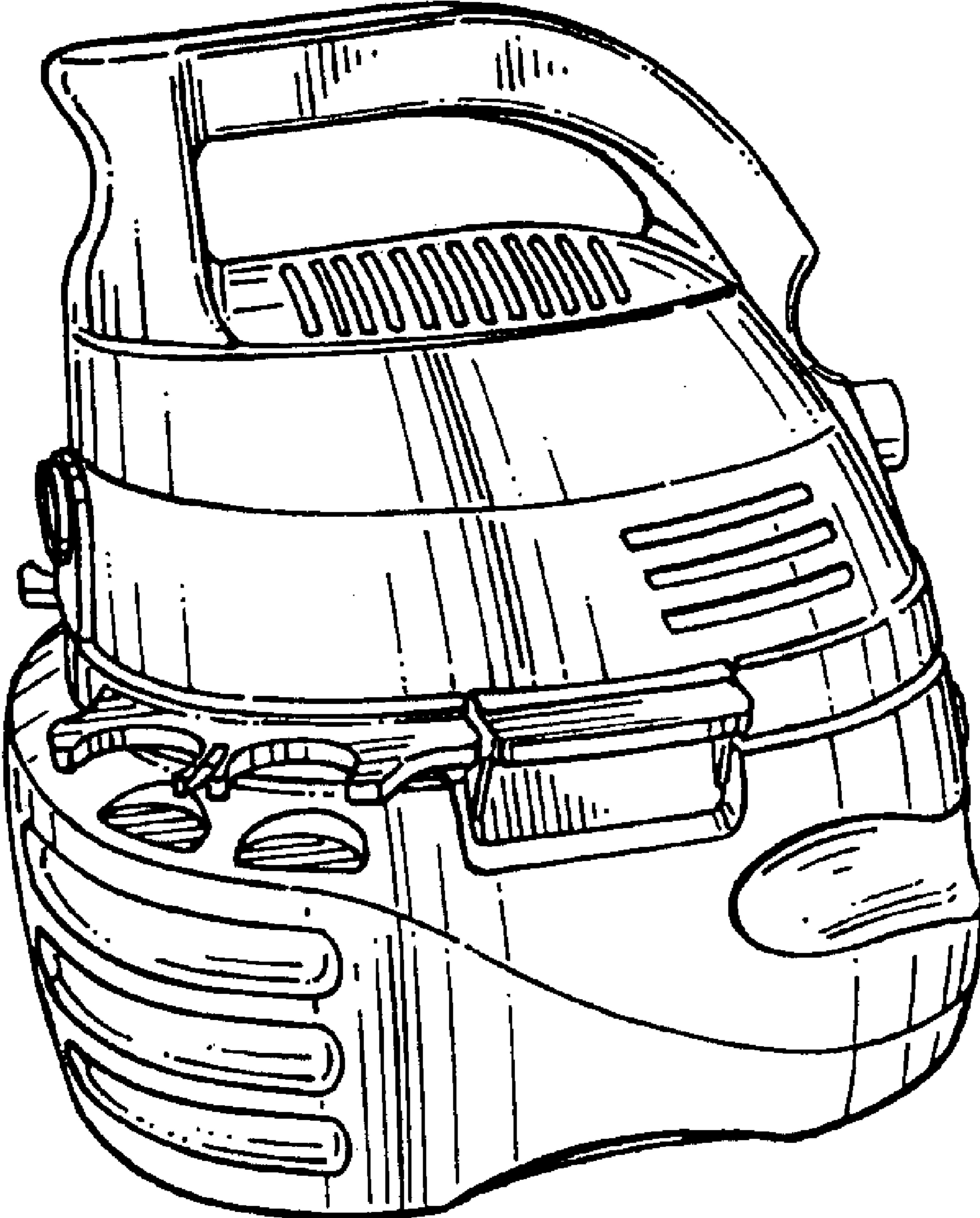

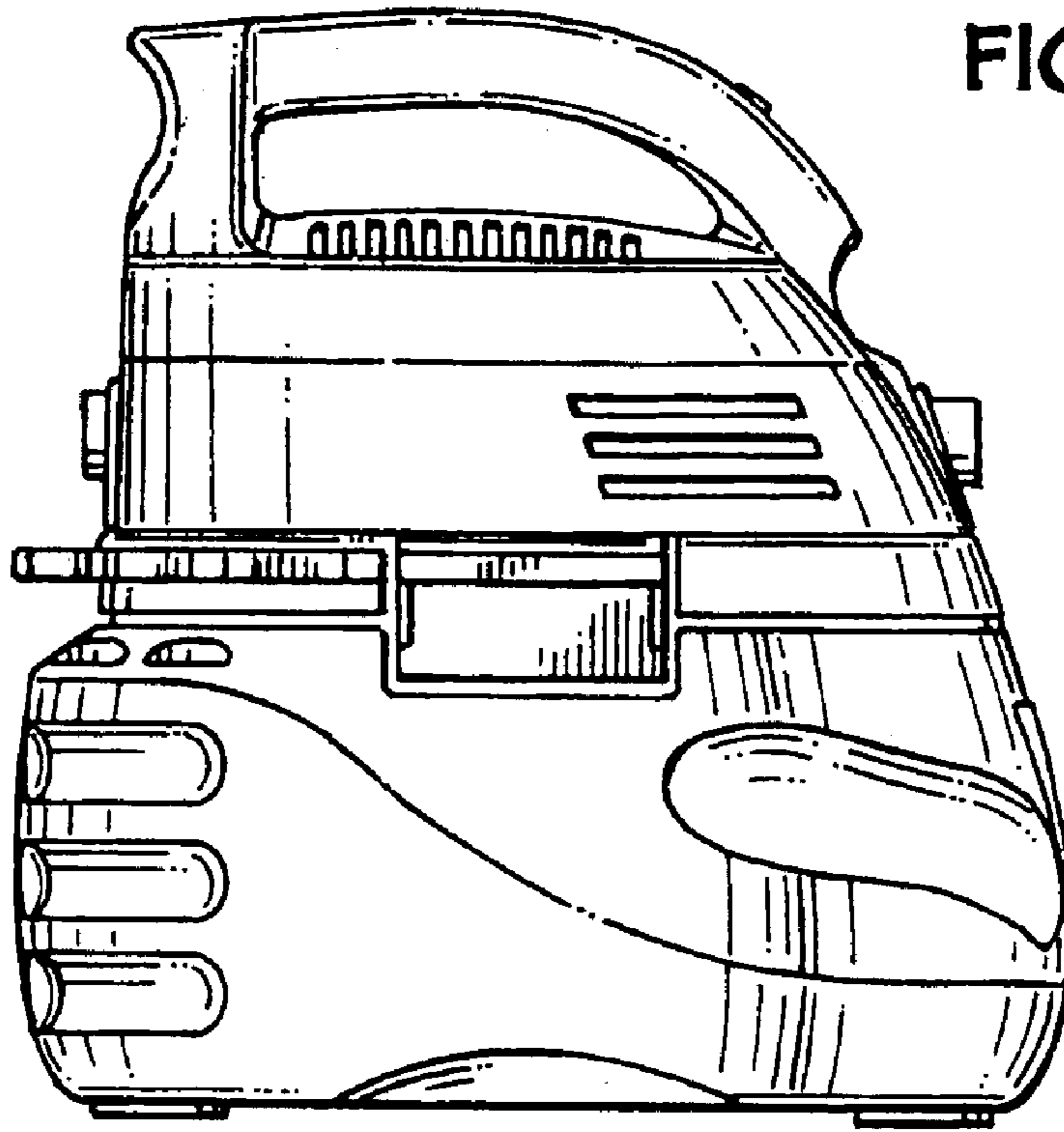

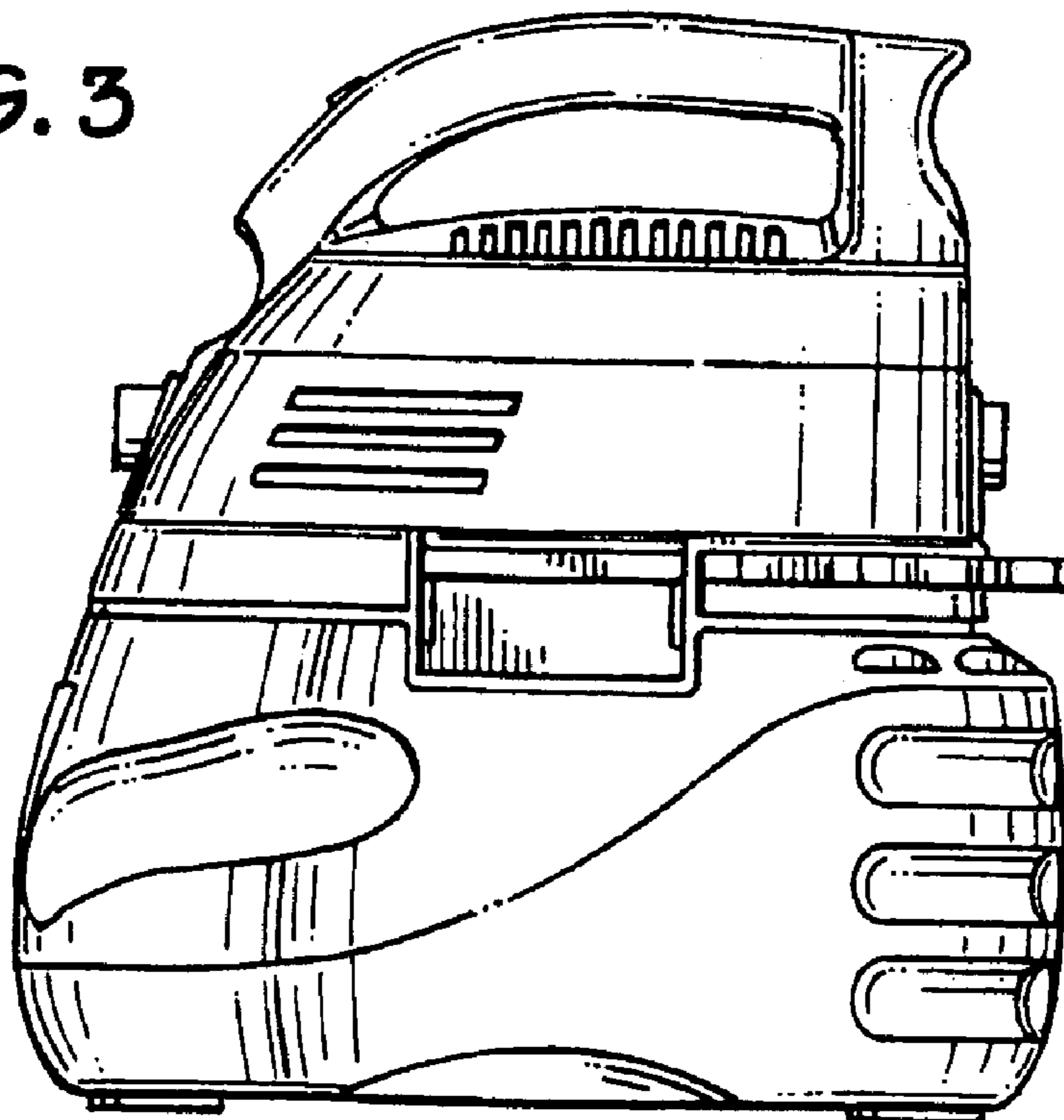

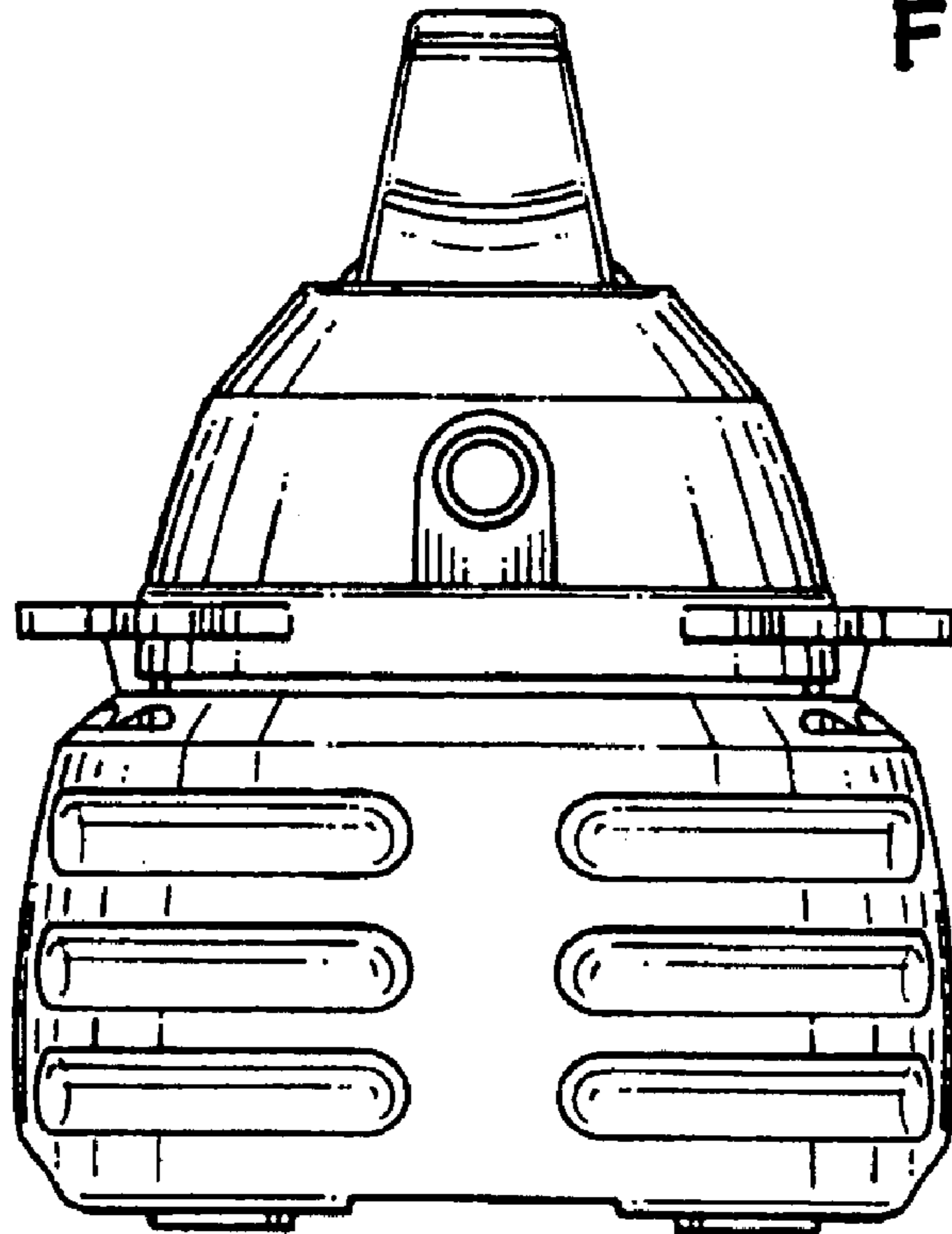

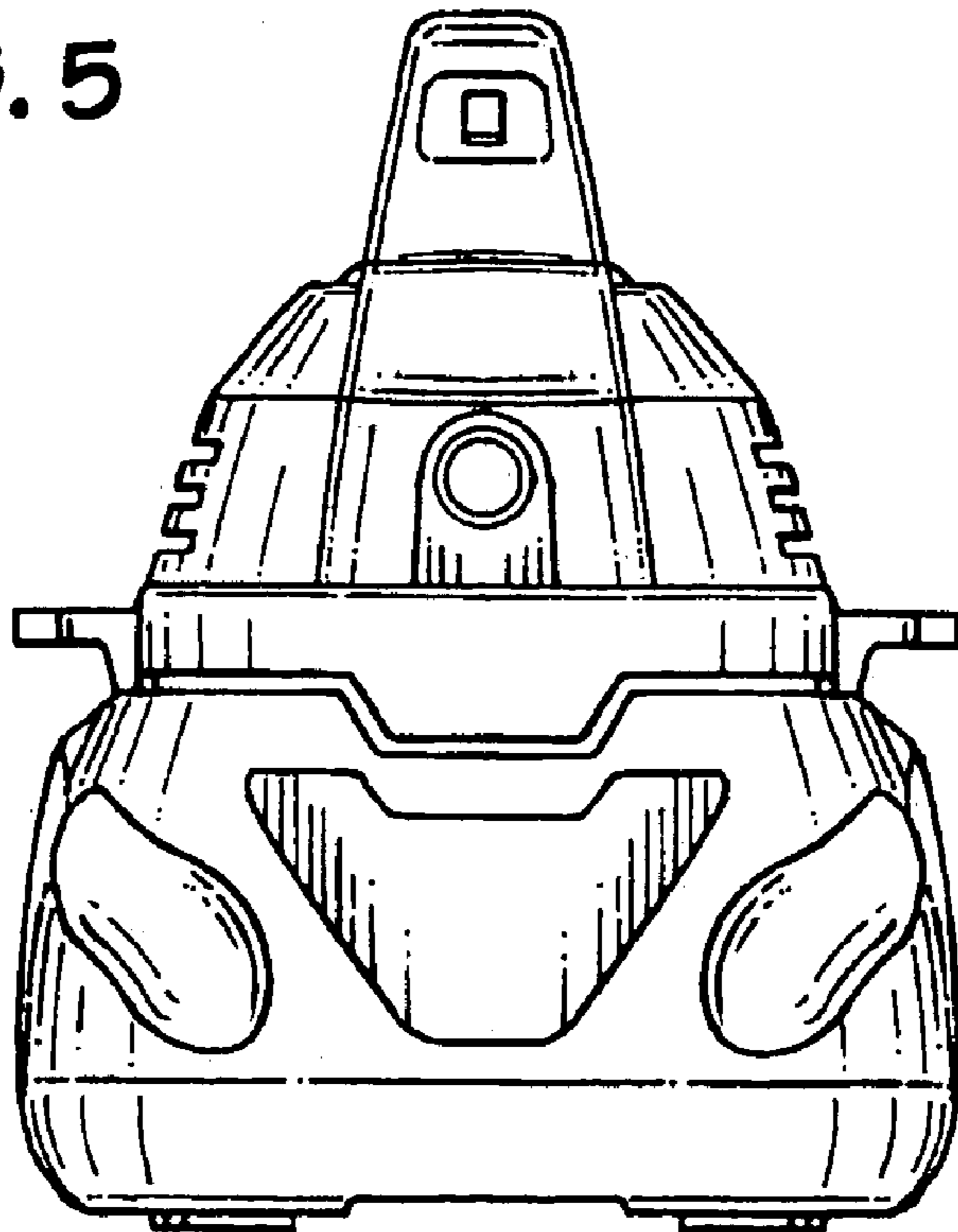

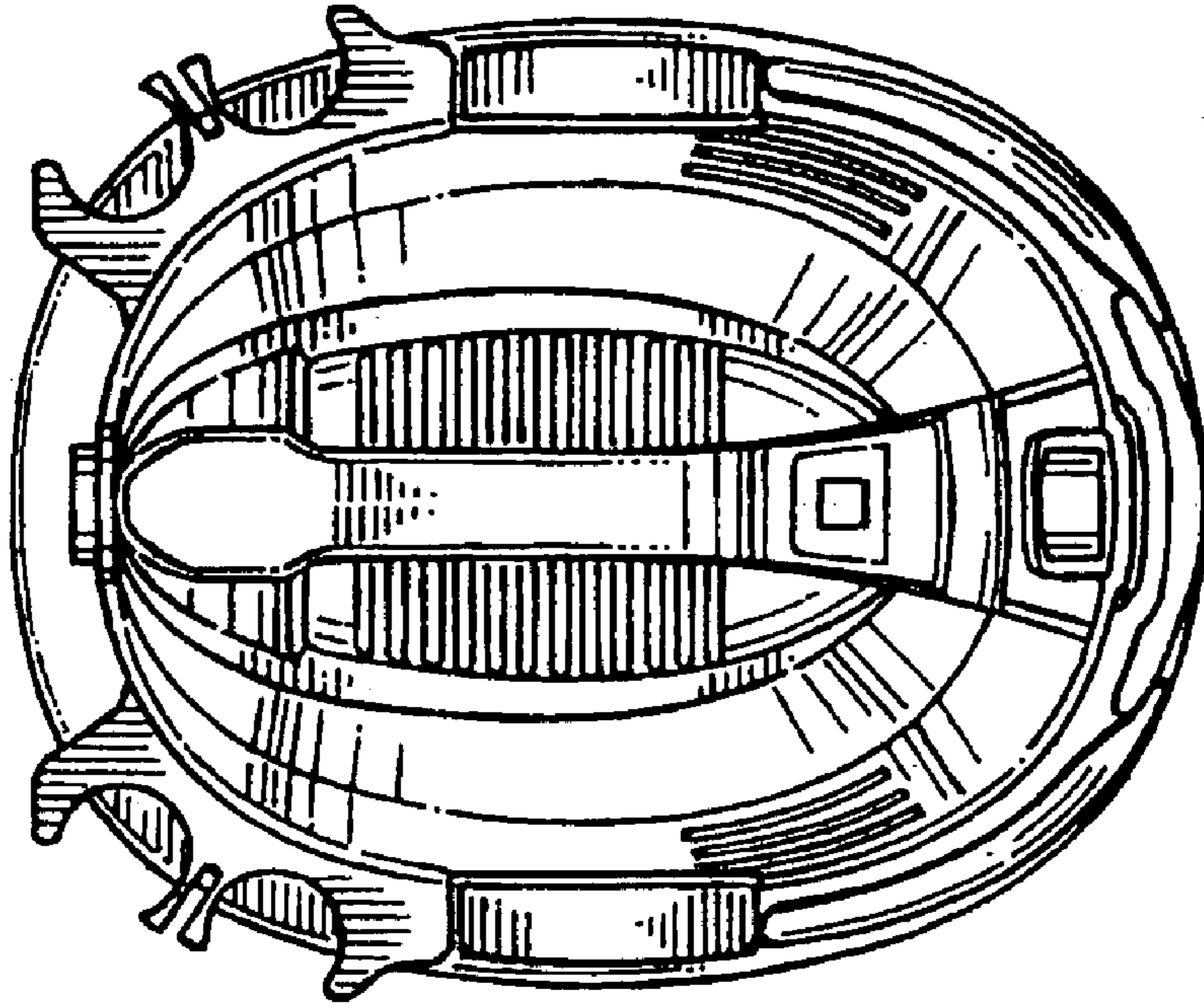
