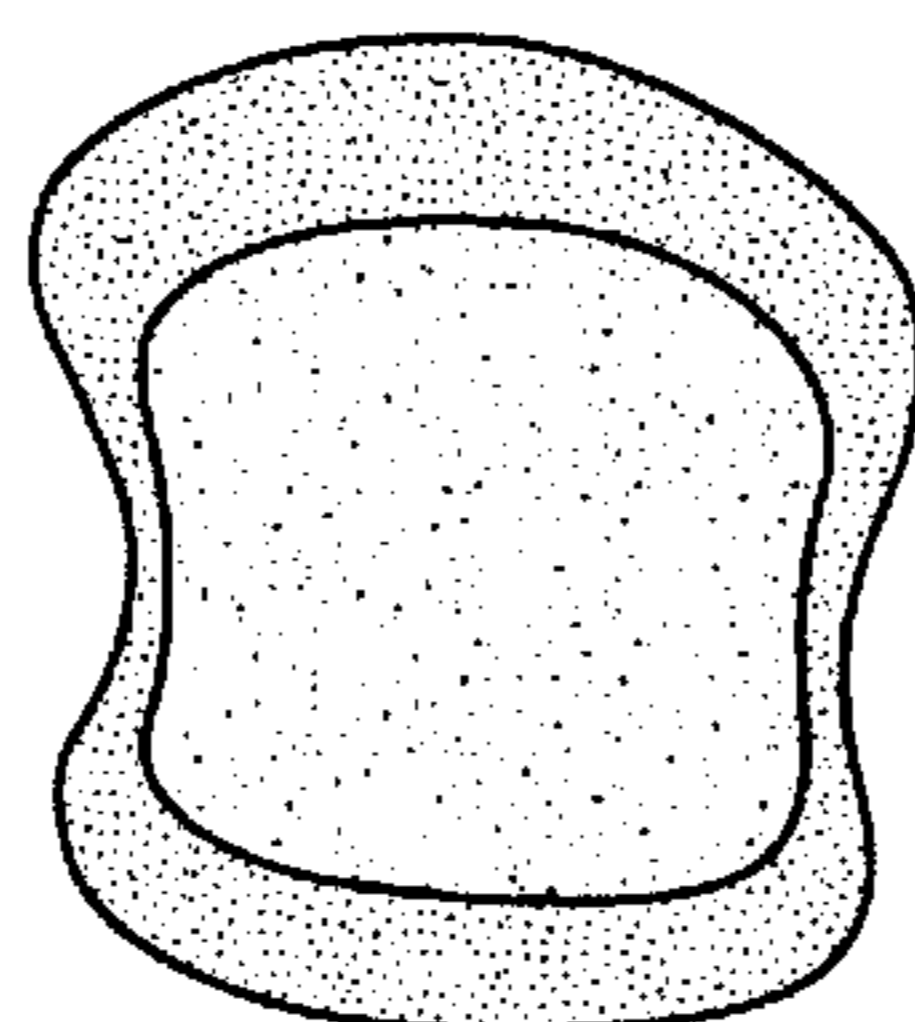
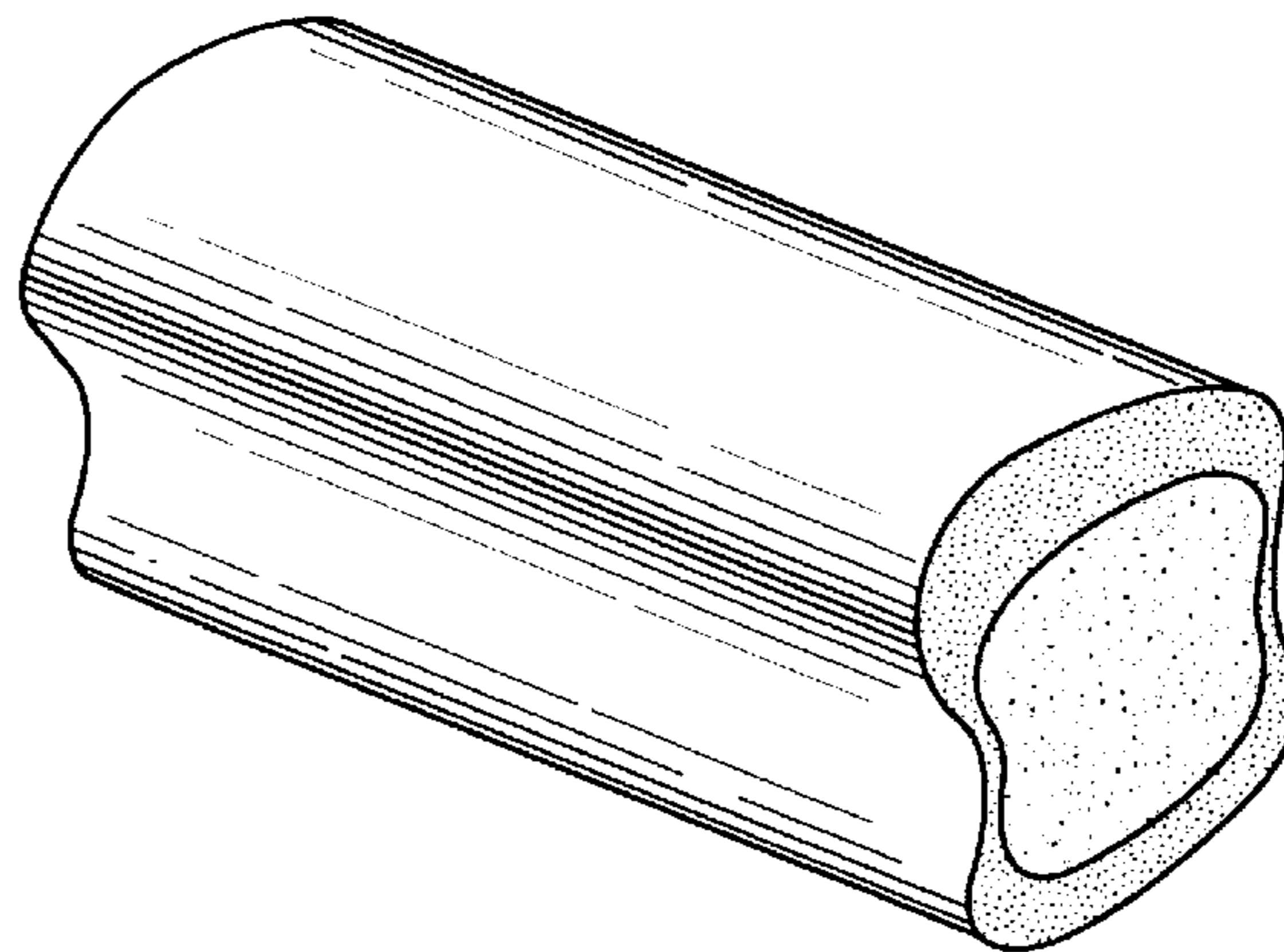
(57) **CLAIM**

The ornamental design for a pet treat bone, substantially as shown and described.

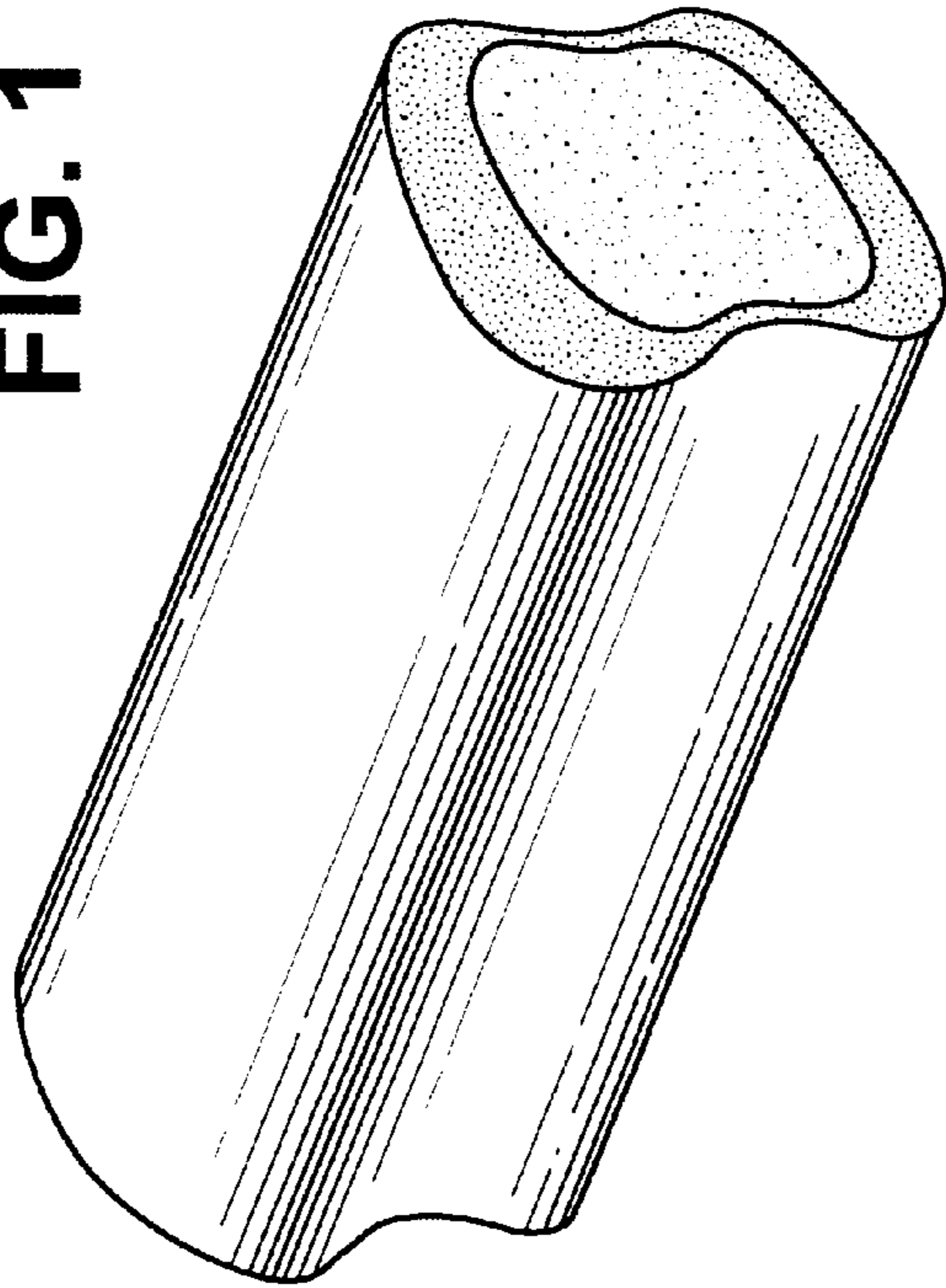
**DESCRIPTION**

FIG. 1 is a perspective view of the top, front, and right side of the pet treat bone, showing our new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a side elevational view of the left side thereof;  
FIG. 4 is a rear elevational view thereof;  
FIG. 5 is a side elevational view of the right side thereof;

FIG. 7 is a bottom plan view thereof.

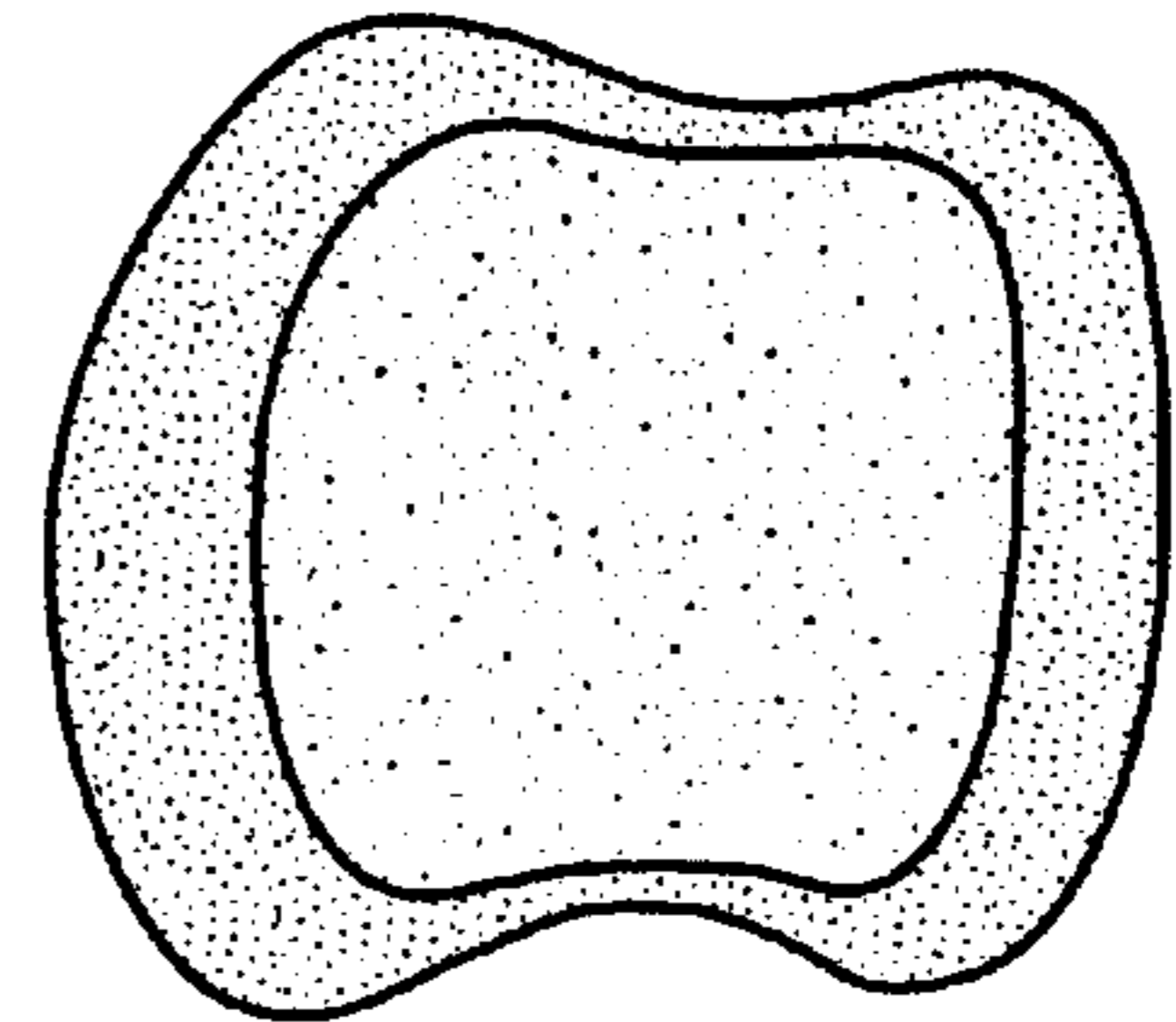

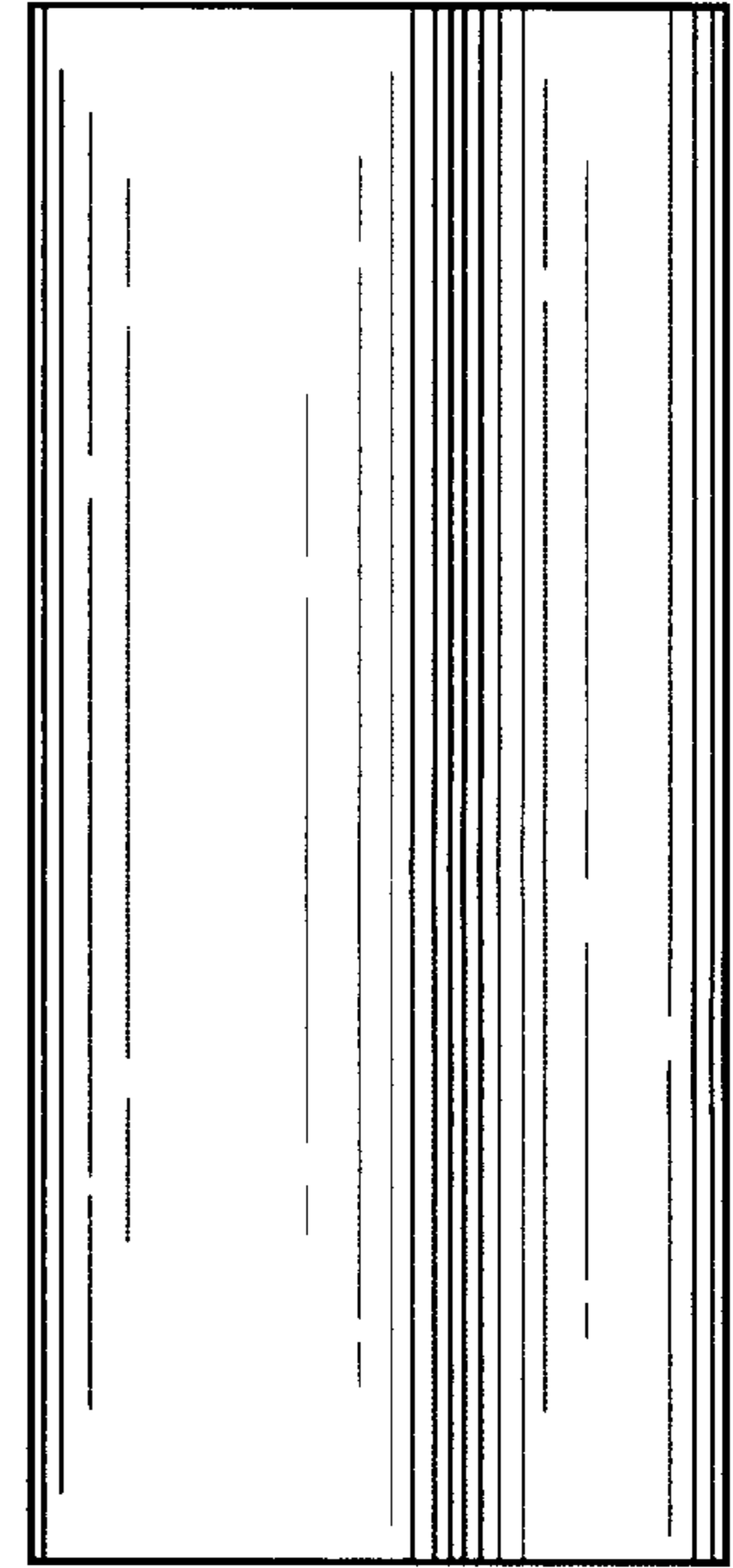

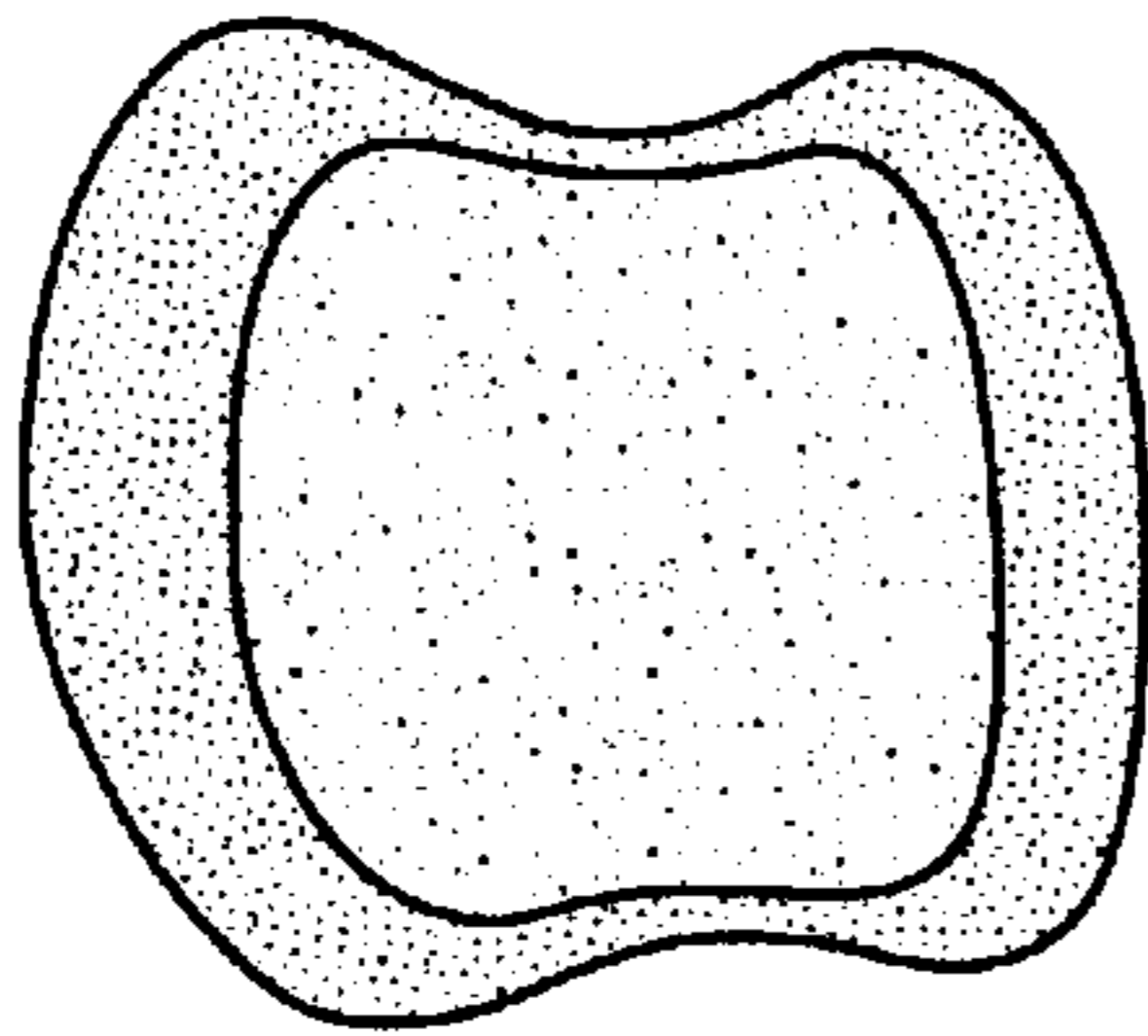

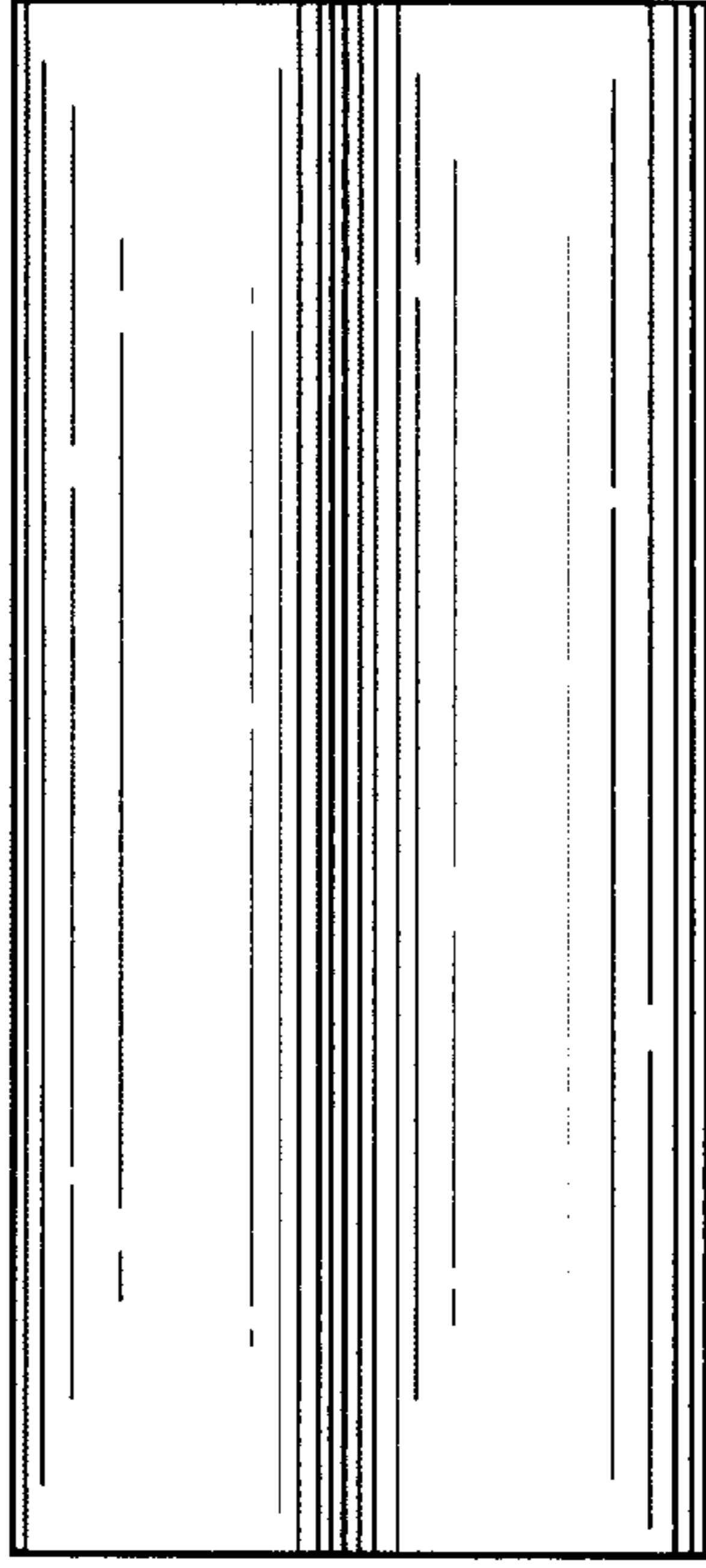

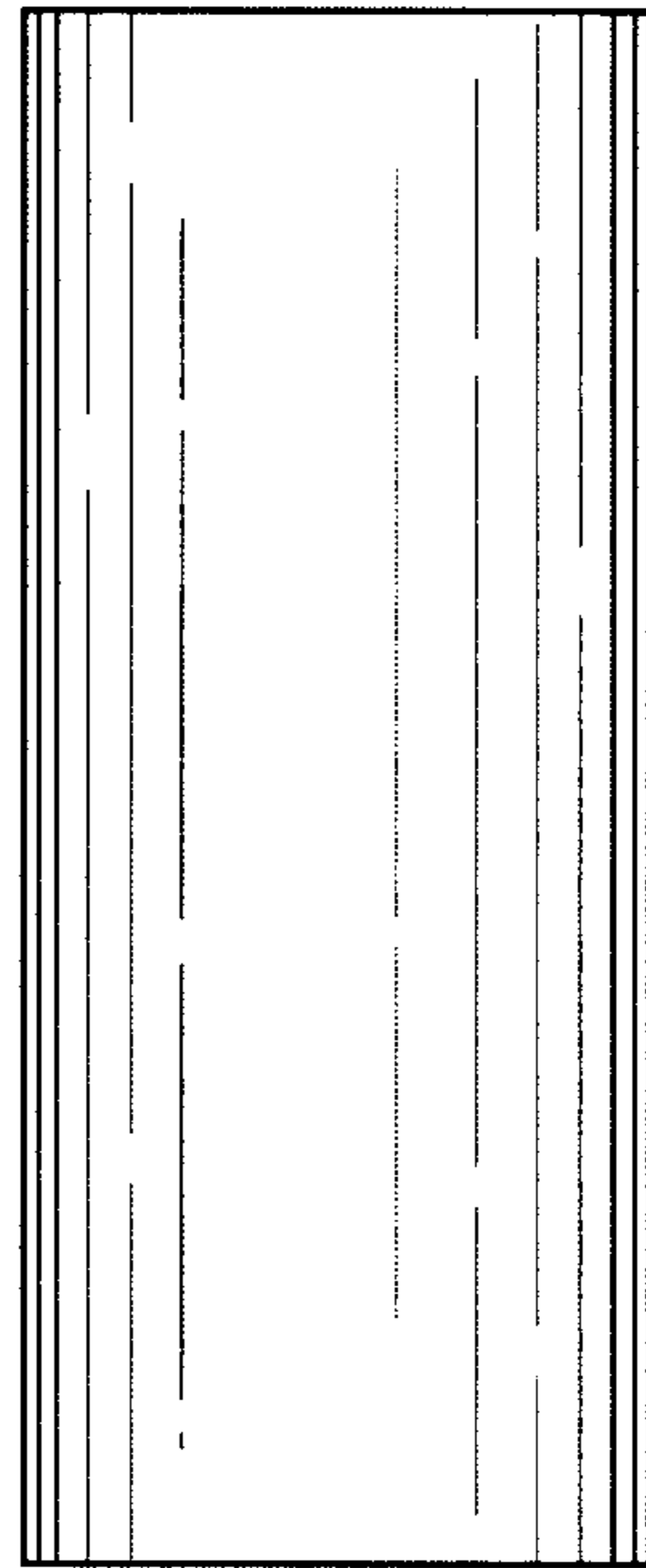
