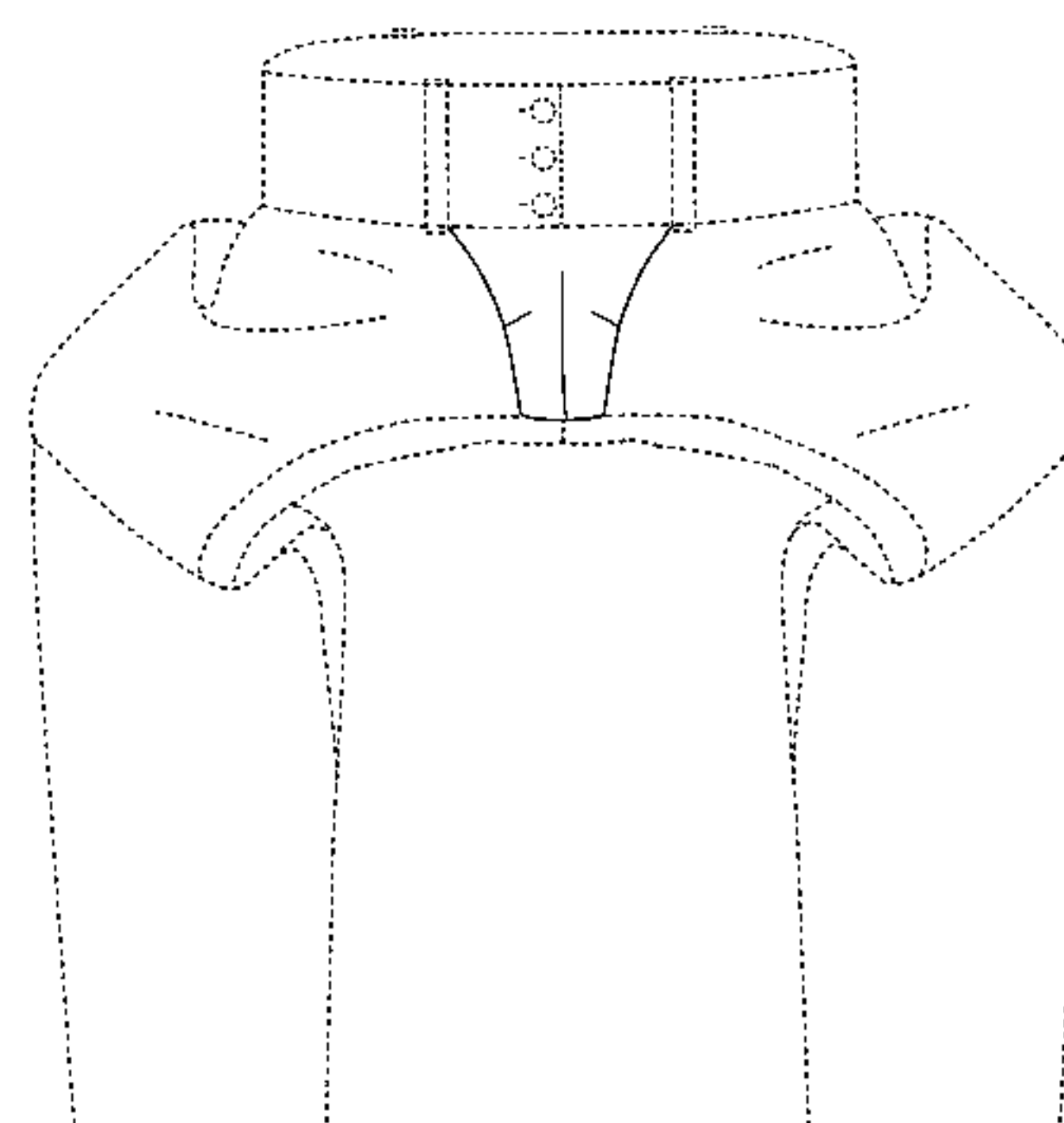
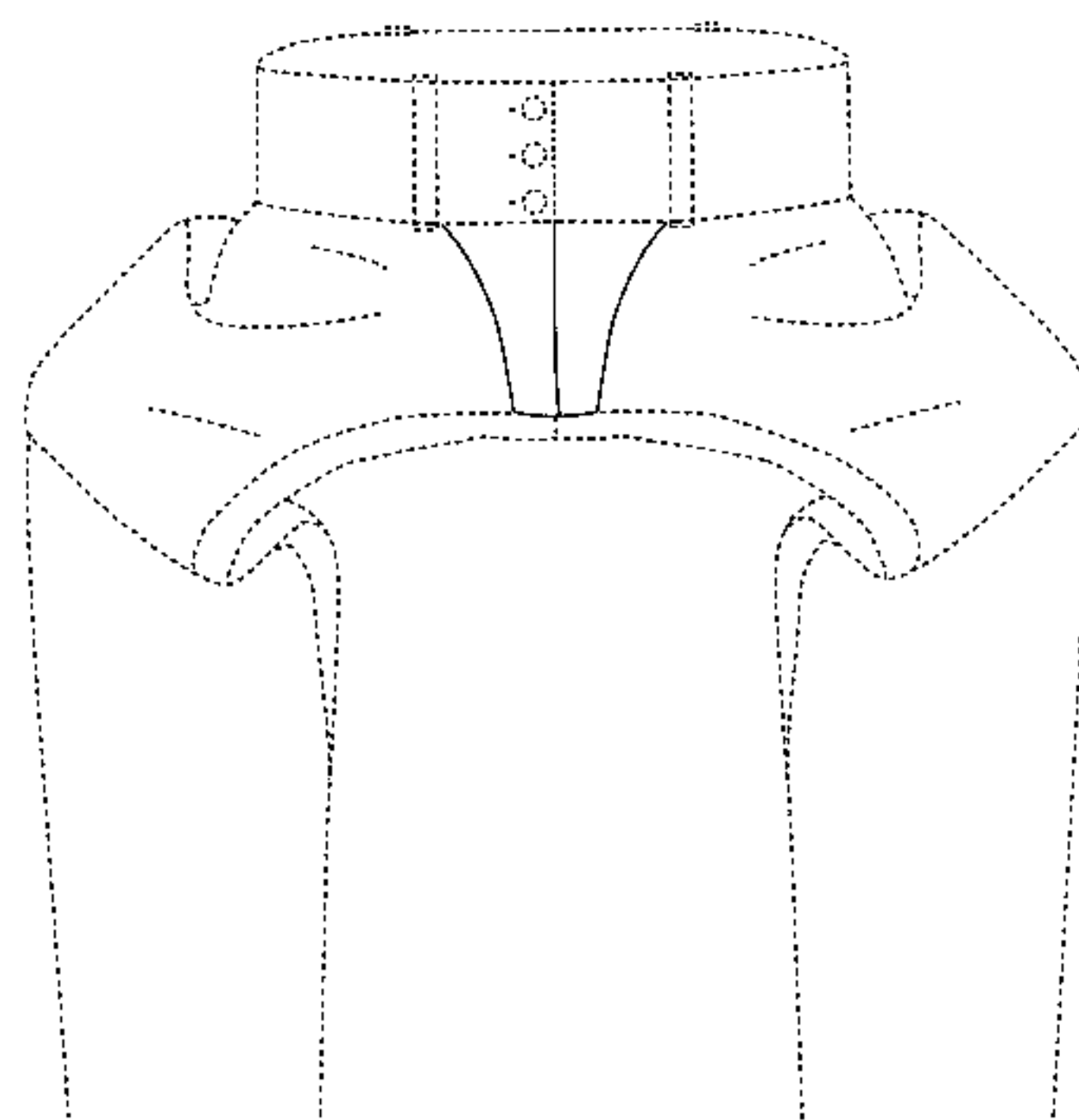
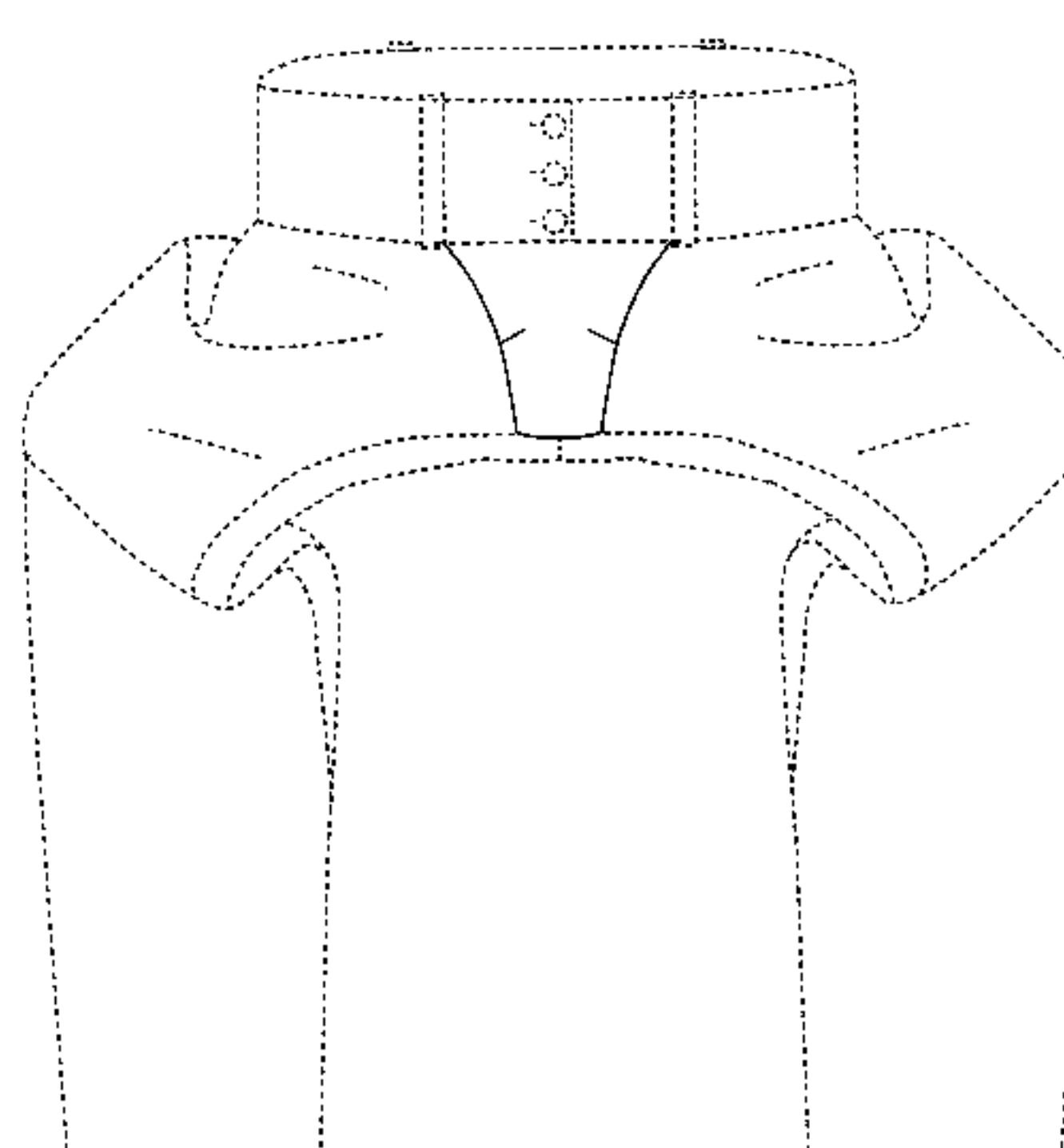
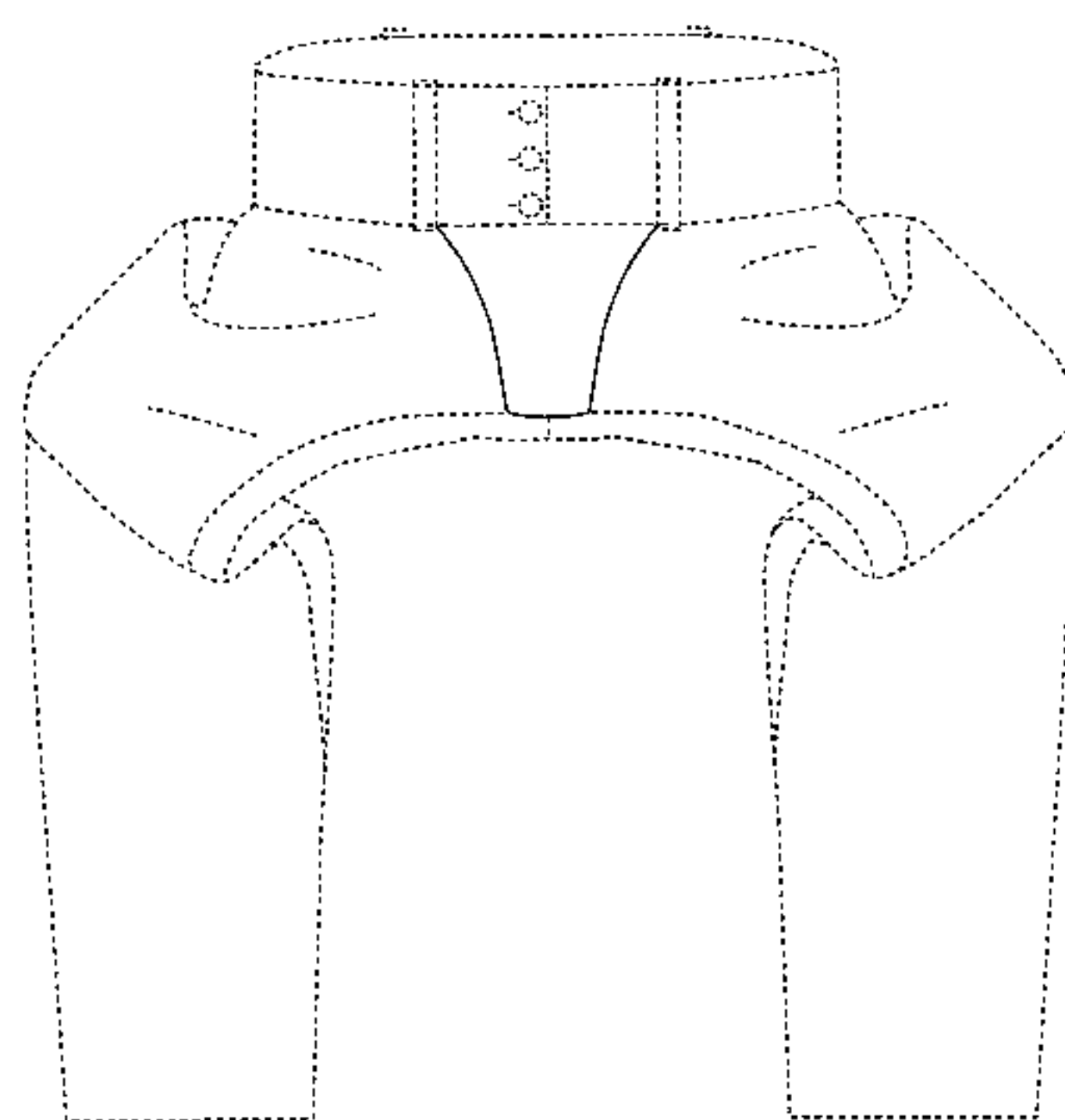
(57) **CLAIM**

The ornamental design for the crotch for trousers, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a first embodiment of a crotch for trousers showing my new design;
 FIG. 2 is a front elevational view of a second embodiment of a crotch for trousers
 FIG. 3 is a front elevational view of a third embodiment of a crotch for trousers; and,
 FIG. 4 is a front elevational view of a fourth embodiment of a crotch for trousers.
 The broken line at the bottom of the waistband defines the bounds of the claimed design form no part thereof.

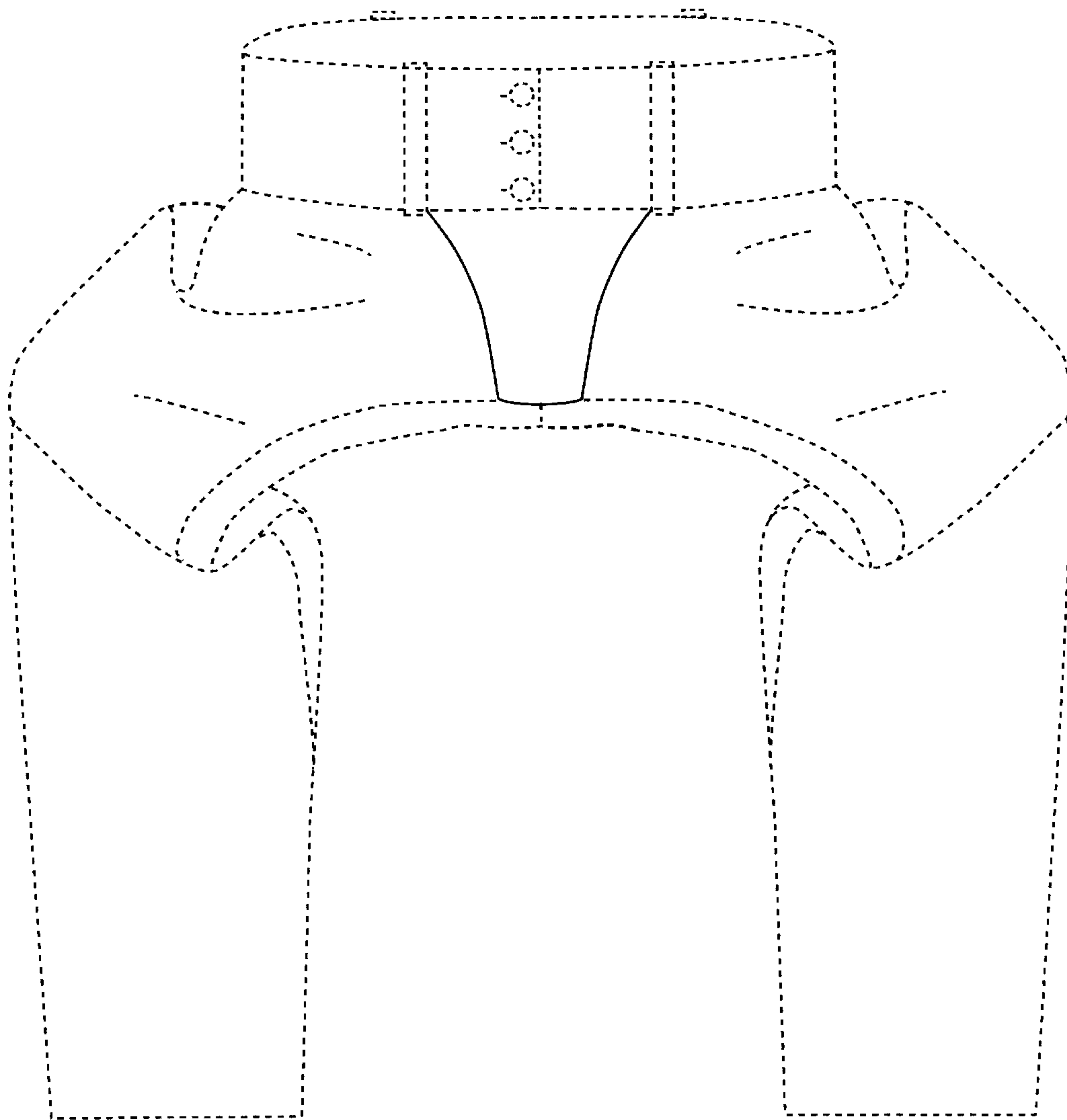

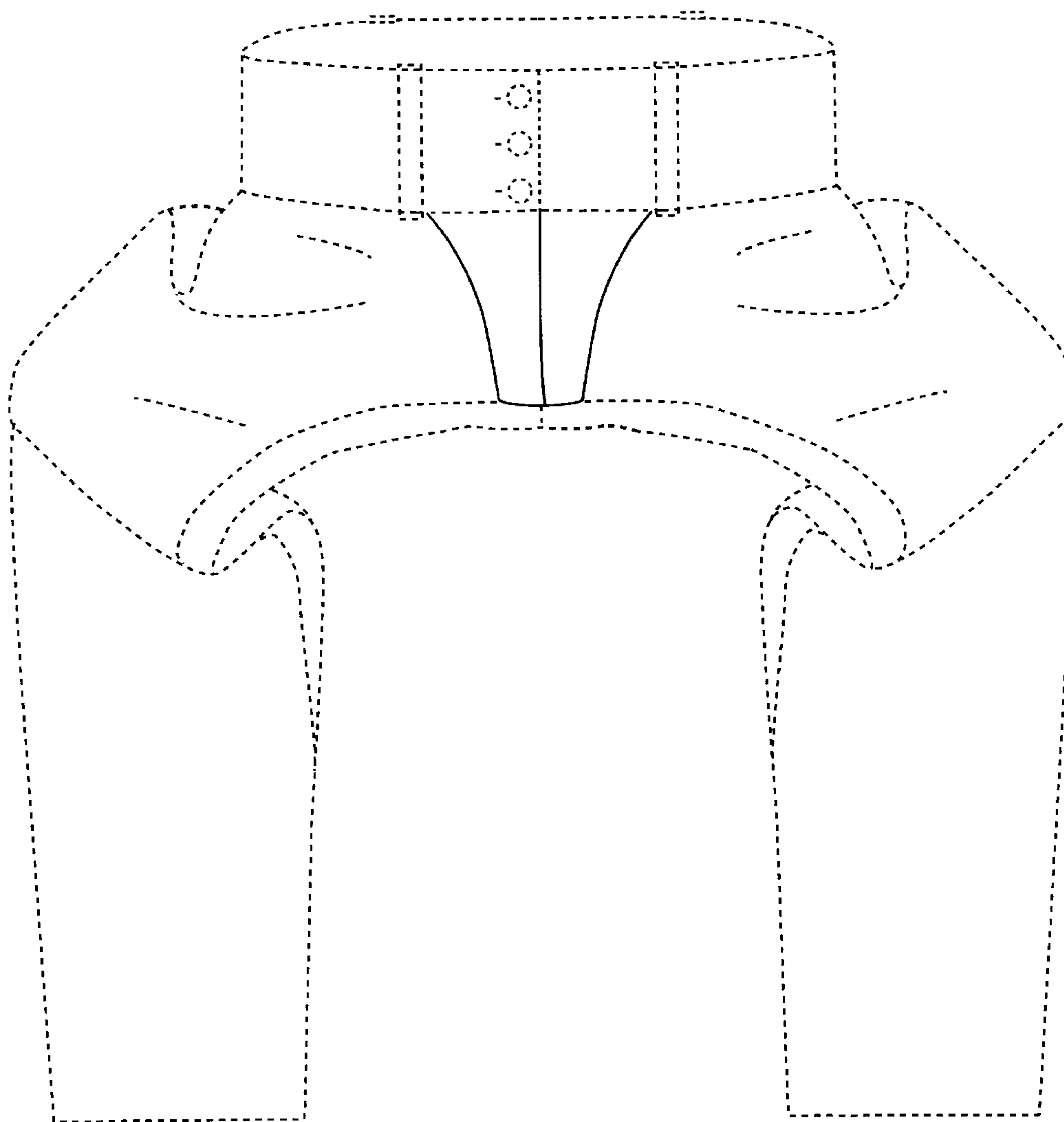

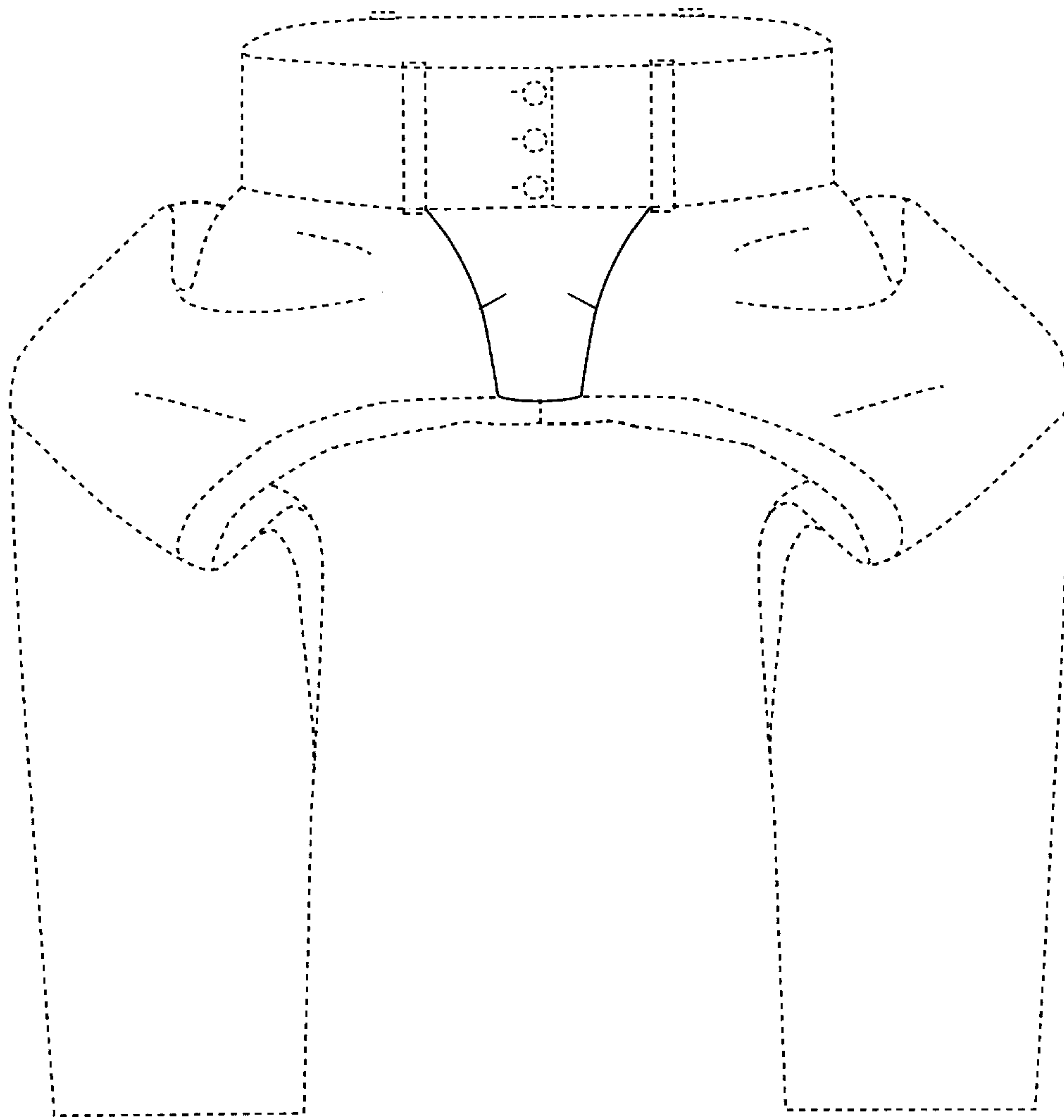

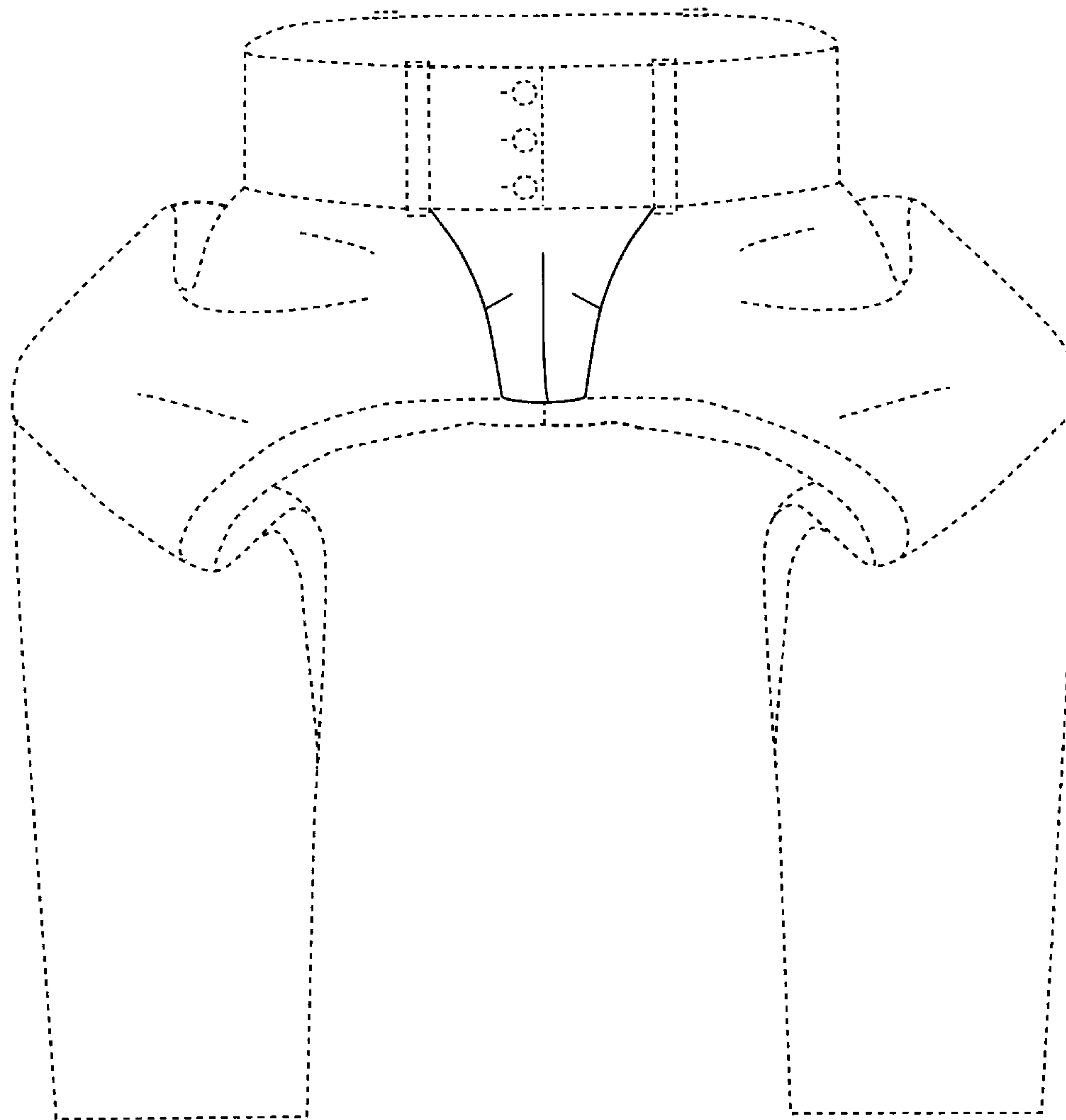
