DESCRIPTION

FIG. 1 is a front elevational view of the paintball marker case of the present invention;

FIG. 2 is a back elevational view of the paintball marker case of FIG. 1;

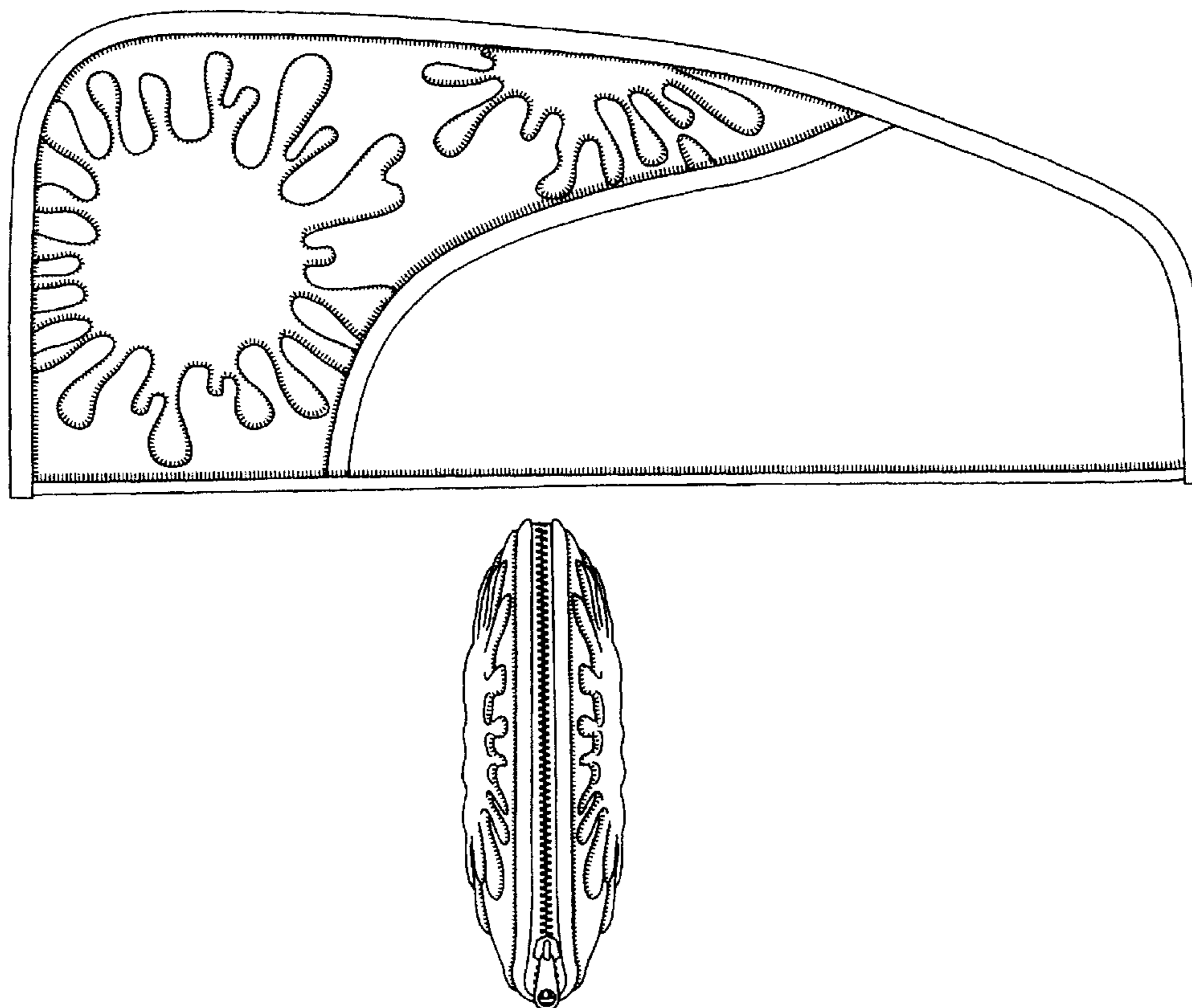
FIG. 3 is a right side elevational view of the paintball marker case of FIG. 1;

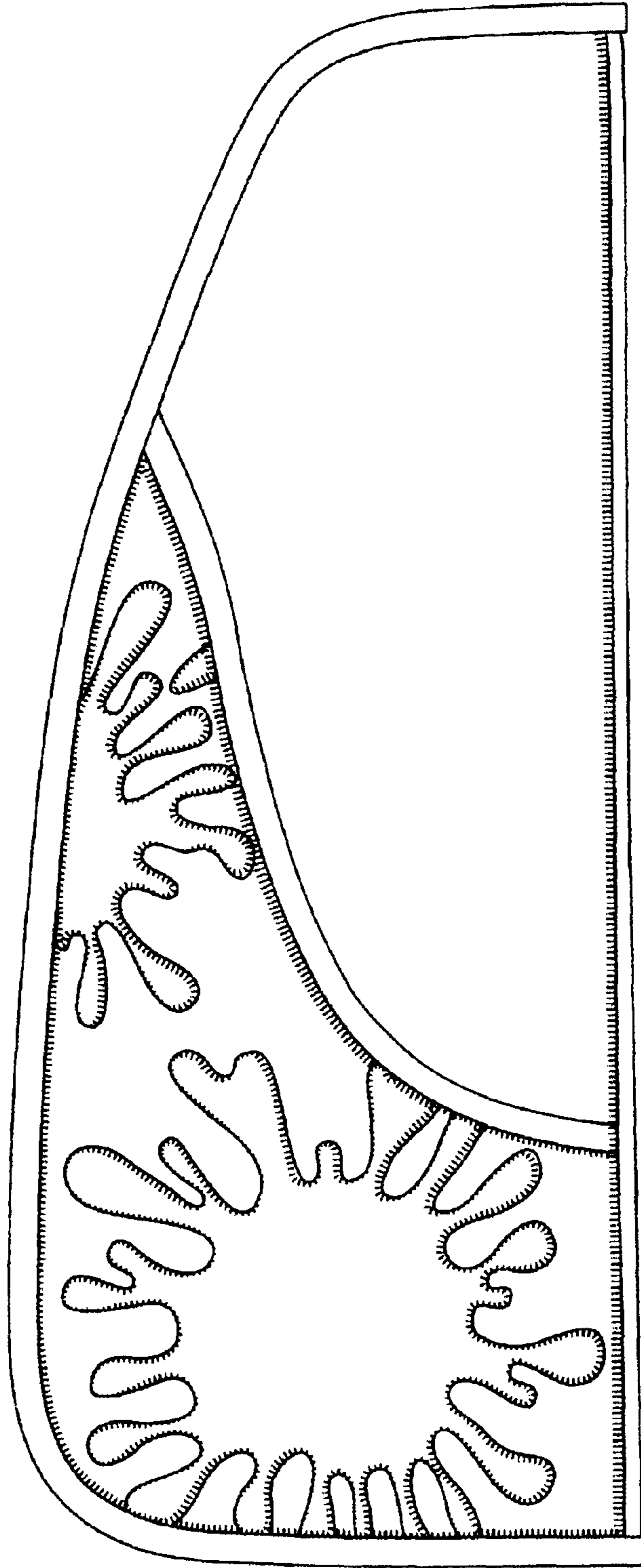

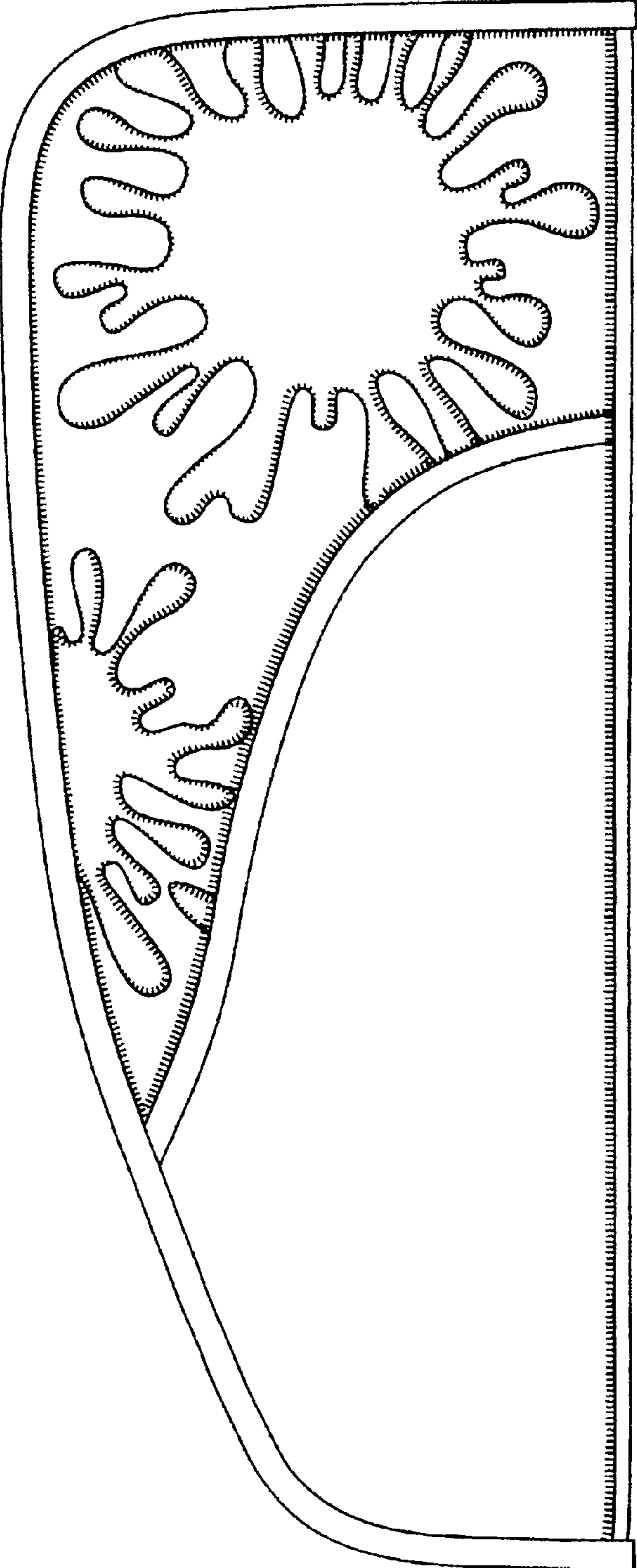

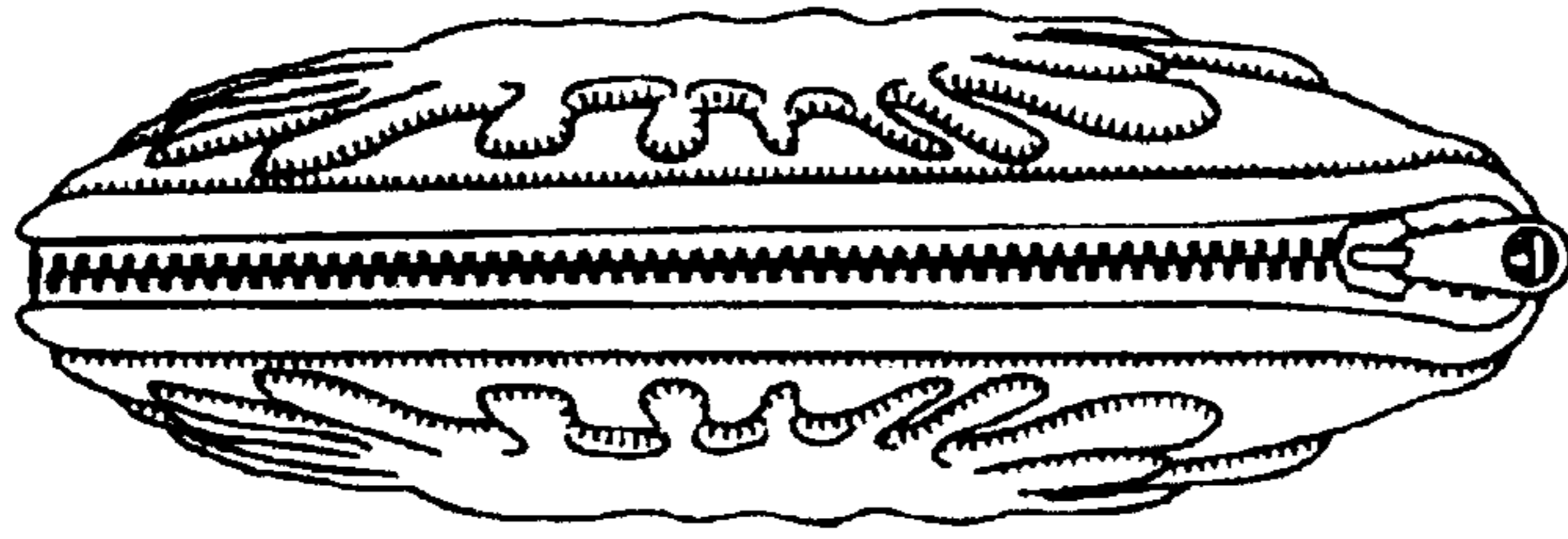

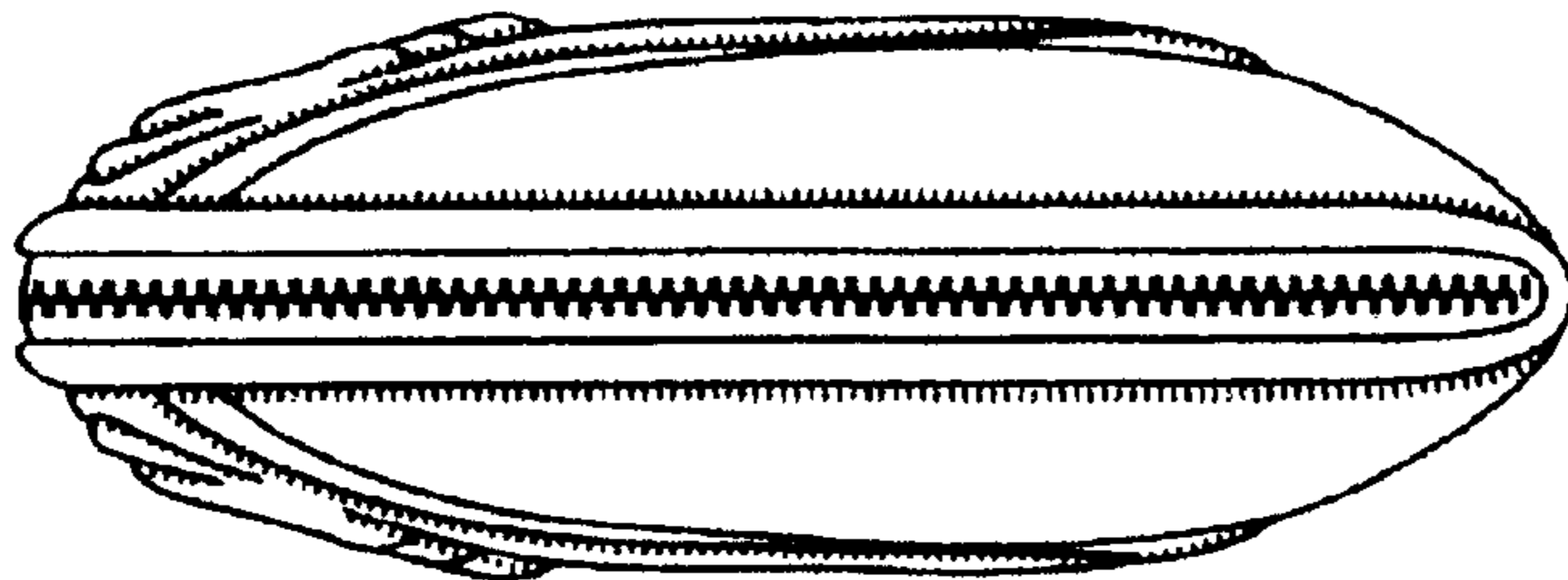

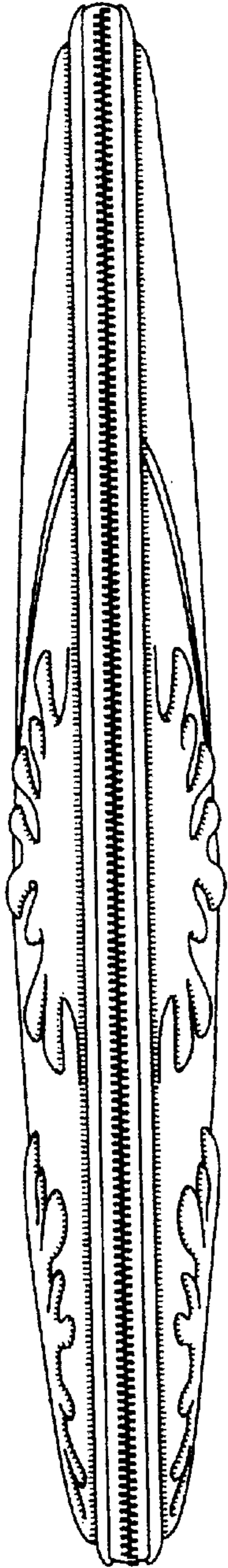

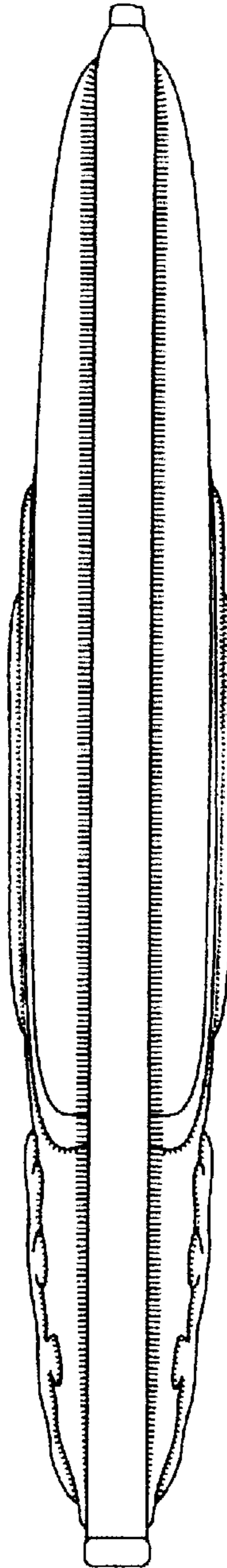
