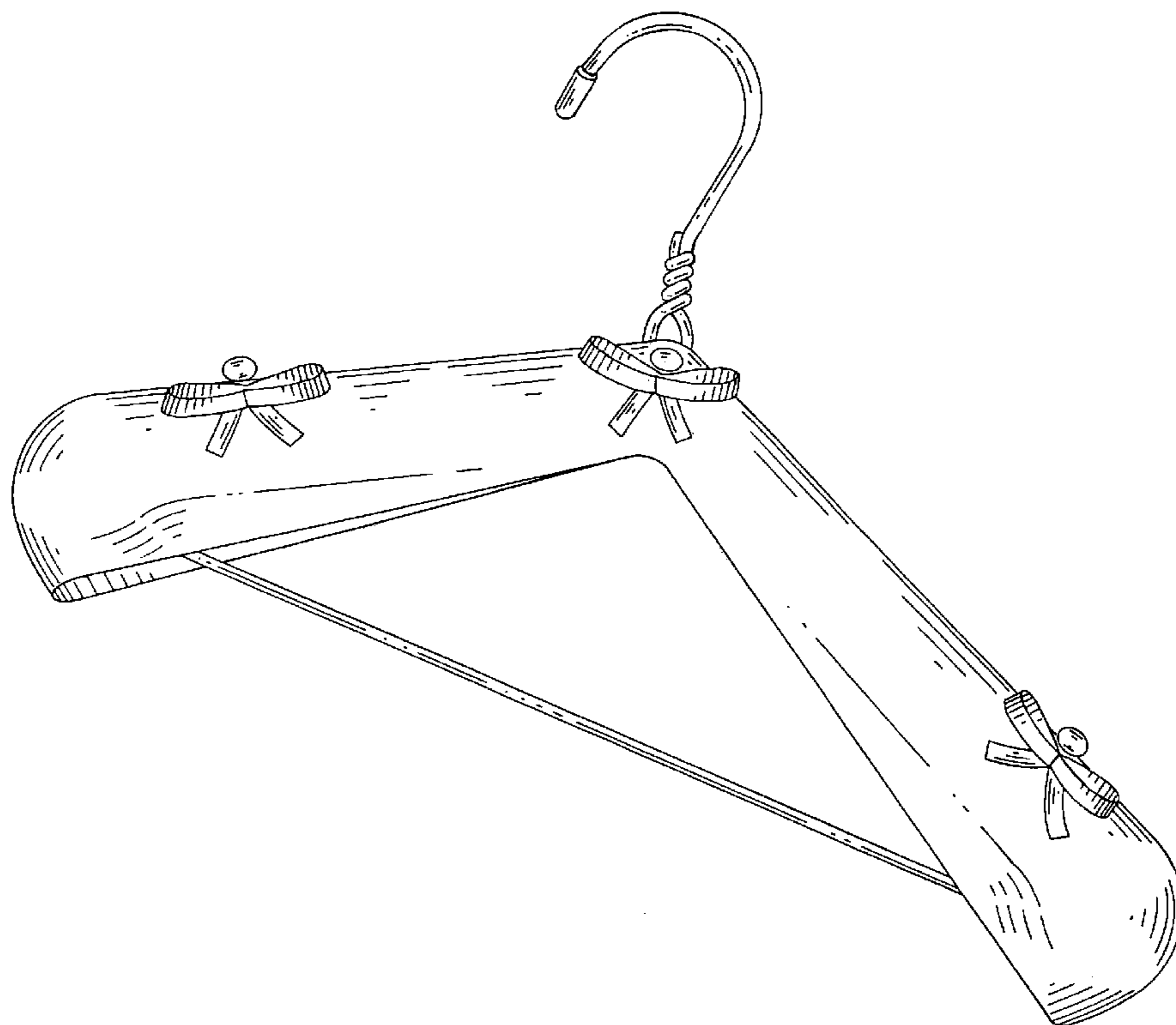
(57) **CLAIM**

I claim the ornamental design for a hanger with cover, as shown.

DESCRIPTION

FIG. 1 is a front perspective view of the hanger with cover showing my new design;
FIG. 2 is a rear perspective view thereof;

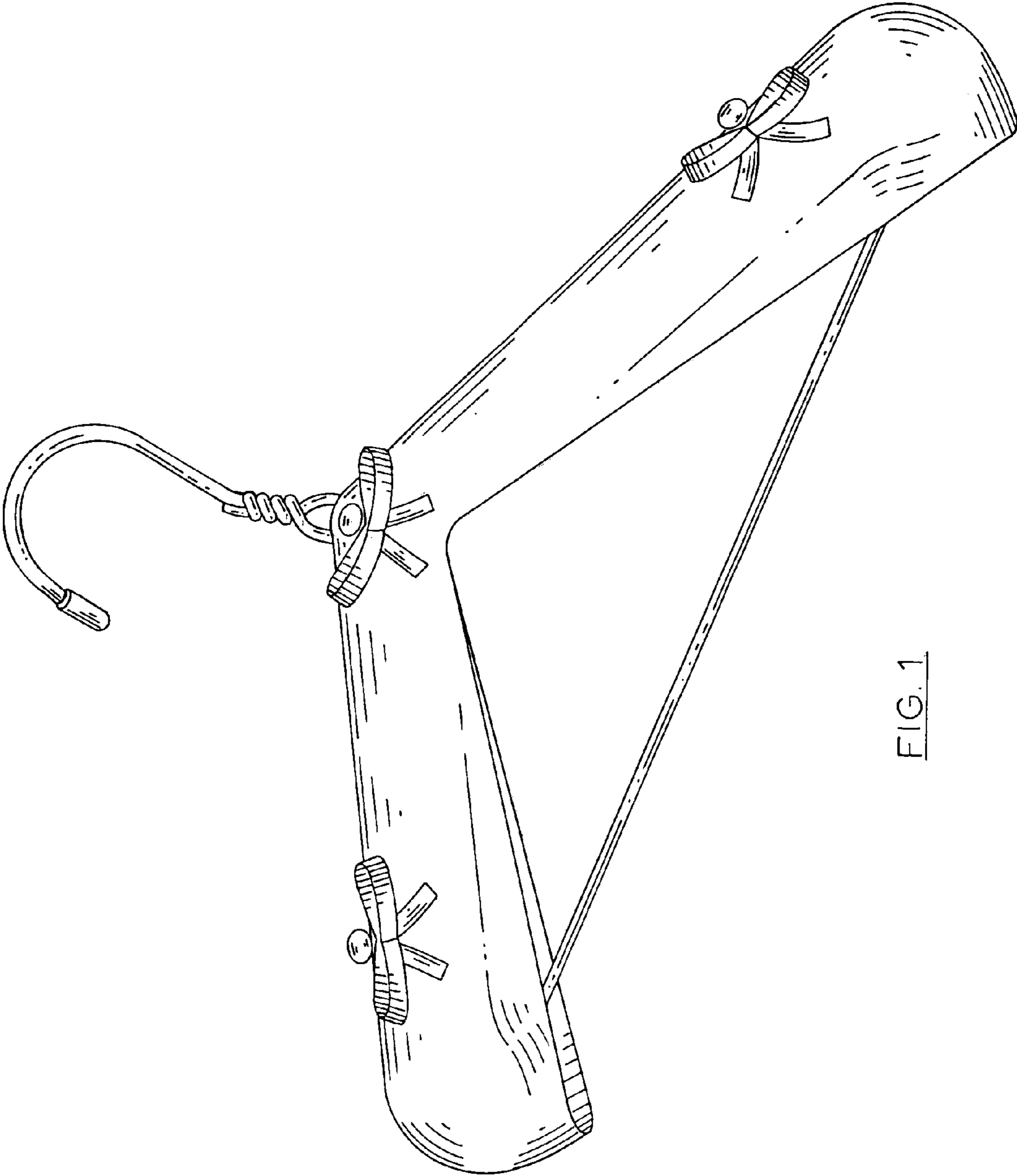

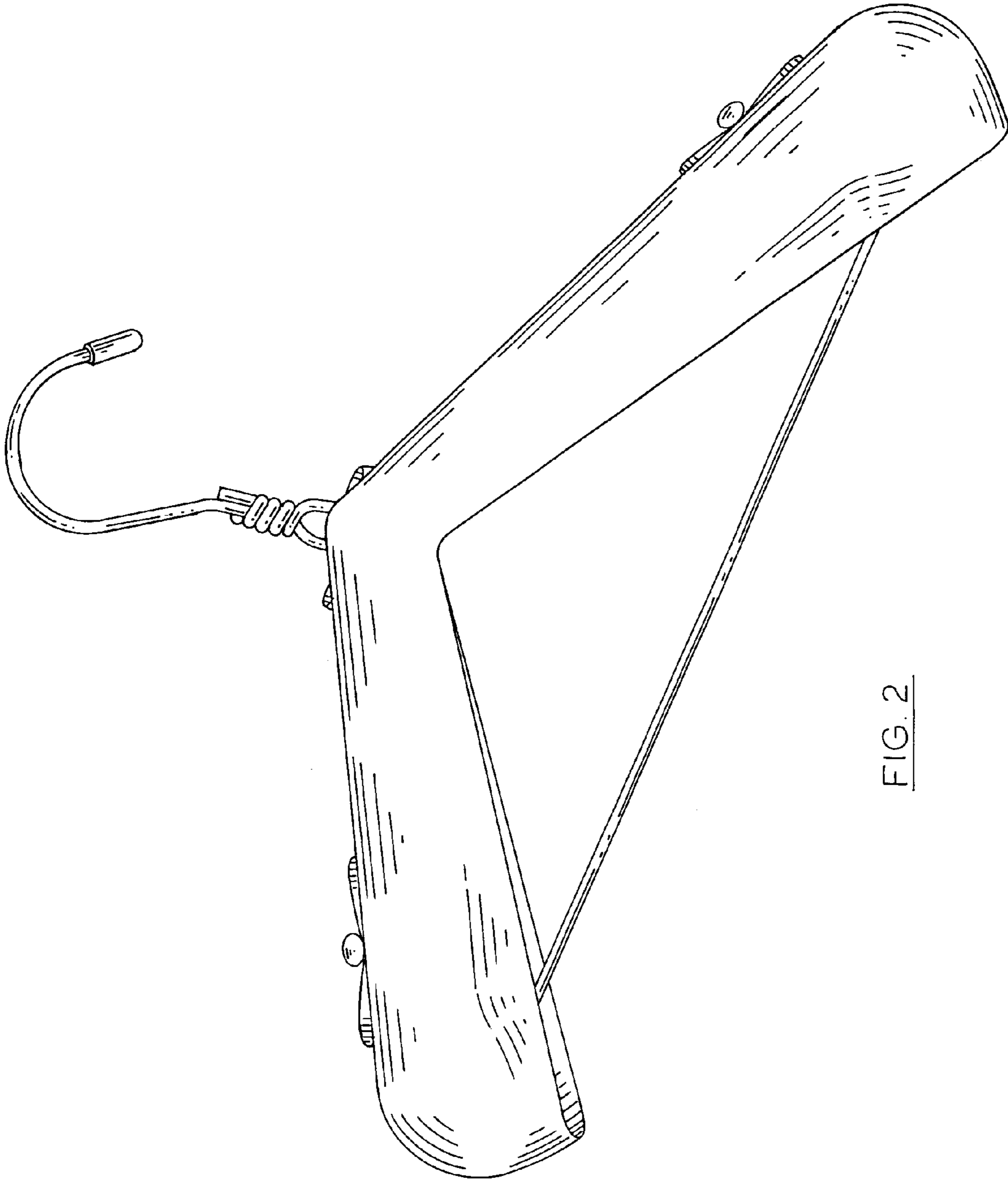

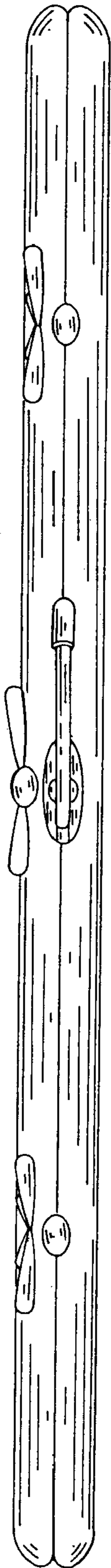

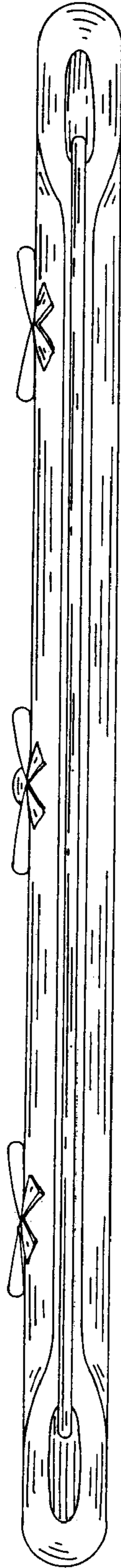

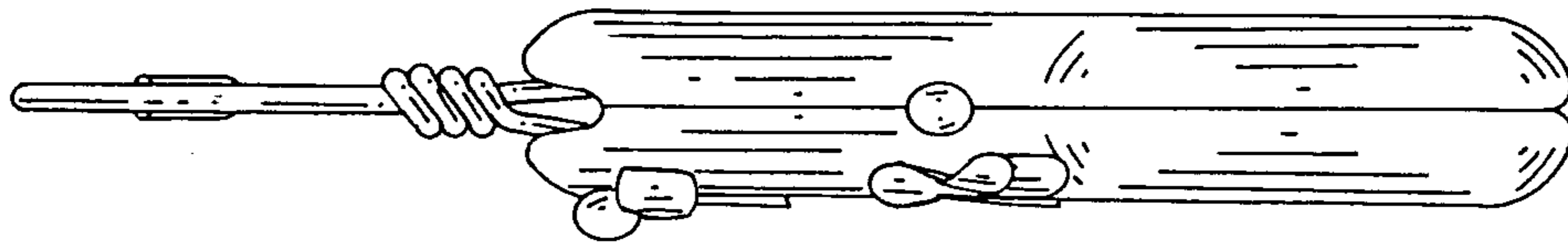

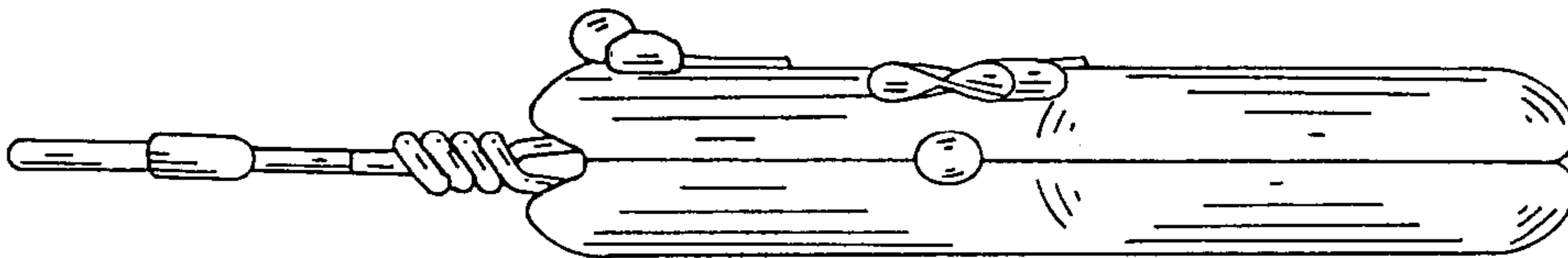
