DESCRIPTION

FIG. 1 is a perspective view of a cabinet comprising the new design;

FIG. 2 is a top view thereof;

FIG. 3 is a front view thereof;

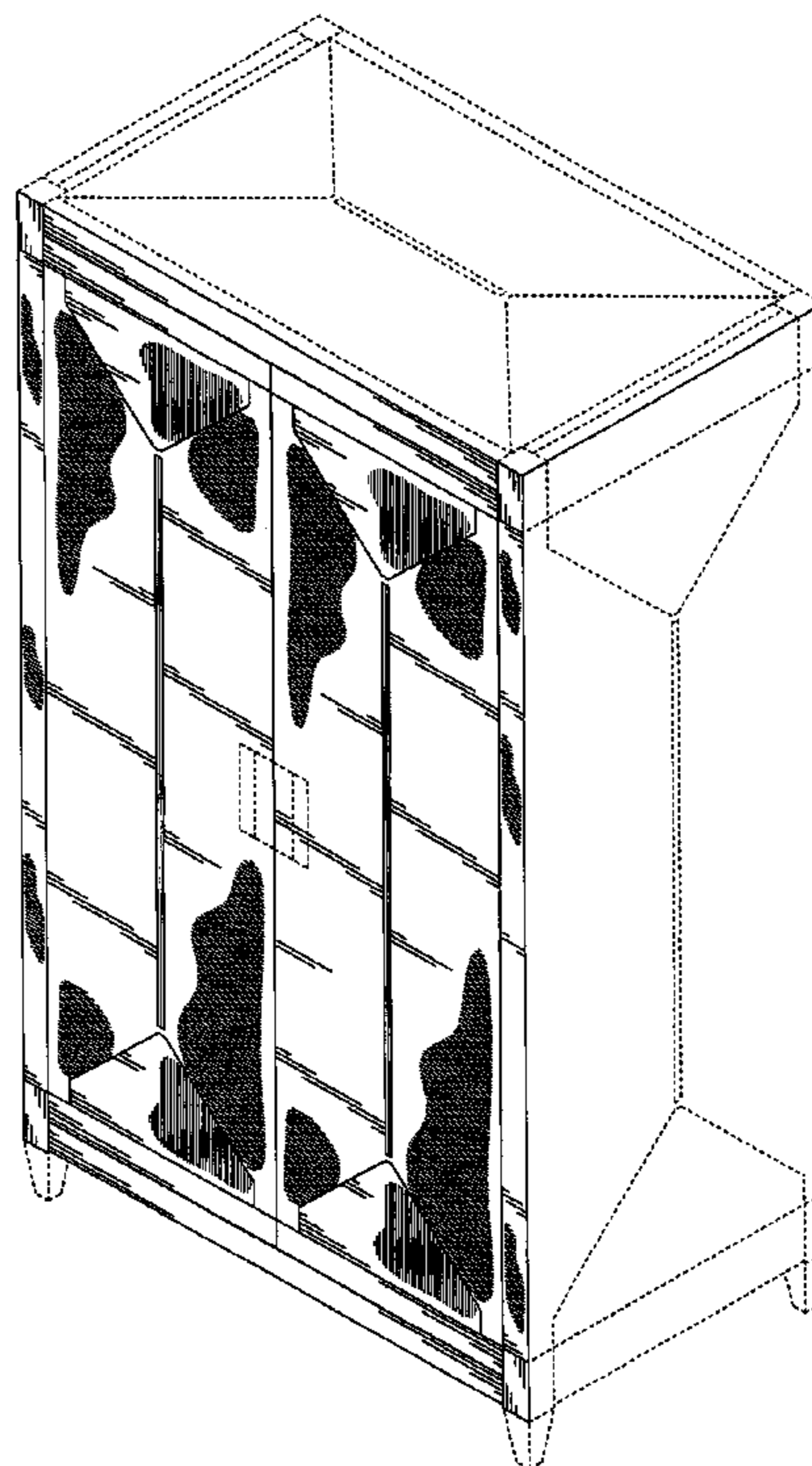
FIG. 4 is a side view thereof; and,

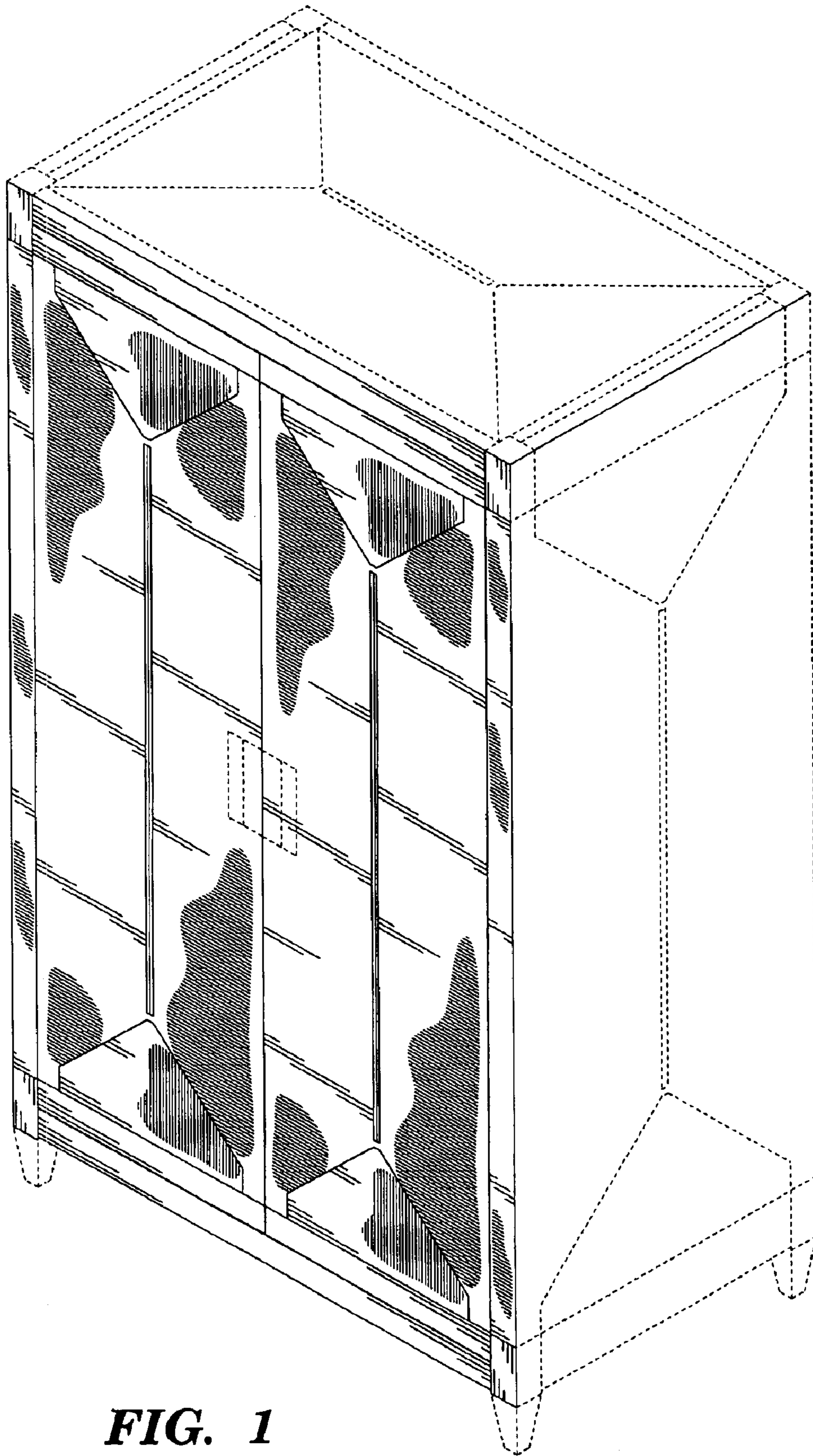

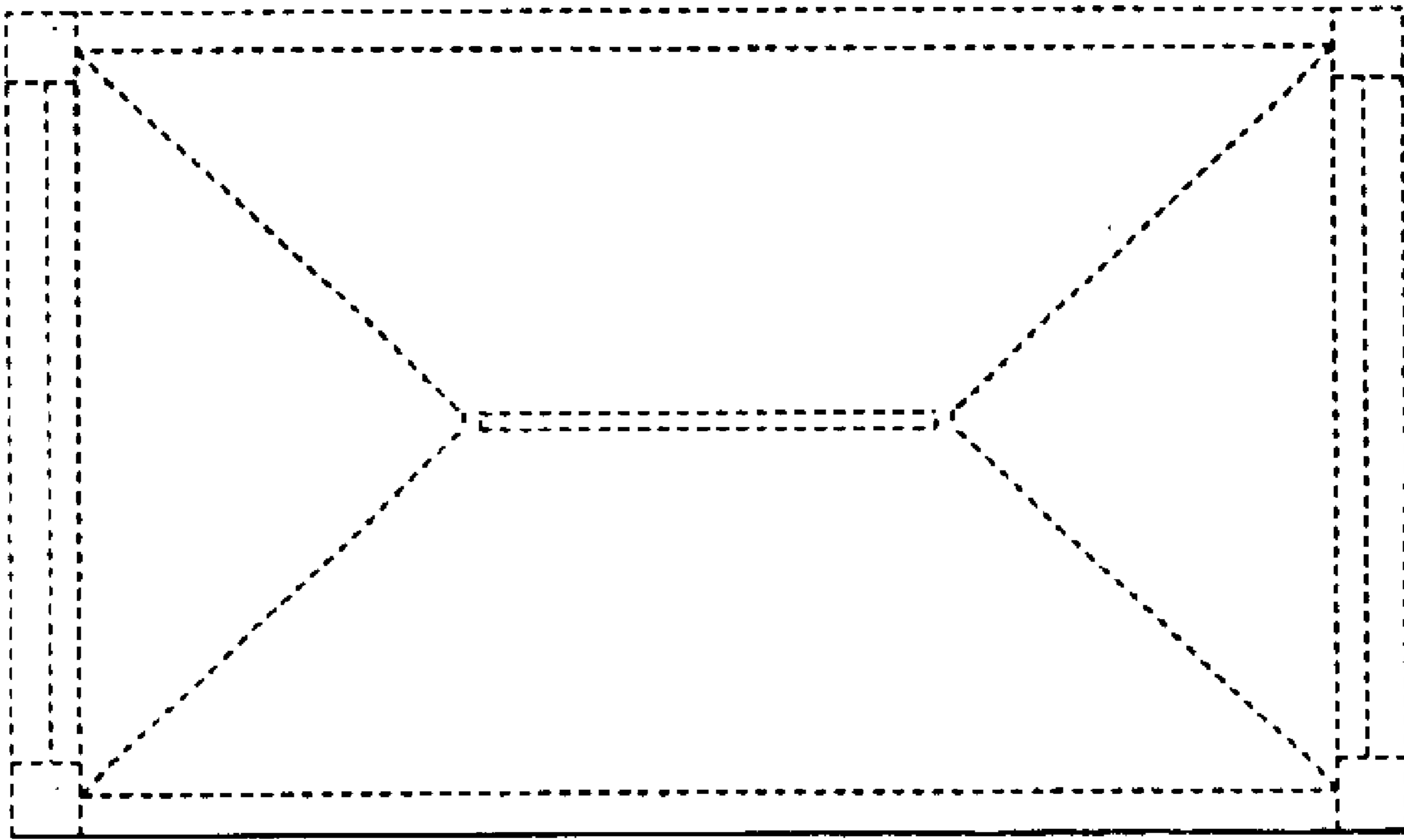

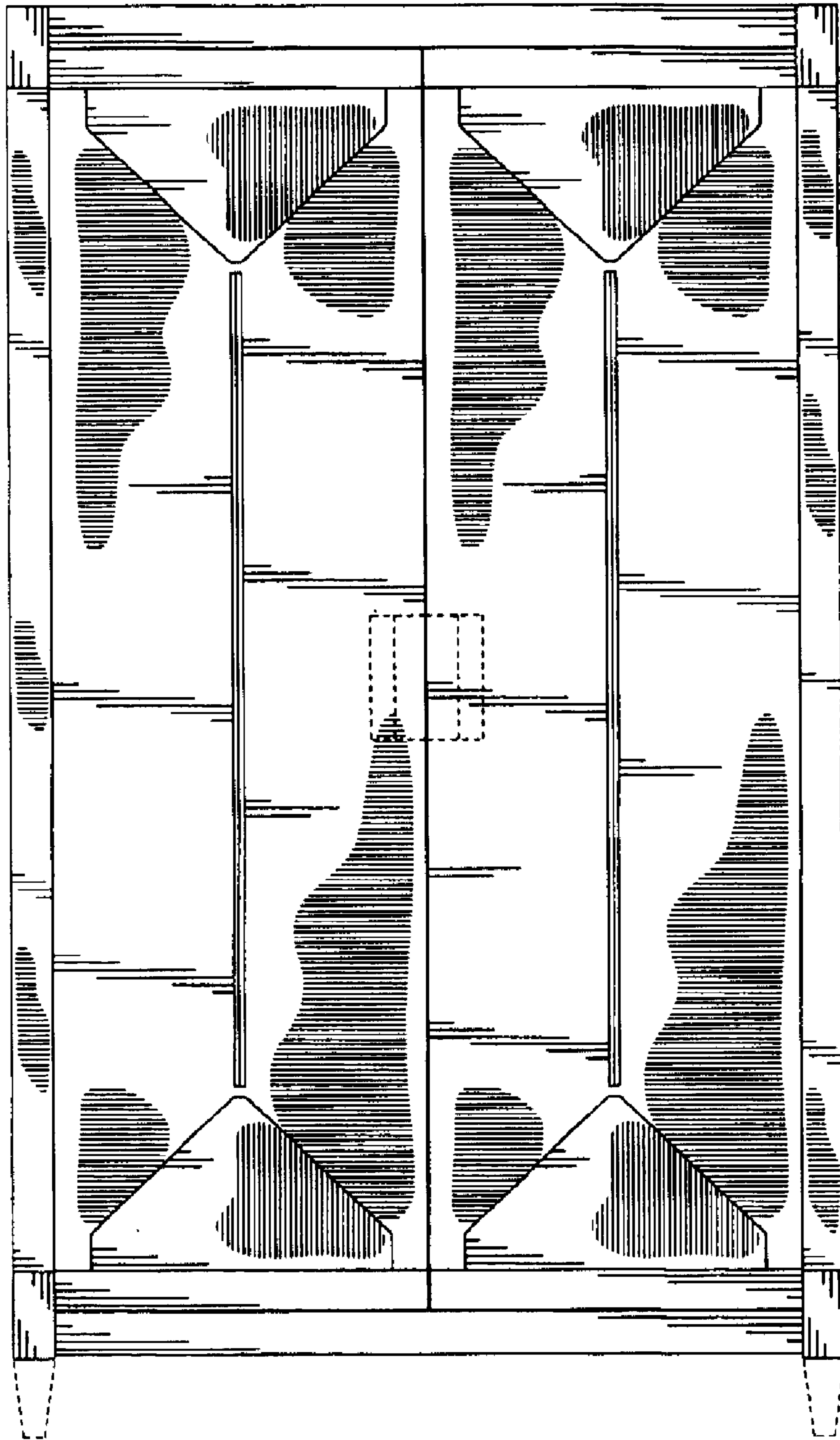

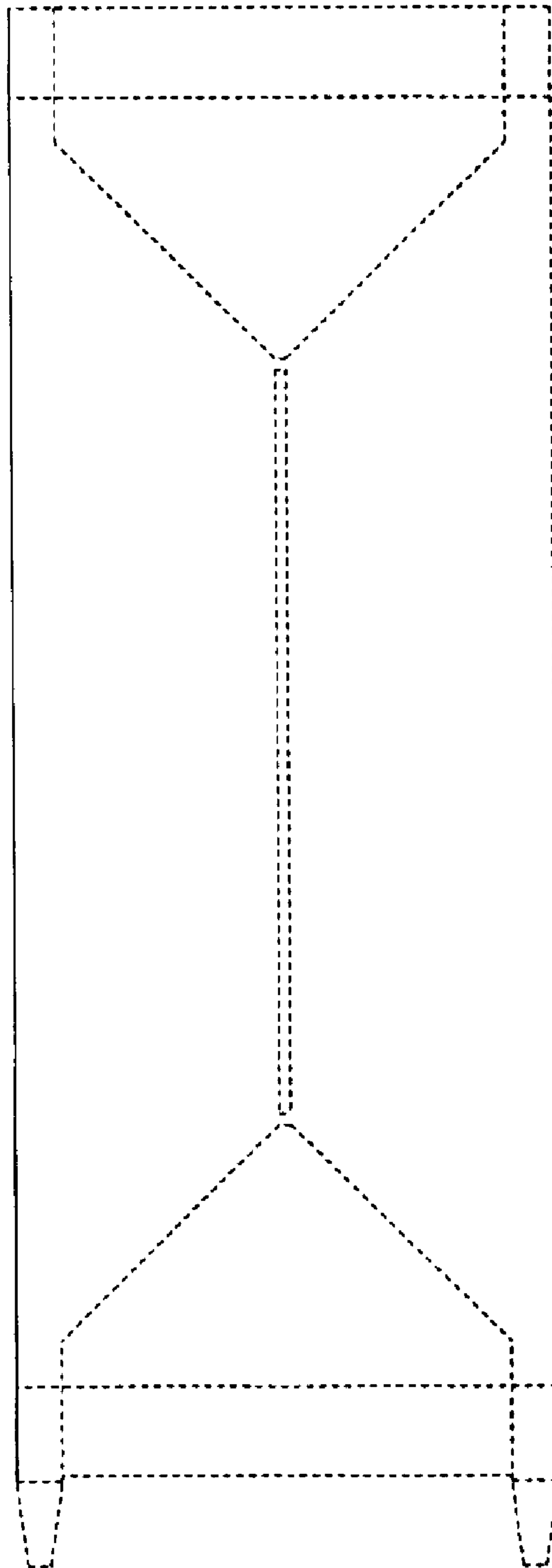

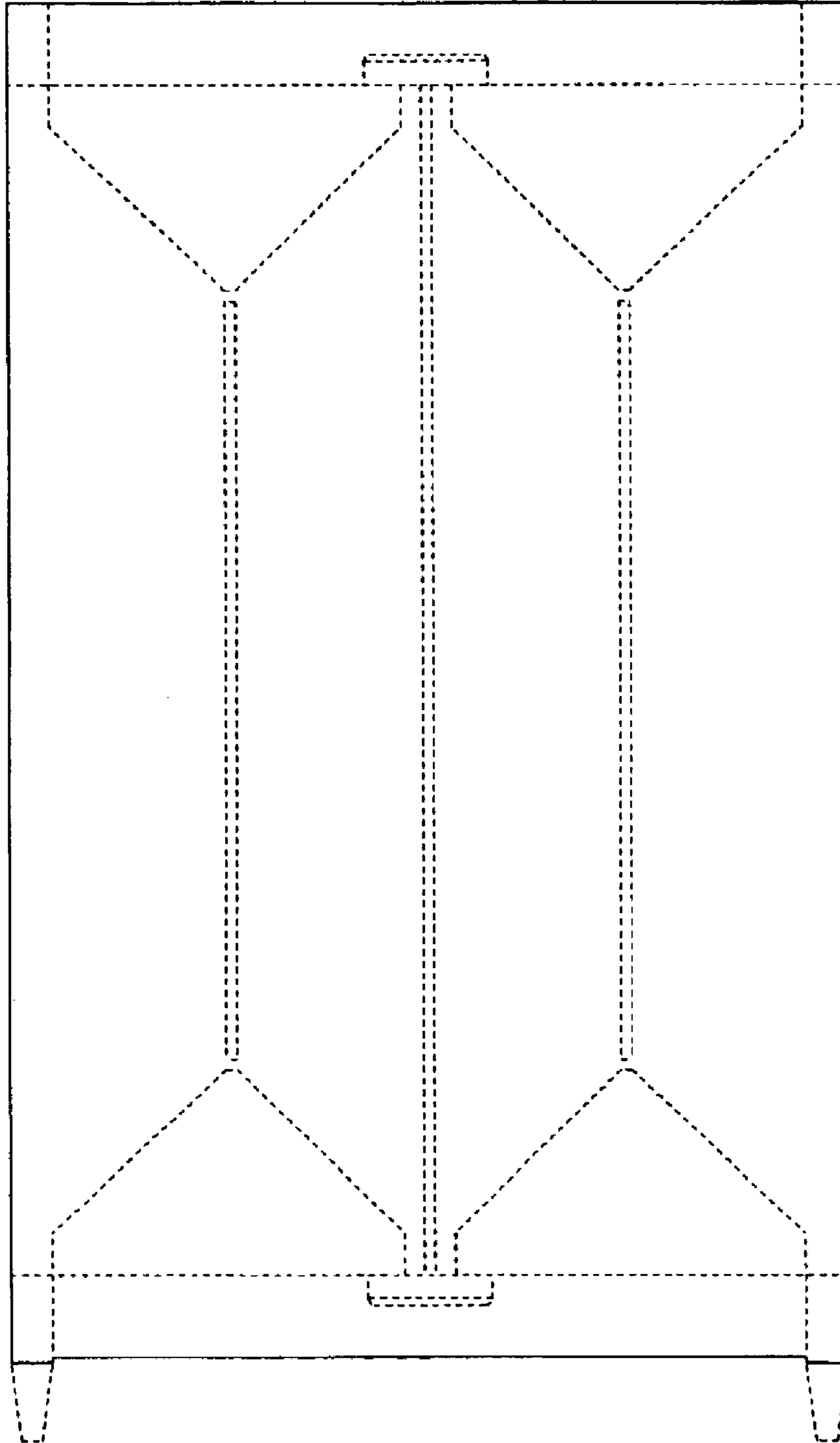
