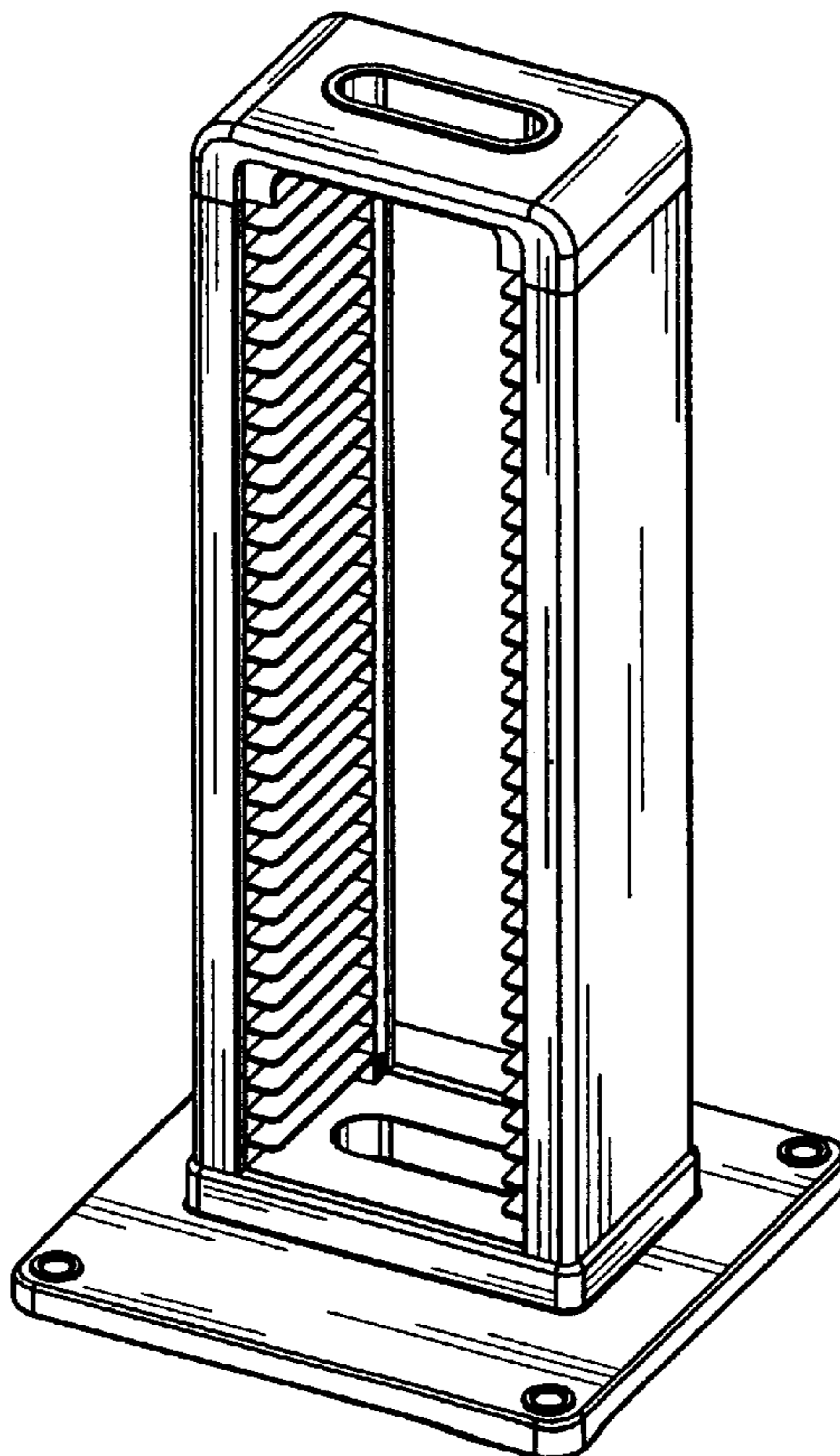
(57) **CLAIM**

The ornamental design for a “disc storage device”, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a “disc storage device” incorporating my design;
 FIG. 2 is a rear view thereof;
 FIG. 3 is an elevation view thereof from the left side;
 FIG. 4 is an elevation view thereof from the right side;
 FIG. 5 is a top view thereof;
 FIG. 6 is a perspective view thereof from the top right side;
 and,
 FIG. 7 is a perspective view thereof, but shown in an alternative configuration and with additional storage units.

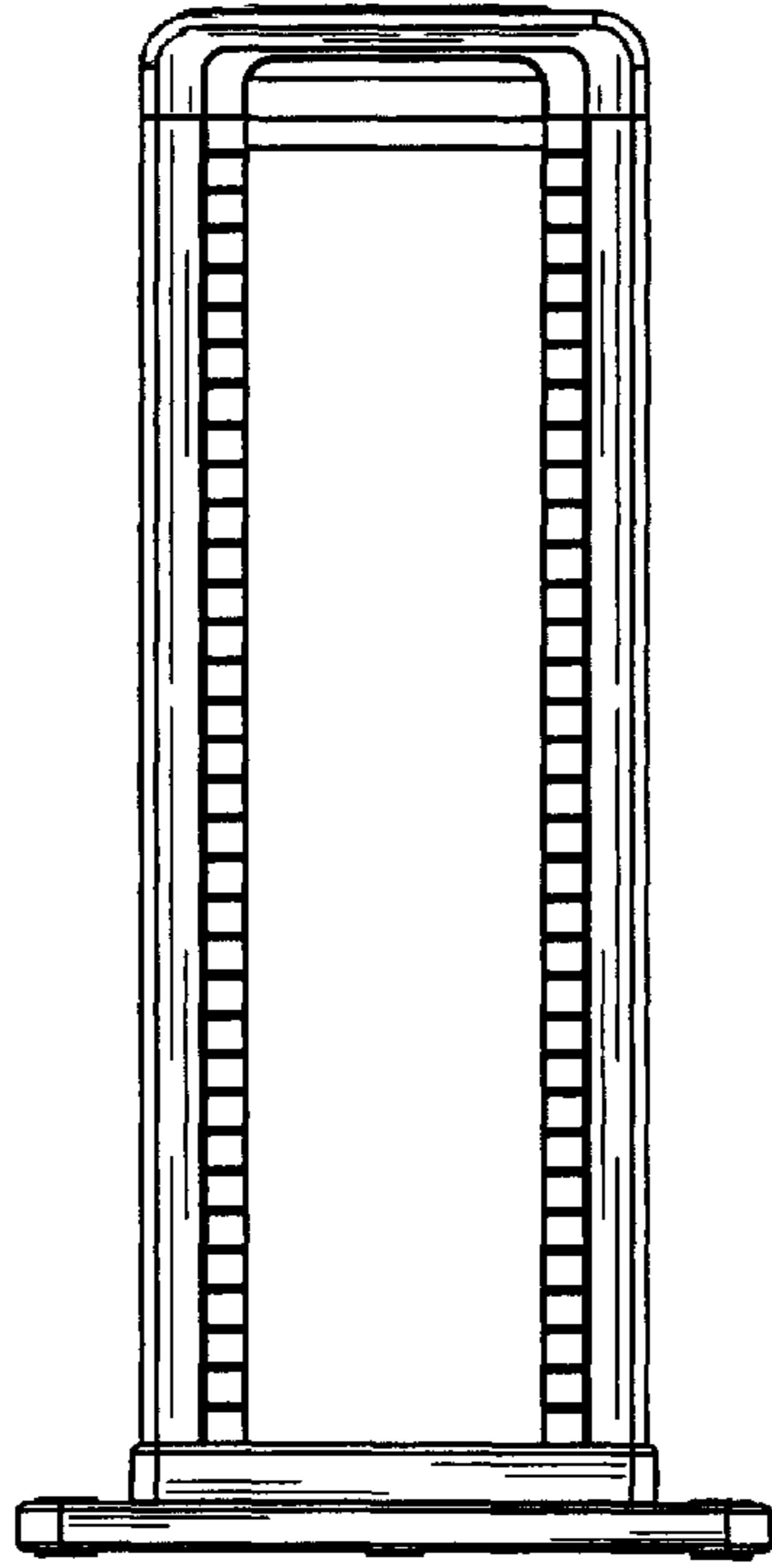

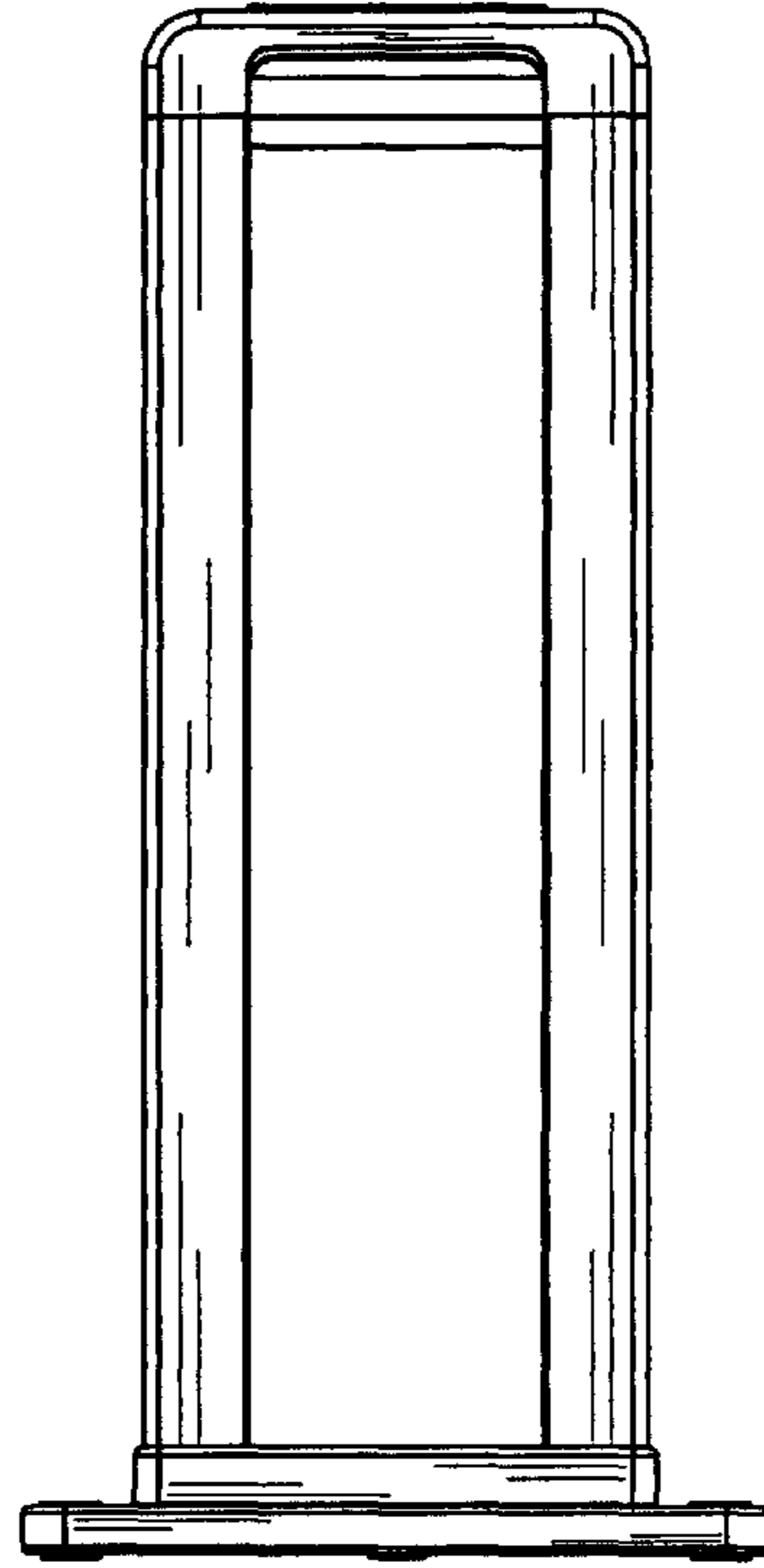

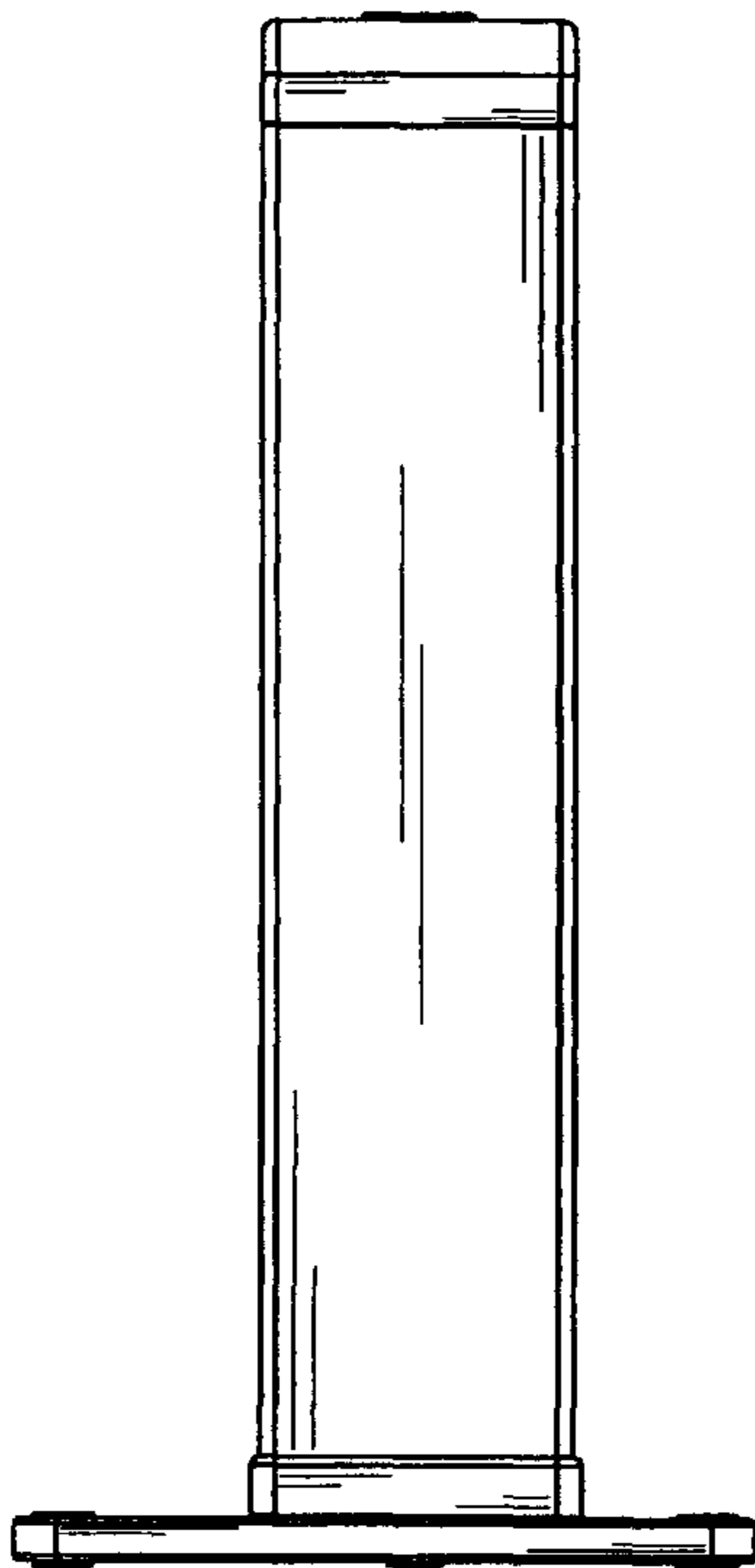

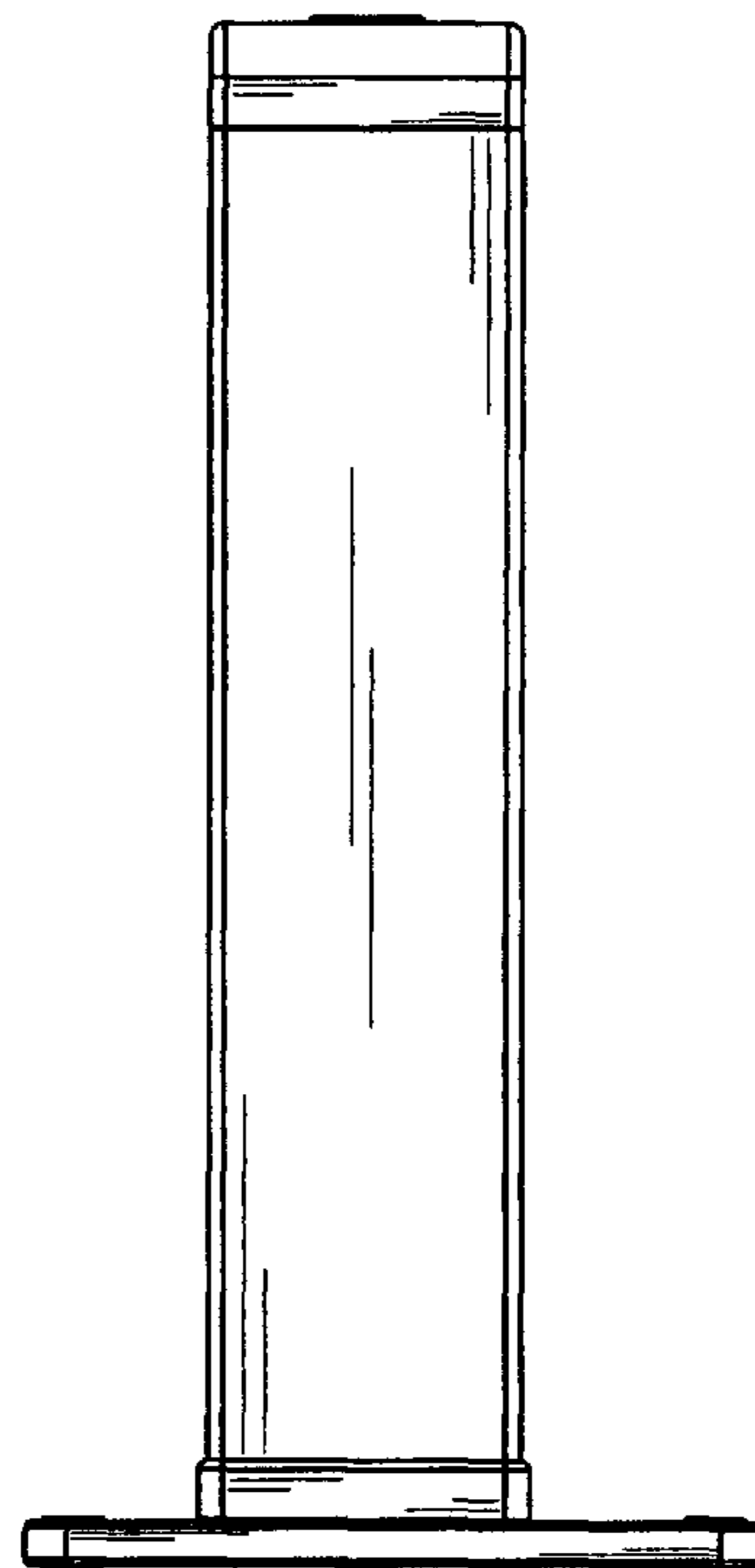

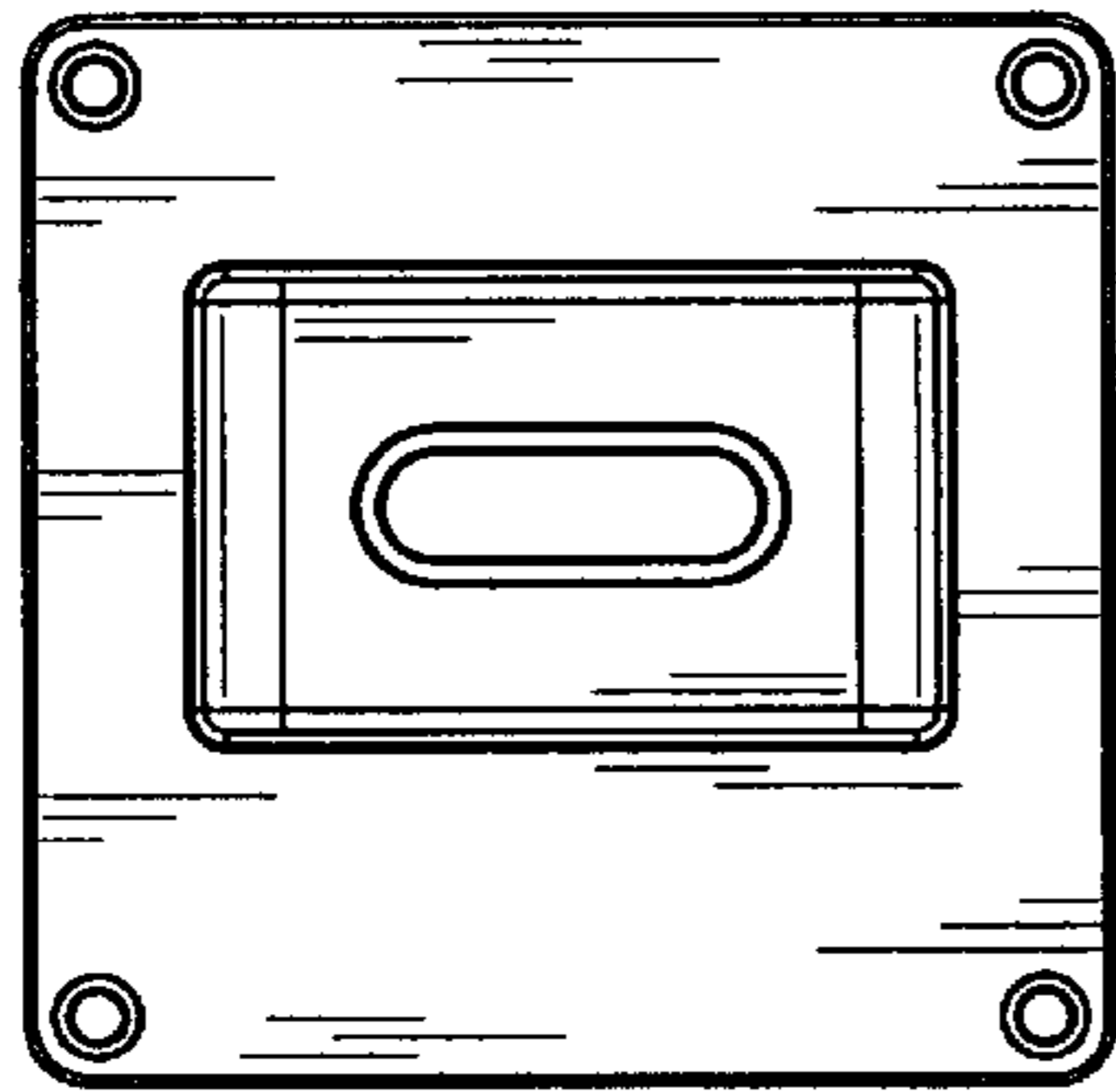

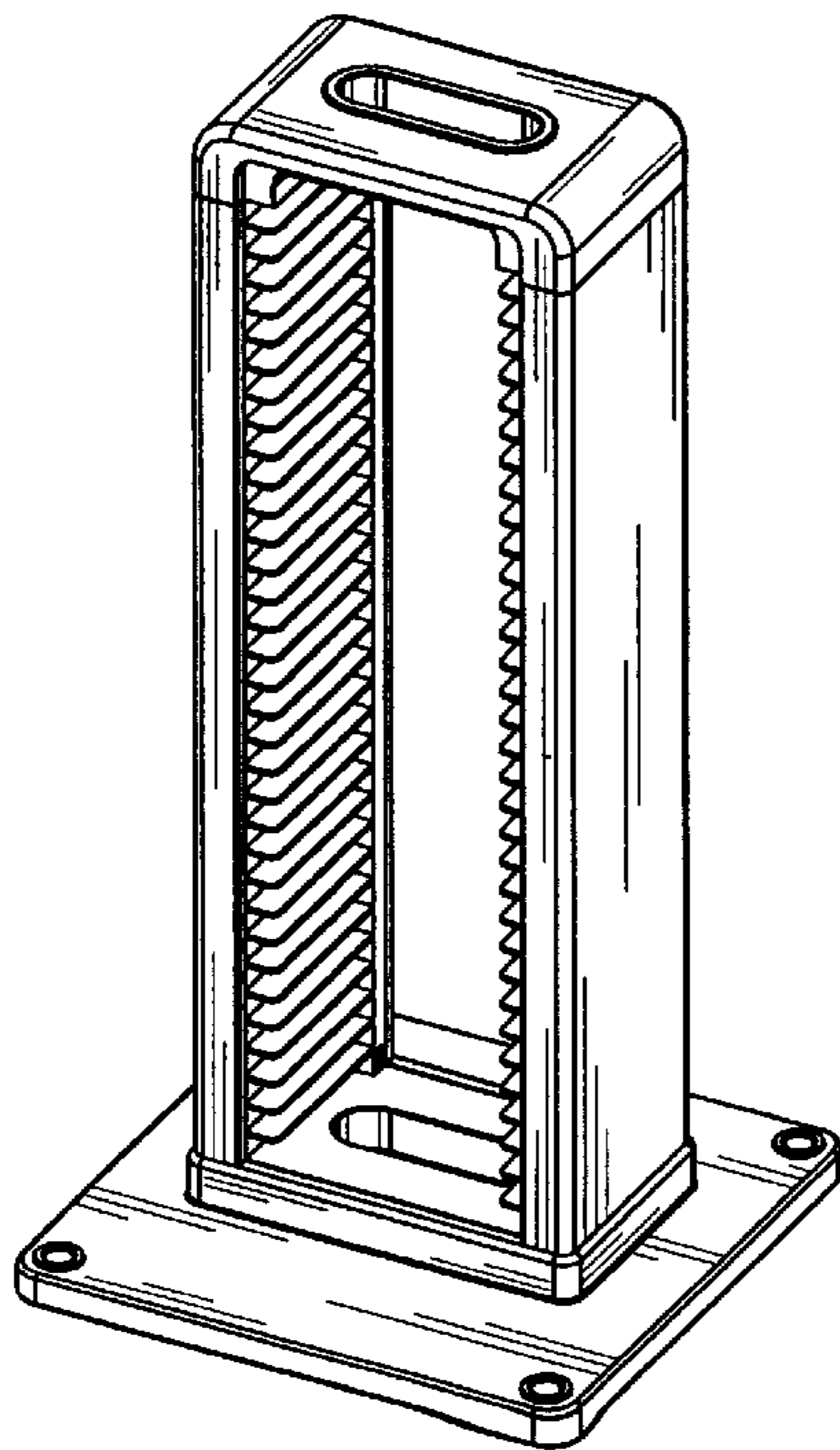

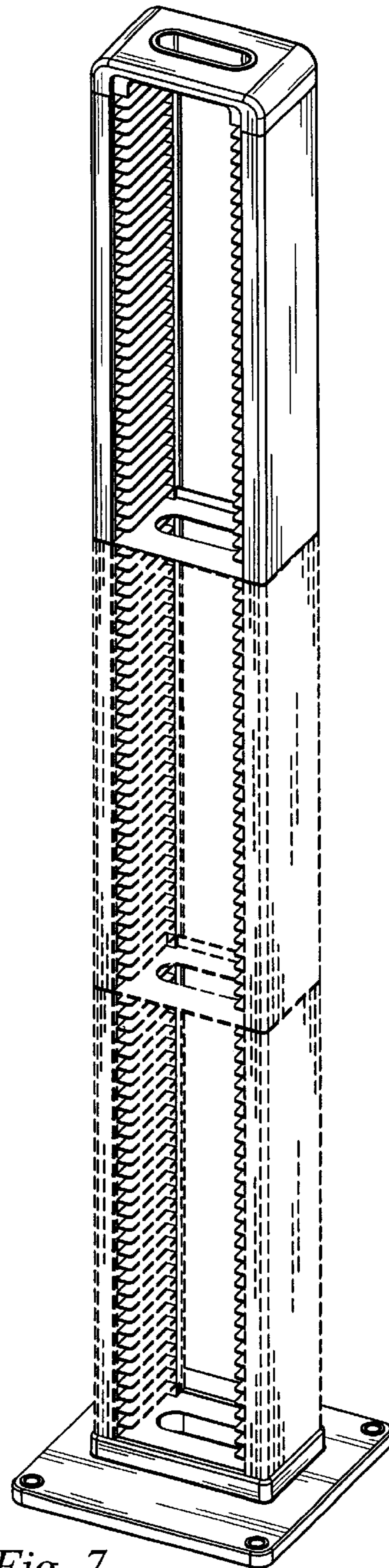
